FIG. 7 is a bottom plan view of the phone cover including card pouch of my new design.

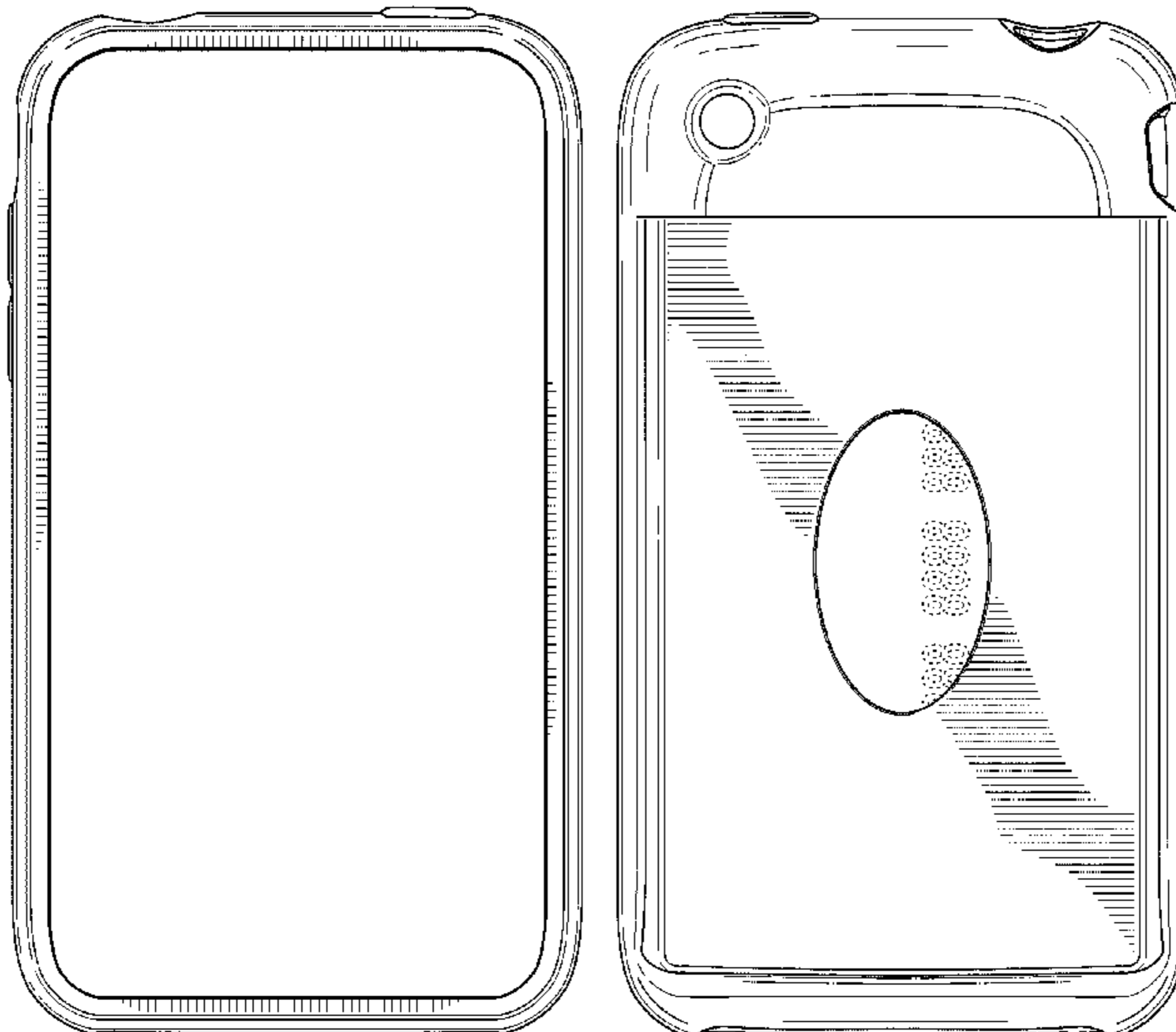

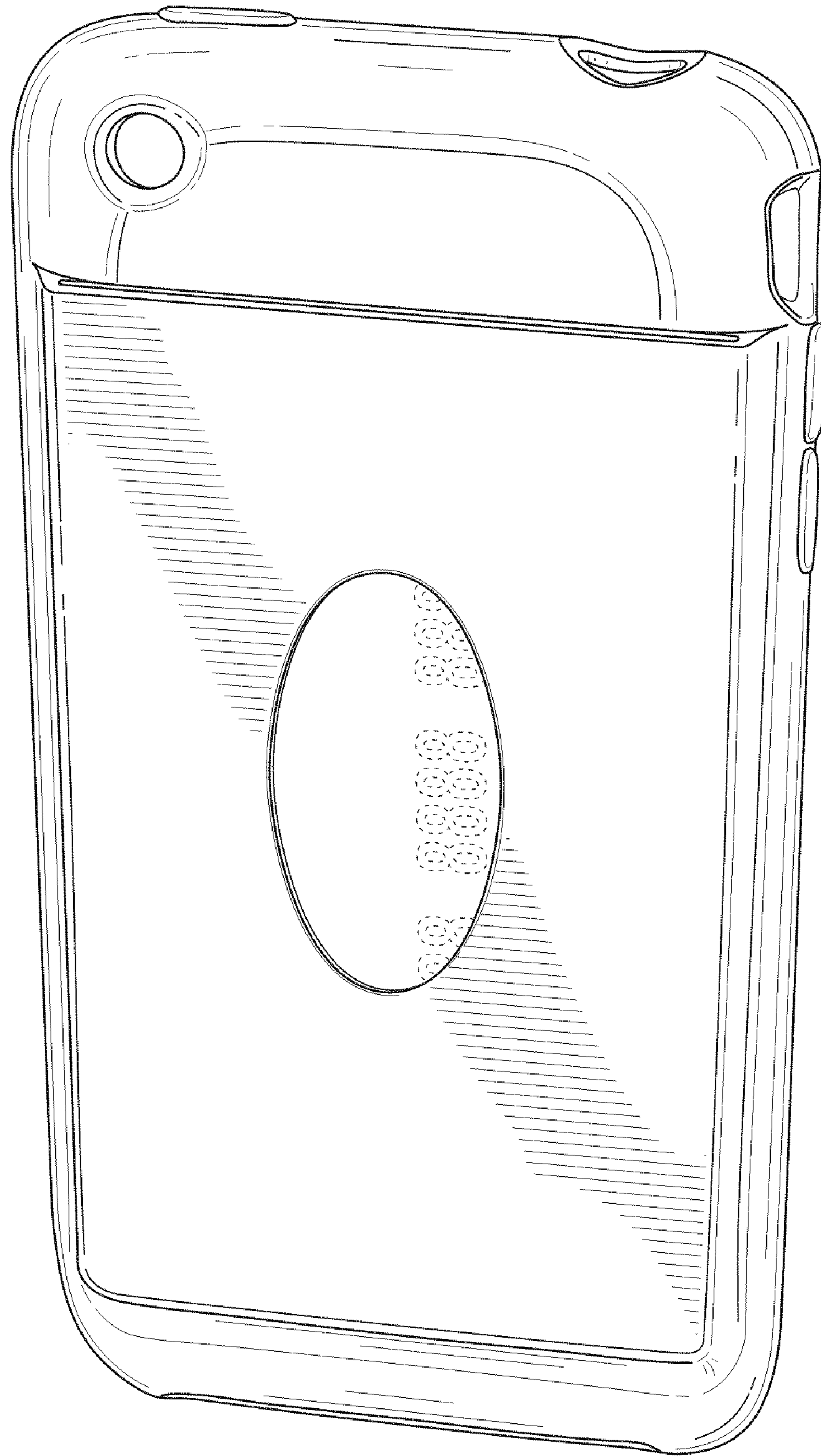

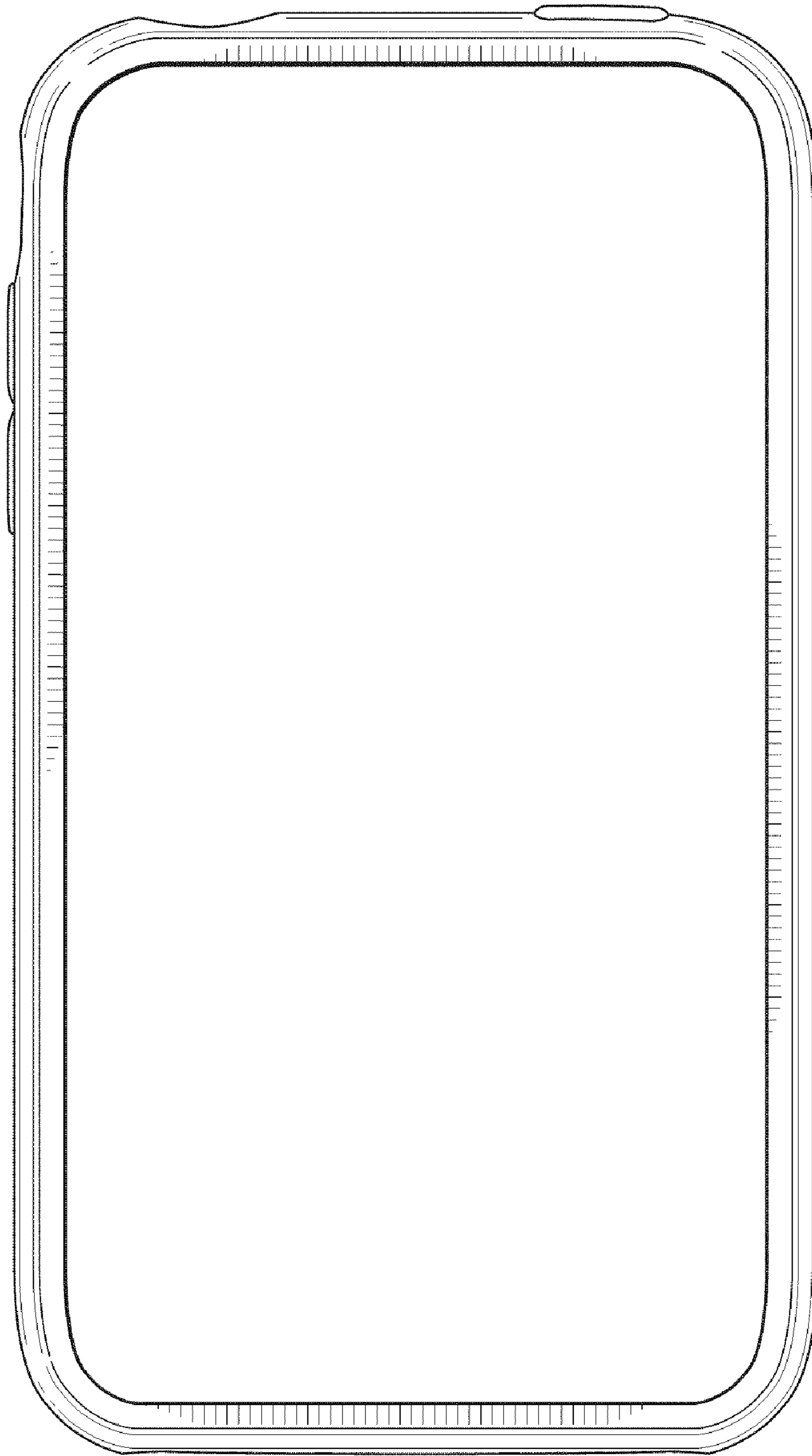

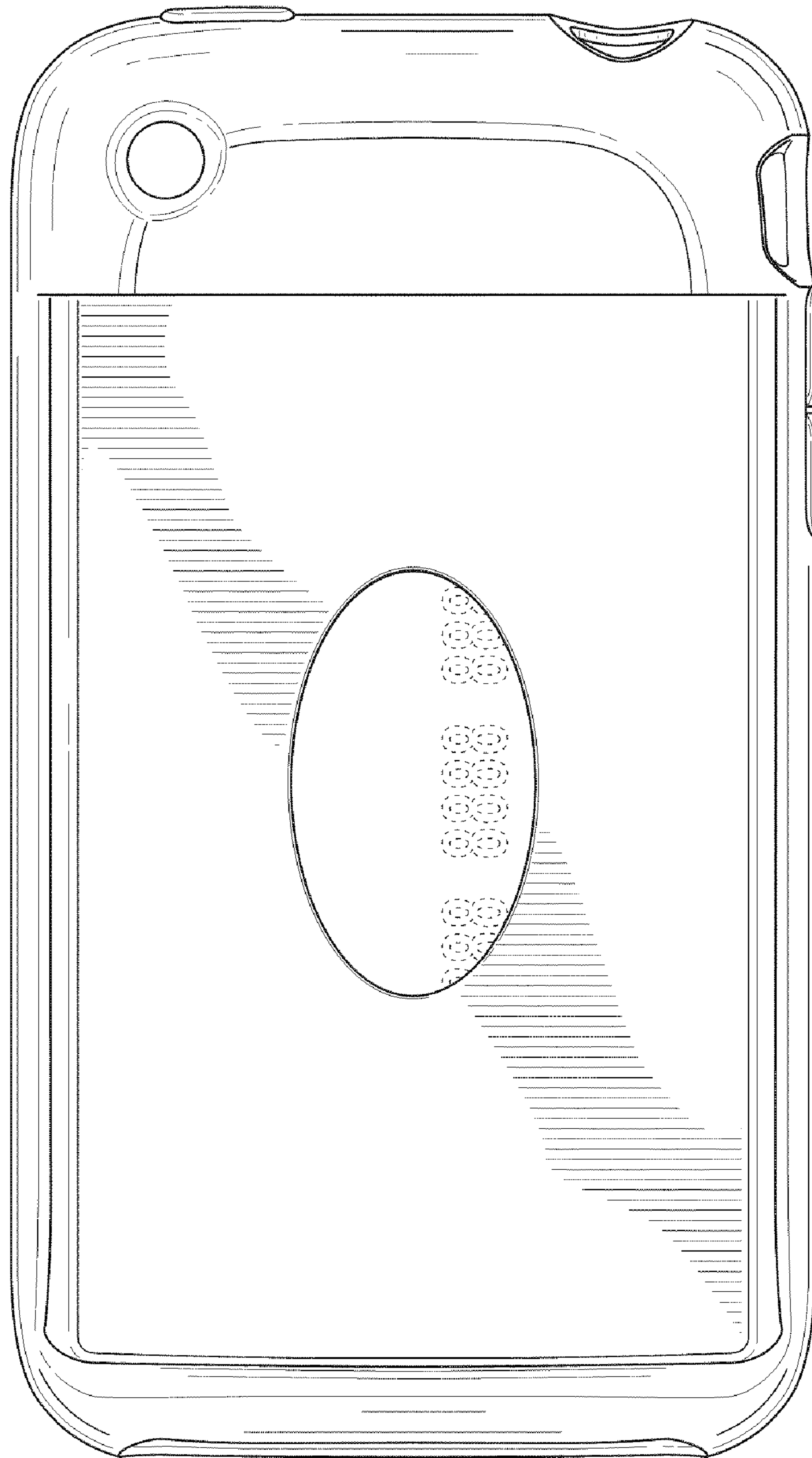

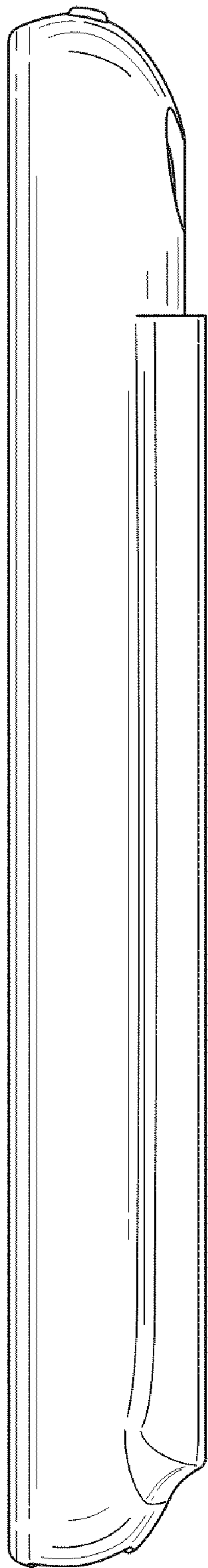

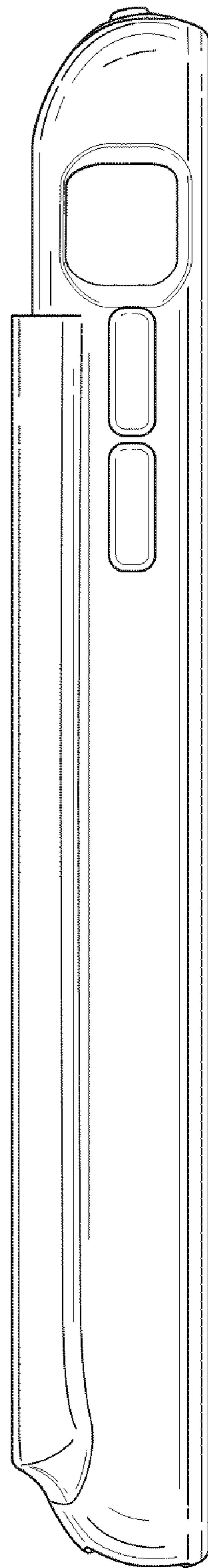

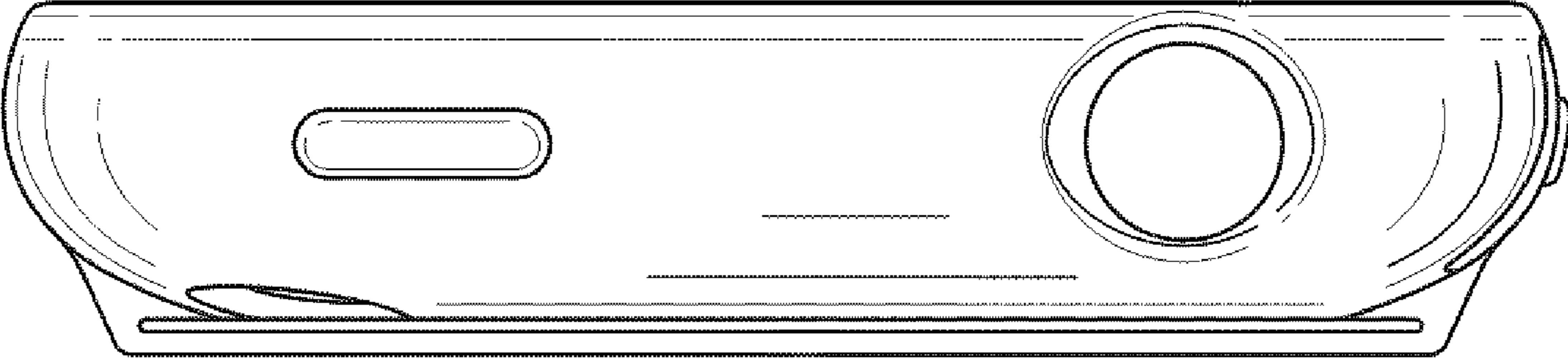

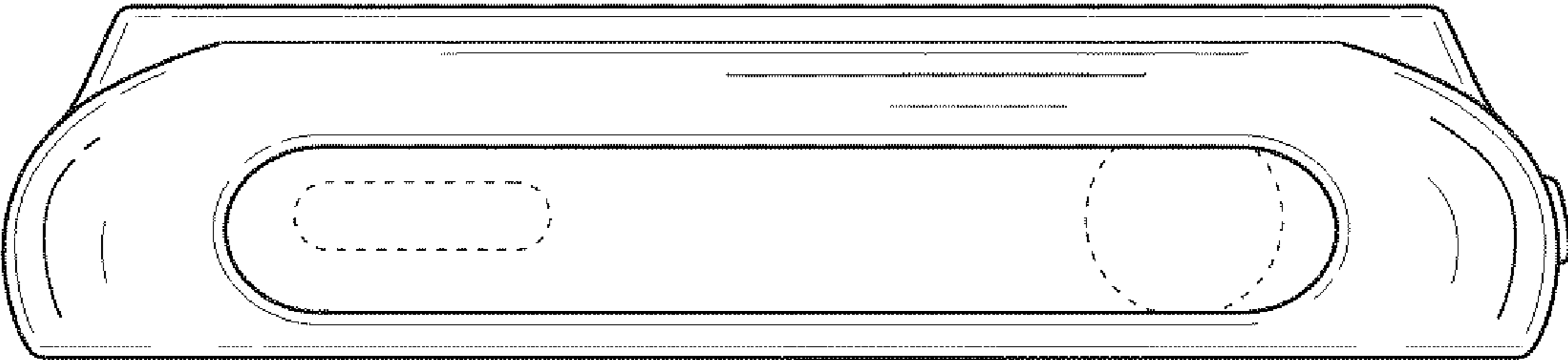
