DESCRIPTION

FIG. 1 is a top plan view of the front of the ace of club playing card, part of the deck of African heritage playing cards, showing my new design;

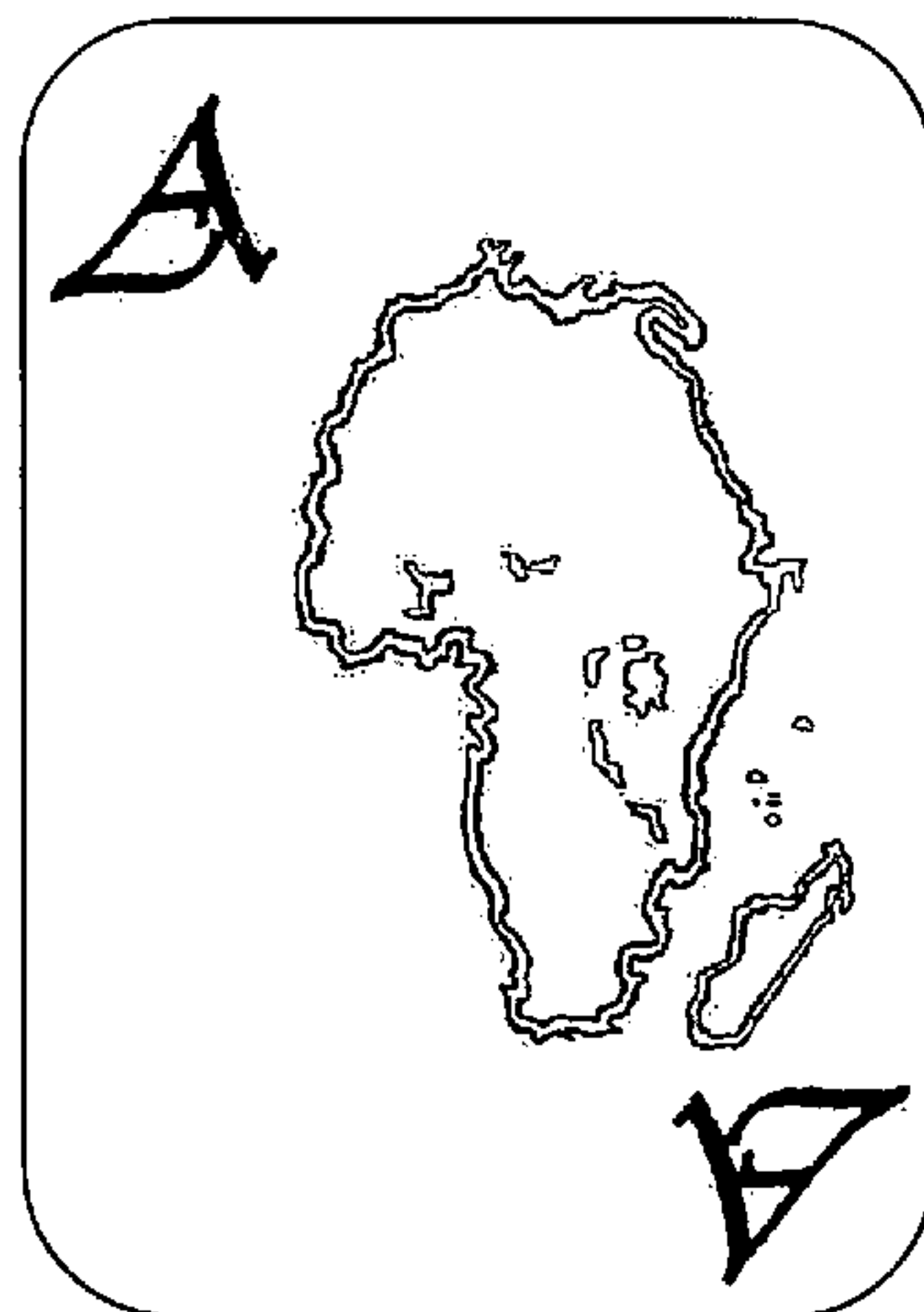


FIG. 2 is a top plan view of the front of the ace of diamond playing card, part of the deck of African heritage playing cards, showing my new design;

FIG. 9 is a top plan view of the front of the three of club playing card, part of the deck of African heritage playing cards, showing my new design;

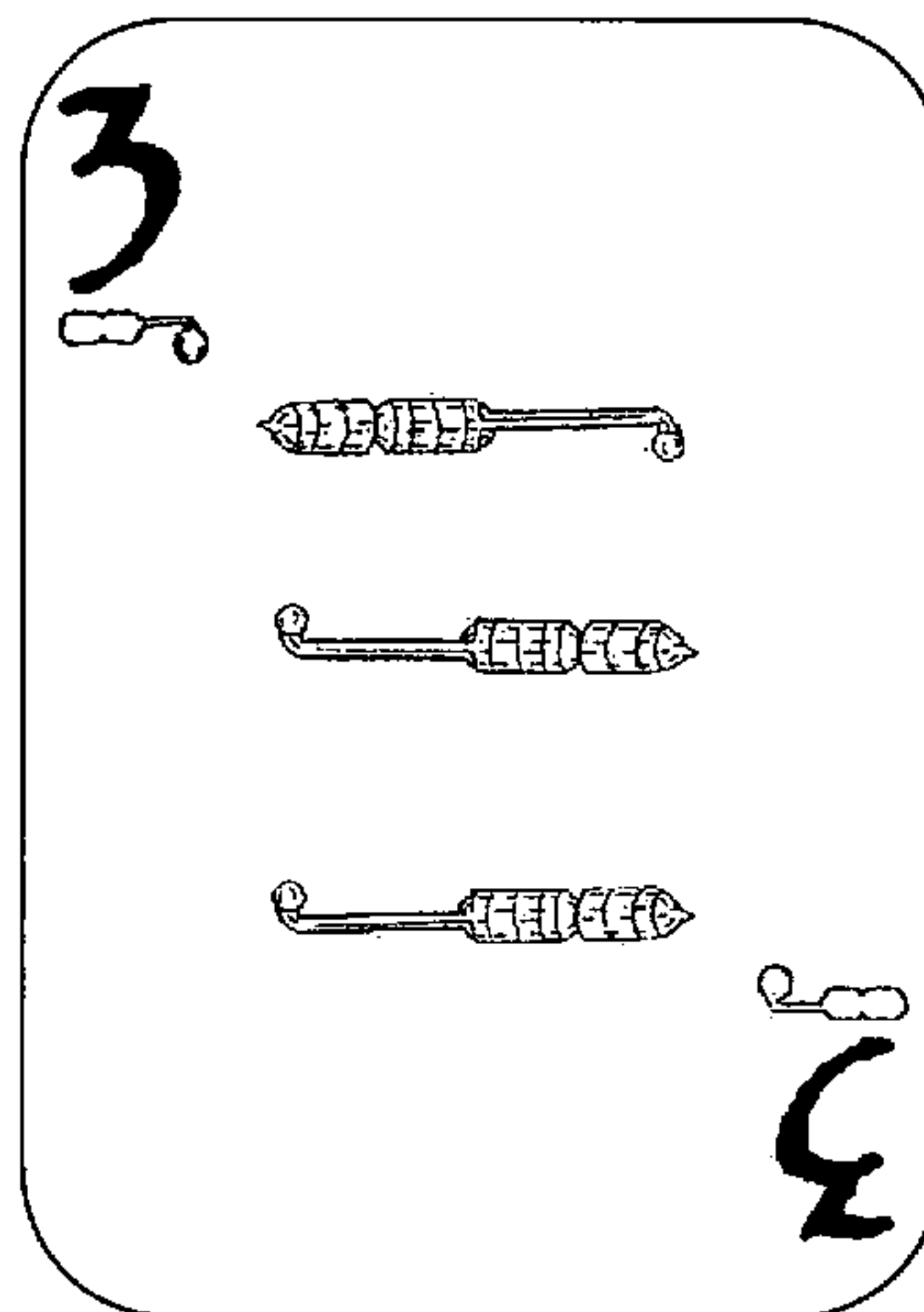
FIG. 10 is a top plan view of the front of the three of diamond playing card, part of the deck of African heritage playing cards, showing my new design;

FIG. 14 is a top plan view of the front of the four of diamond playing card, part of the deck of African heritage playing cards, showing my new design;



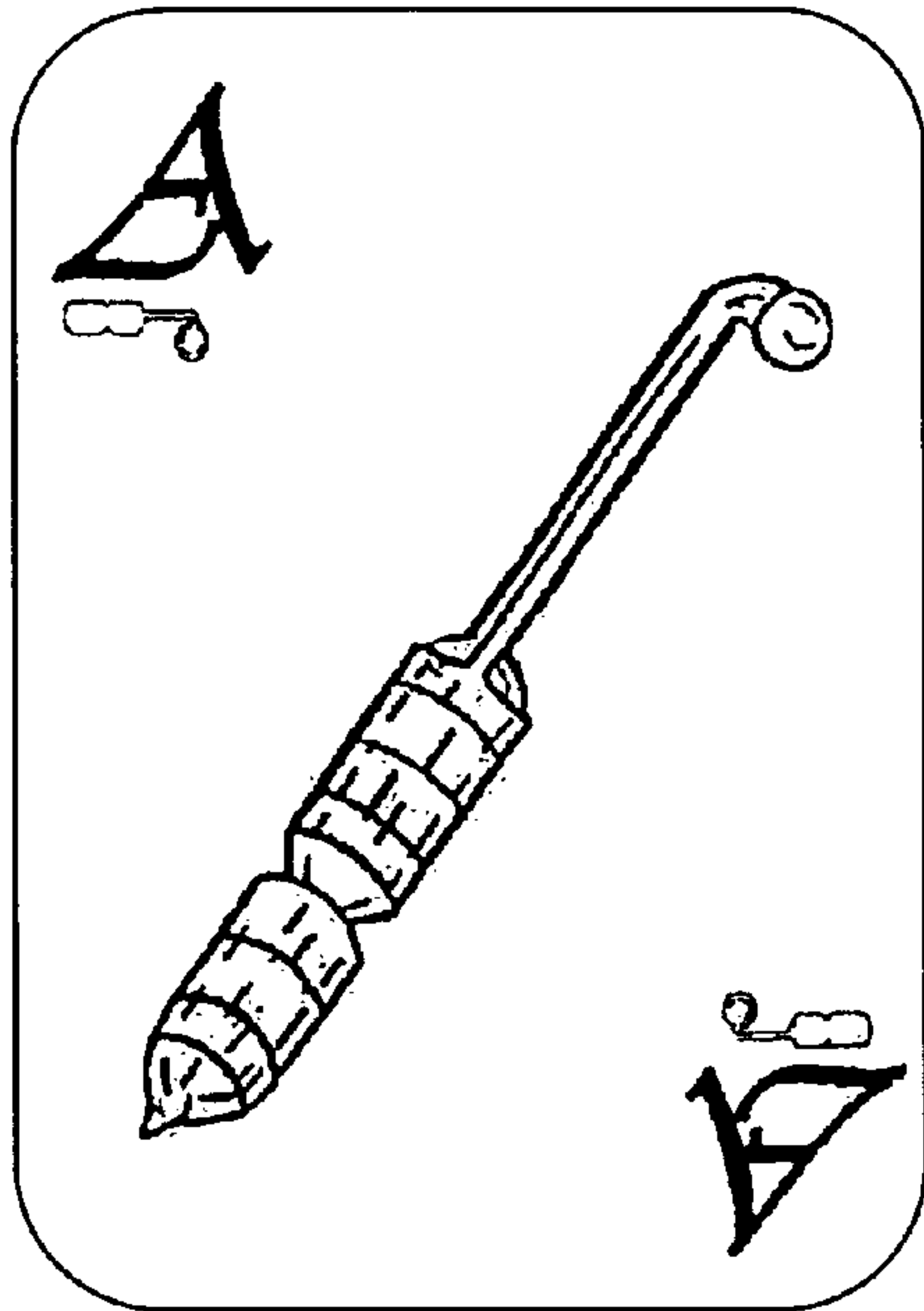

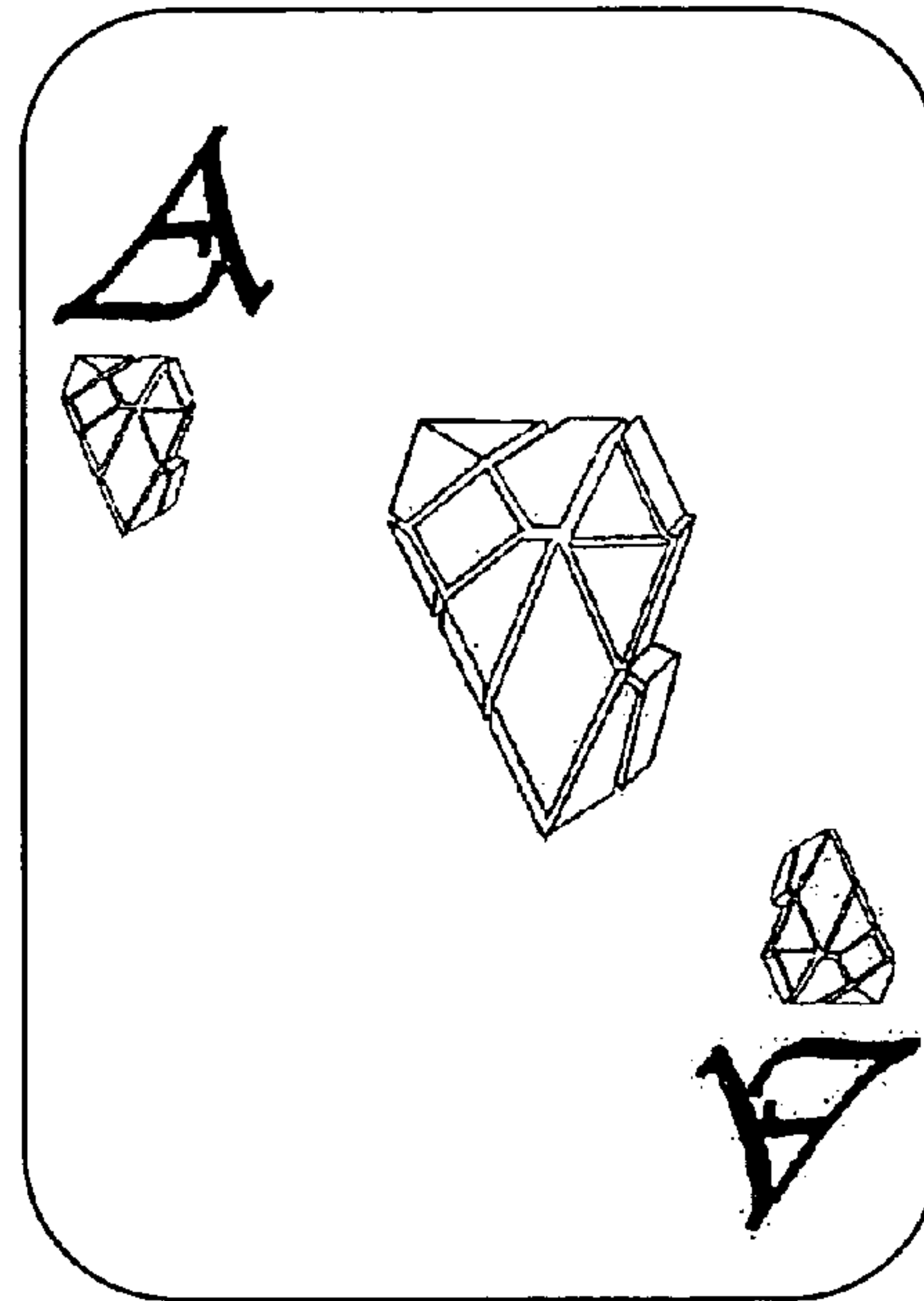

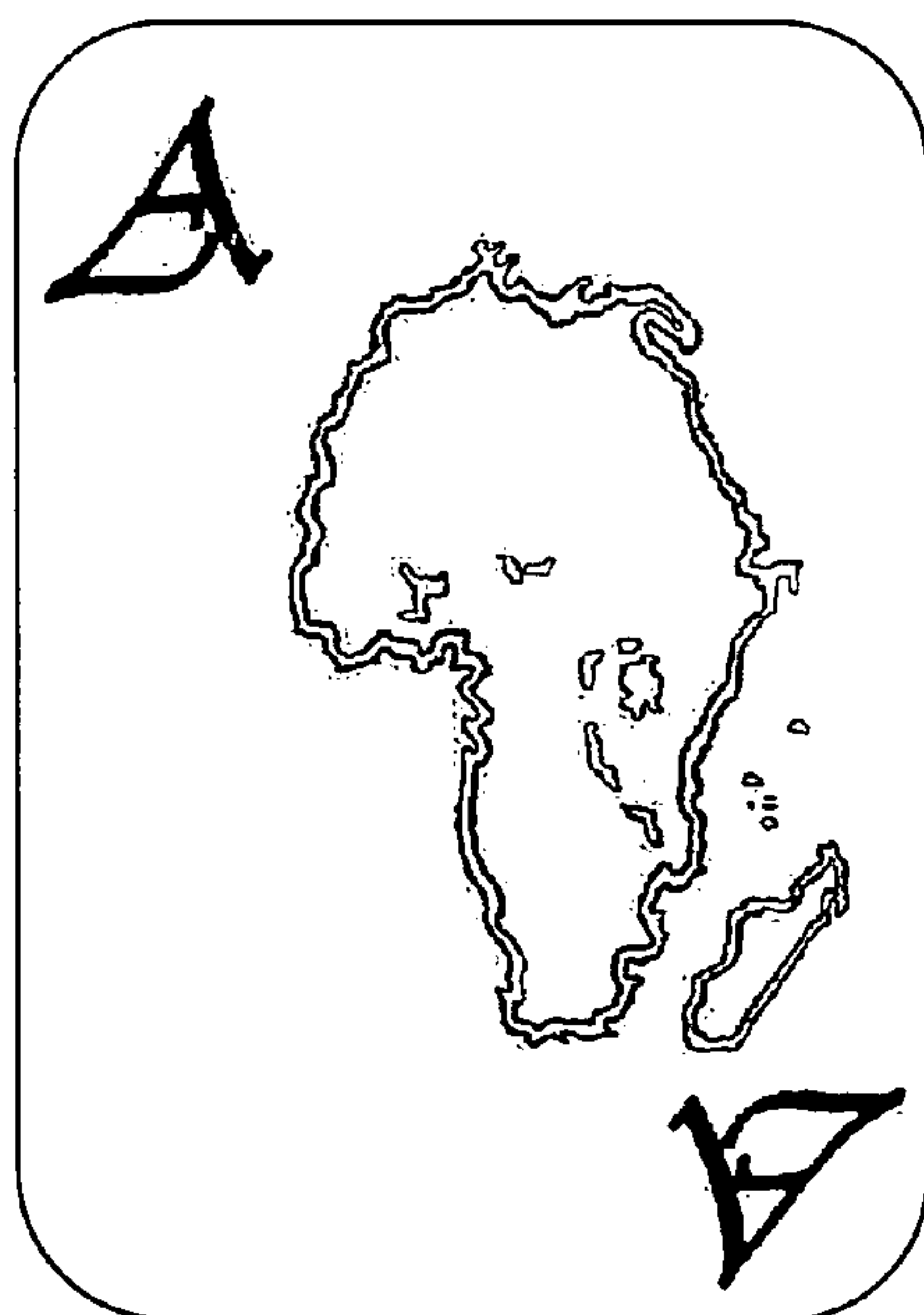

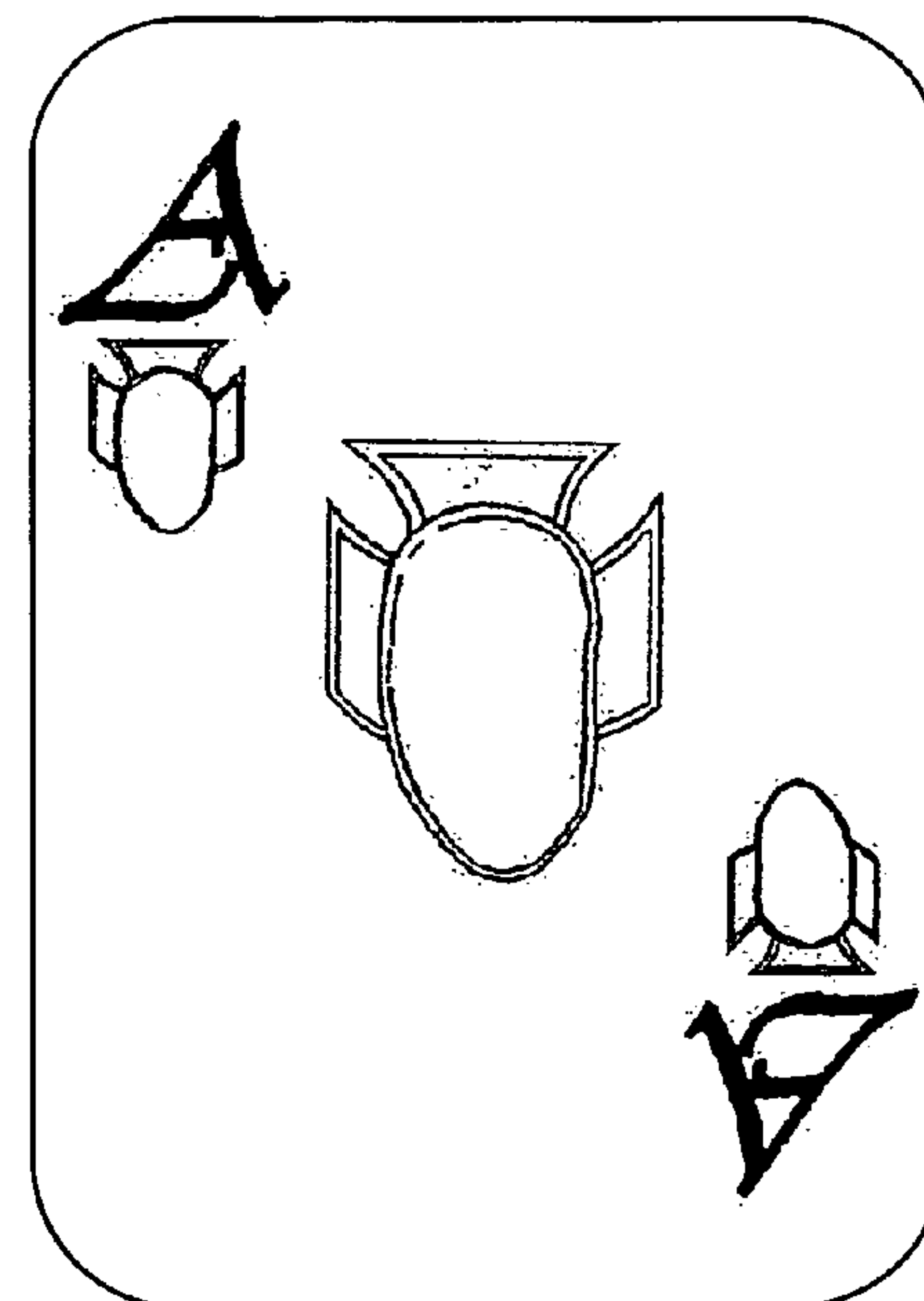

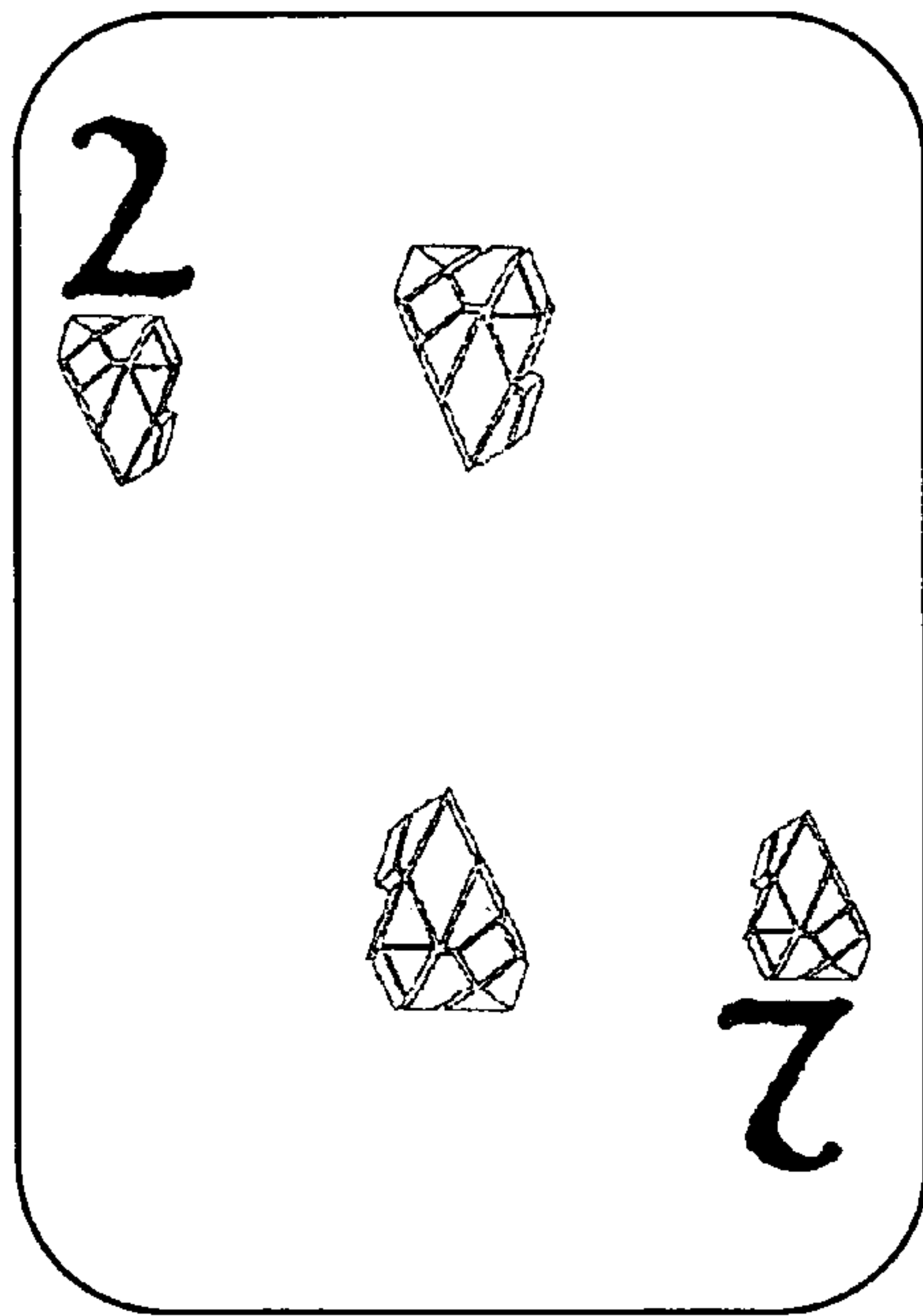

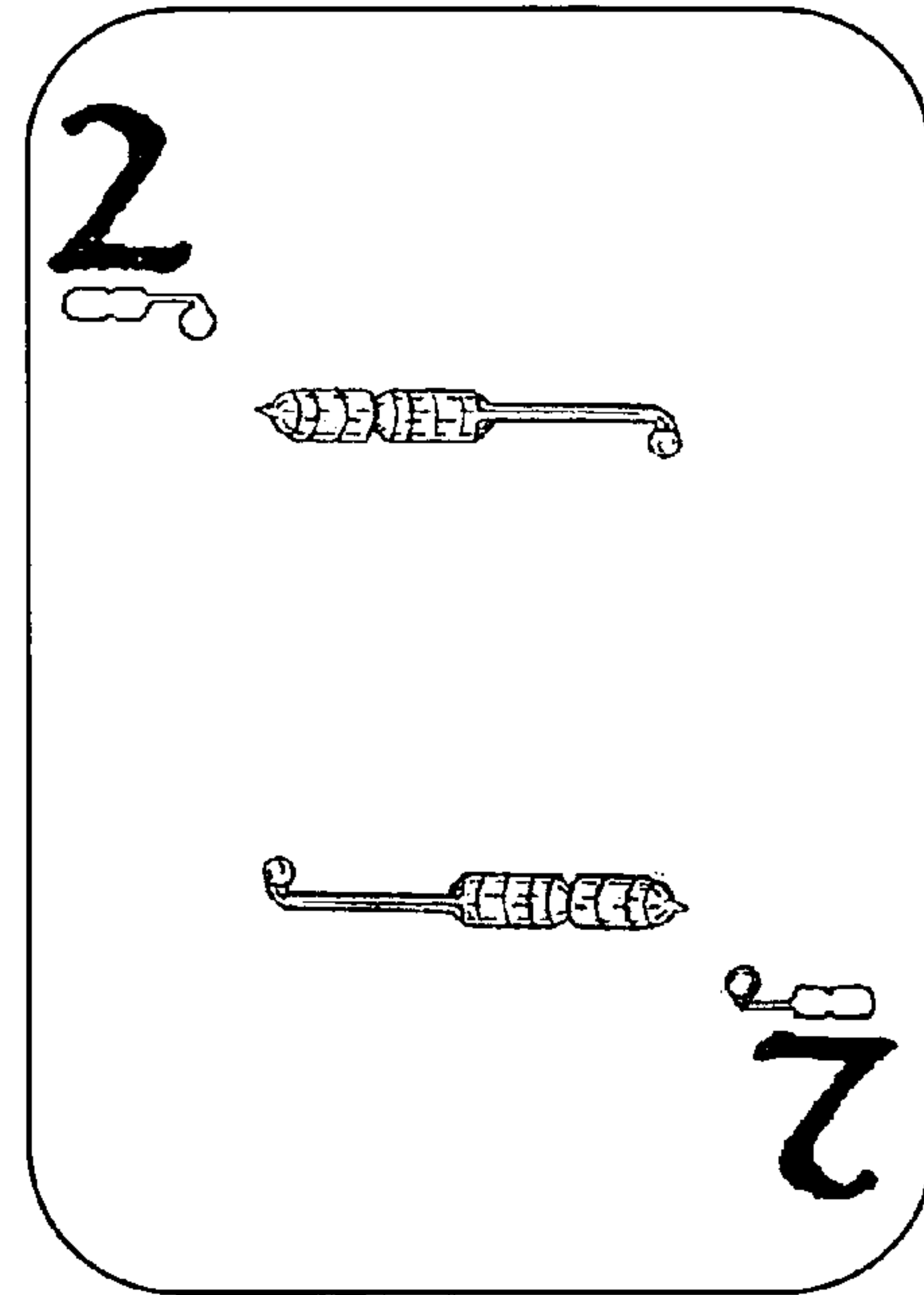

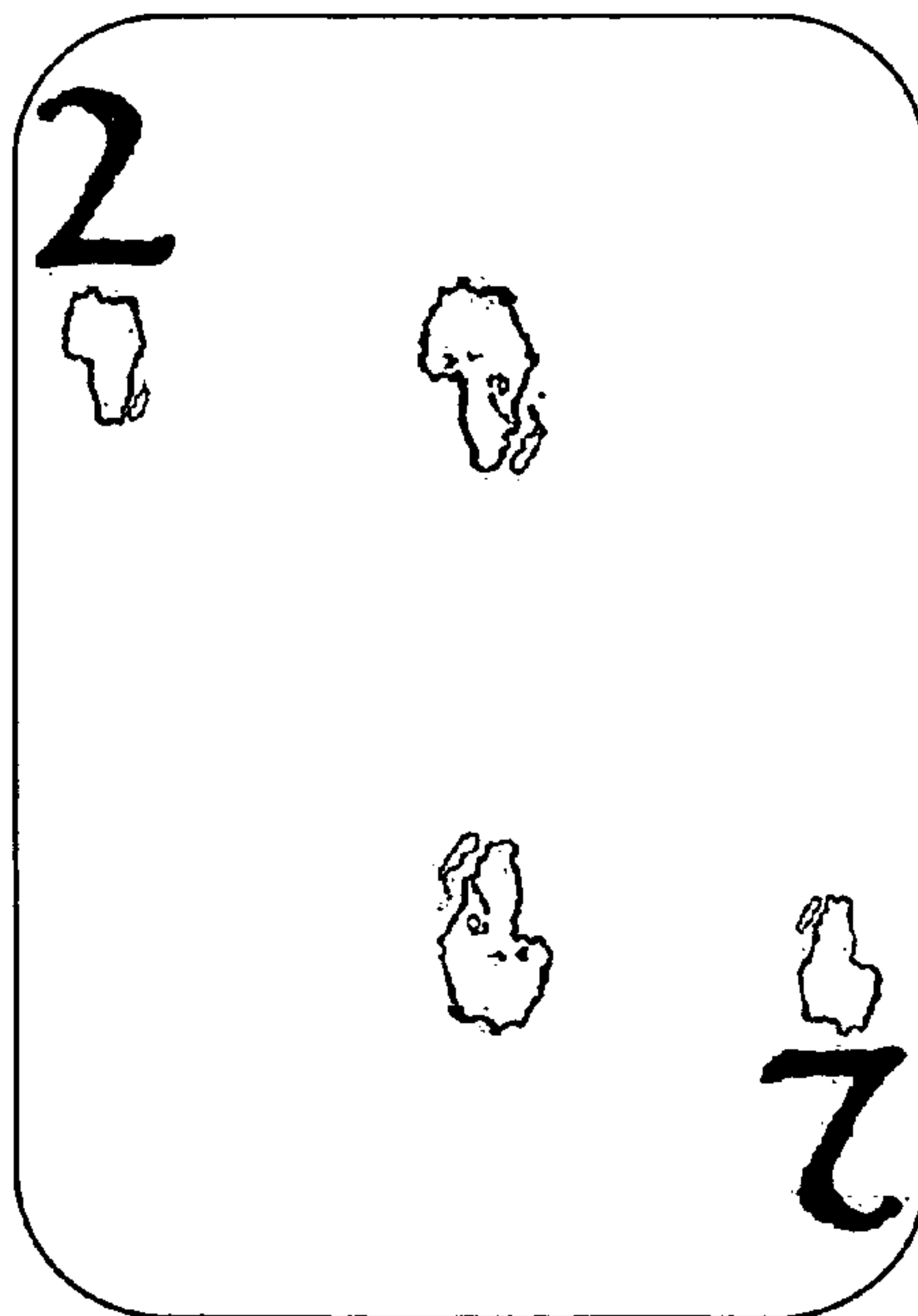

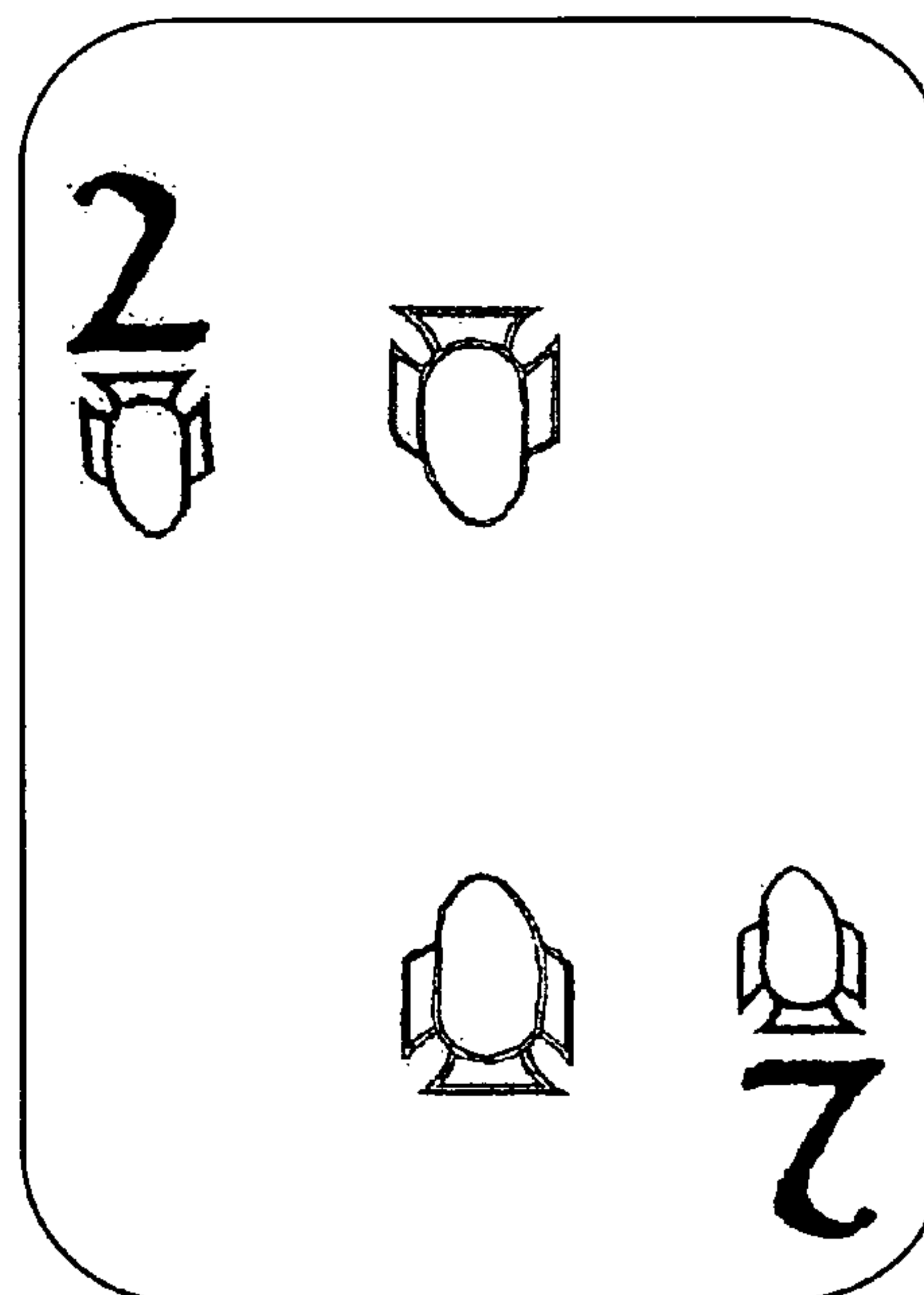

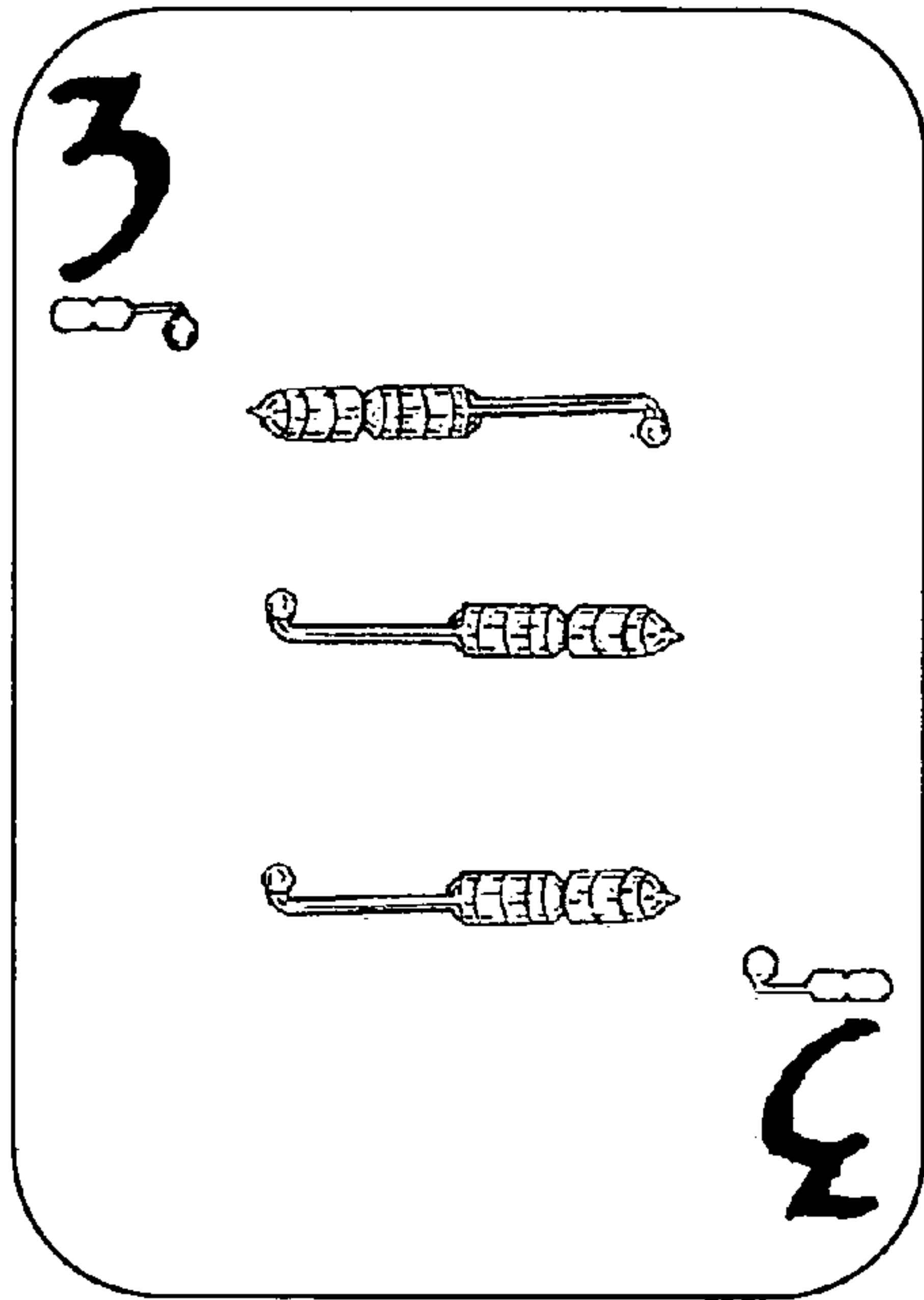

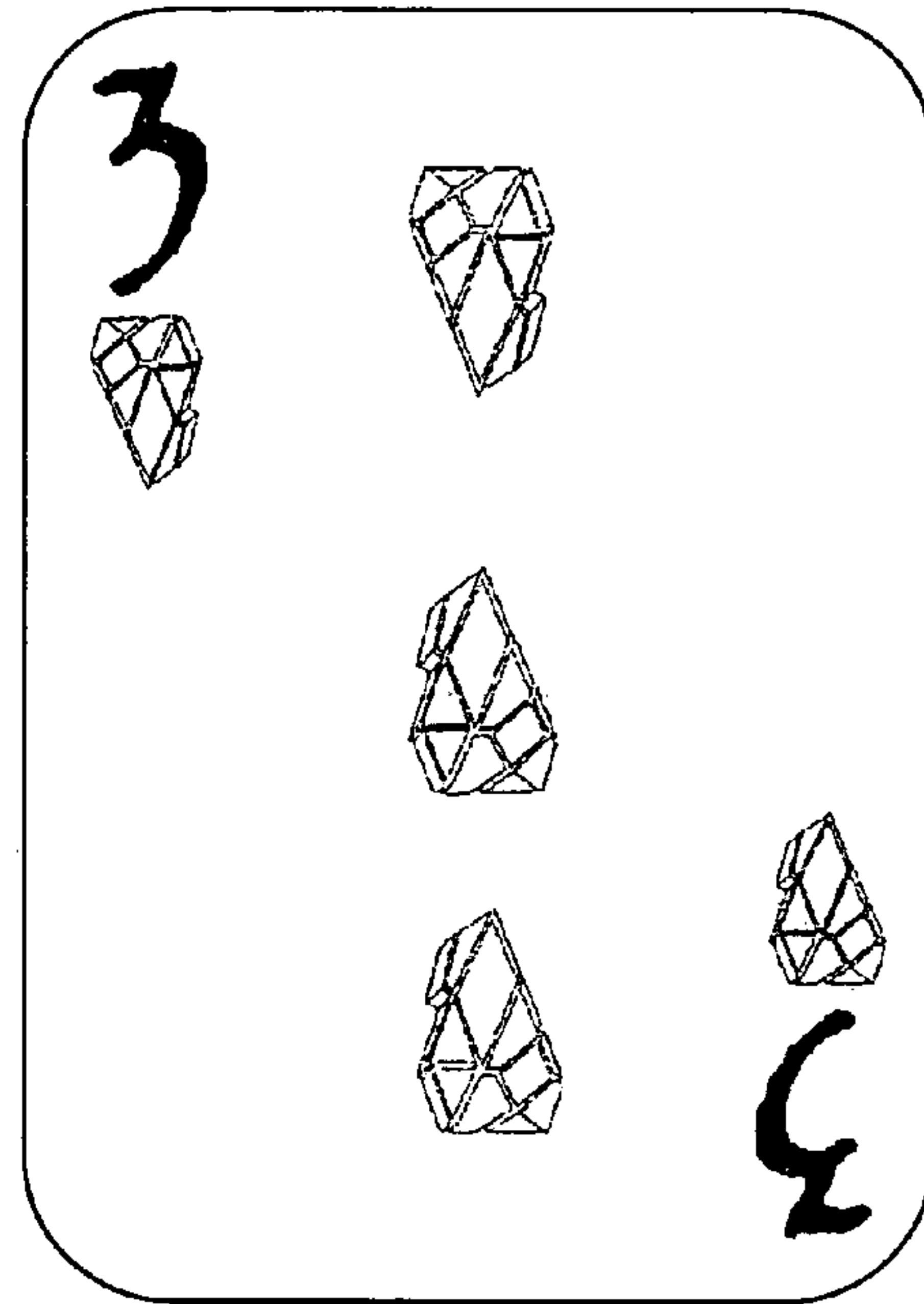

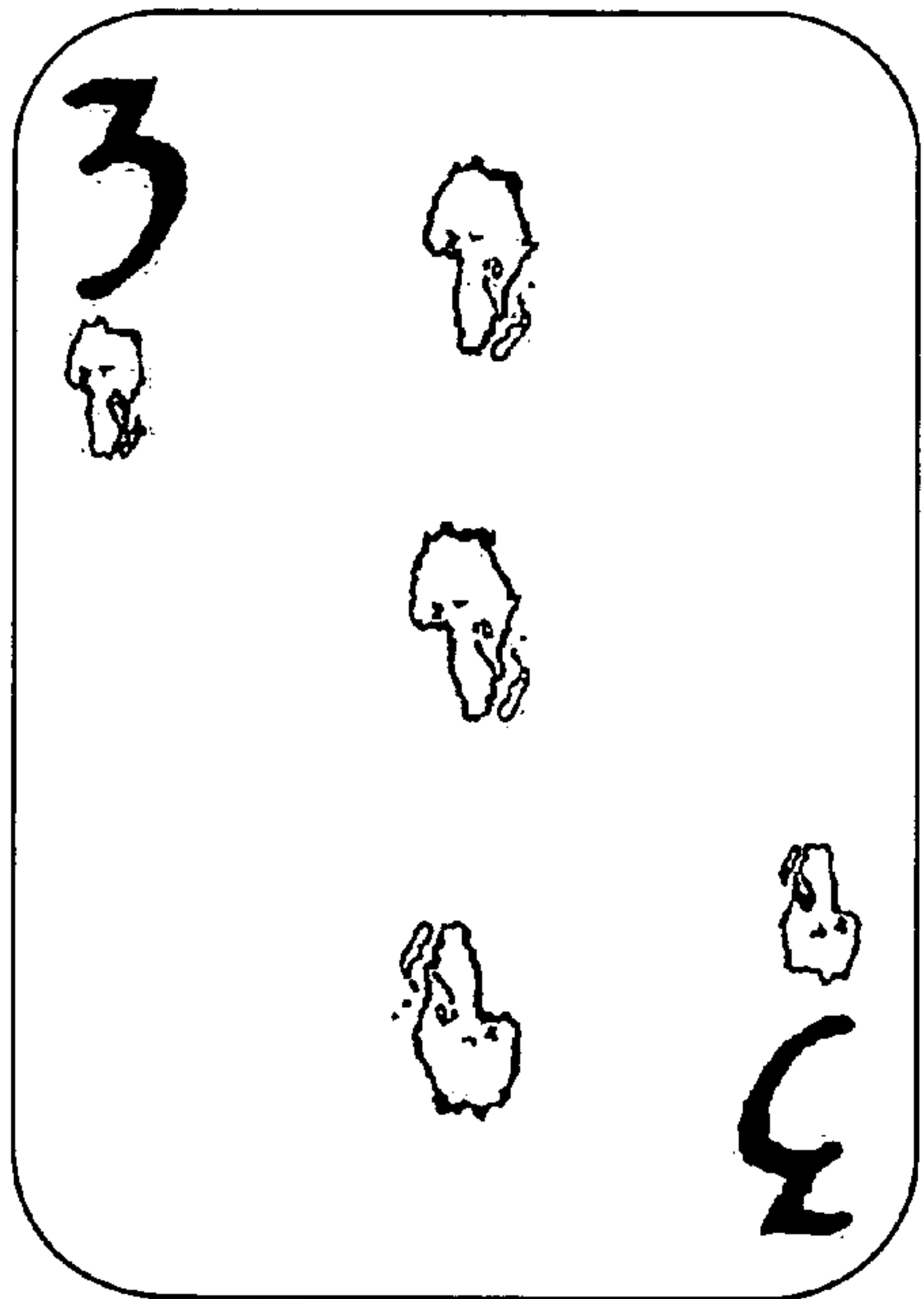

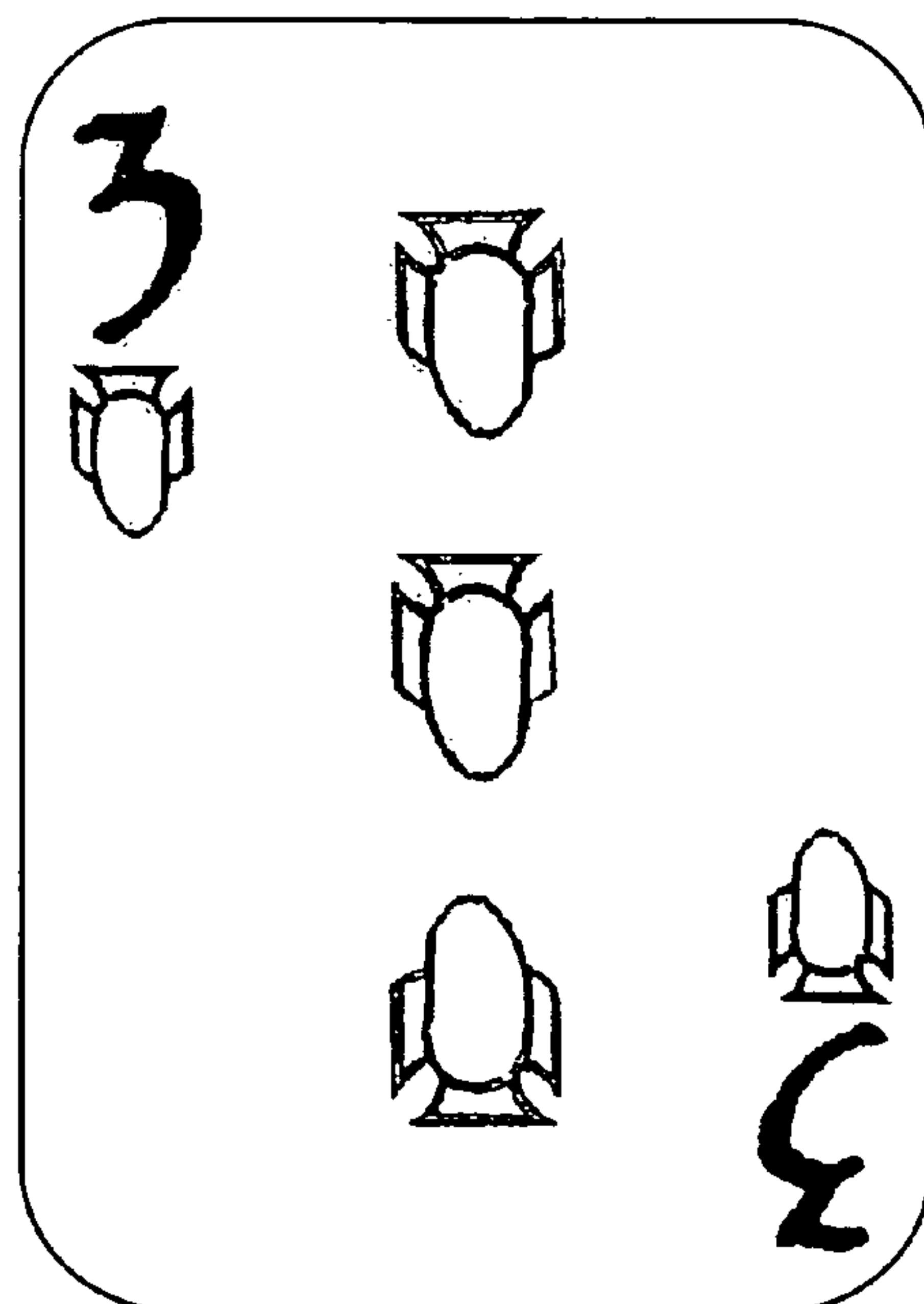

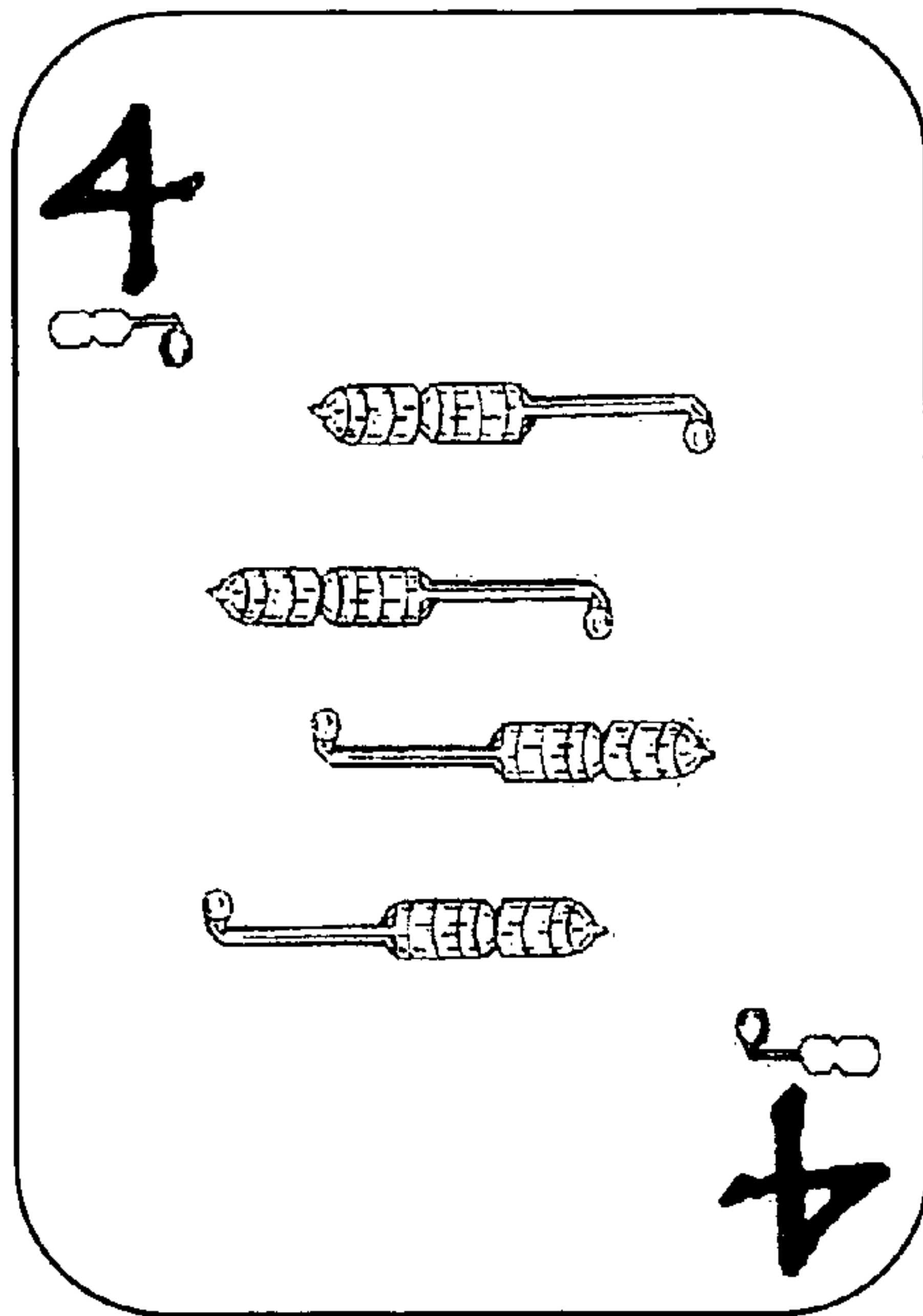

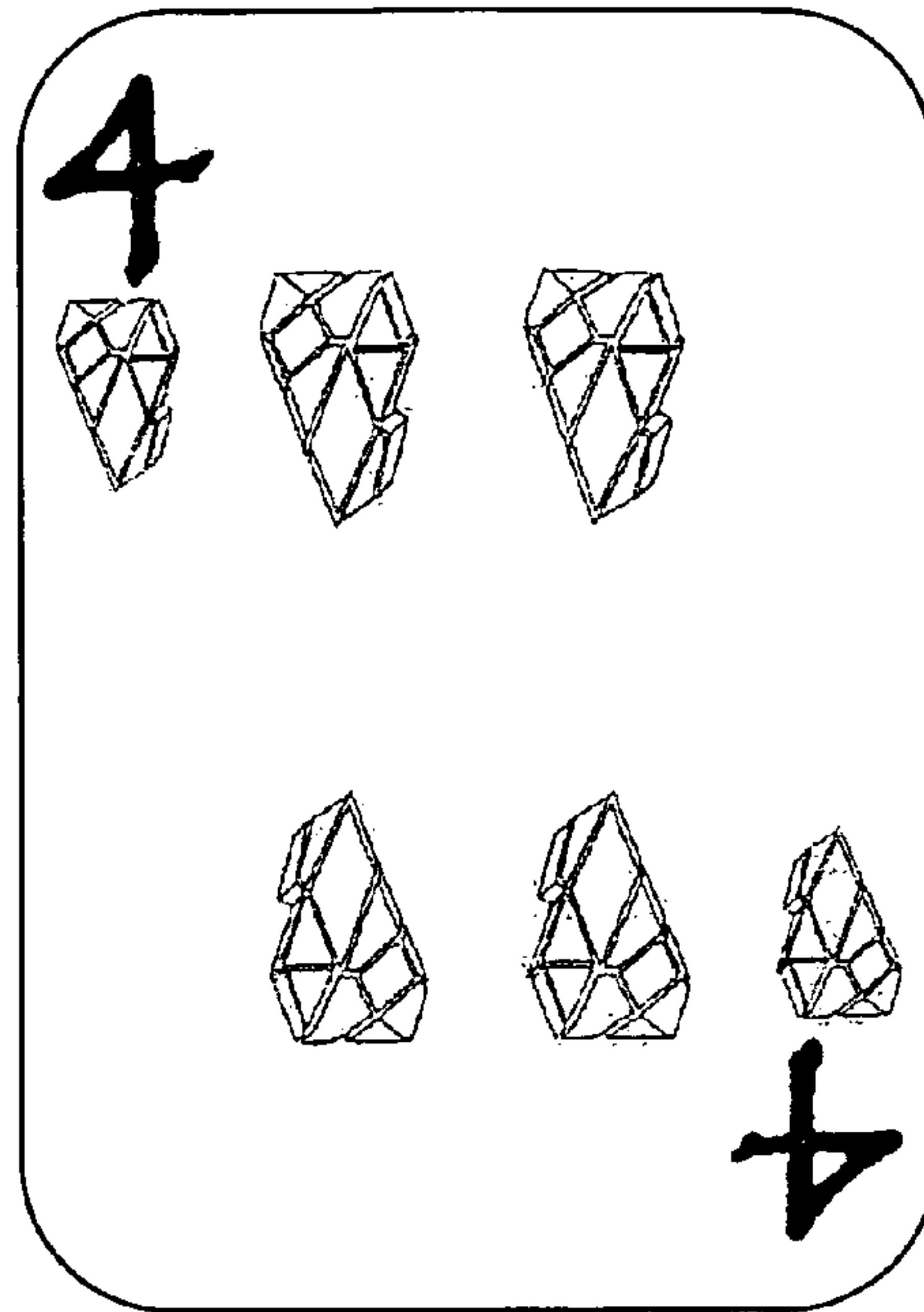

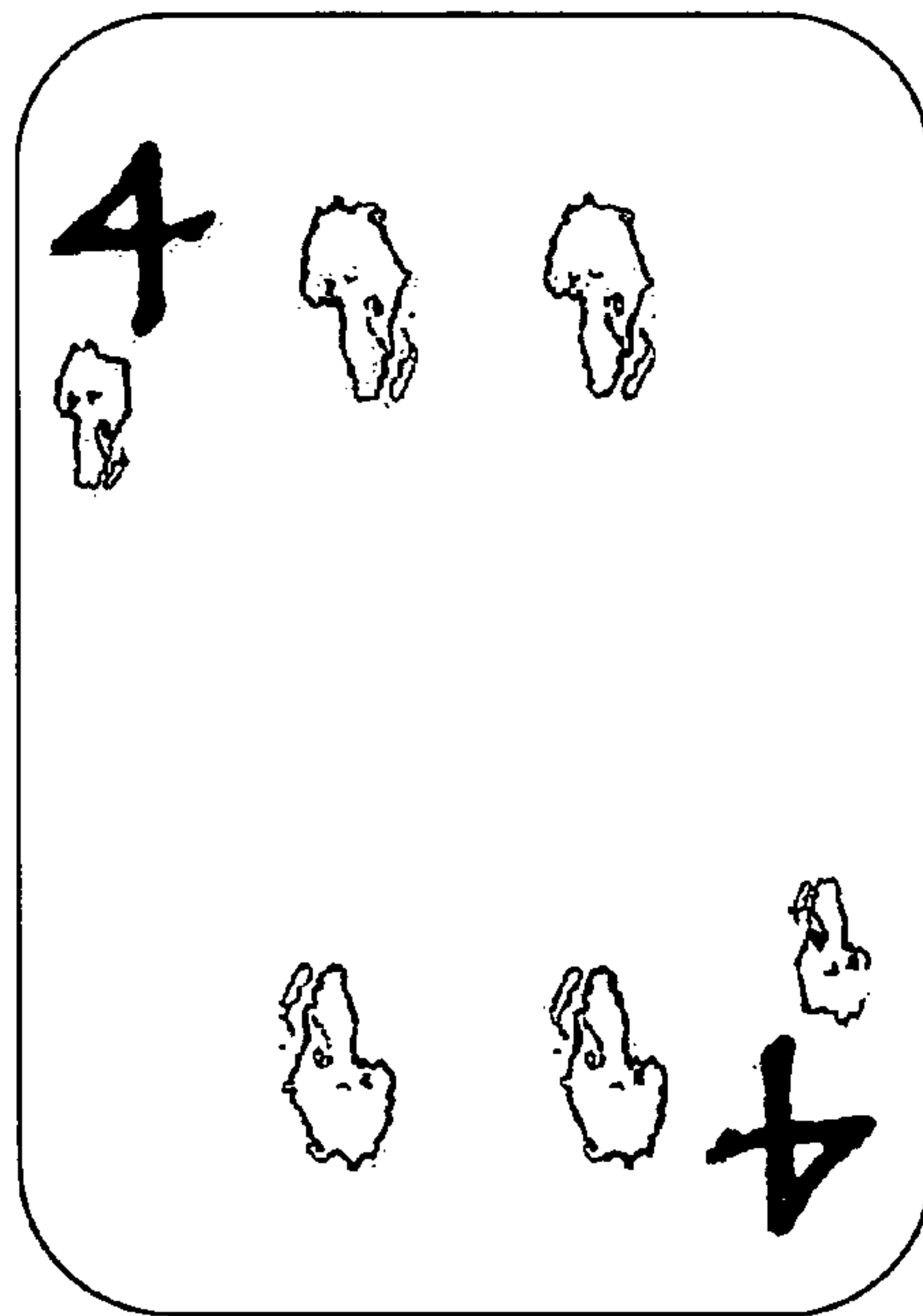

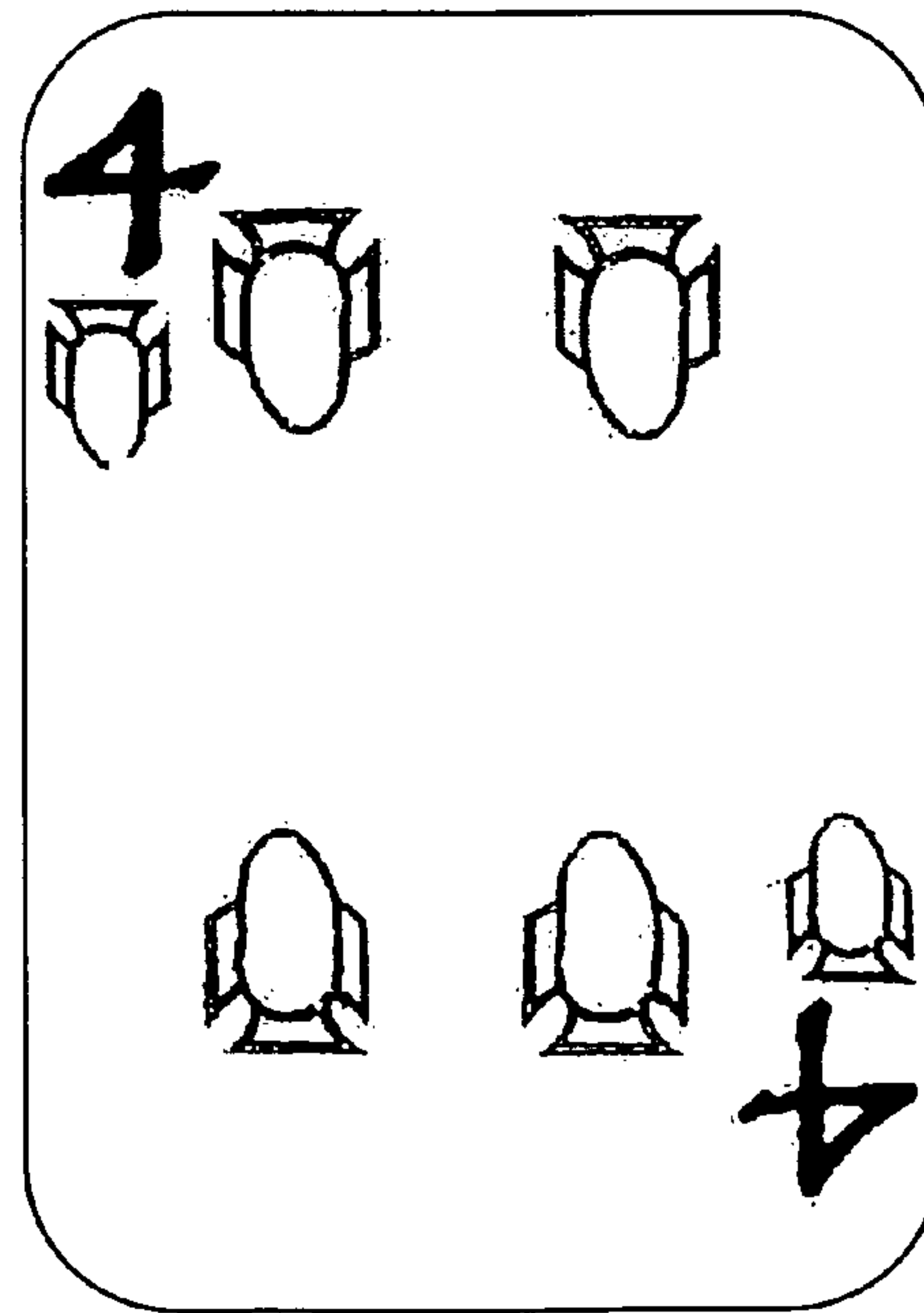

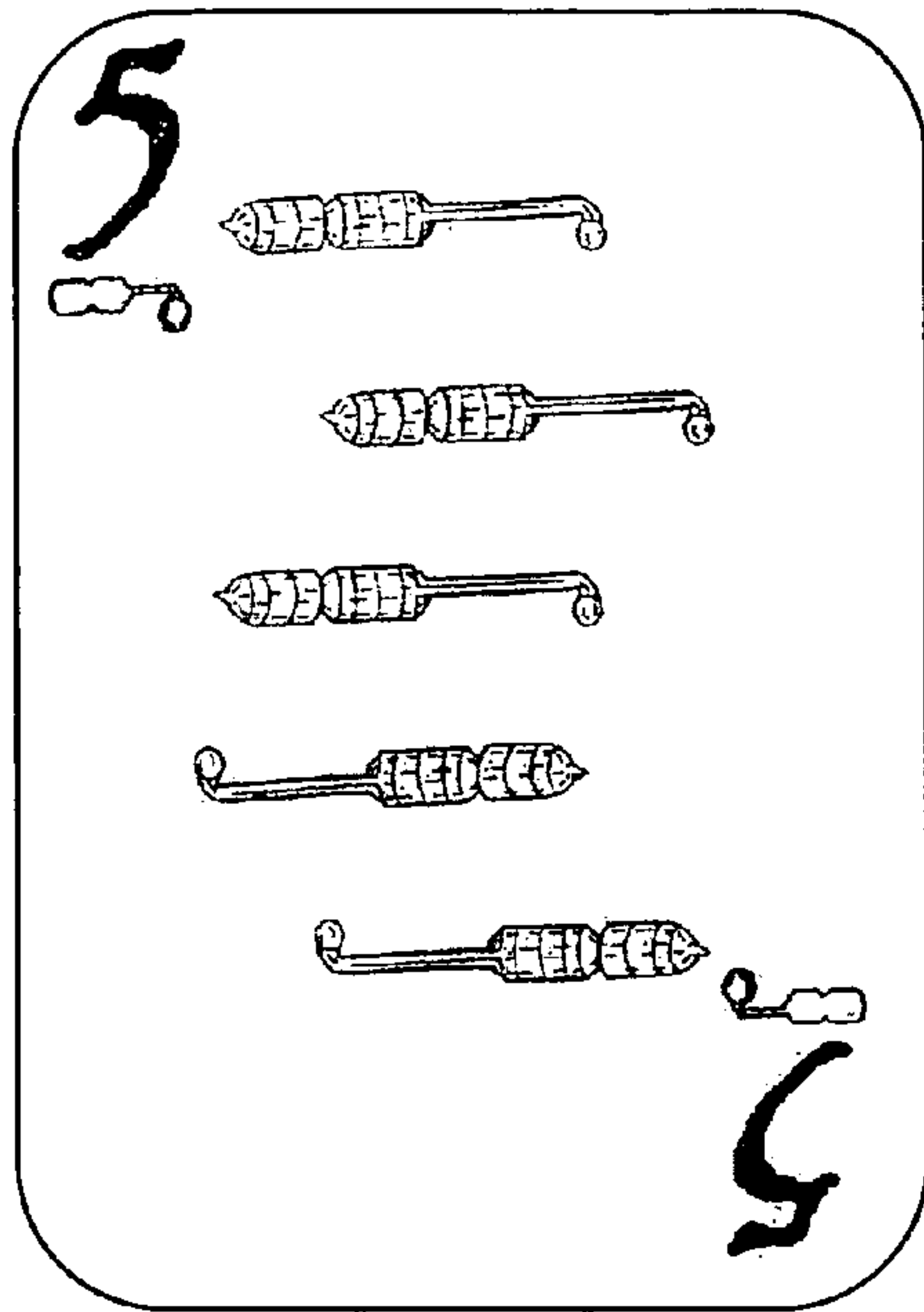

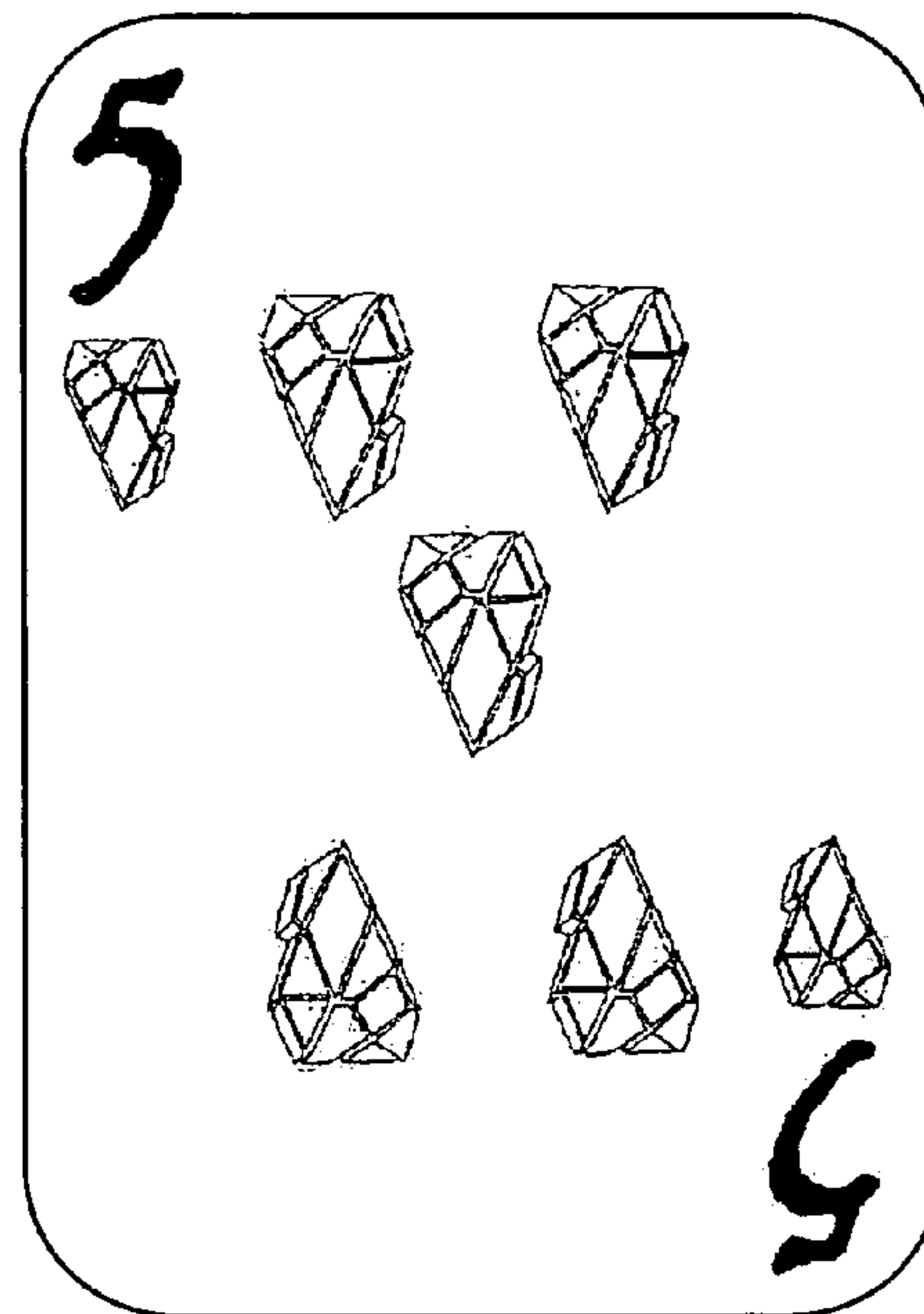

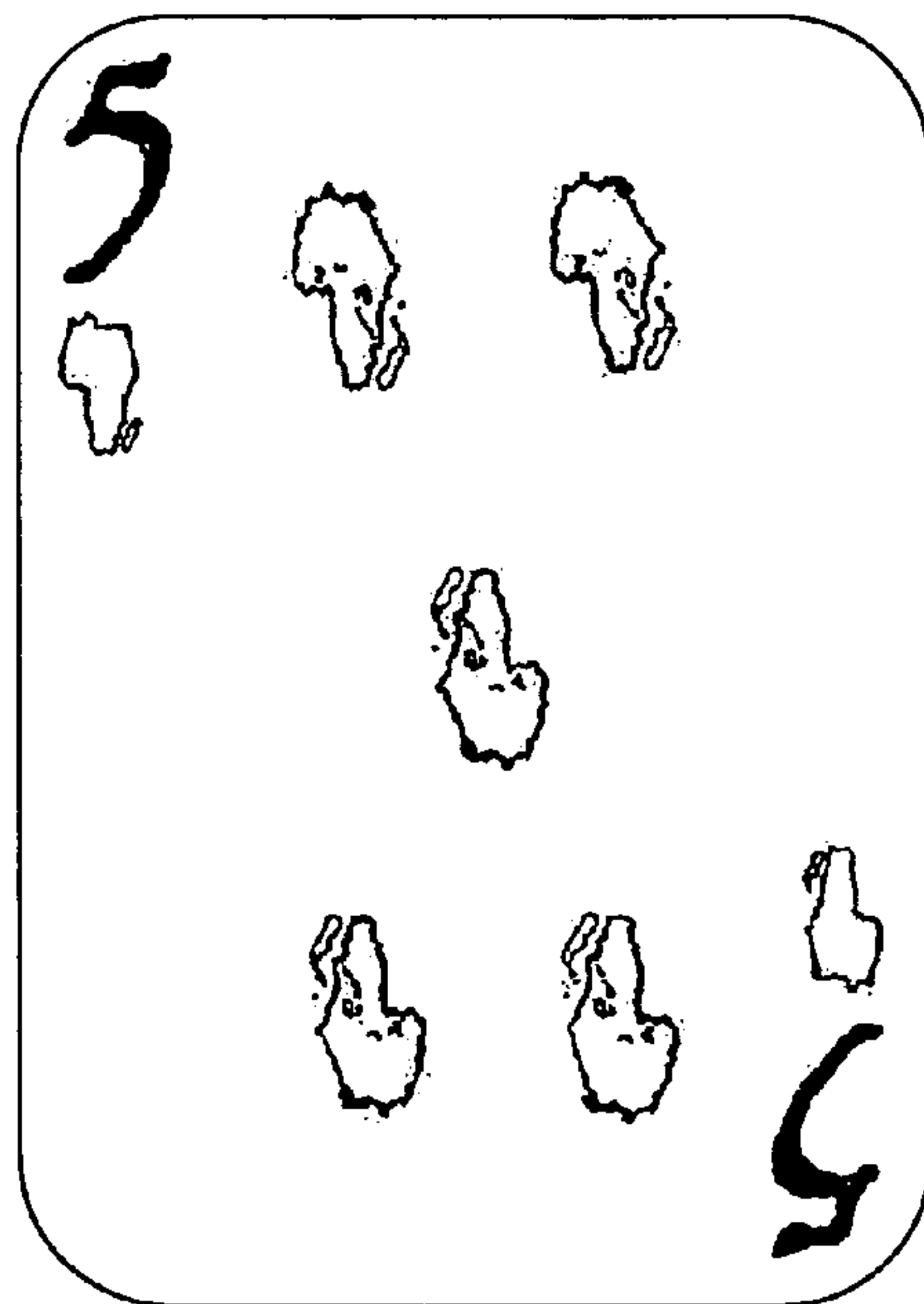

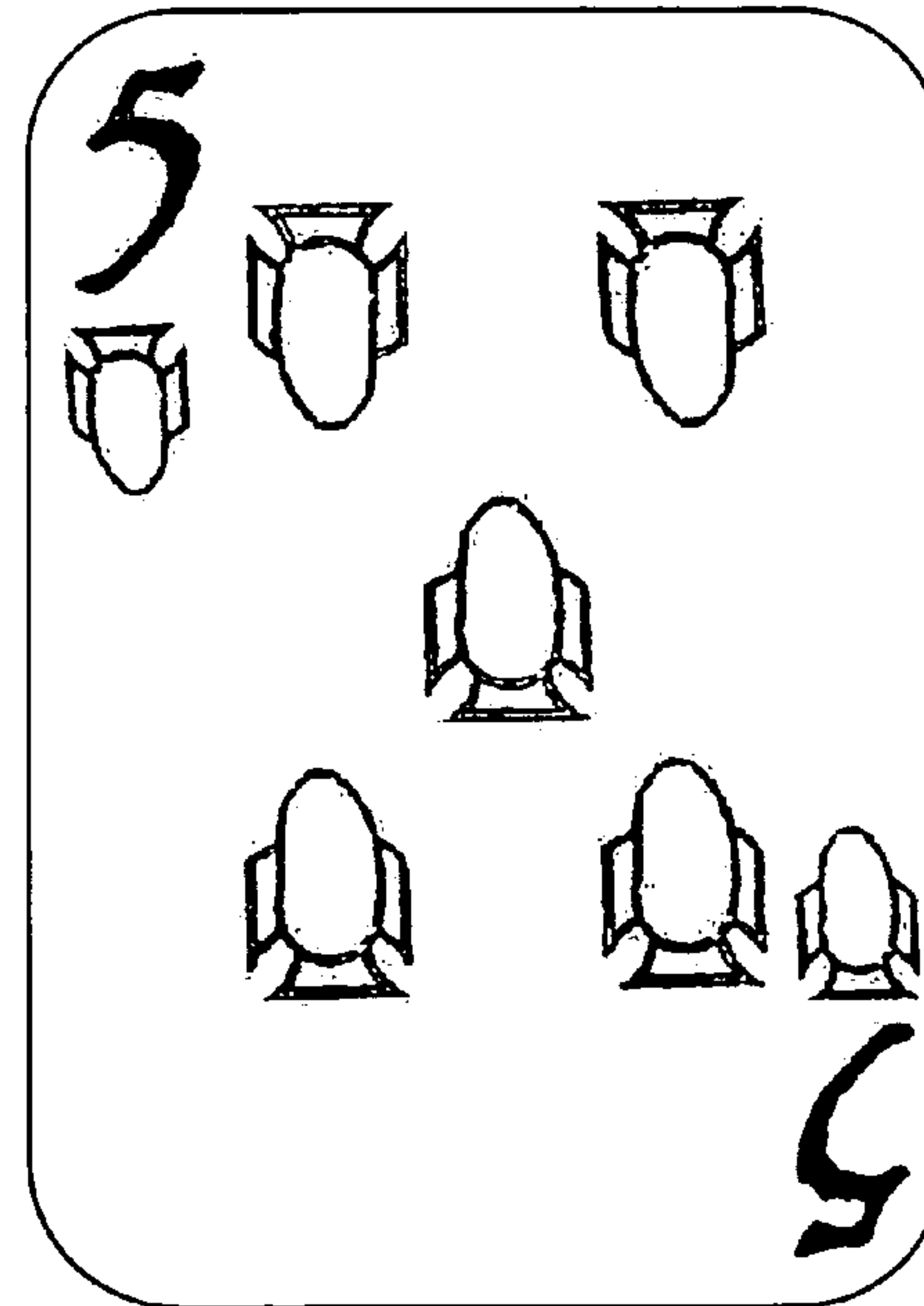

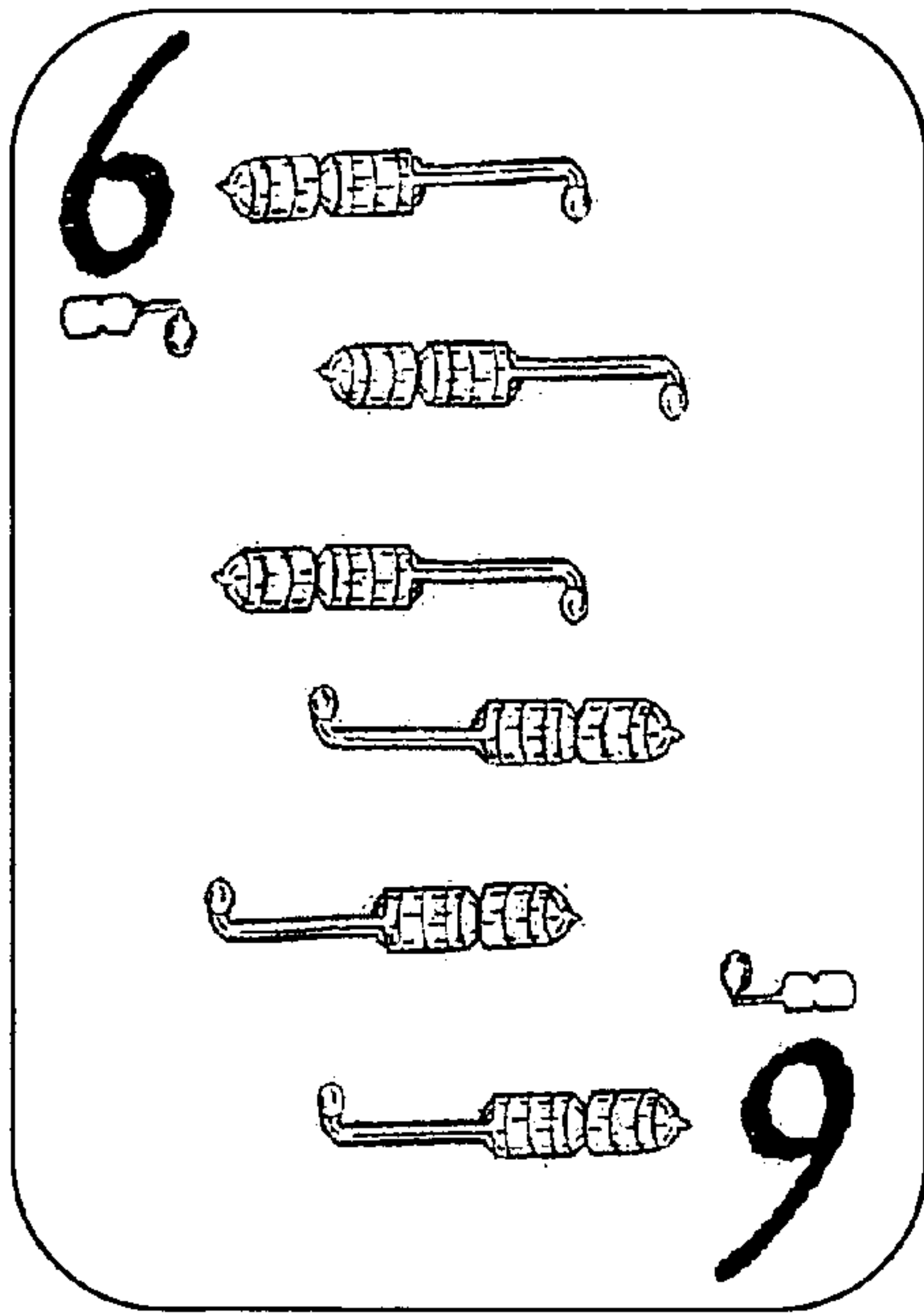

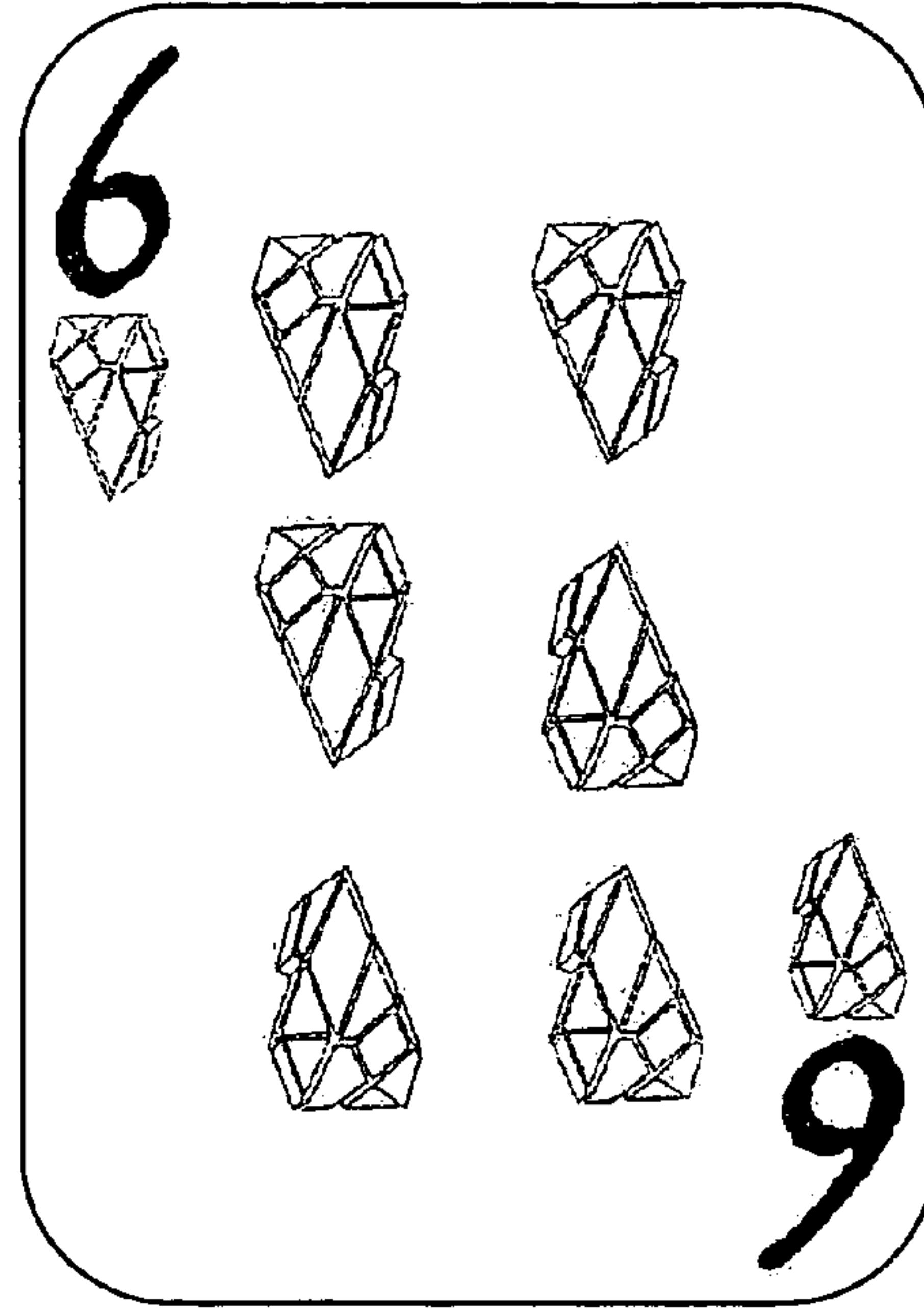

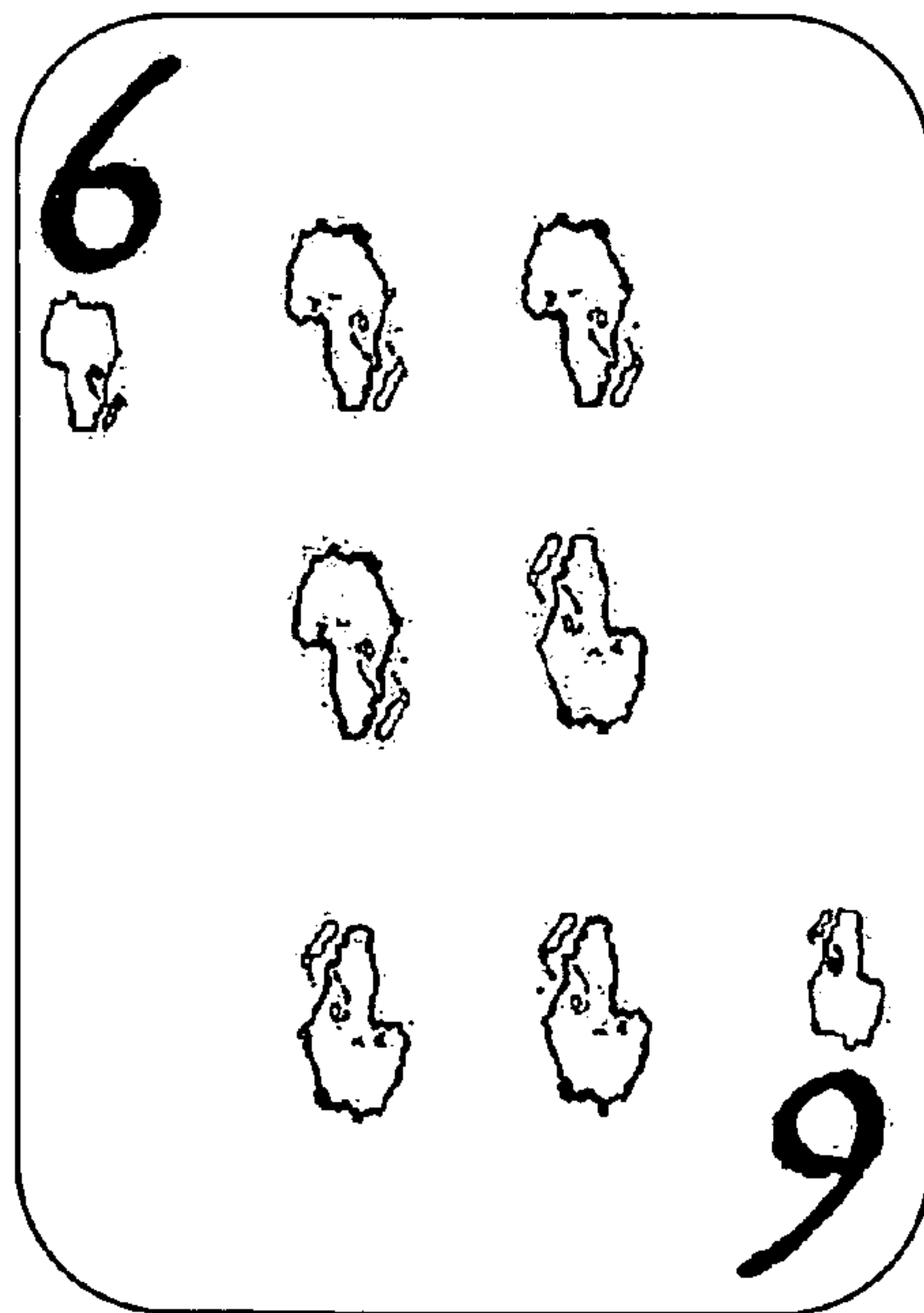

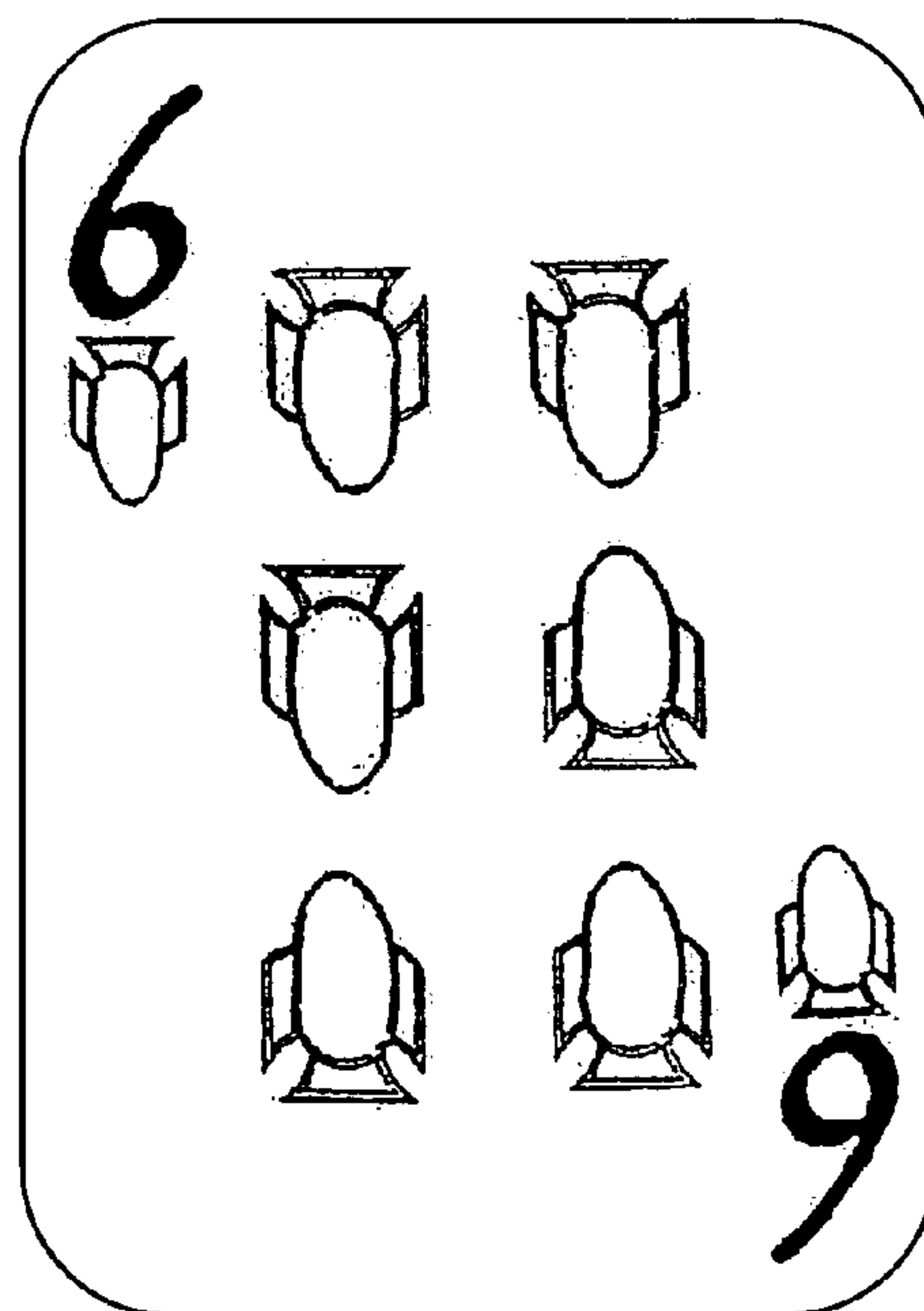

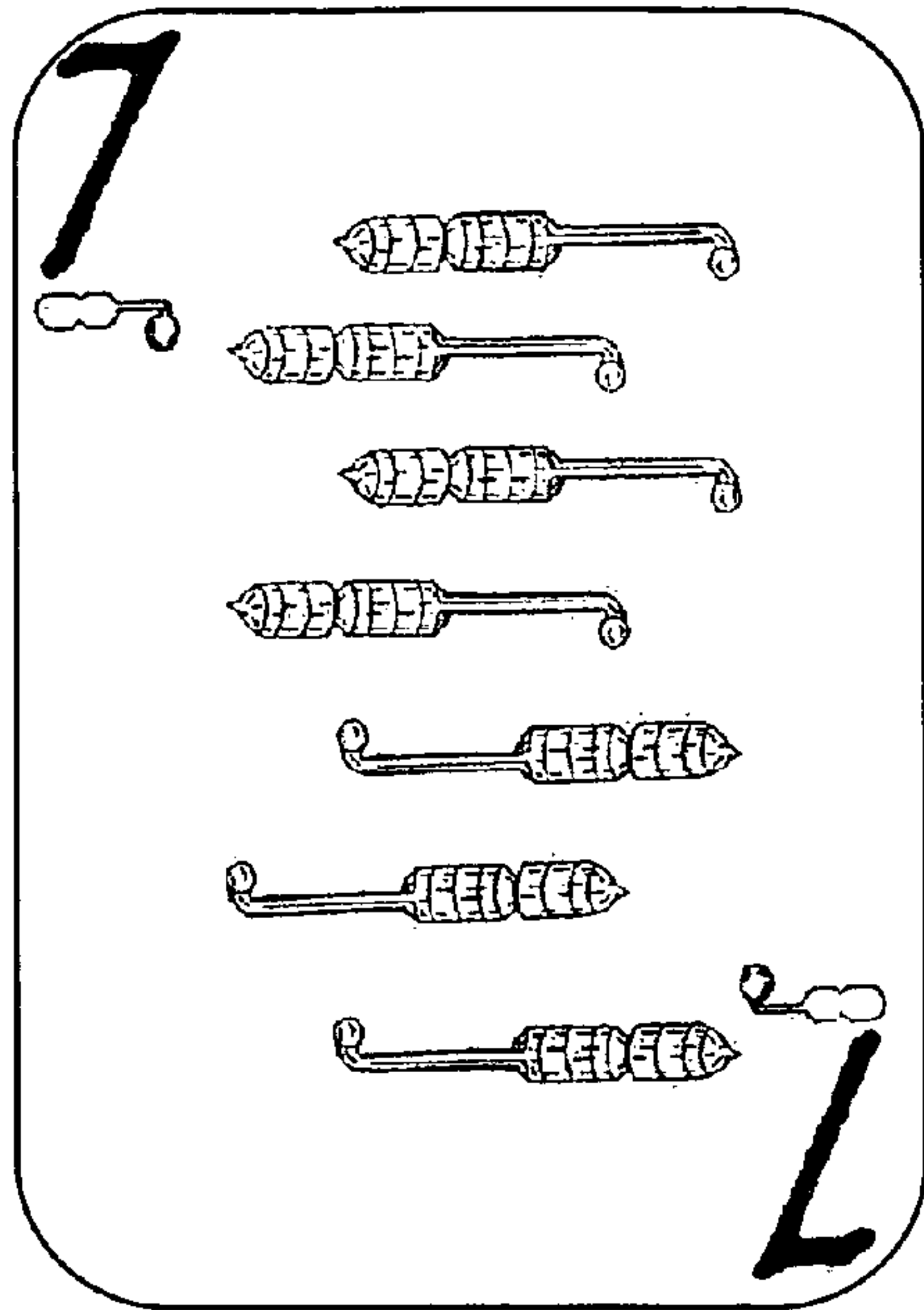

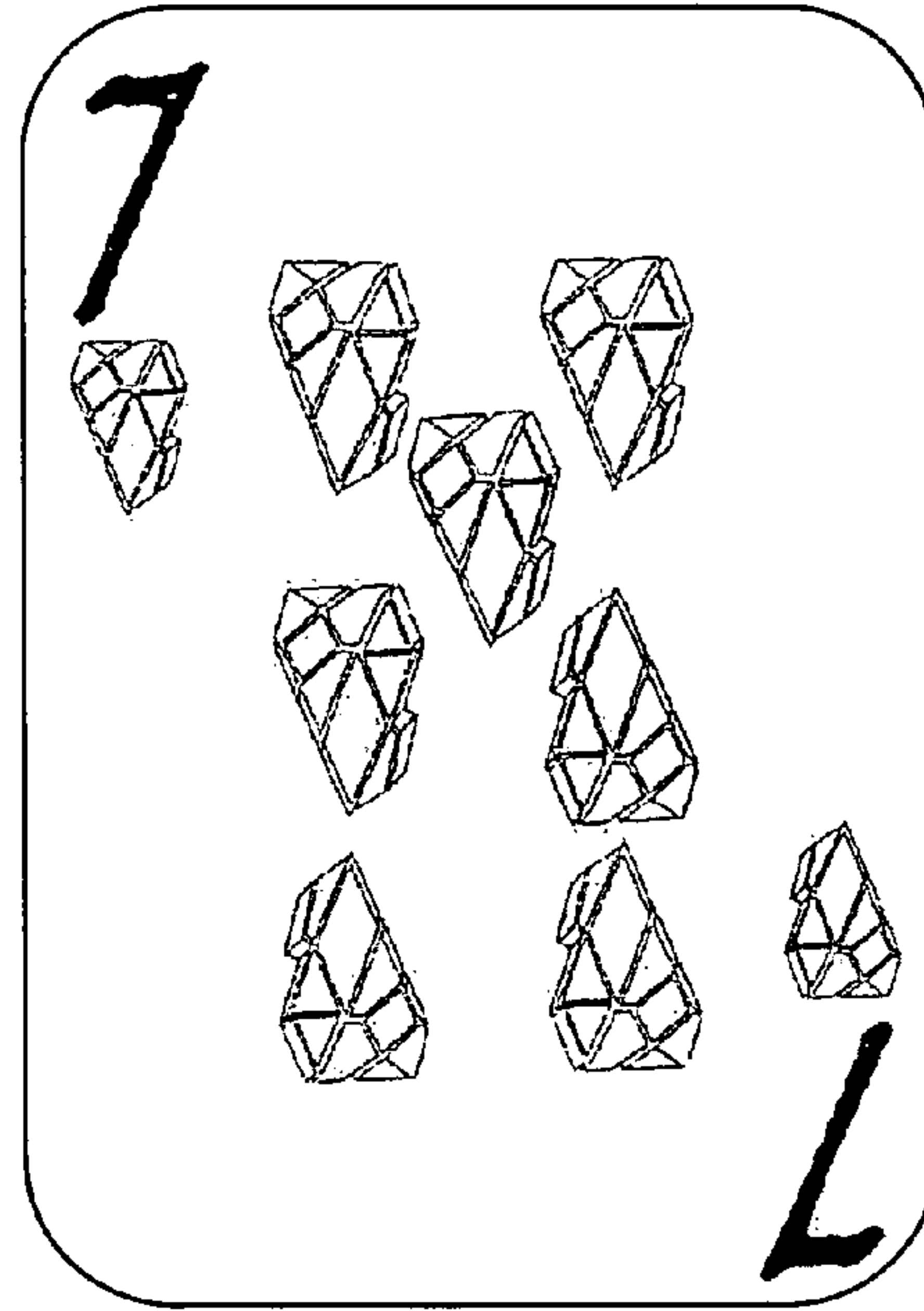

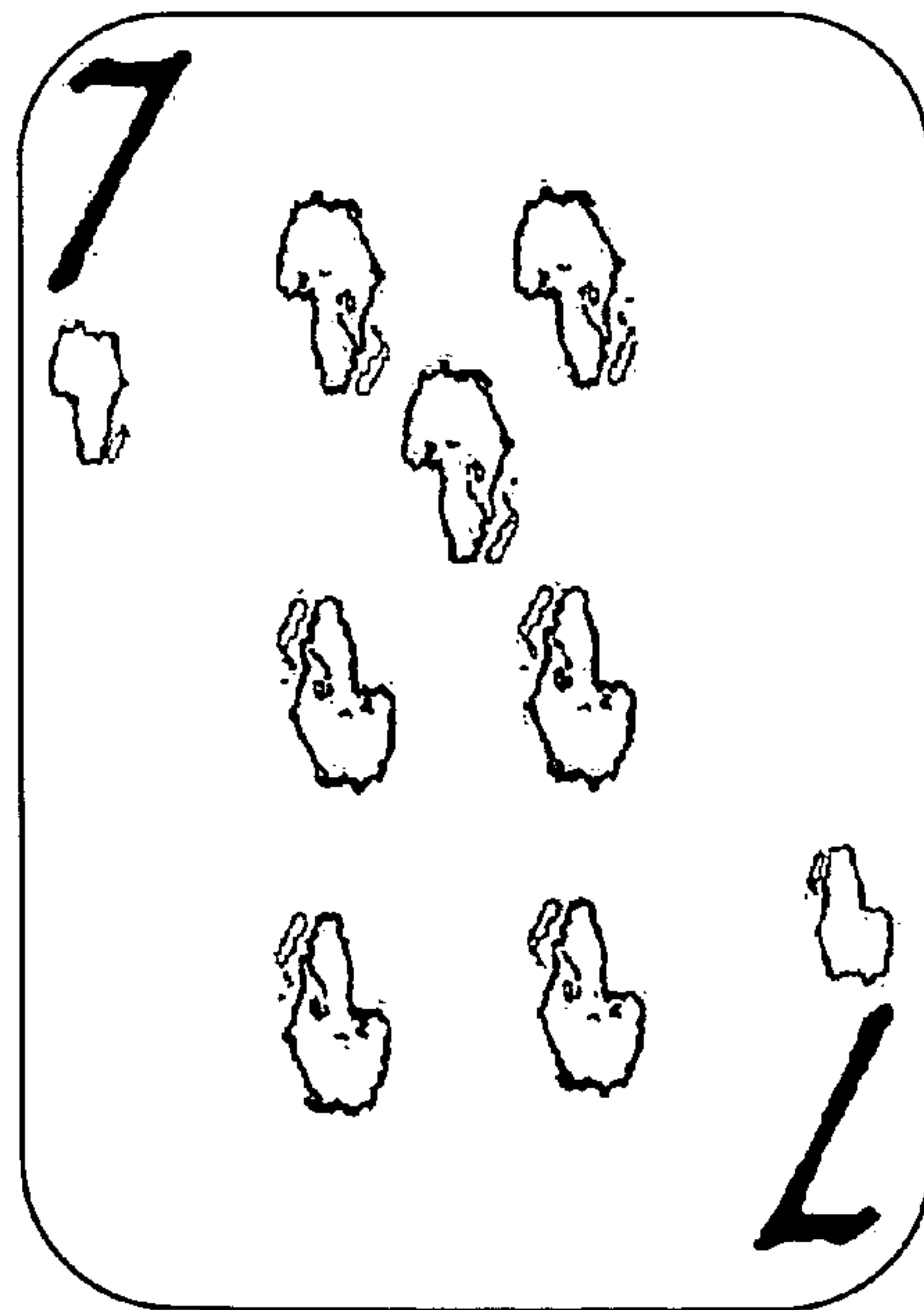

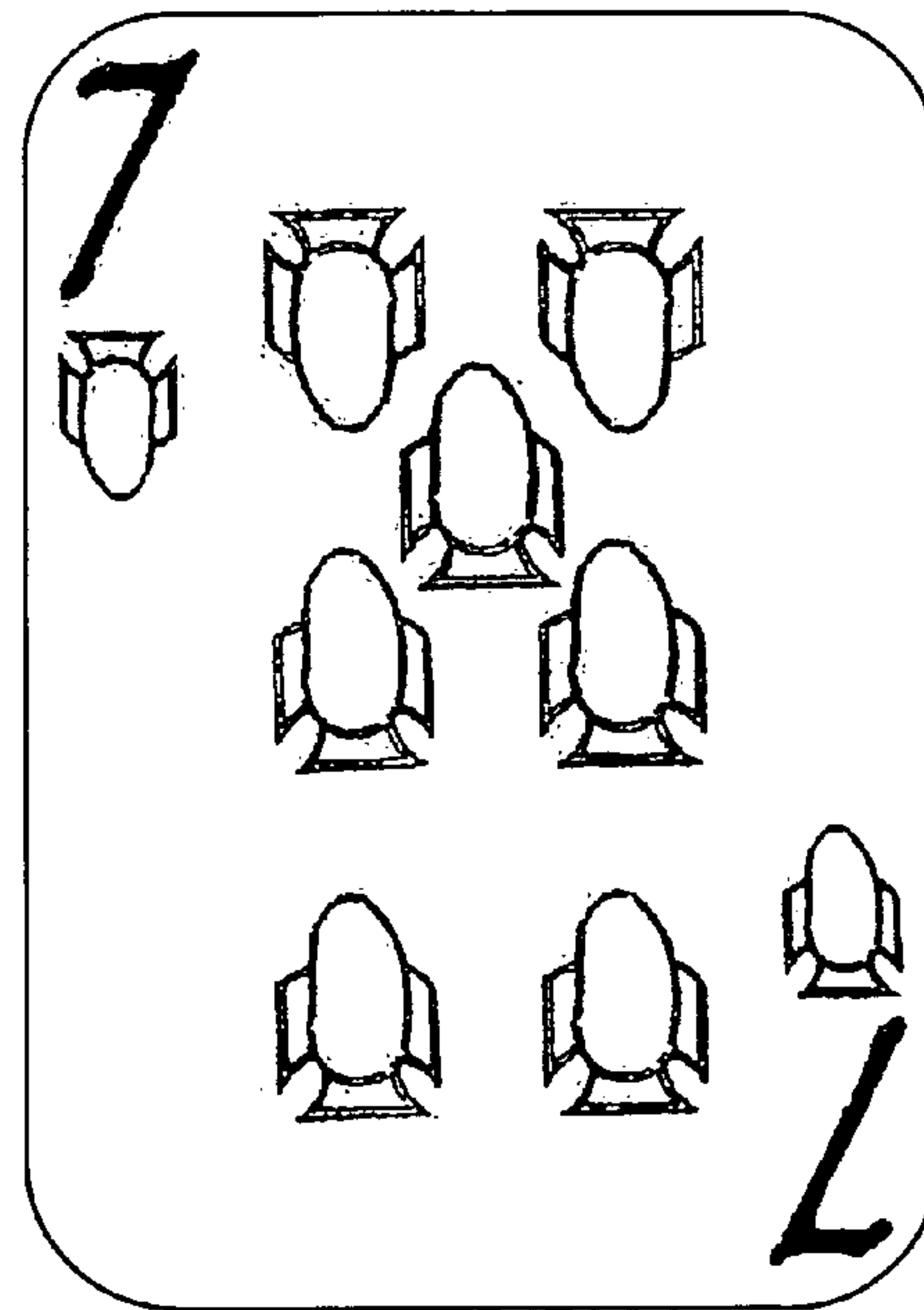

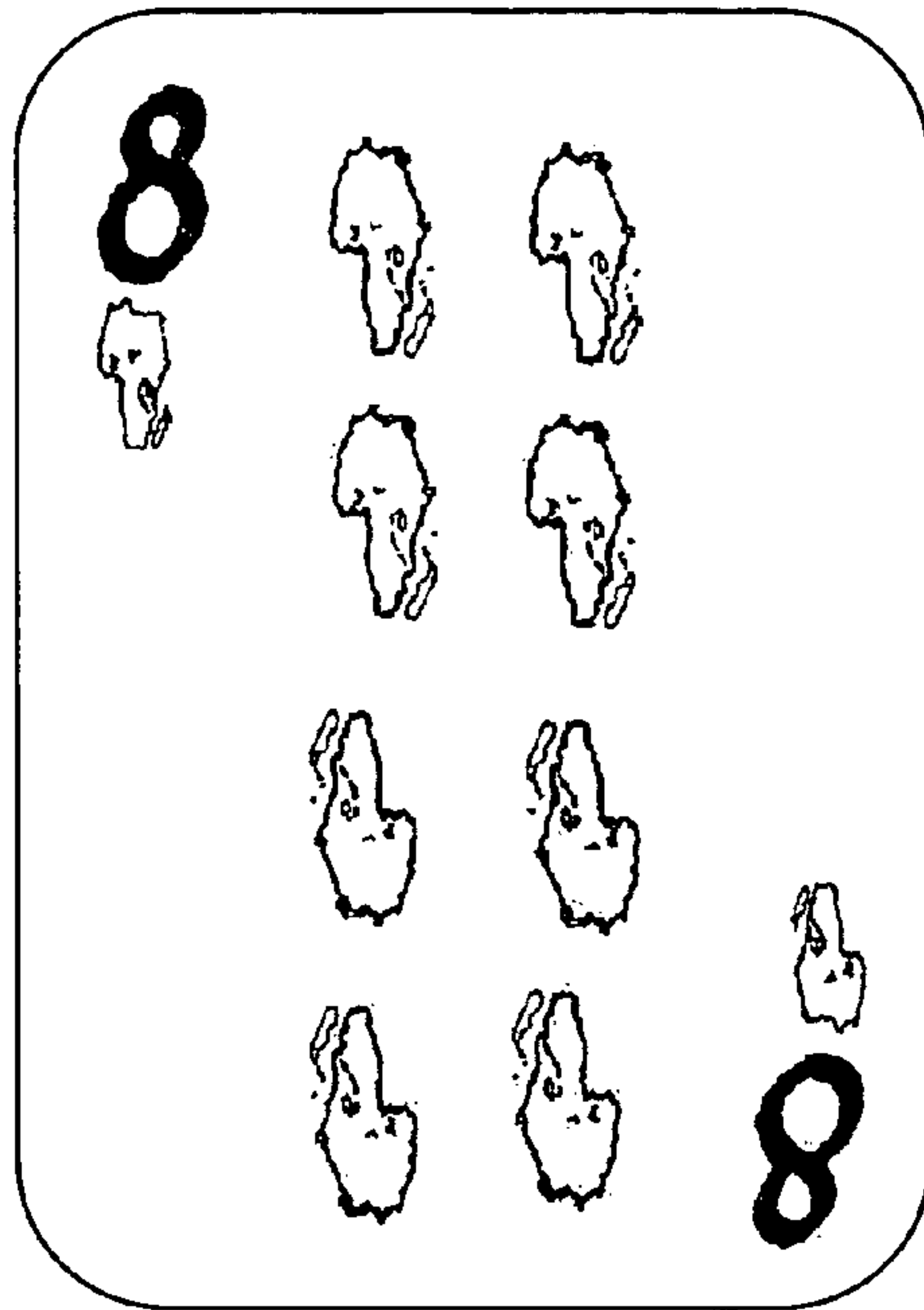

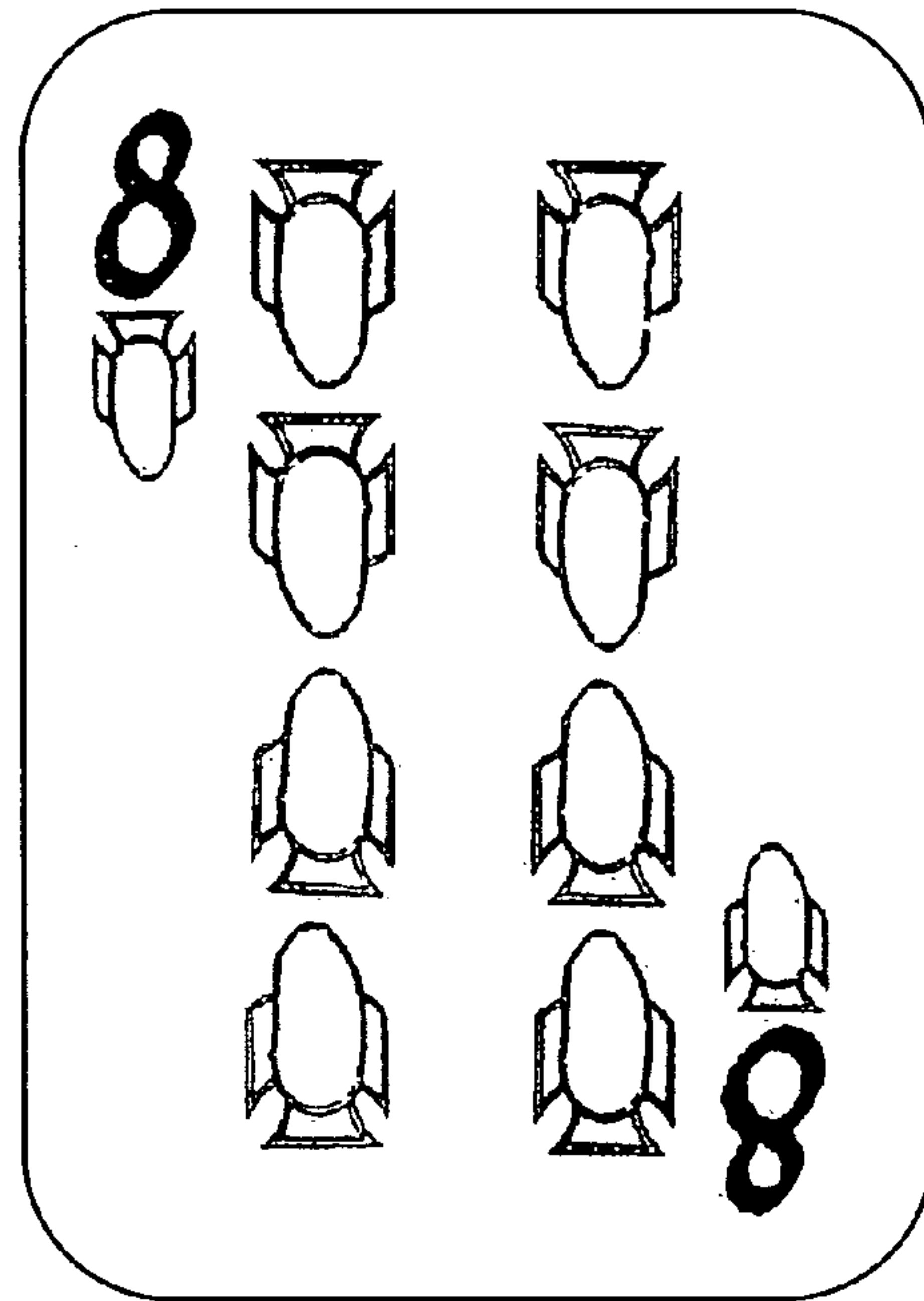

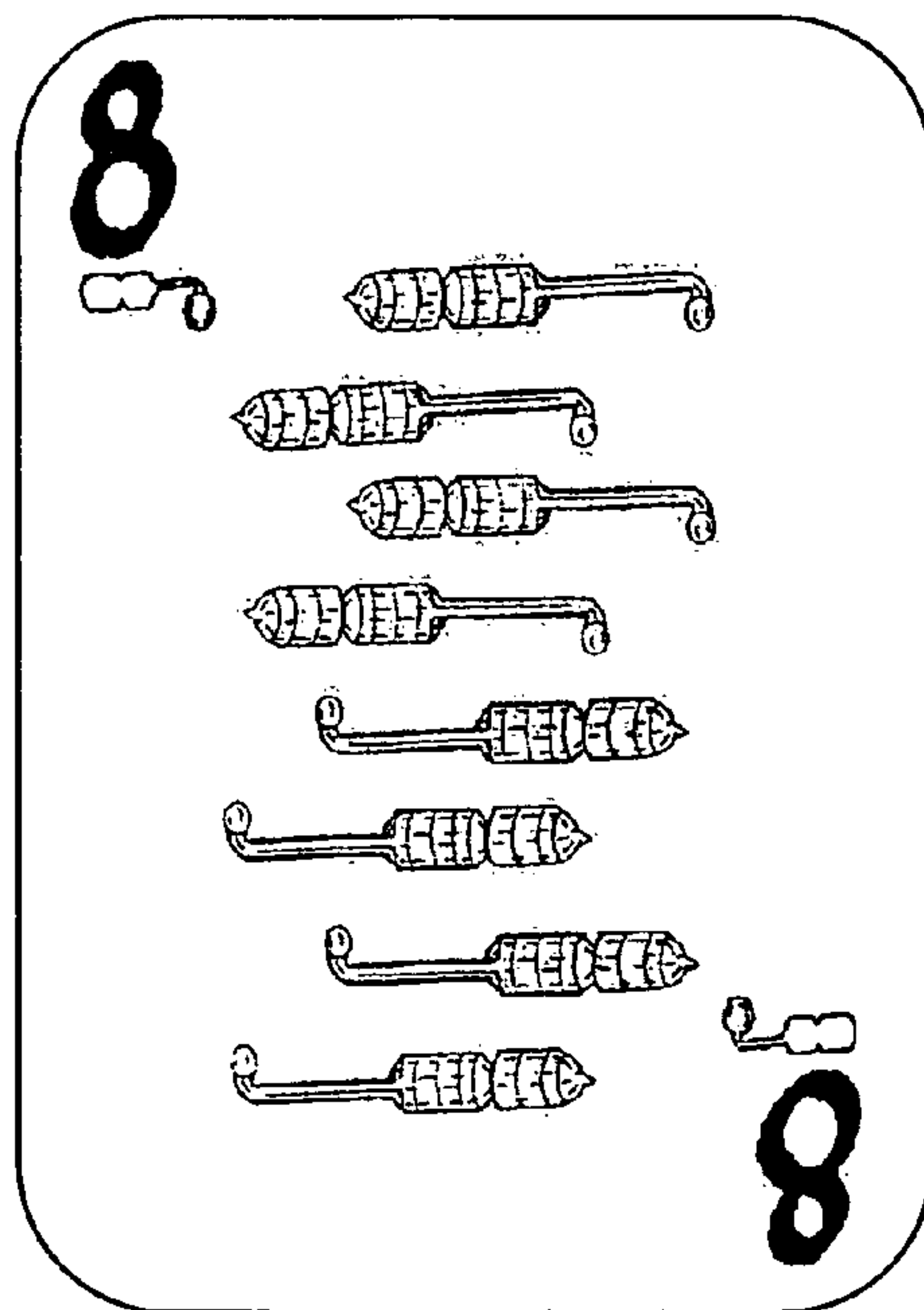

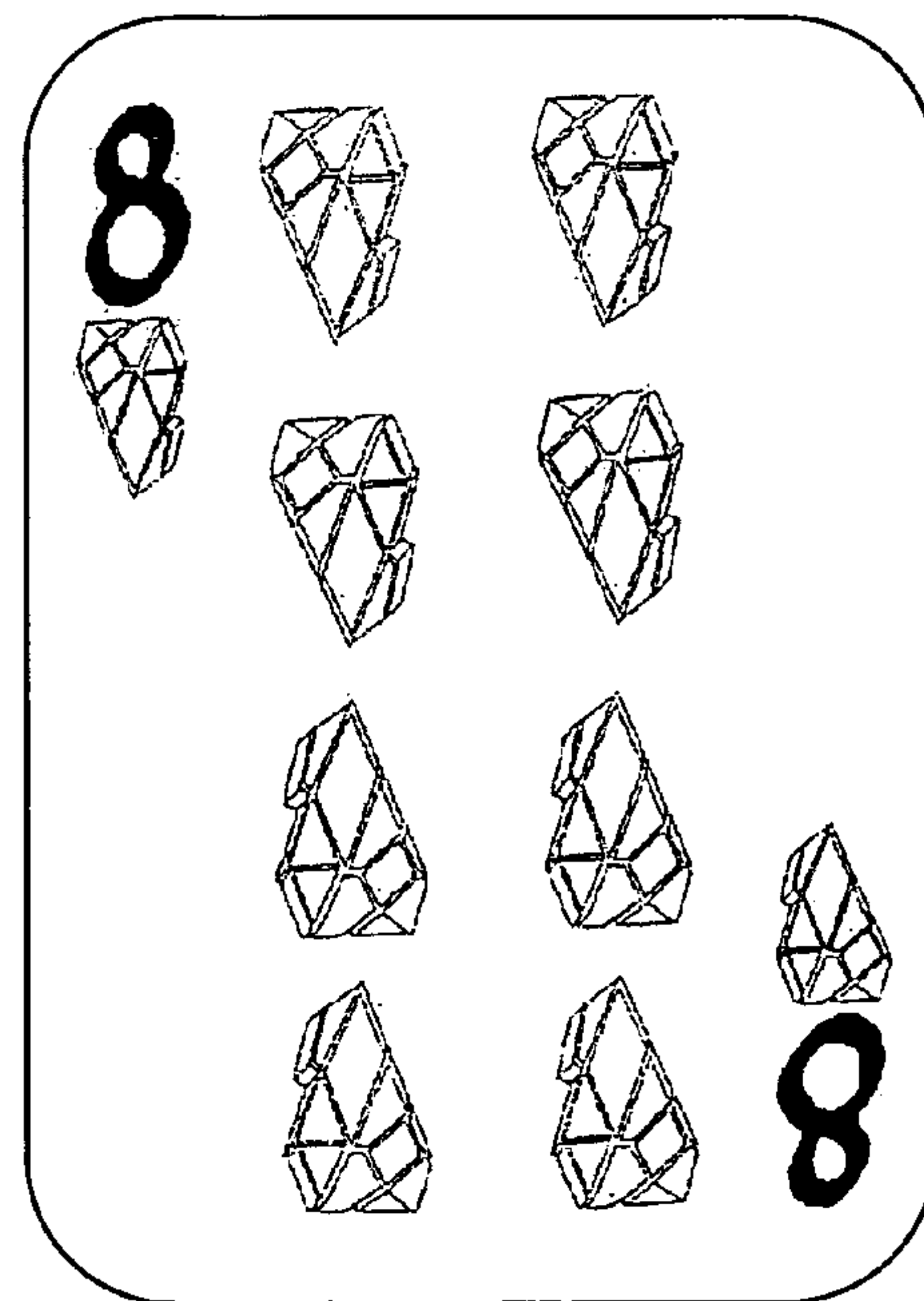

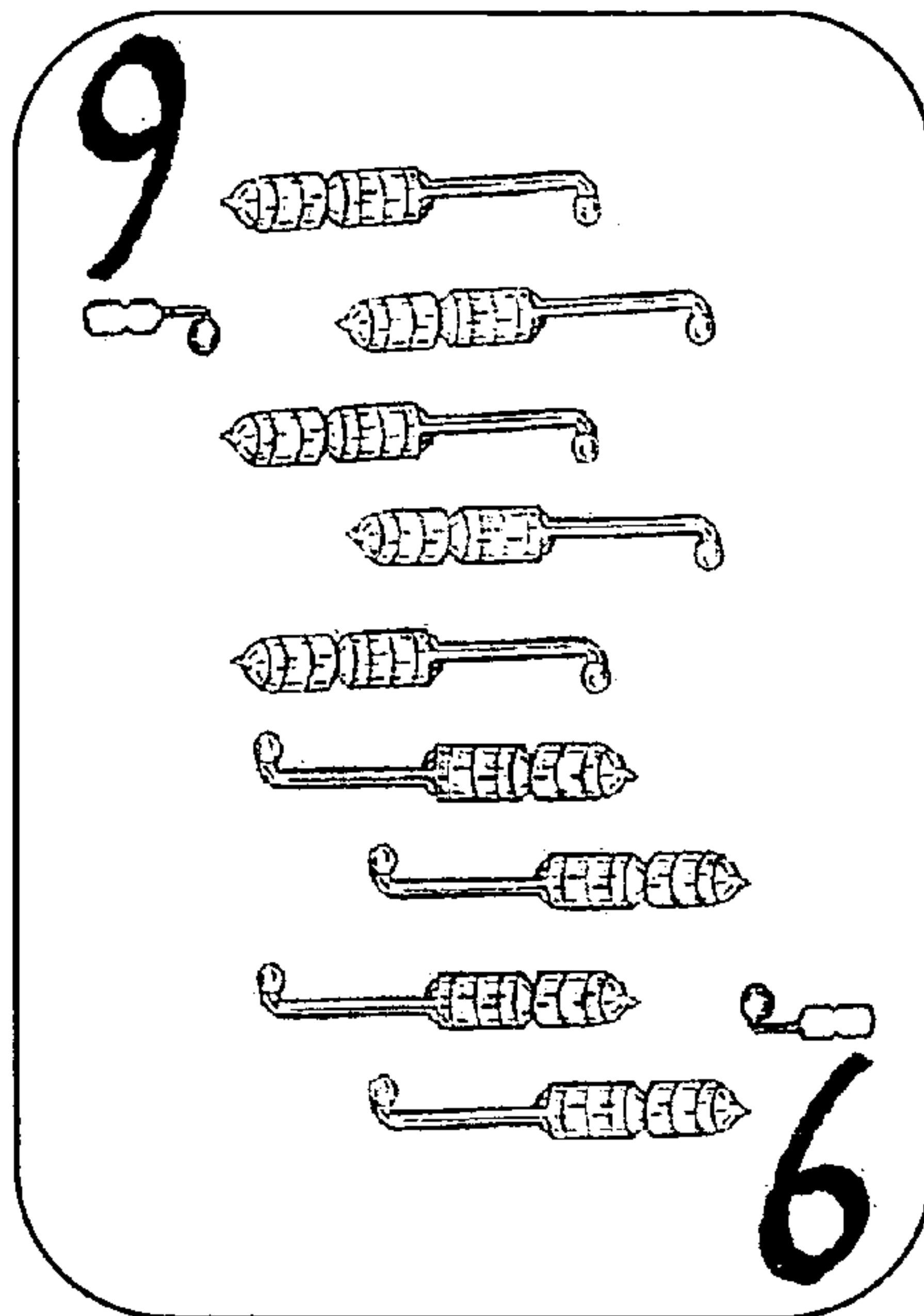

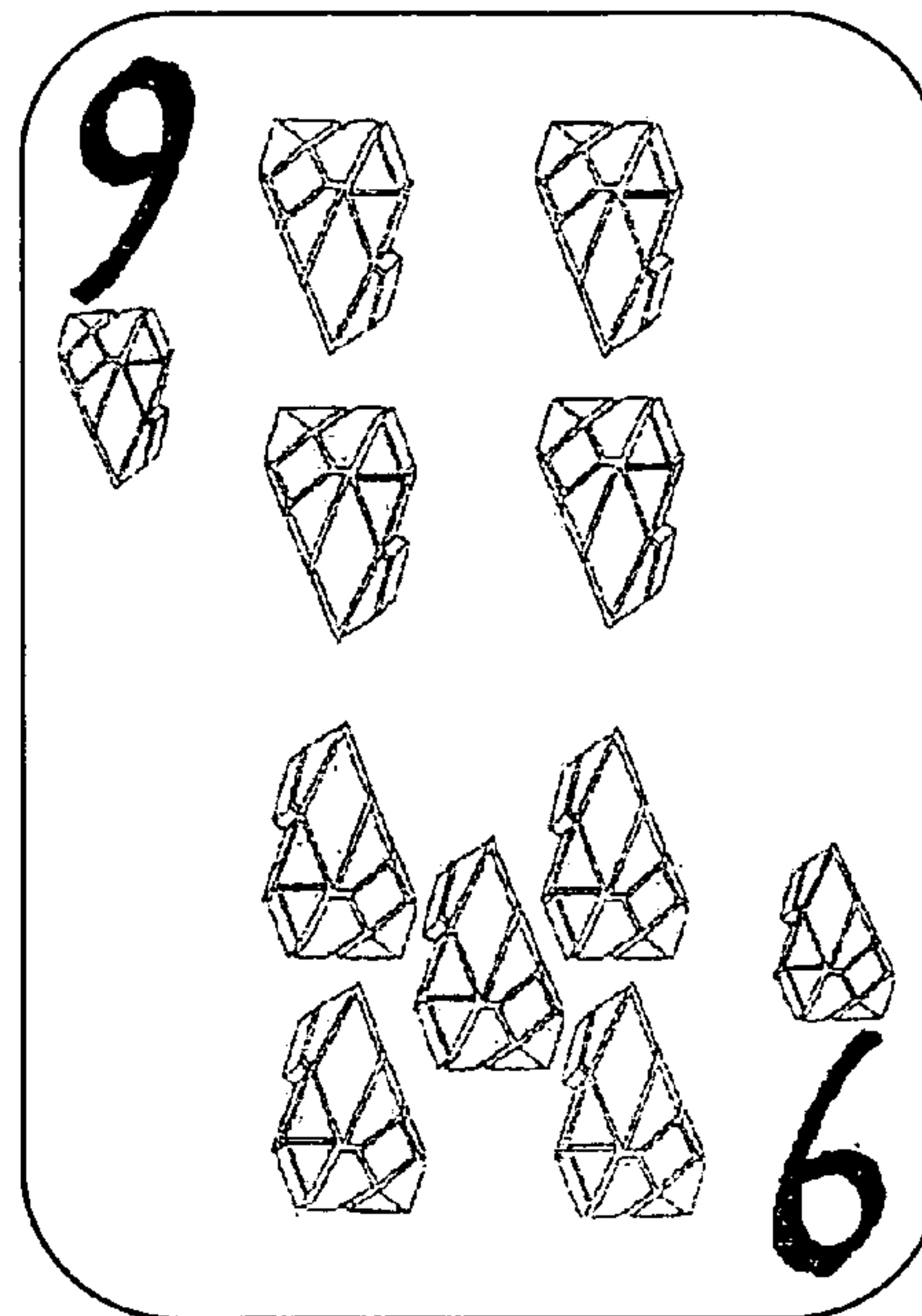

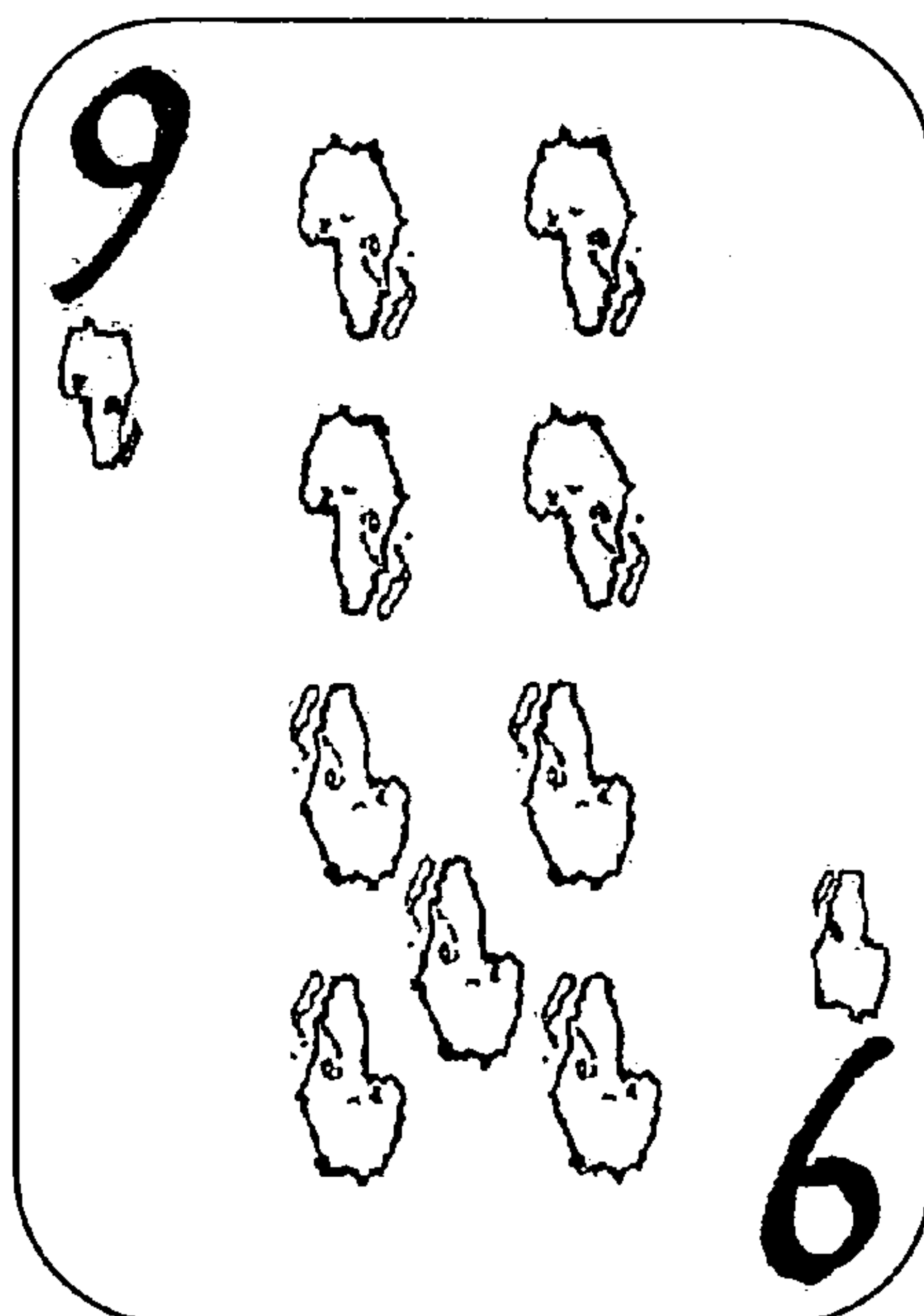

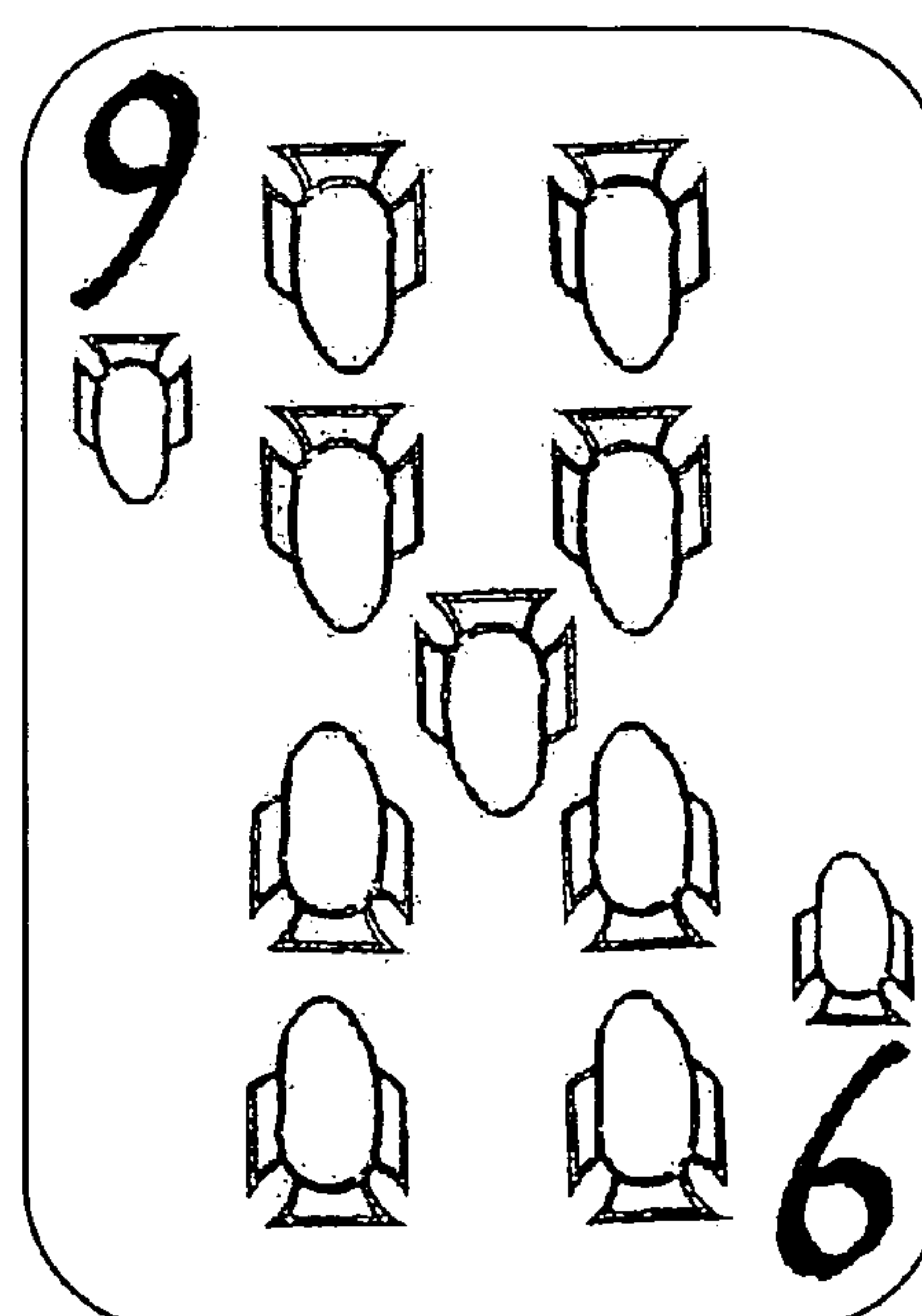

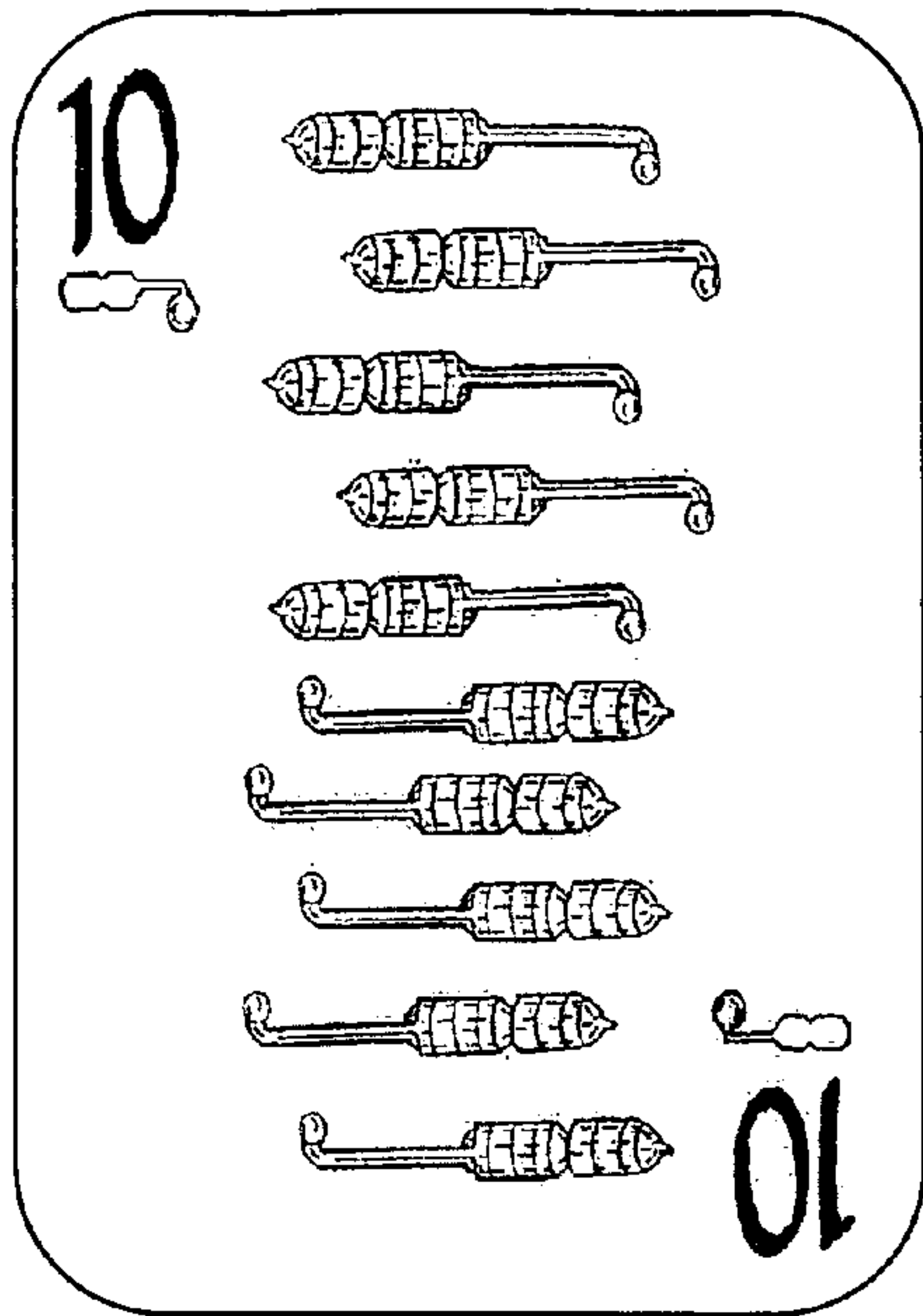

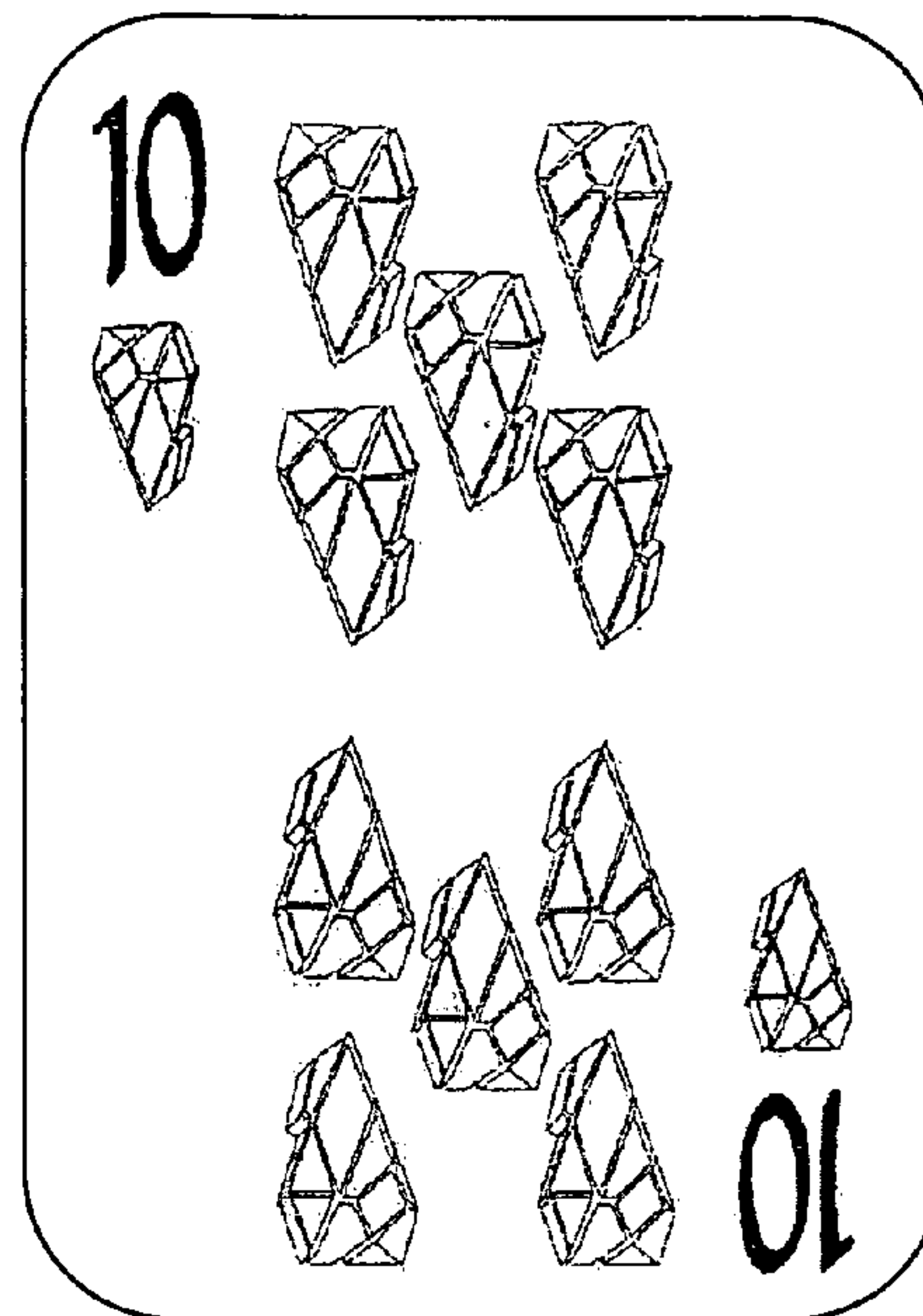

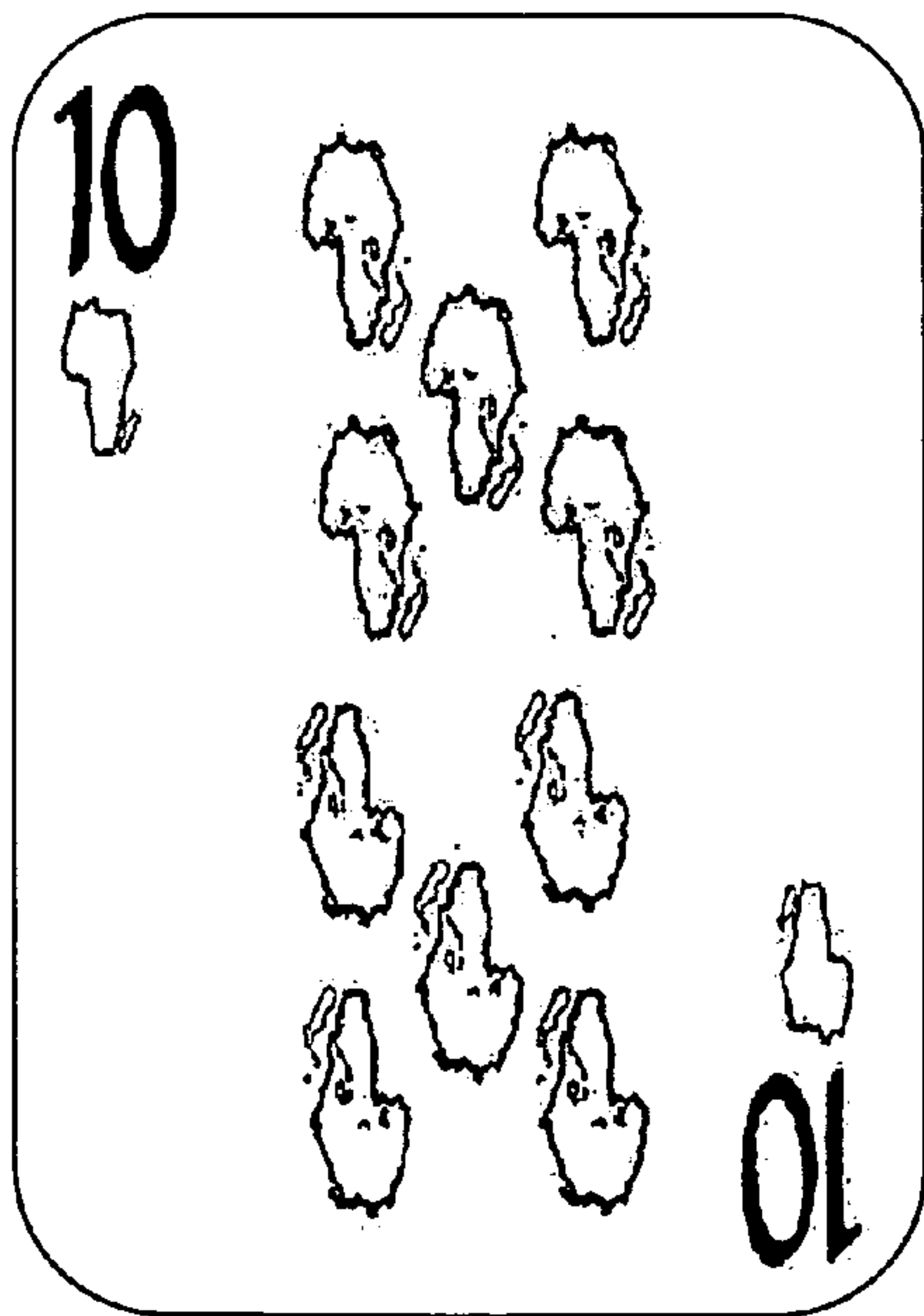

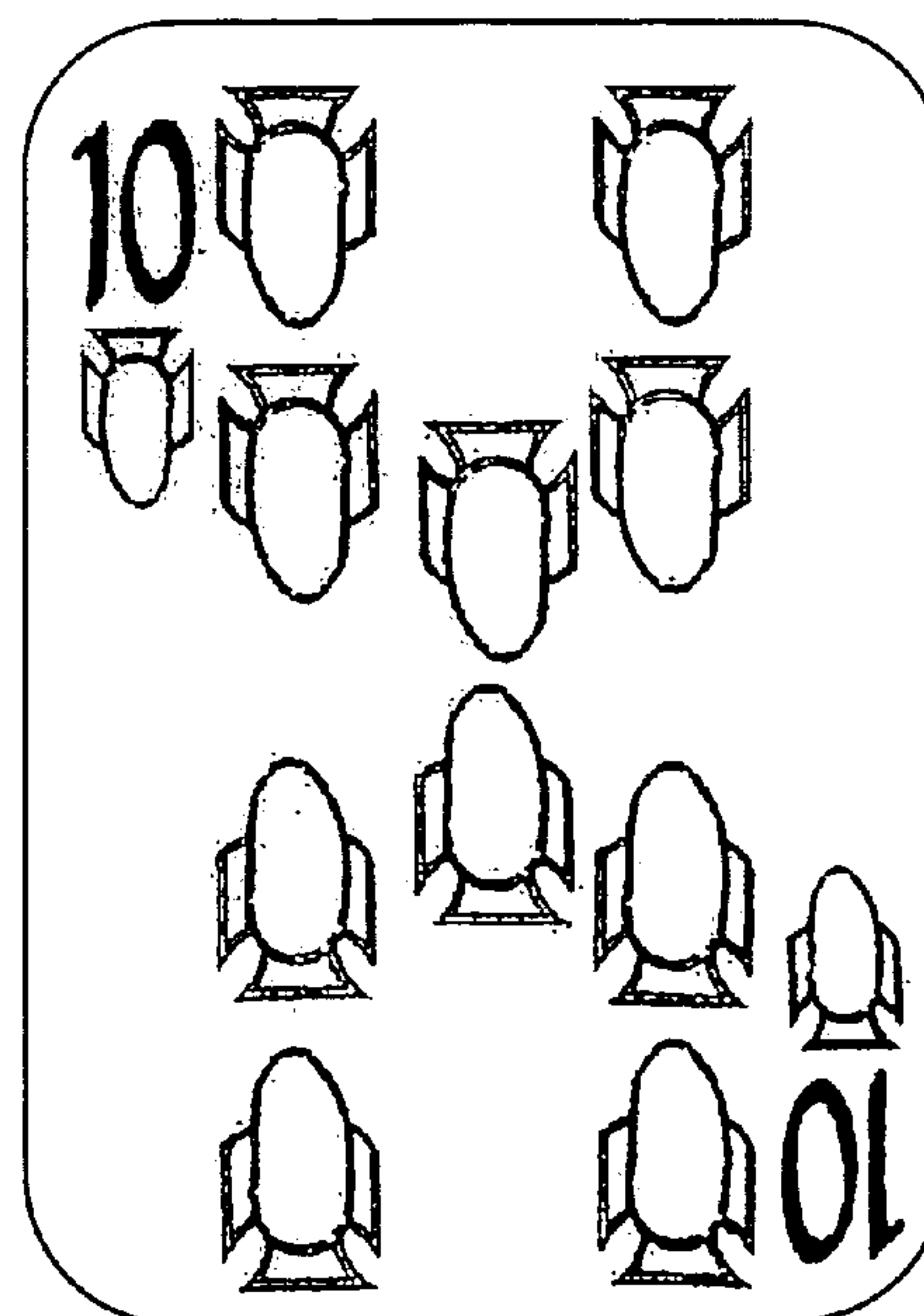

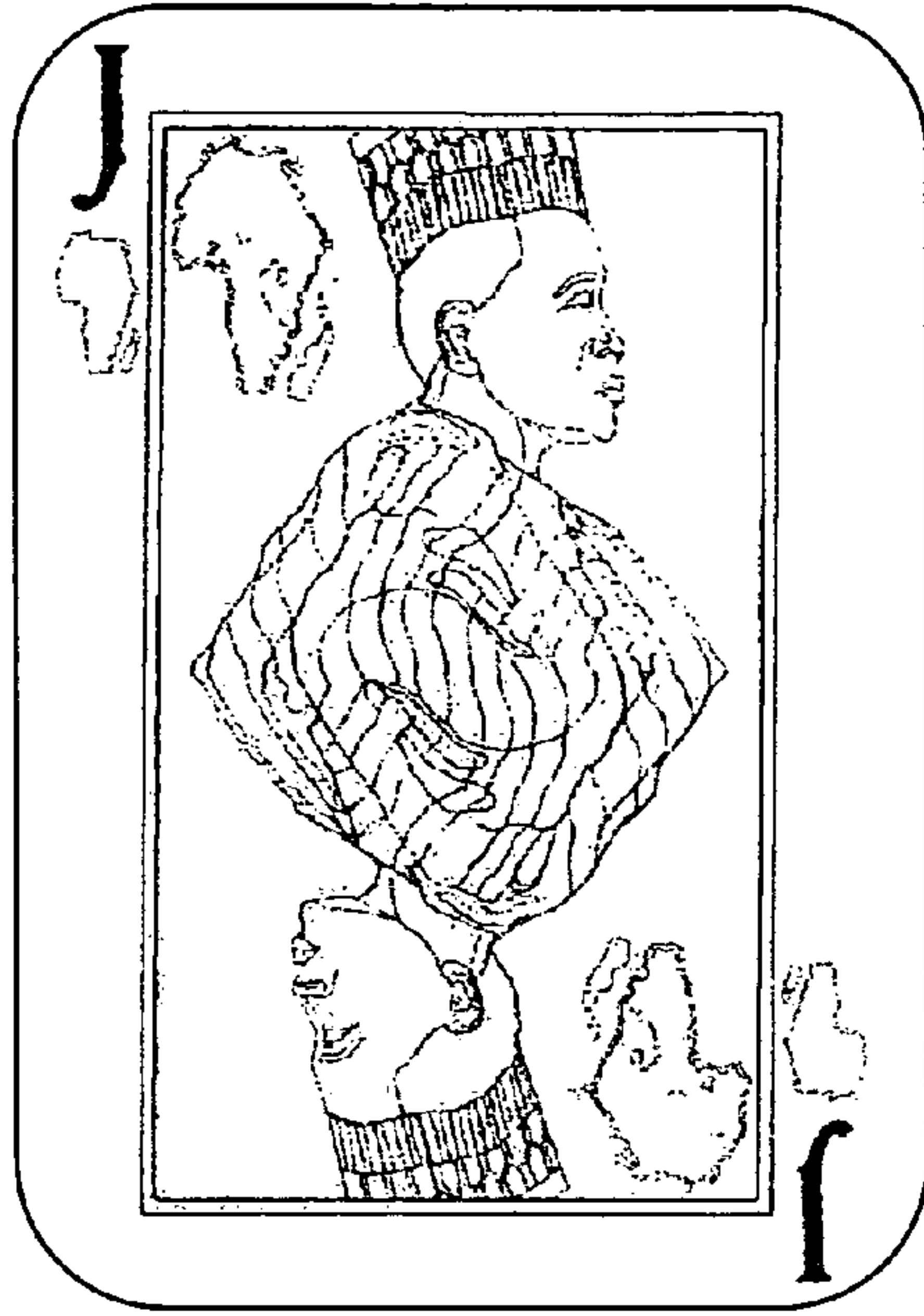

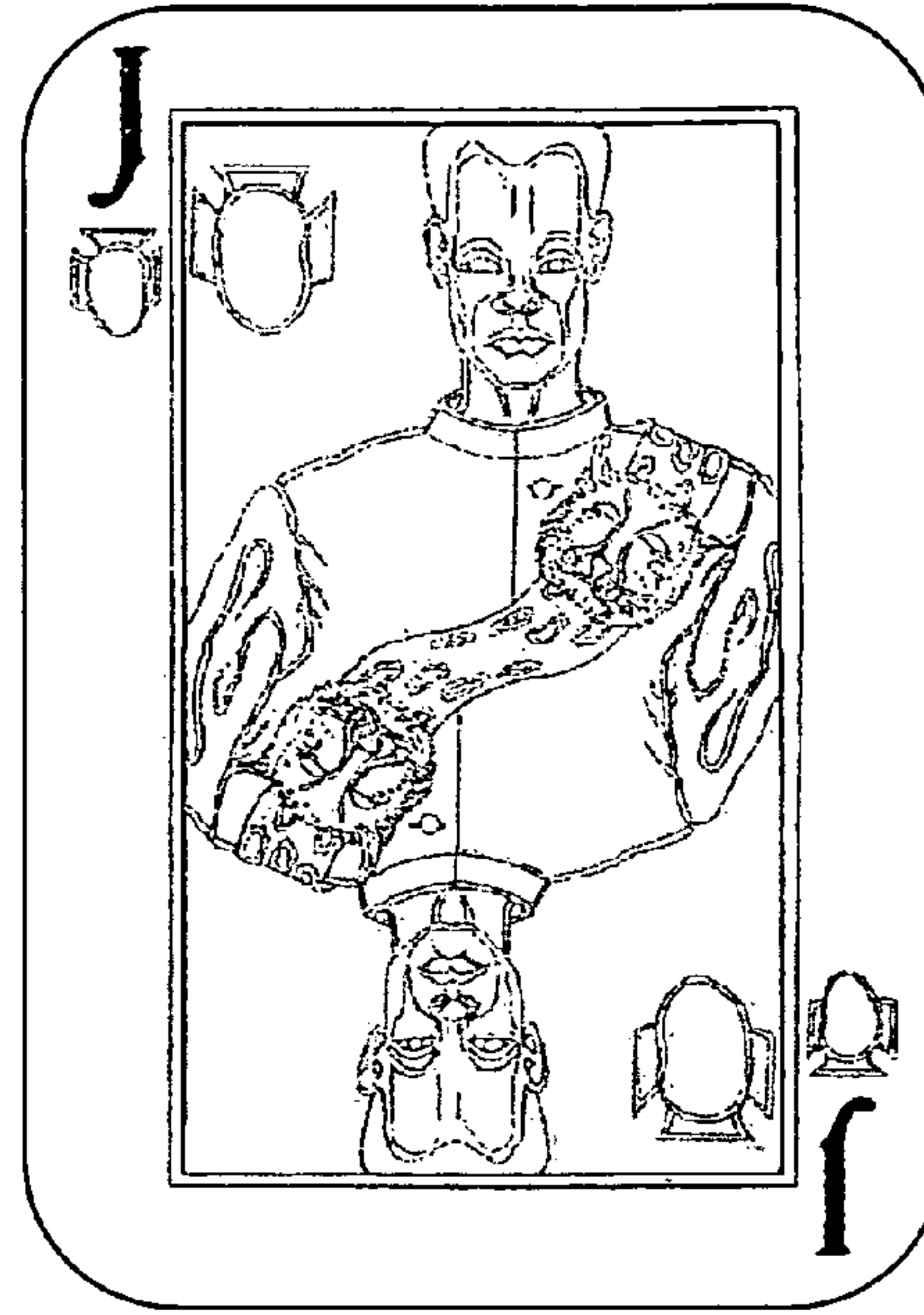

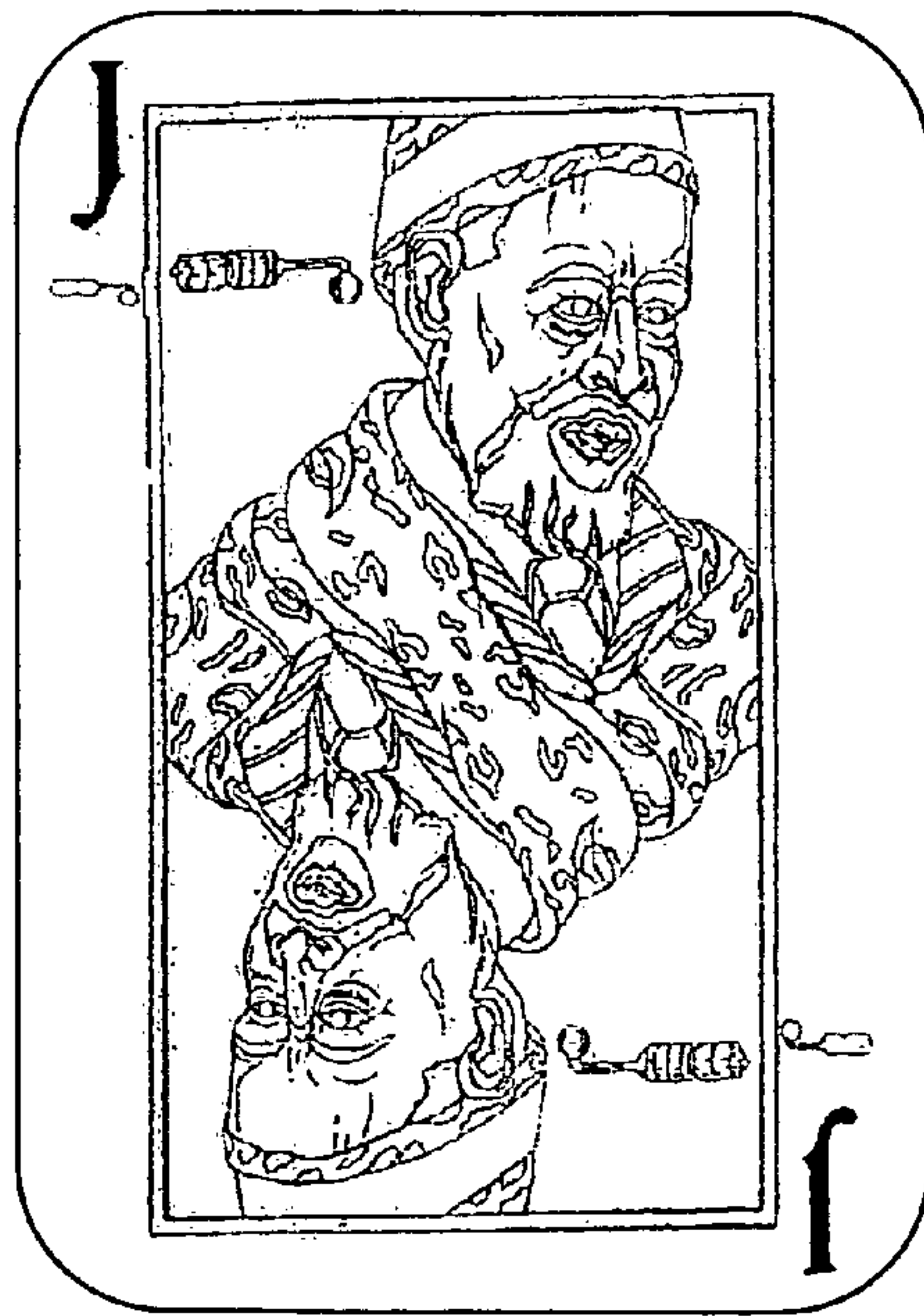

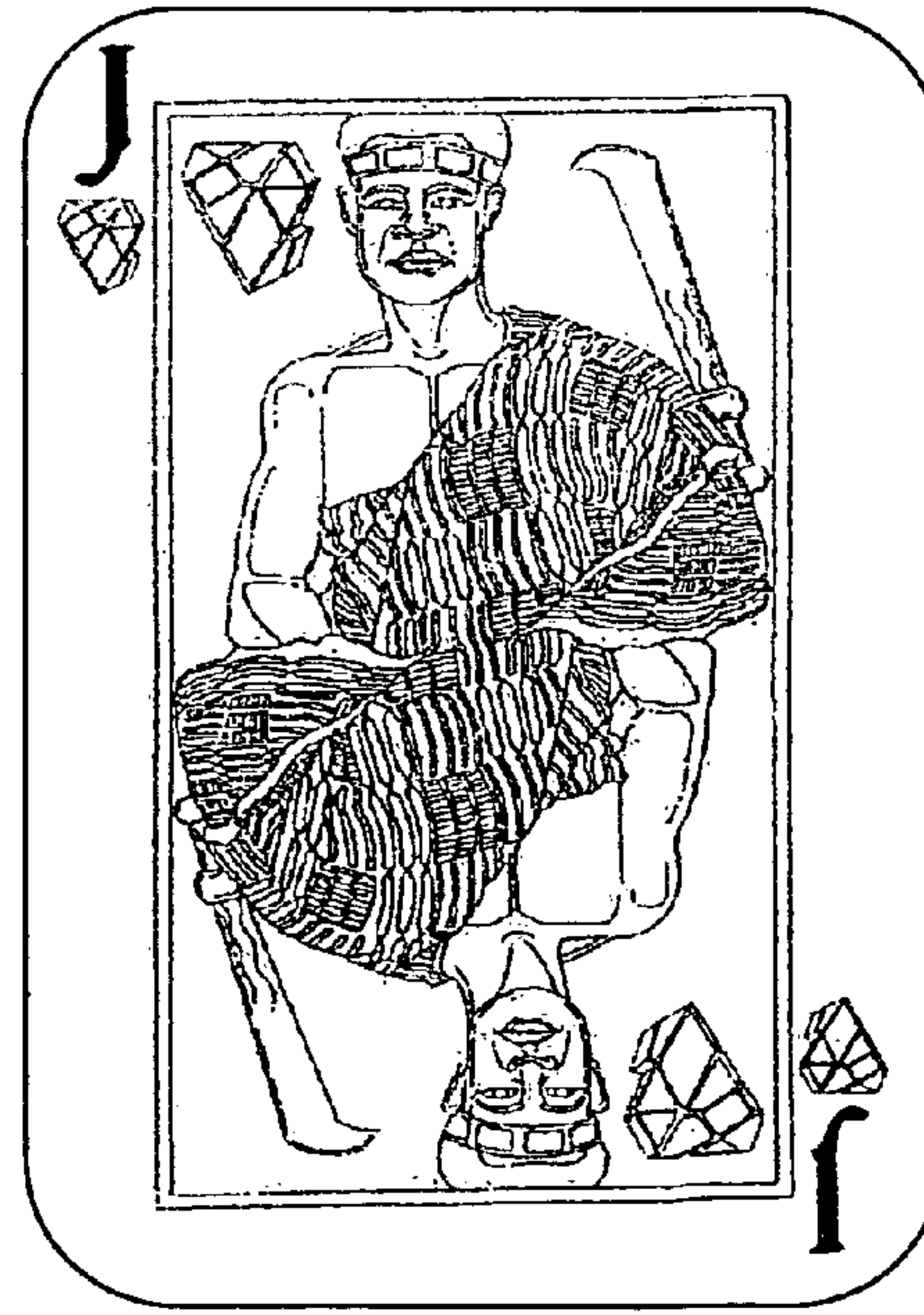

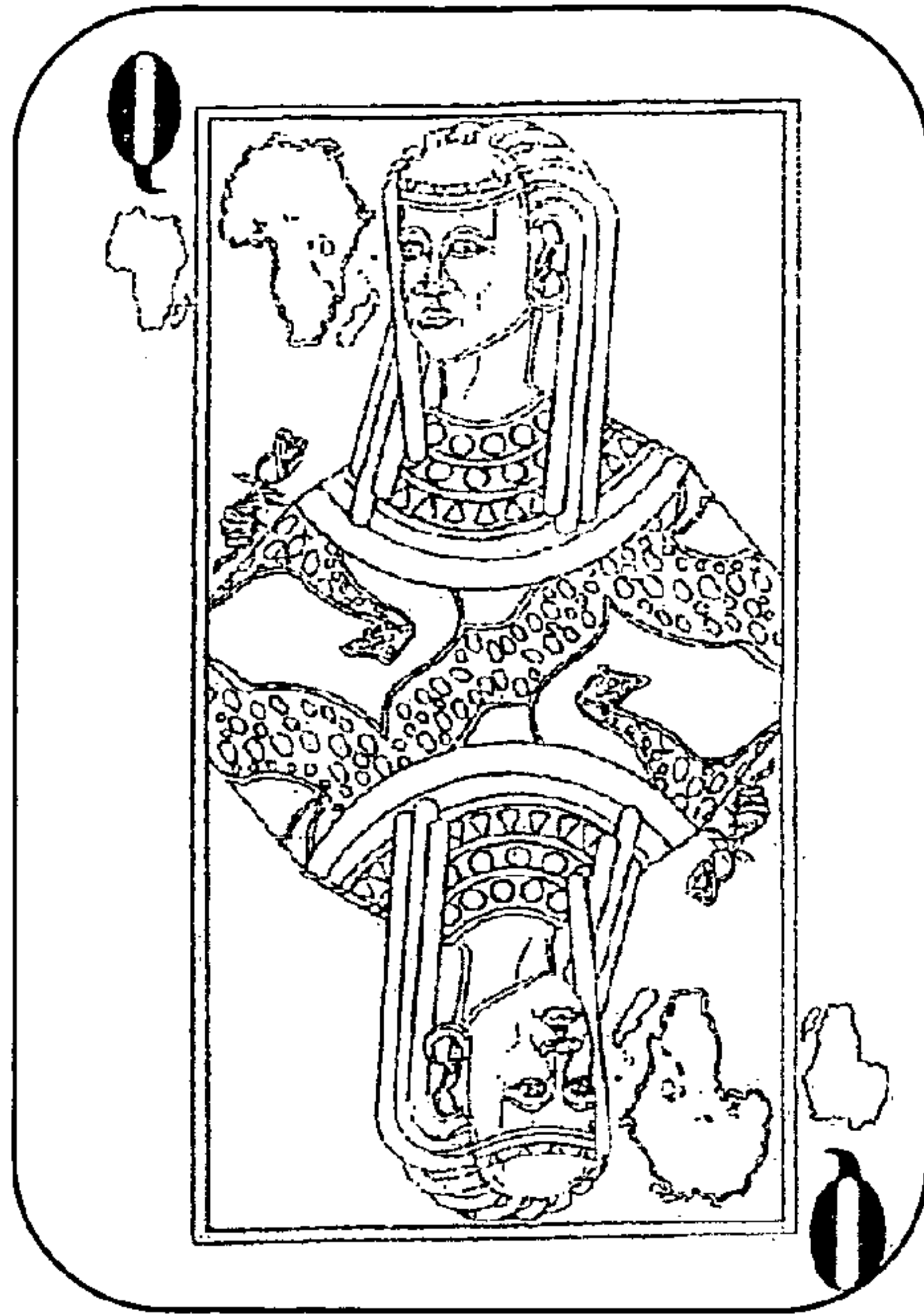

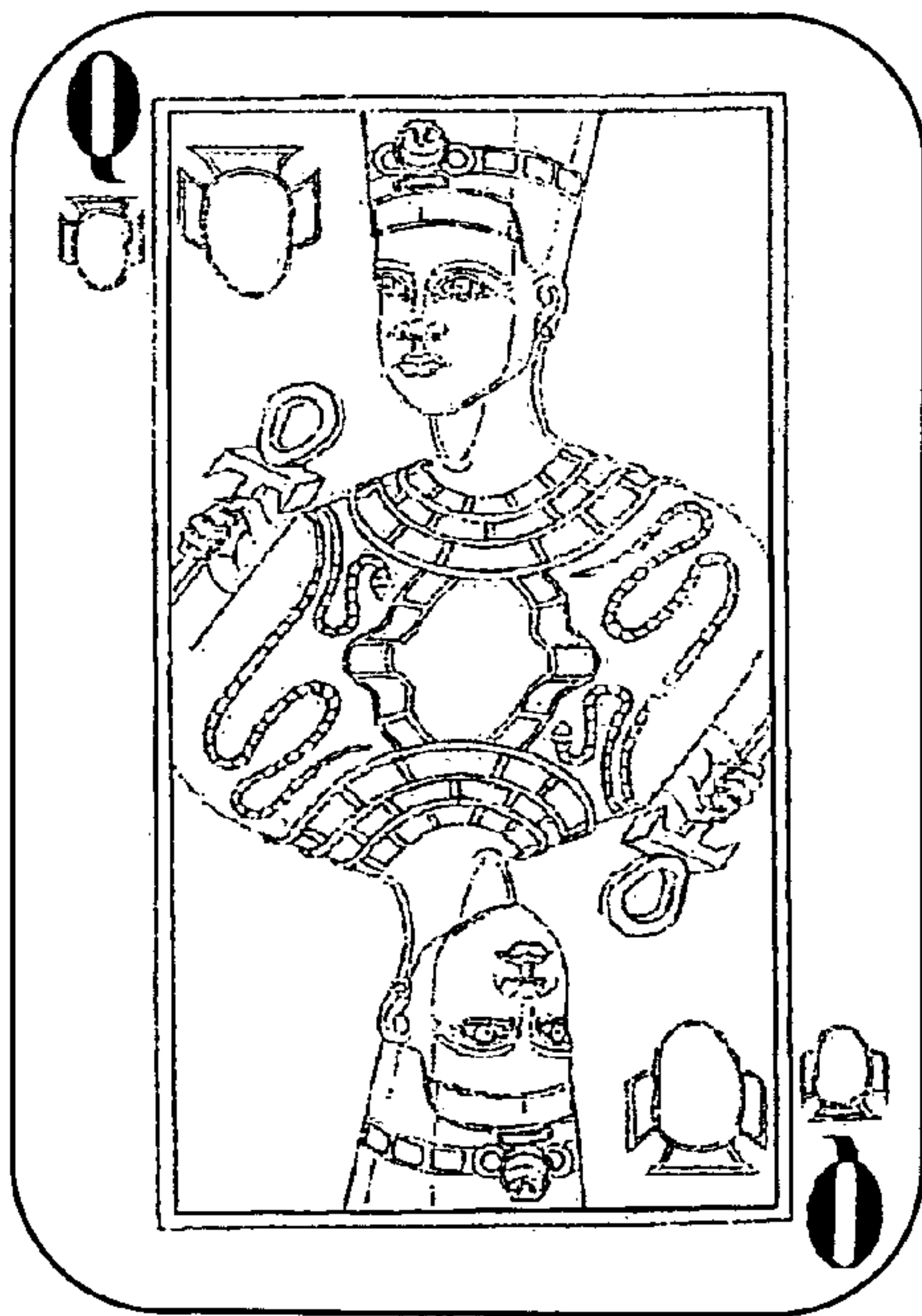

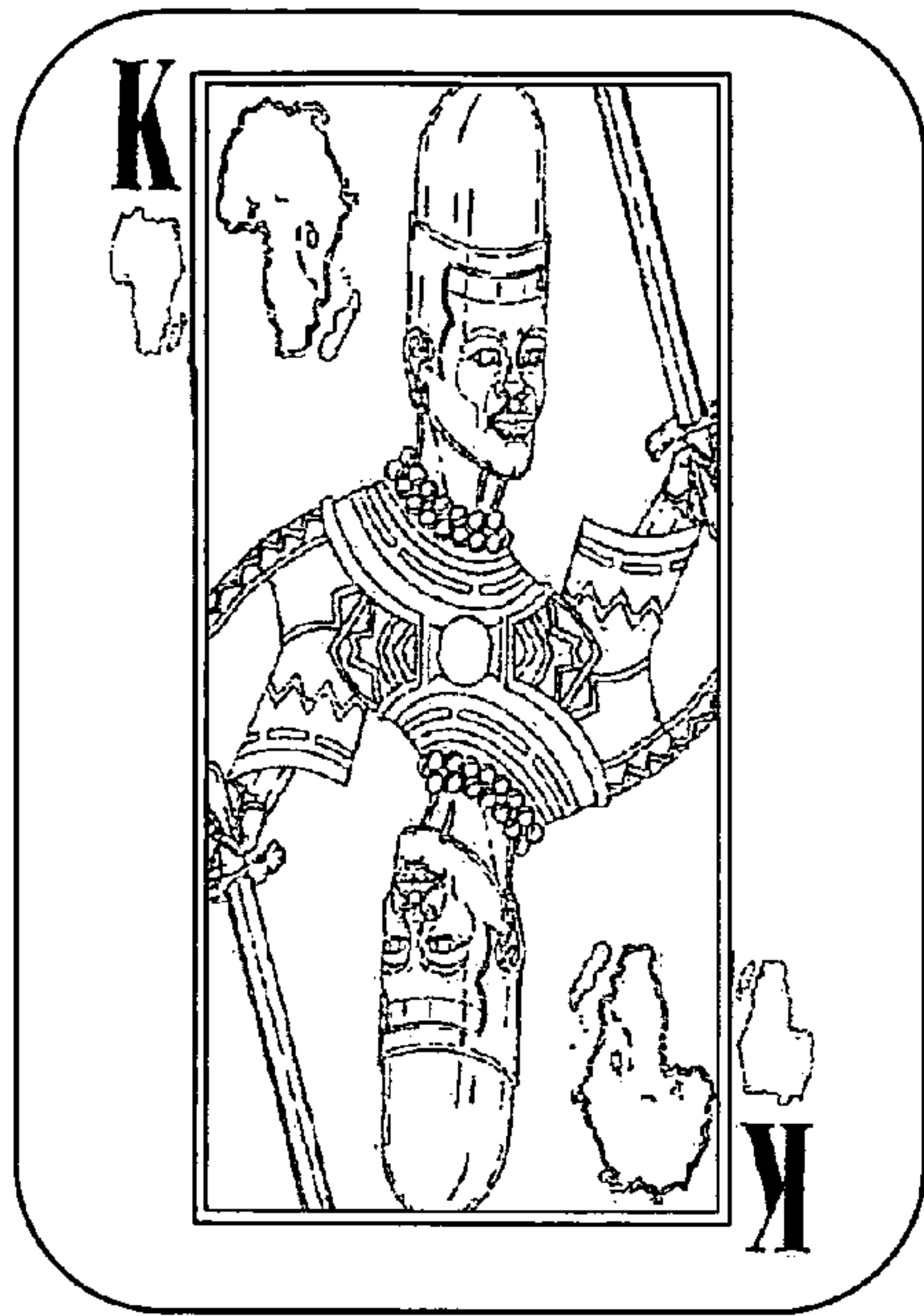

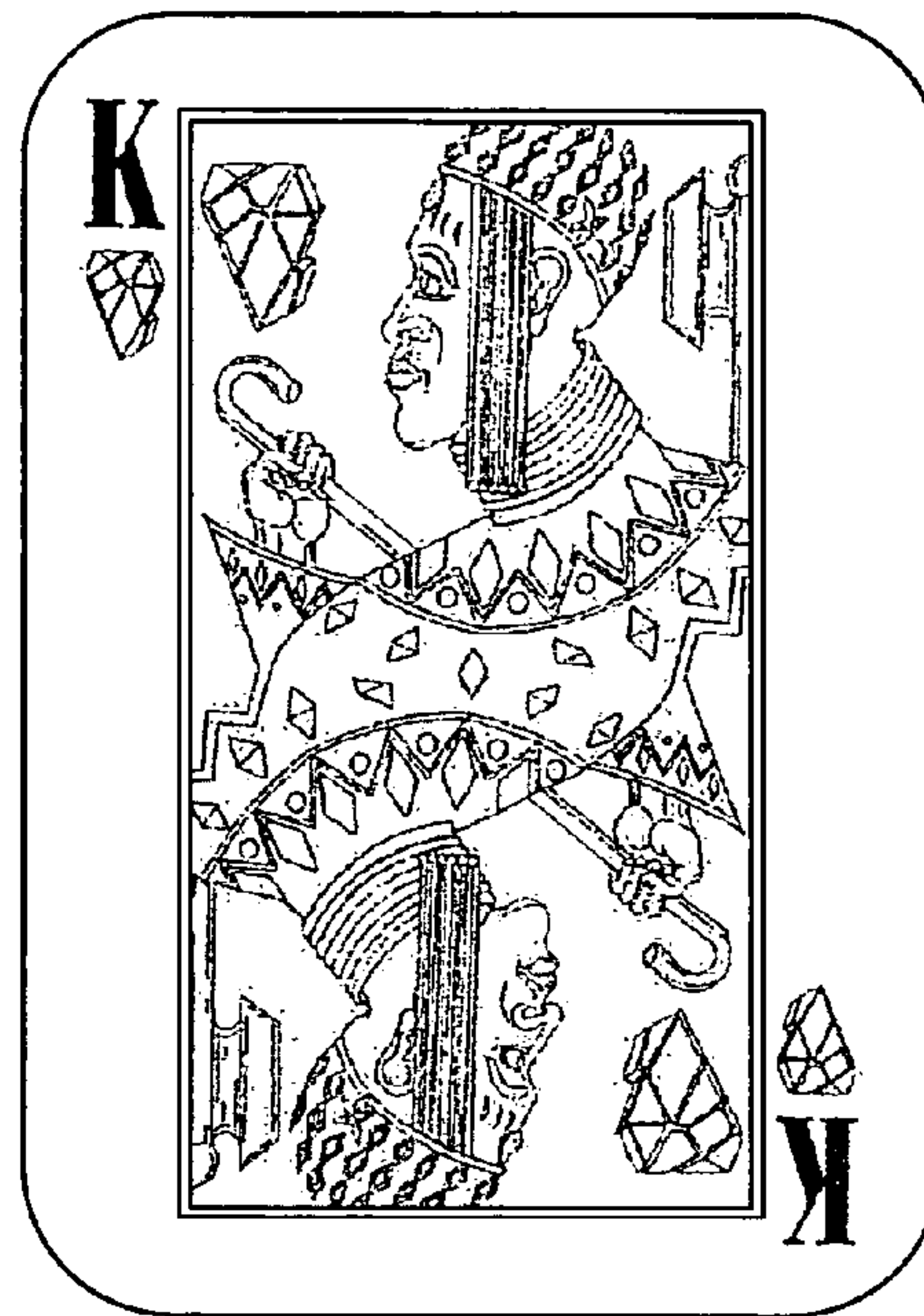

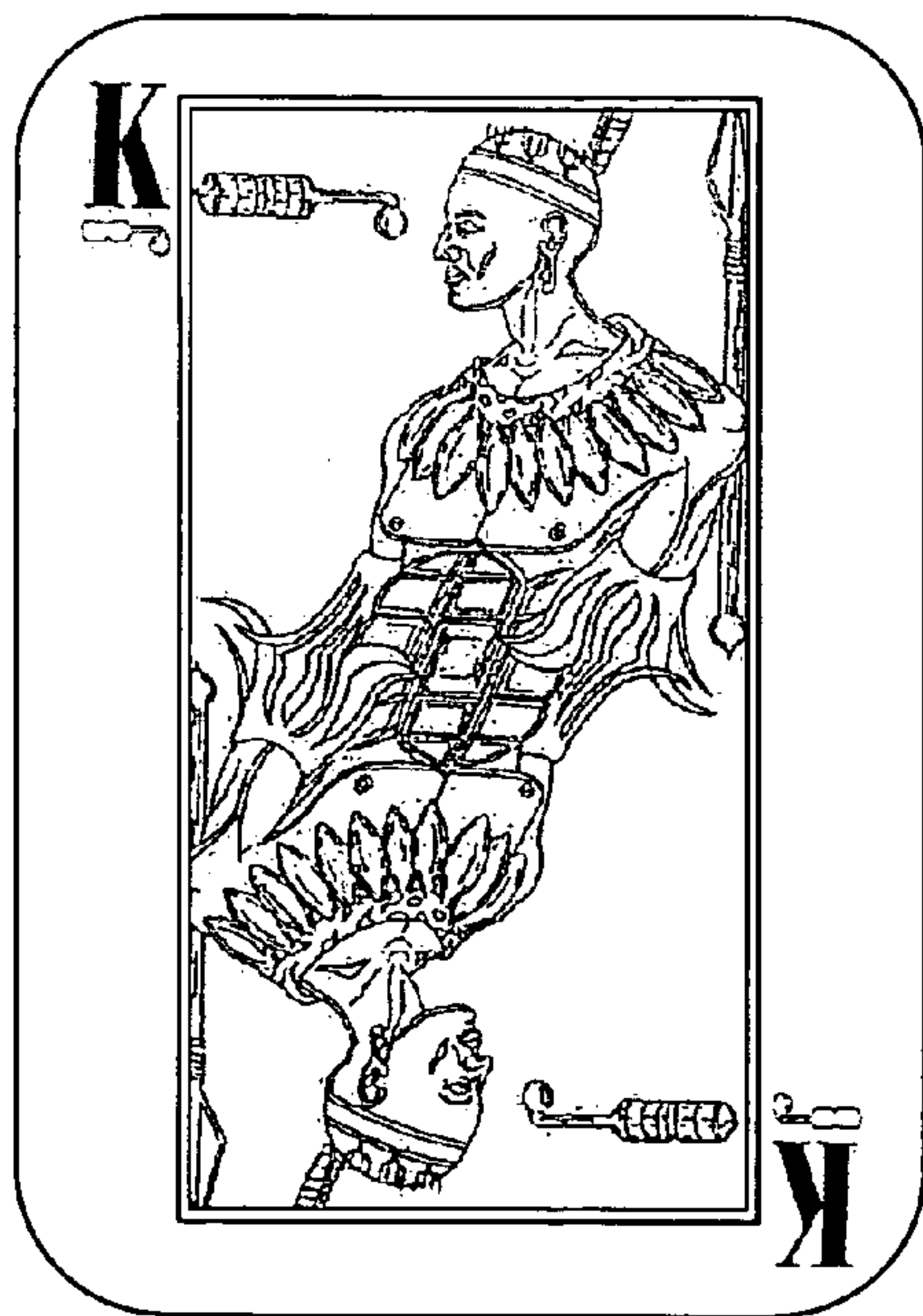

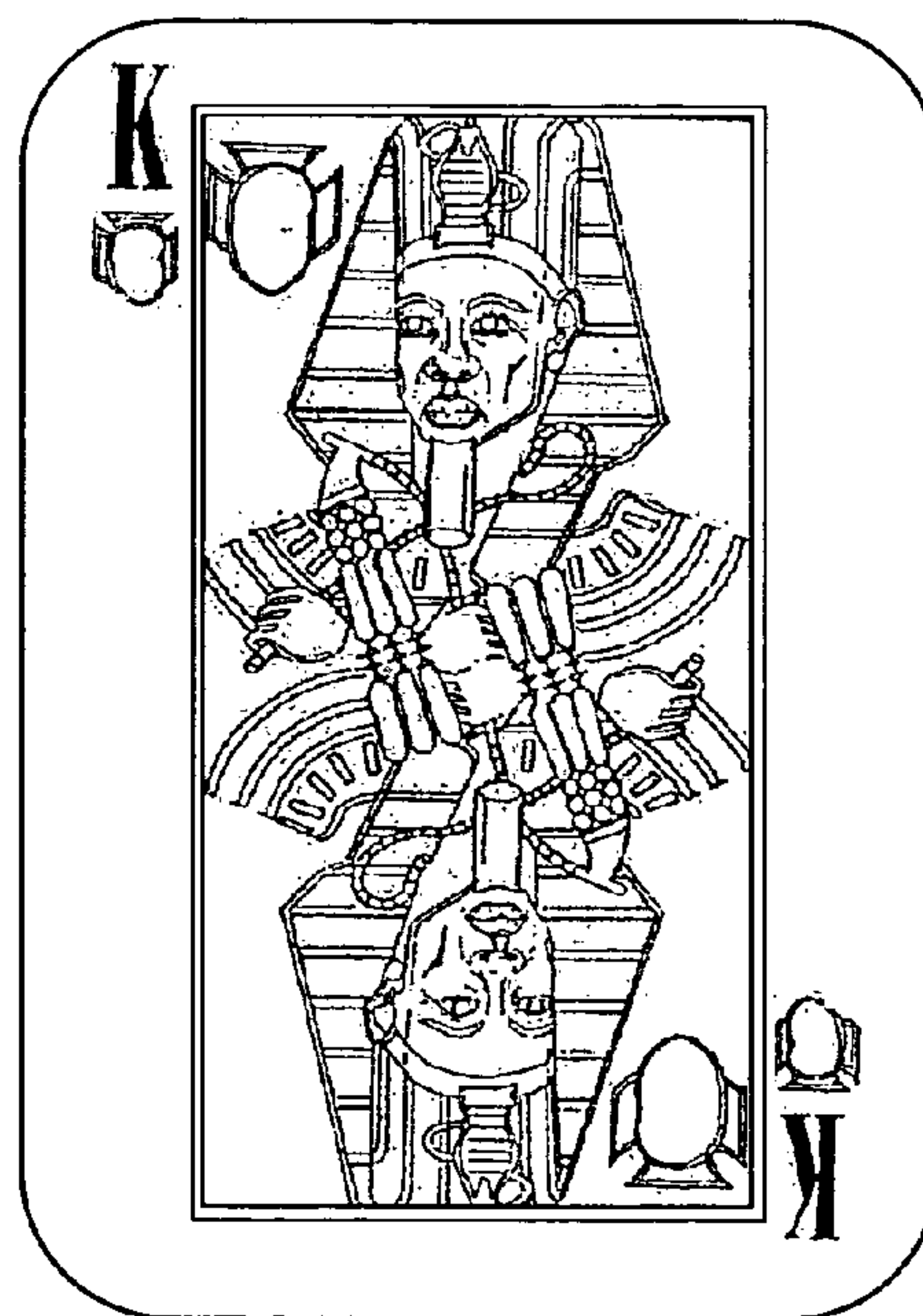

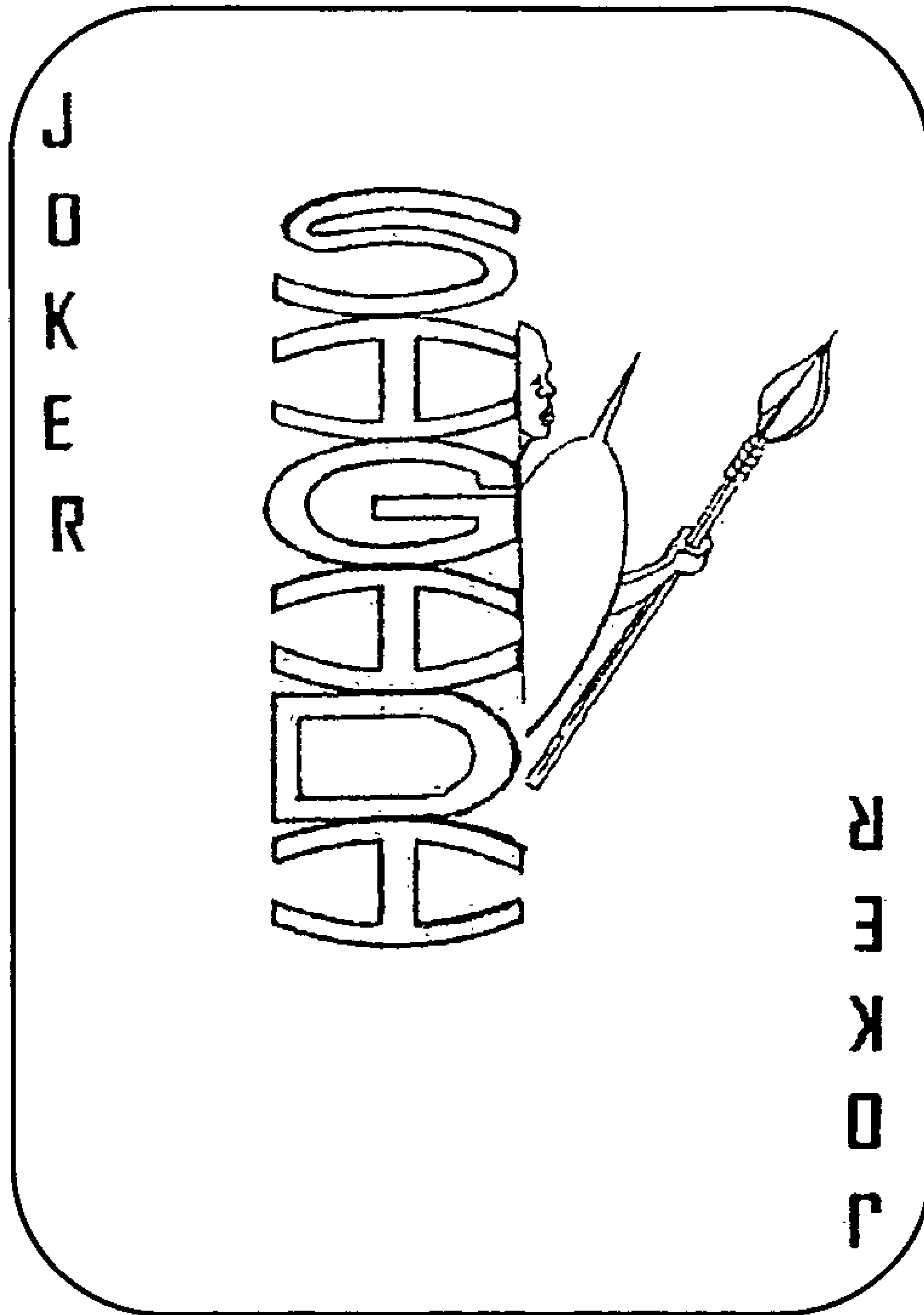

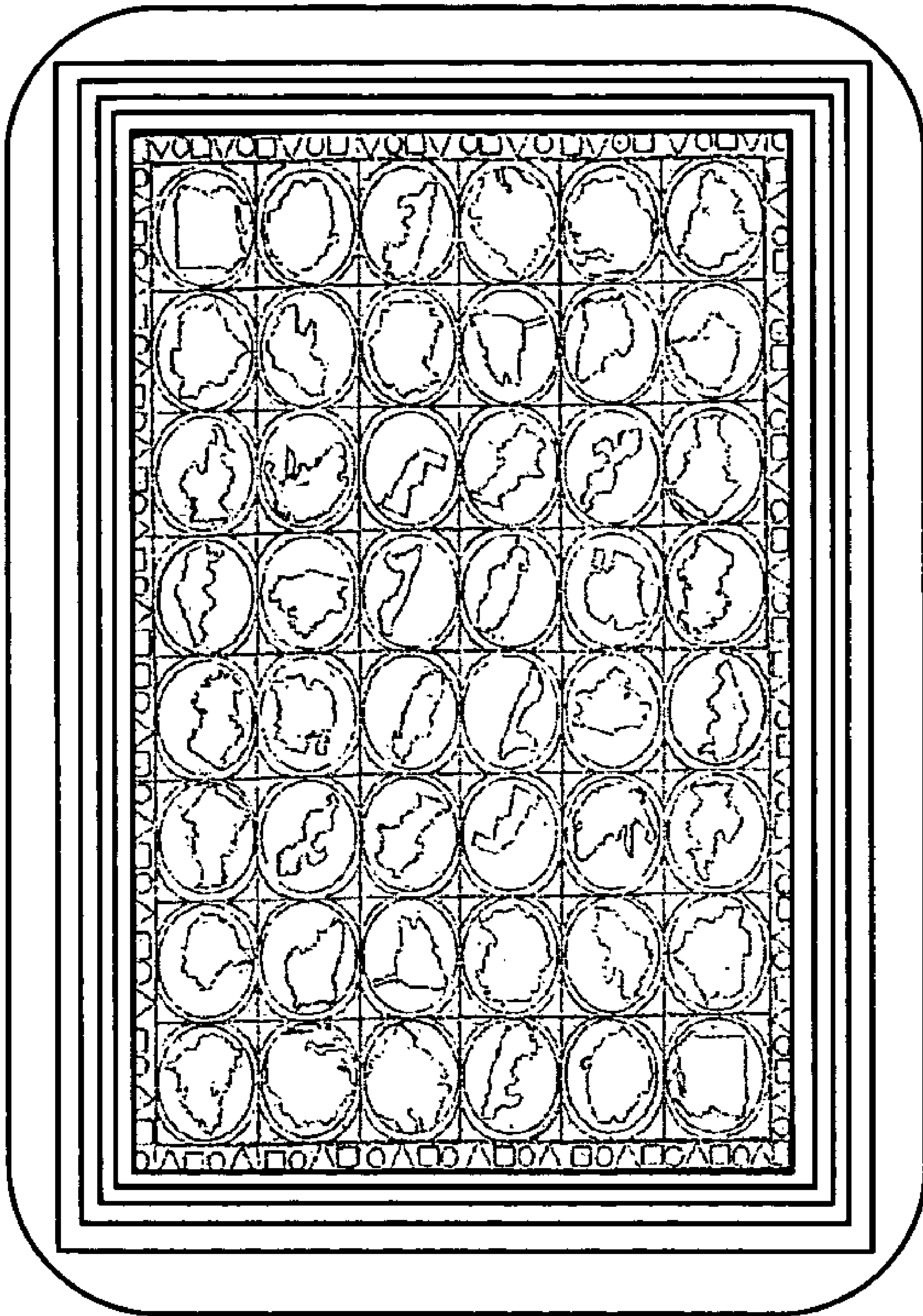
