(57) **CLAIM**

The ornamental design for a tampon applicator with finger grip, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of a tampon applicator with finger grip according to the present invention;

FIG. 2 is a side view of the tampon applicator with finger grip of FIG. 1, wherein the tampon applicator with finger grip rotated 0°, 90°, 180°, and 270° has identical side views to FIG. 2;

FIG. 3 is a front view of the tampon applicator with finger grip of FIG. 1;

FIG. 4 is a rear view of the tampon applicator with finger grip of FIG. 1;

FIG. 5 is a front perspective view of a second embodiment of a tampon applicator with finger grip according to the present invention;

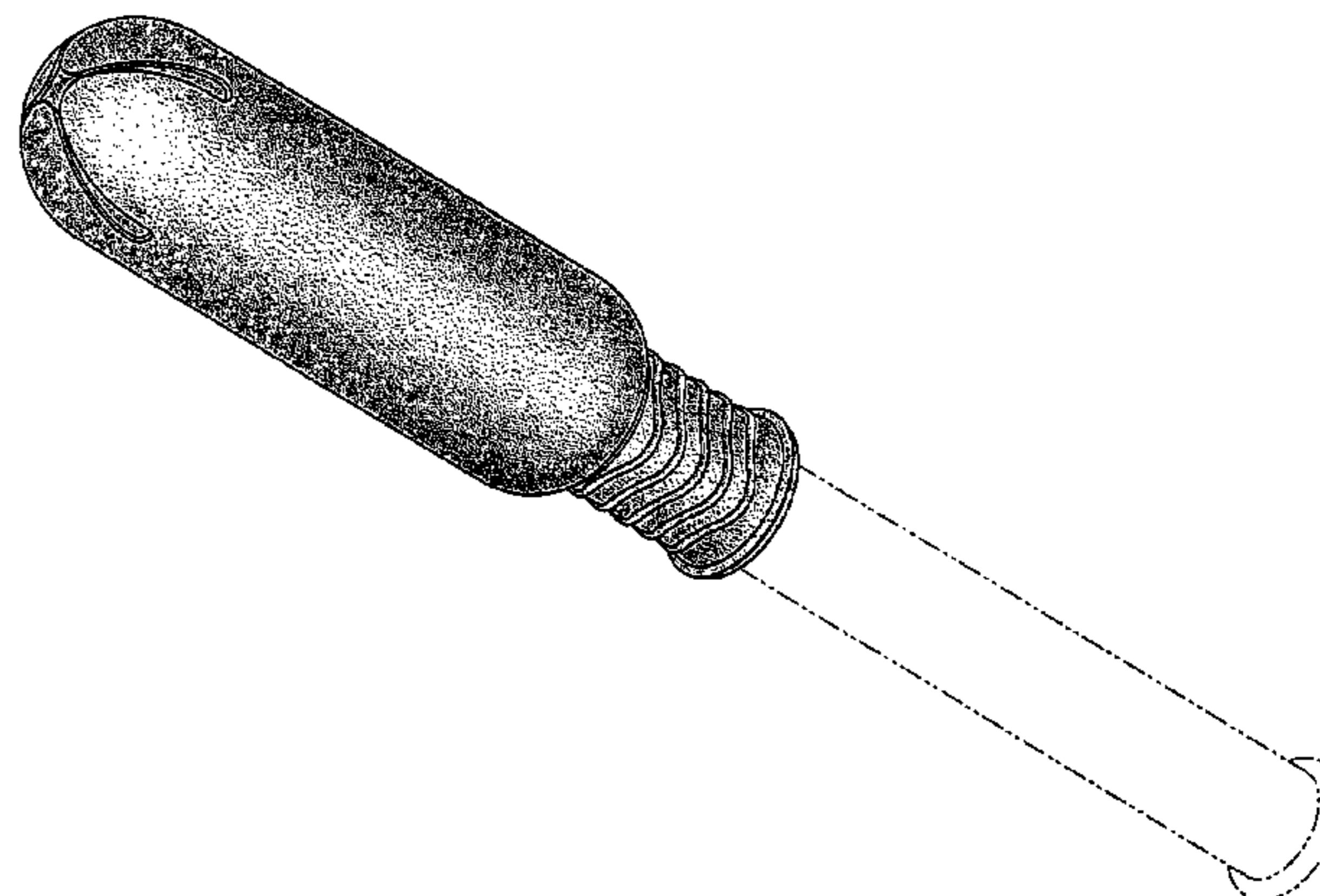
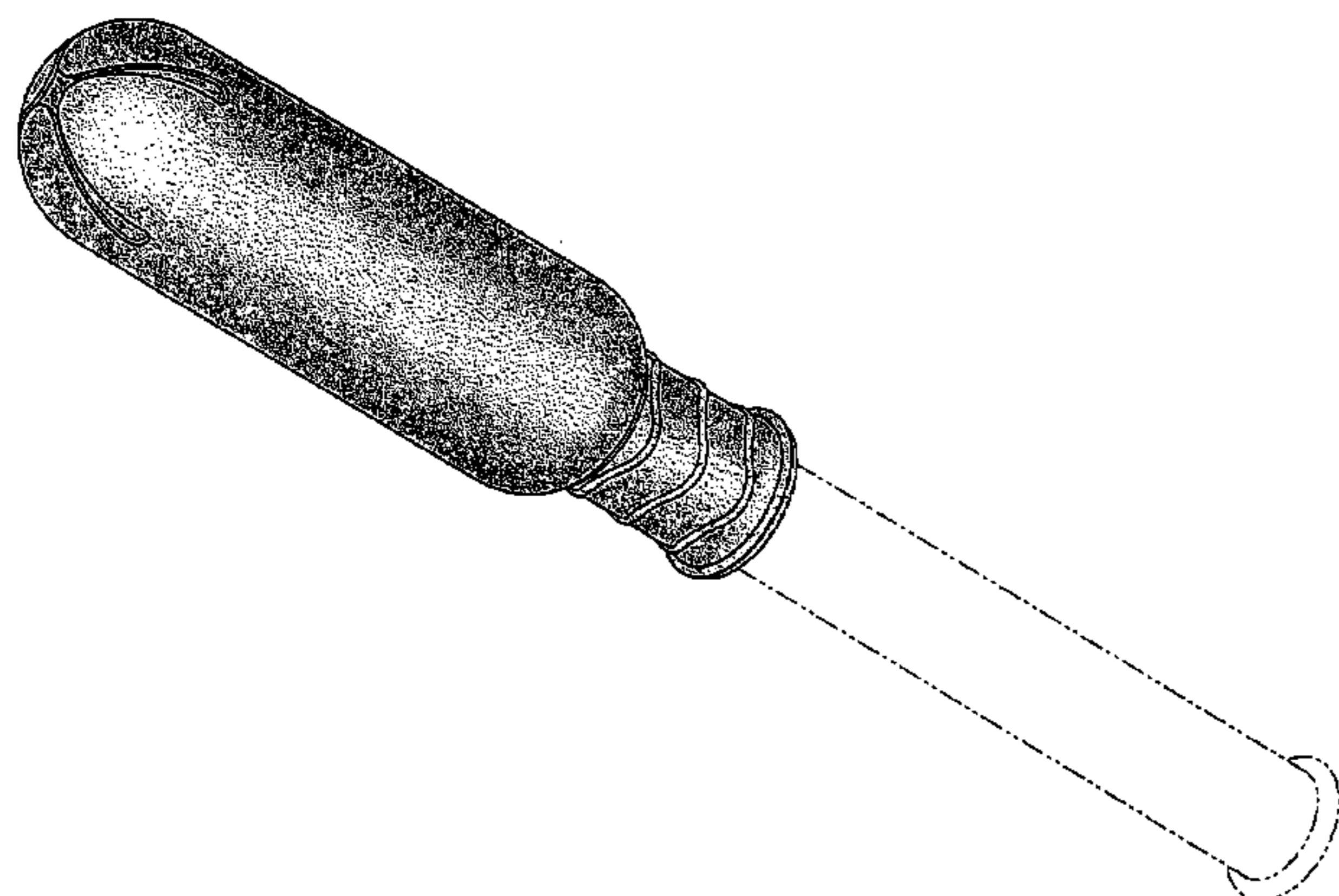
FIG. 6 is a side view of the tampon applicator with finger grip of FIG. 5, wherein the tampon applicator with finger grip rotated 0°, 90°, 180°, and 270° has identical side views to FIG. 6;

FIG. 7 is a front view of the tampon applicator with finger grip of FIG. 5; and,

FIG. 8 is a rear view of the tampon applicator with finger grip of FIG. 5.

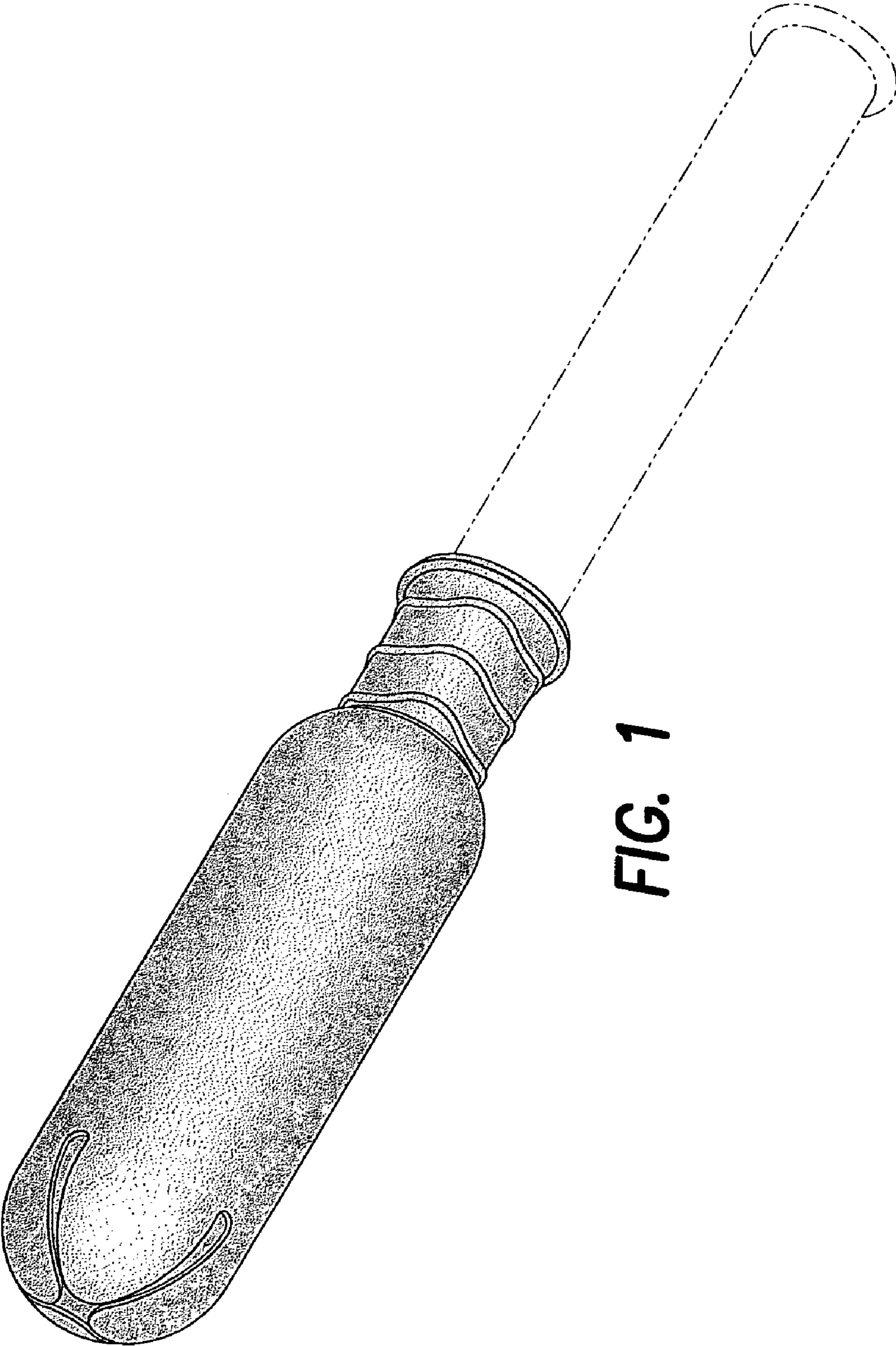
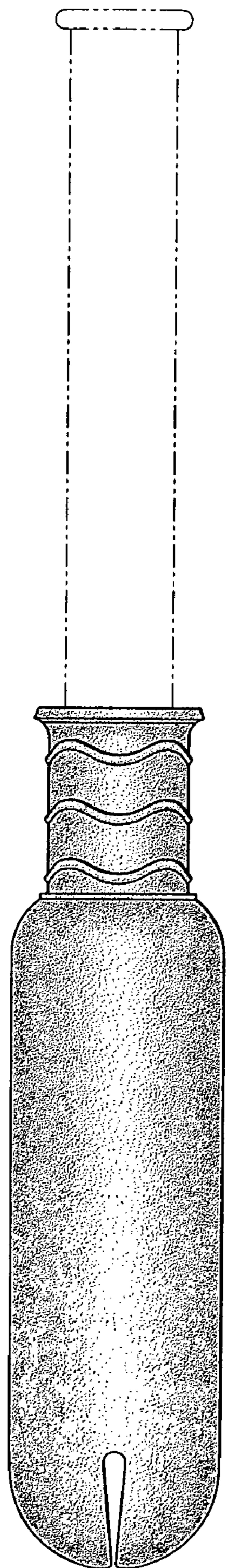
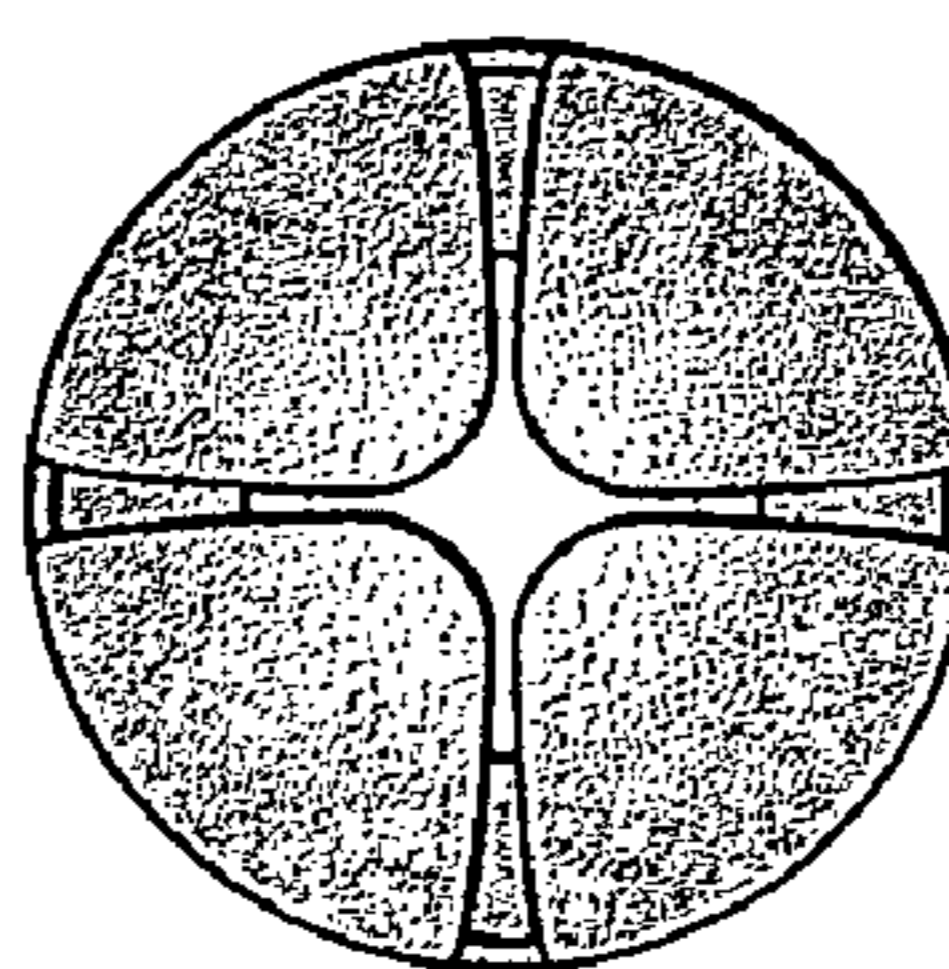


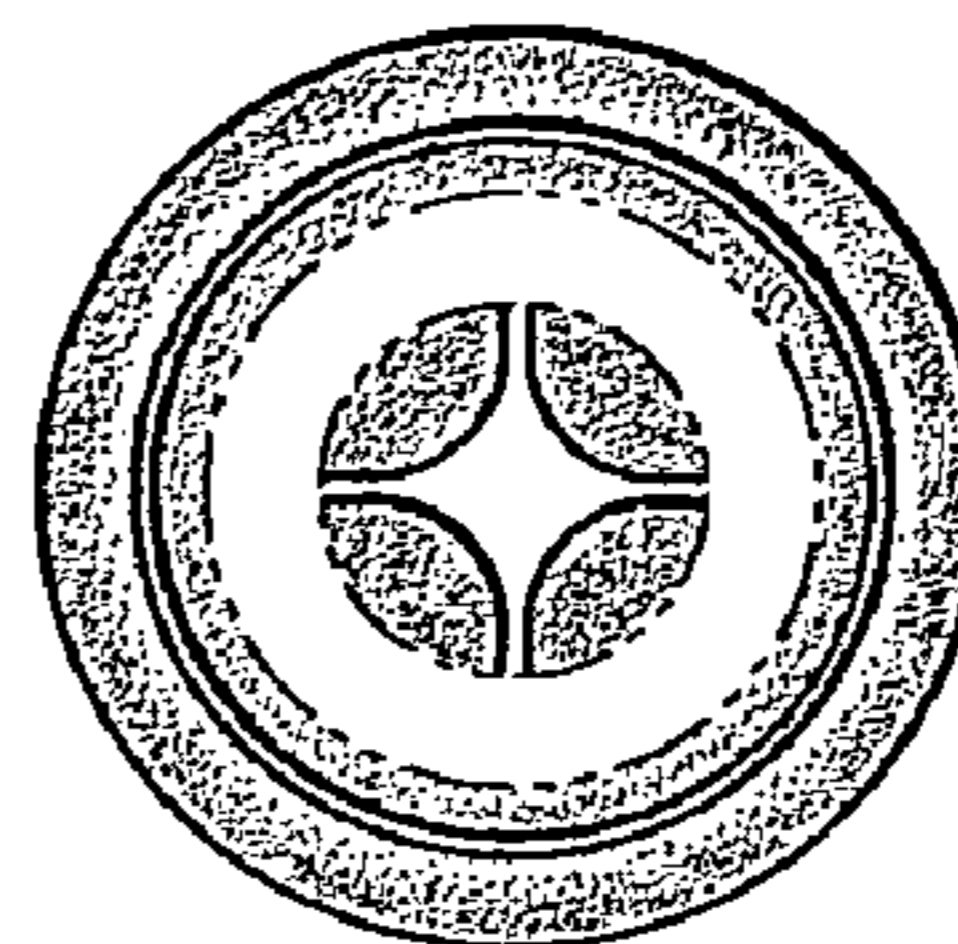

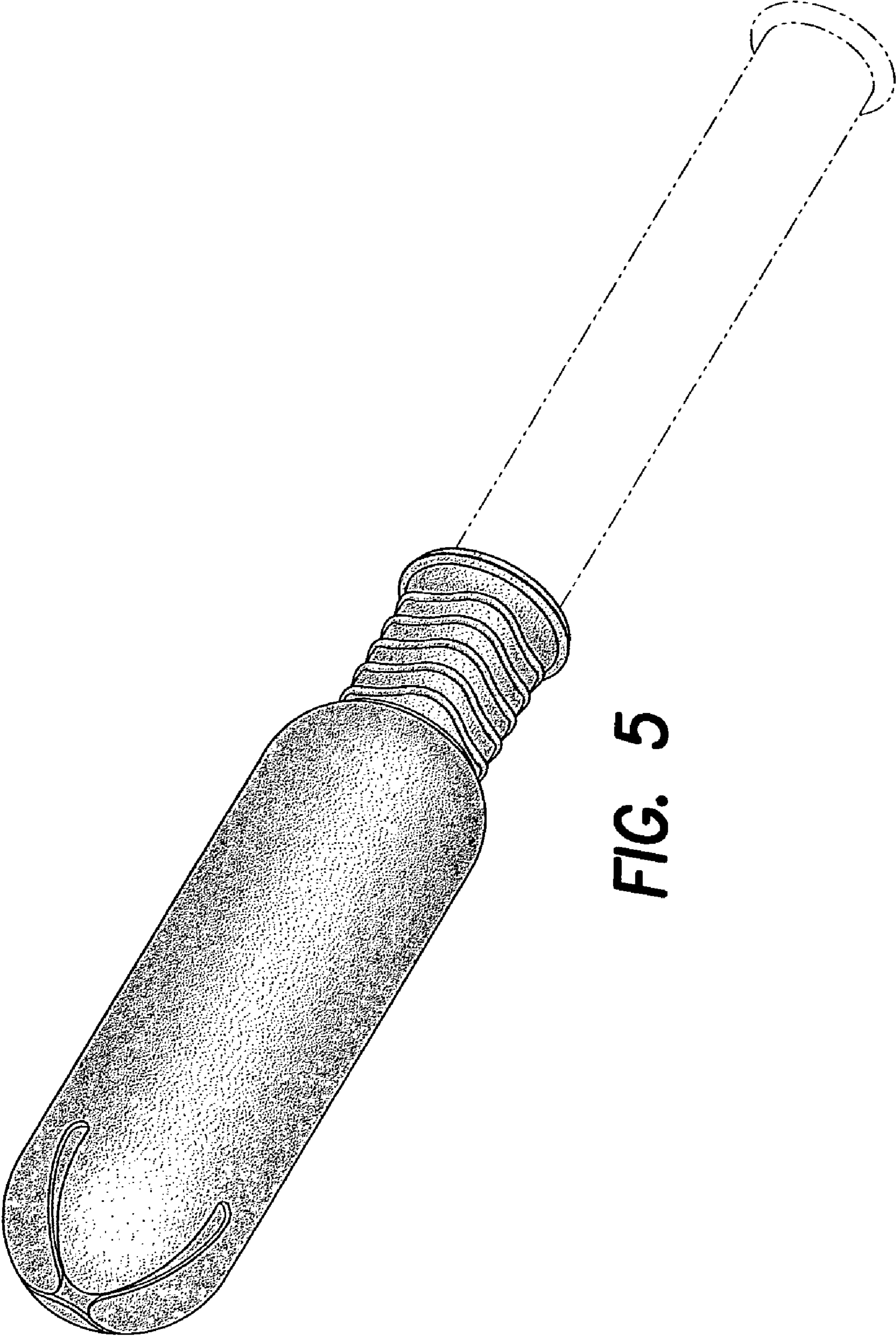

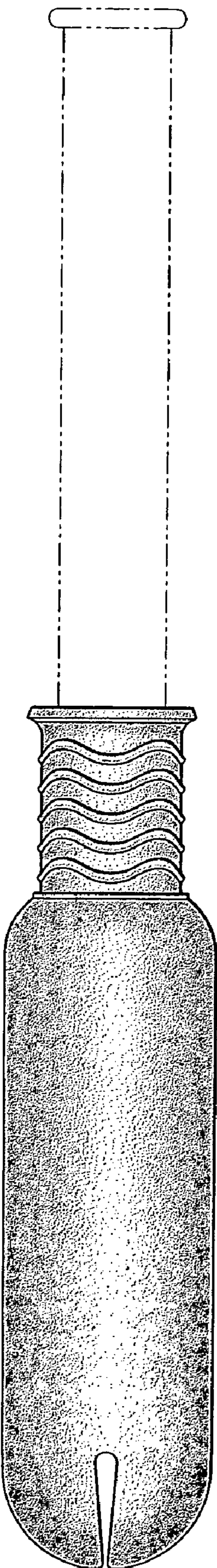

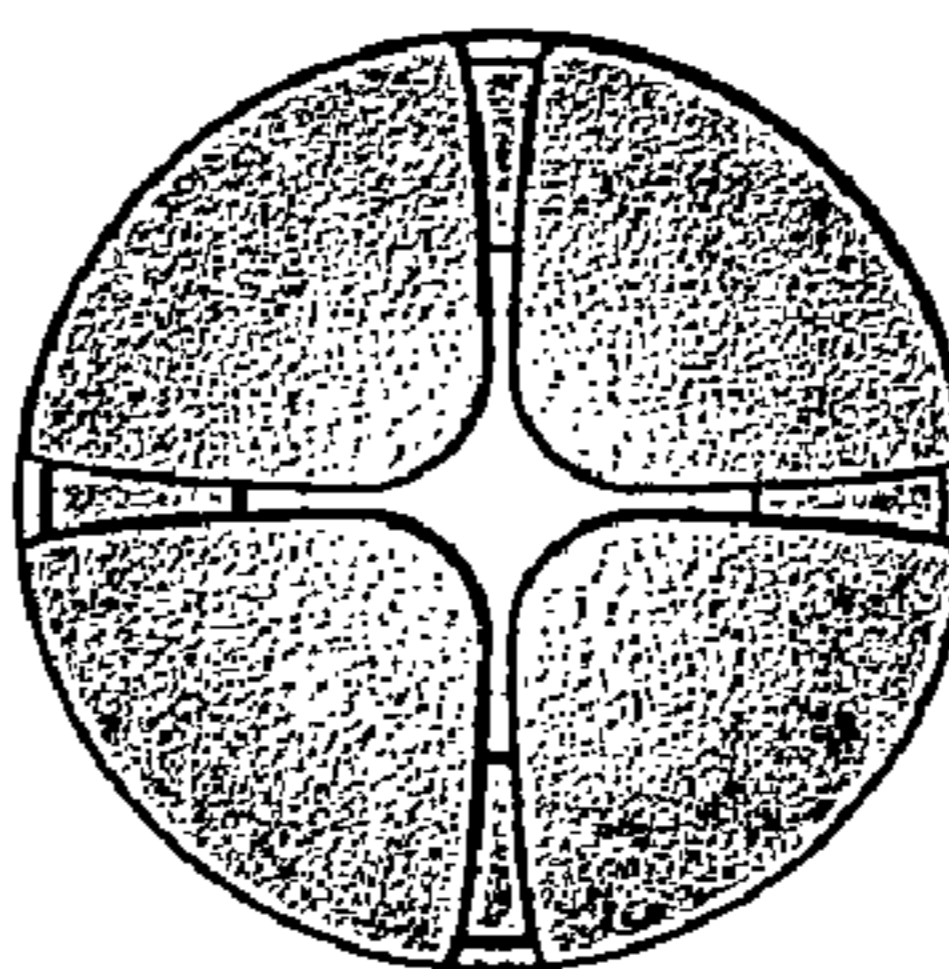

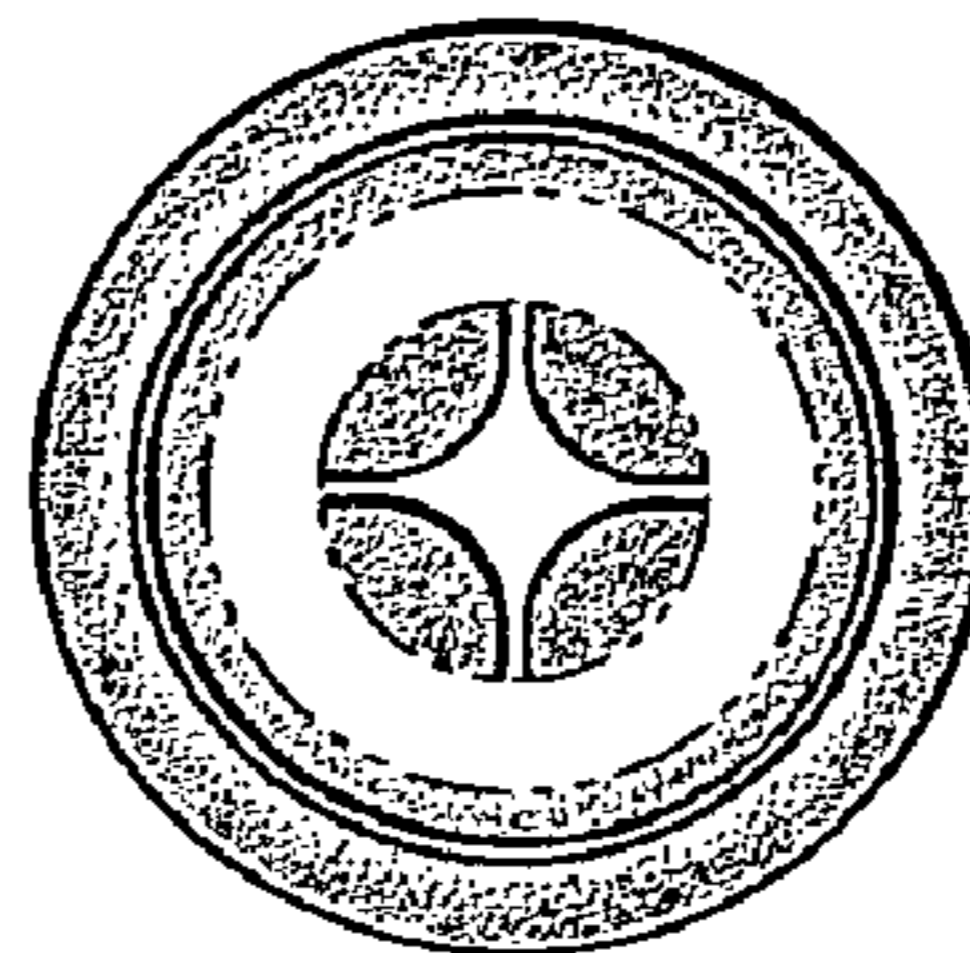
