**DESCRIPTION**

FIG. 5 is a right side view of the dog coat of FIG. 1;

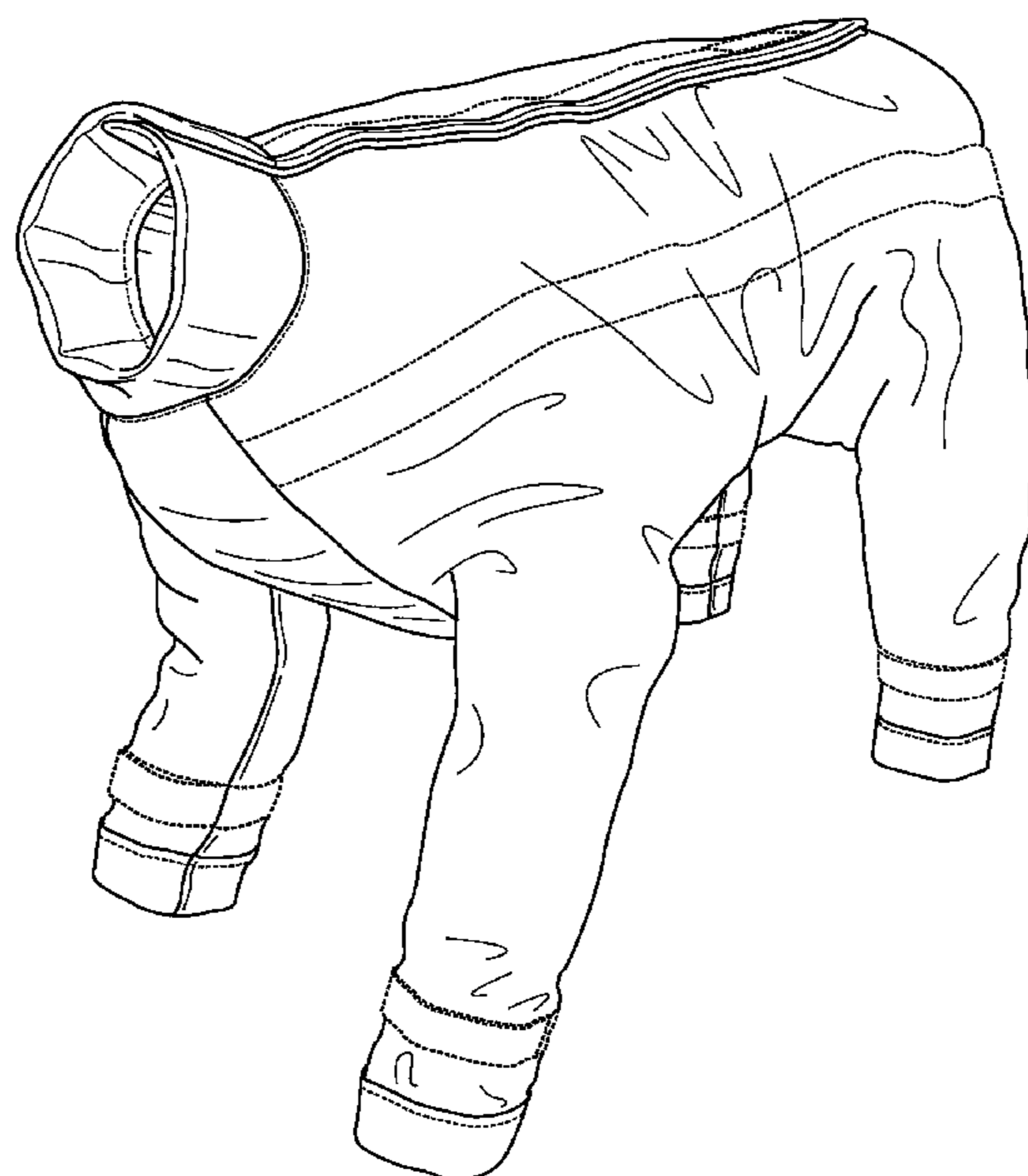
FIG. 6 is a back view of the dog coat of FIG. 1;

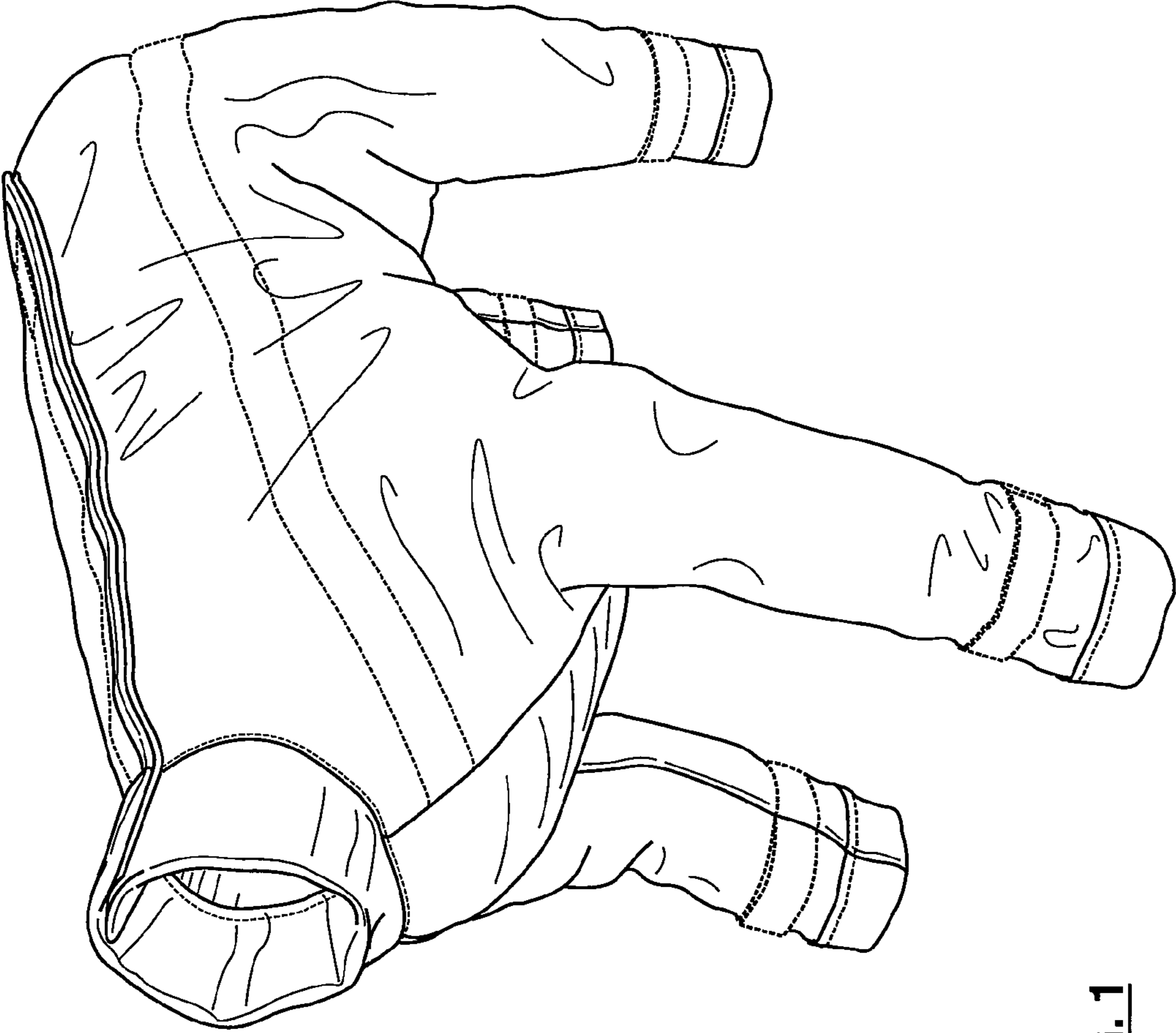
FIG. 7 is a top view of the dog coat of FIG. 1; and,

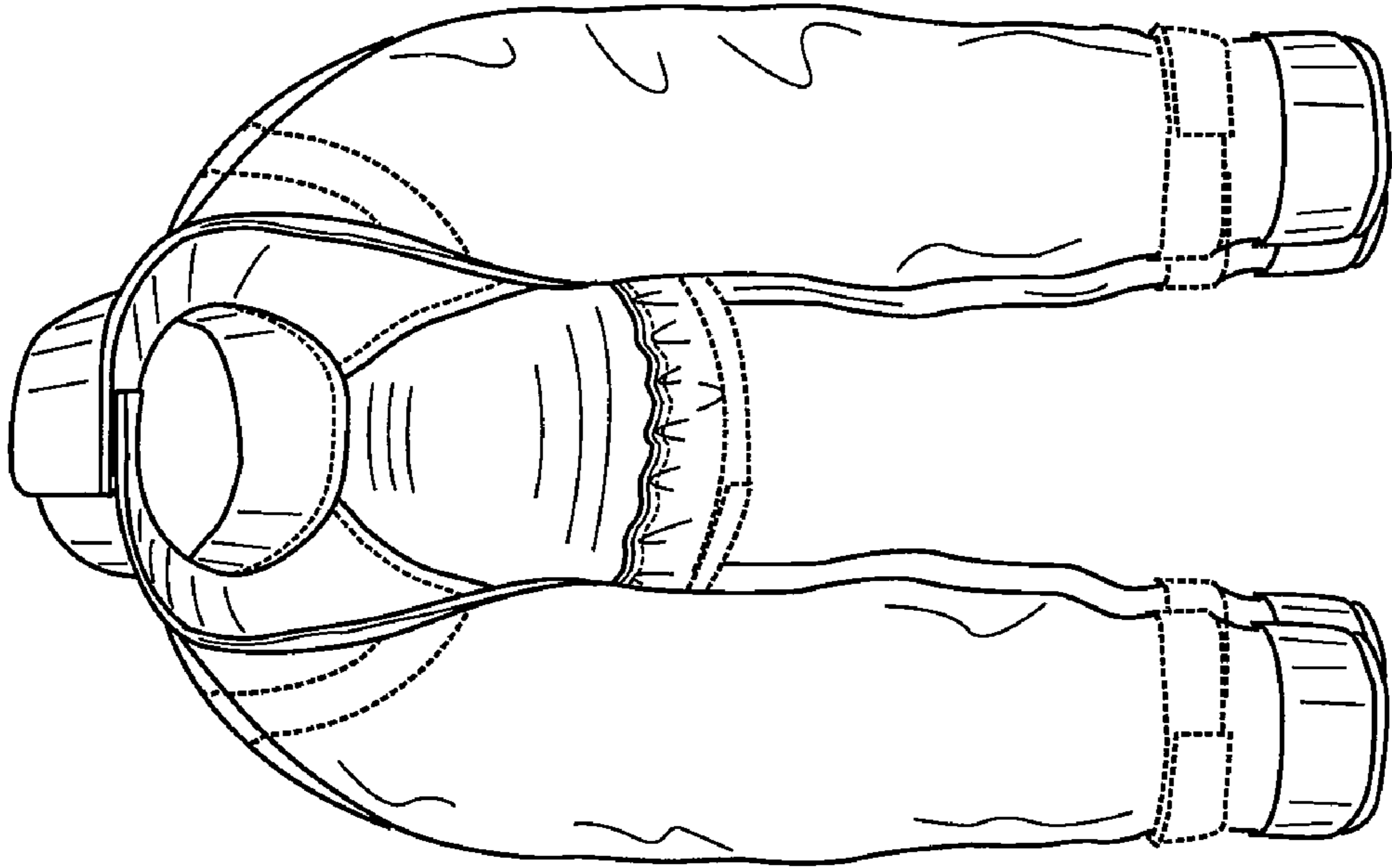

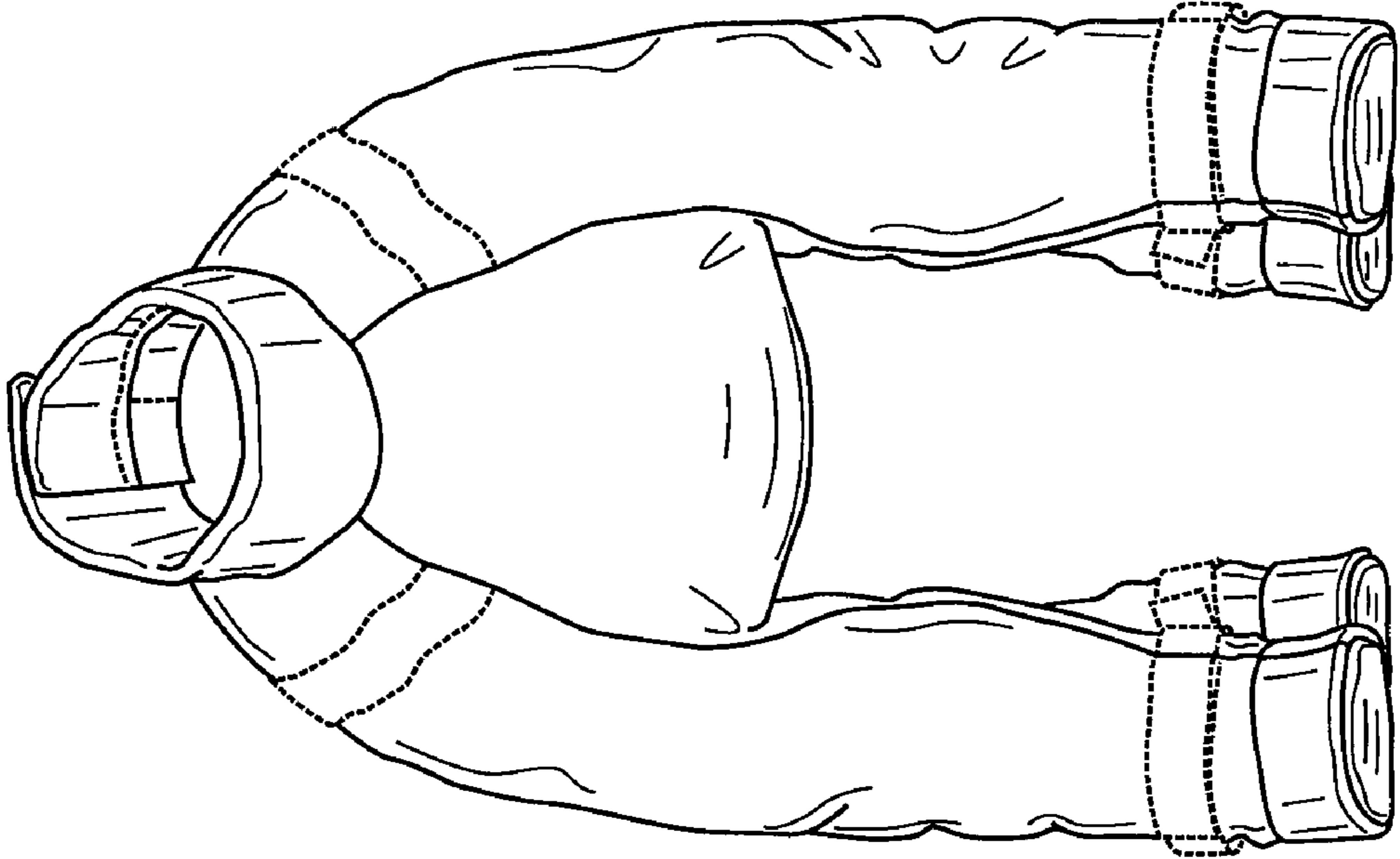

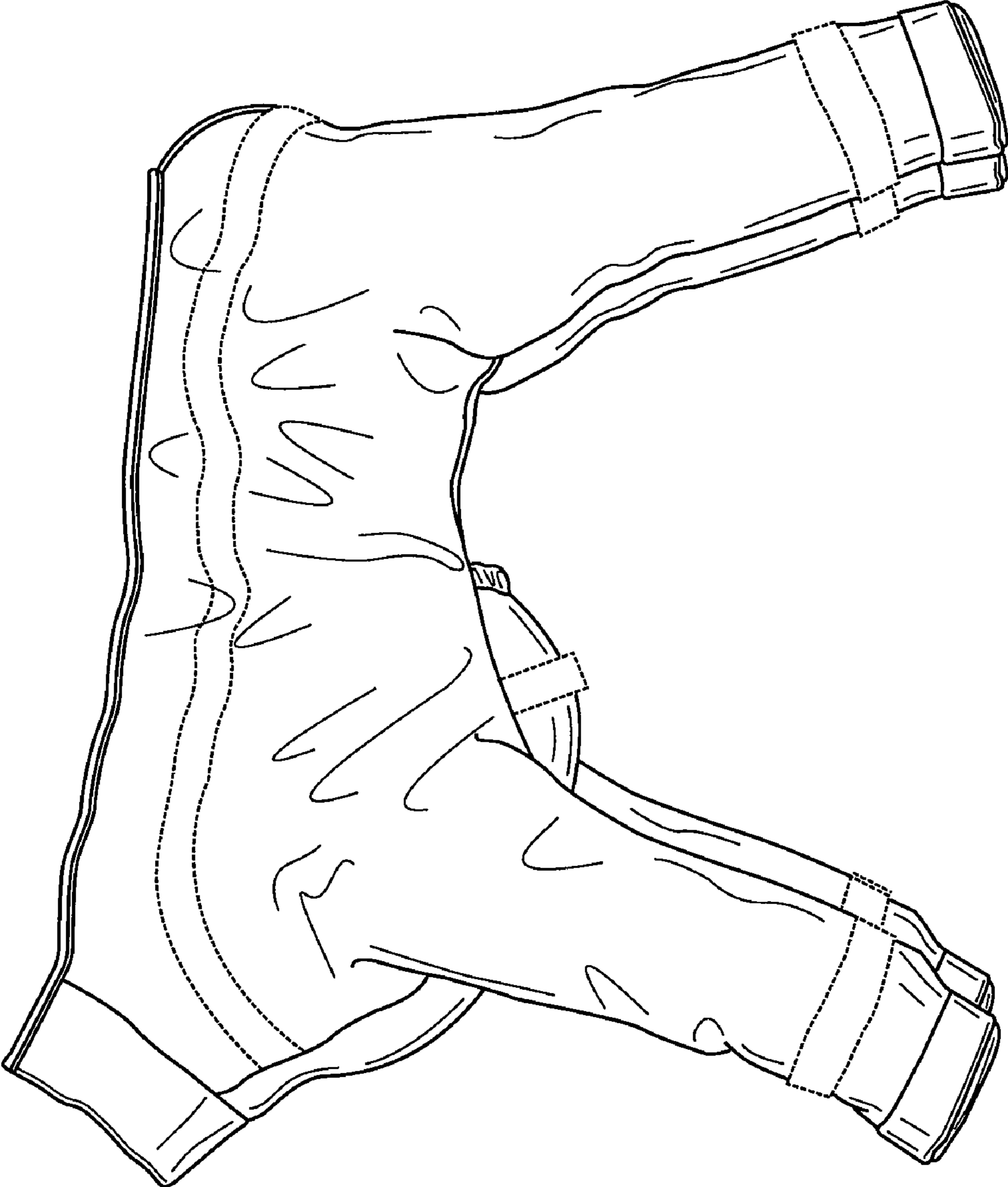

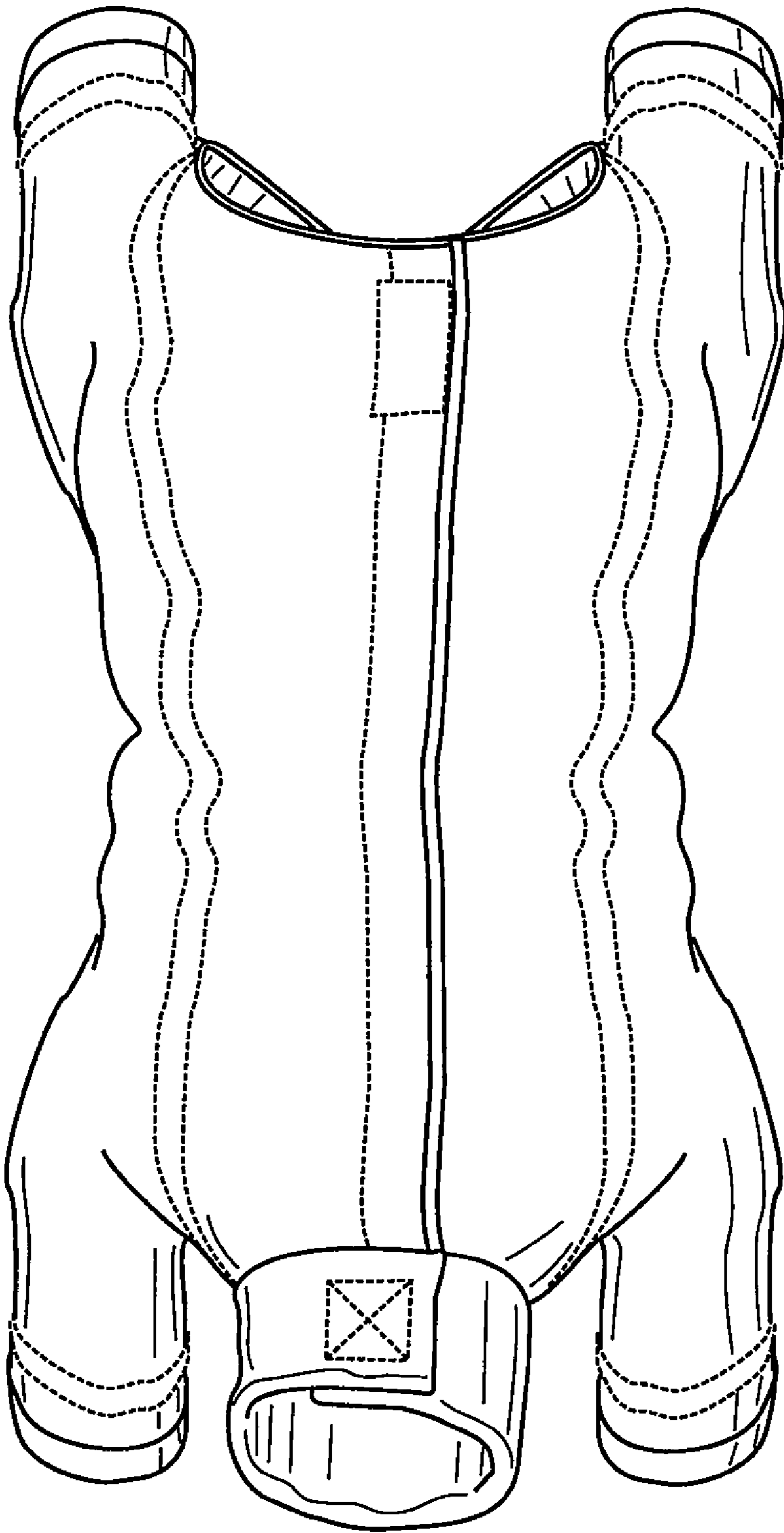

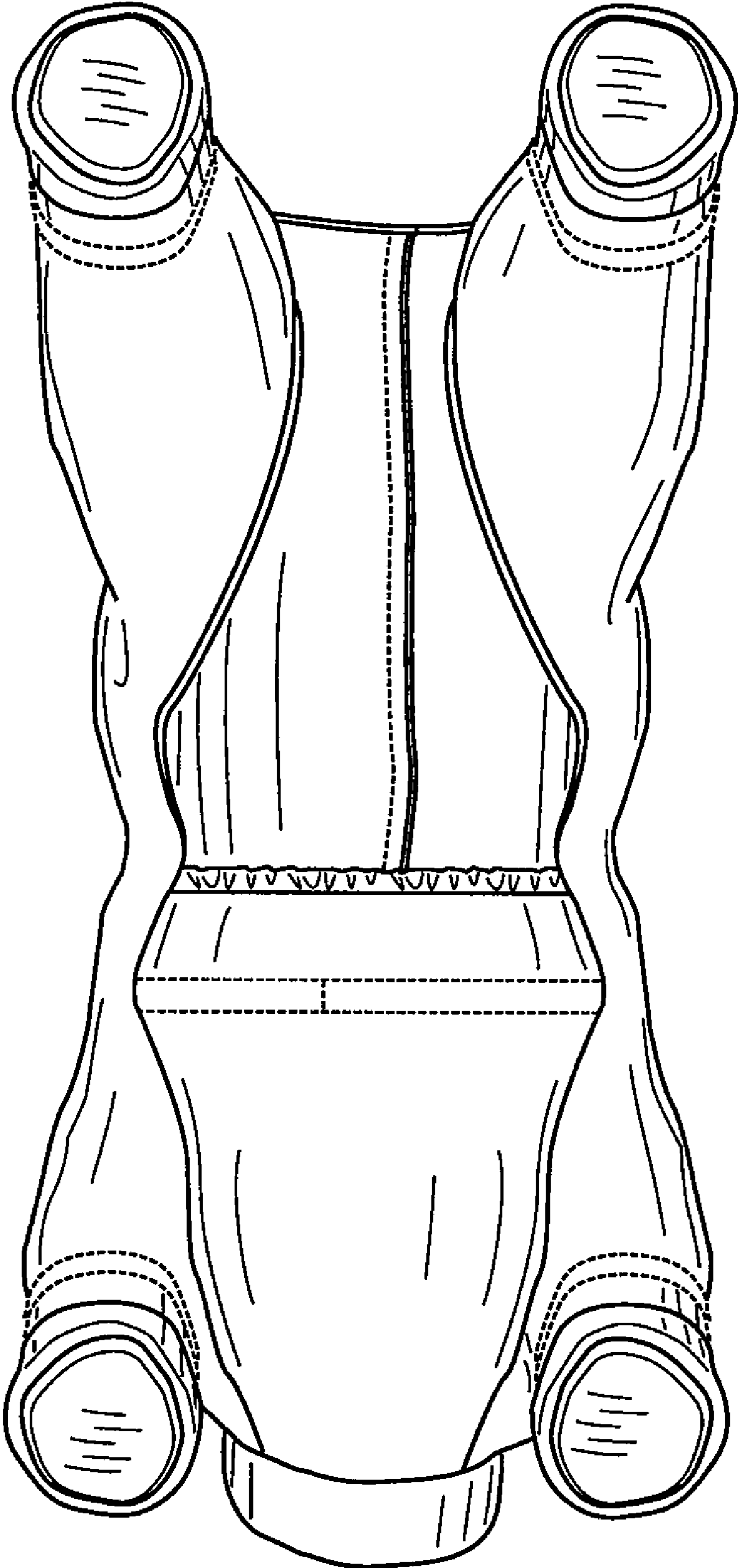
