I claim the ornamental design for a round breast support pad, as shown and described.

FIG. 1 is a rear perspective view of a round breast support pad;

FIG. 4 is a bottom view thereof;

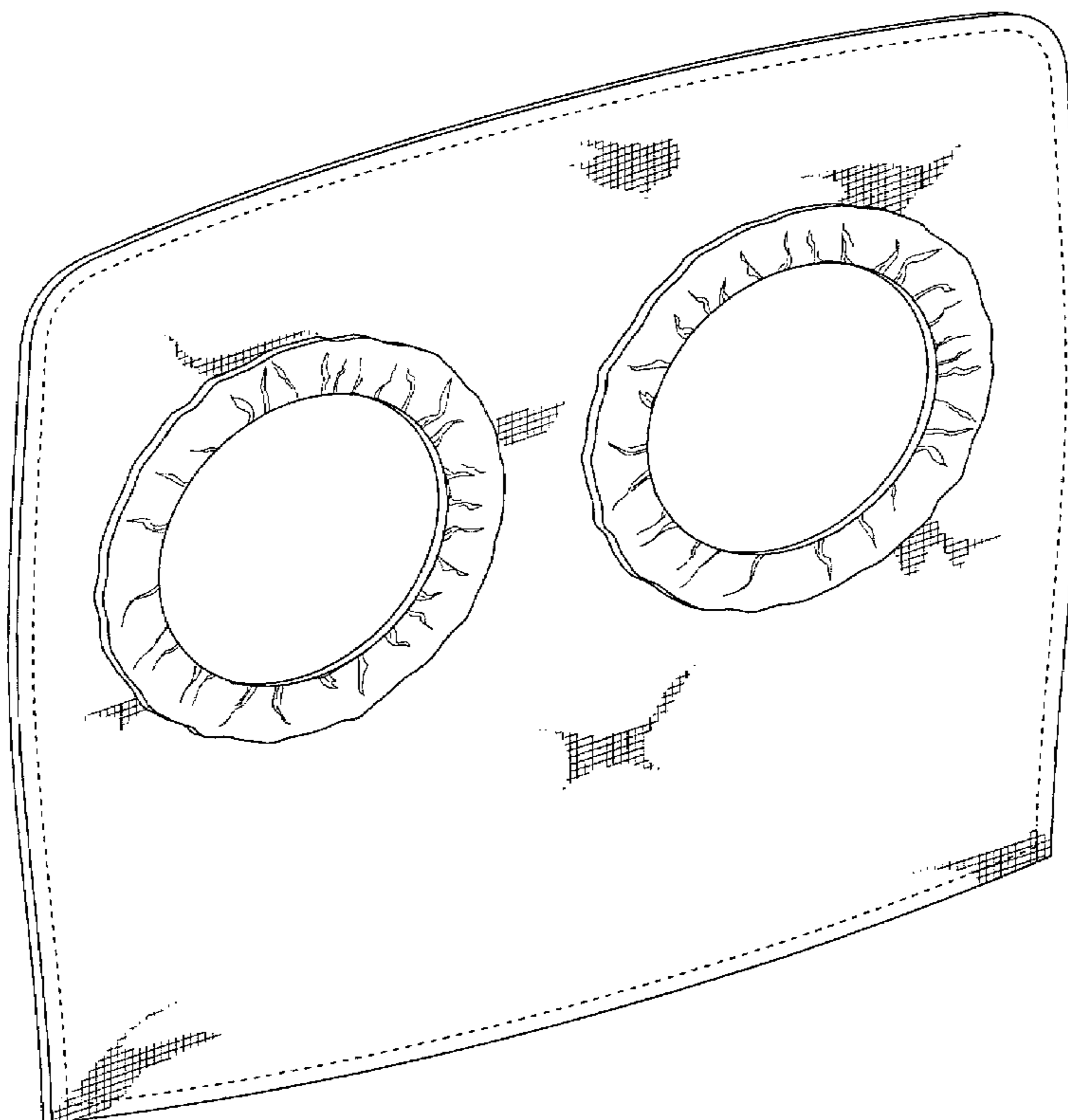
FIG. 5 is a left side view thereof;

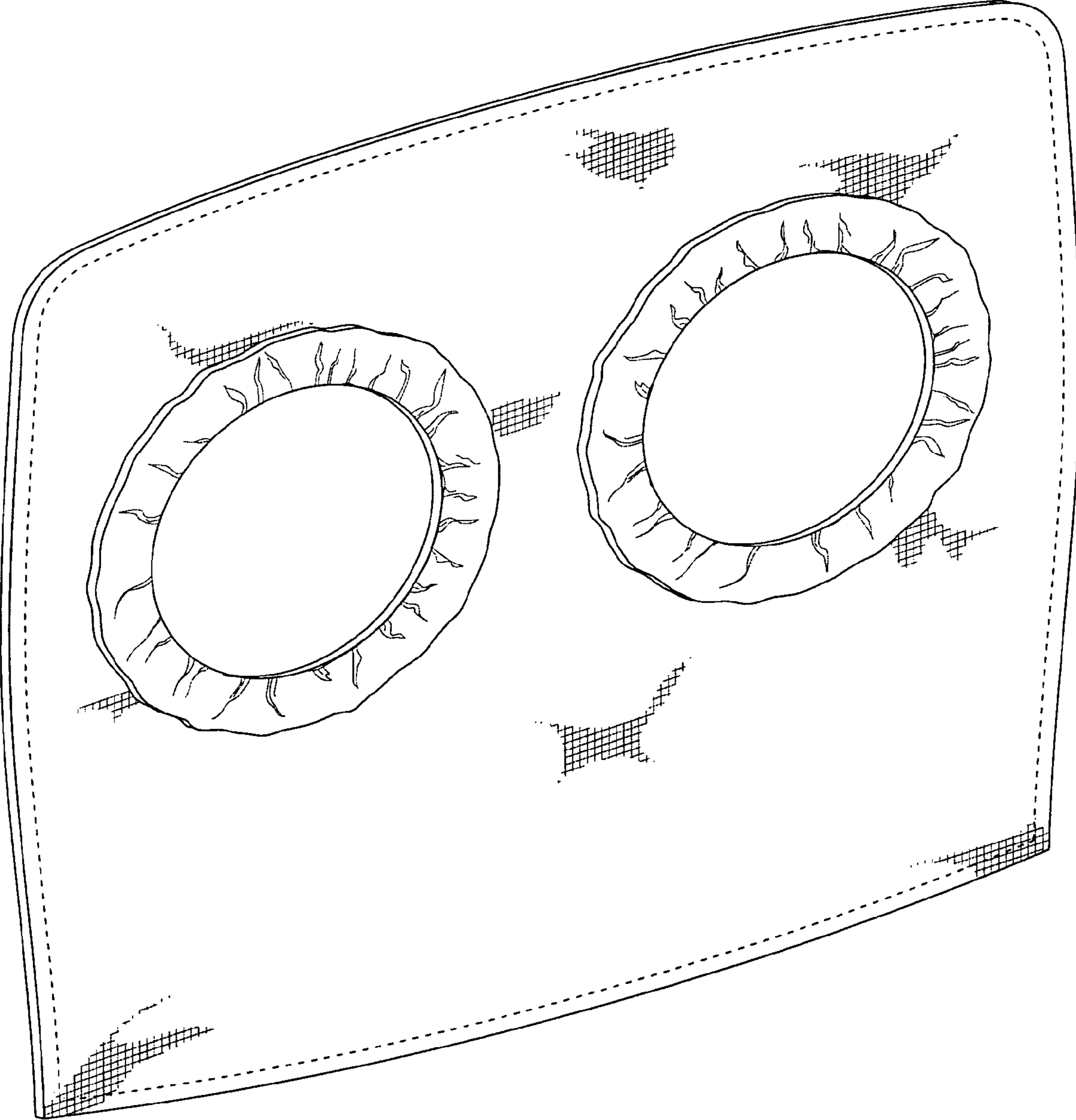

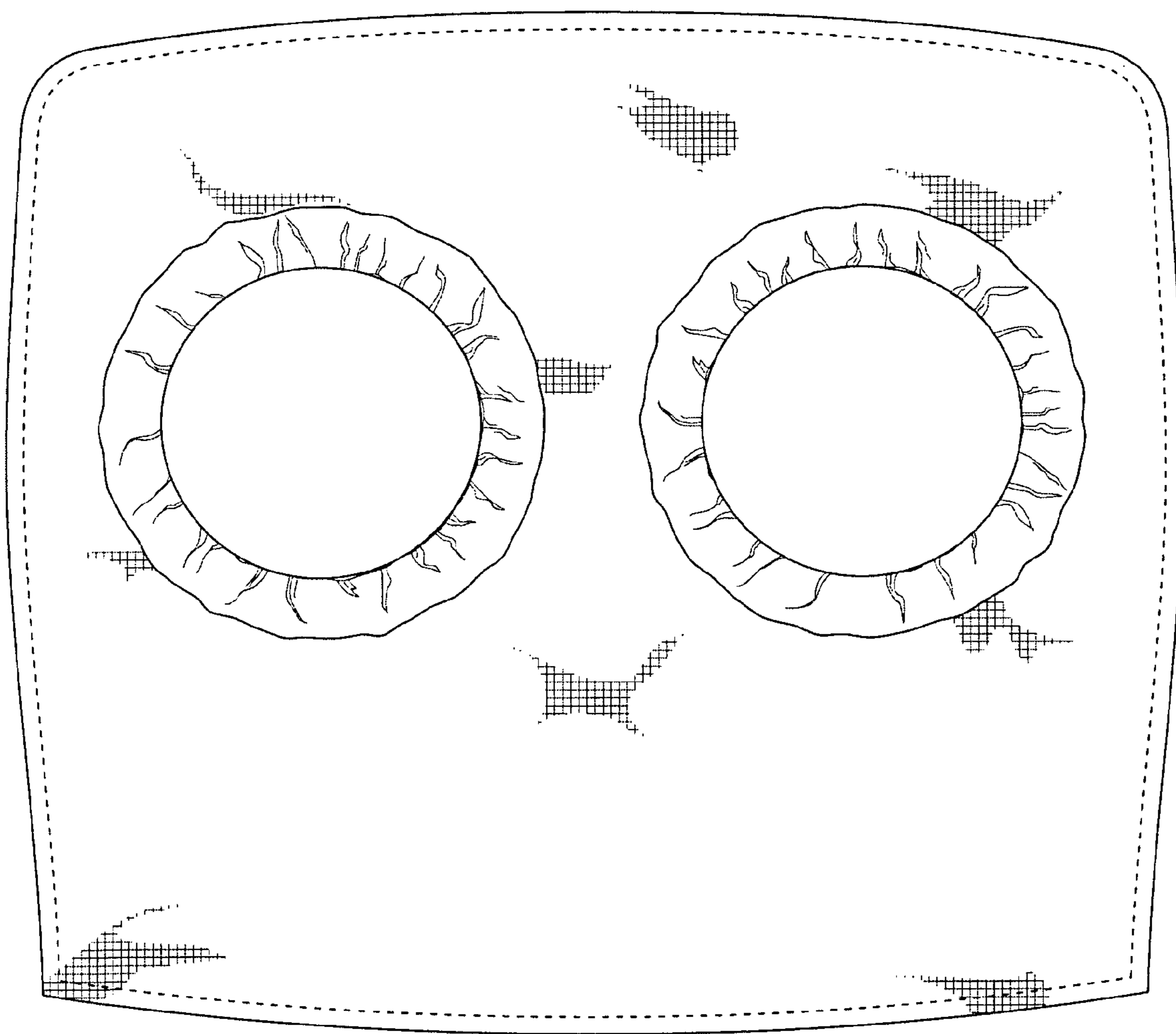

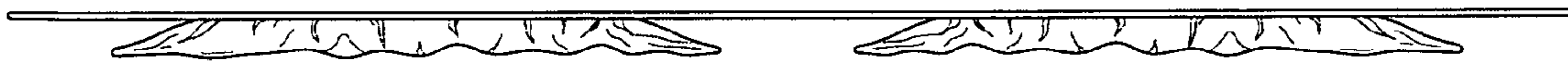

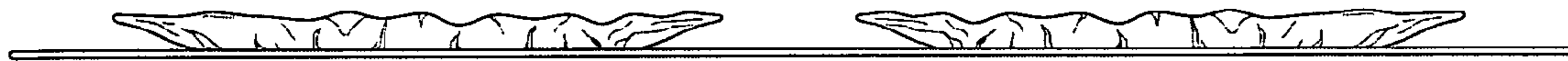

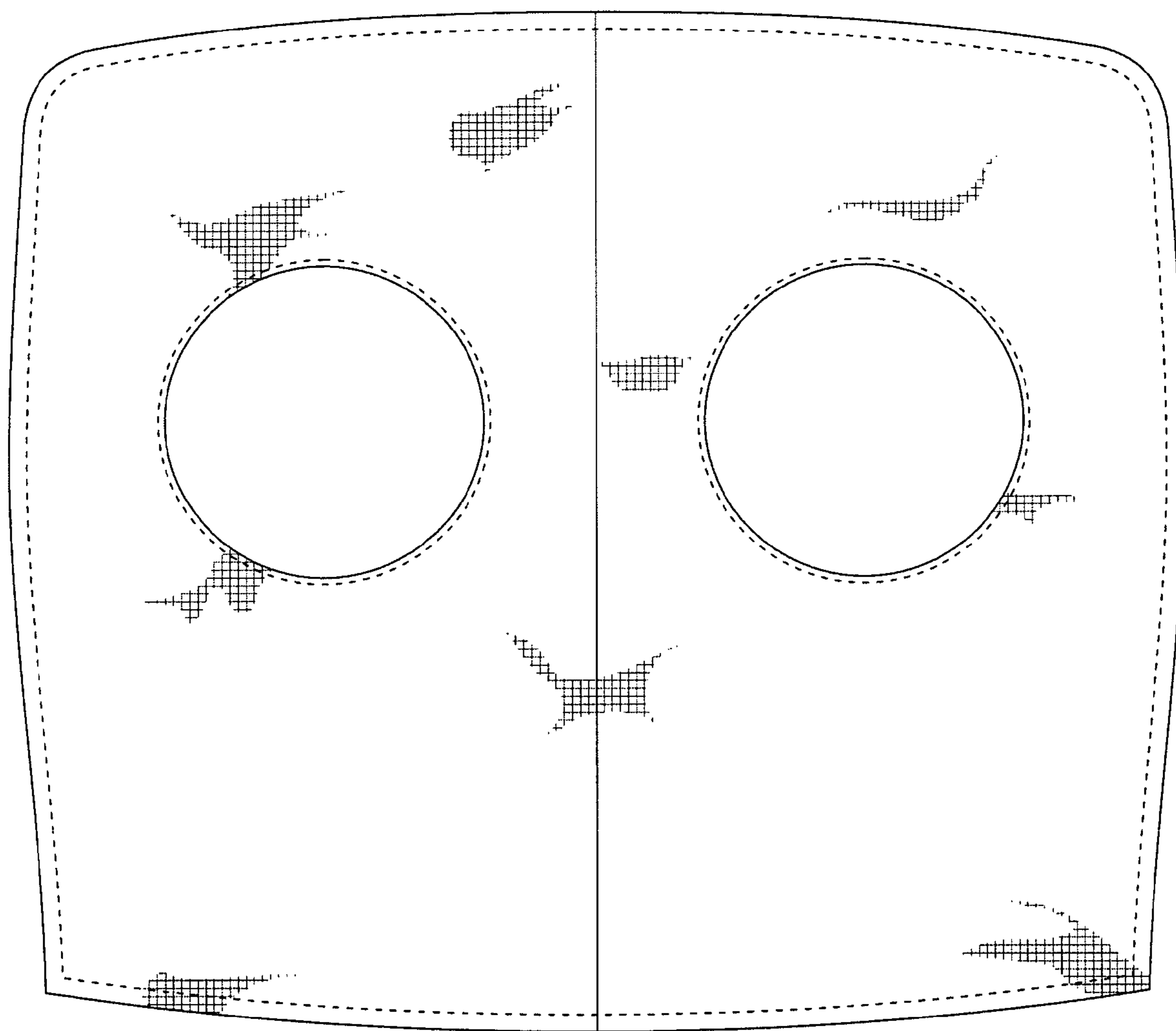
