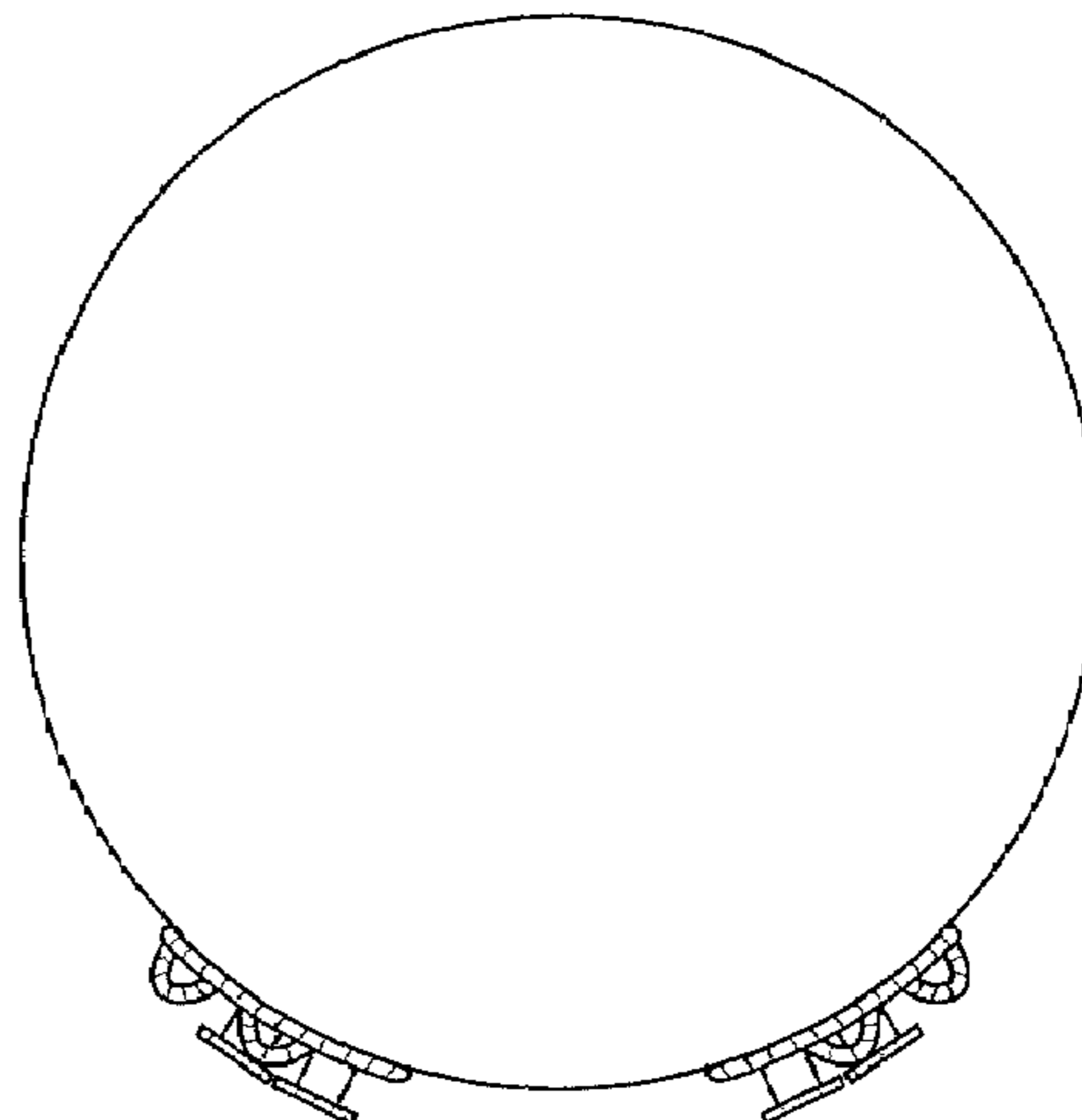
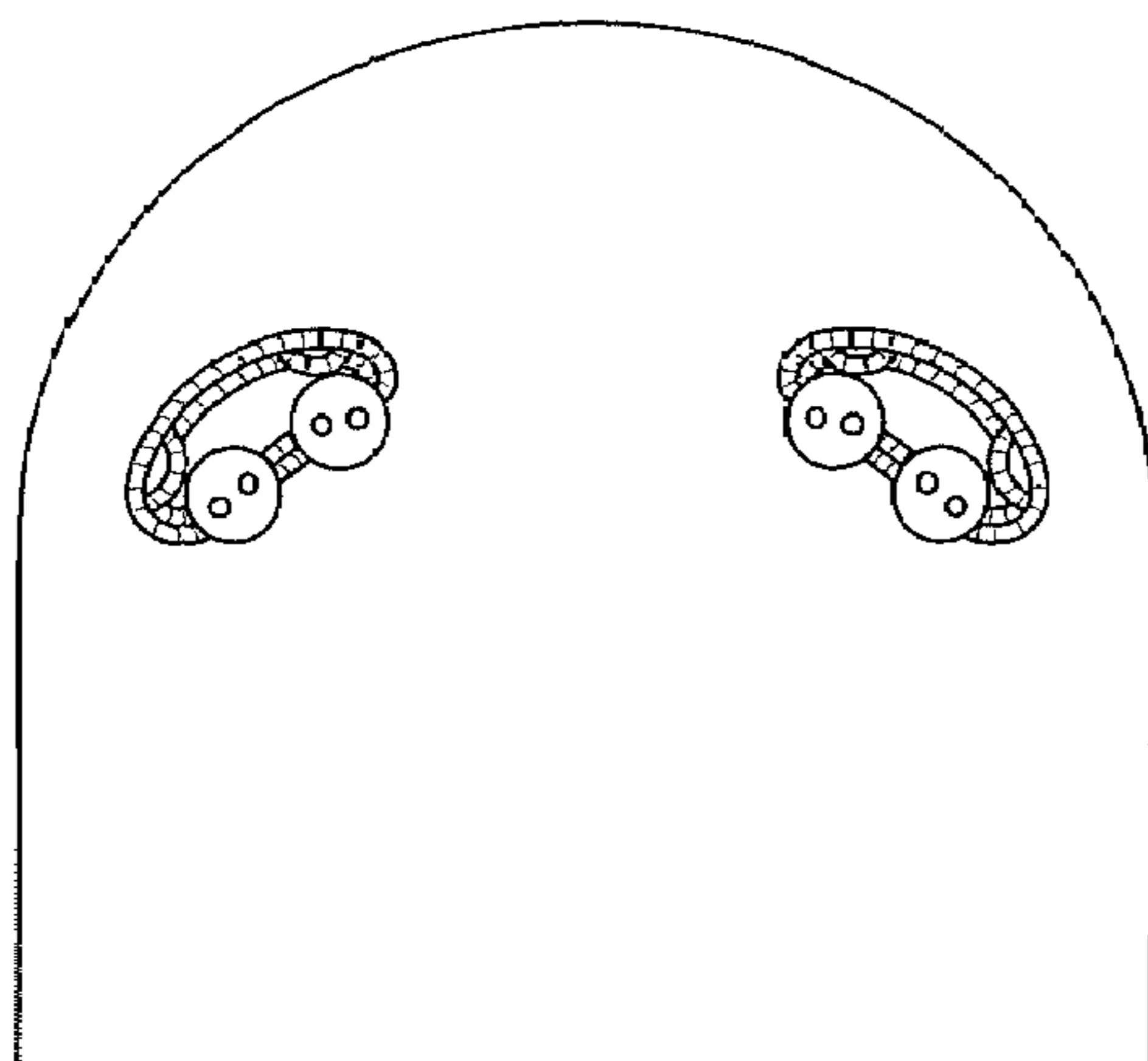
(57) **CLAIM**

An ornamental design for a beanie with openings having button and loop closures, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear elevational view of my new design in which the button and loop closures are shown in a fully open position;  
FIG. 2 is a right side elevational view thereof, the left side elevational view being identical; and,  
FIG. 3 is a top plan view thereof.

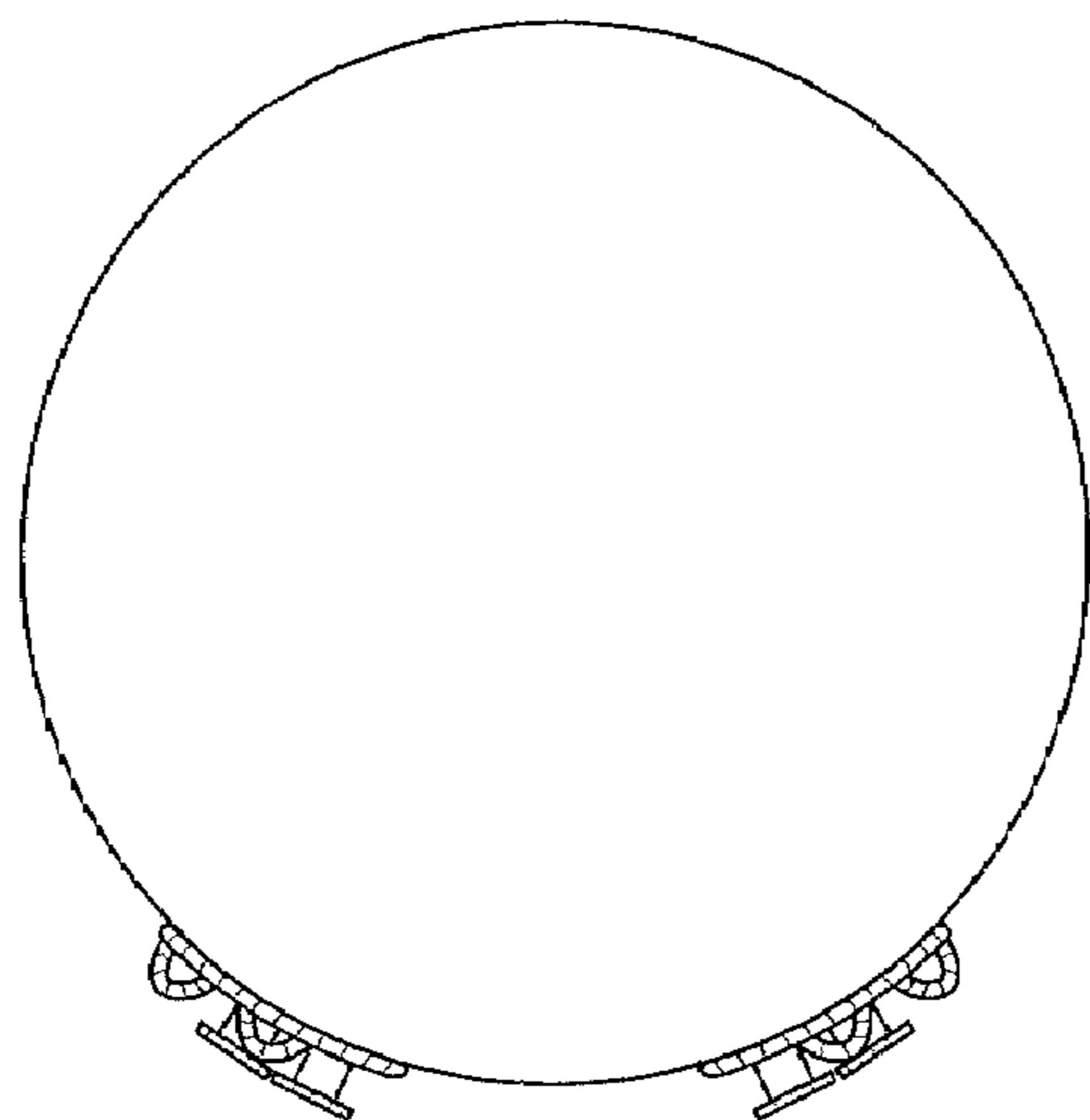

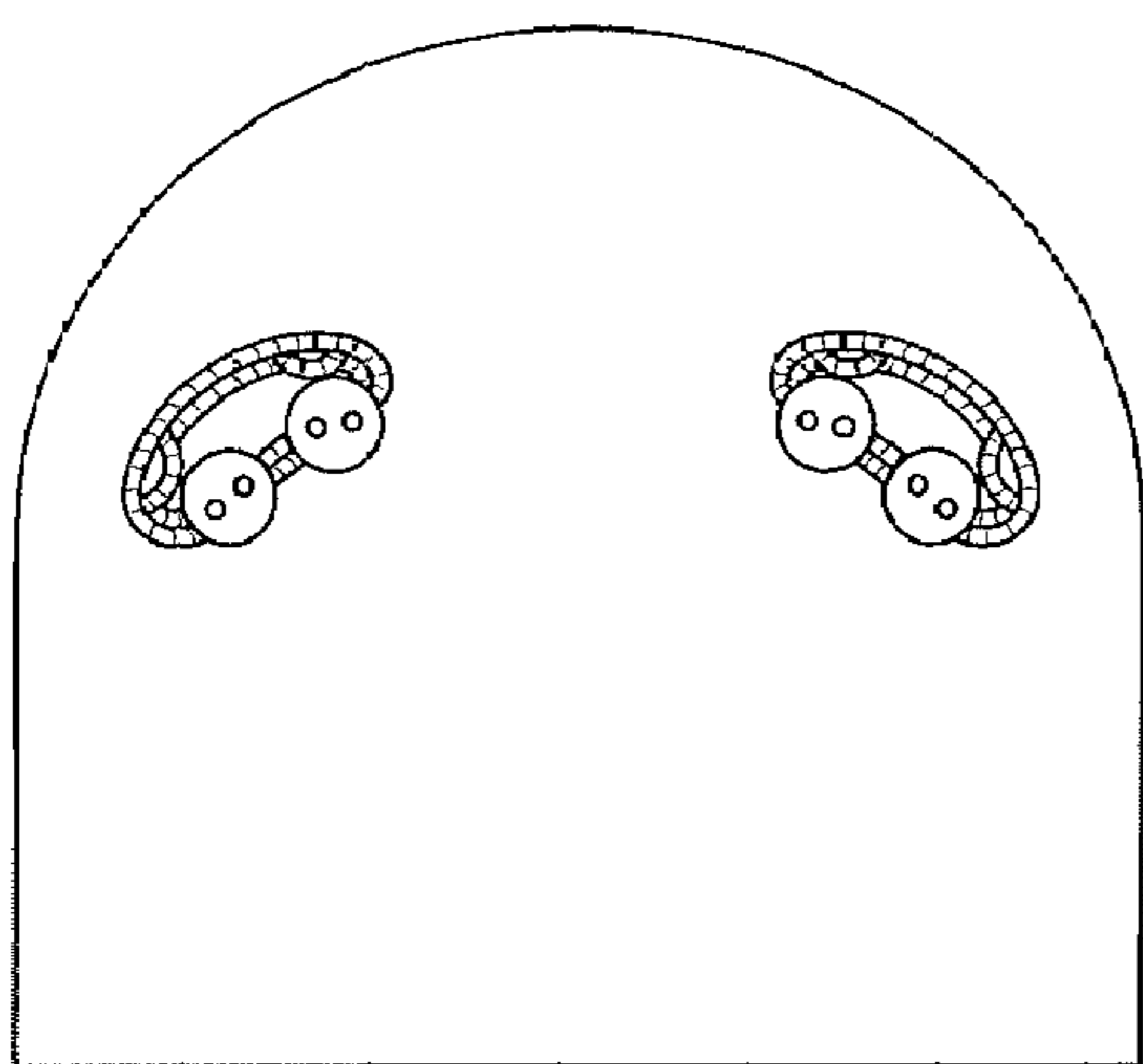

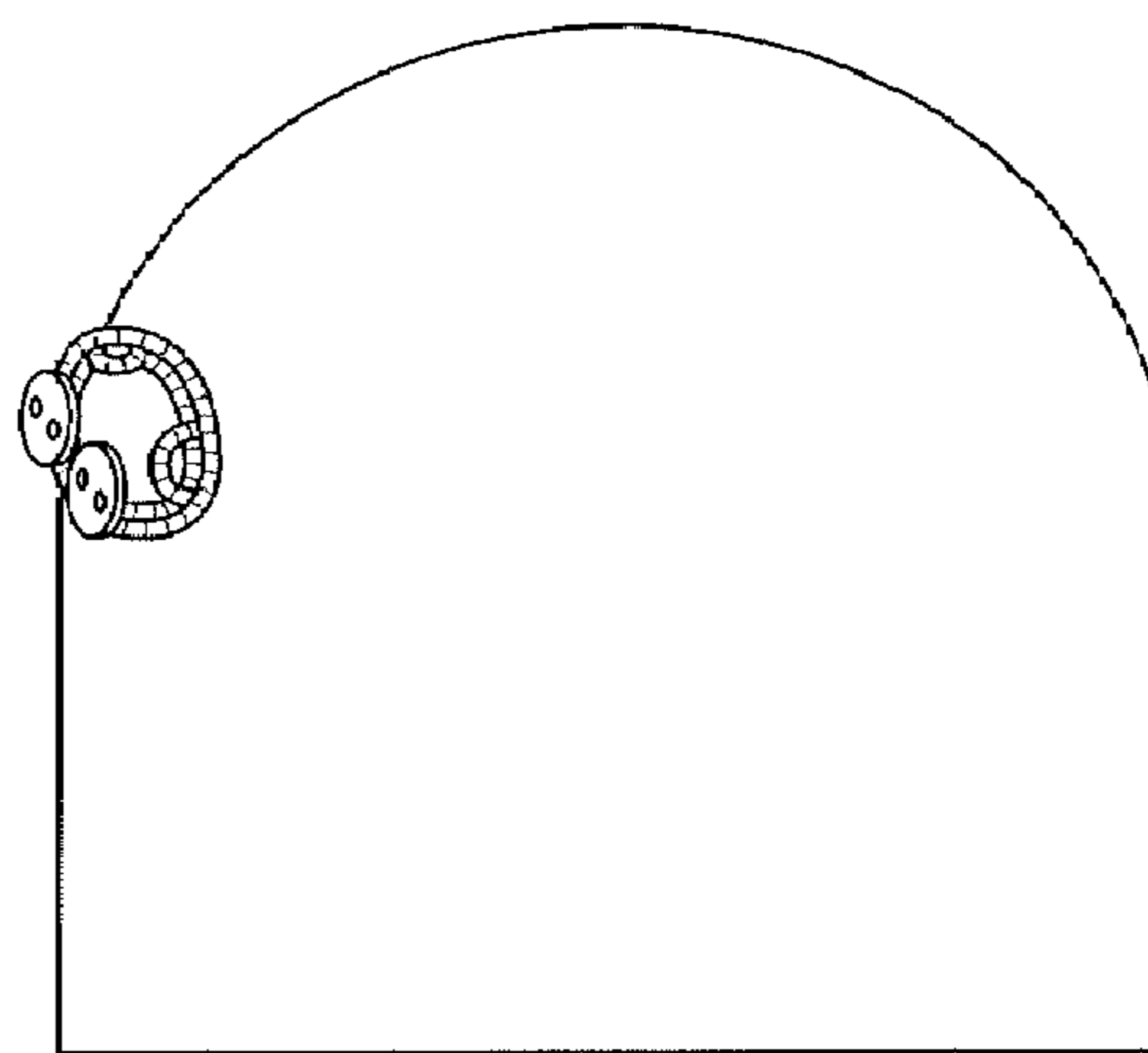
