DESCRIPTION

FIG. 3 is a bottom view thereof;

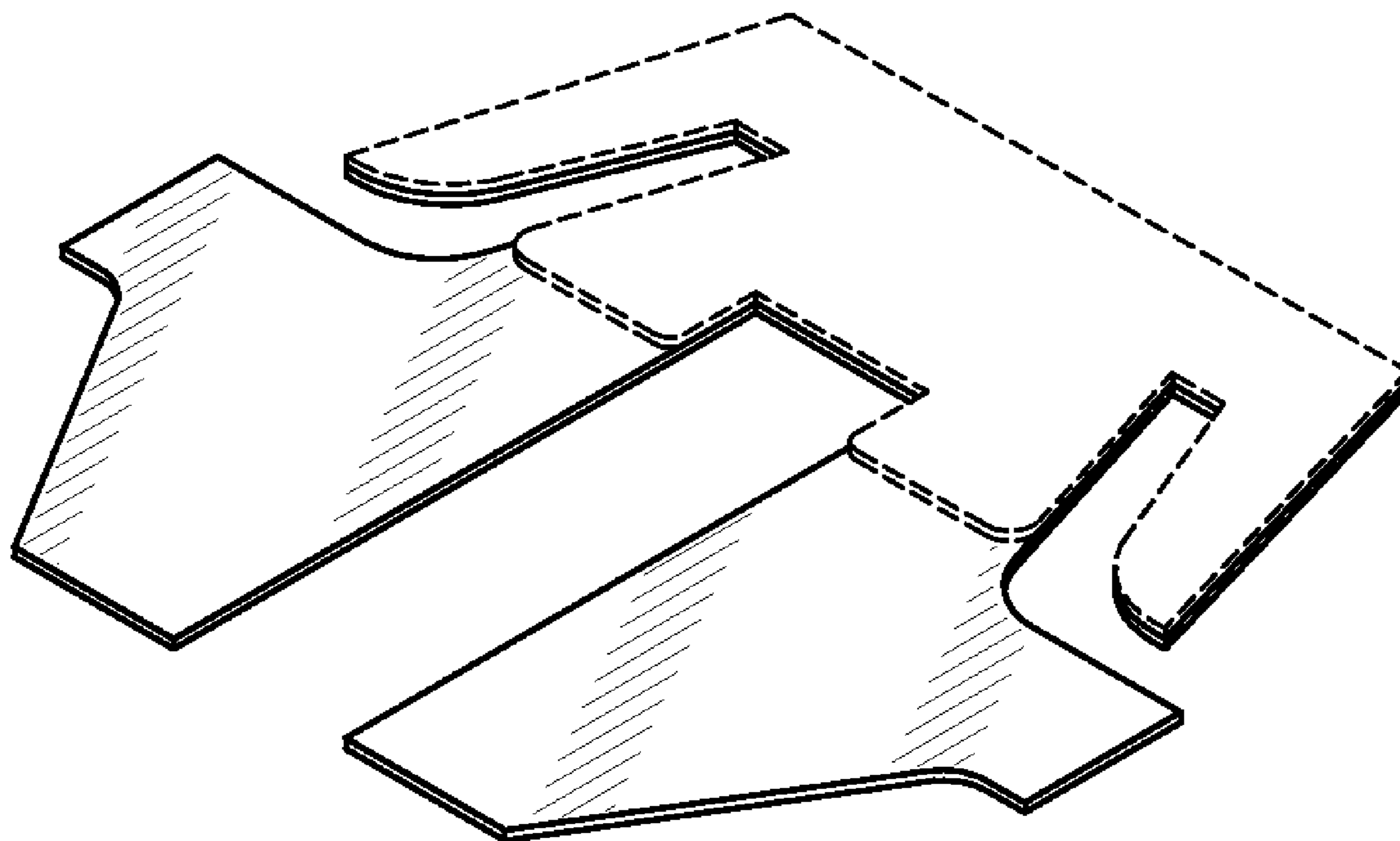
FIG. 4 is a rear view thereof;

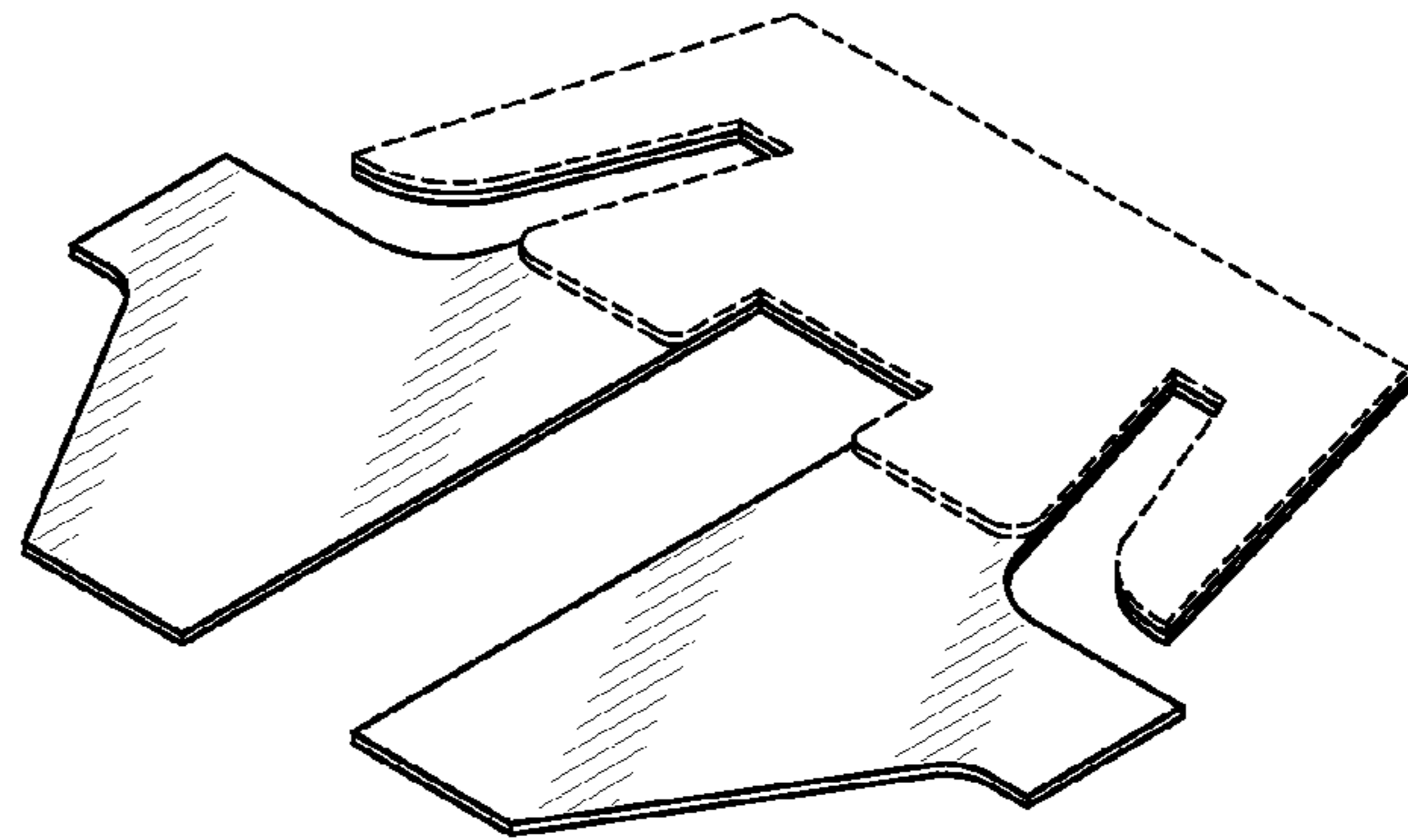

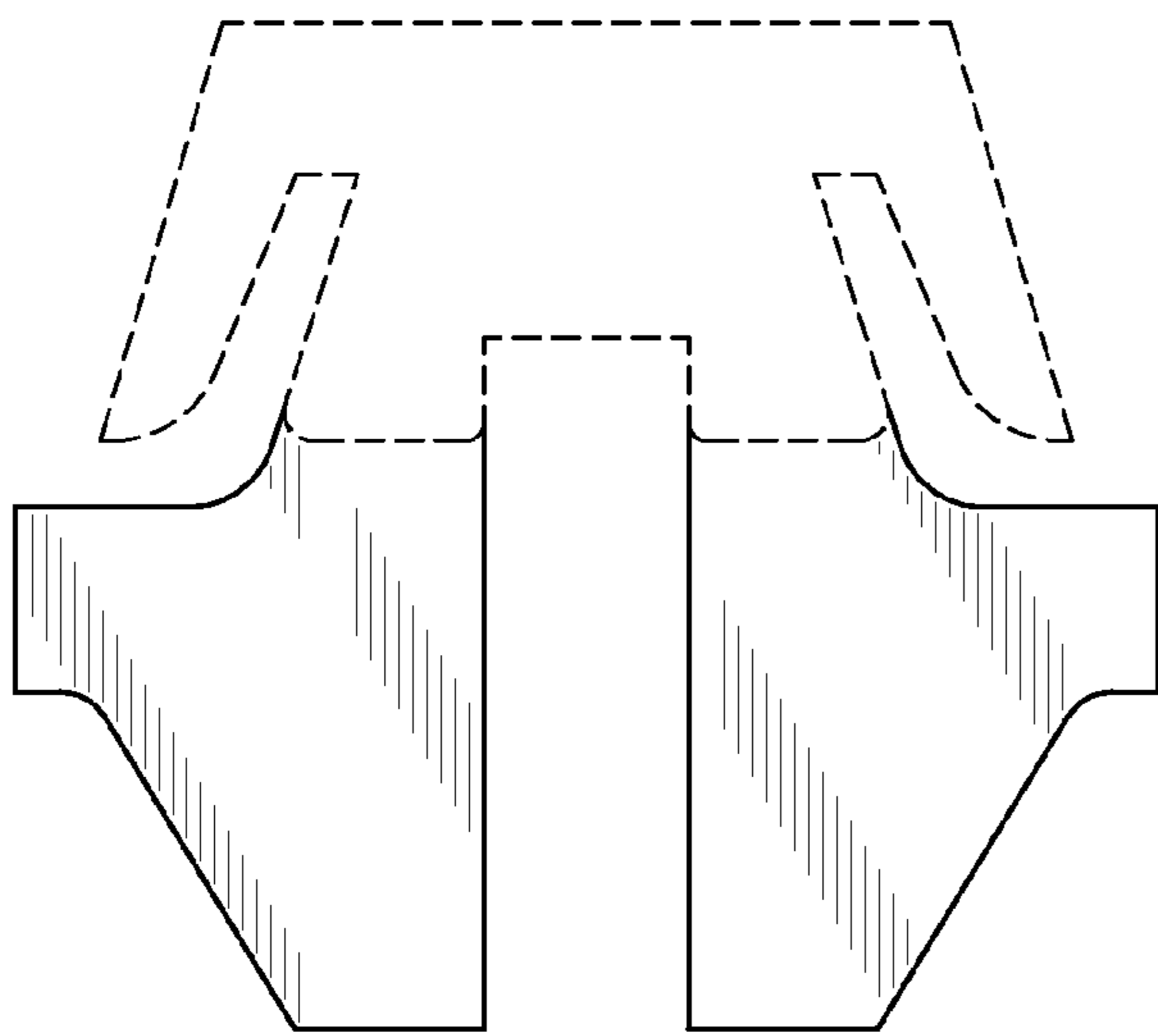

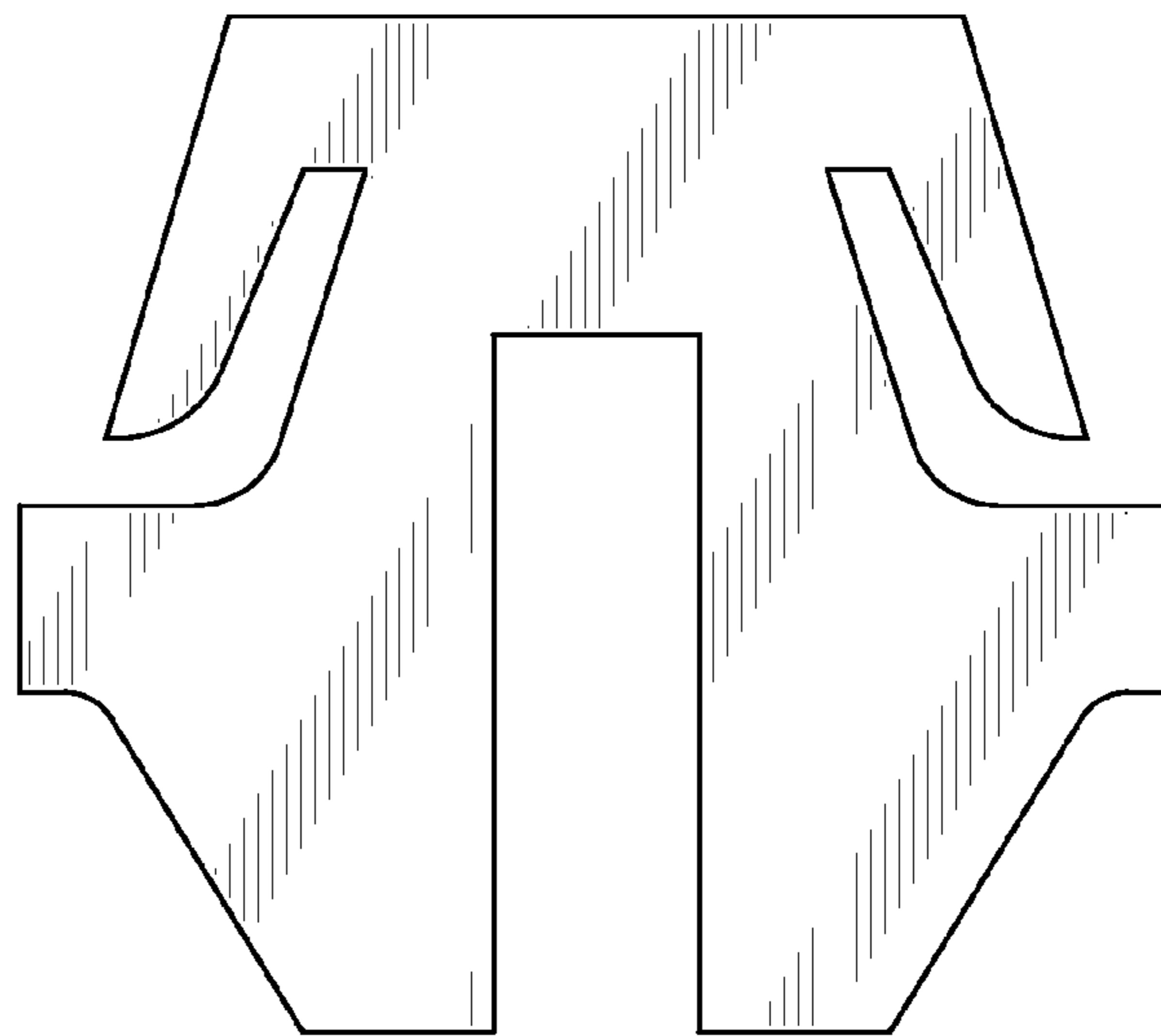

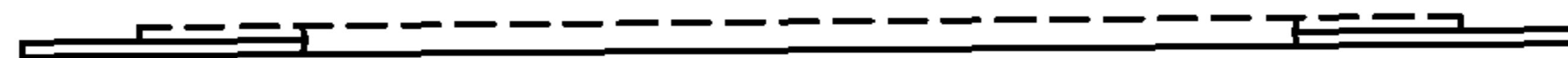
