(57) **CLAIM**

An ornamental design for a compartmented tray for promotional merchandise, as shown and described.

DESCRIPTION

FIG. 1 is a view of the front of a compartmented tray for promotional merchandise showing our new design;
FIG. 2 is the left side elevation view thereof;
FIG. 3 is the right side elevation view thereof;
FIG. 4 is view of the back thereof; and,

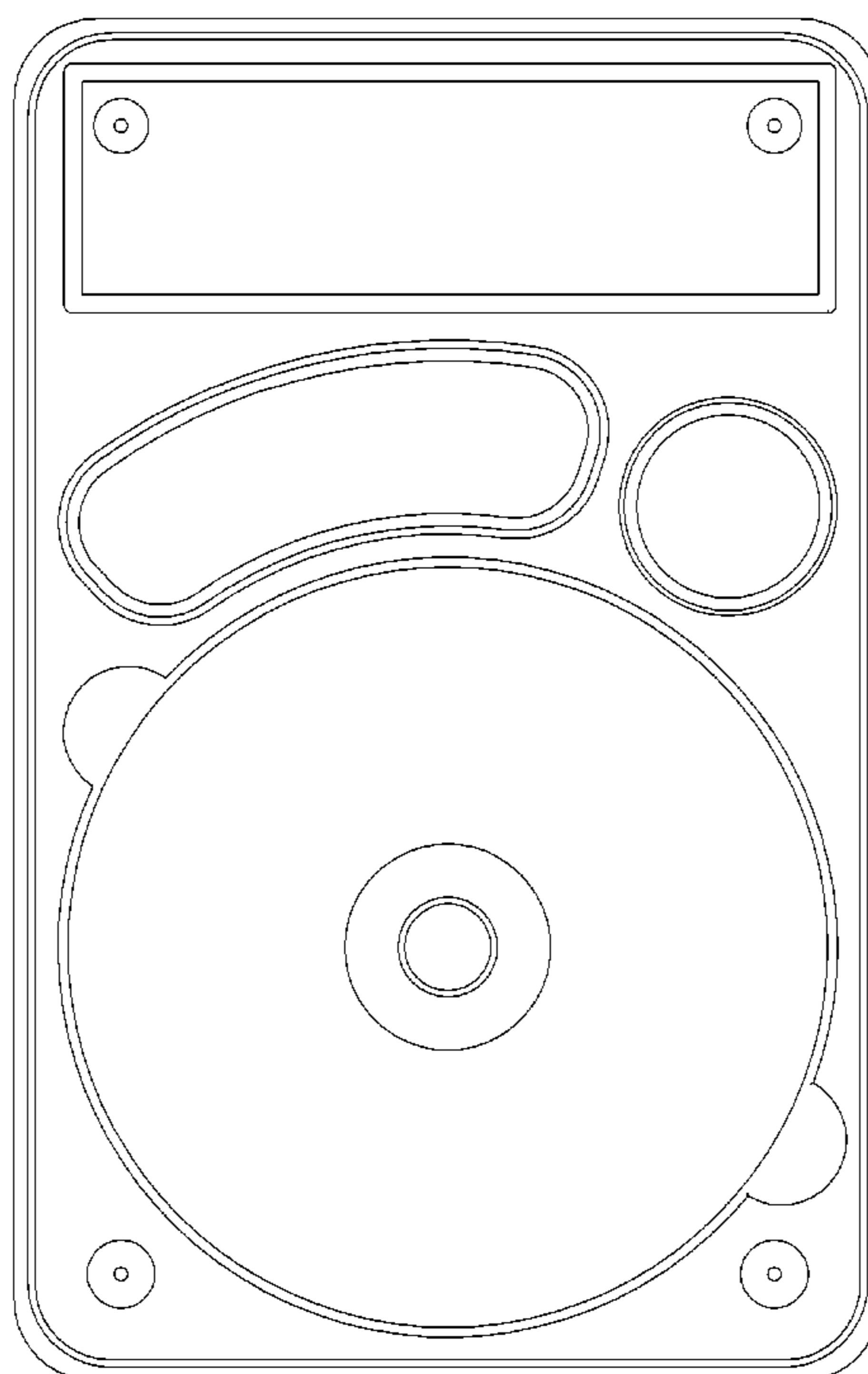

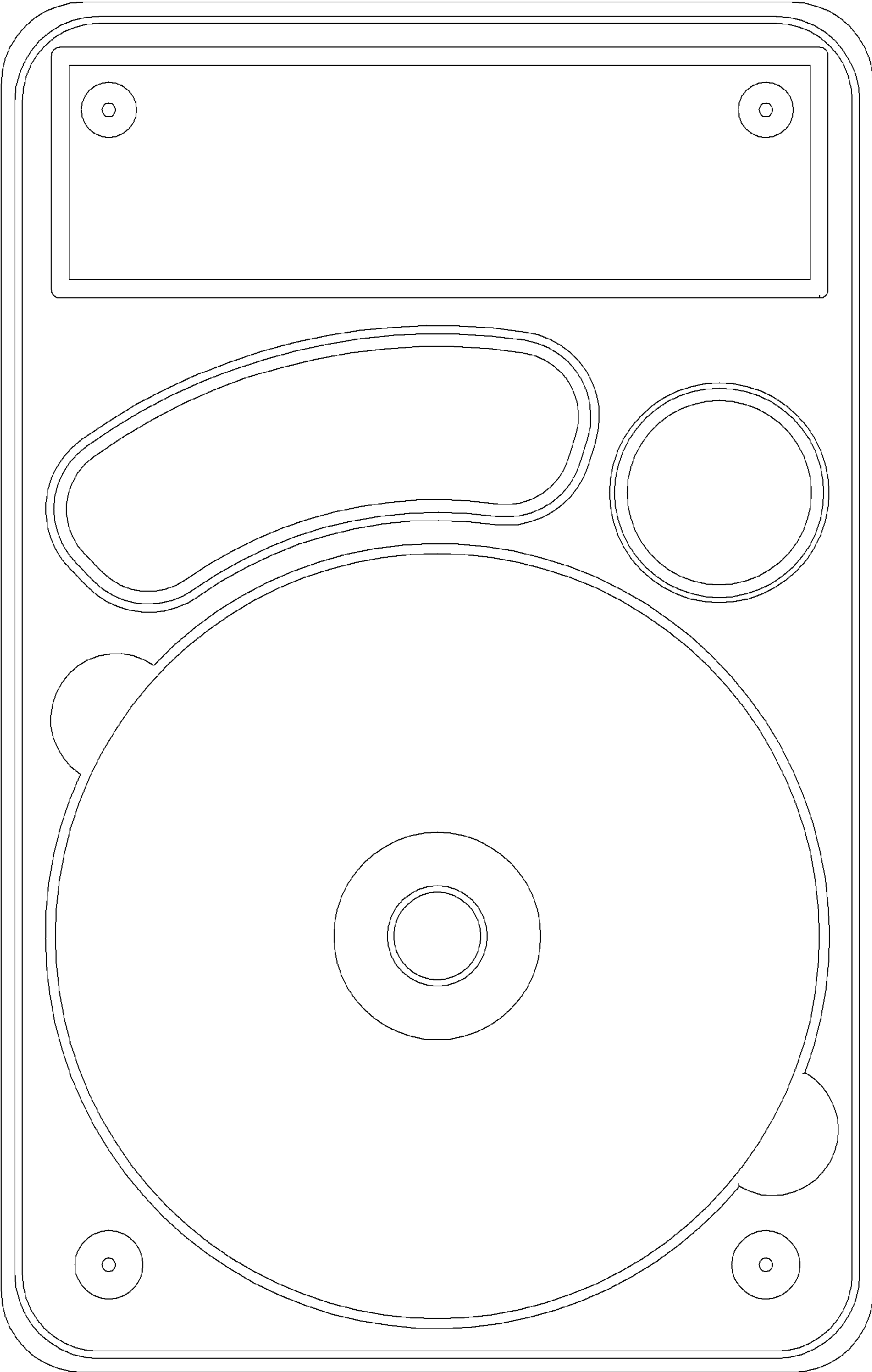

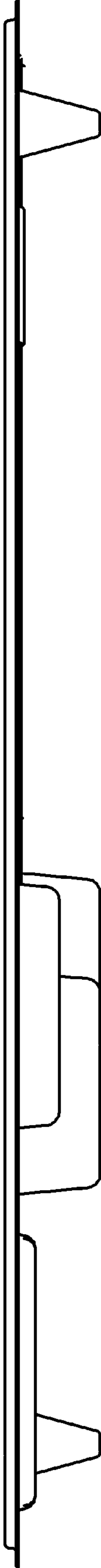

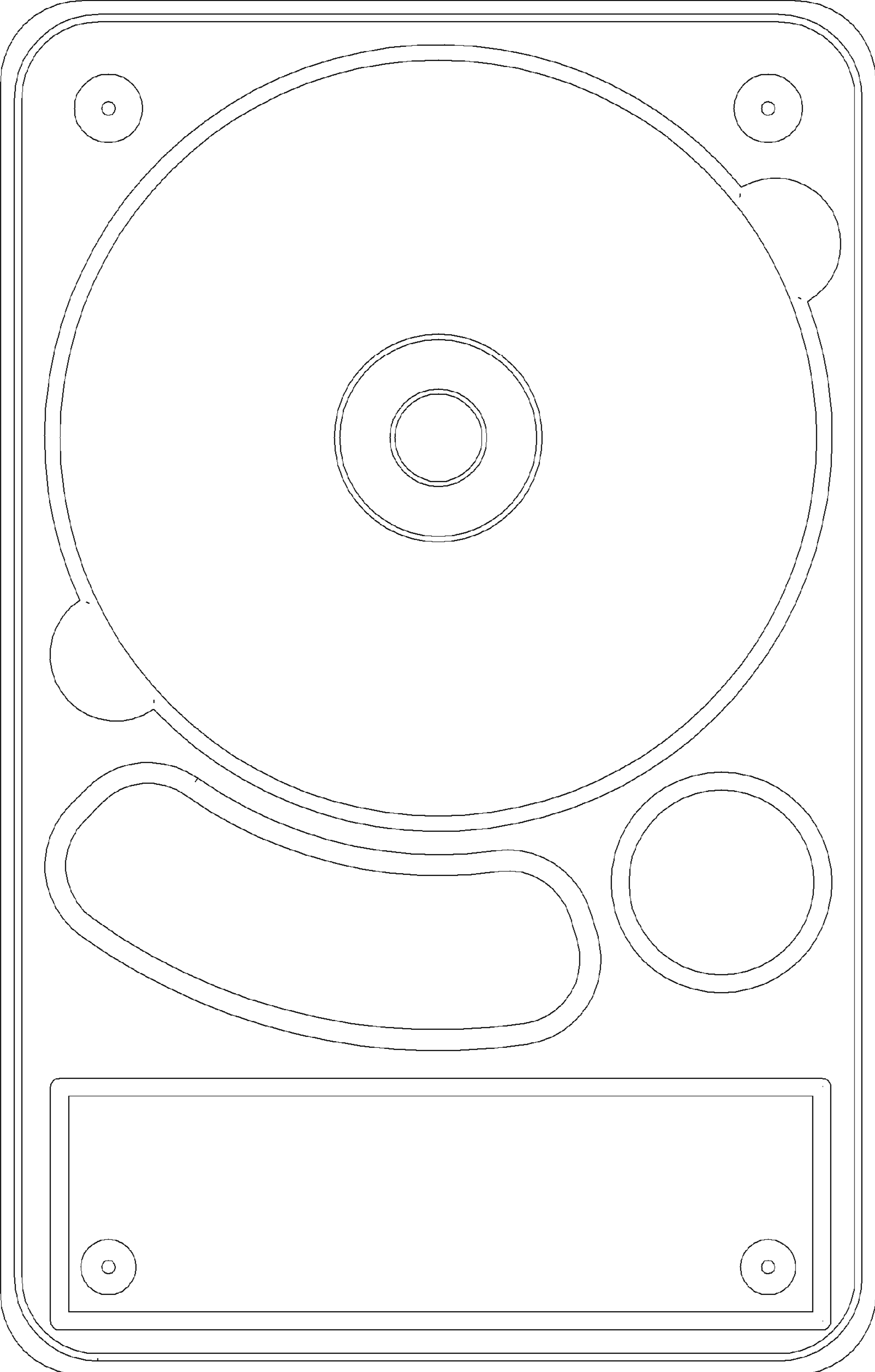
