DESCRIPTION

FIG. 1 is a front, left side and top perspective view of a first embodiment of a center pull dispenser showing my new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 4 is a top plan view thereof;

FIG. 5 is a bottom plan view thereof;

FIG. 6 is a rear elevational view thereof;

FIG. 7 is a front, left side and top perspective view of a second embodiment of a center pull dispenser showing my new design;

FIG. 8 is a front elevational view thereof;

FIG. 9 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 10 is a top plan view thereof;

FIG. 11 is a bottom plan view thereof, the rear elevational view being the same as that of FIG. 6;

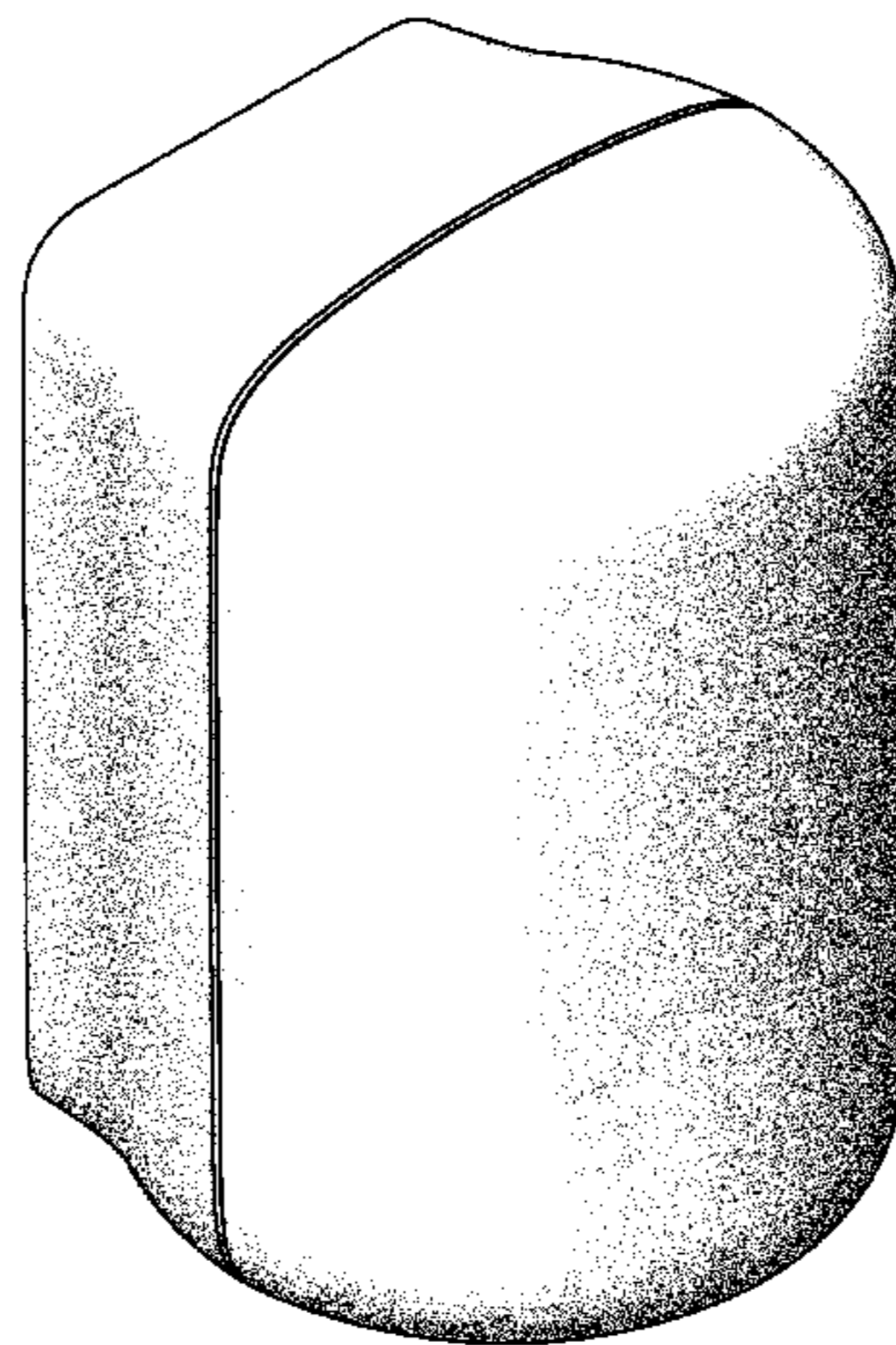
FIG. 12 is a front, left side and top perspective view of a third embodiment of a center pull dispenser showing my new design;

FIG. 17 is a front, left side and top perspective view of a fifth embodiment of a center pull dispenser showing my new design;

FIG. 18 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 19 is a top plan view thereof;

FIG. 20 is a bottom plan view thereof, the front and rear elevational views being the same as those of FIGS. 8 and 6, respectively;

FIG. 21 is a front, left side and top perspective view of a sixth embodiment of a center pull dispenser showing my new design;

FIG. 22 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 23 is a top plan view thereof;

FIG. 24 is a bottom plan view thereof, the front and rear elevational views being the same as those of FIGS. 8 and 6, respectively;

FIG. 25 is a front, left side and top perspective view of a seventh embodiment of a center pull dispenser showing my new design;

FIG. 26 is a front elevational view thereof;

FIG. 27 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;

FIG. 28 is a top plan view thereof;

FIG. 29 is a bottom plan view thereof, the rear elevational view being the same as that of FIG. 6;

FIG. 30 is a front, left side and top perspective view of an eighth embodiment of a center pull dispenser showing my new design;

FIG. 31 is a front elevational view thereof; and,

FIG. 32 is a left side elevational view thereof, the right side elevational view being a mirror image thereof, and the top plan view, bottom plan view and rear elevational view being the same as those of FIGS. 4, 5 and 6, respectively.

The oblique-line shading in the views is understood to represent a frosted, translucent material, and the broken-line disclosure is understood to represent a portion of the article in which the claimed design is embodied, but which forms no part of the claimed design.

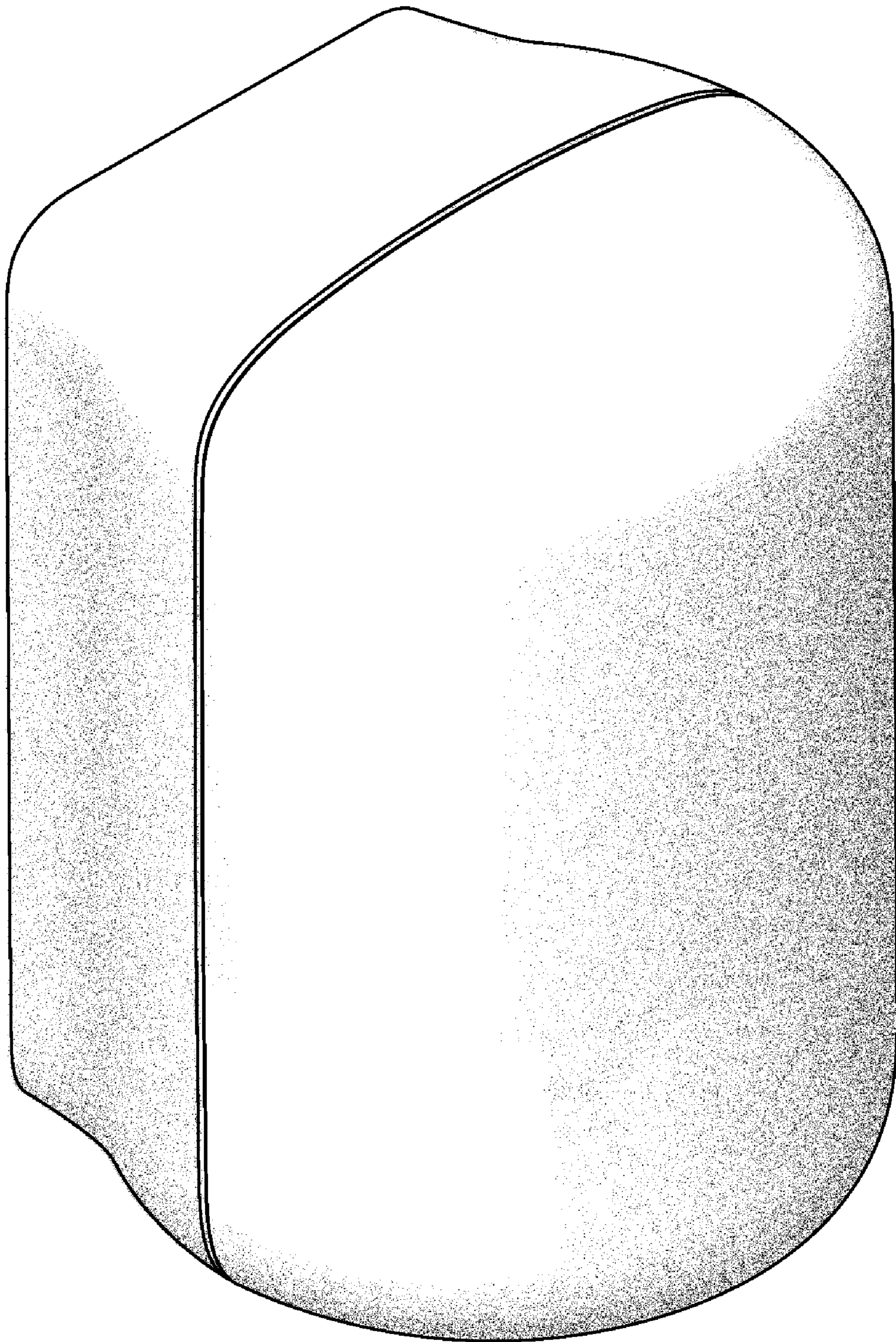

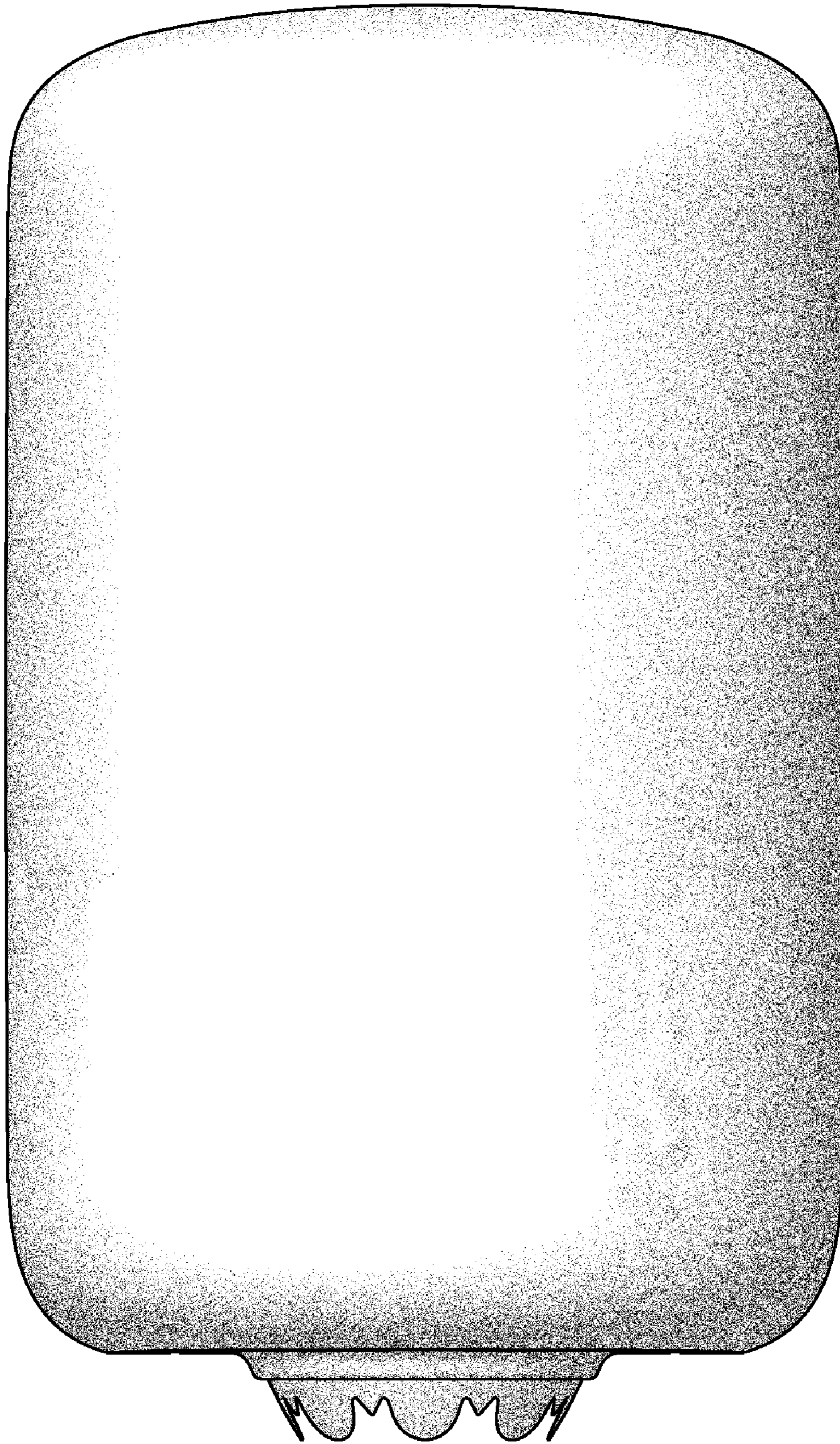

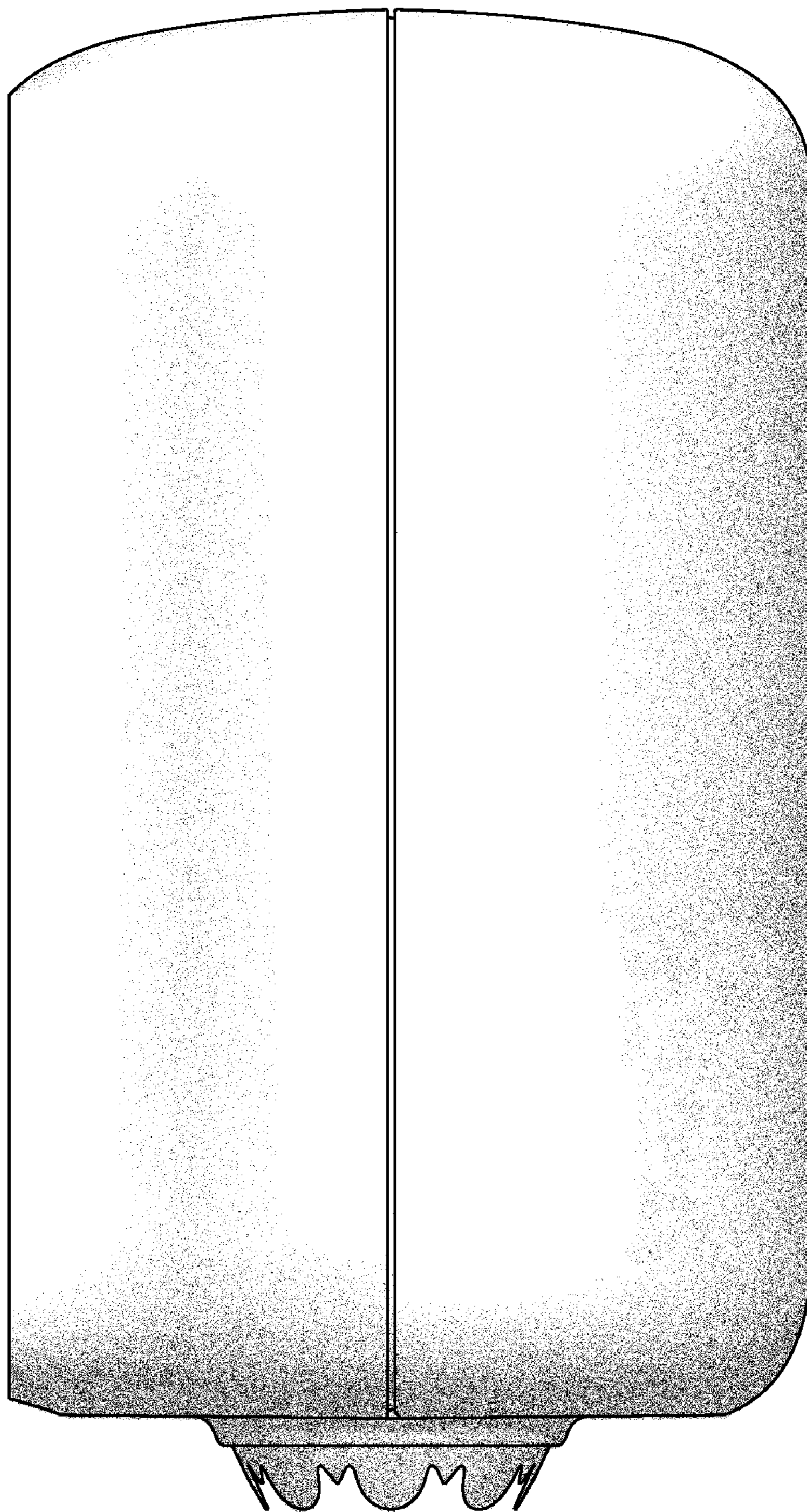

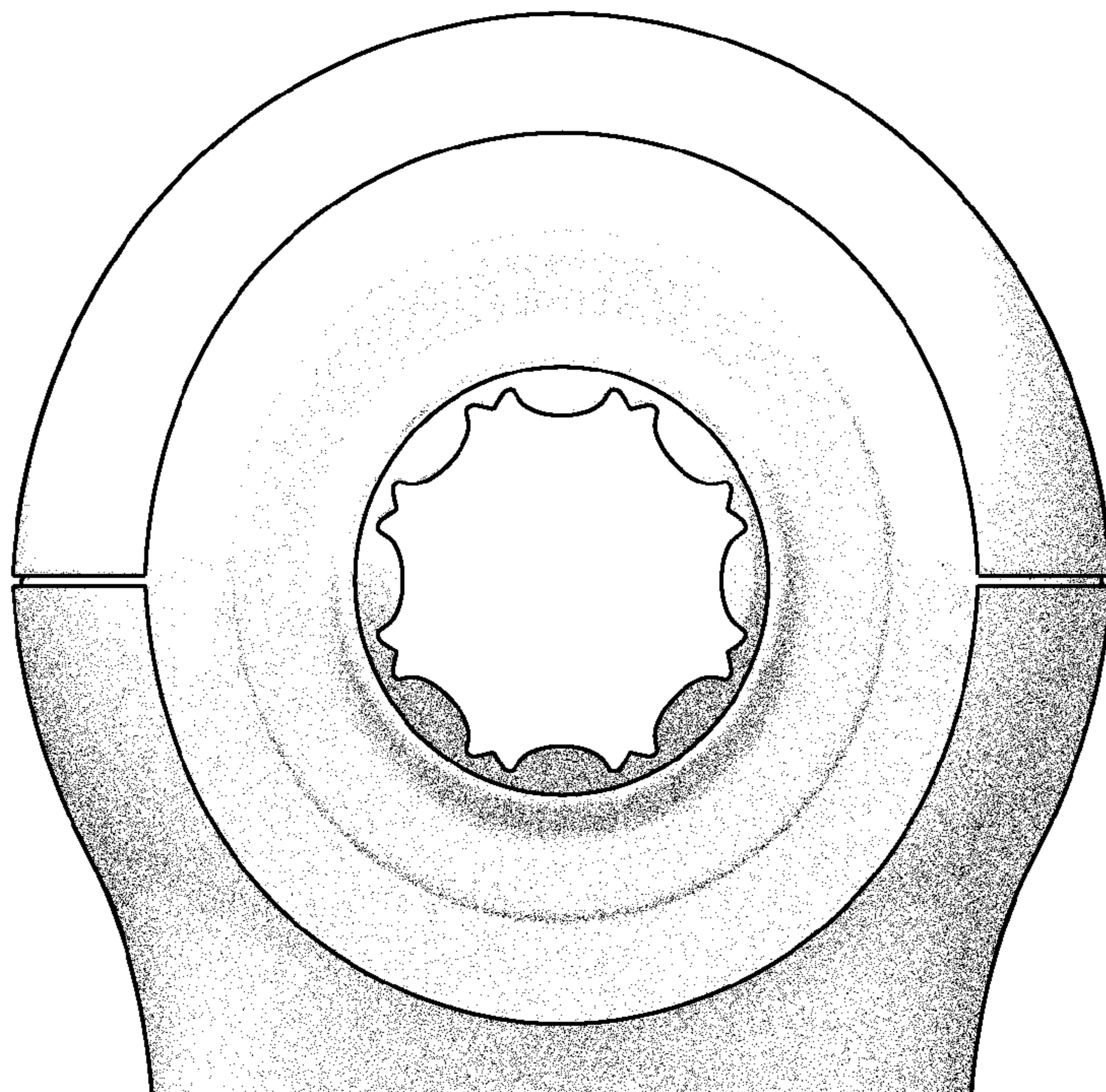
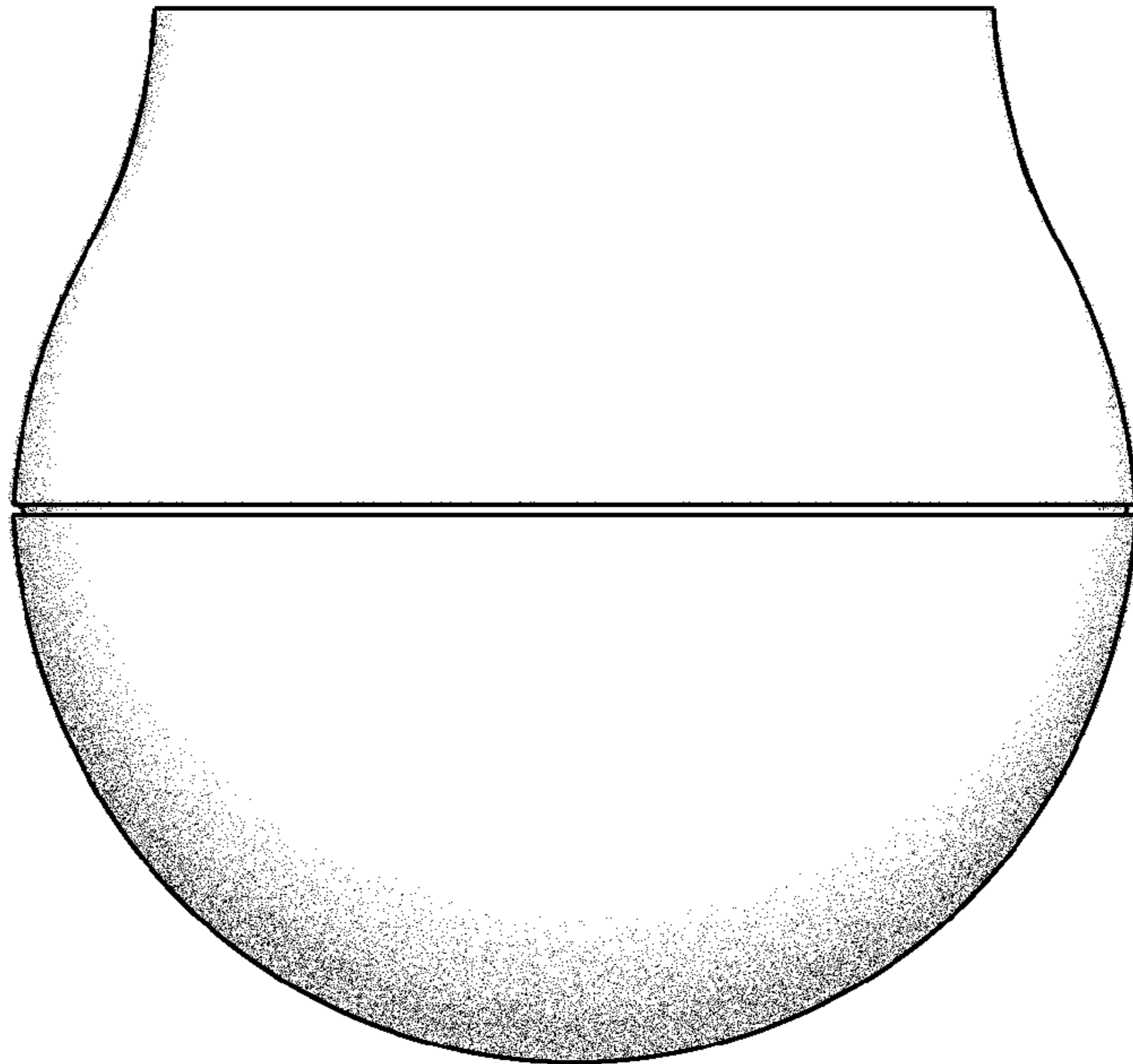

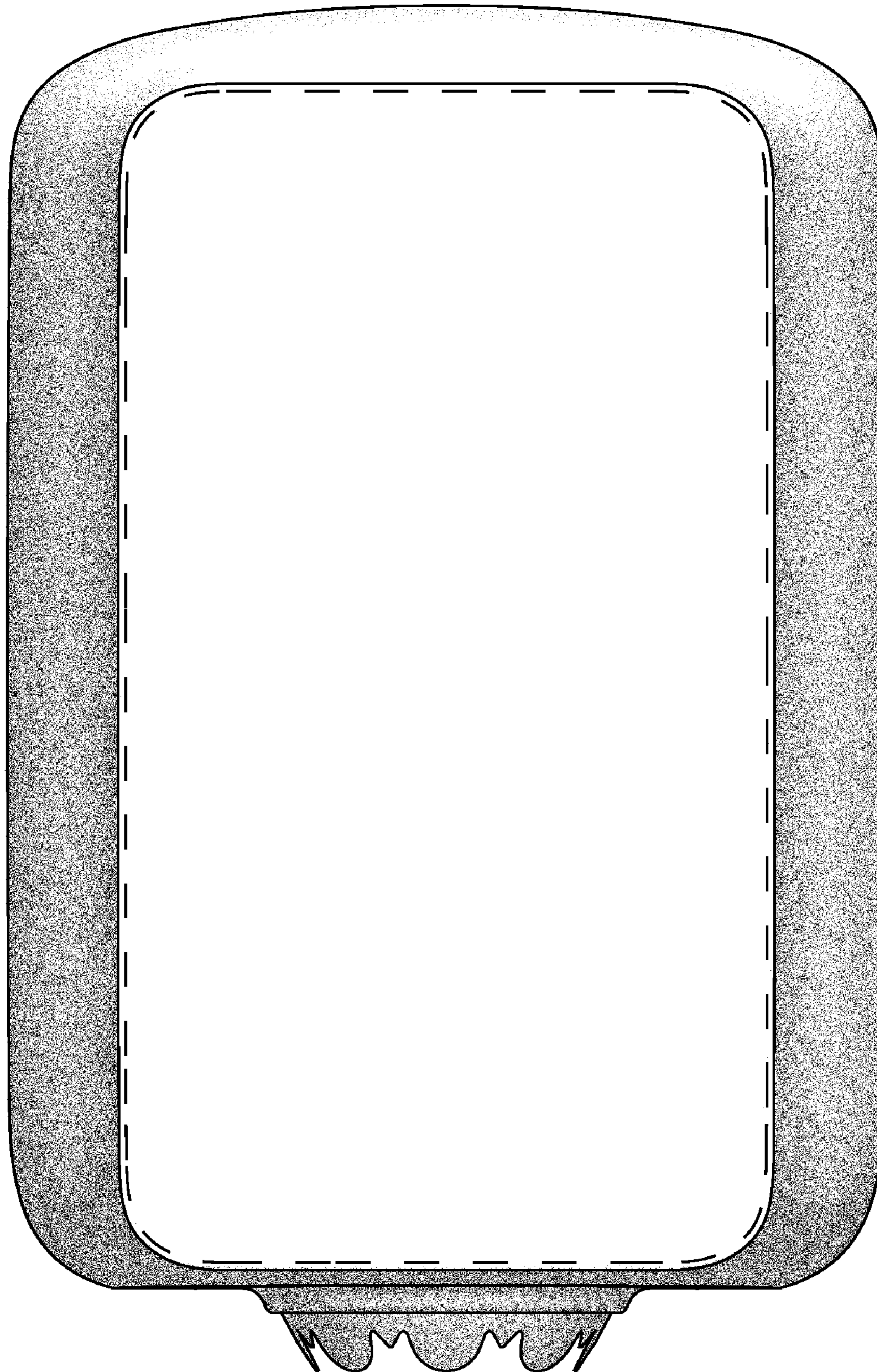

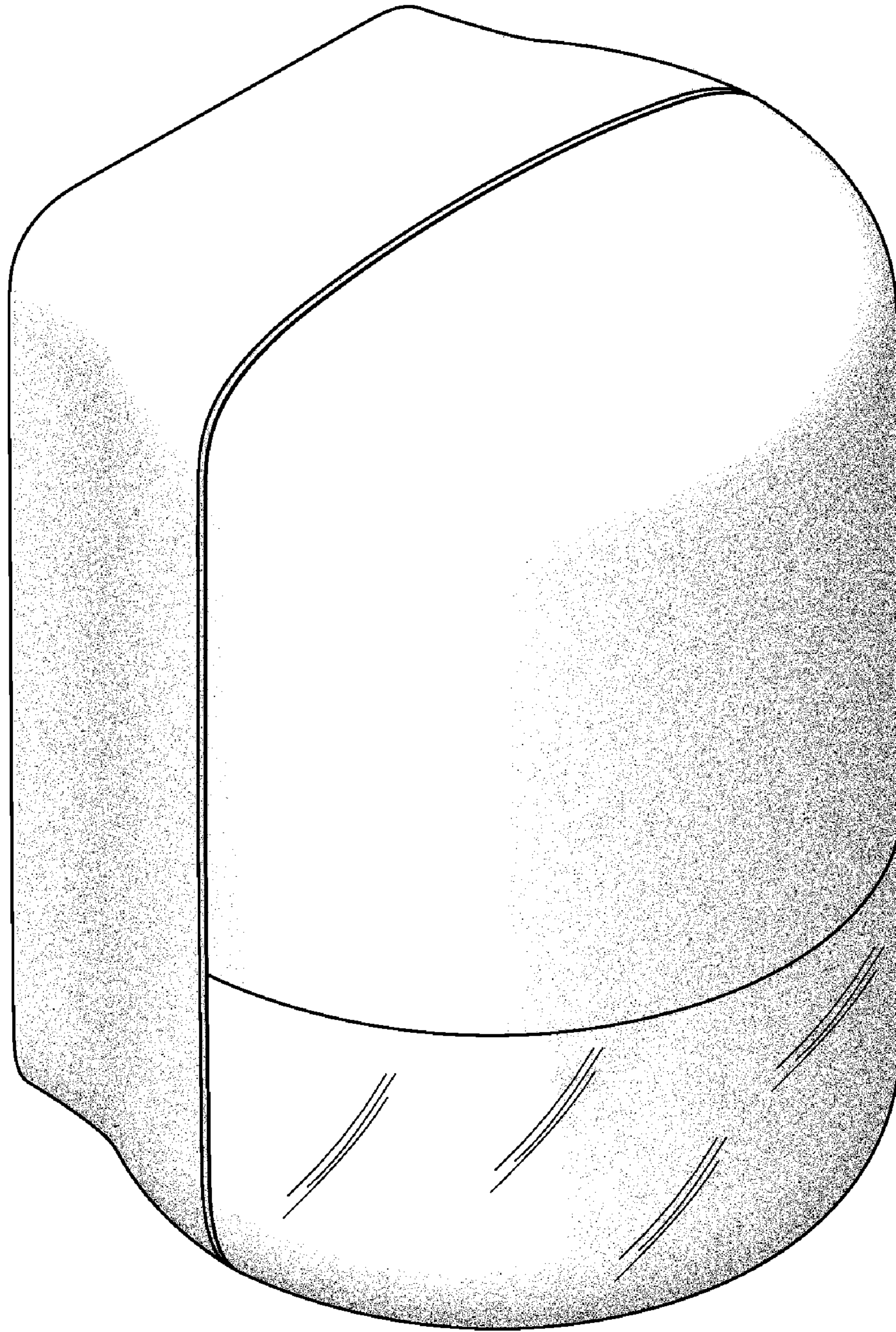

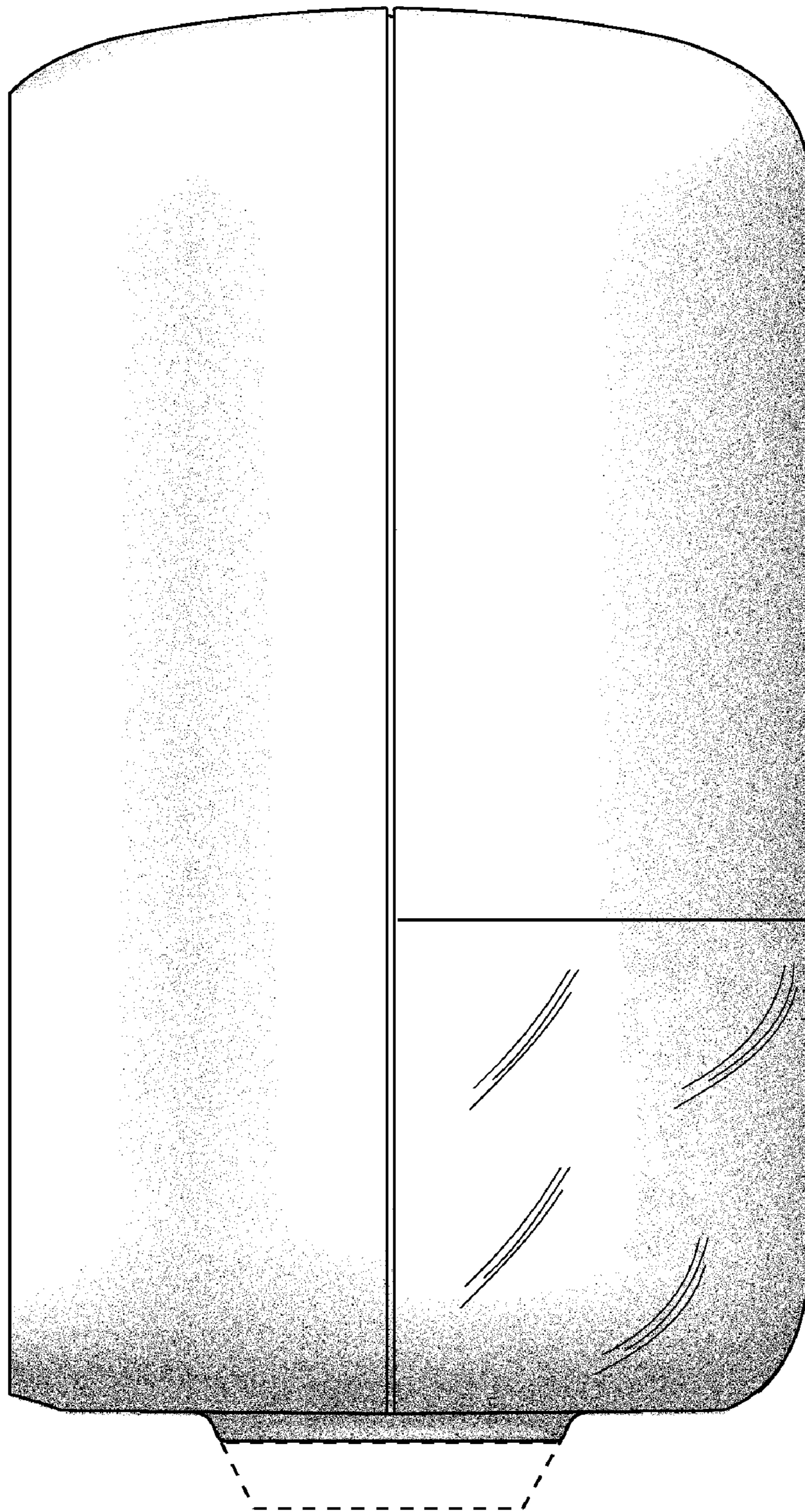

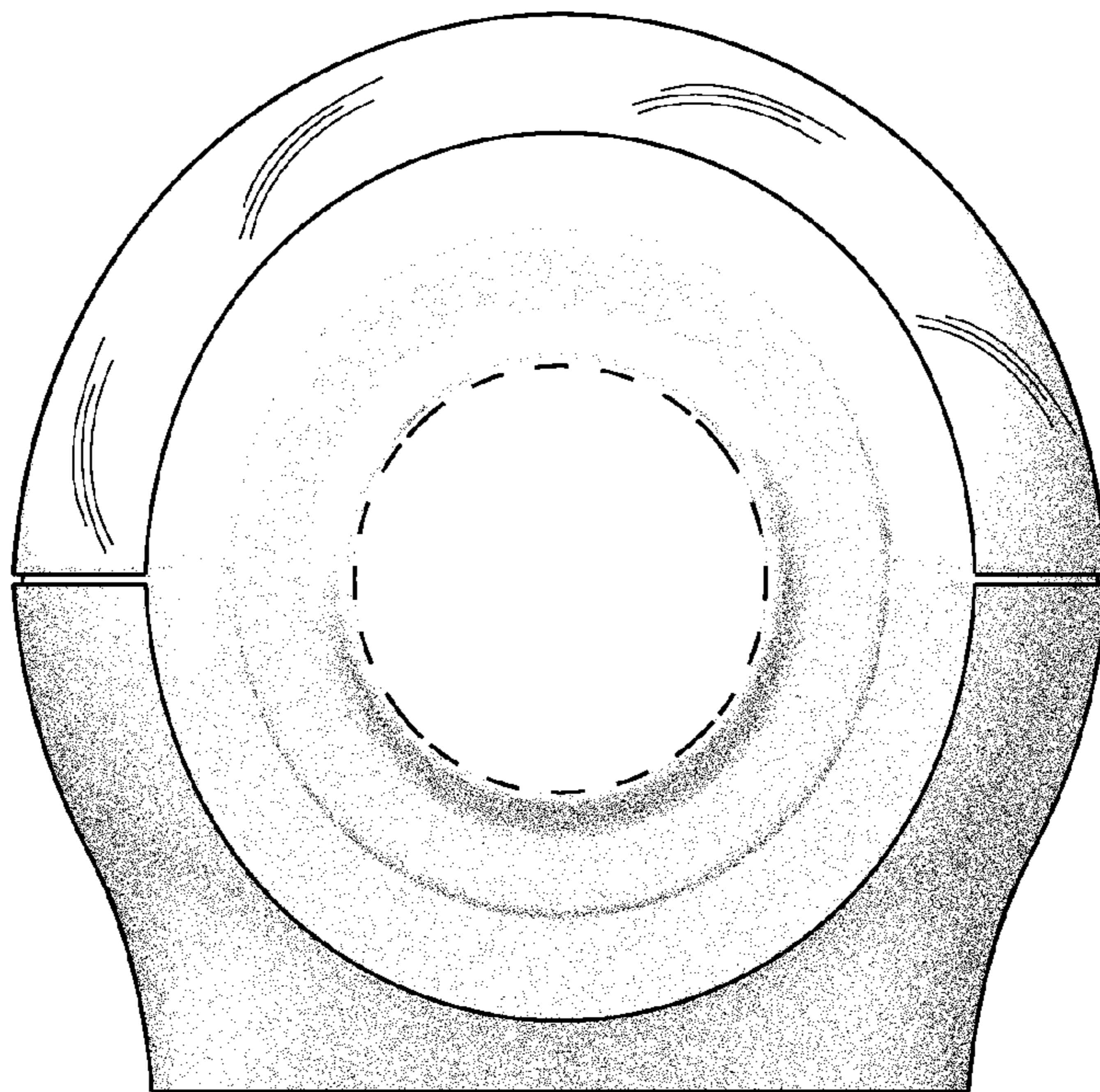
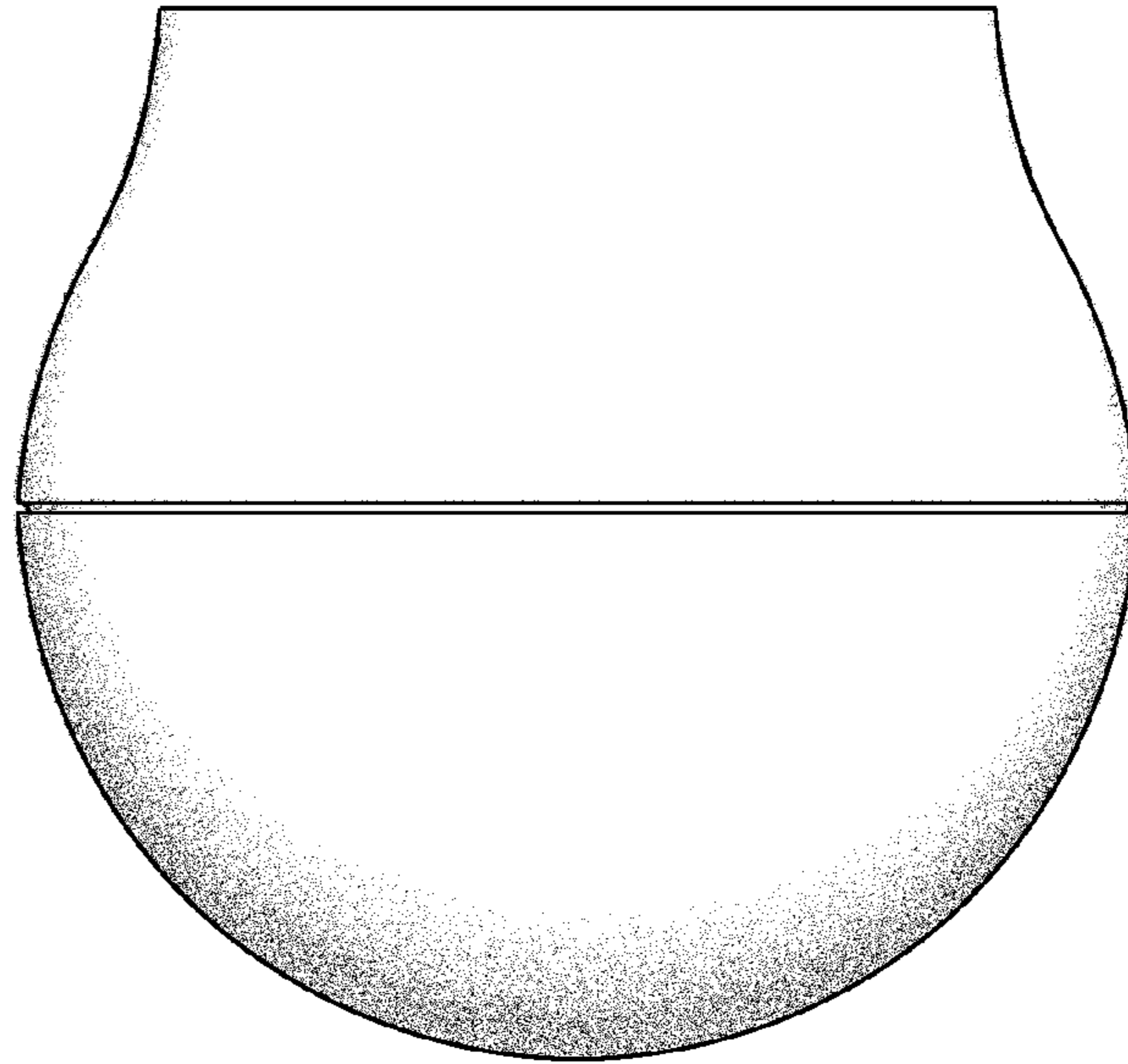

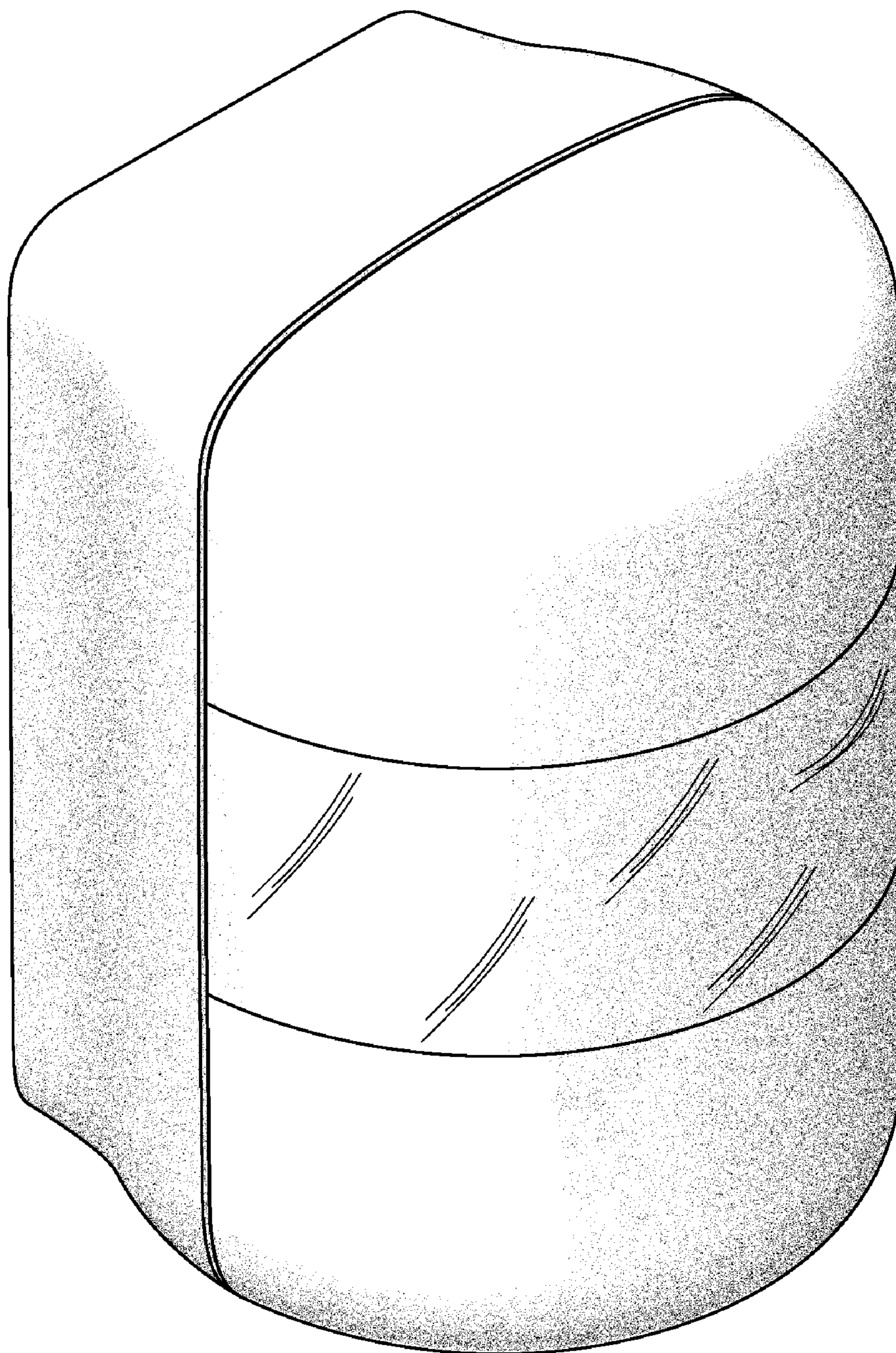

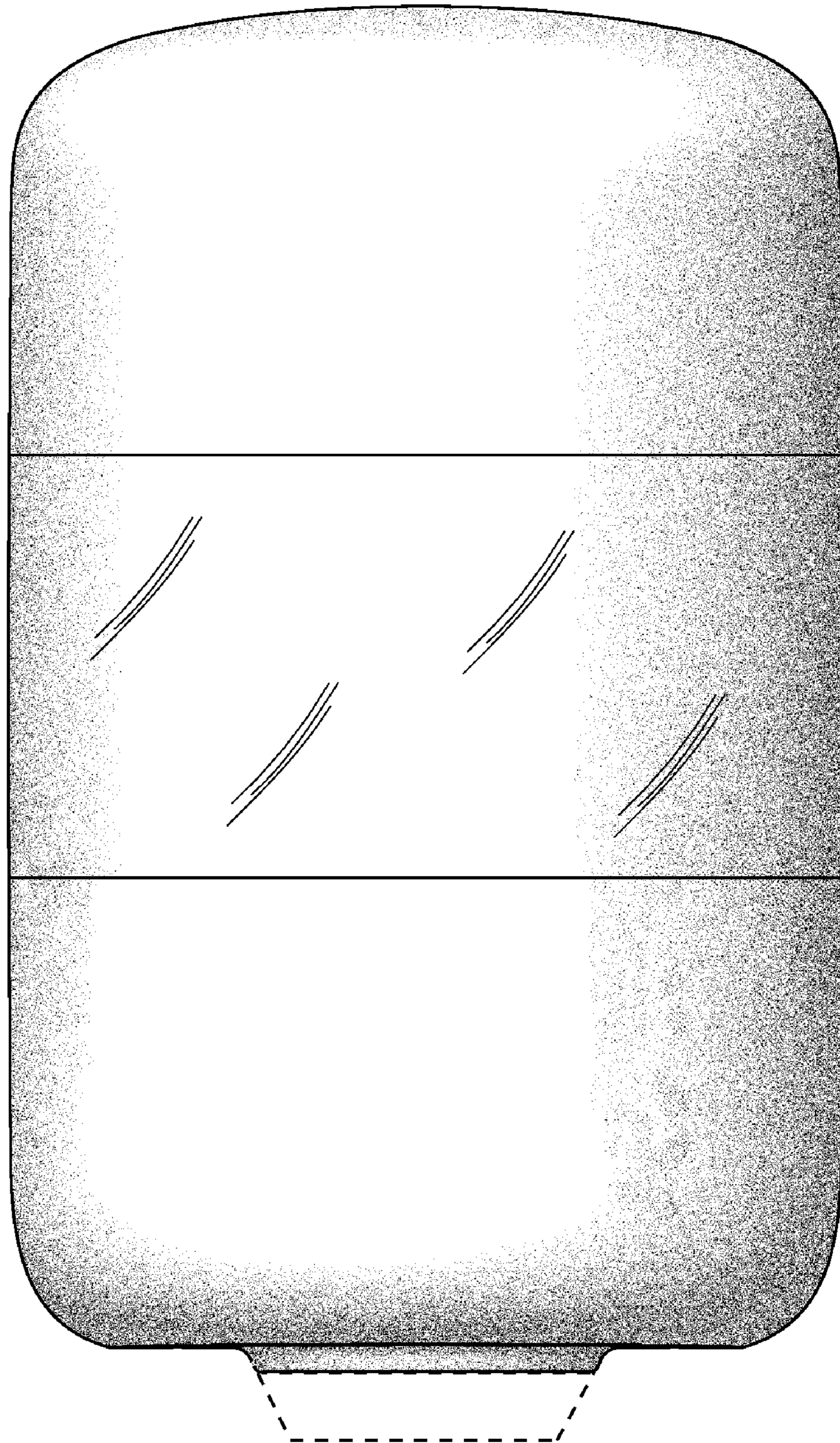

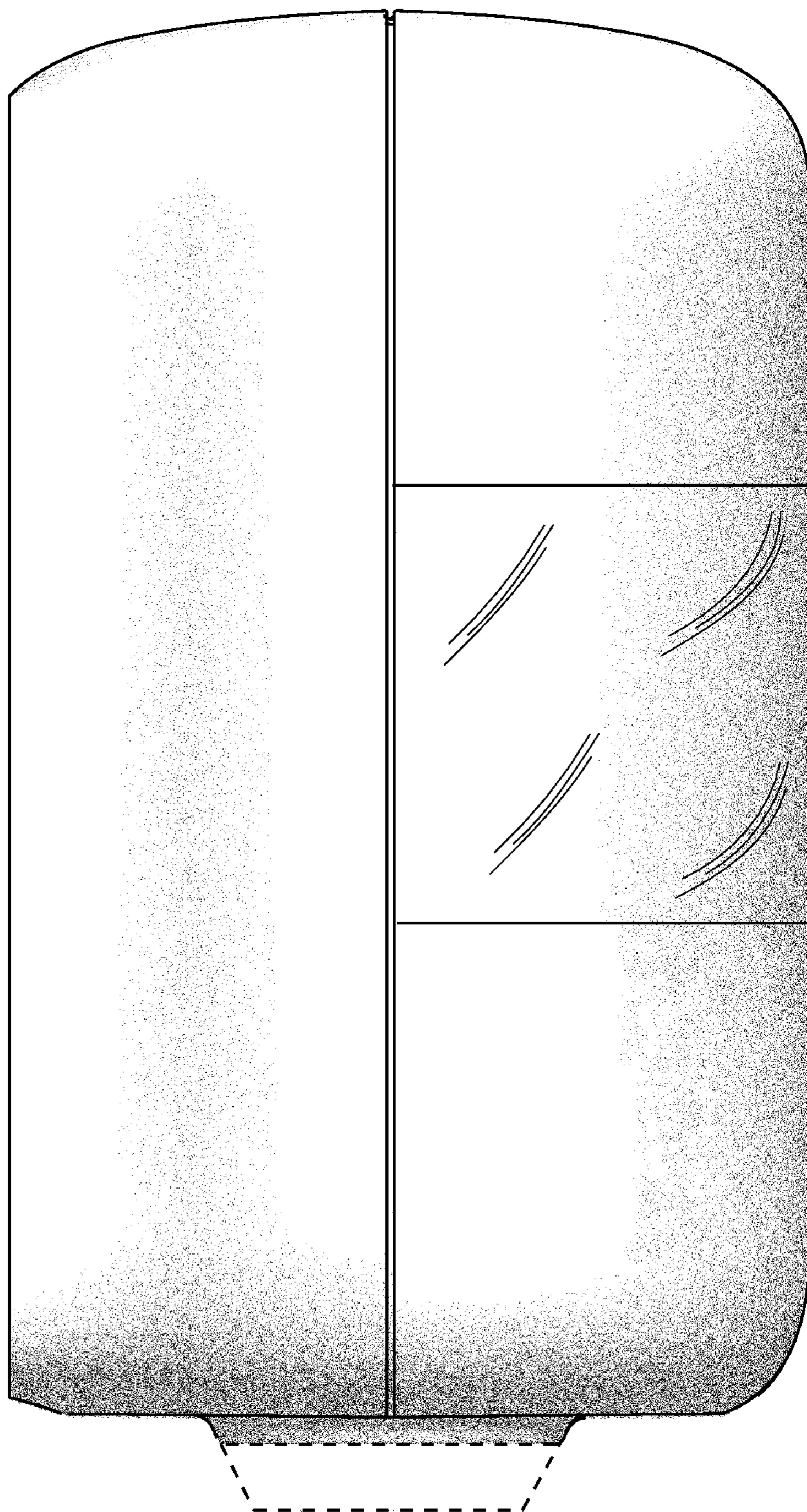

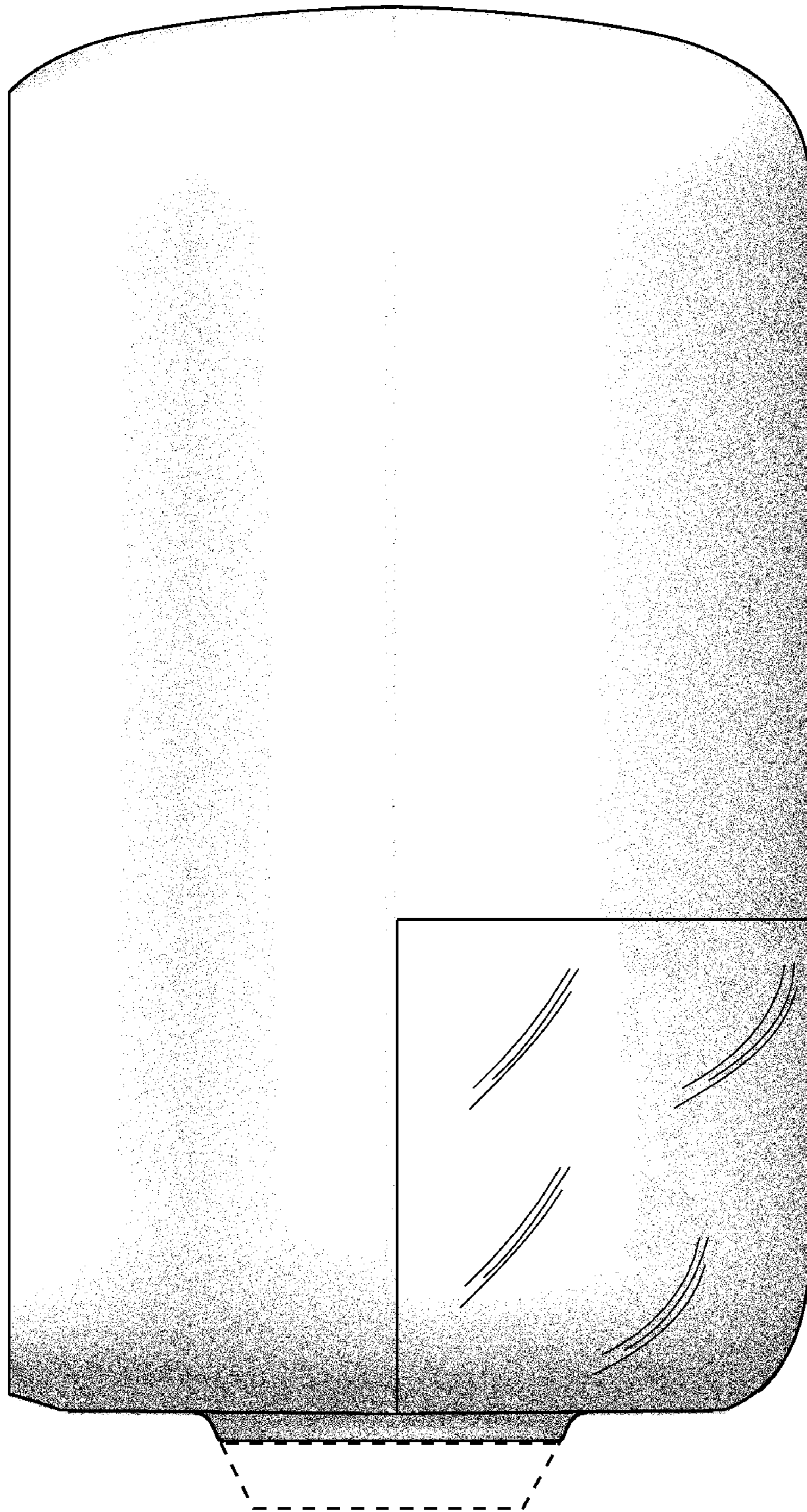

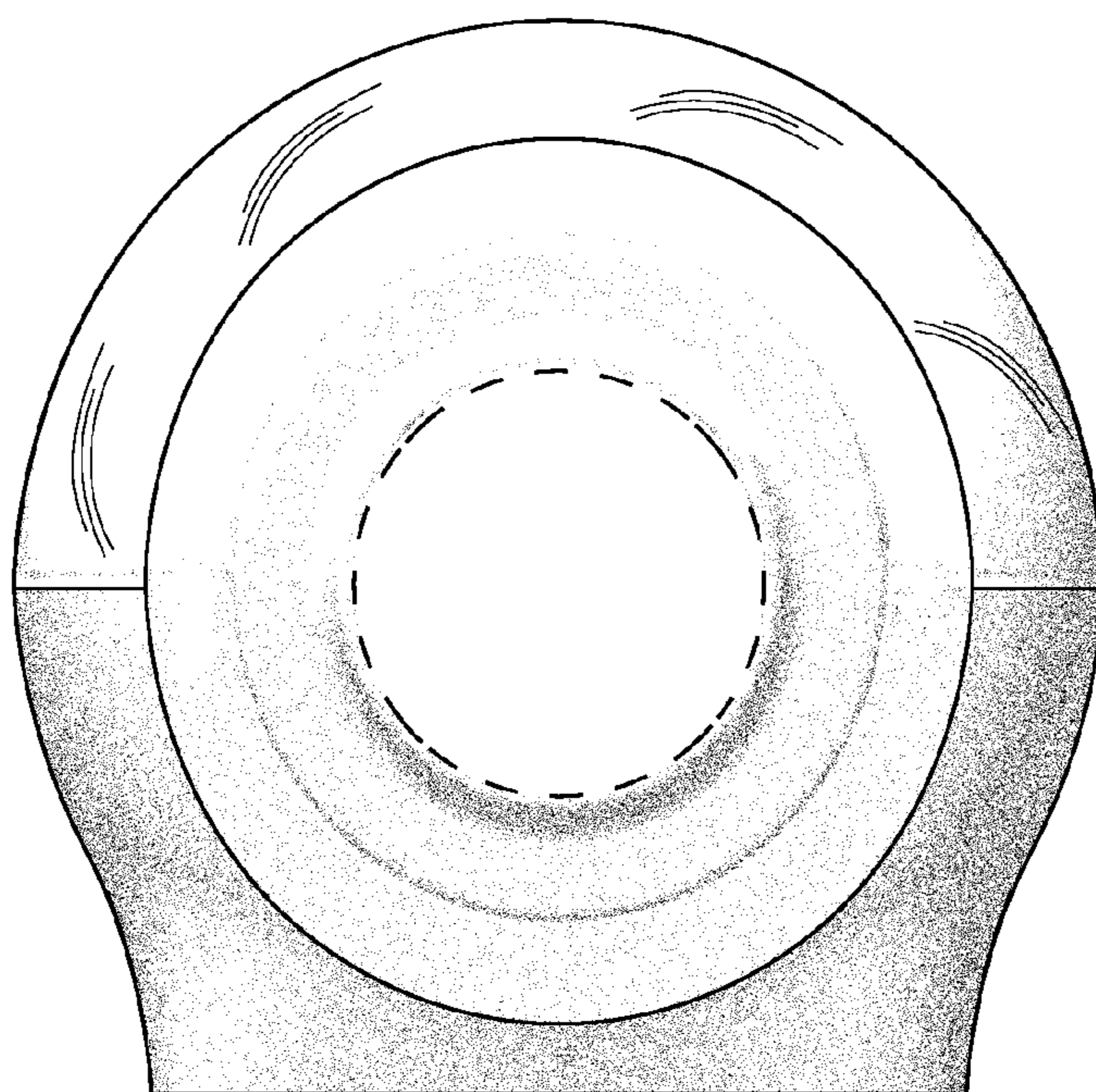
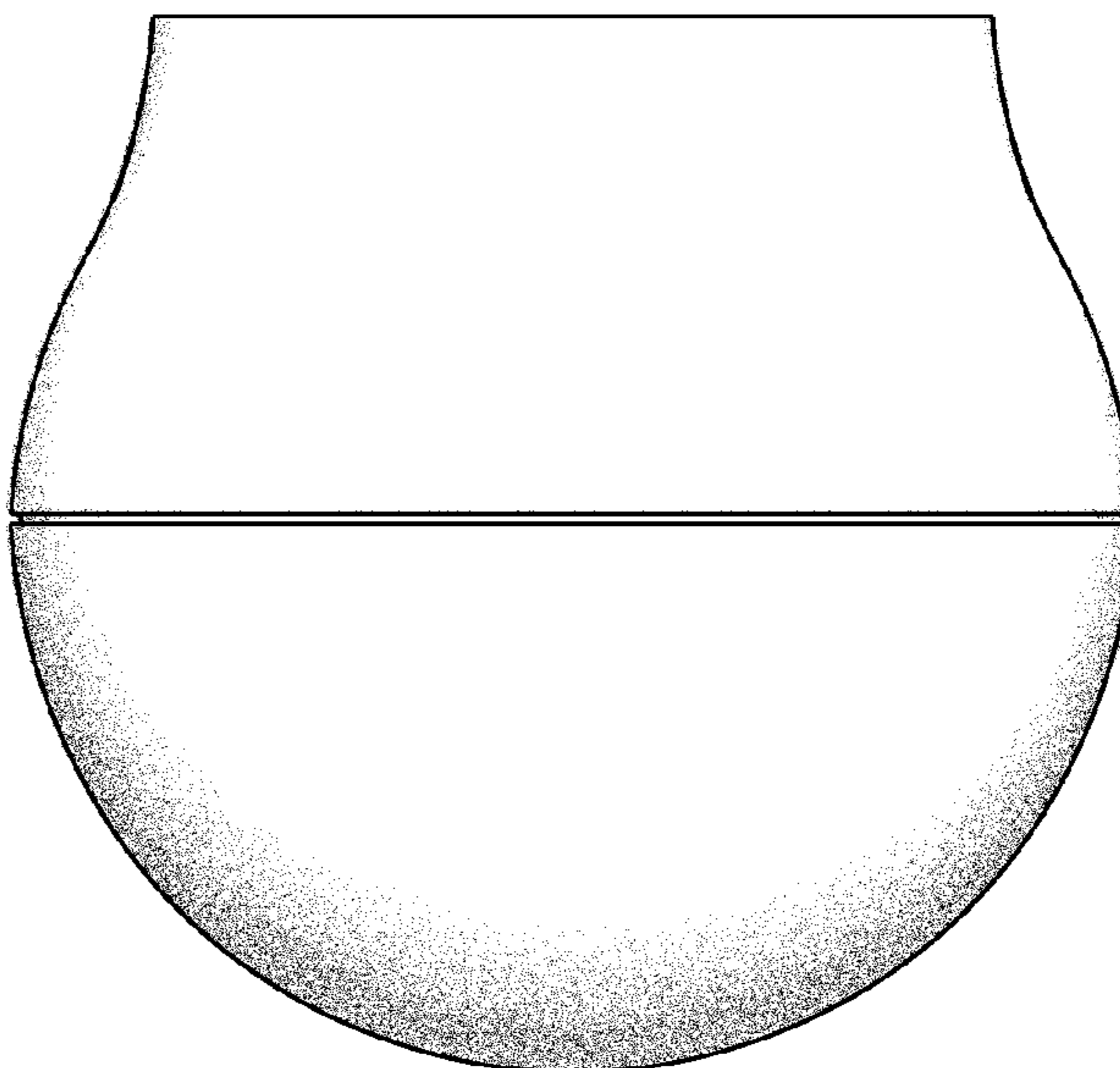

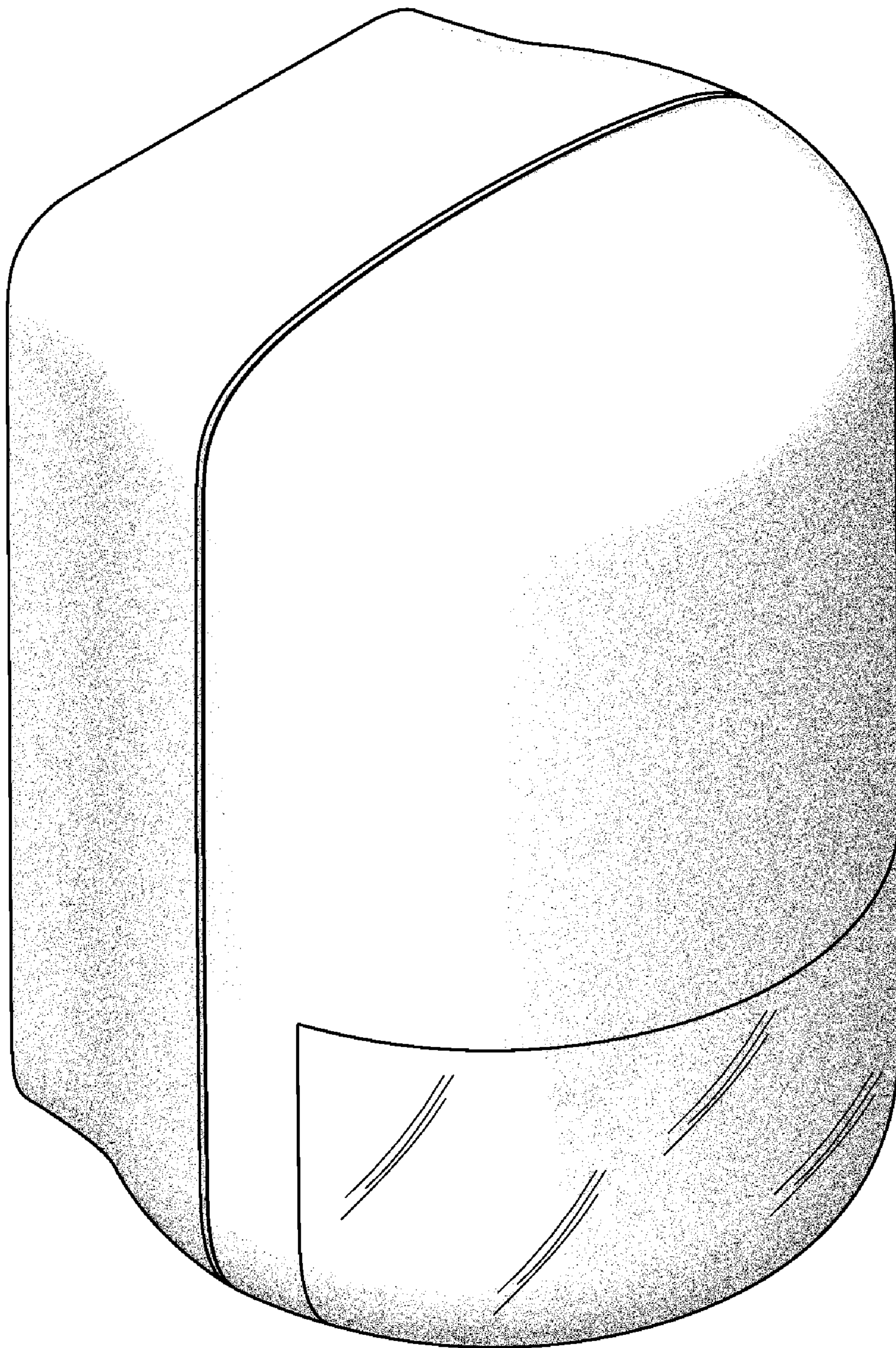

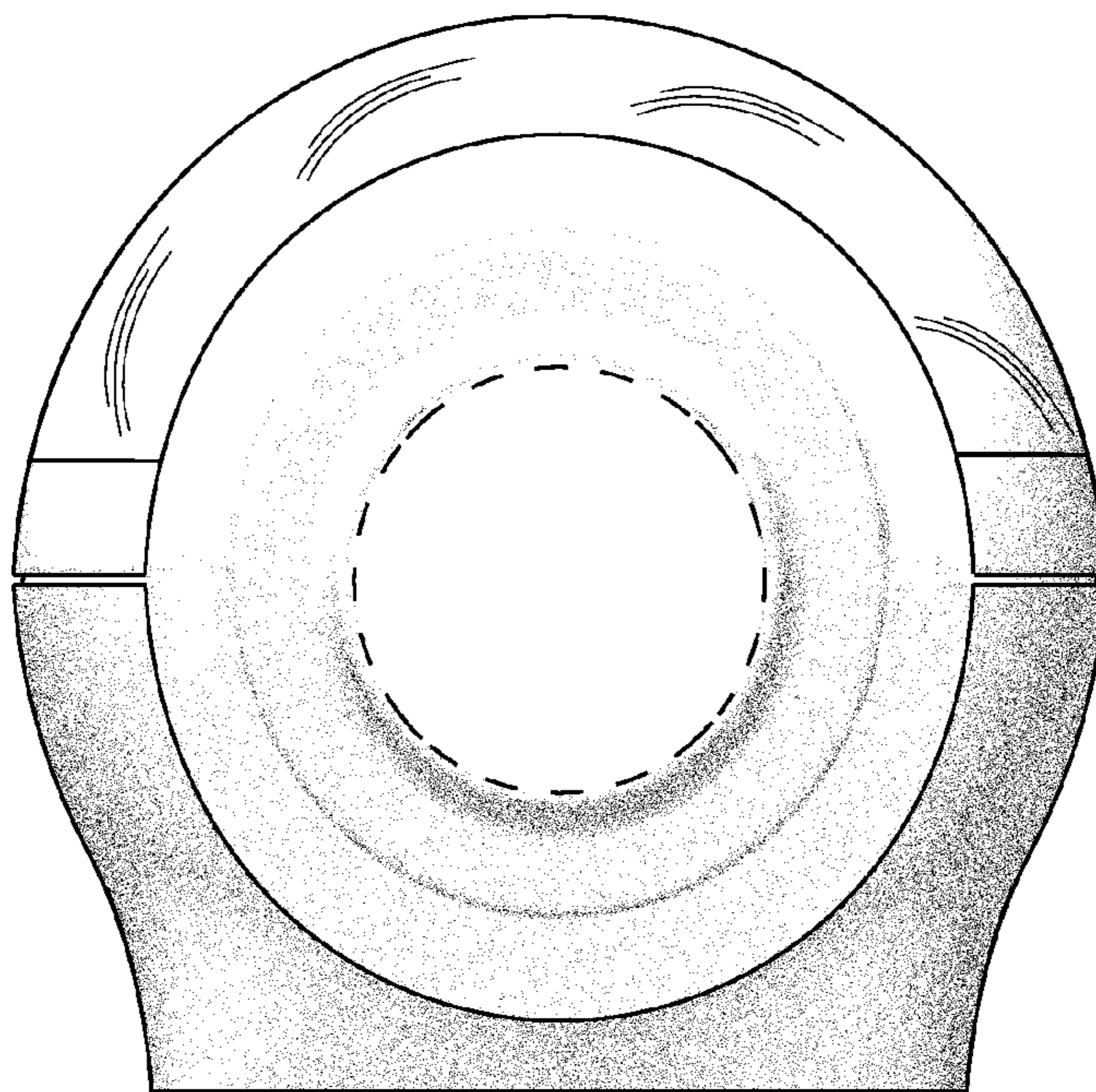
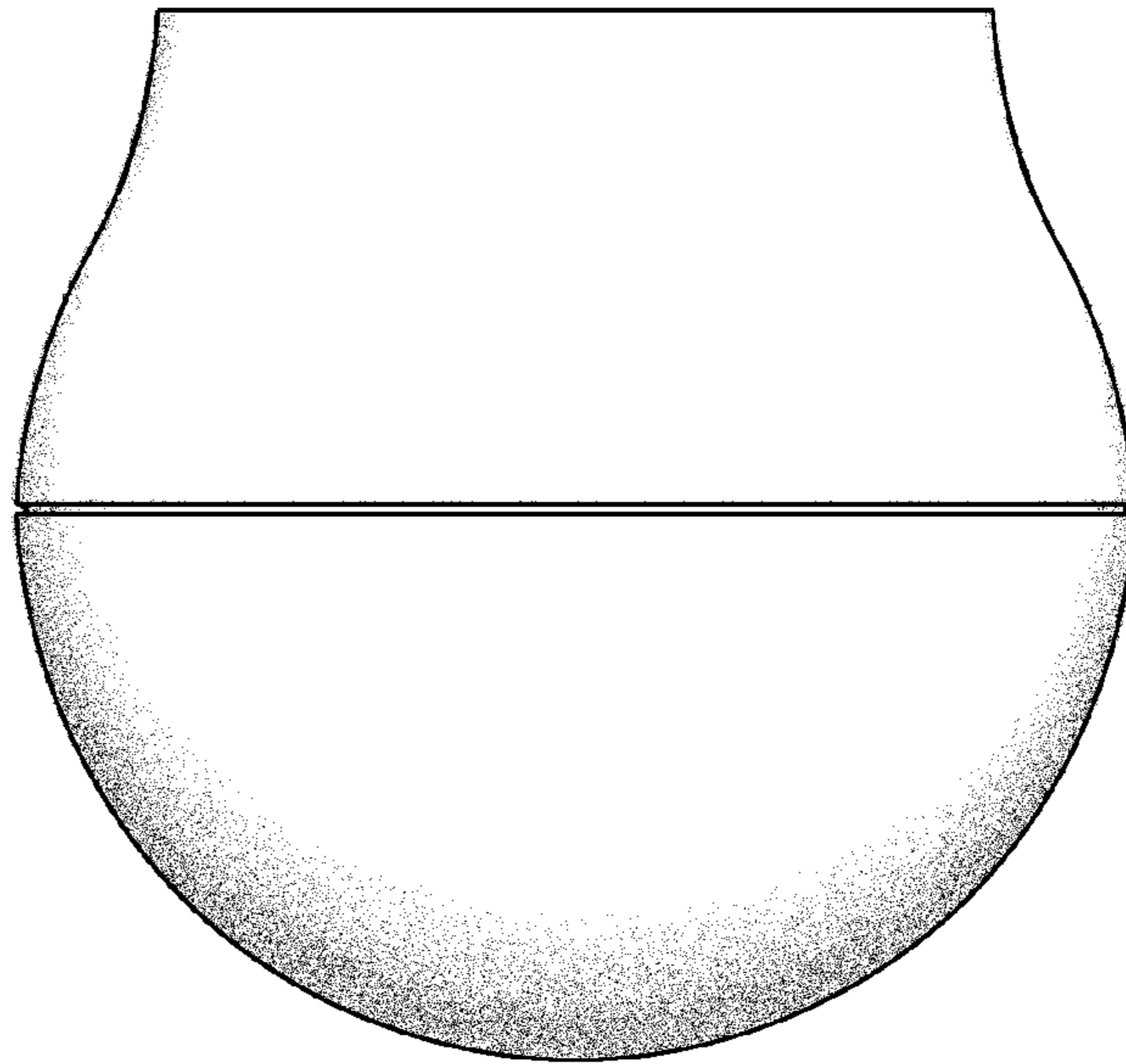

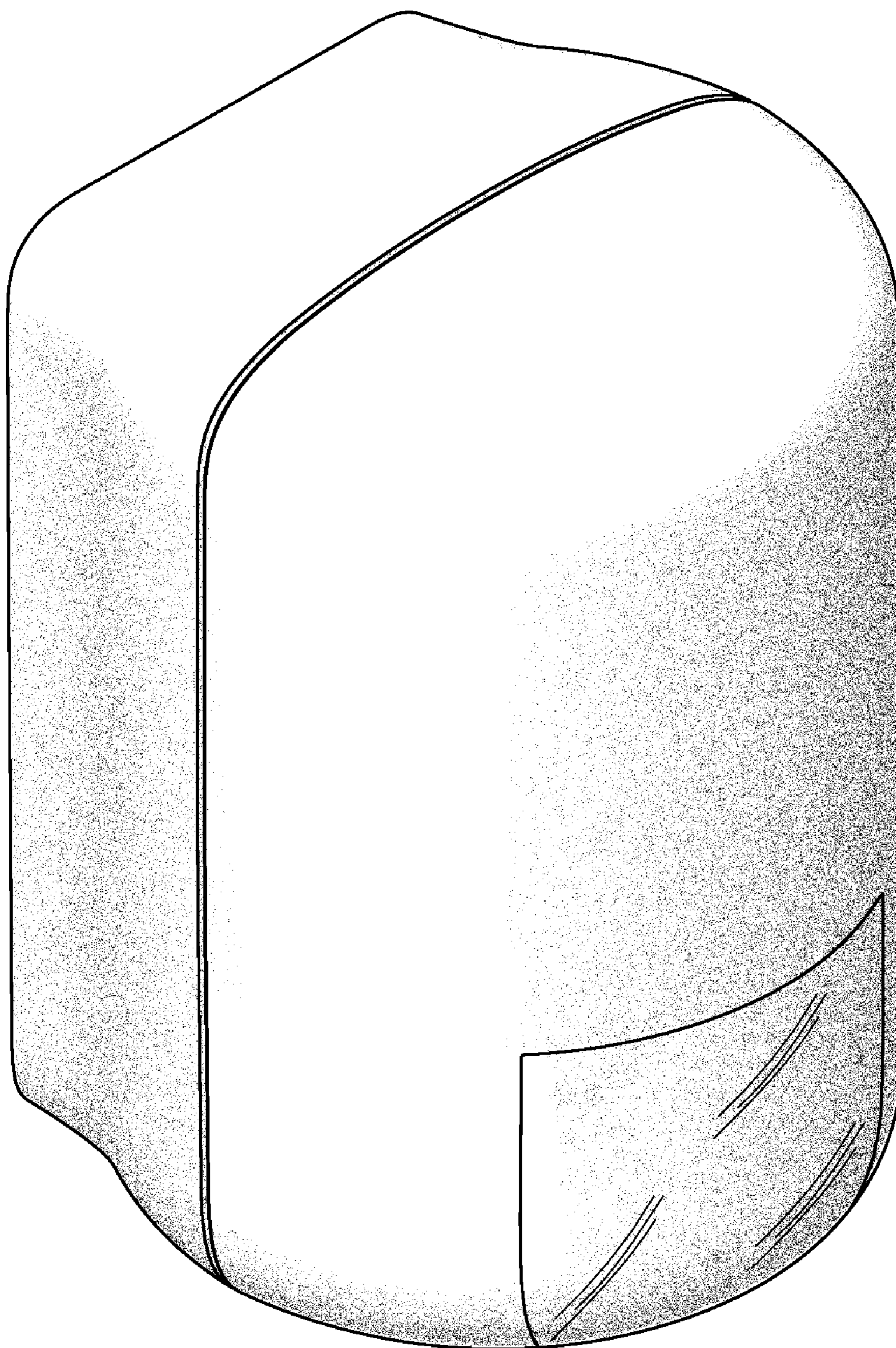

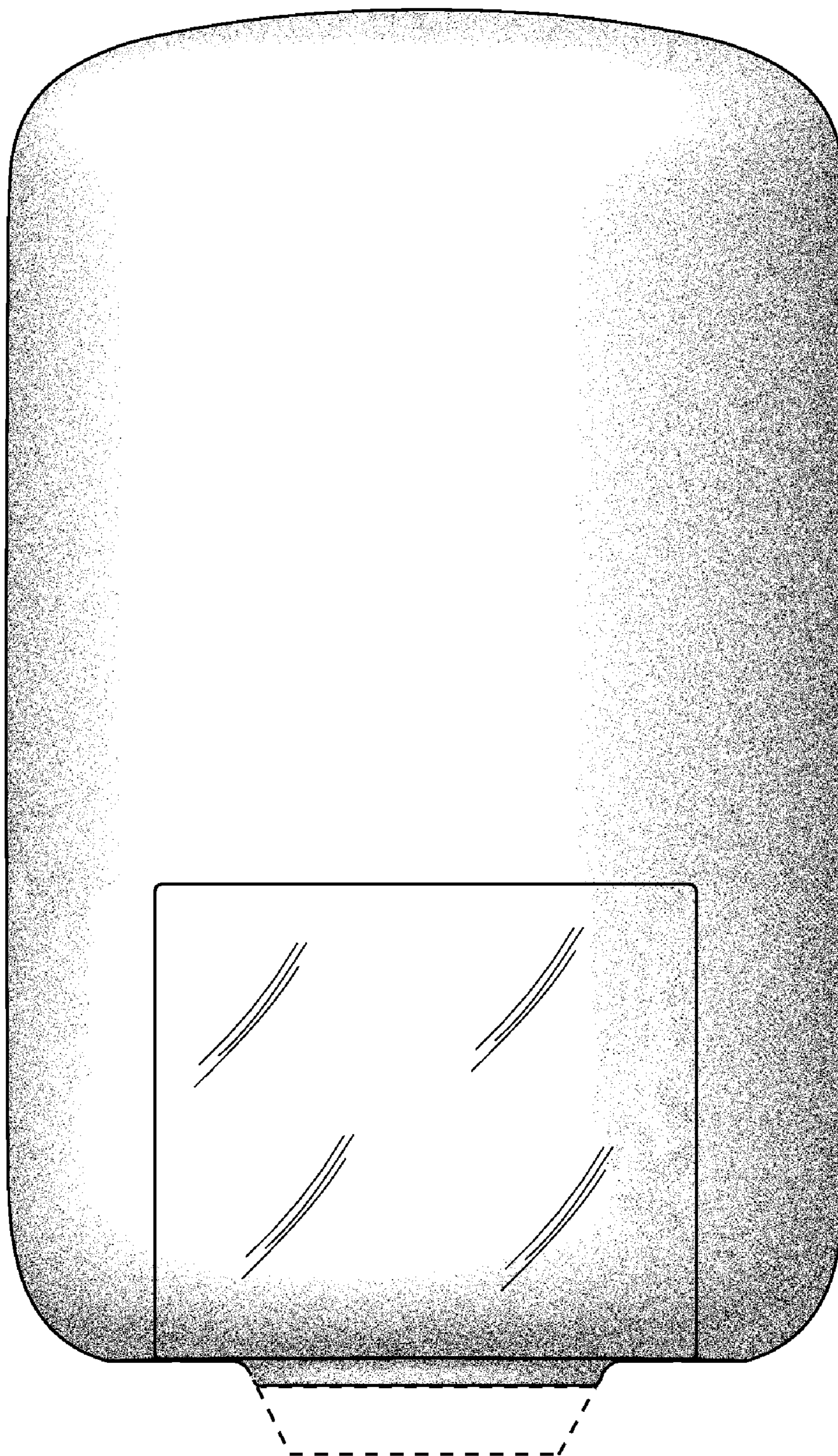

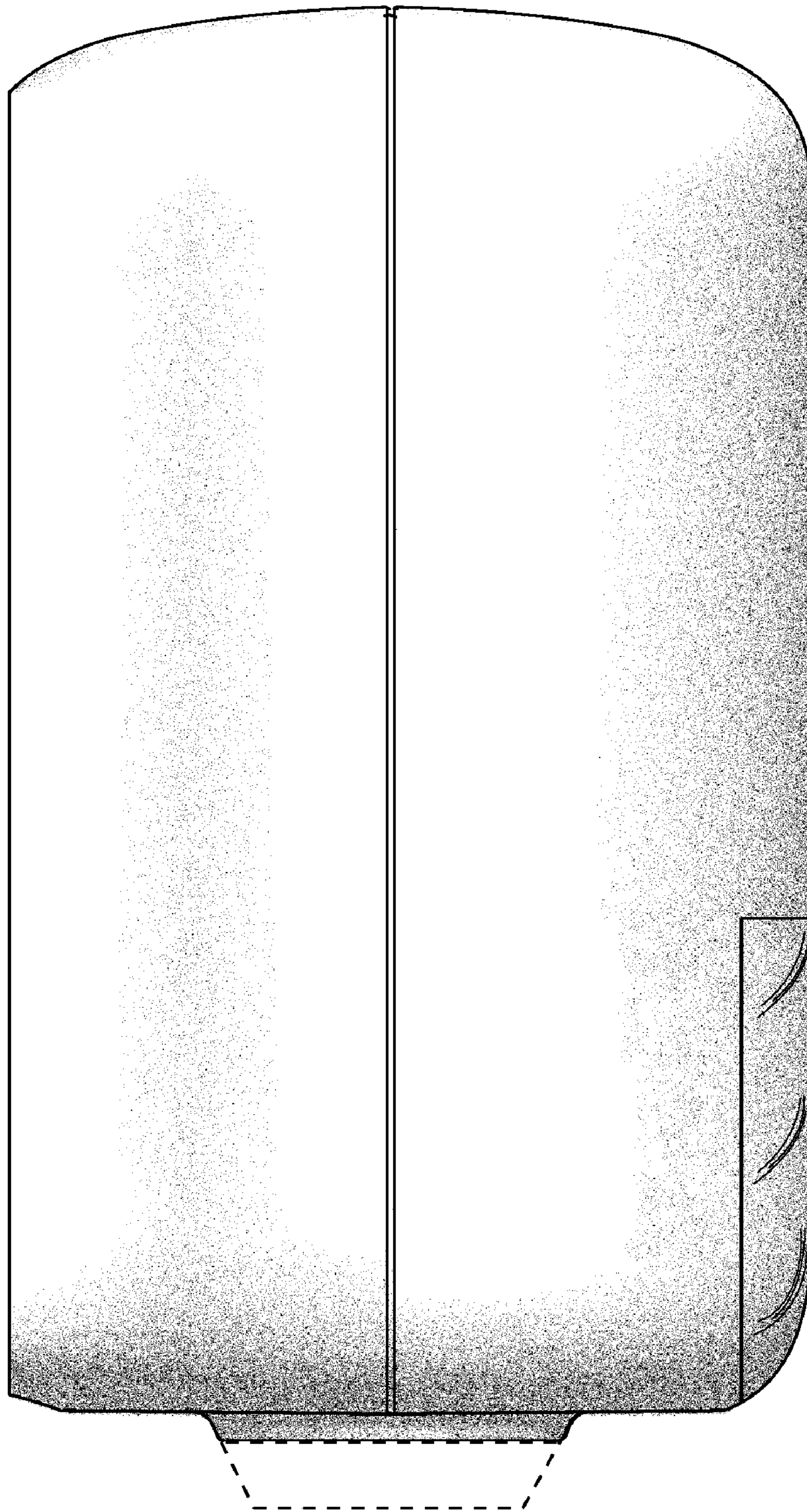

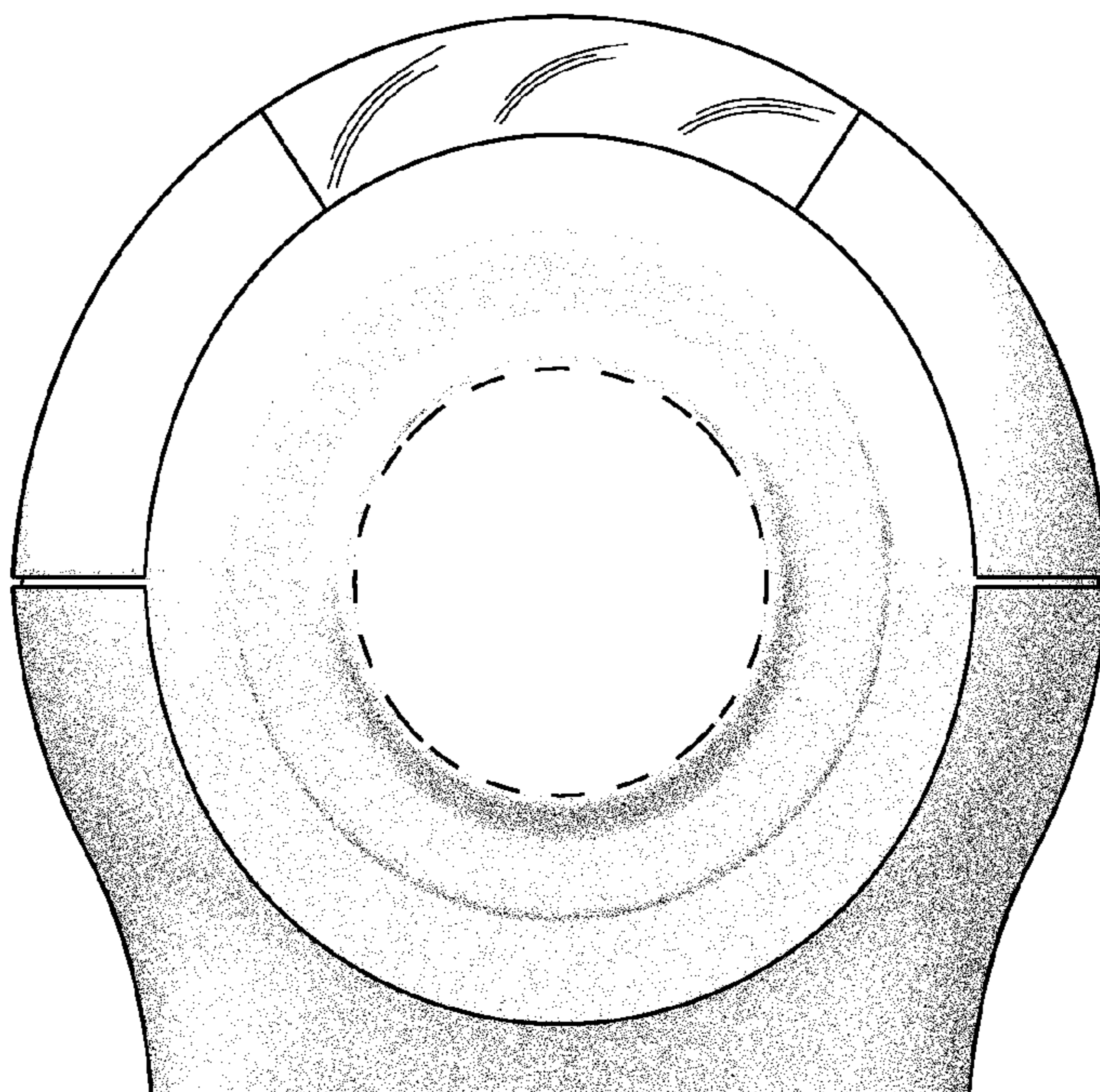
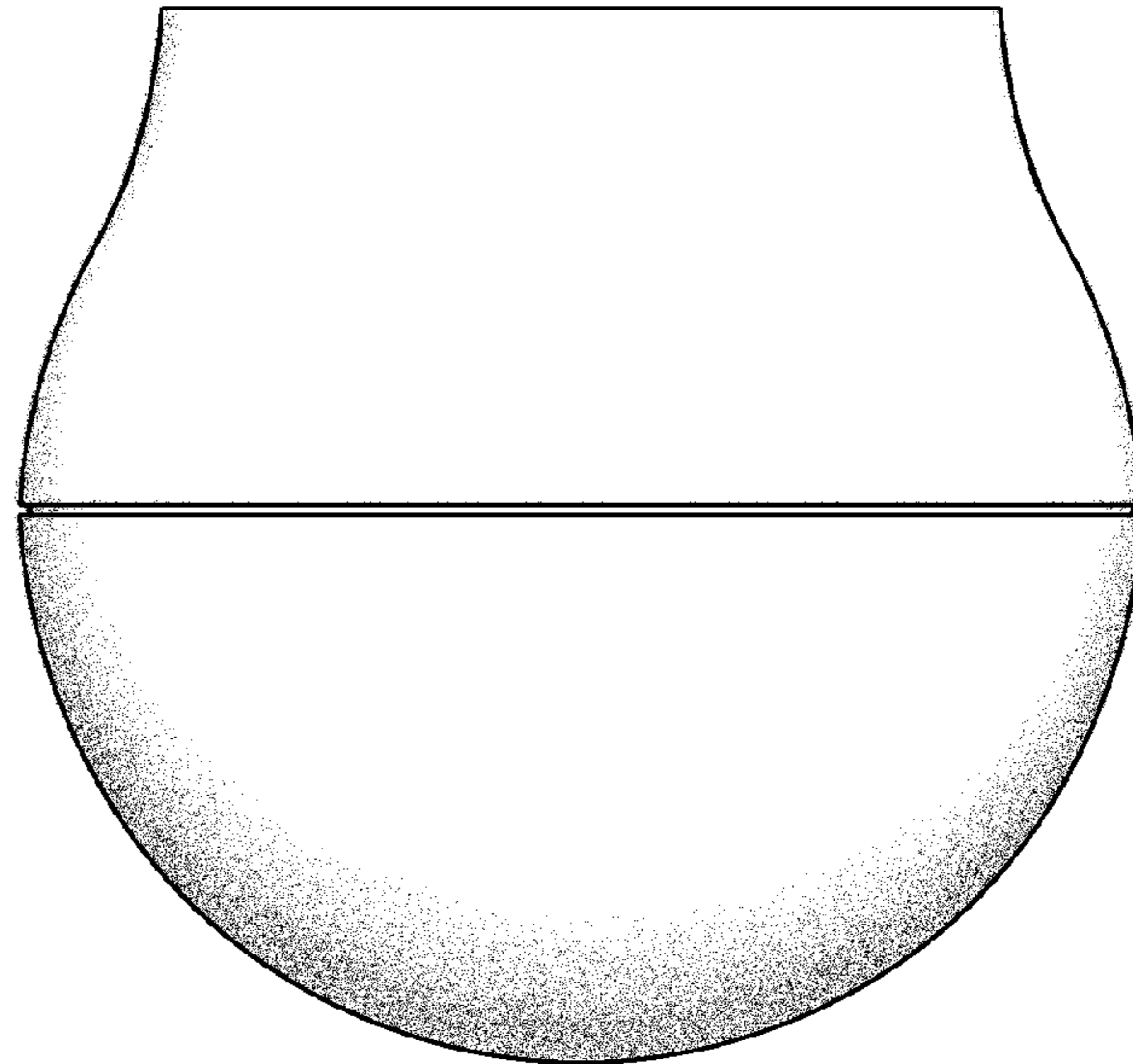

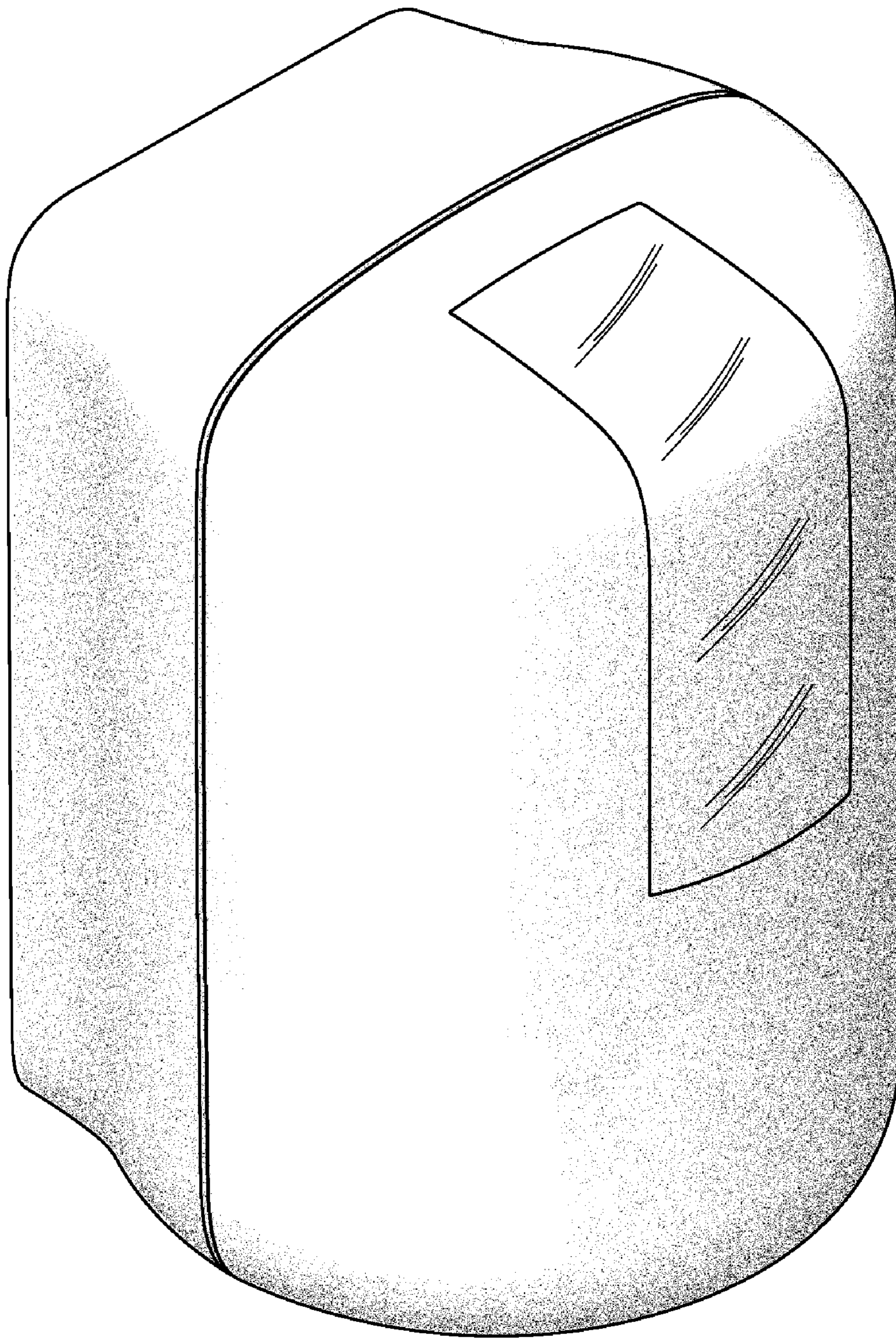

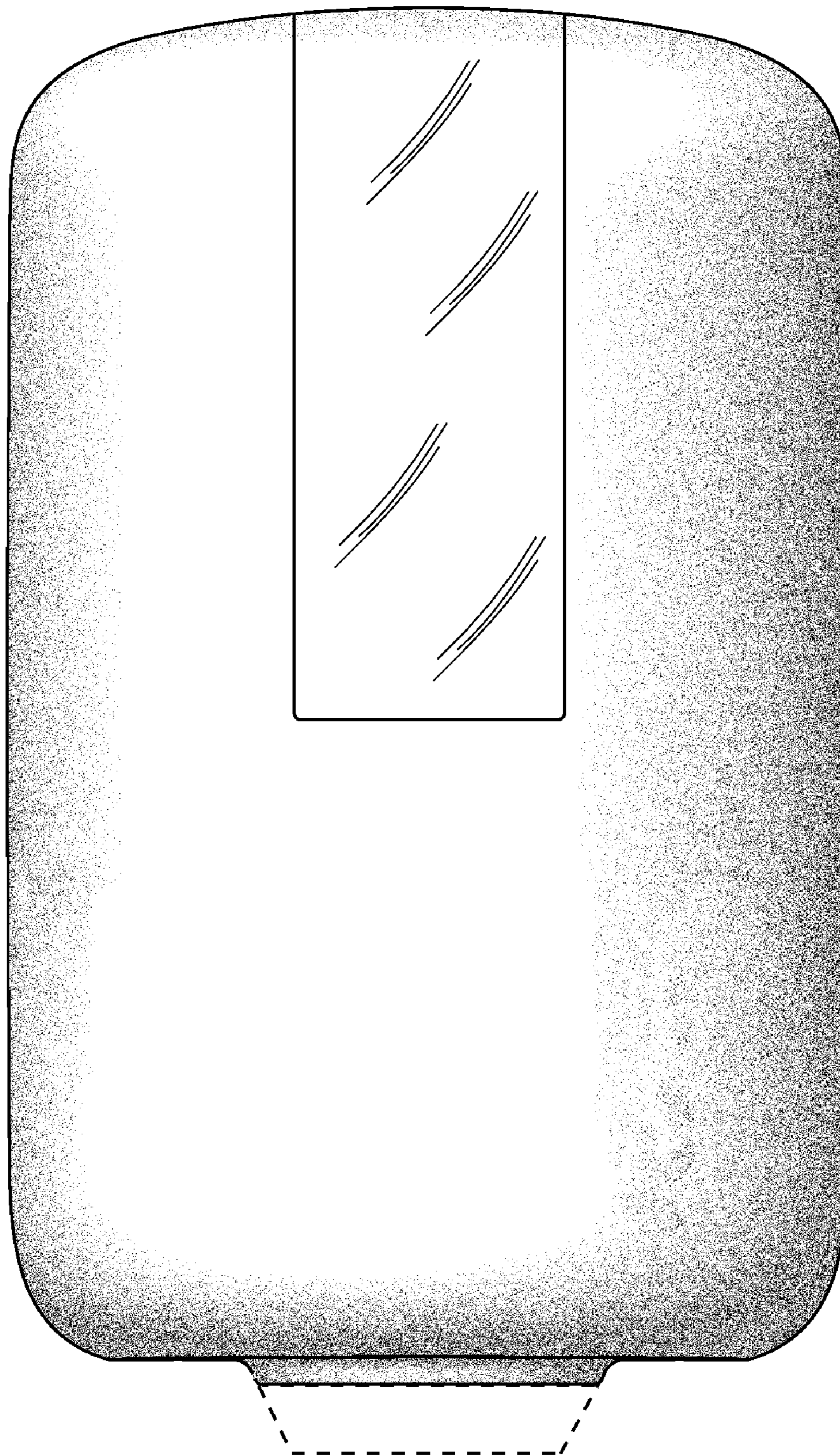
