FIG. 3 is a front view of the shower caddy as shown in FIG. 1;

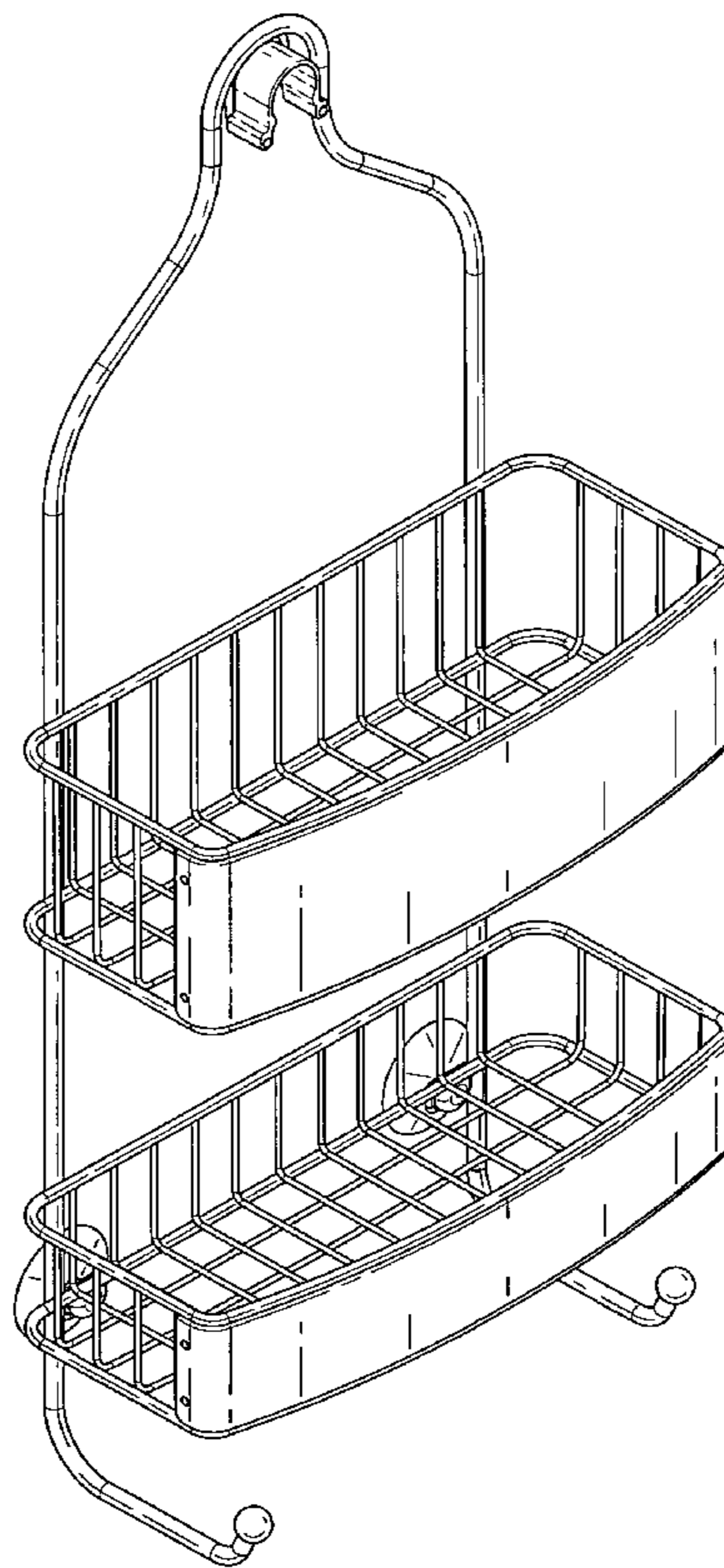
FIG. 4 is a side view of the shower caddy as shown in FIG. 1;

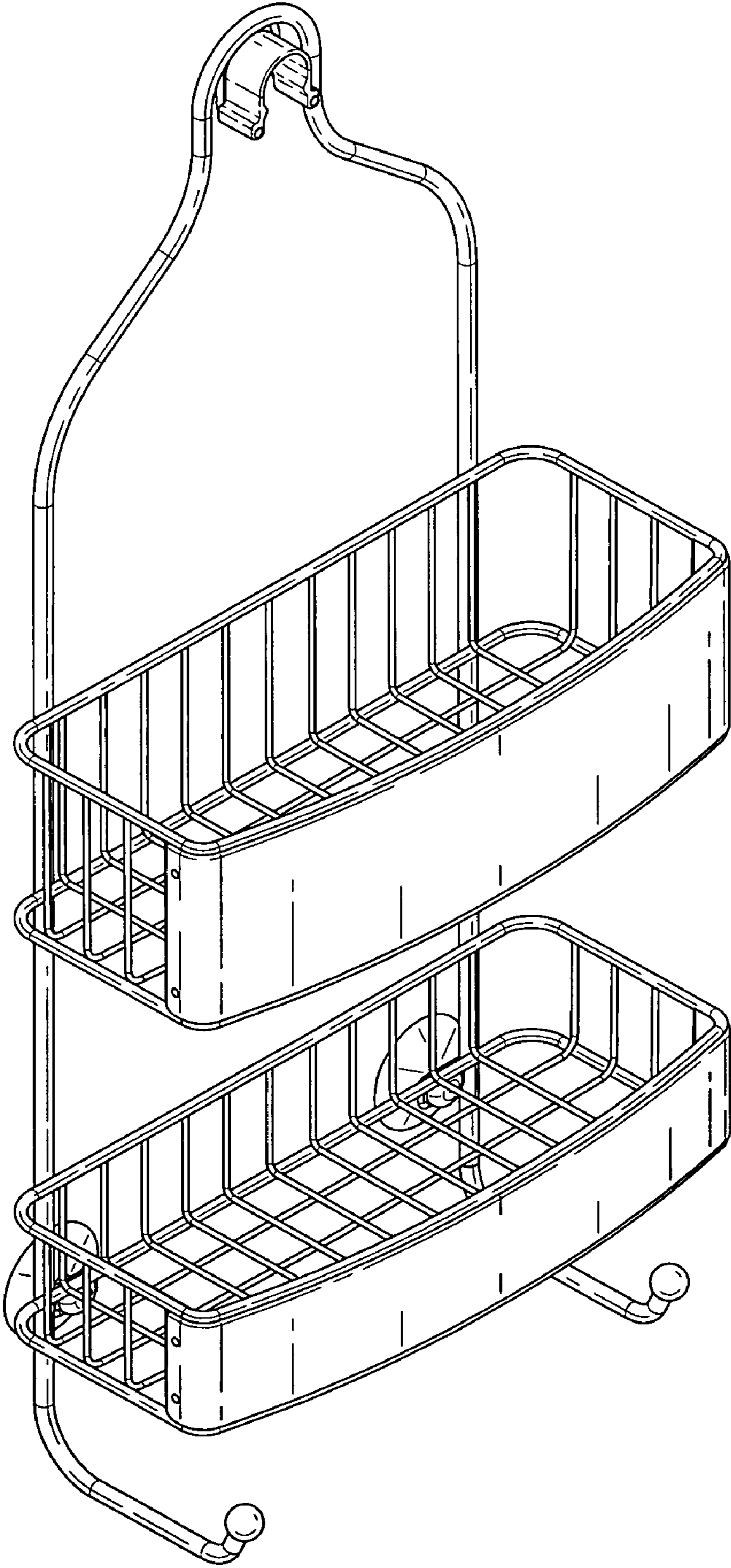

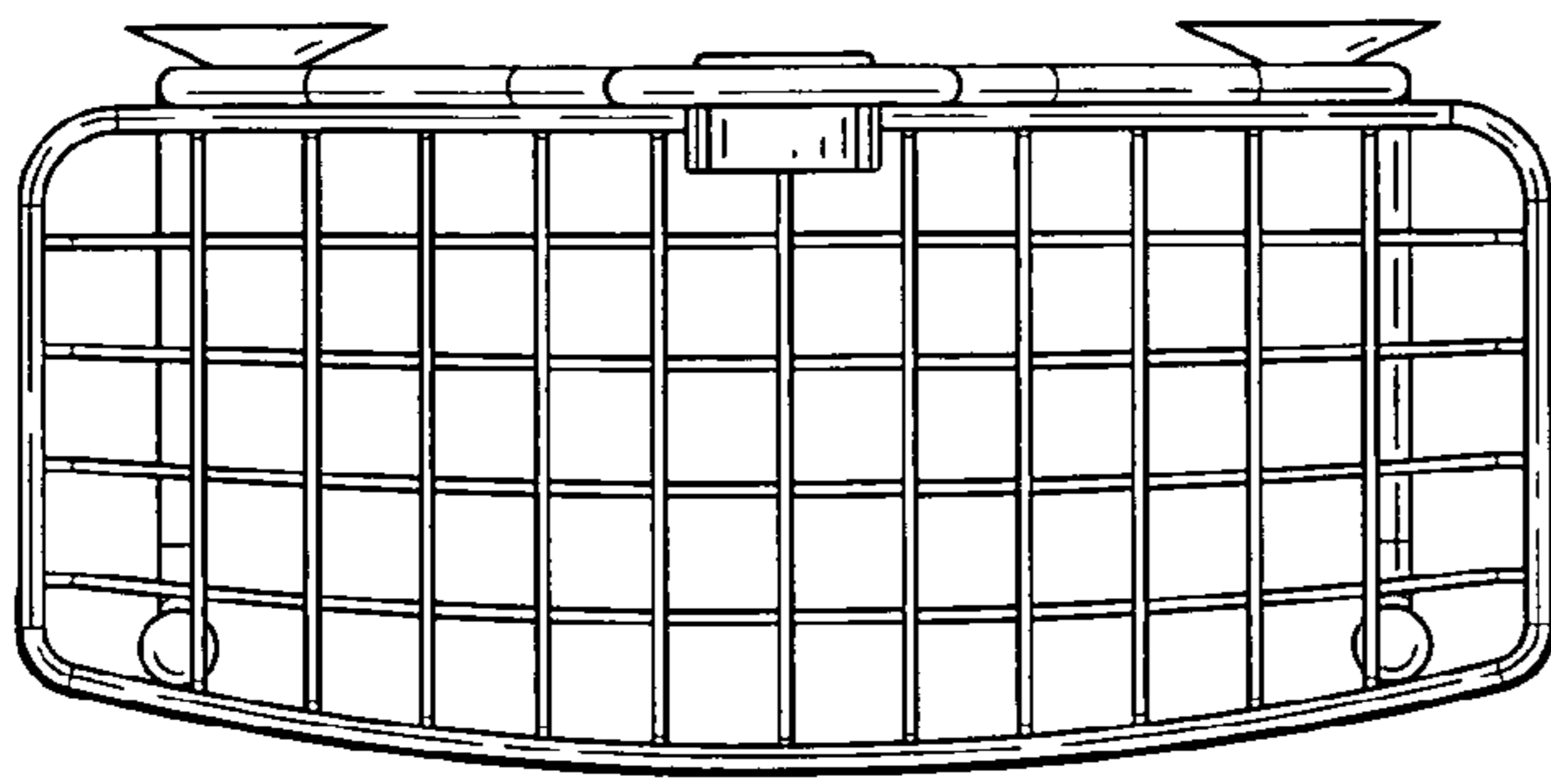

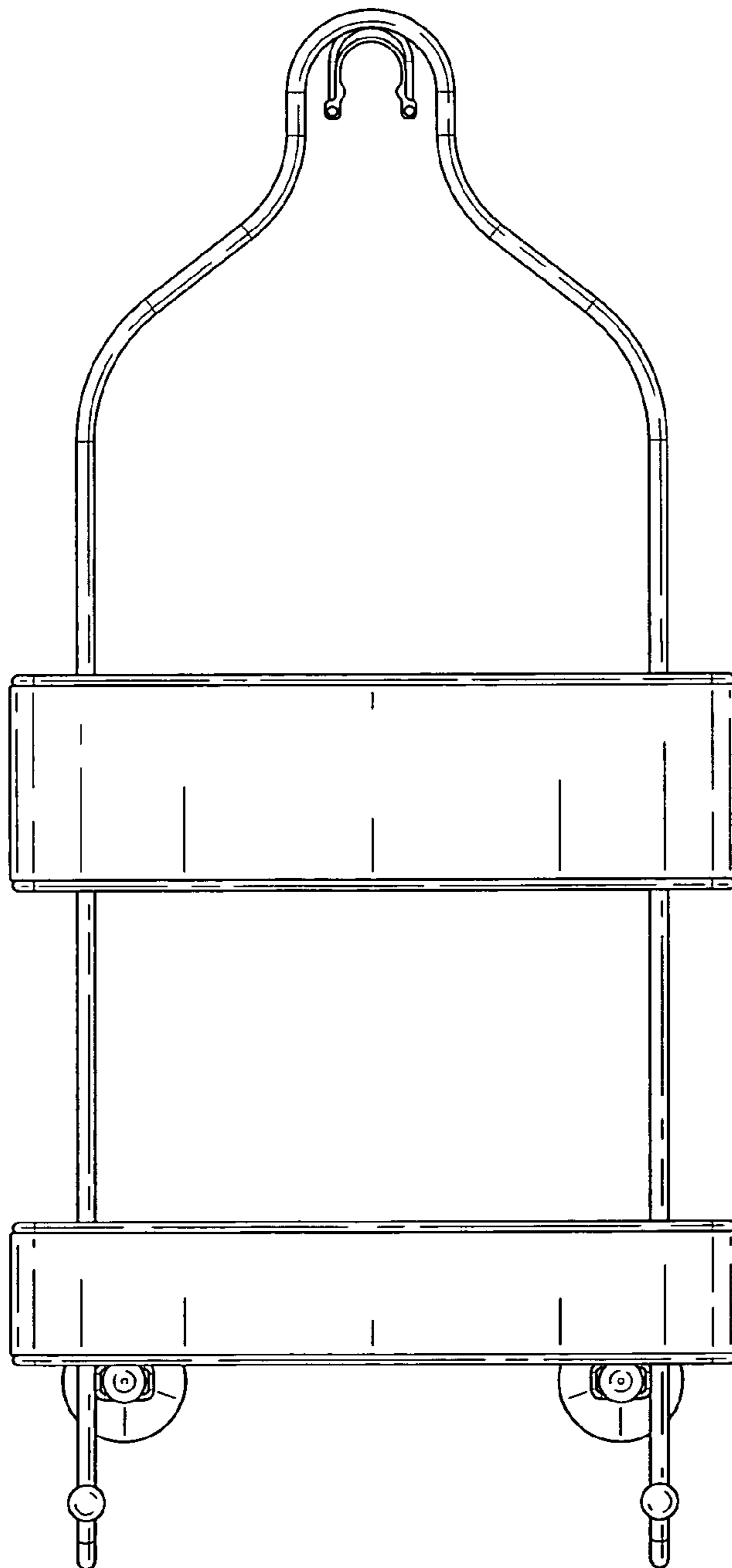

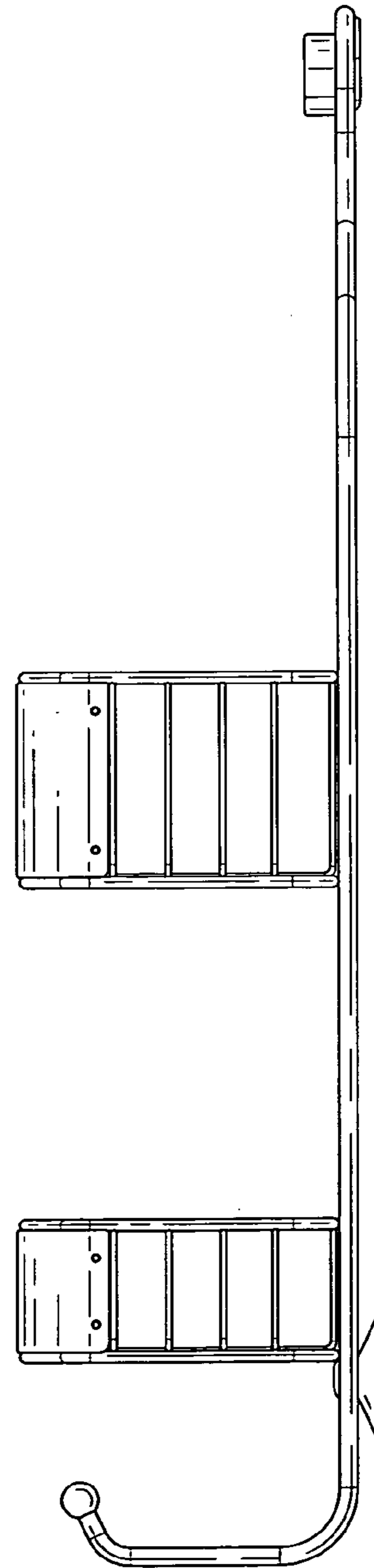

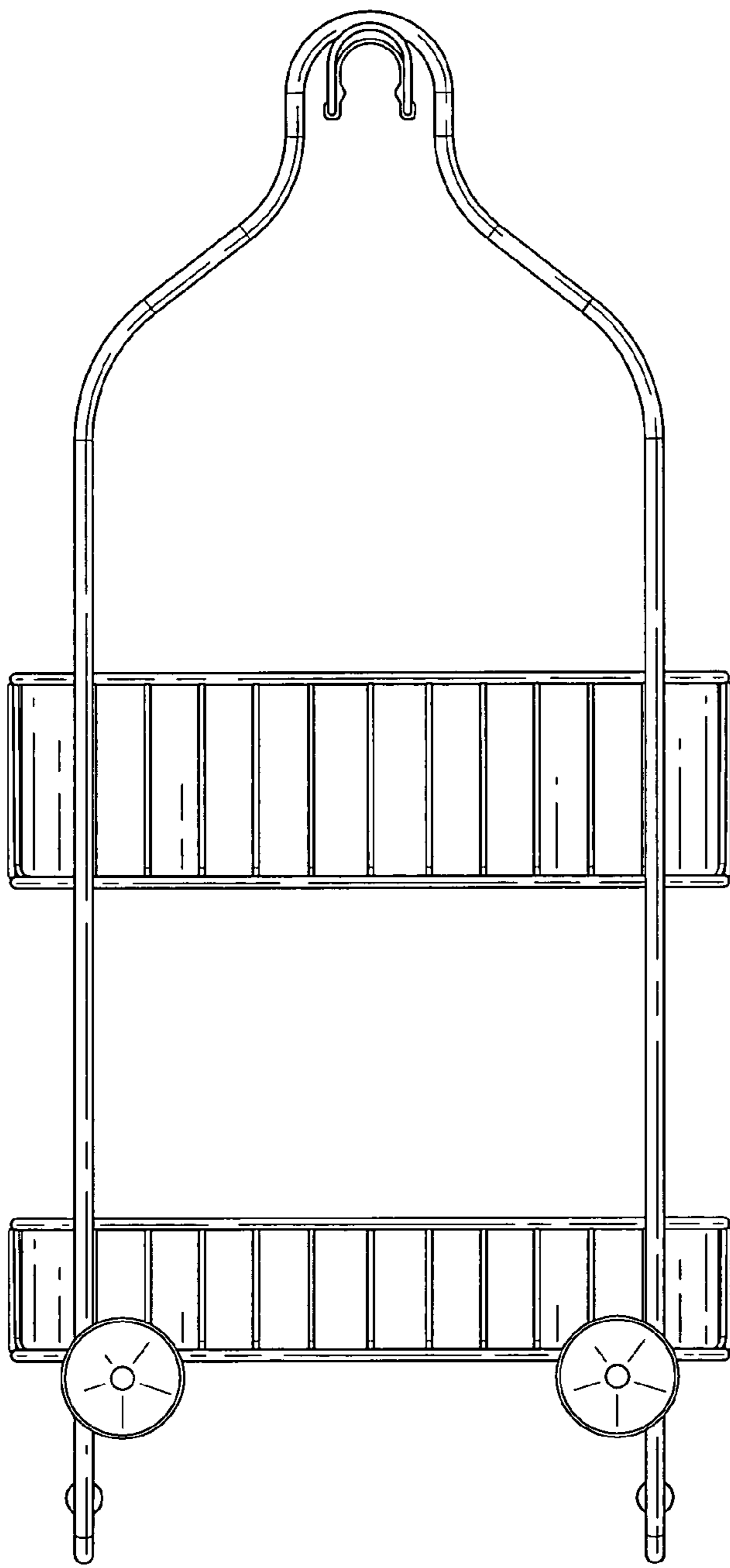

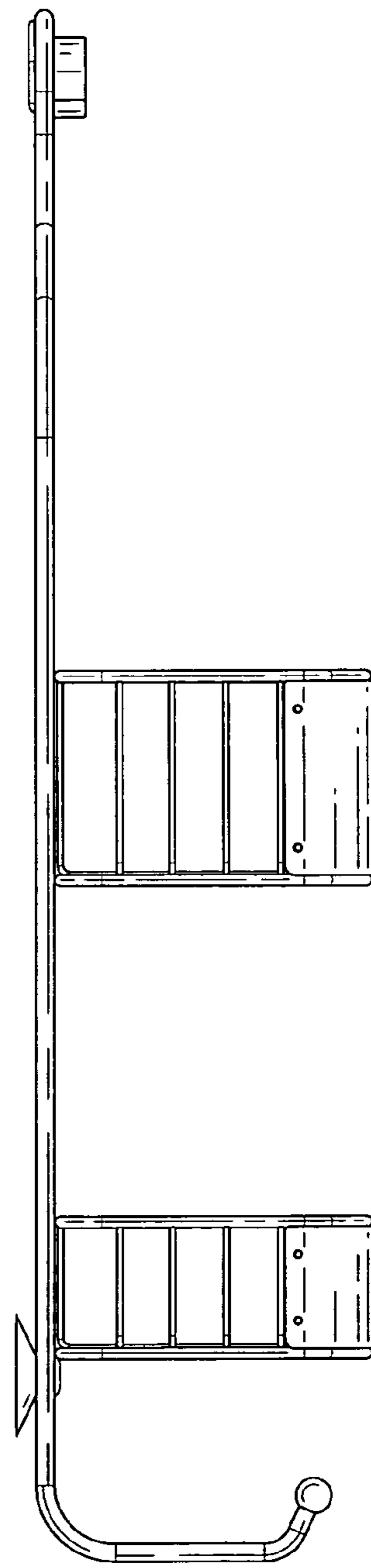

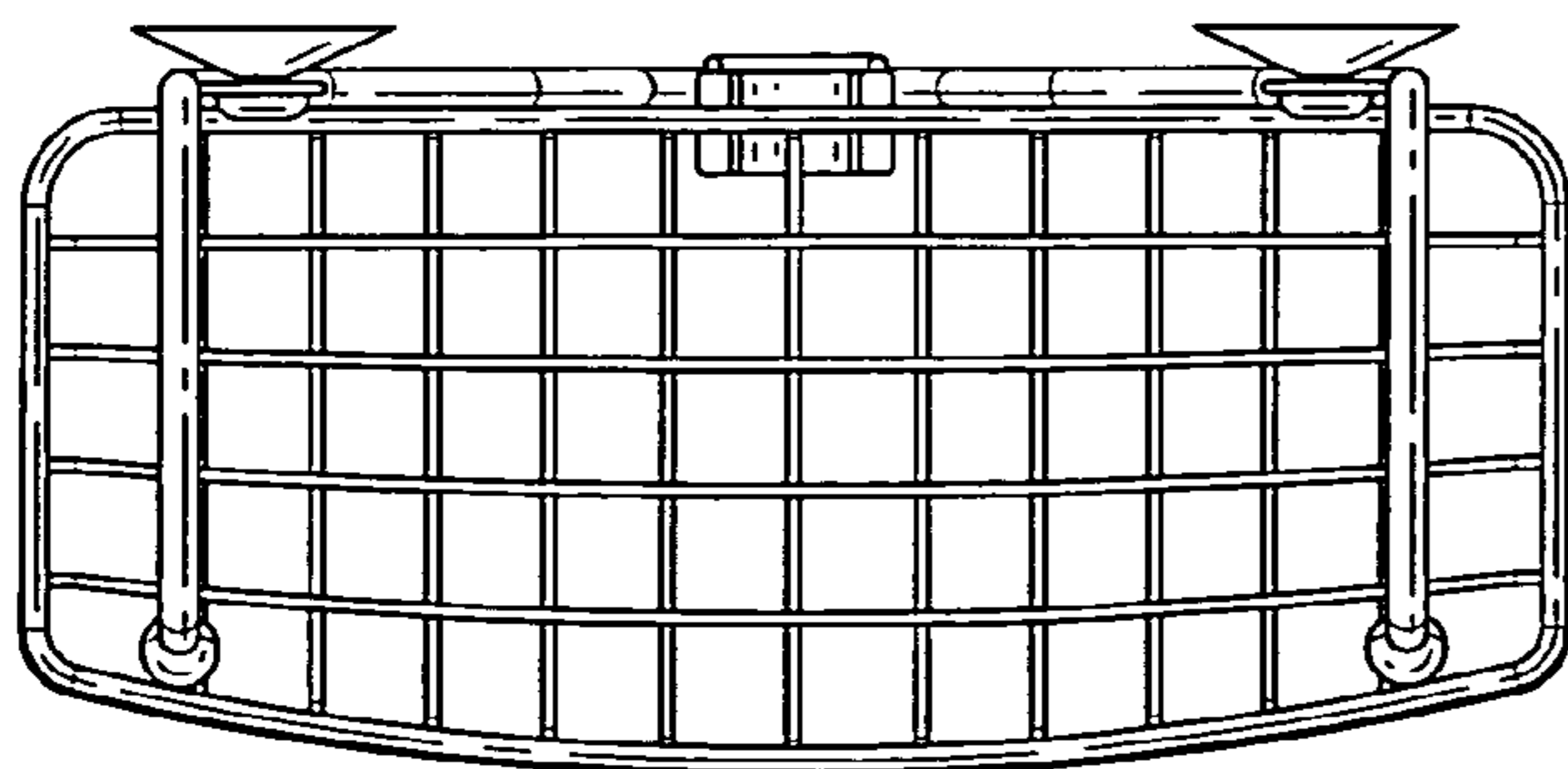
