The ornamental design for a “food storage container lid,” as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view showing my new design for a food storage container lid;

FIG. 2 is a front view of the food storage container lid shown in FIG. 1;

FIG. 6 is a top view of the food storage container lid shown in FIG. 1;

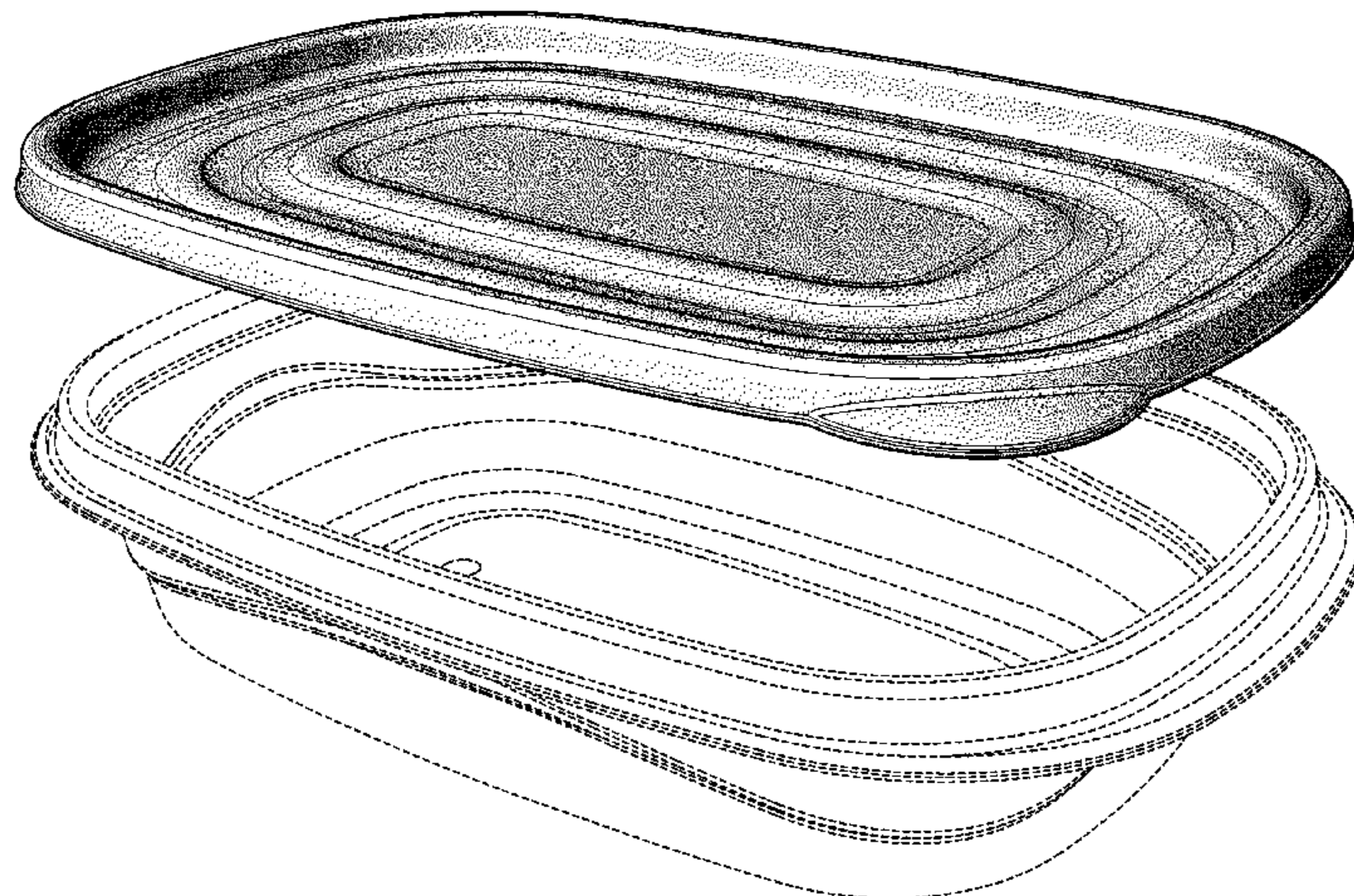
FIG. 7 is a bottom view of the food storage container lid shown in FIG. 1;

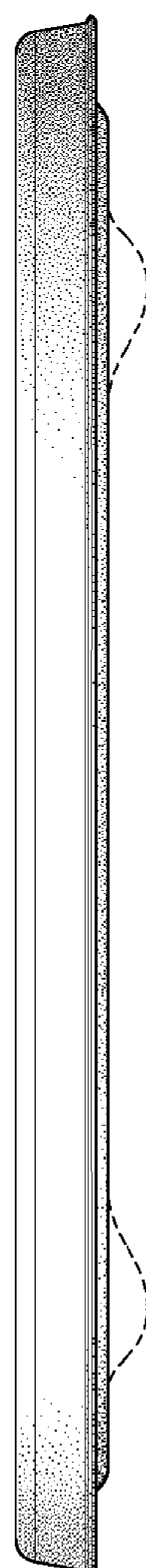
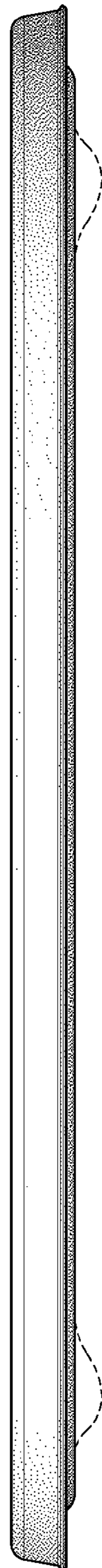
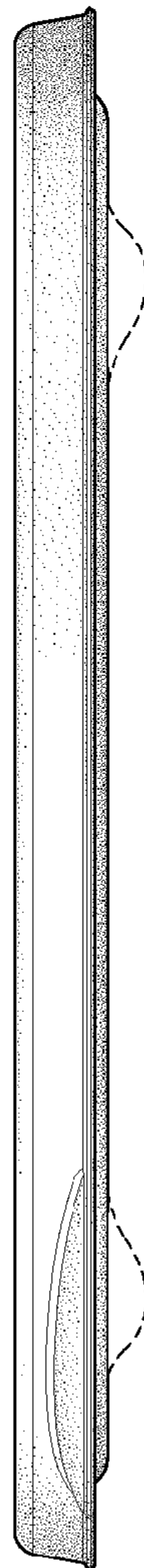
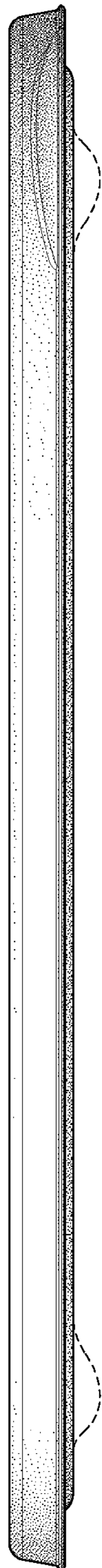
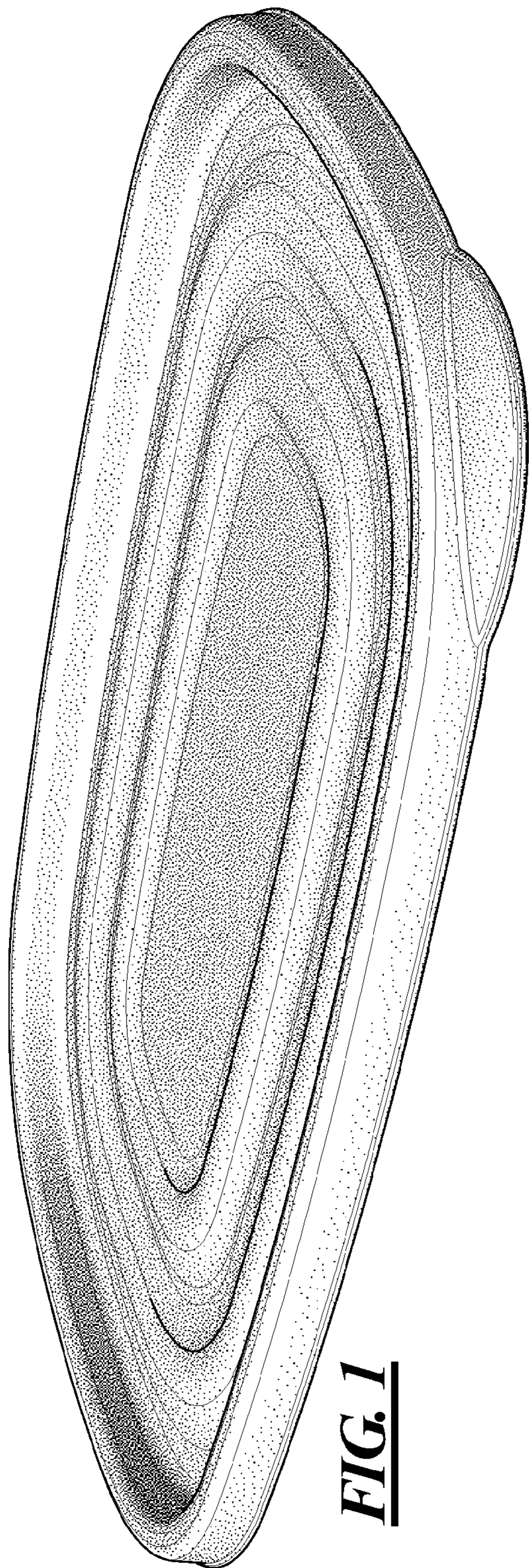
FIG. 8 is a perspective exploded view of the food storage container lid shown in FIG. 1 with an exemplary base; and,

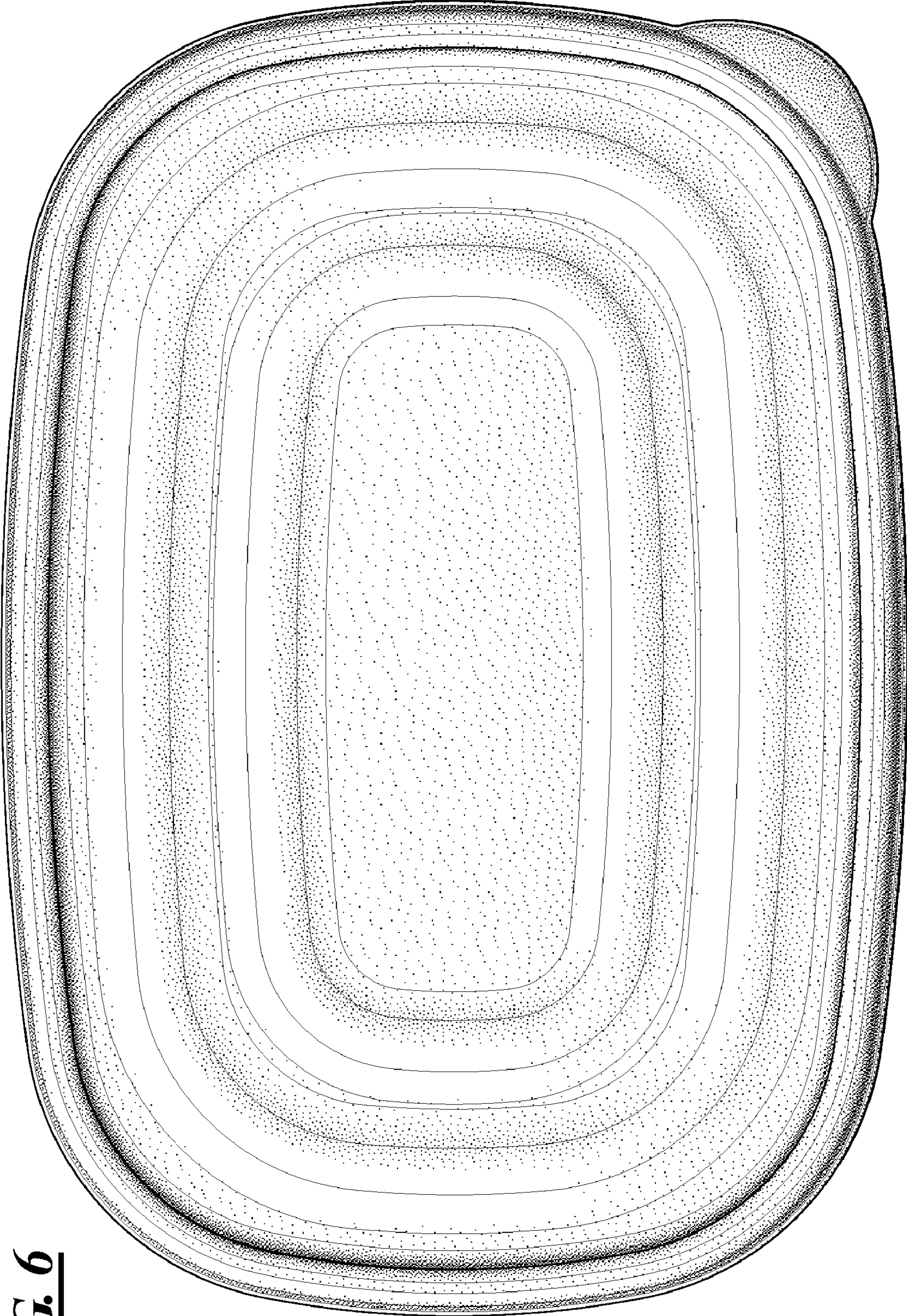

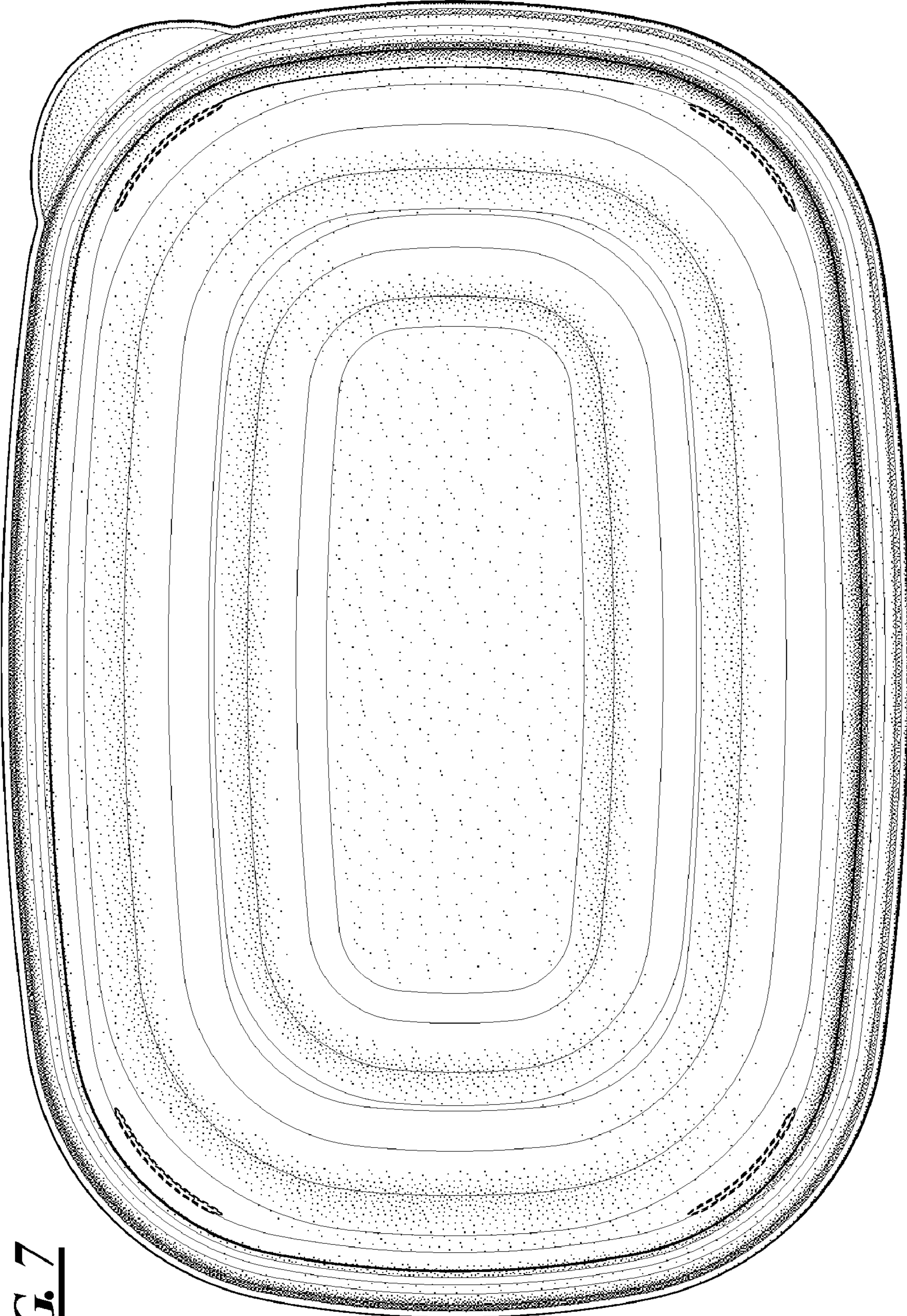

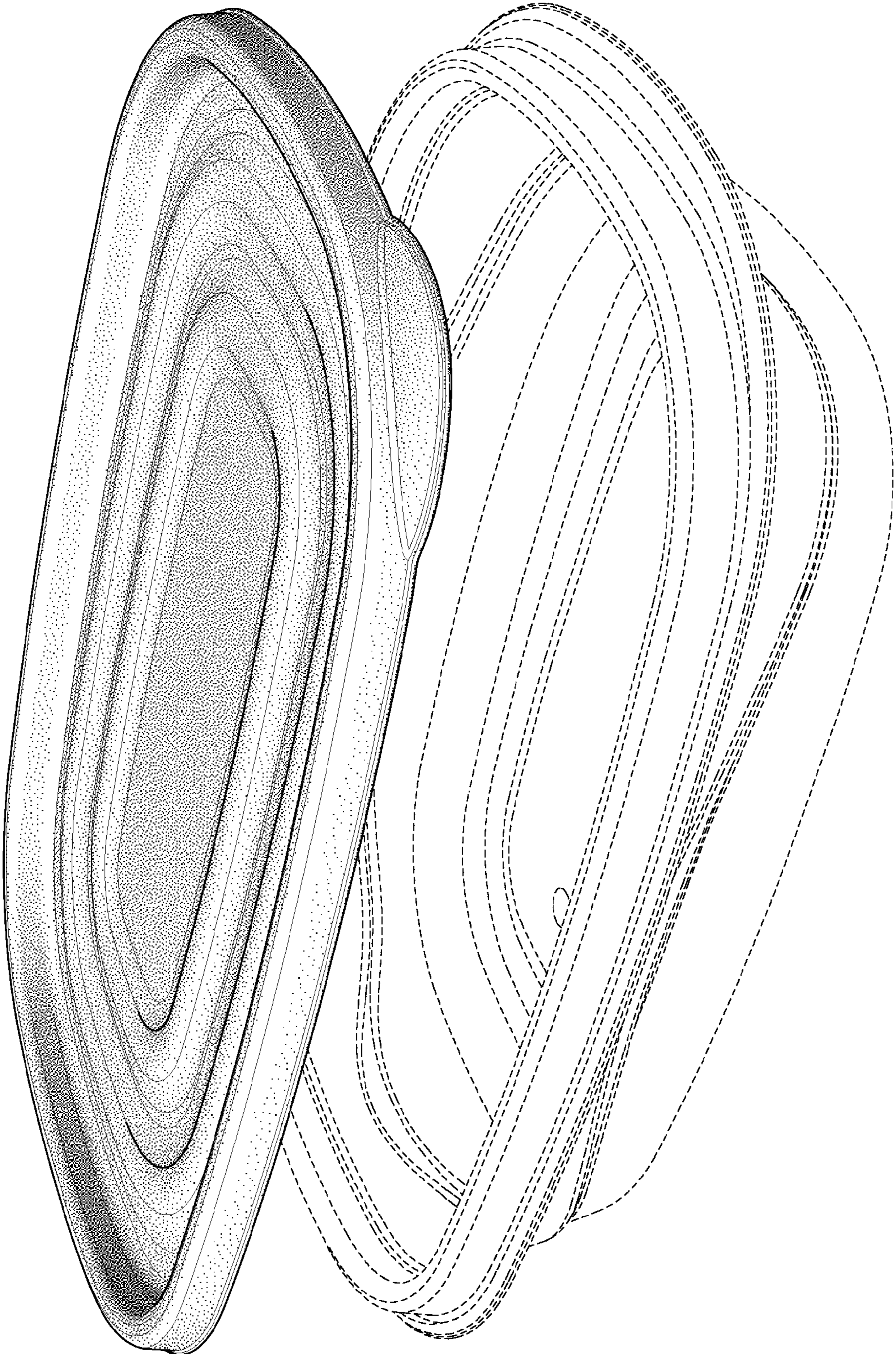
