FIG. 2 is a bottom perspective view of the double-walled dessert glass shown in FIG. 1;

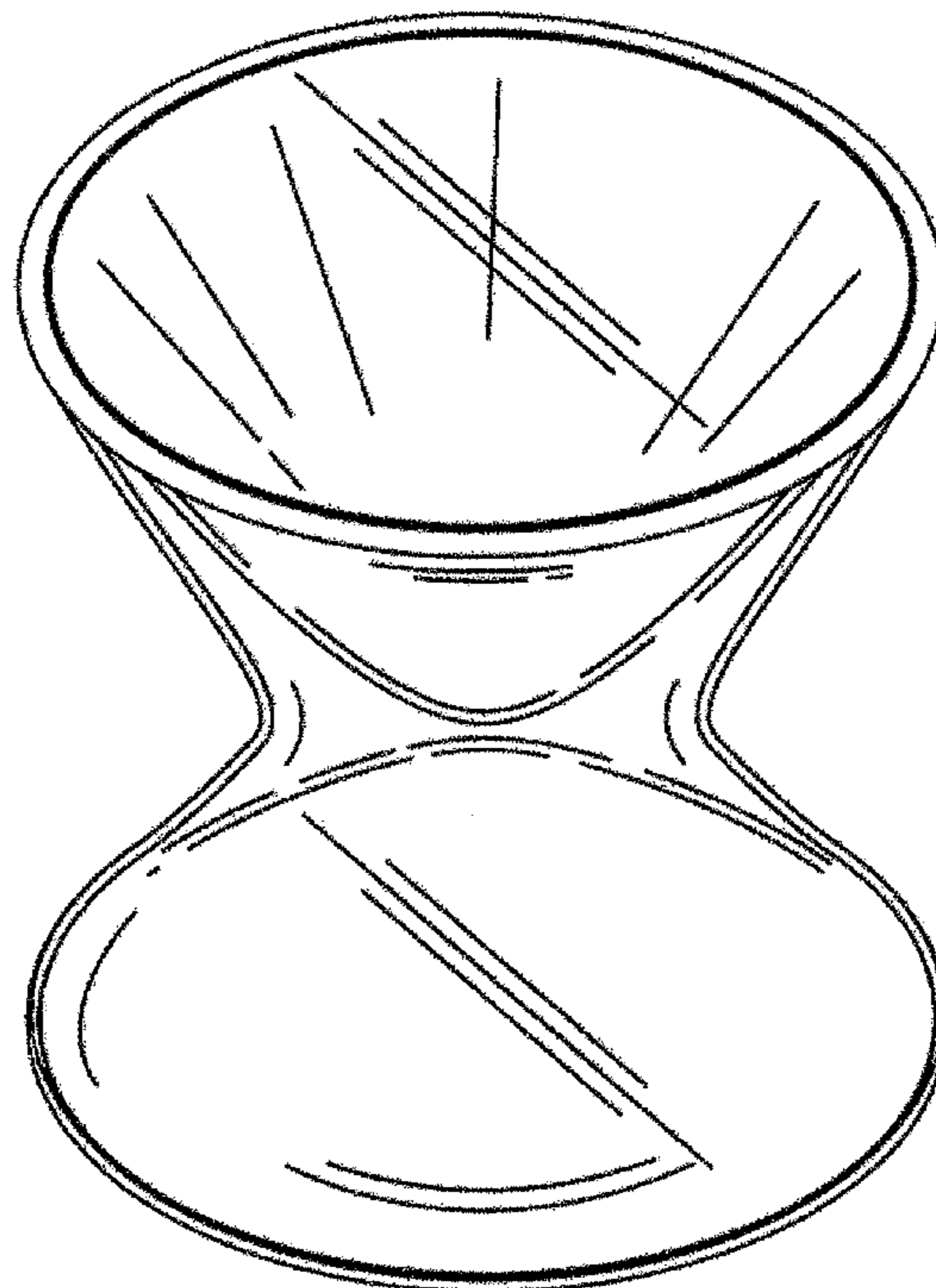
FIG. 3 is a side view of the double-walled dessert glass shown in FIG. 1;

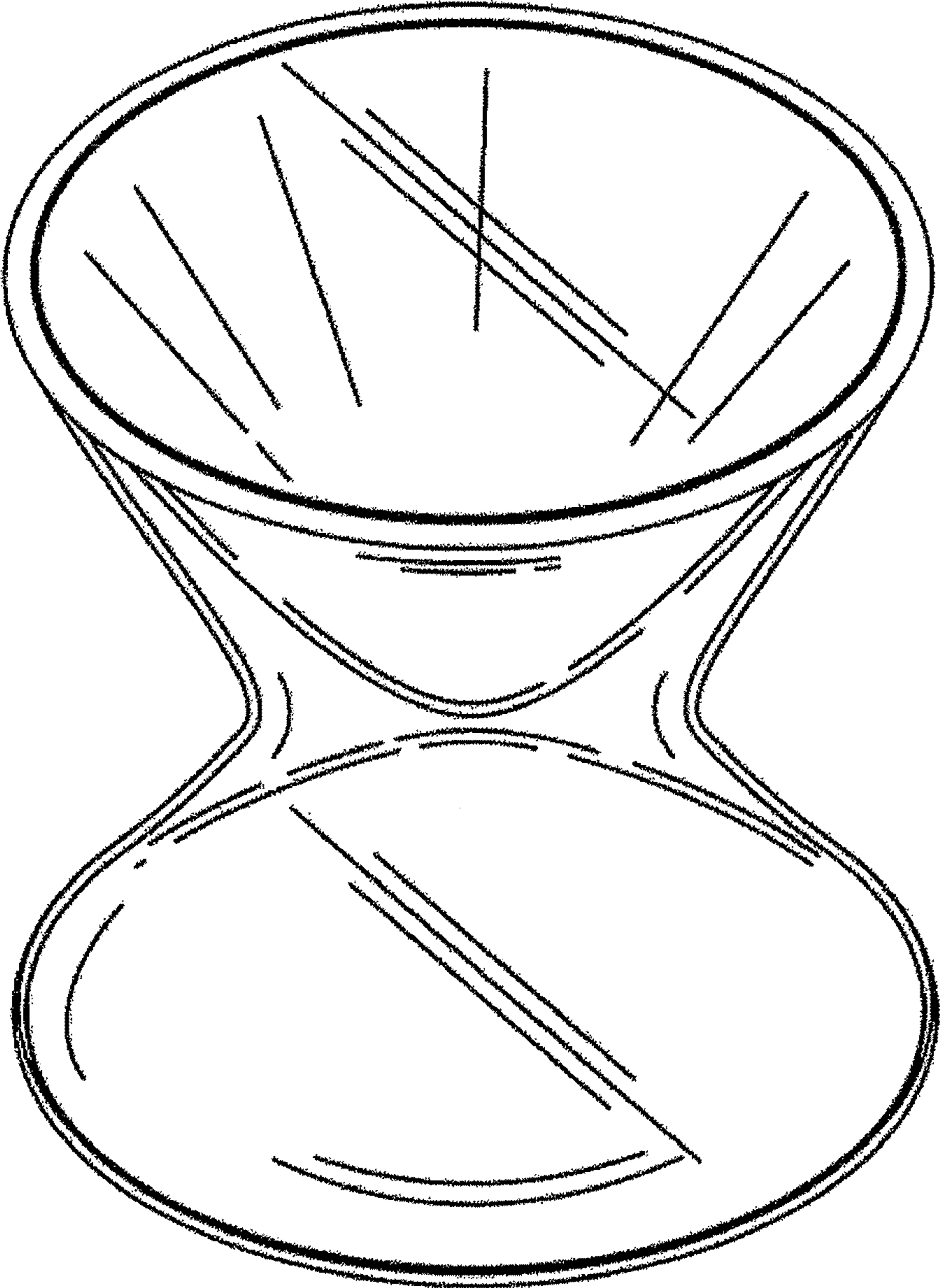
FIG. 4 is a cross-sectional view of the double-walled dessert glass in FIG. 3 along the A—A axis.

FIG. 5 is a top plan view of the double-walled dessert glass shown in FIG. 1; and,

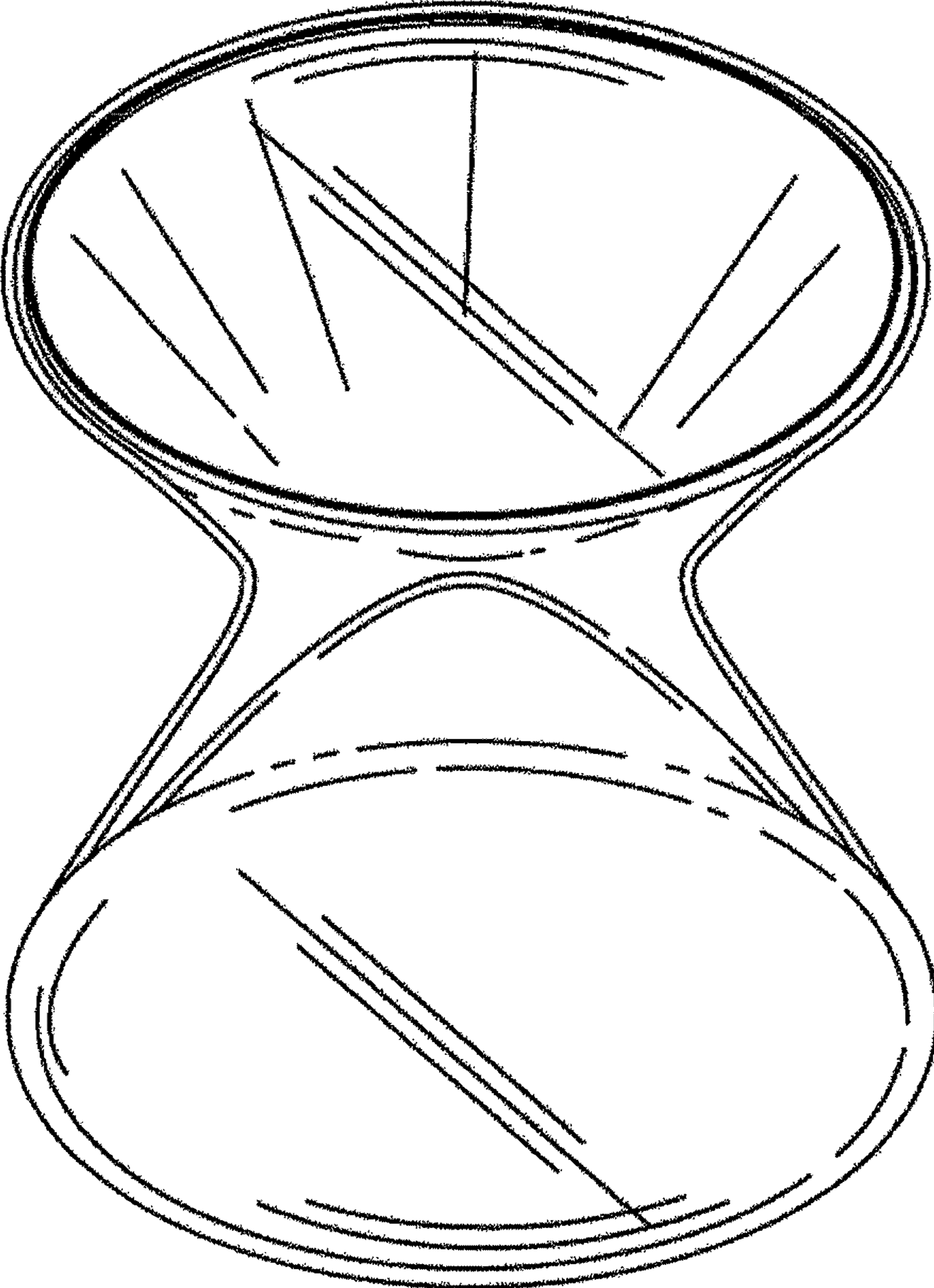
FIG. 6 is a bottom plan view of the double-walled dessert glass shown in FIG. 1.

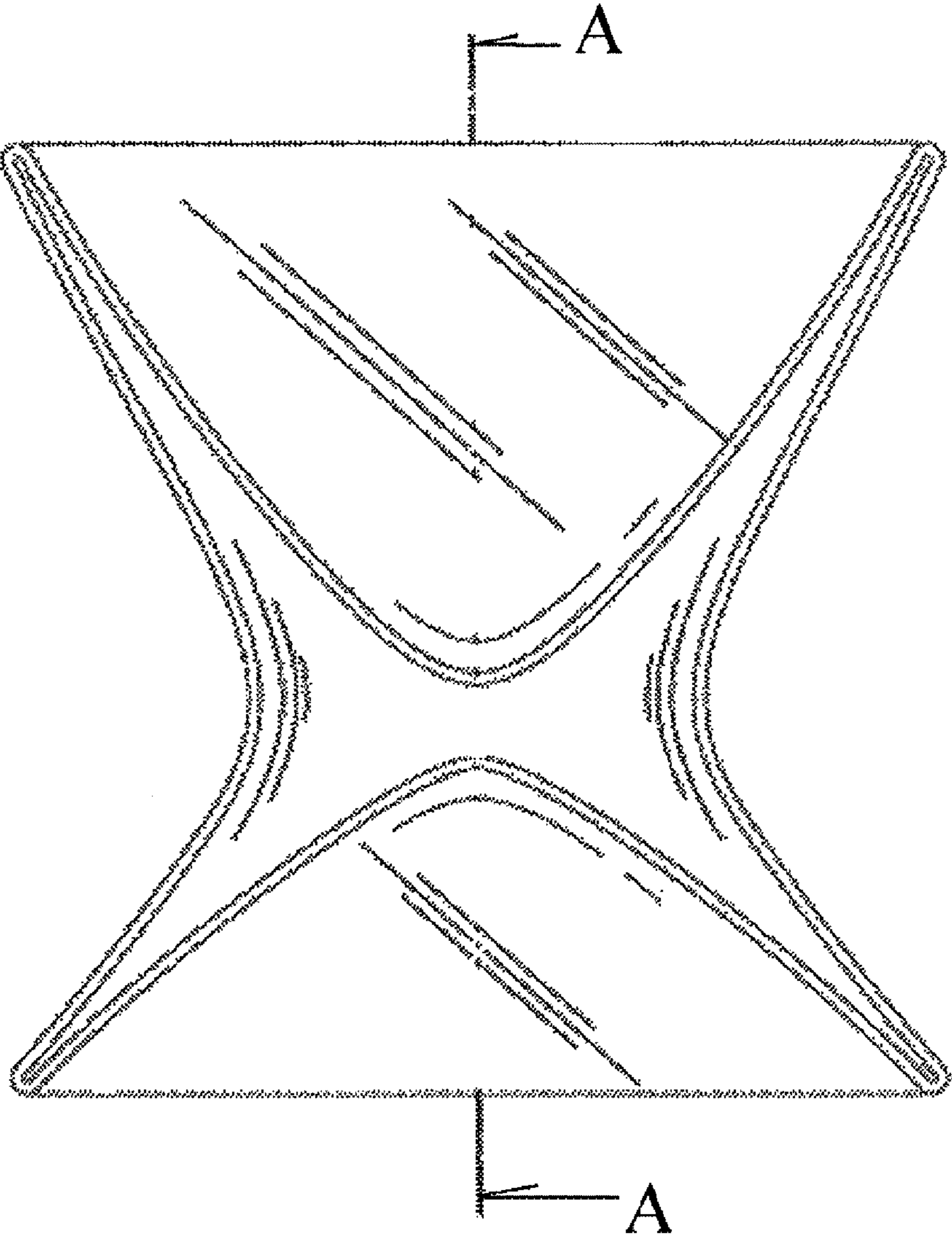




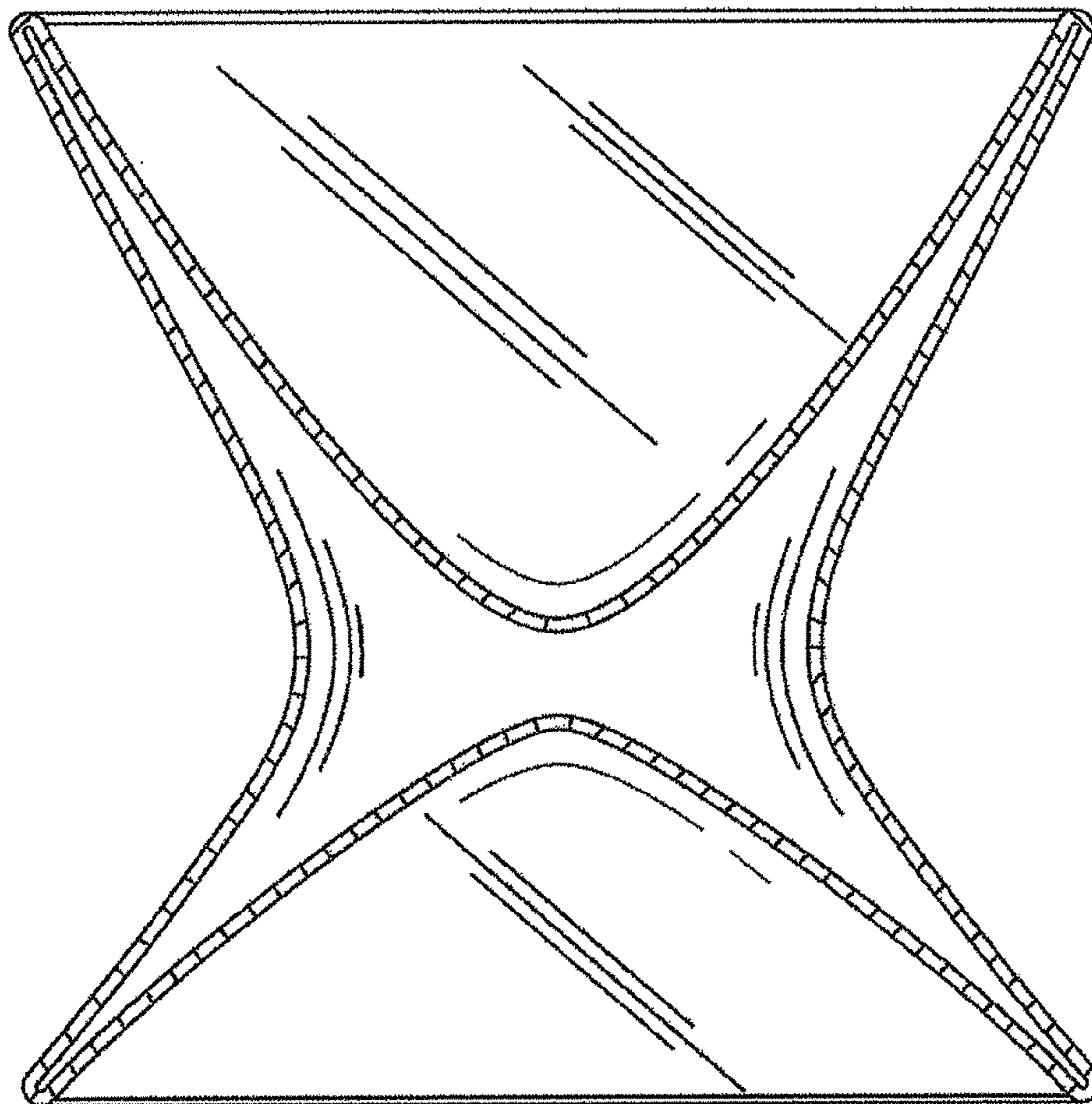

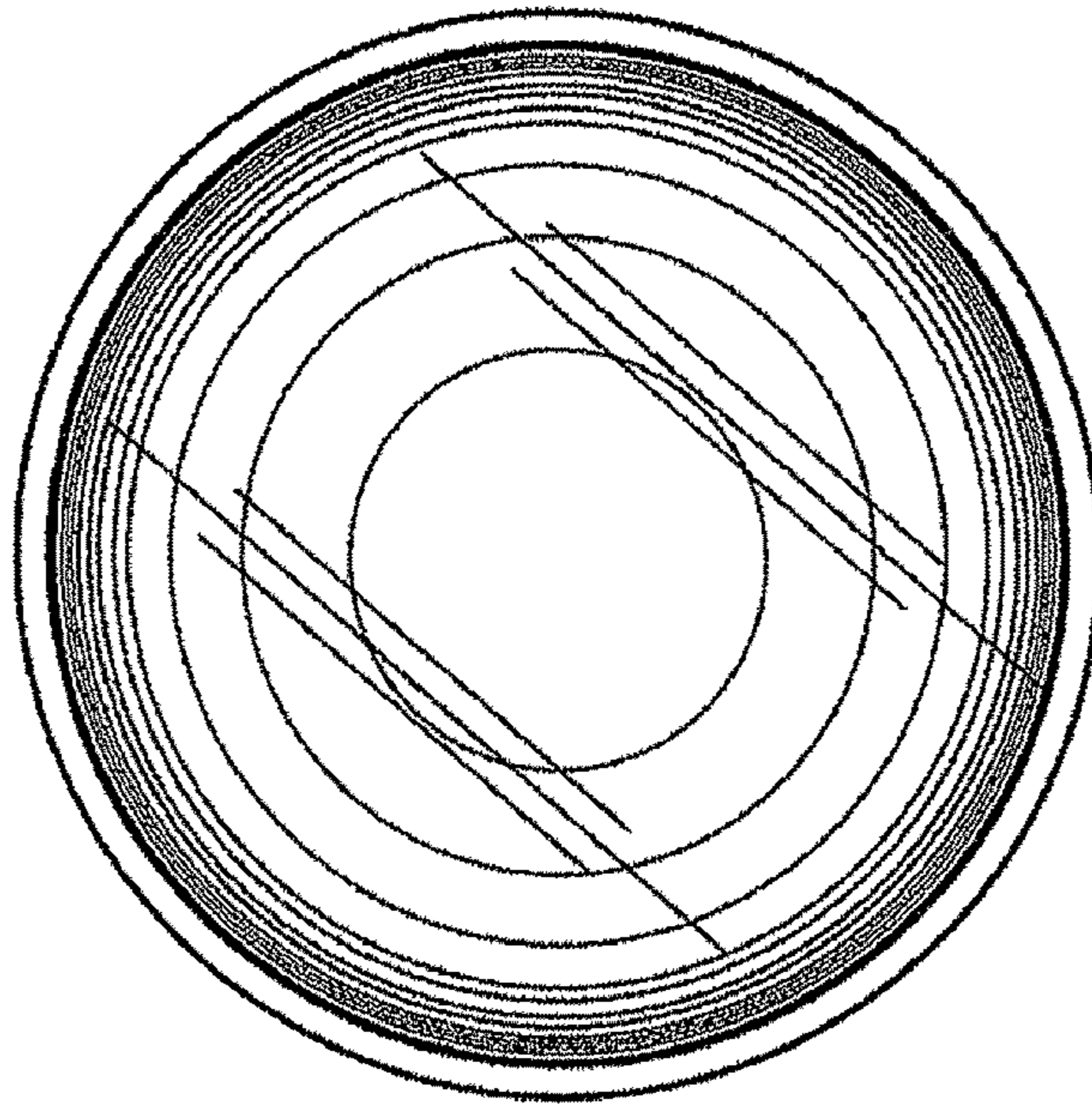

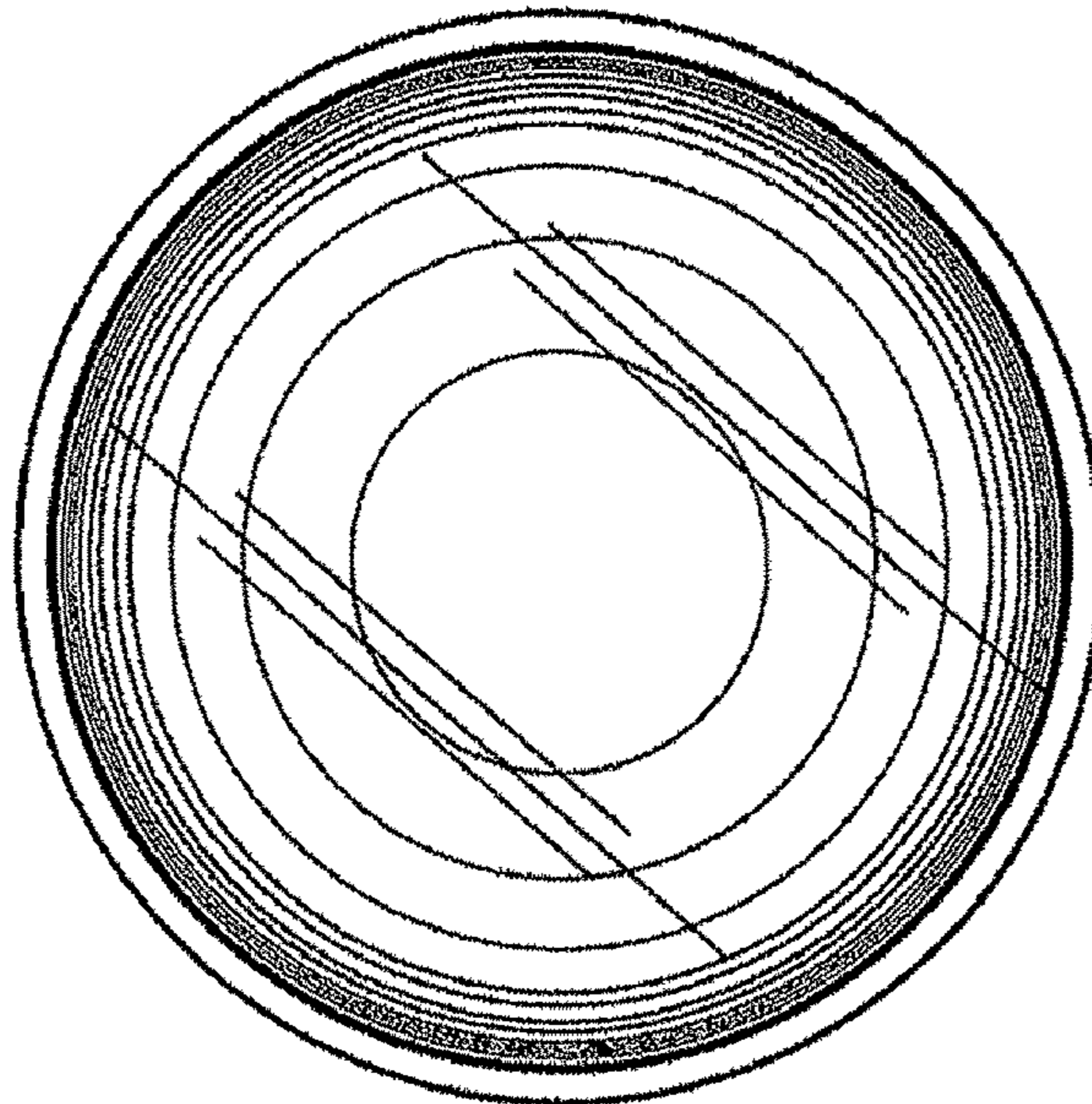
