The ornamental design for a insulated container holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the insulated container holder of this invention.

FIG. 2 is an elevational front view of the insulated container holder shown in FIG. 1.

FIG. 3 is a top plan view of the insulated container holder shown in FIG. 1.

FIG. 4 is an elevational rear view of the insulated container holder shown in FIG. 1.

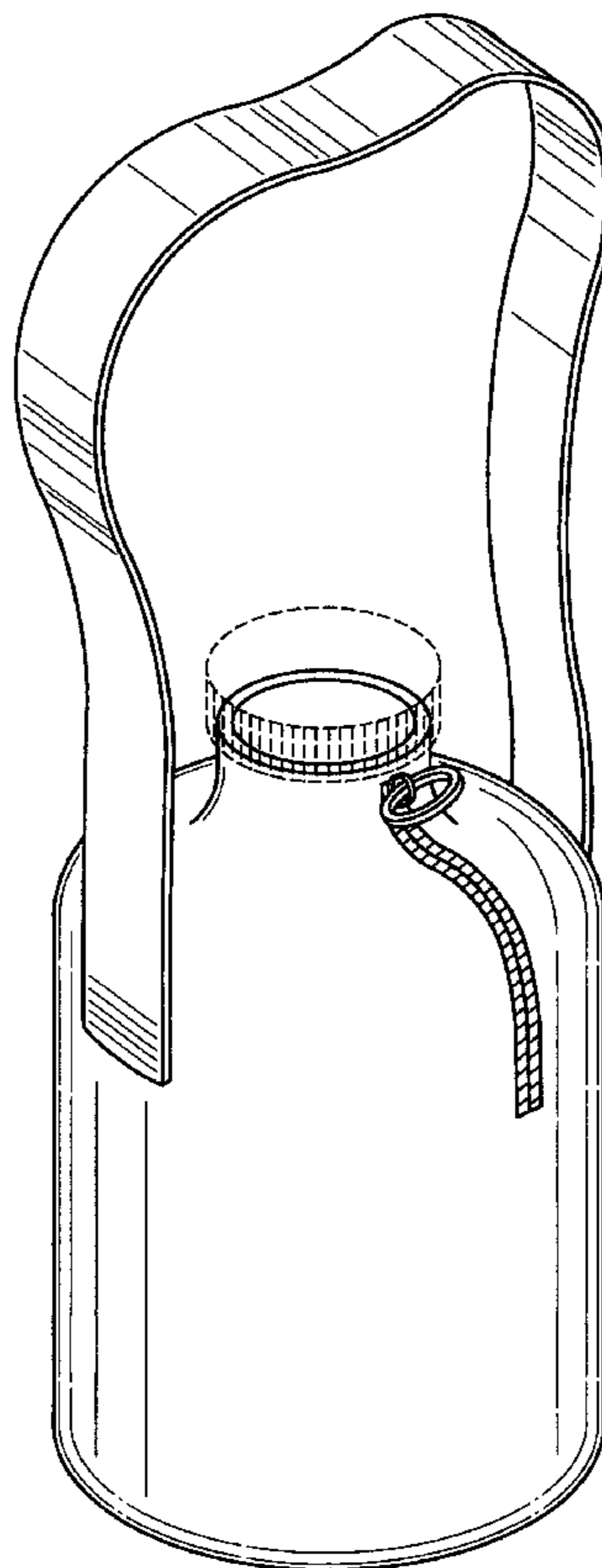
FIG. 5 is a bottom plan view of the insulated container holder shown in FIG. 1.

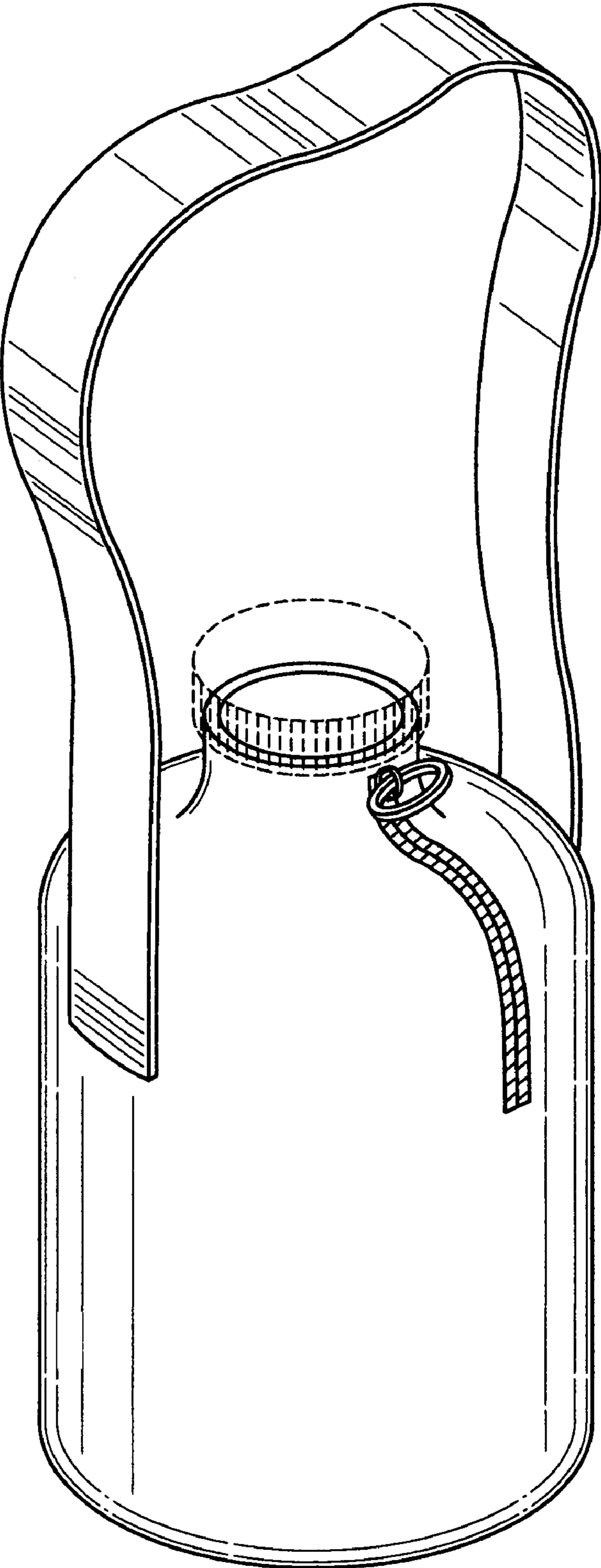
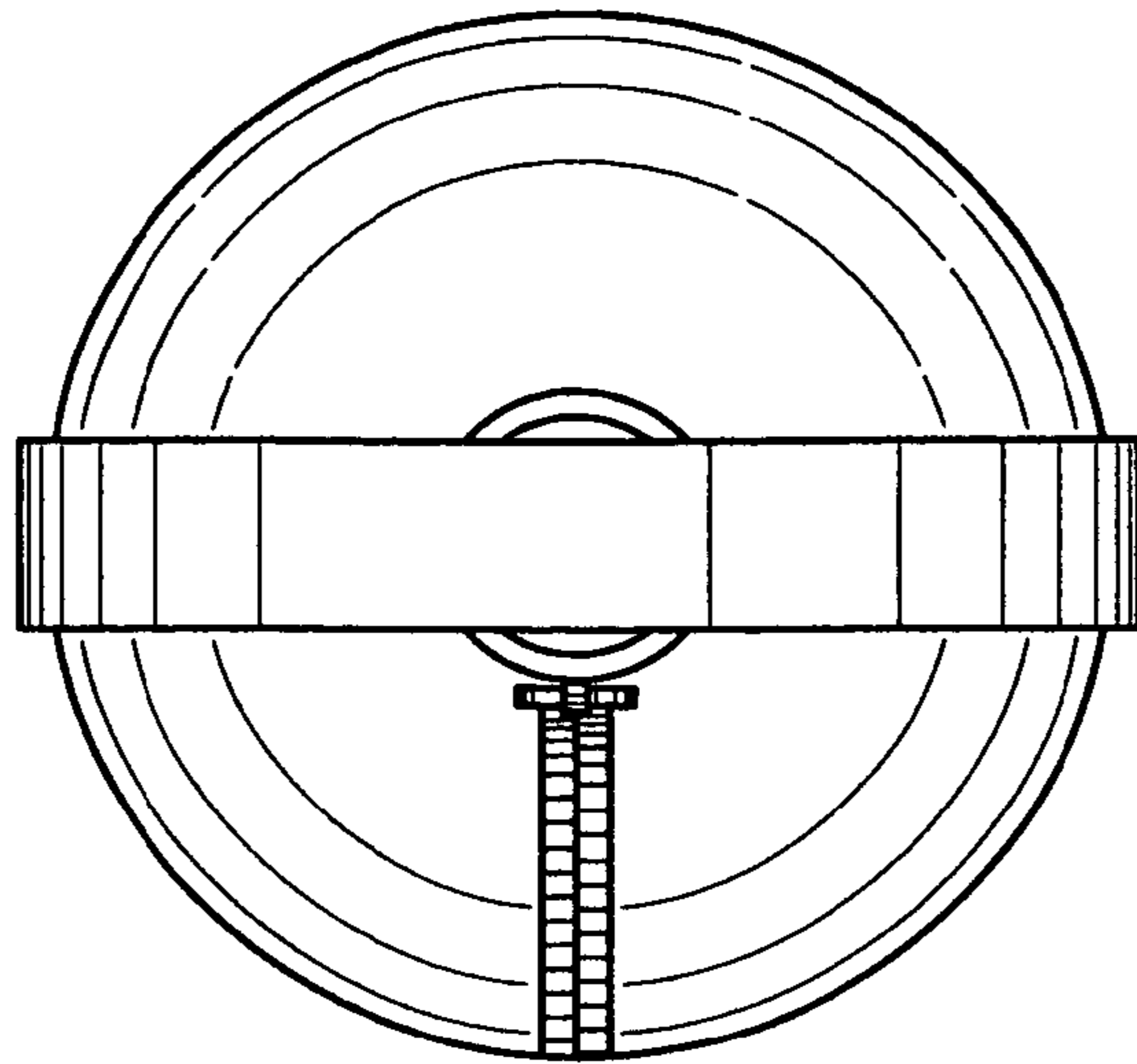
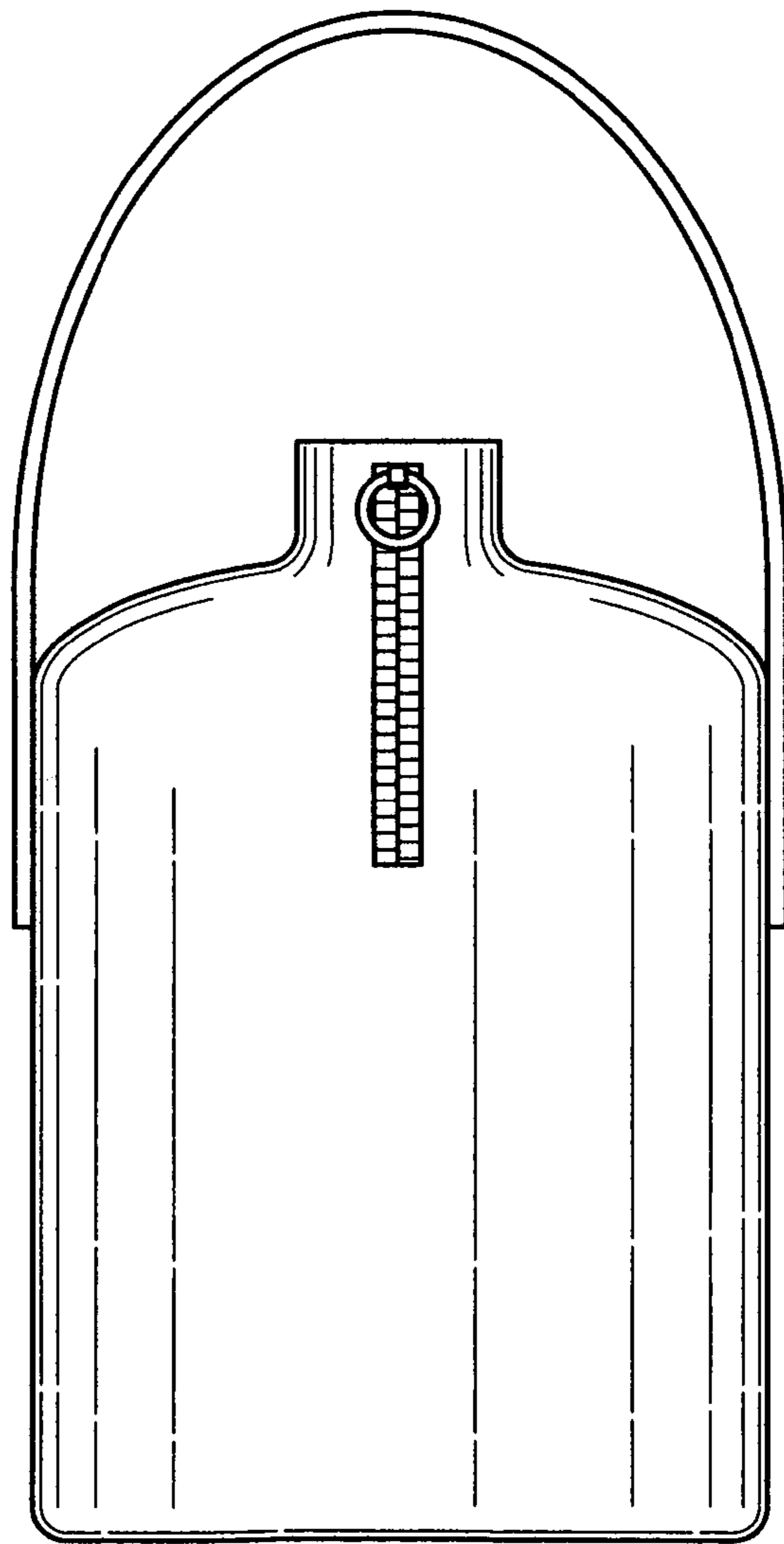


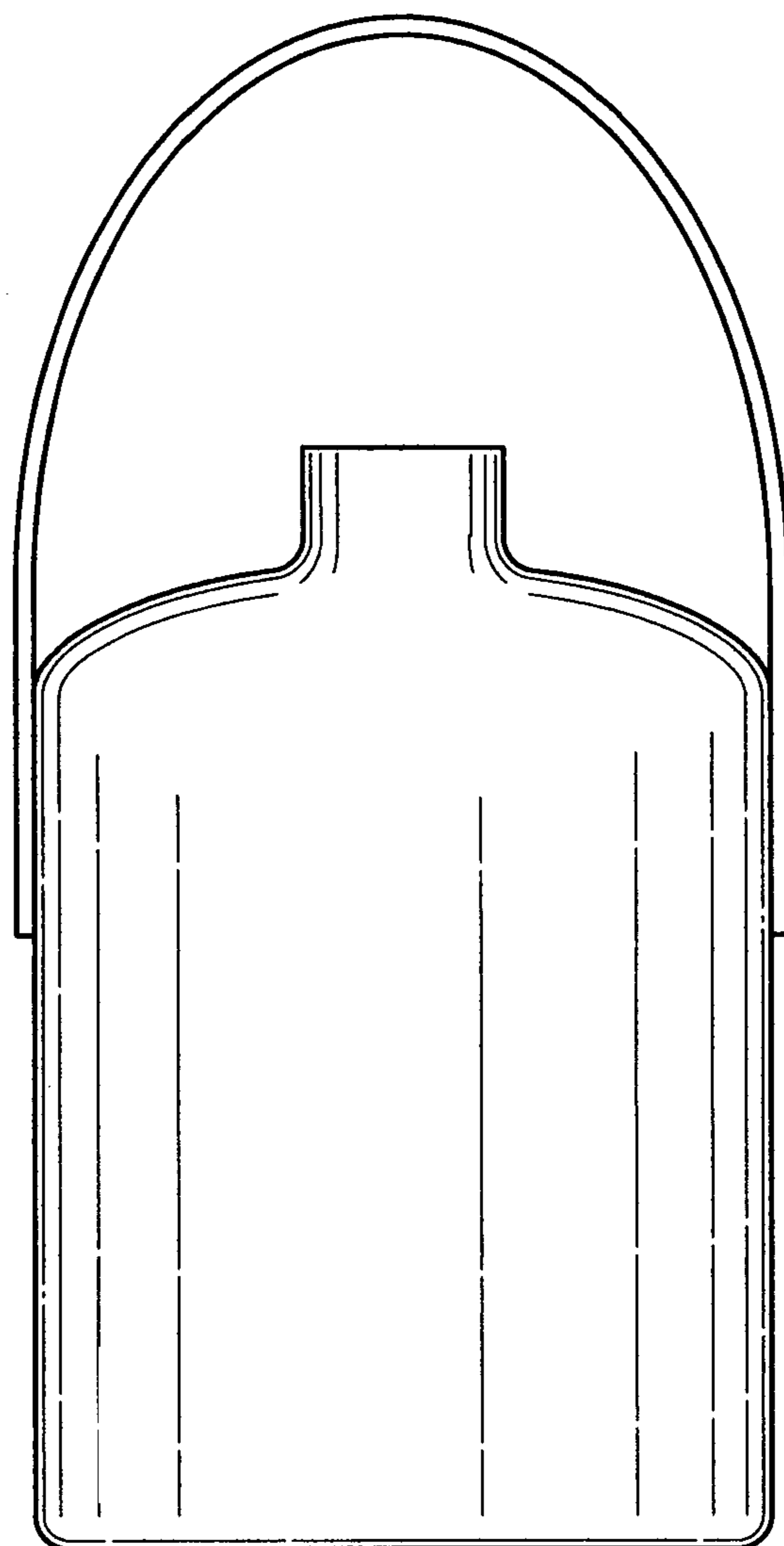

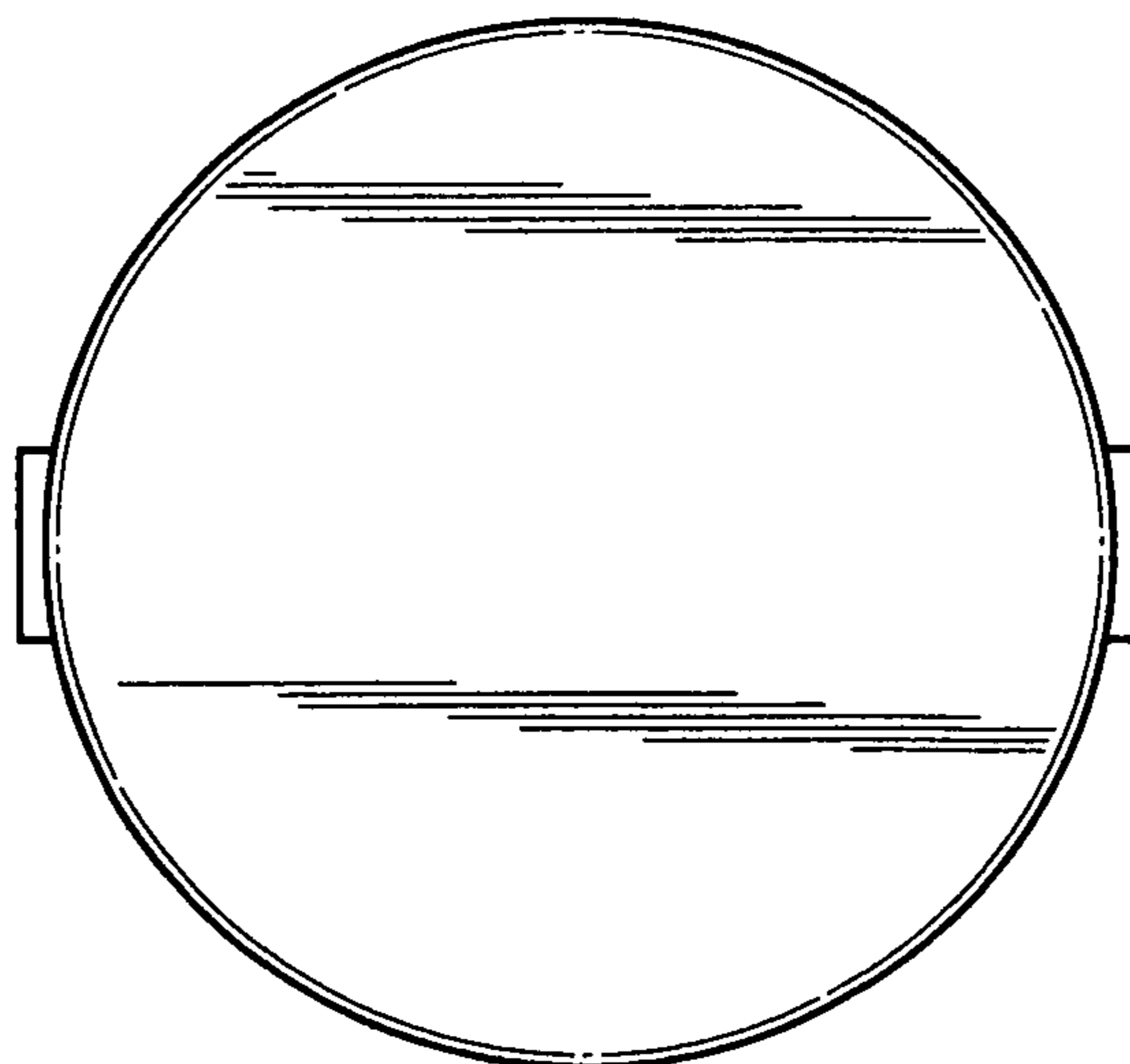

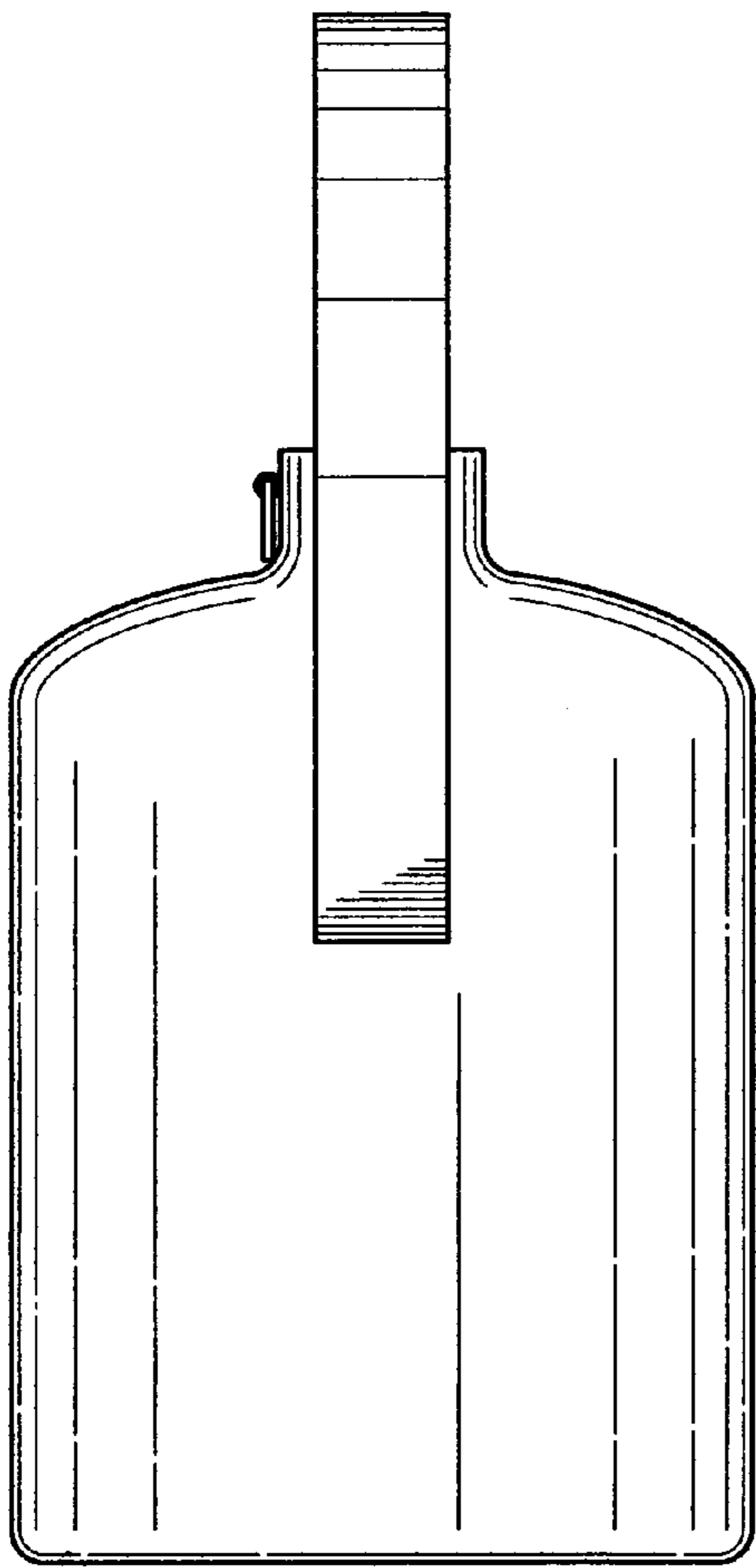

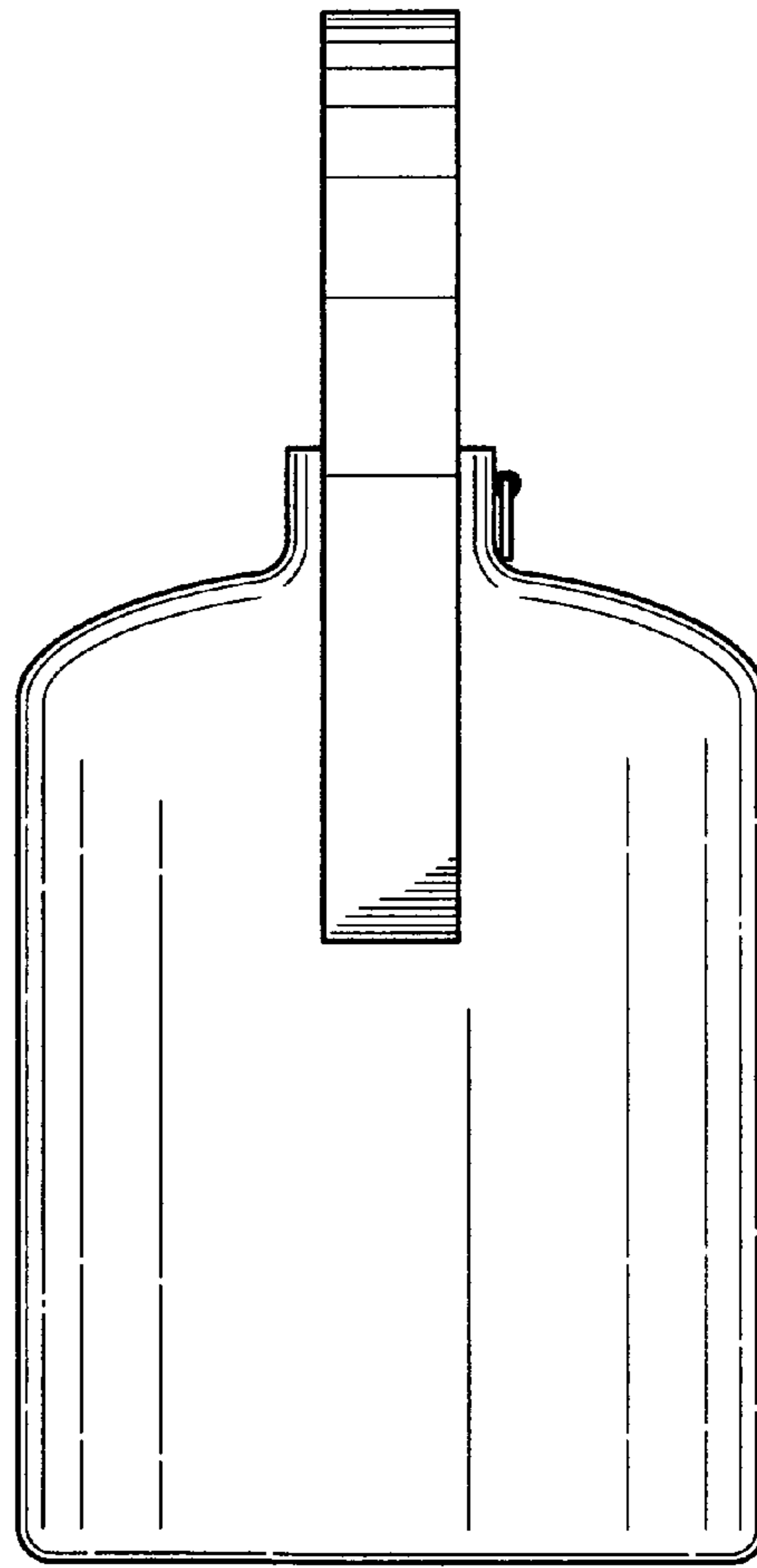
