**DESCRIPTION**

FIG. 1 is a front view of a first embodiment of a container showing our new design;

FIG. 2 is a top view thereof;

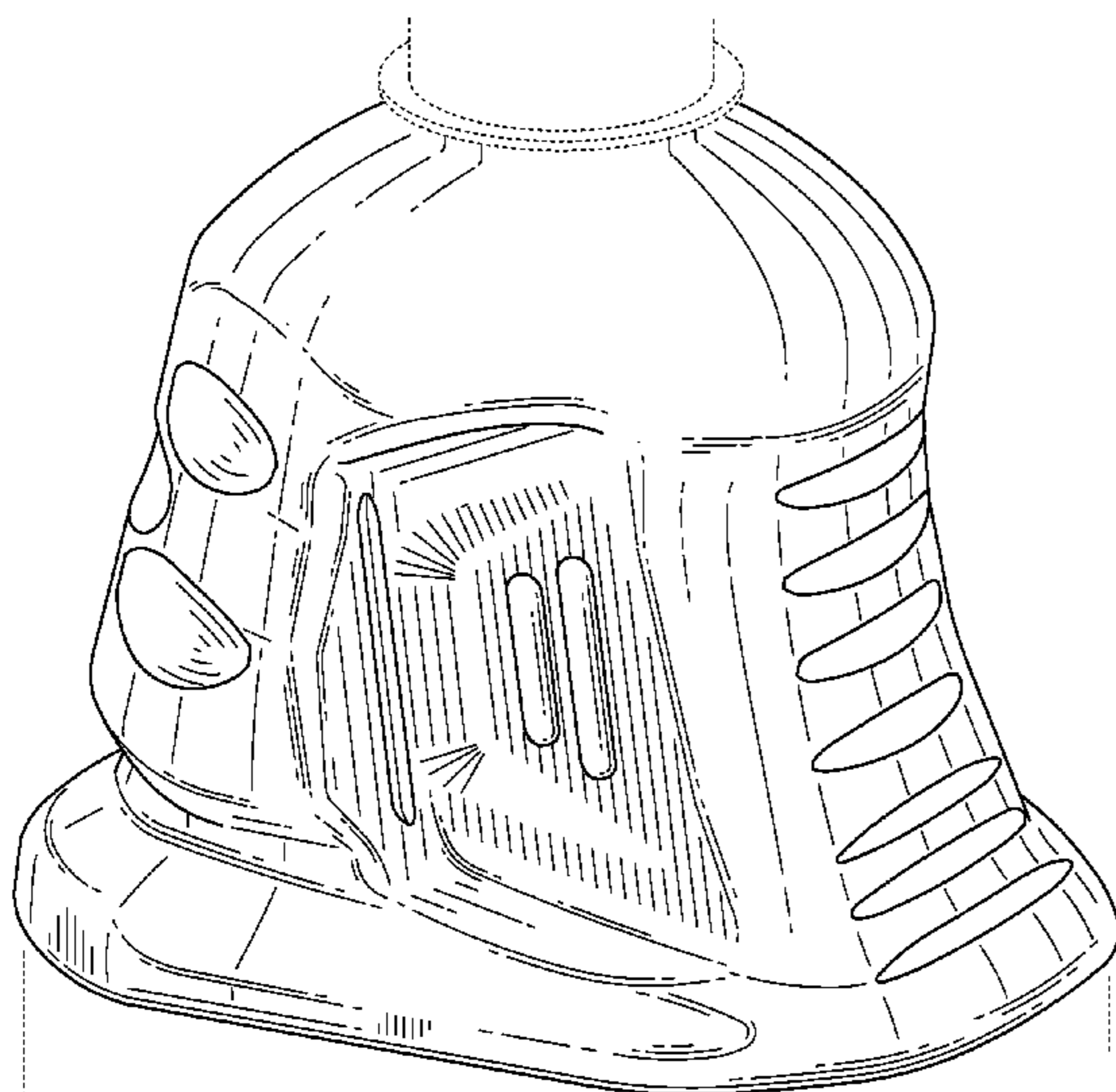

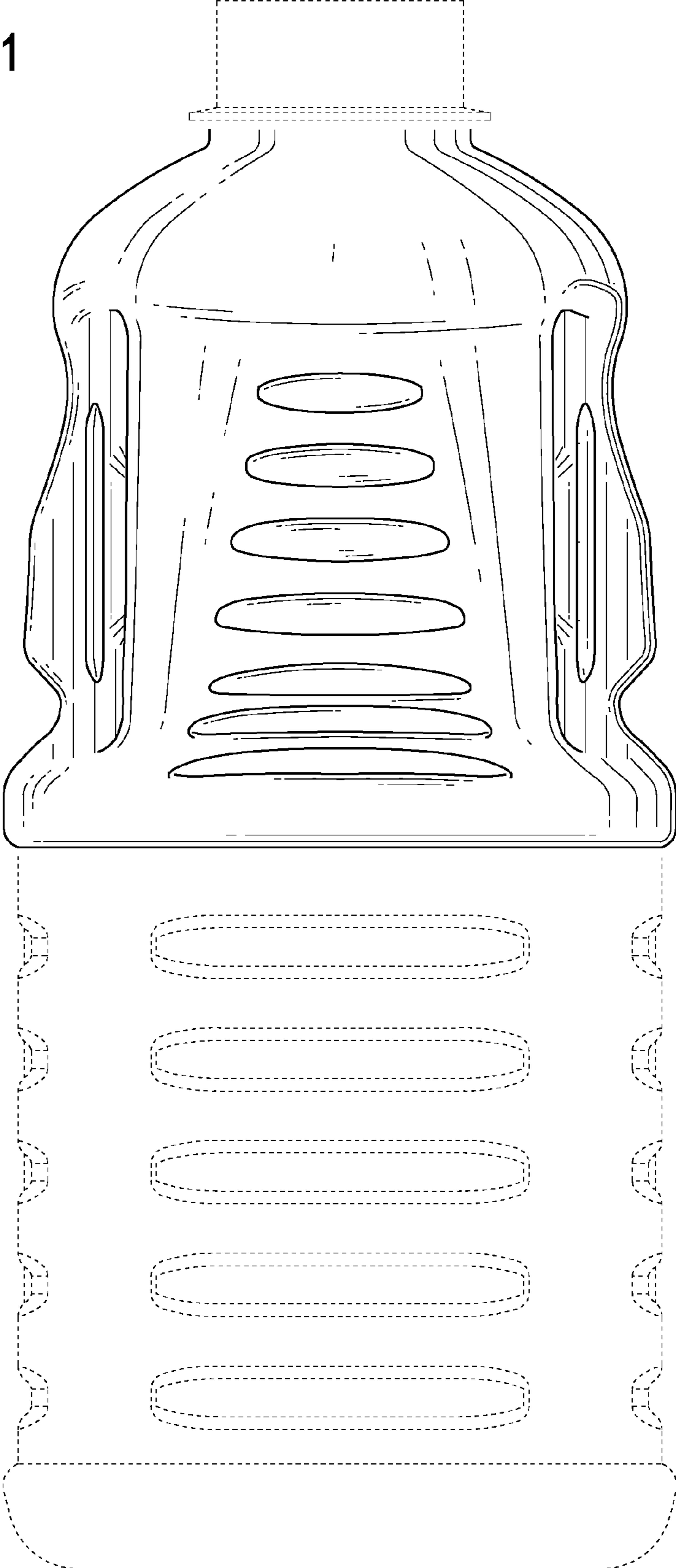

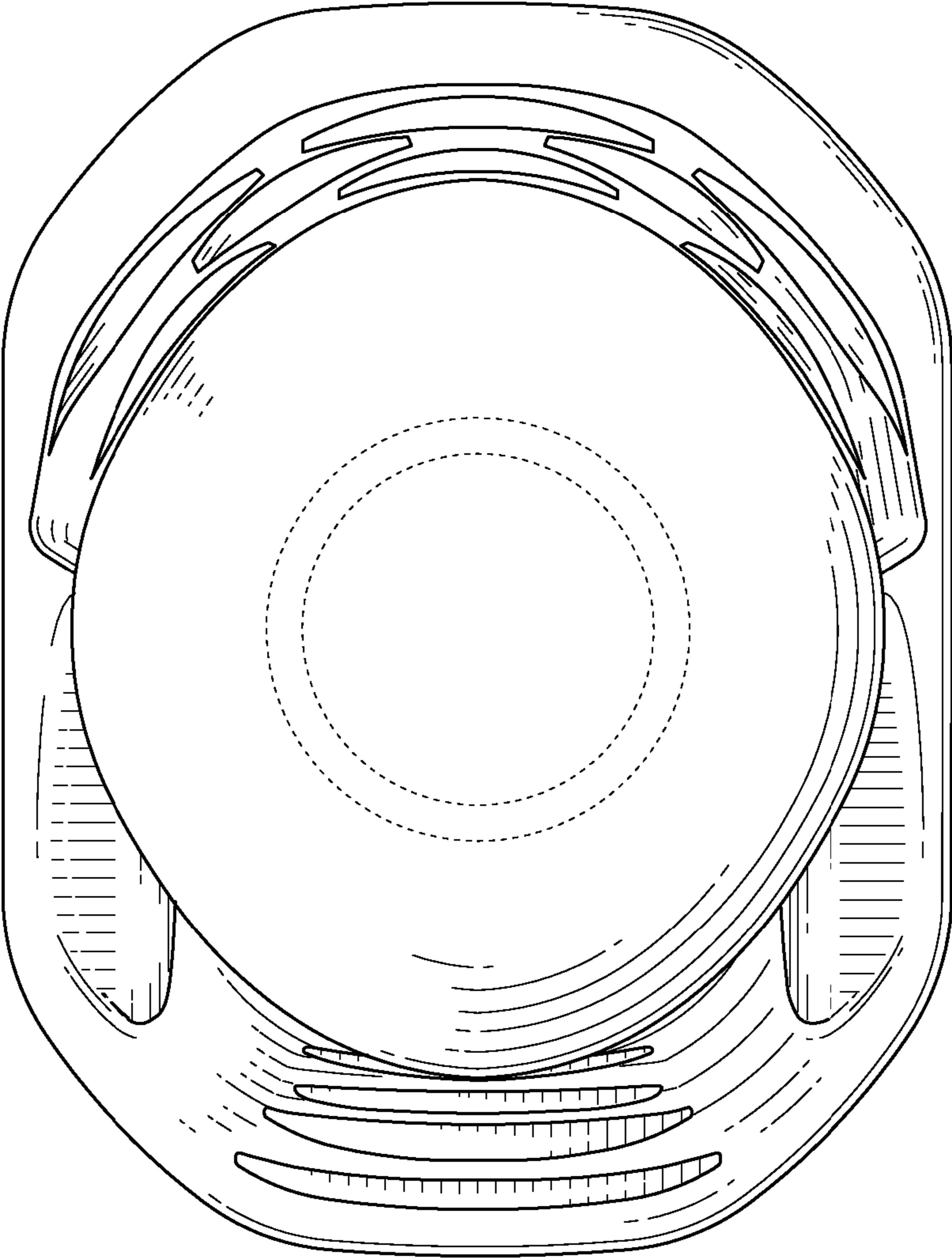

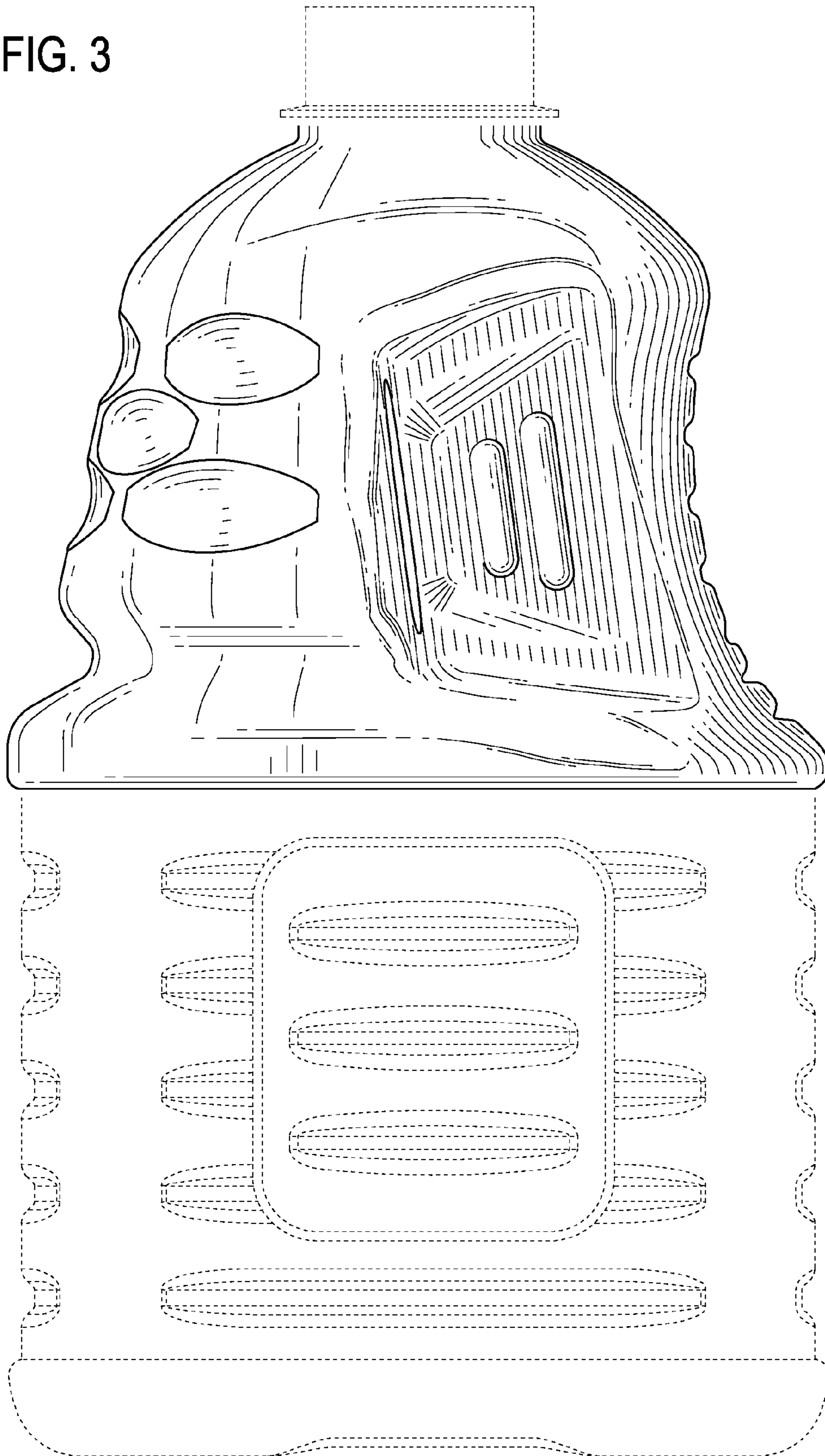

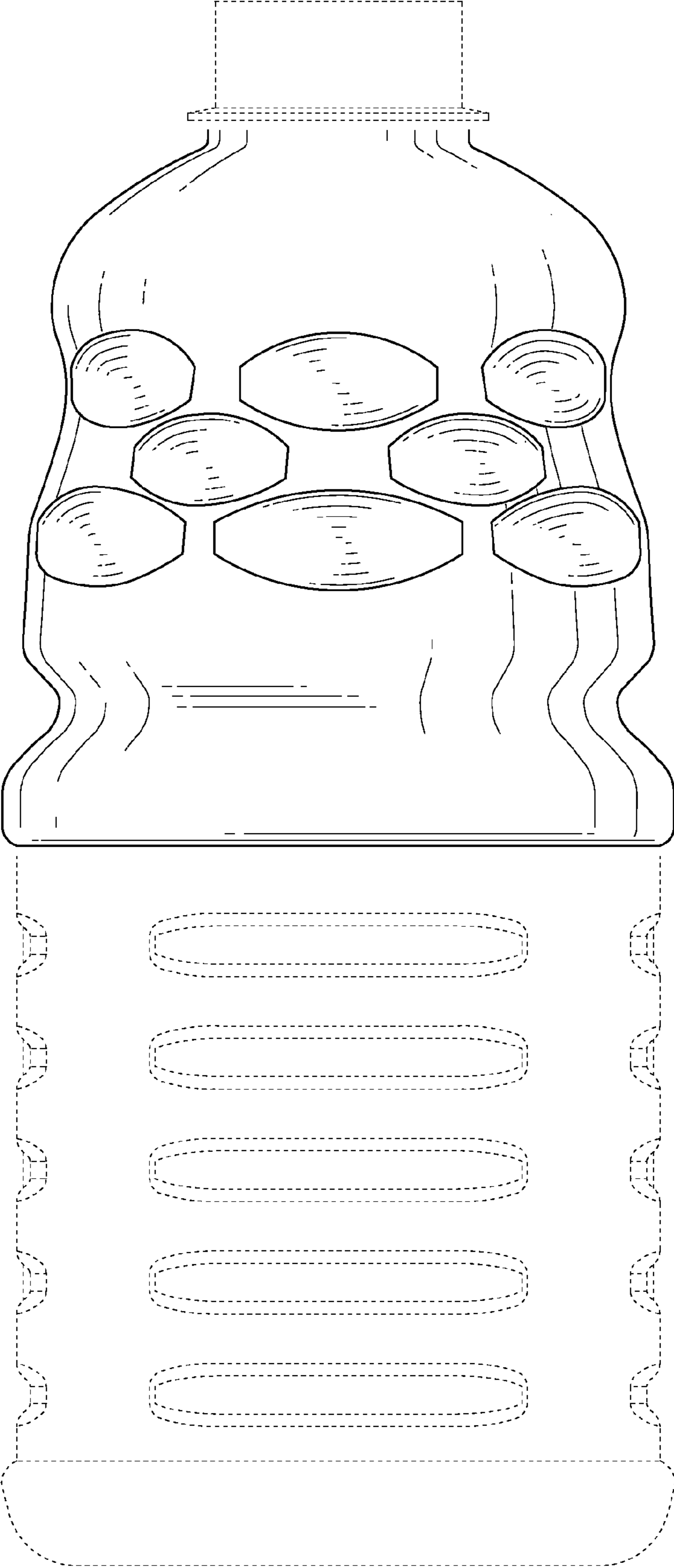

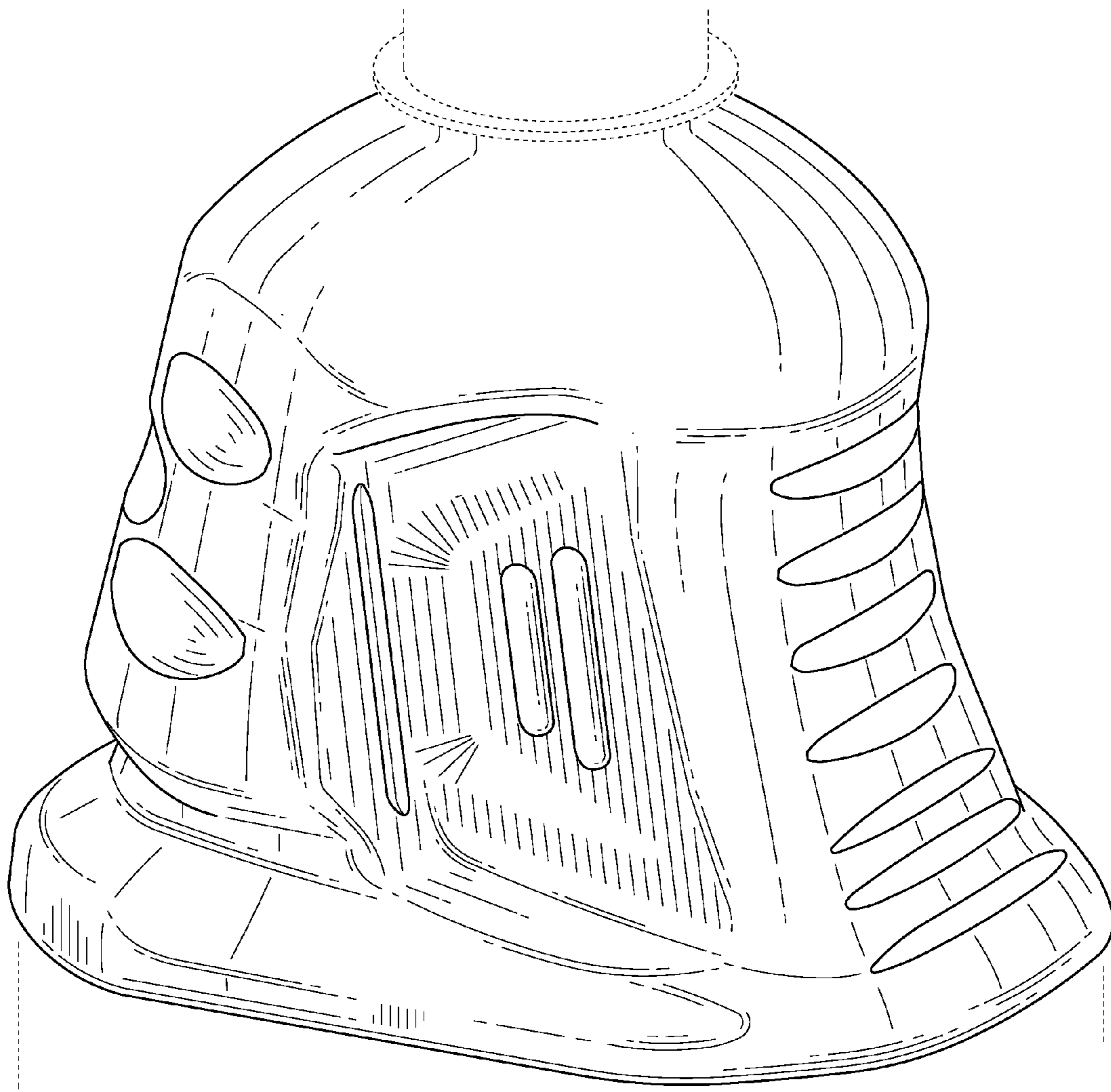

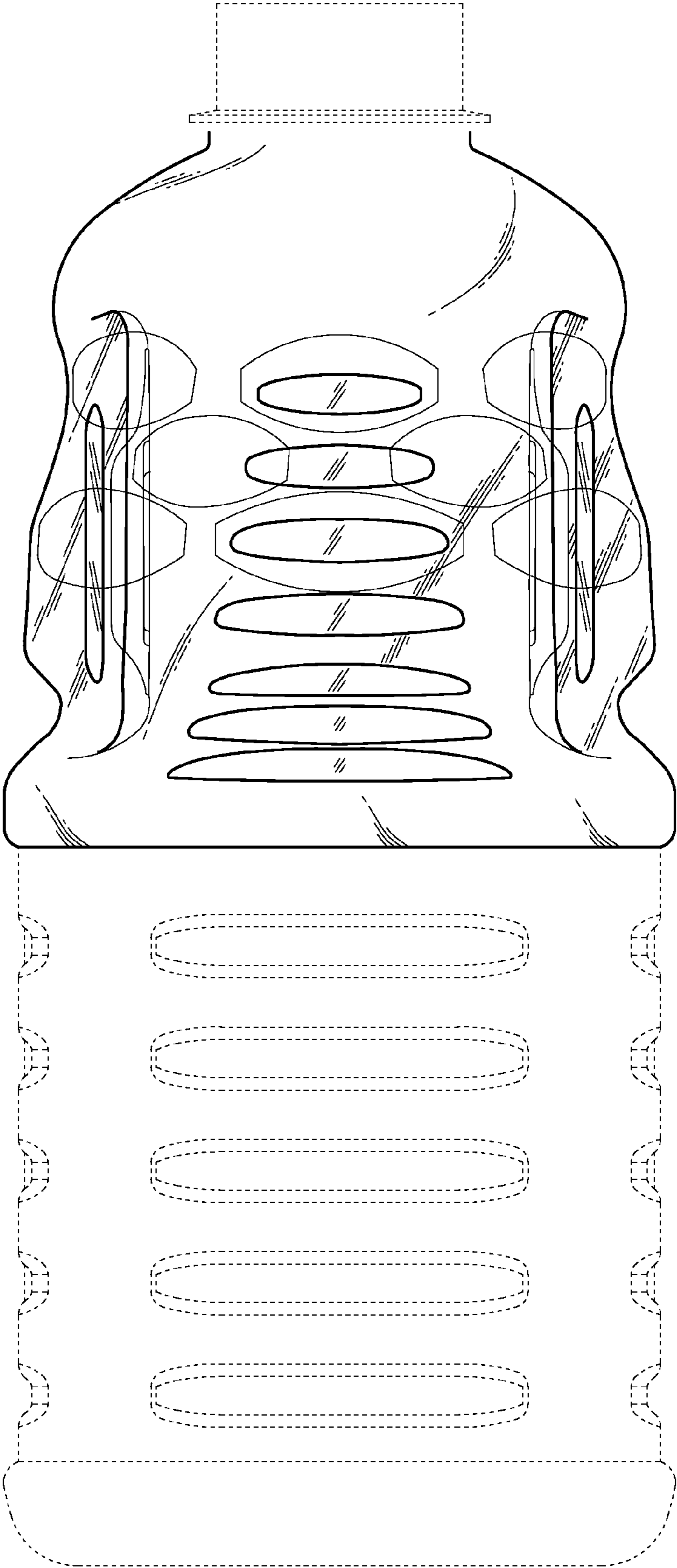

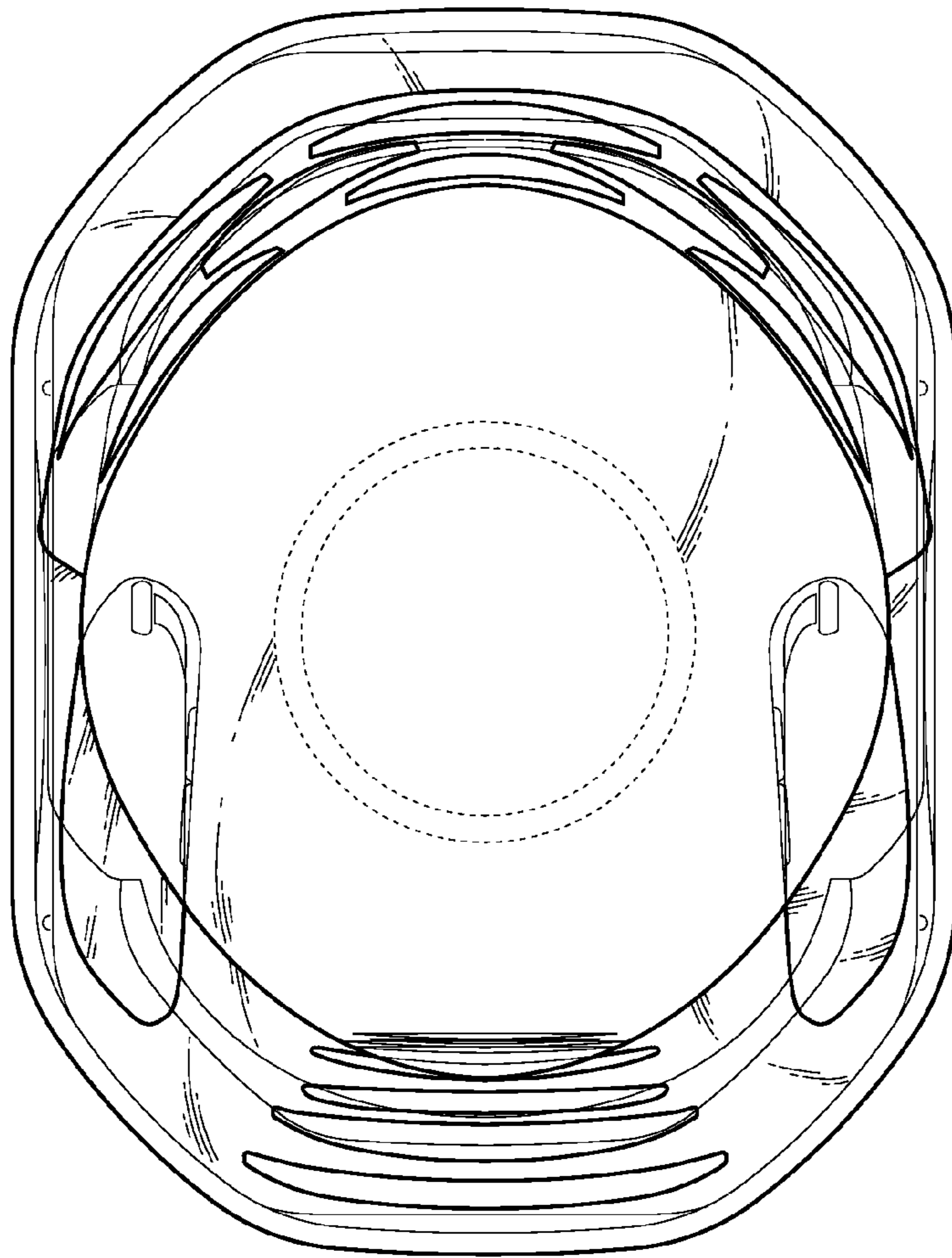

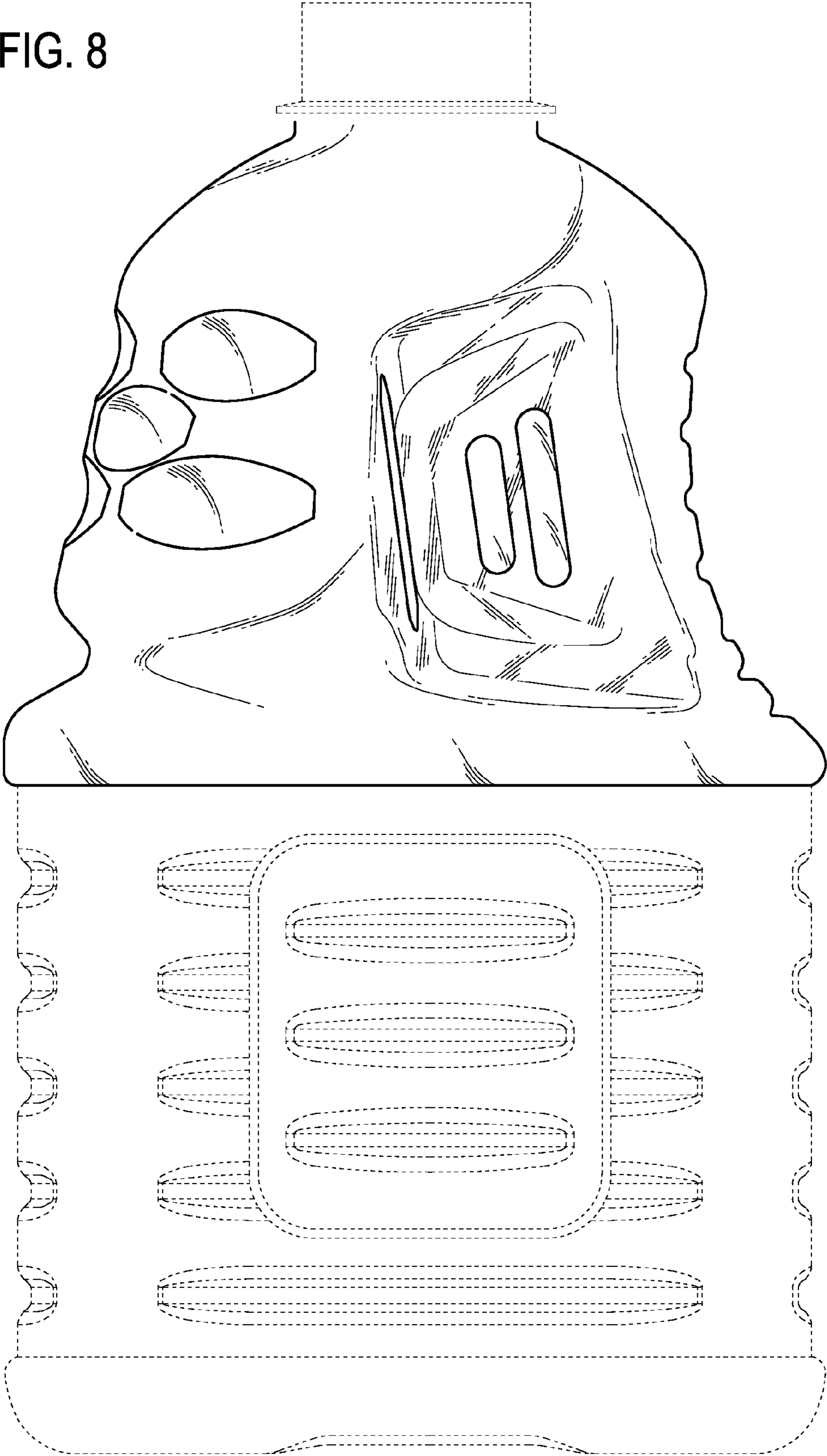

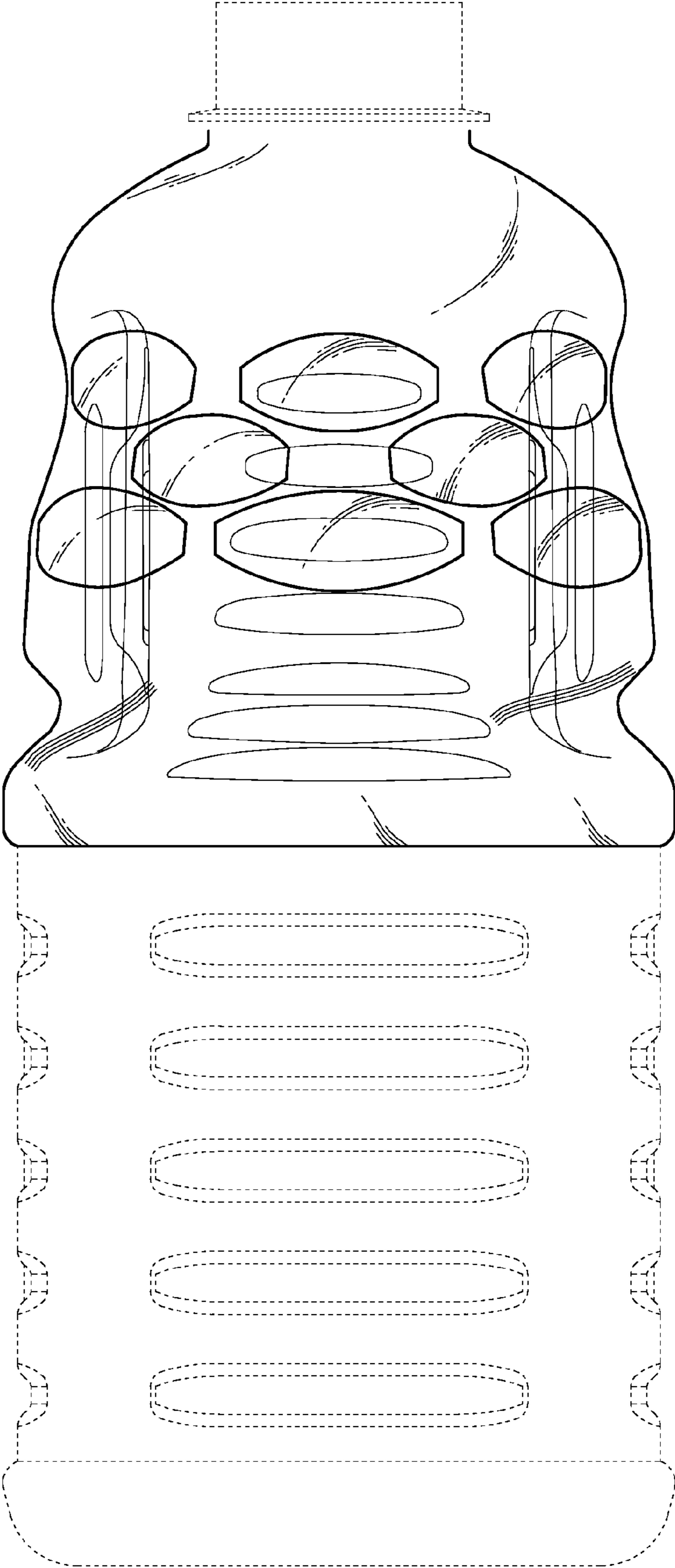
