FIG. 8 is a front view thereof, the rear view being identical thereto;

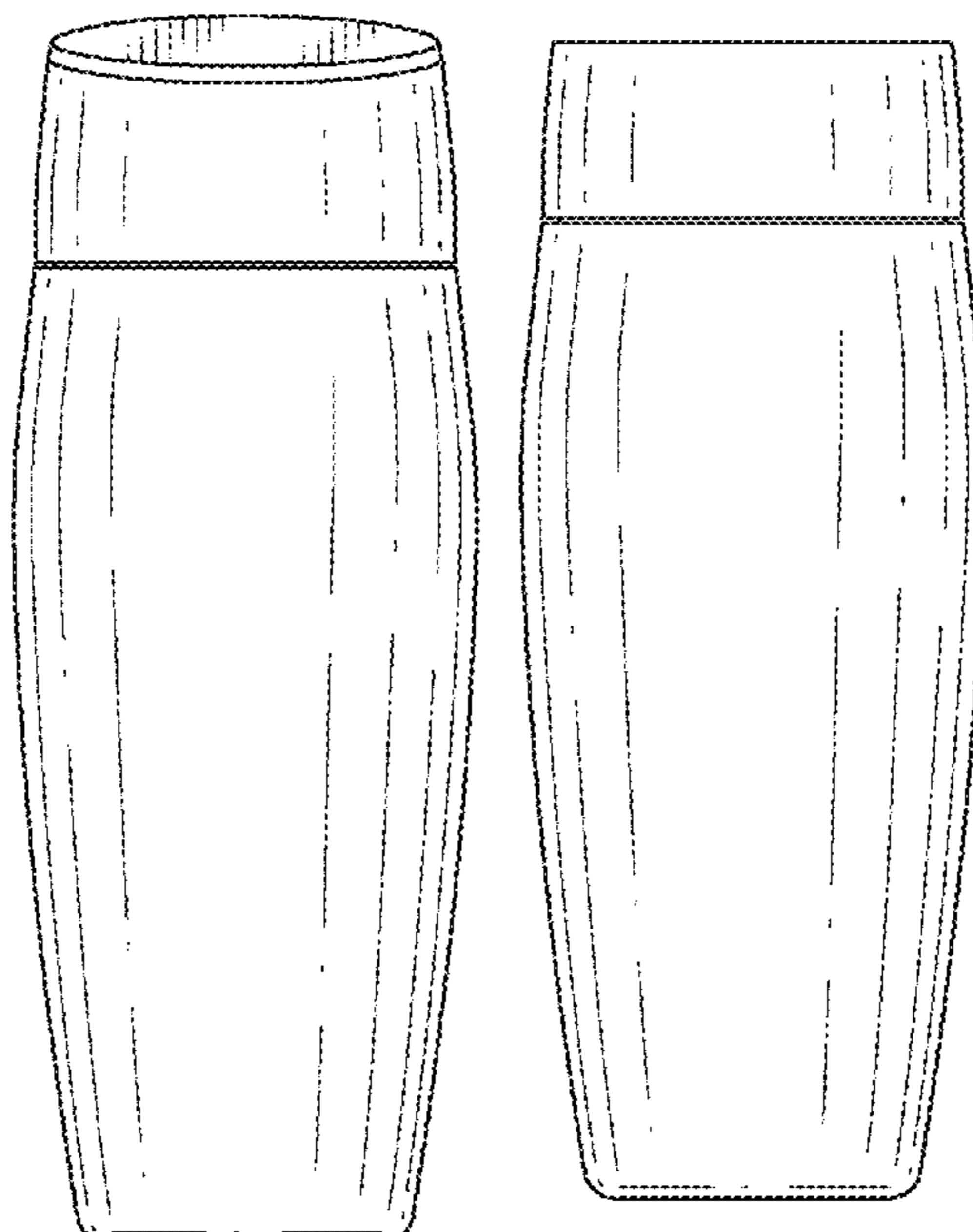
FIG. 9 is a side view thereof, the opposite side view being identical thereto;

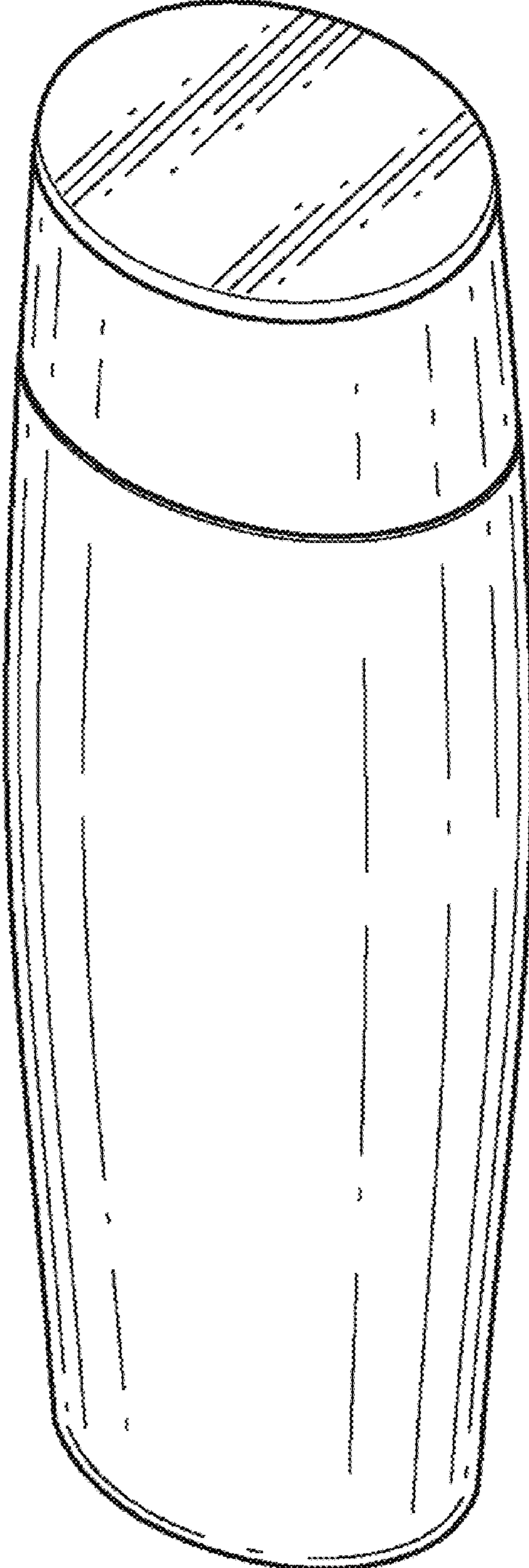

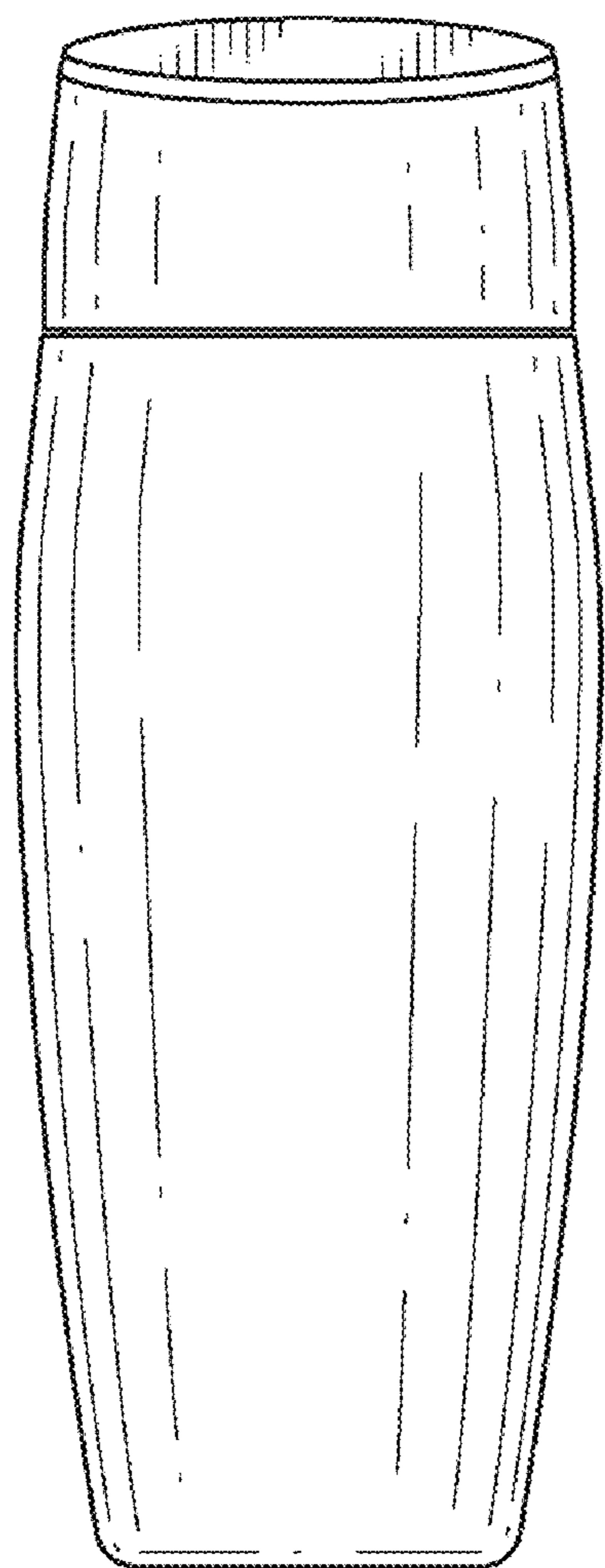

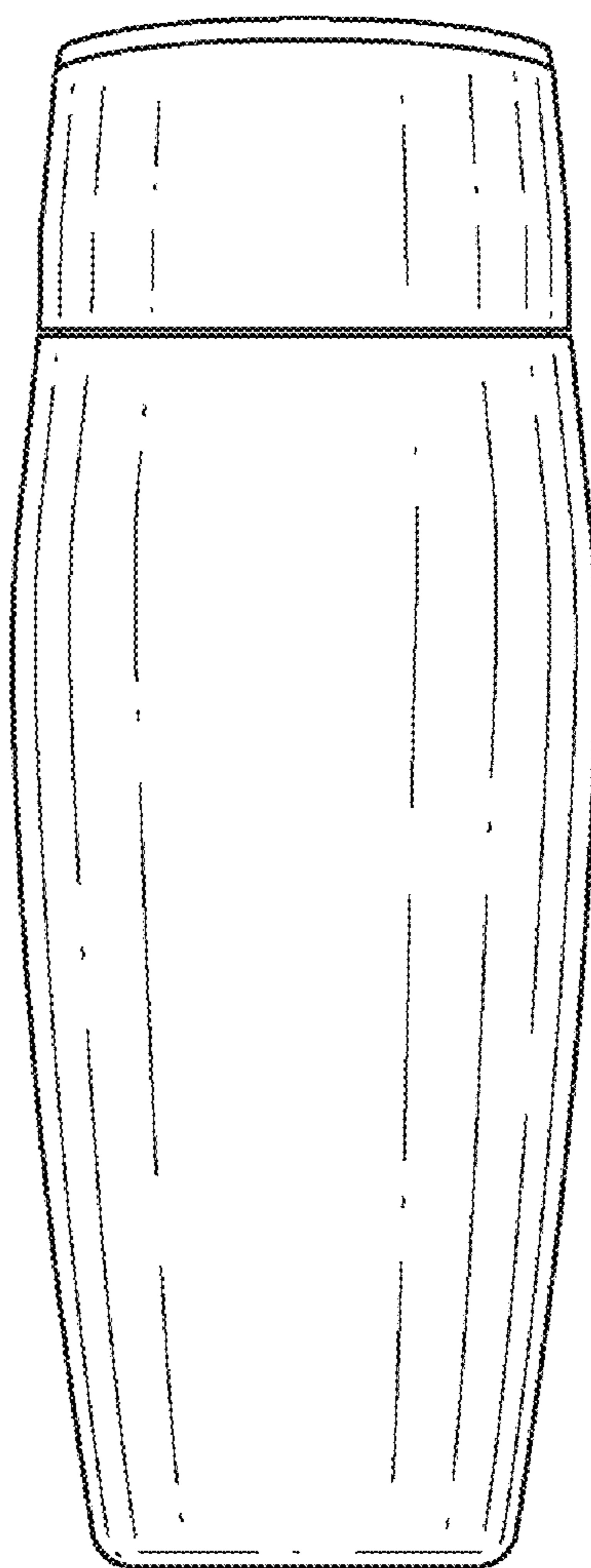

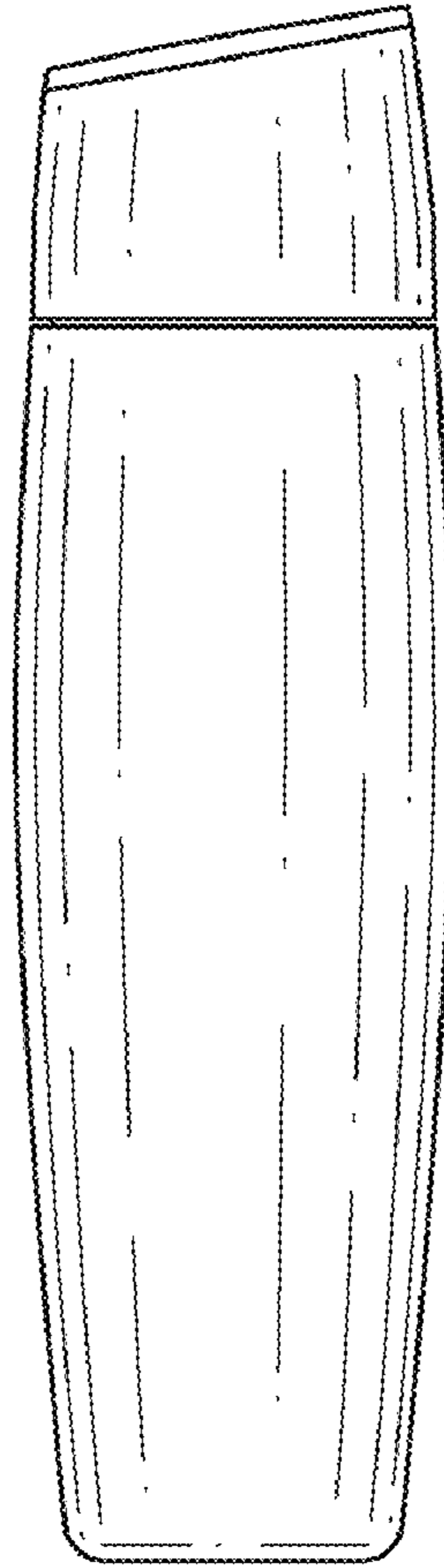

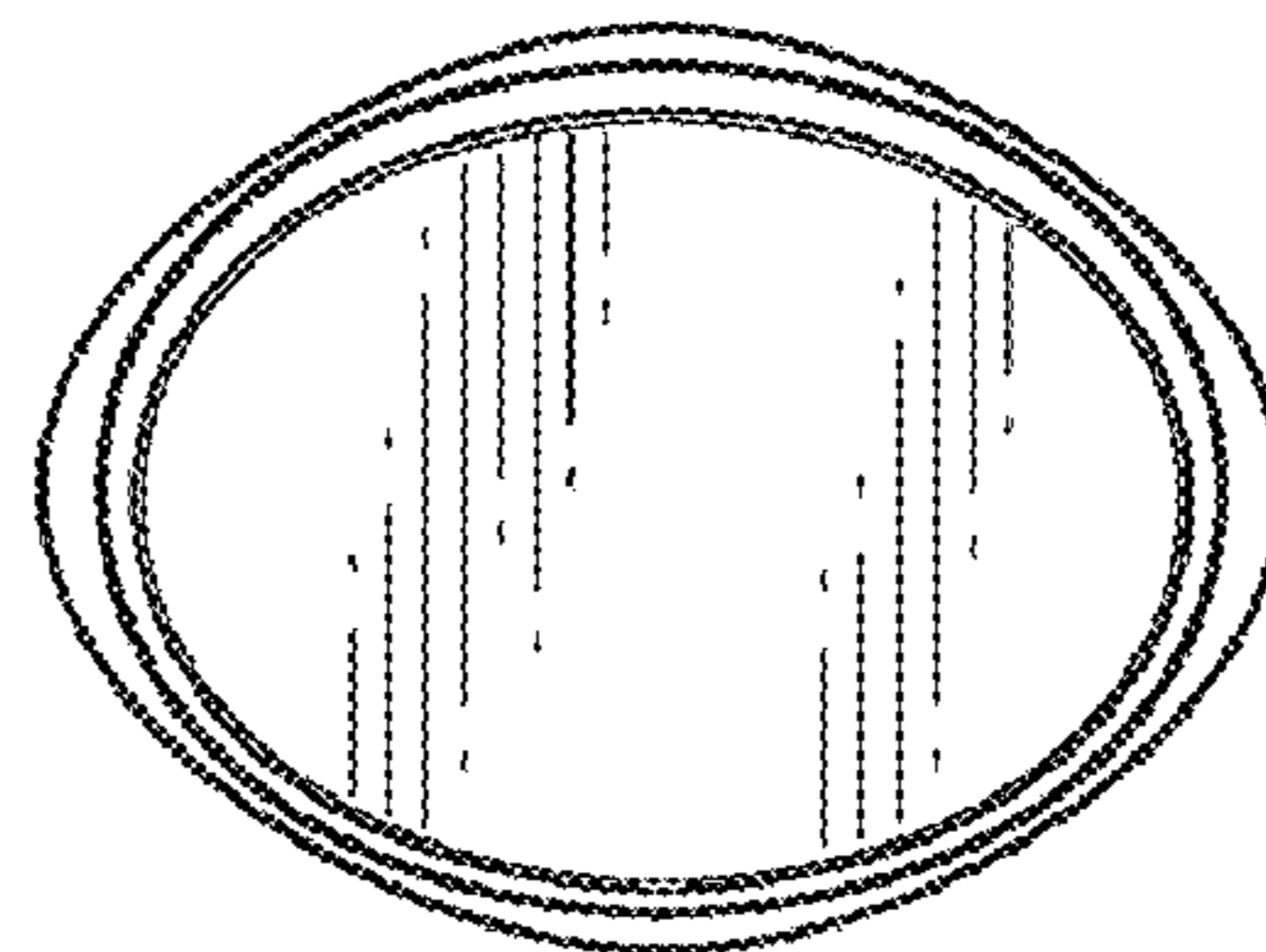

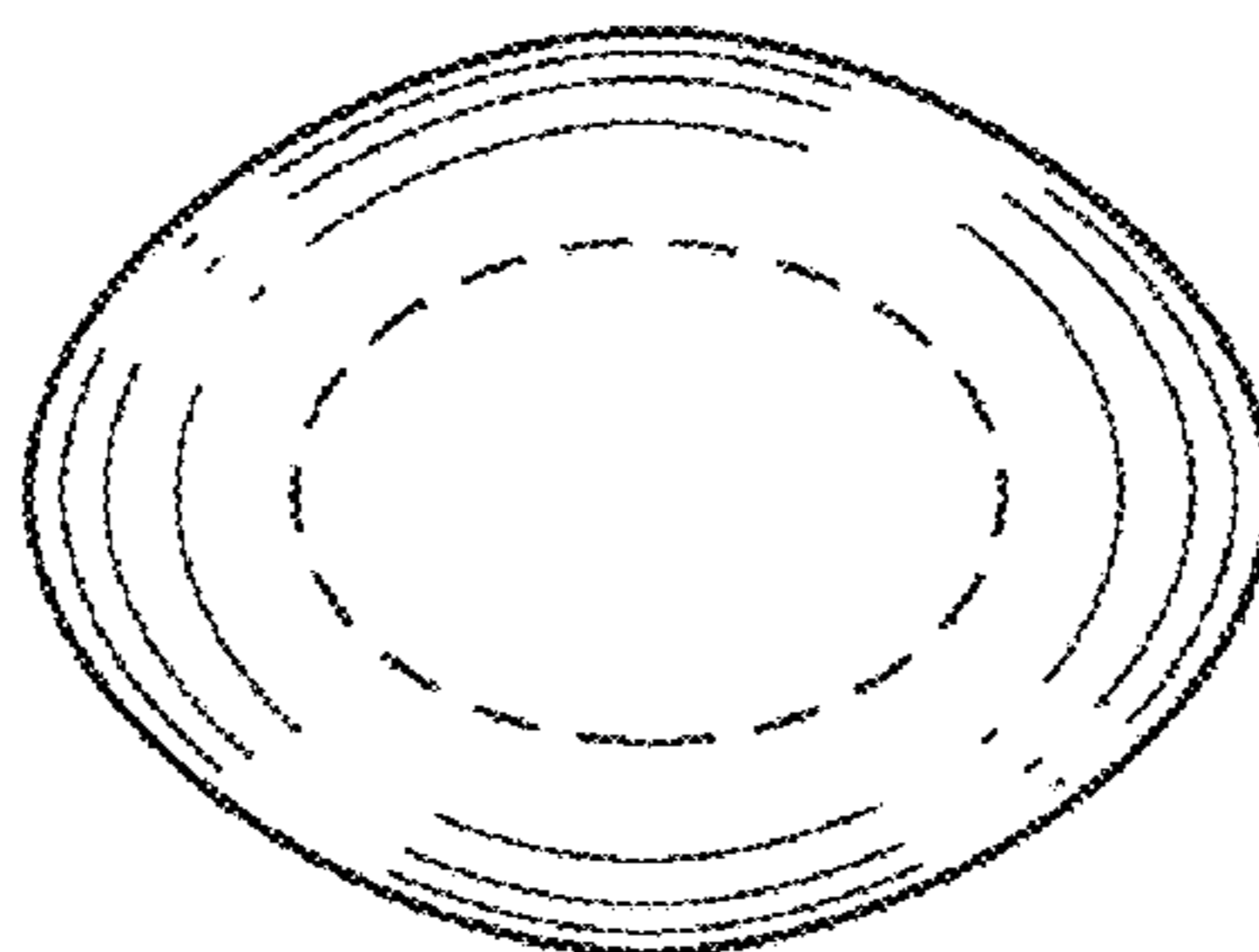

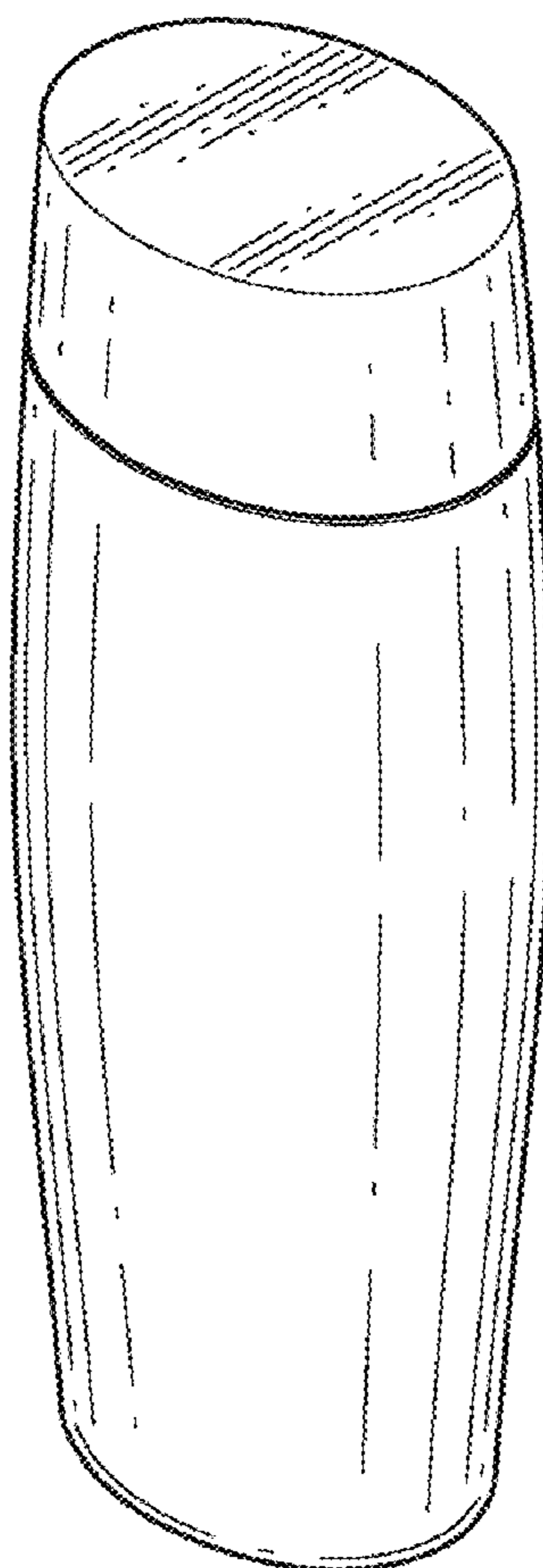

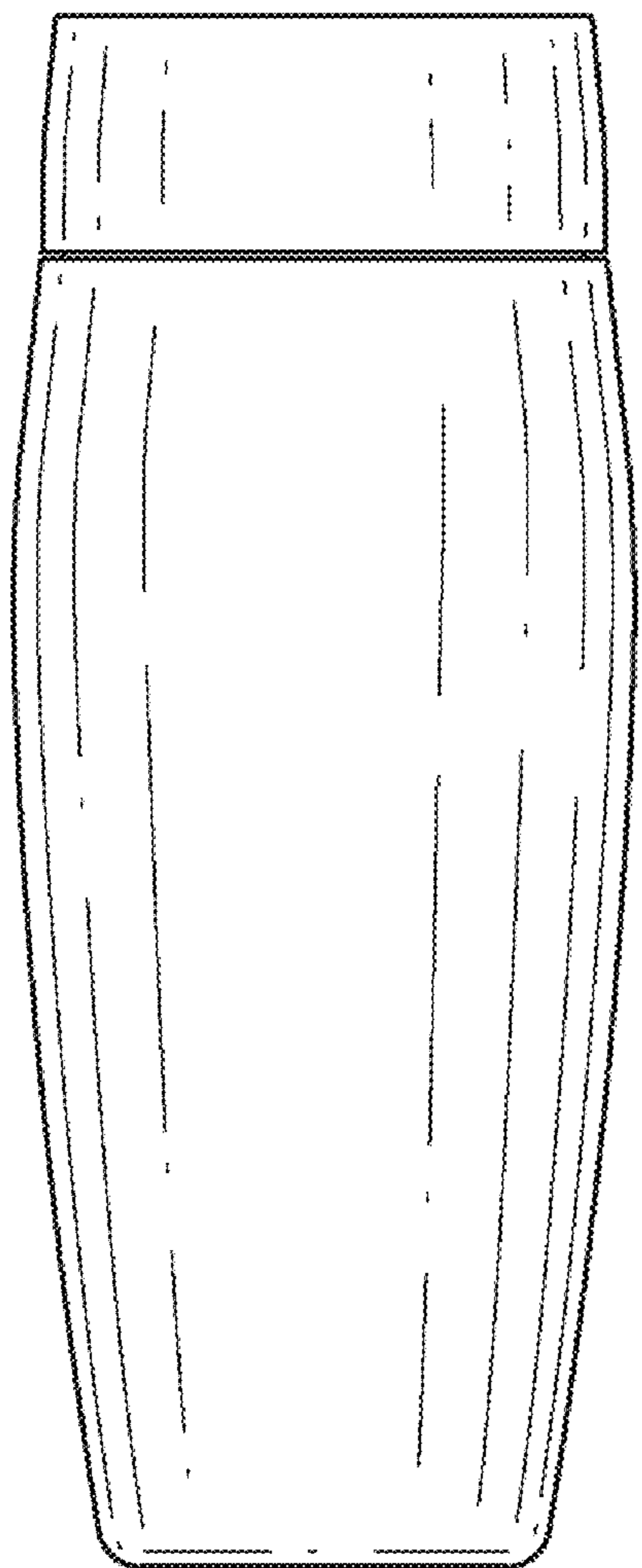

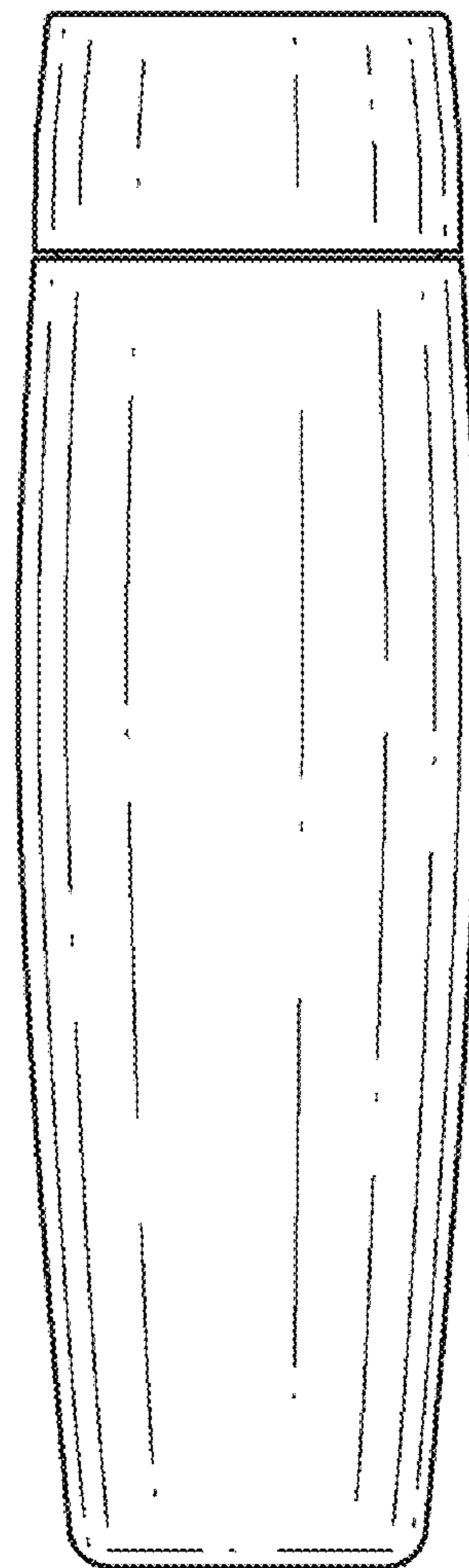

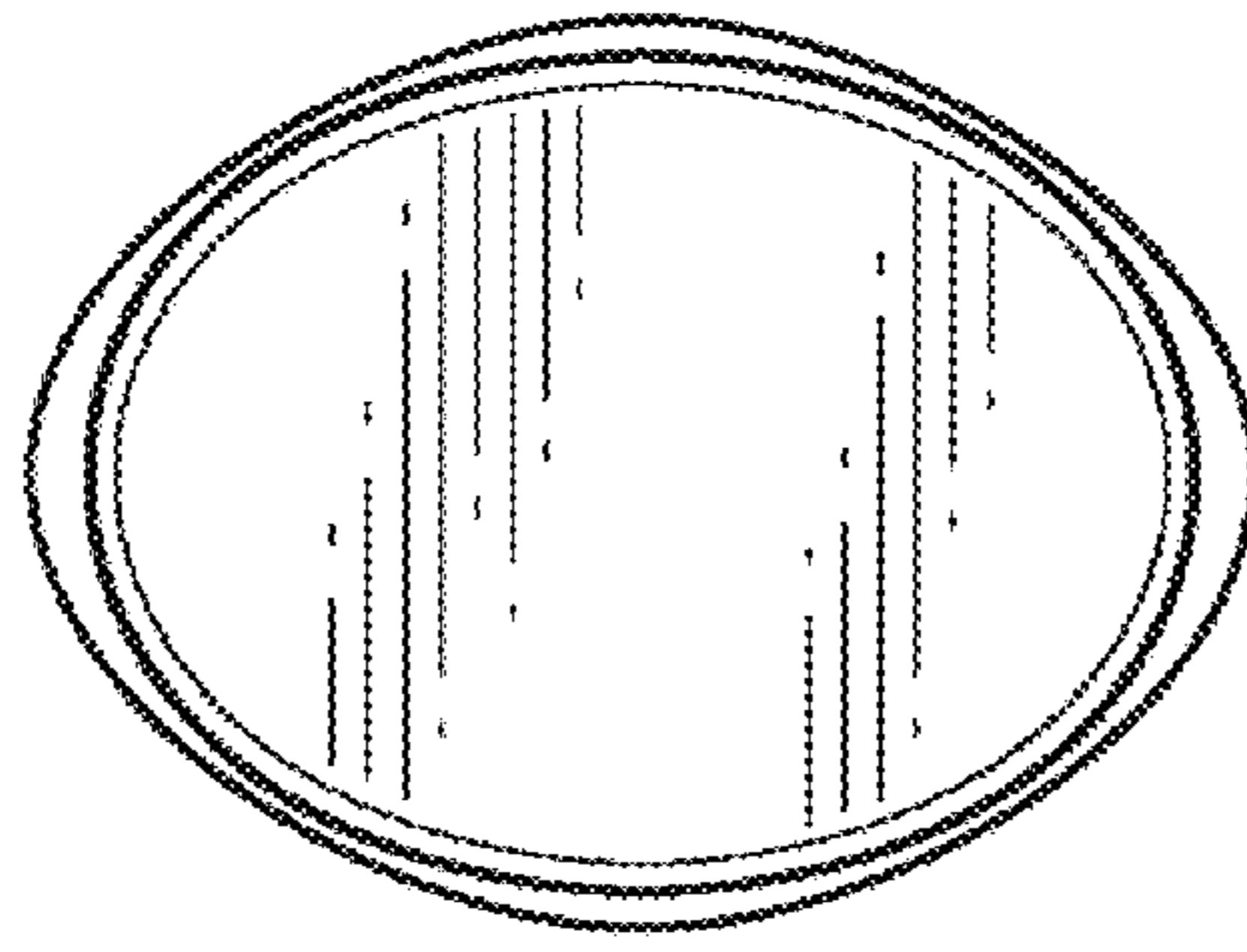

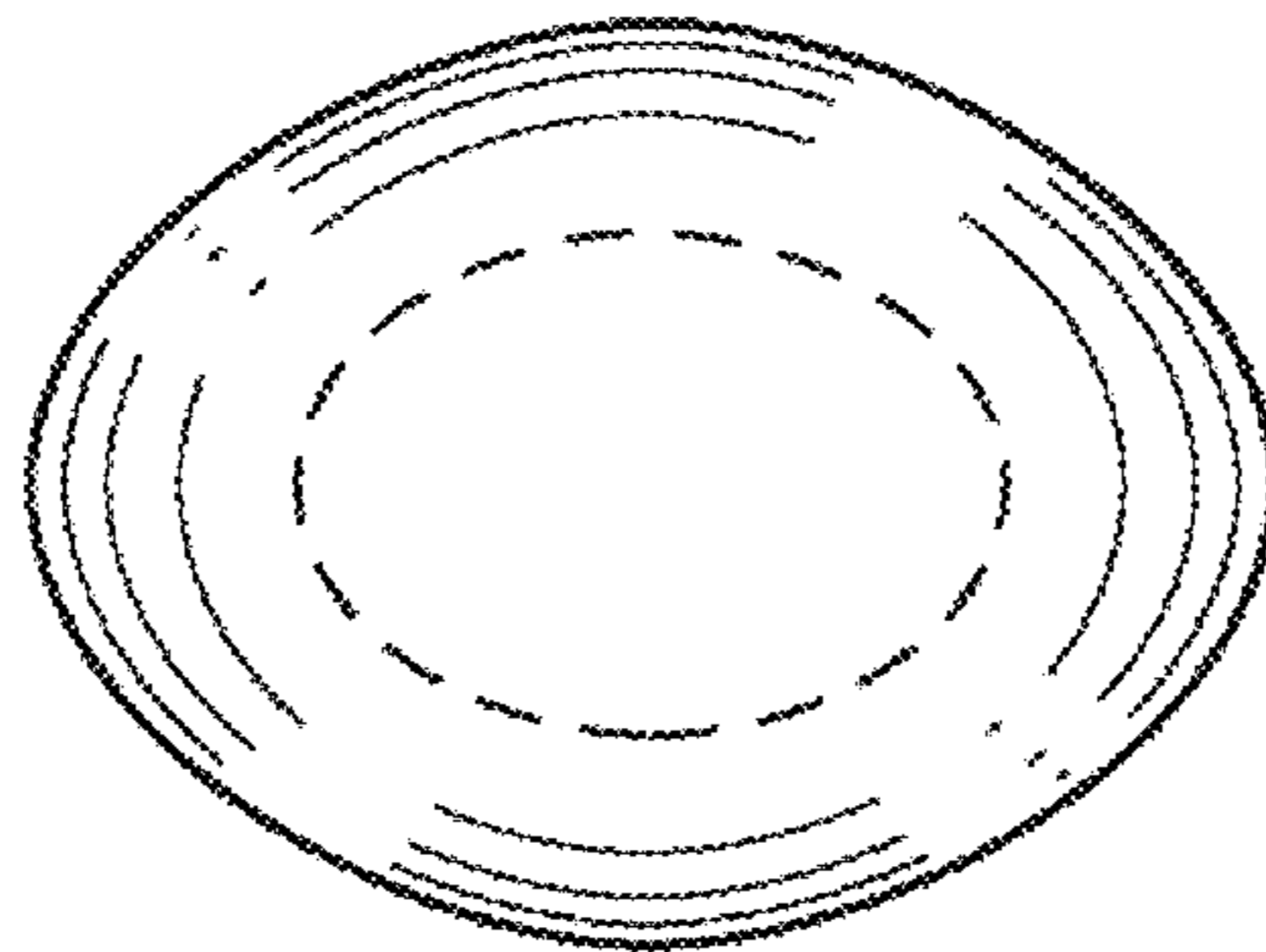
