(57) **CLAIM**

The ornamental design for a cosmetic applicator with cap, substantially as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left side perspective view of a first embodiment of my new design for a cosmetic applicator with cap;

FIG. 2 is a front elevational view of the cosmetic applicator with cap shown in FIG. 1, the rear elevational view being identical thereto;

FIG. 3 is a top plan view of the cosmetic applicator with cap shown in FIG. 1;

FIG. 4 is a side elevational view of the cosmetic applicator with cap shown in FIG. 1, the opposite side elevational view being identical thereto;

FIG. 5 is a bottom plan view of the cosmetic applicator with cap shown in FIG. 1;

FIG. 6 is an exploded perspective view of the cosmetic applicator of FIG. 1, having the cap separated therefrom;

FIG. 7 is a top, front, left side perspective view of a second embodiment of my new design for a cosmetic applicator with cap;

FIG. 8 is a front elevational view of the cosmetic applicator with cap shown in FIG. 7, the rear elevational view being identical thereto;

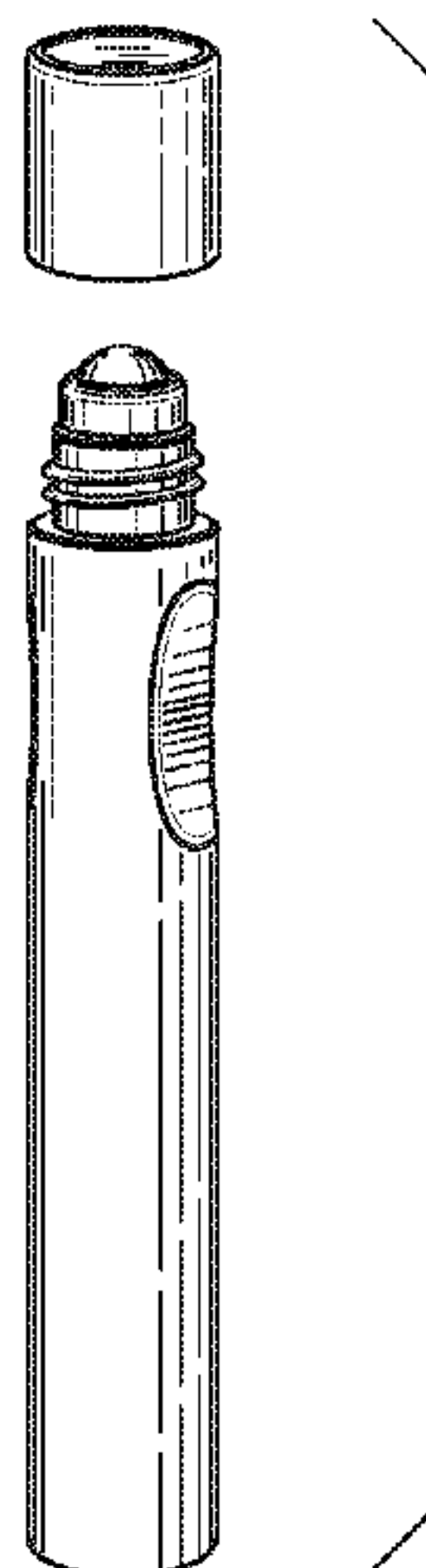
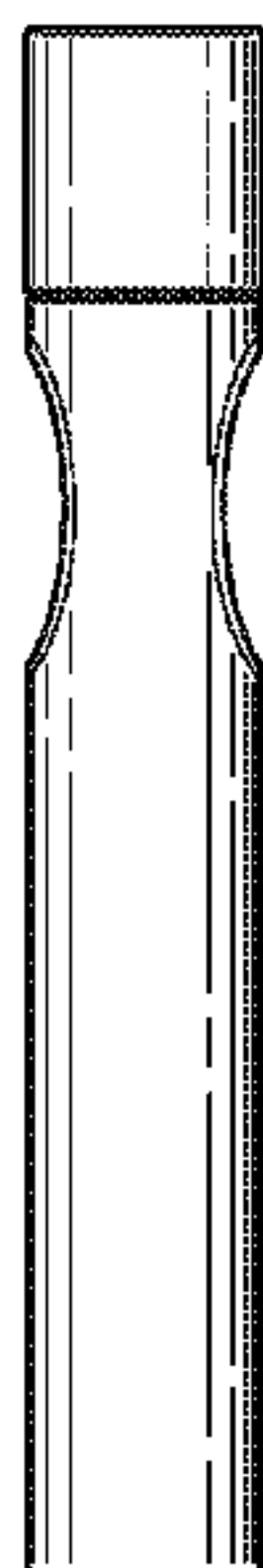
FIG. 9 is a top plan view of the cosmetic applicator with cap shown in FIG. 7;

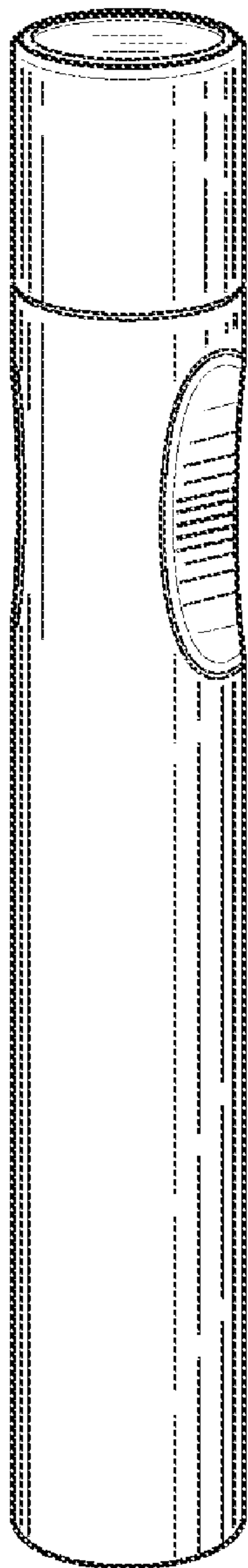

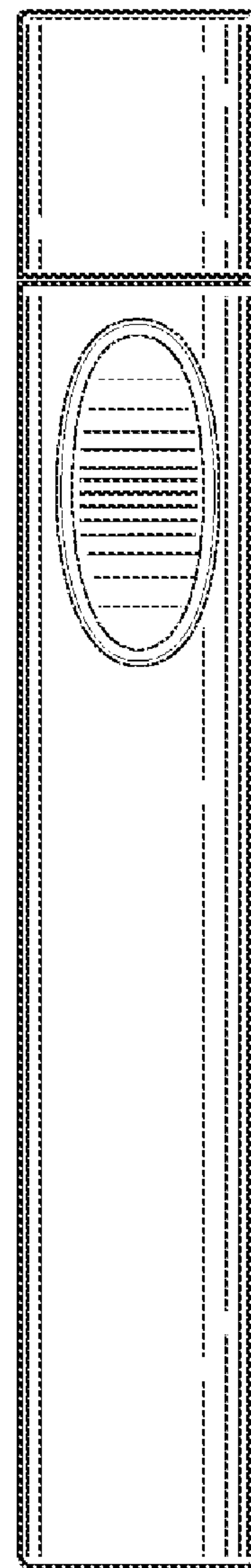

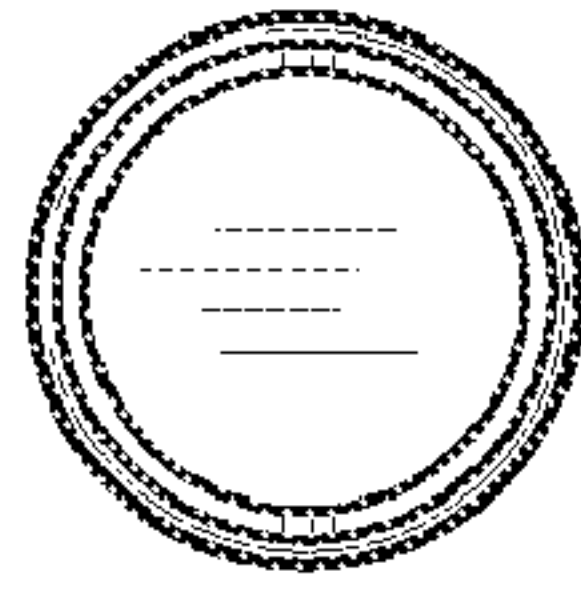

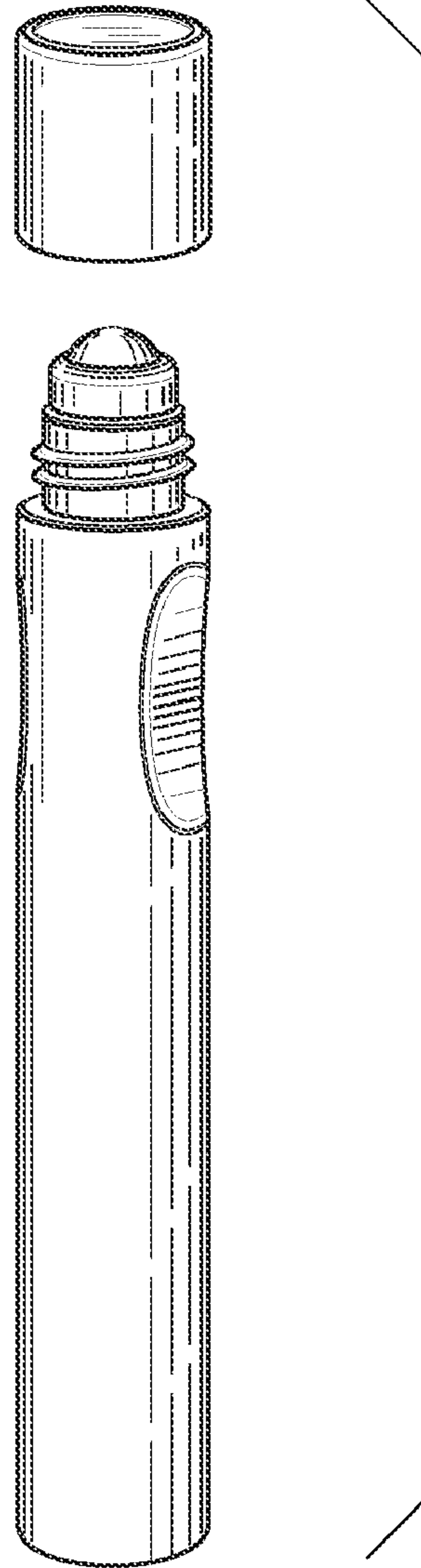

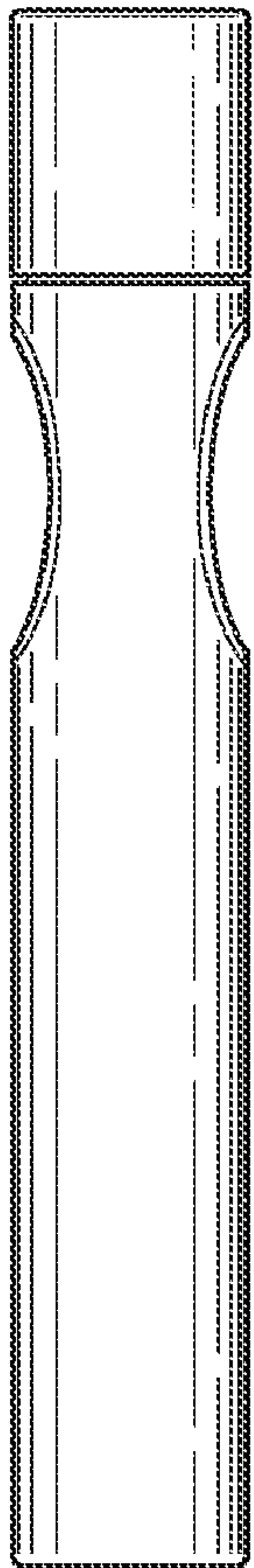

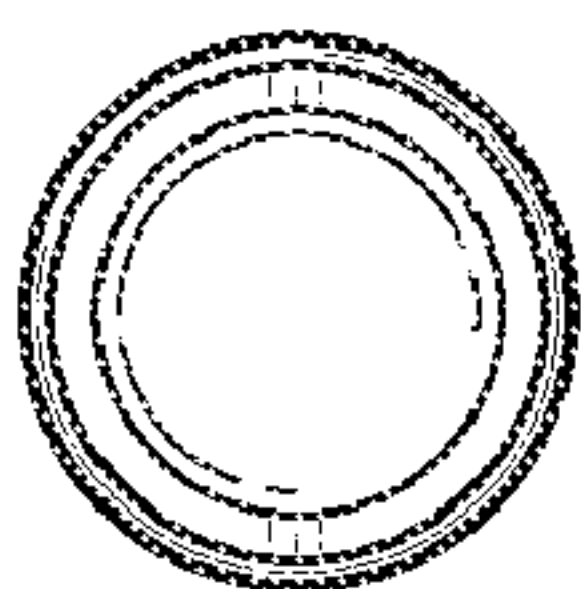

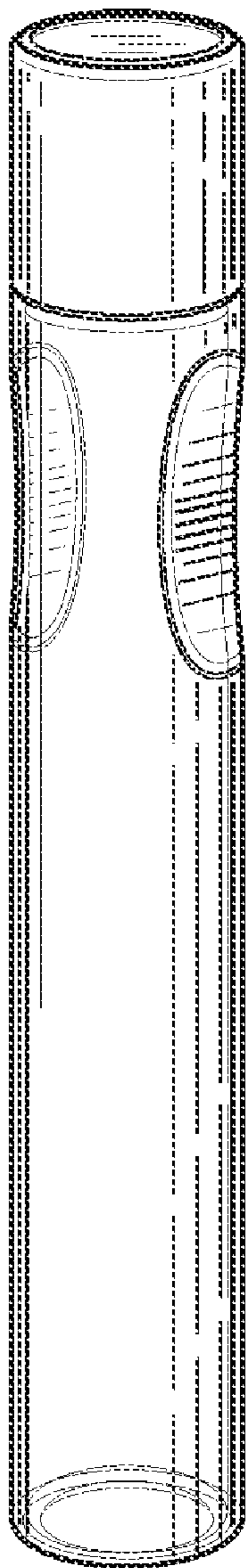

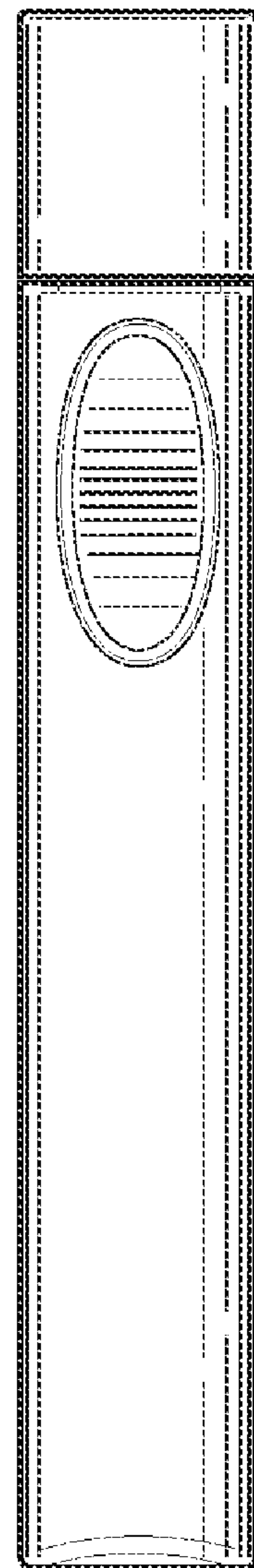

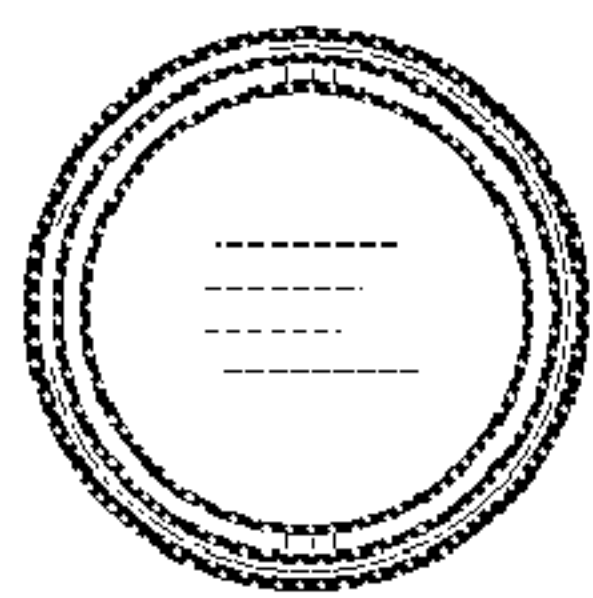

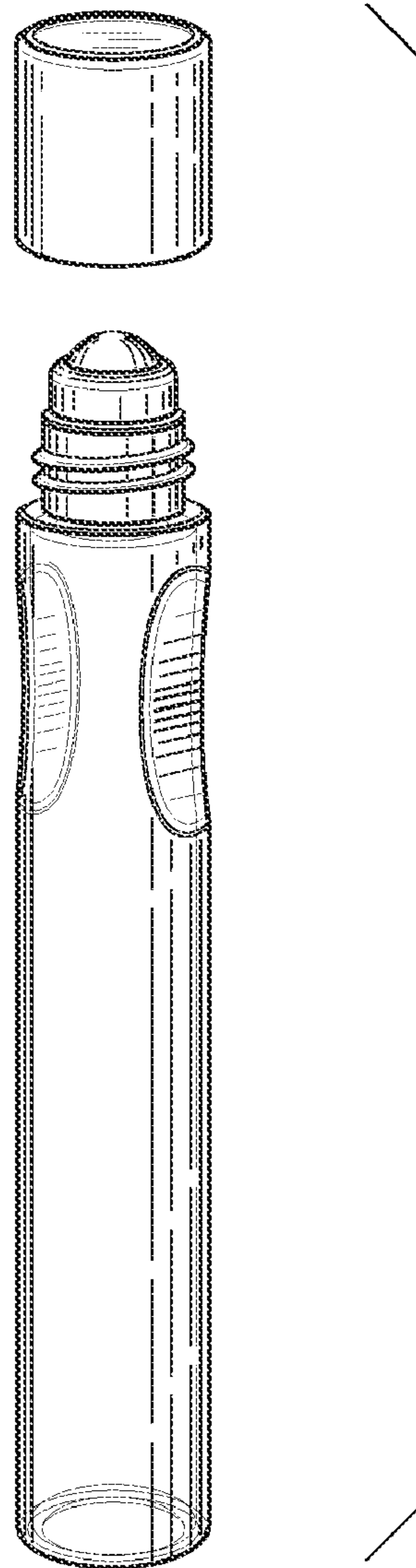

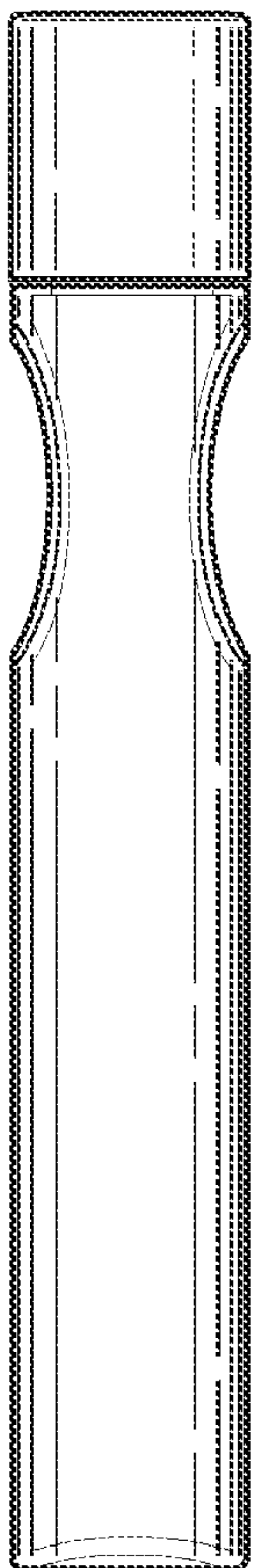
