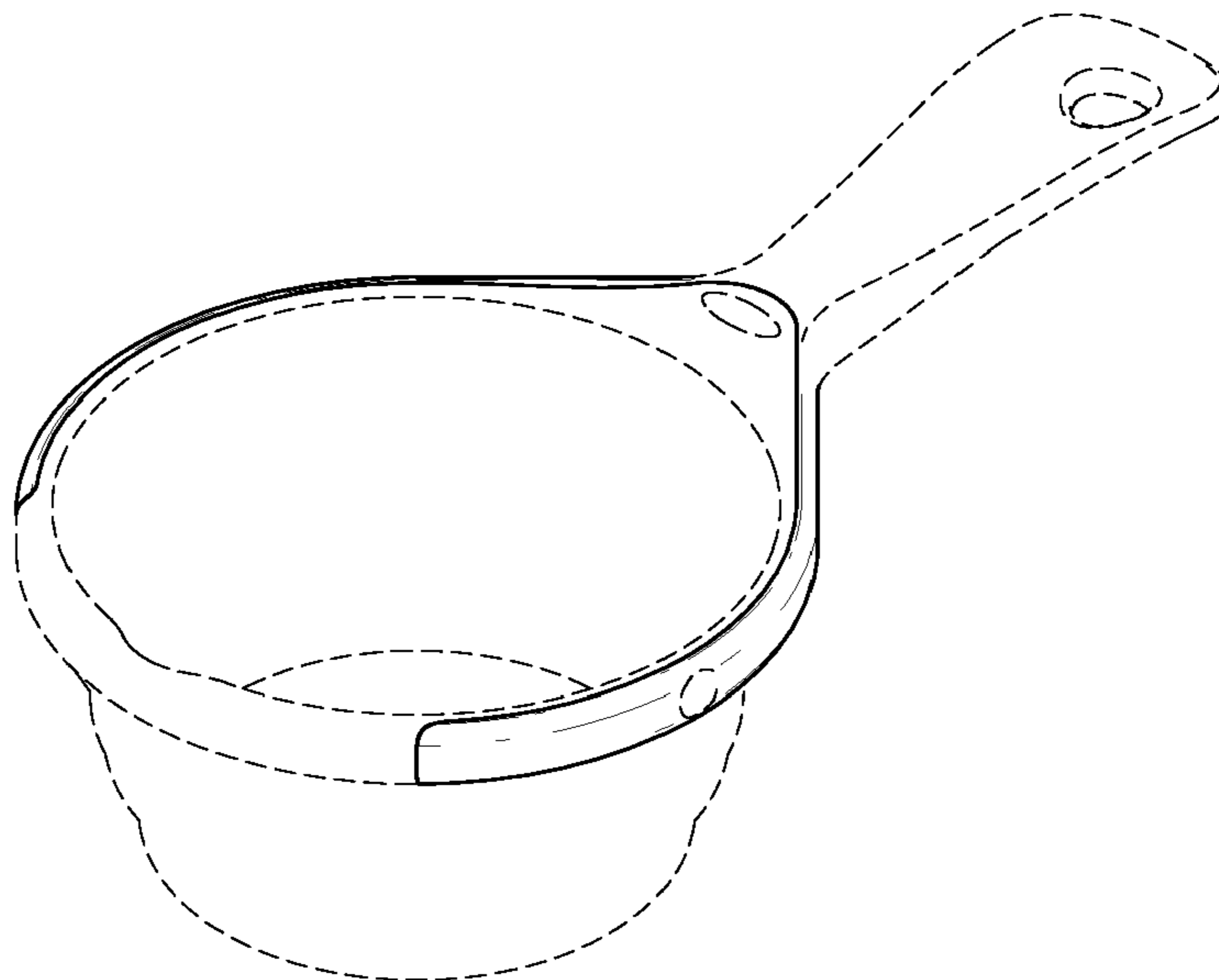
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a cup with deformable pour spout showing our new design.
FIG. 2 is a bottom plan view thereof.
FIG. 3 is a front elevation view thereof.
FIG. 4 is a rear elevation view thereof.
FIG. 5 is a top plan view thereof.
FIG. 6 is a right side elevation view thereof; and,

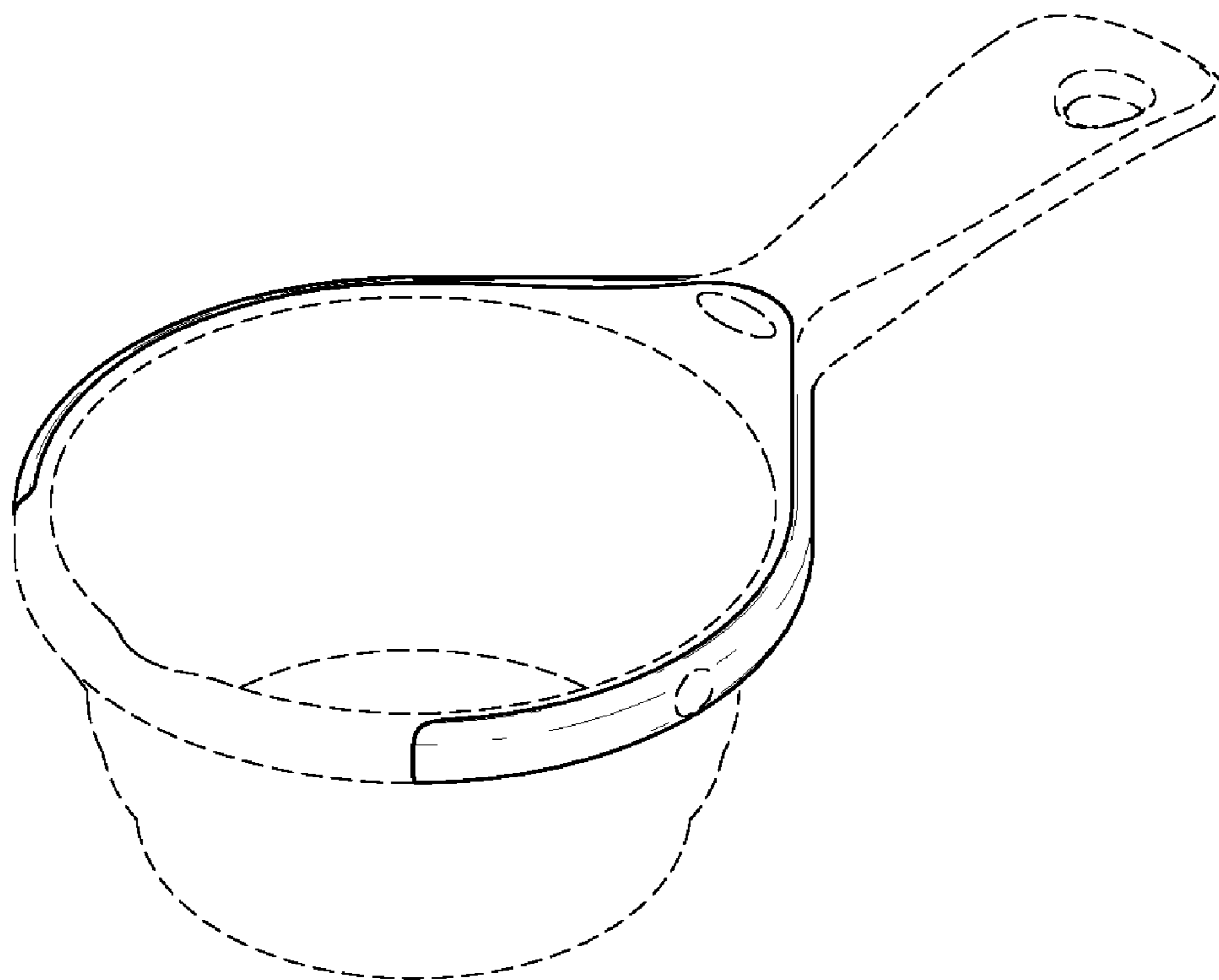

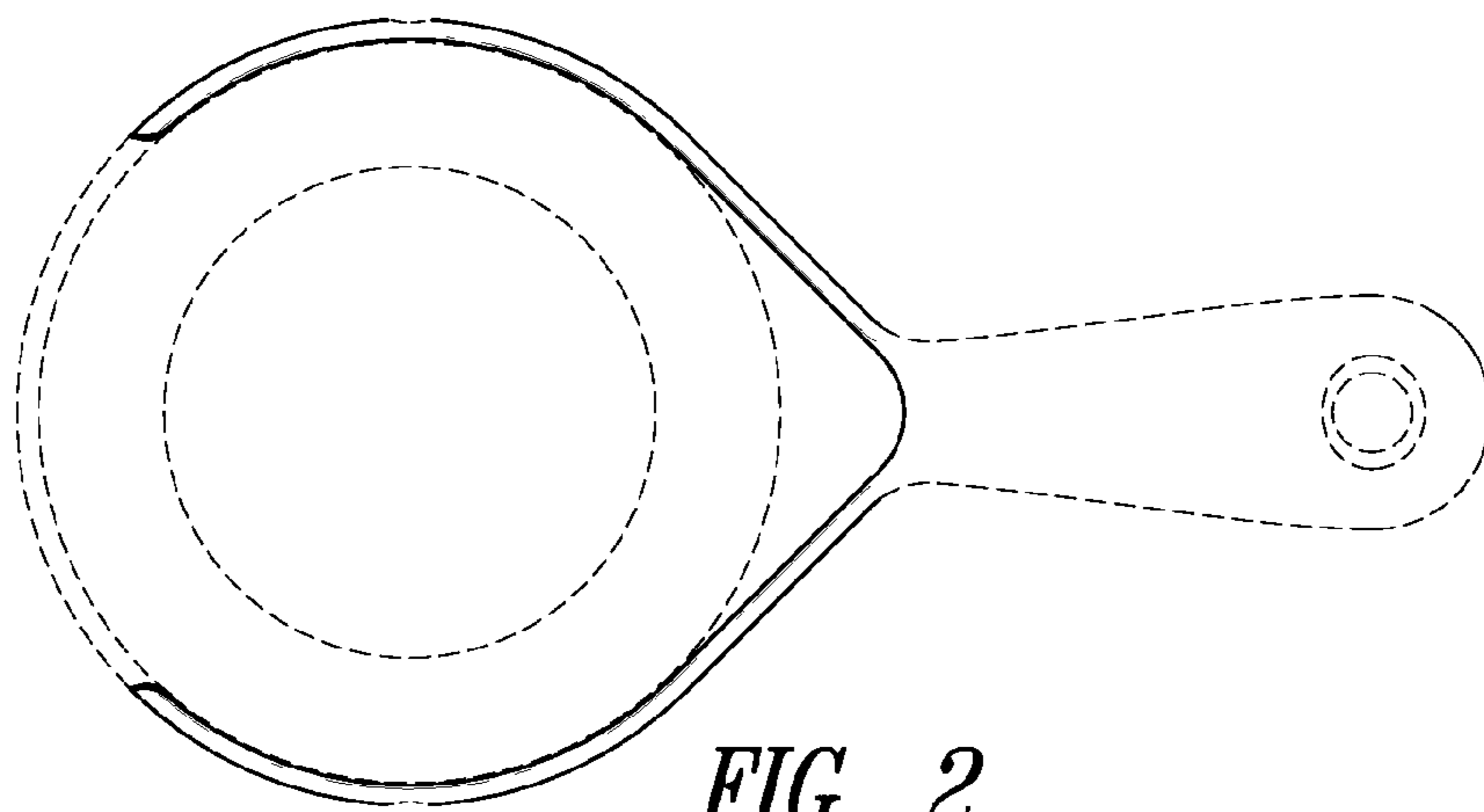

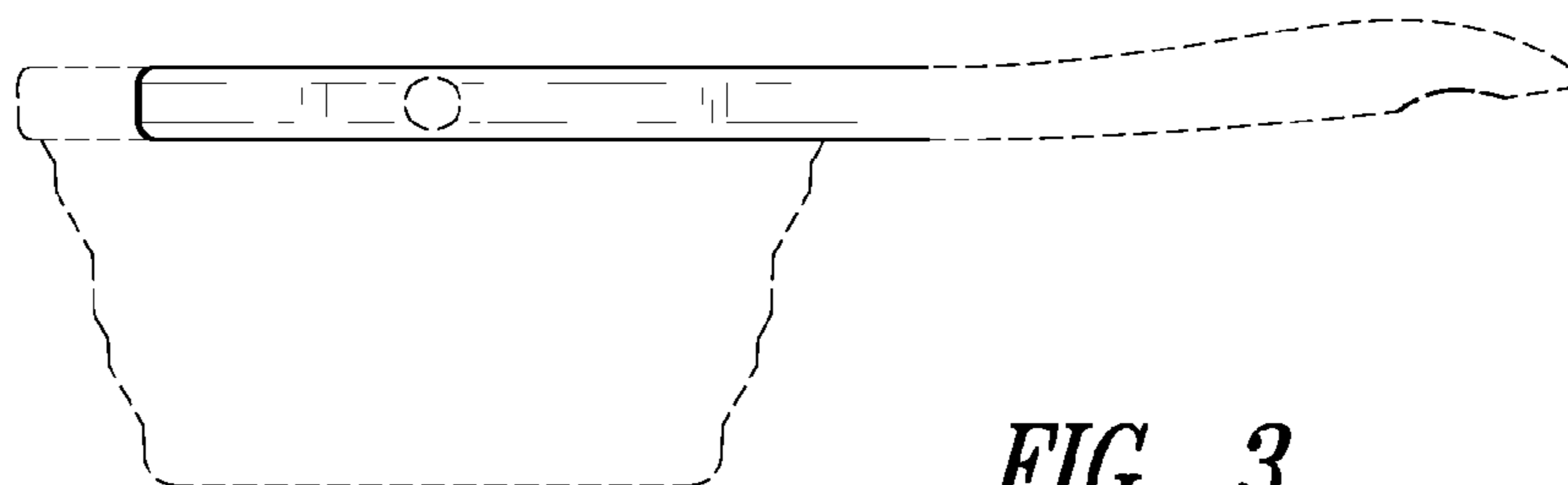

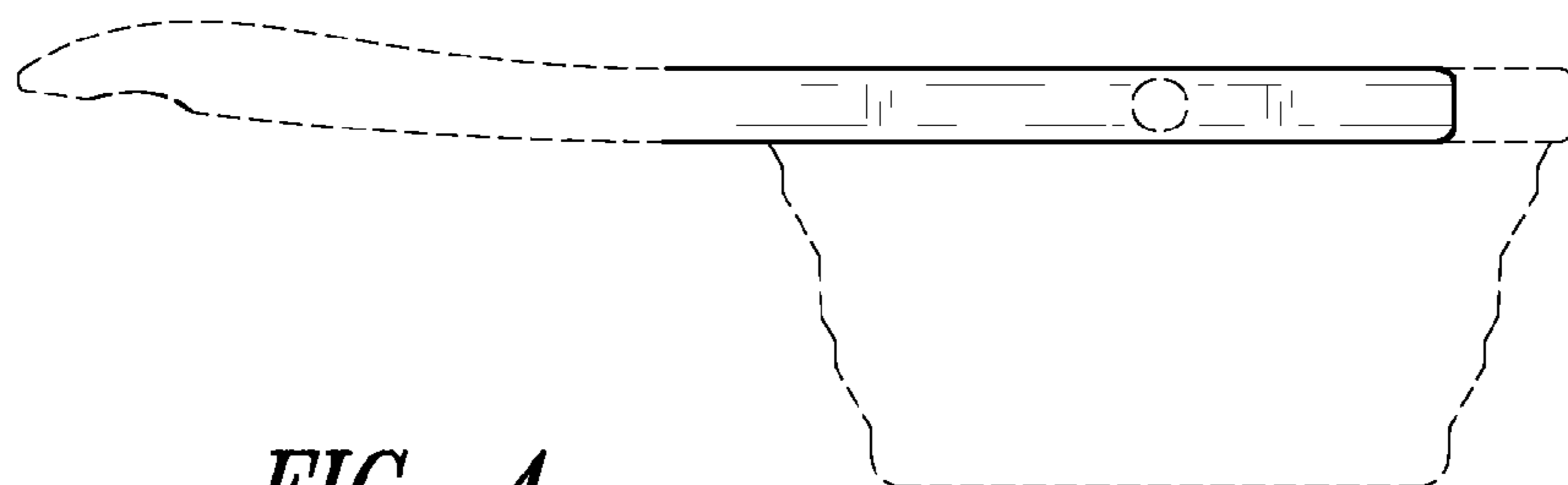

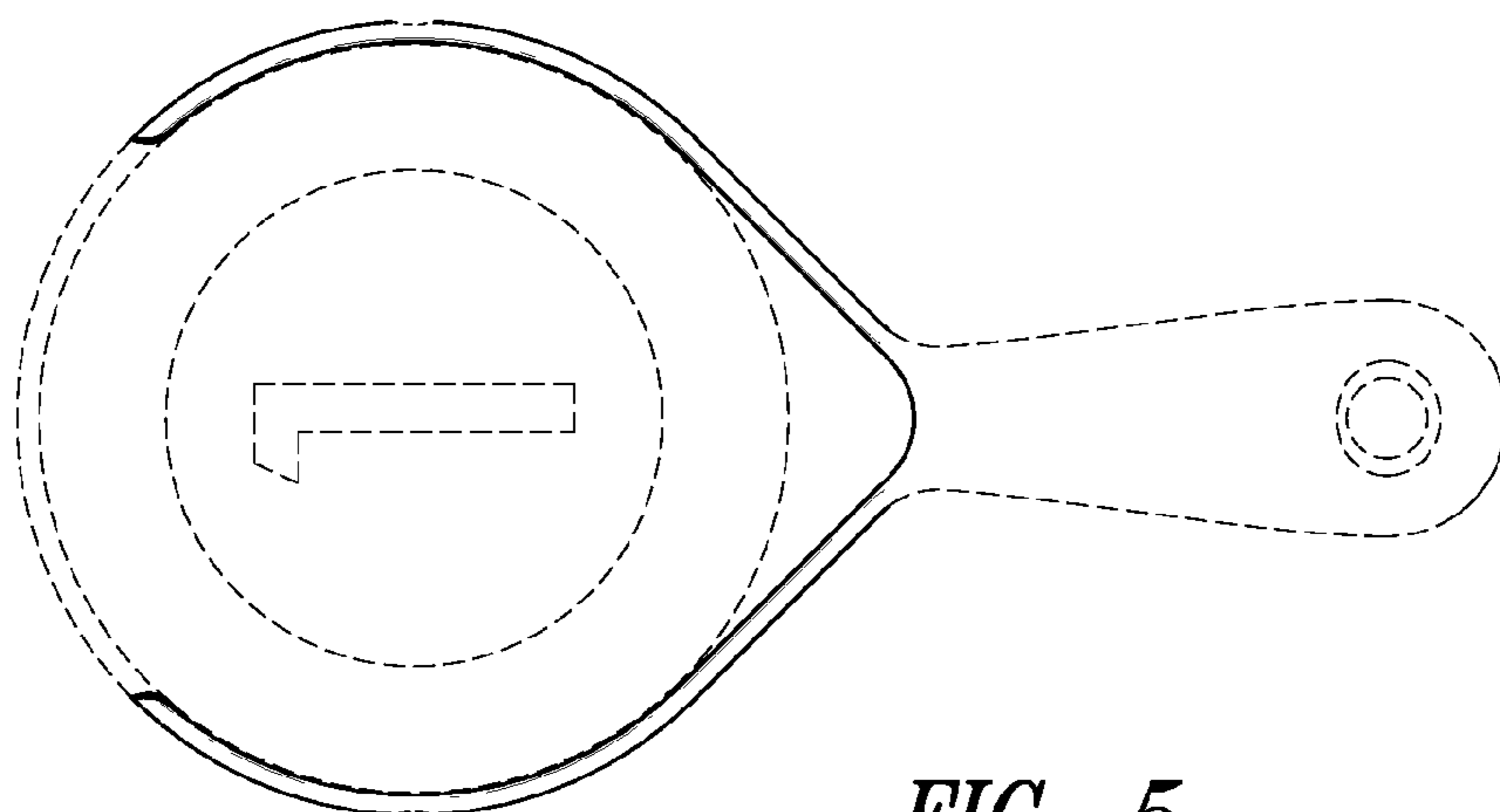

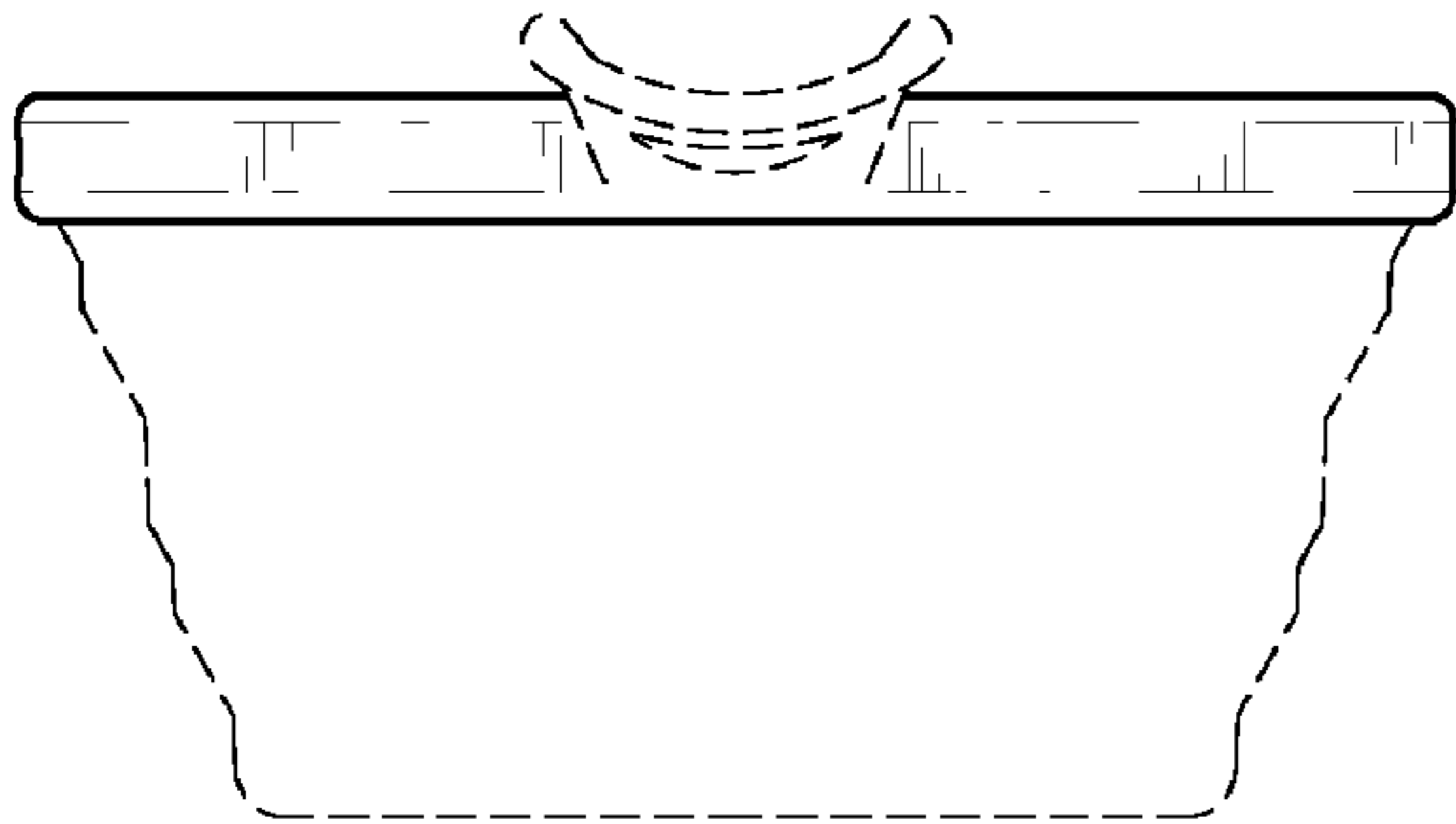

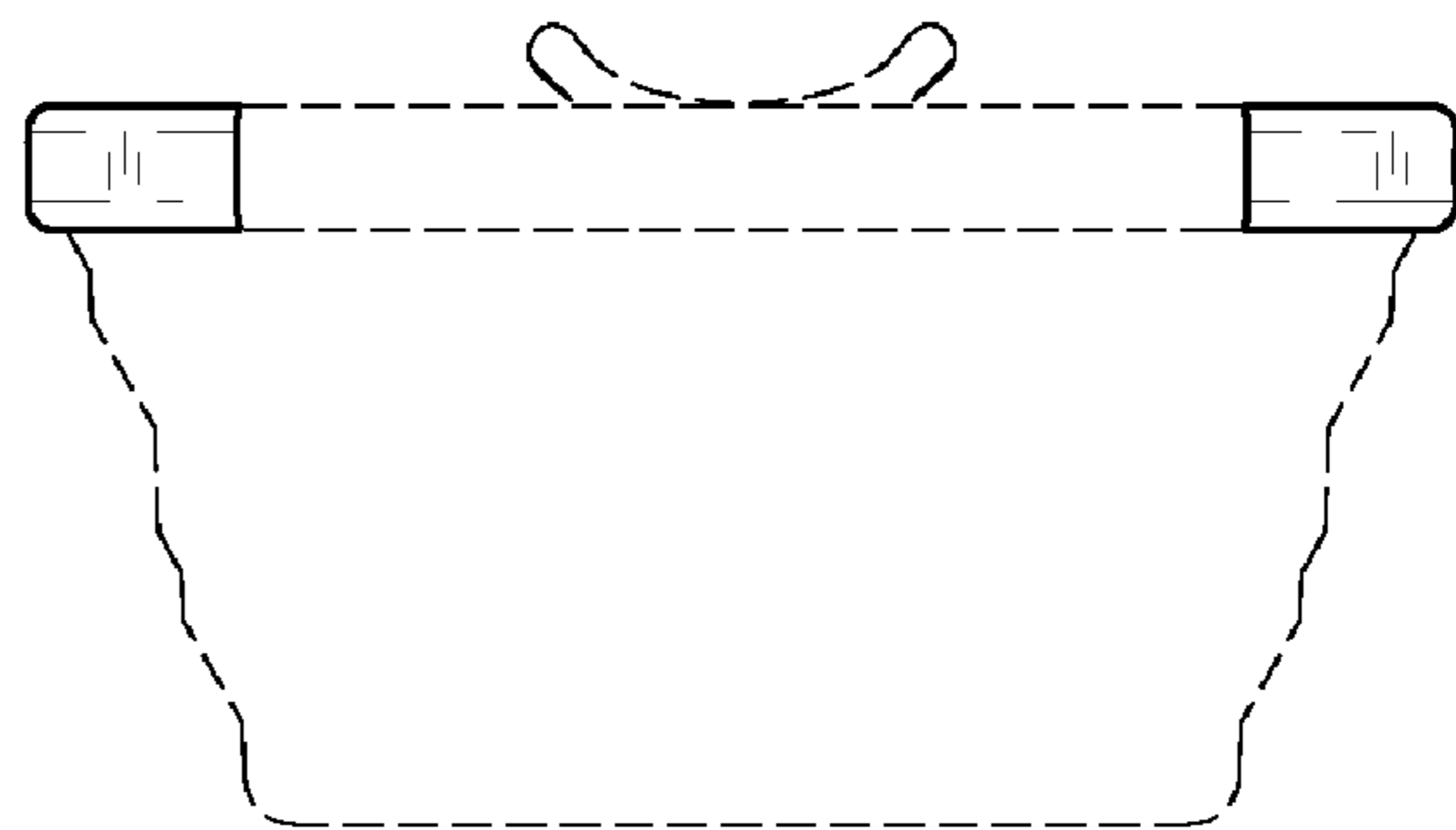
