DESCRIPTION

FIG. 1 is a perspective view of an electrical probe showing our new design;

FIG. 2 is a top elevational view thereof;

FIG. 3 is a bottom elevational view thereof;

FIG. 4 is a left side elevational view thereof;

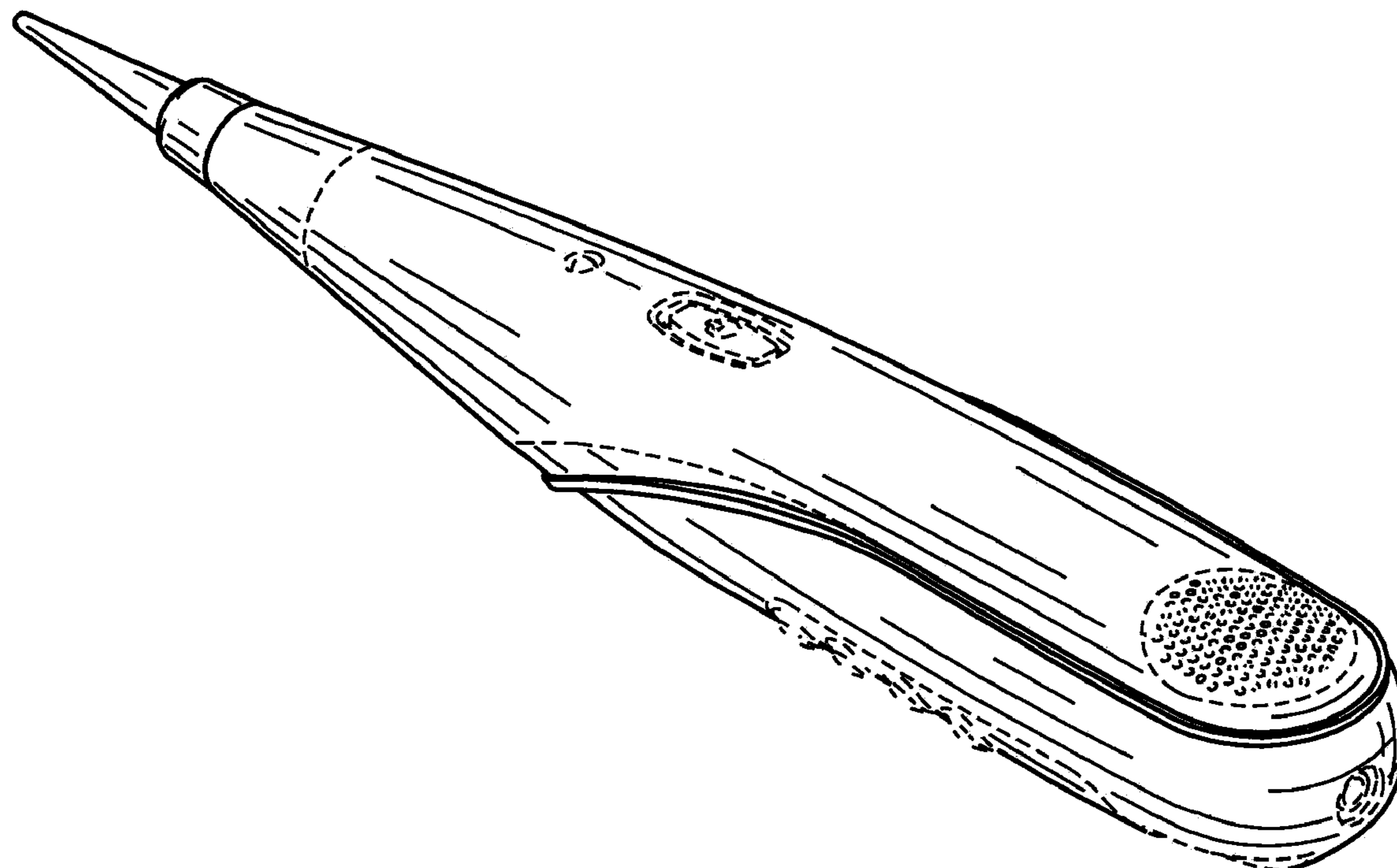
FIG. 5 is a right side elevational view thereof;

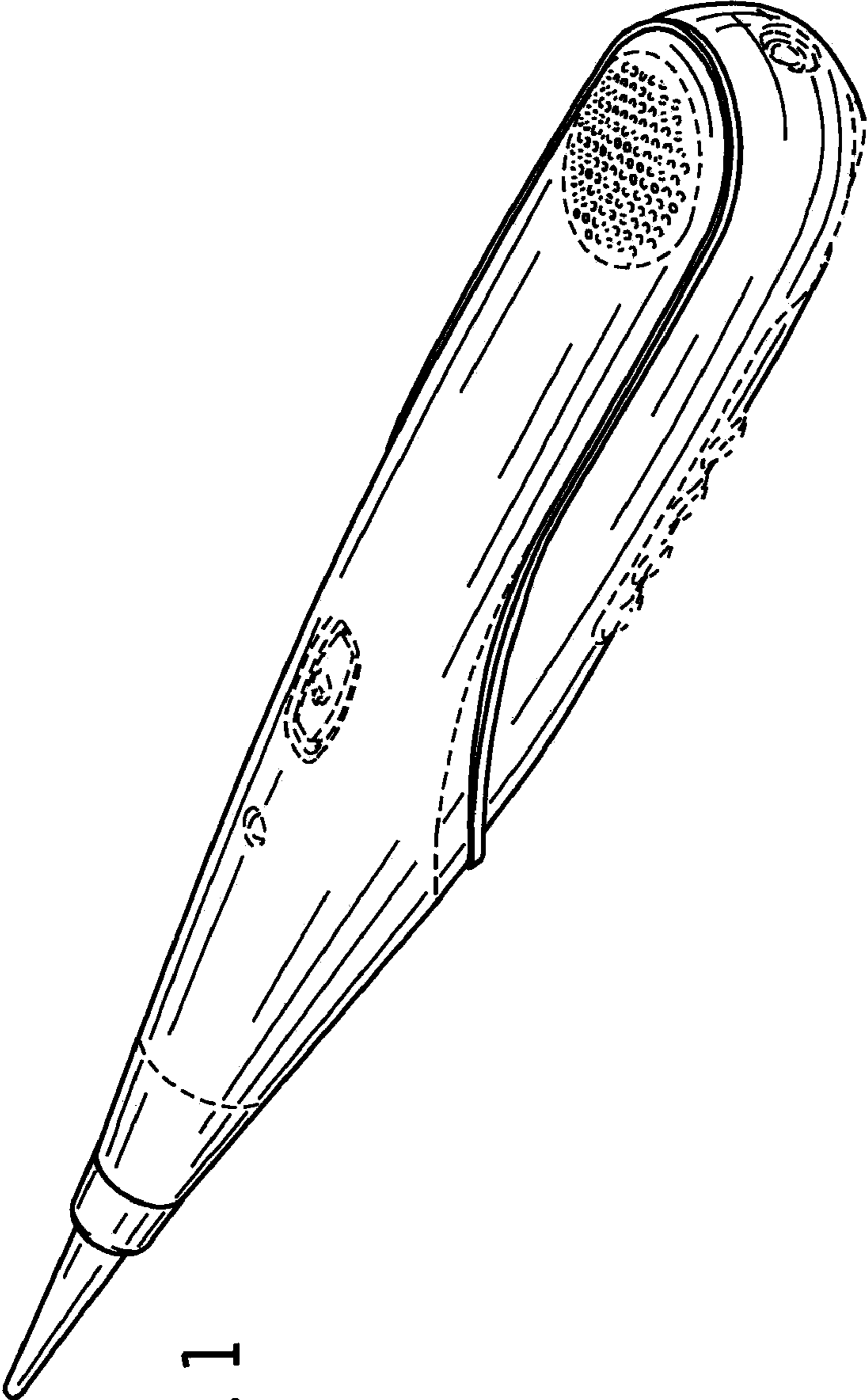

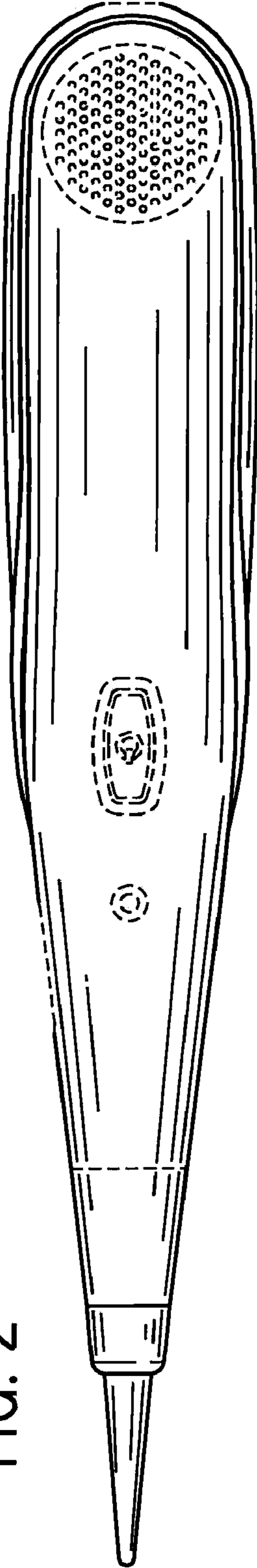

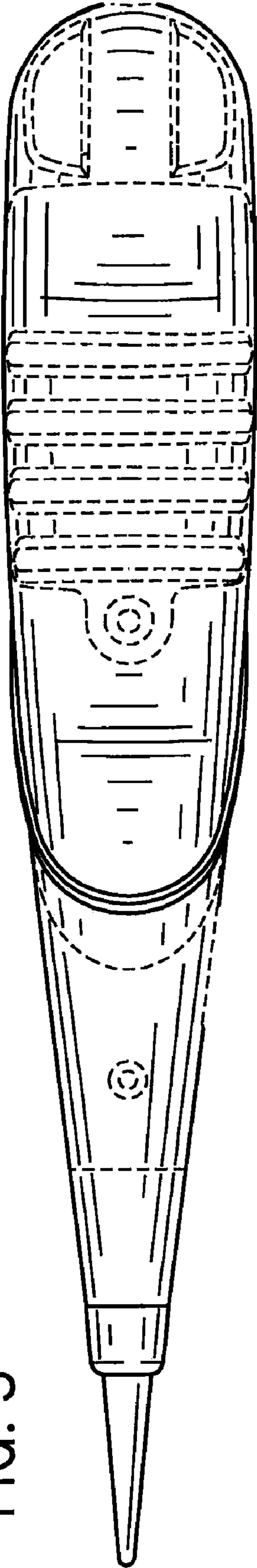

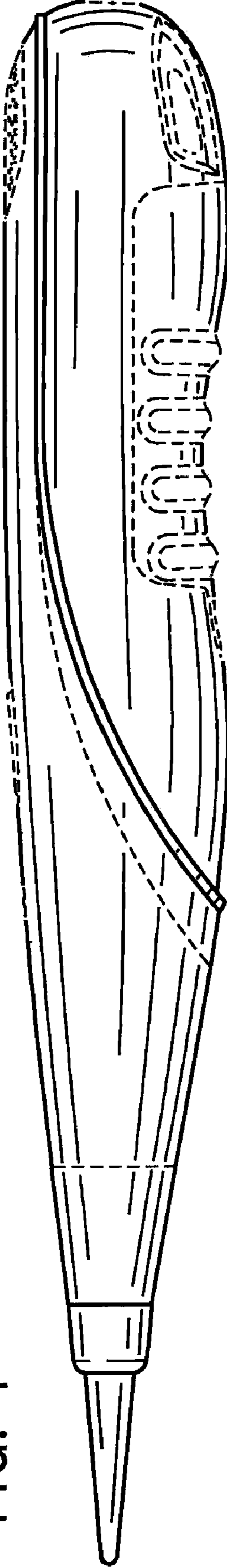

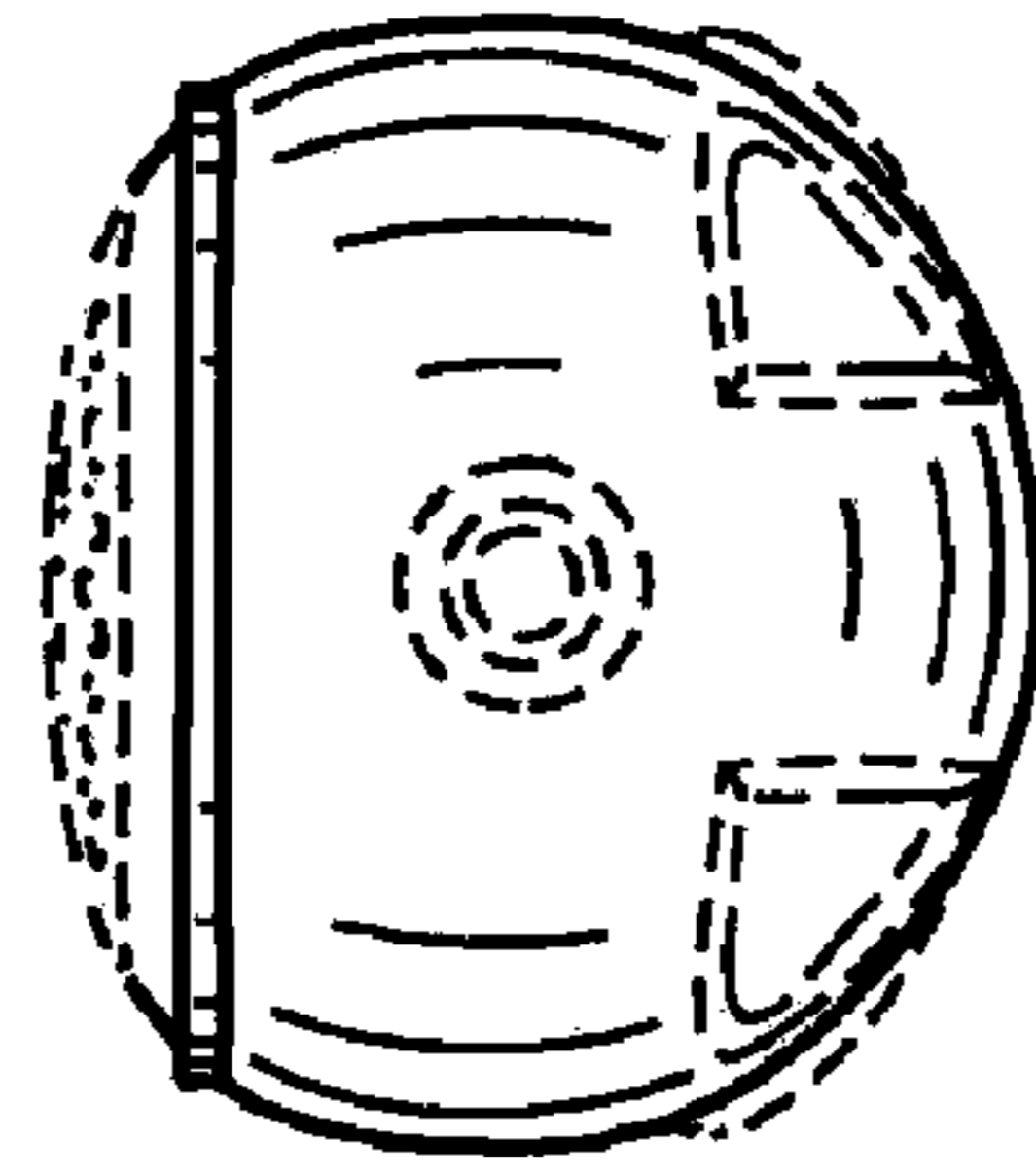
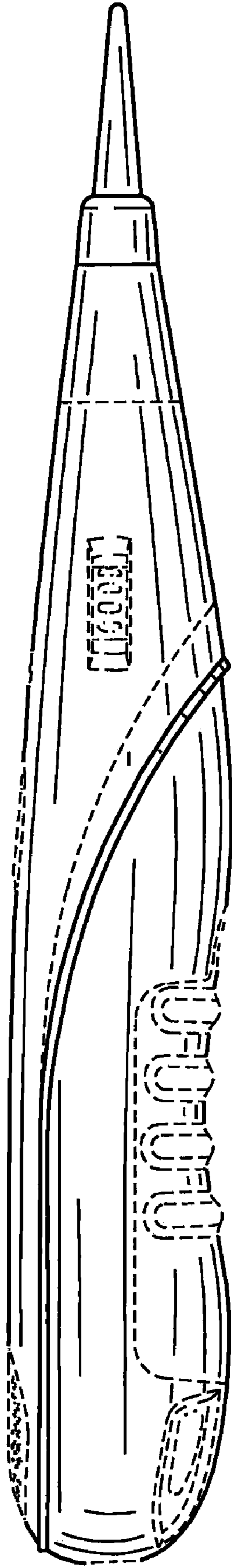

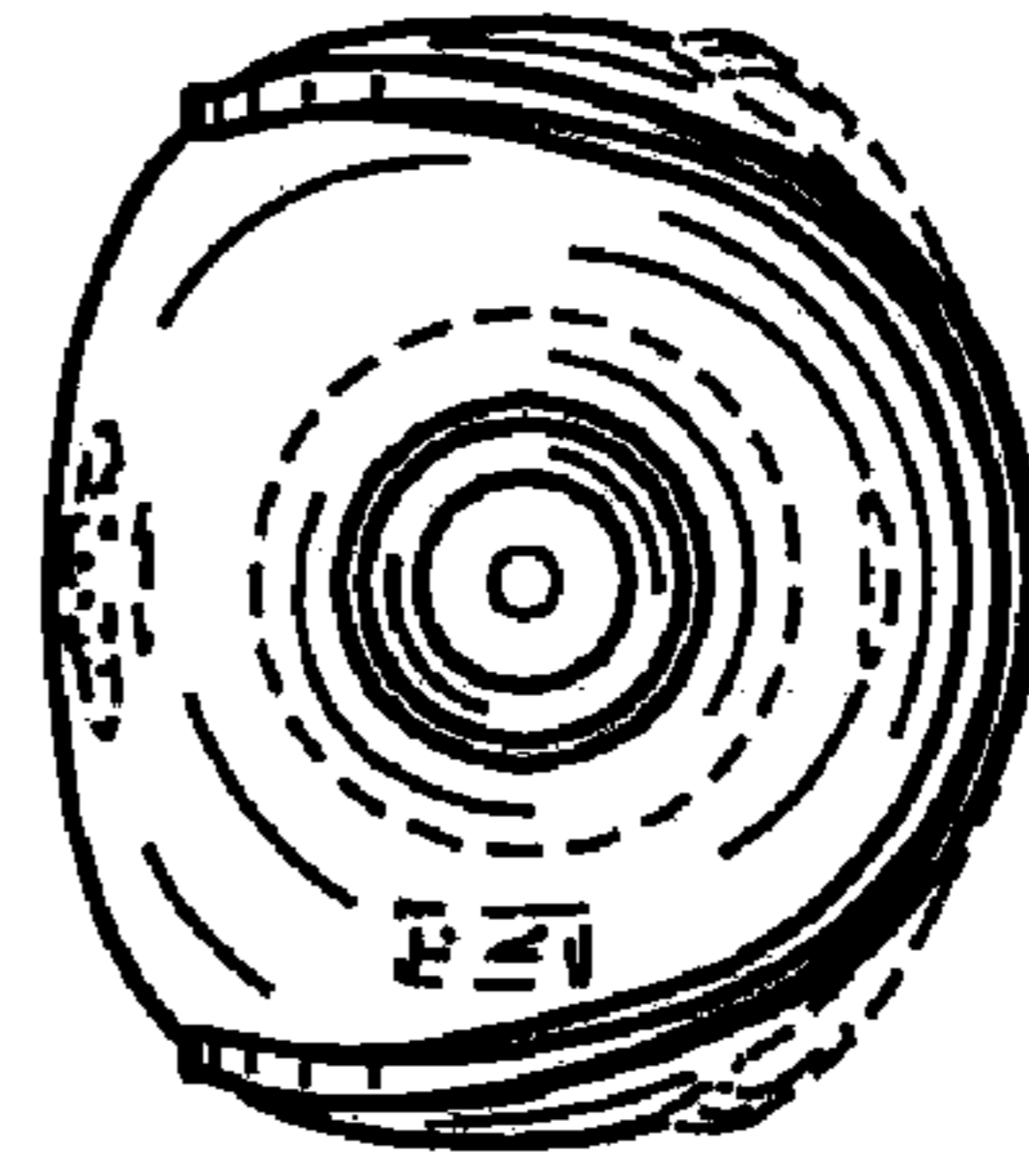
