(57) **CLAIM**

The ornamental design for a pneumatic tire for vehicle wheels, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a pneumatic tire for vehicle wheels incorporating my new design, it being understood that the tread pattern repeats circumferentially throughout the outer circumference;

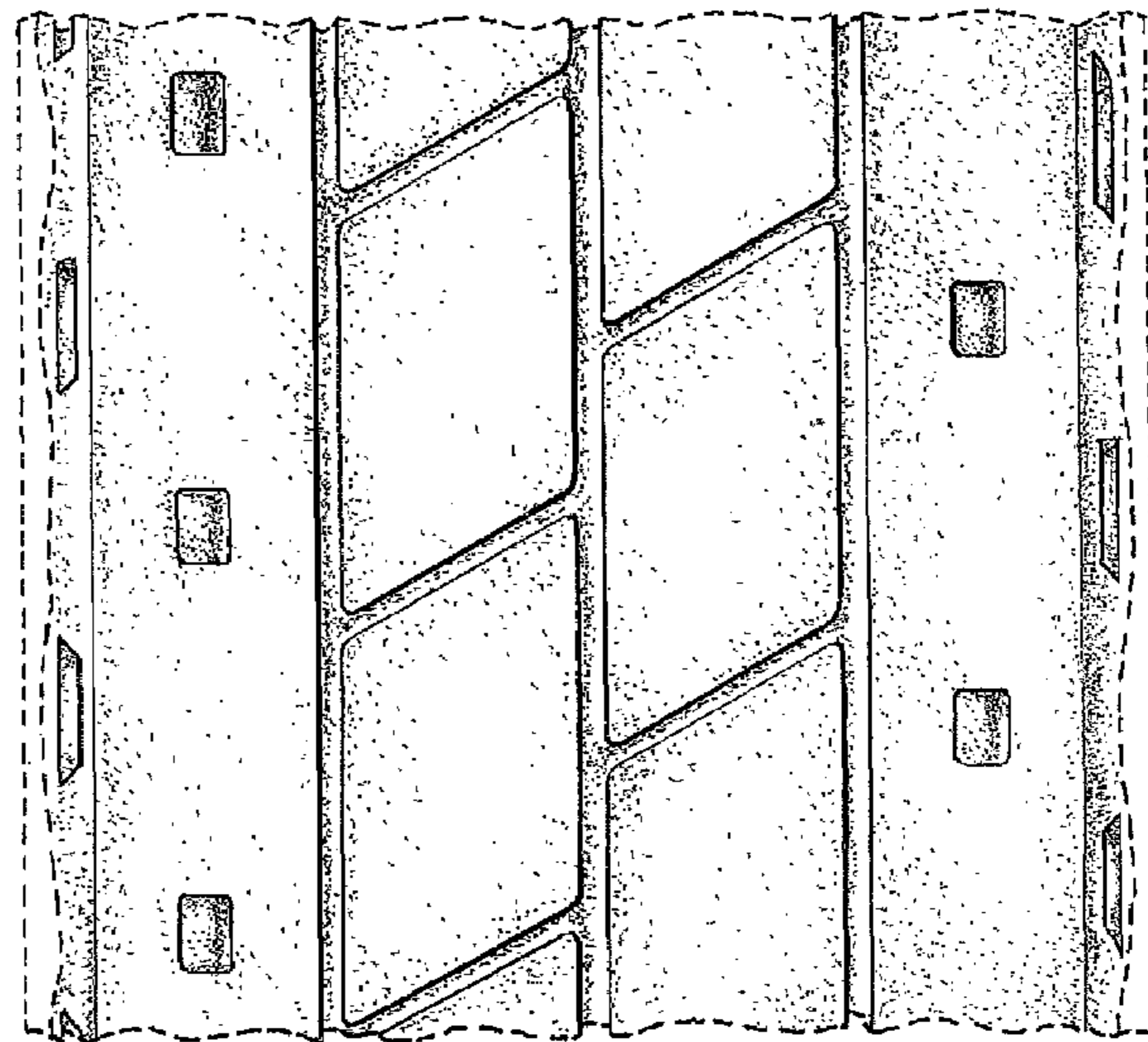
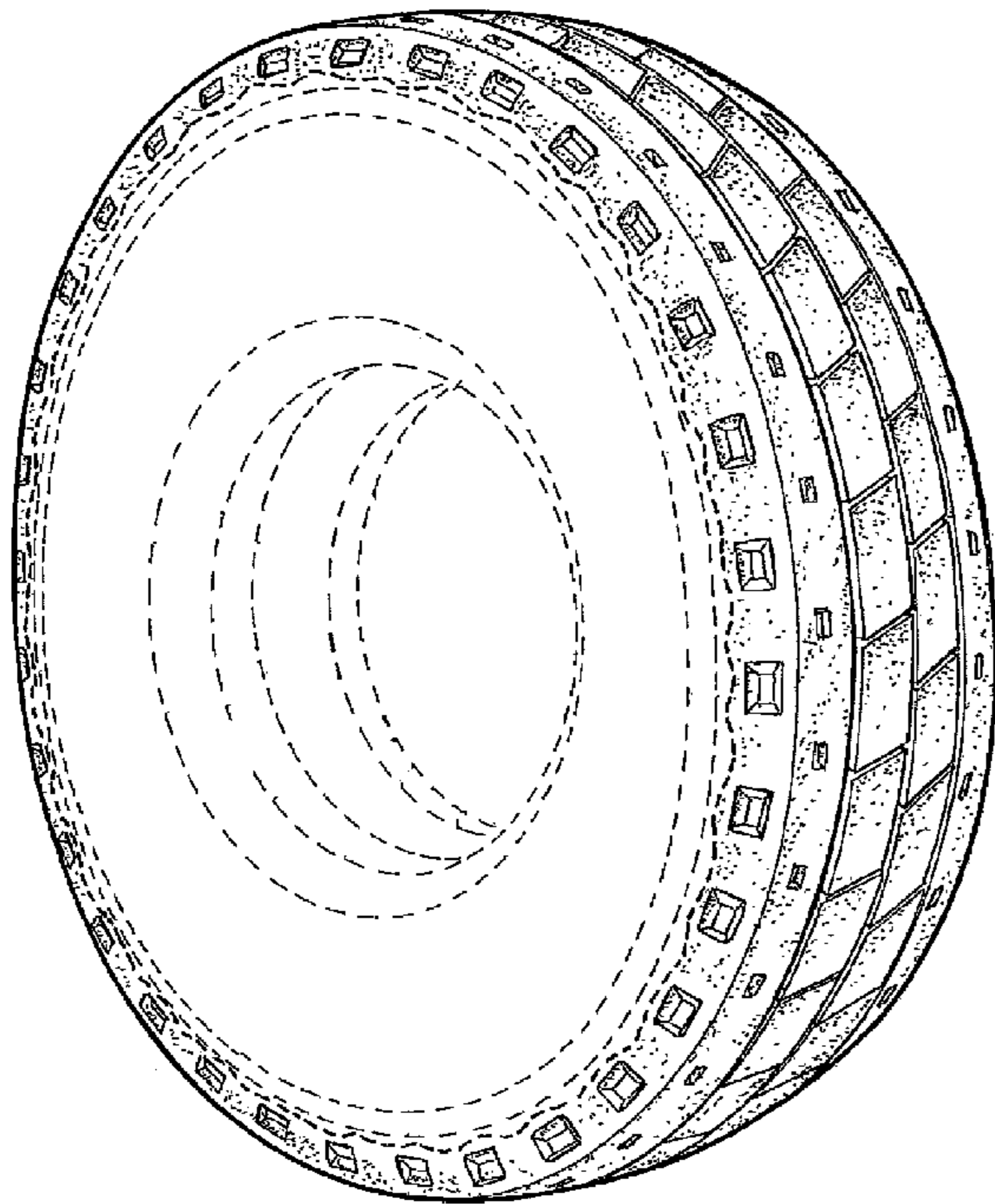
FIG. 2 is a side view of FIG. 1, the opposite side being of identical shape;

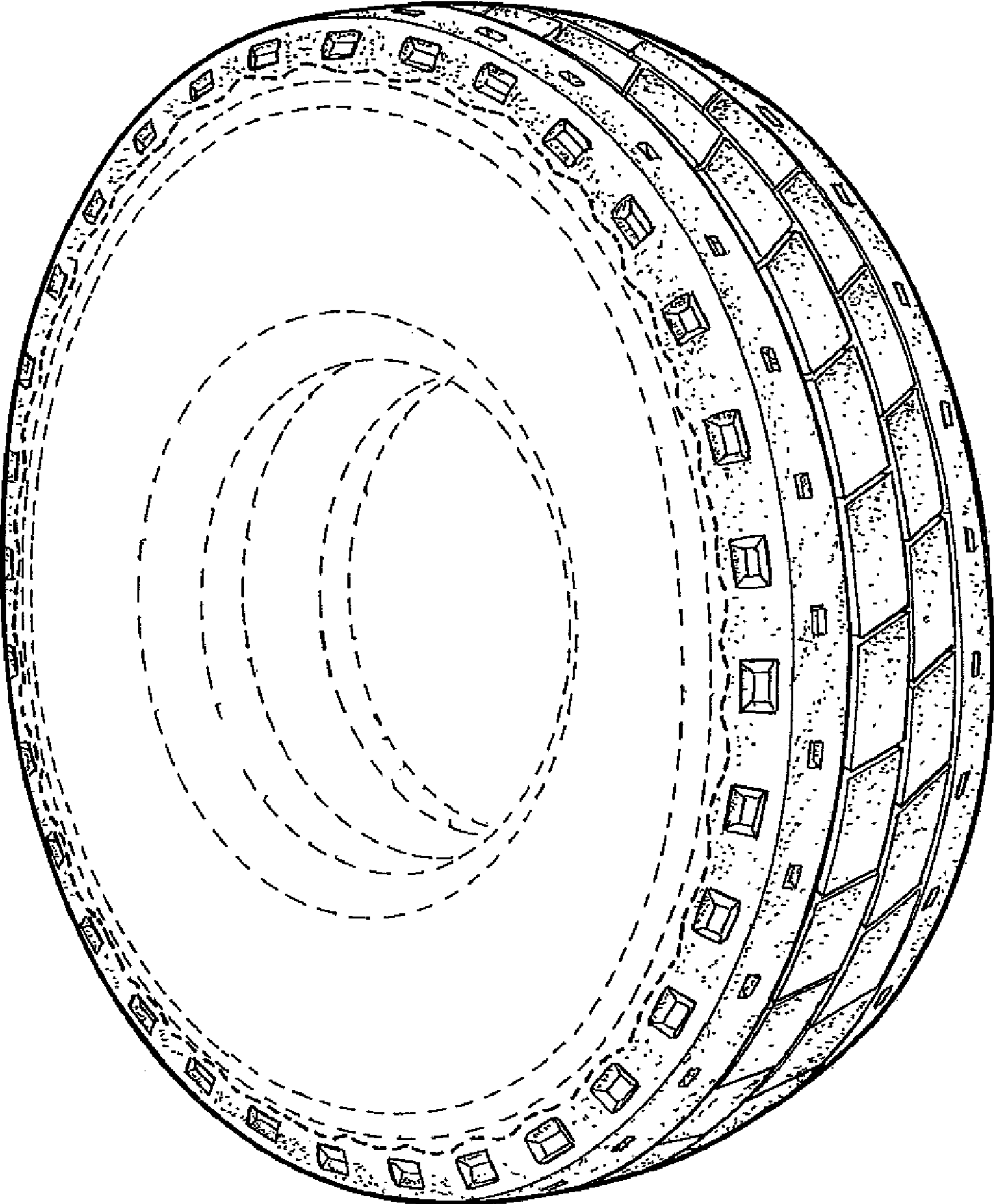

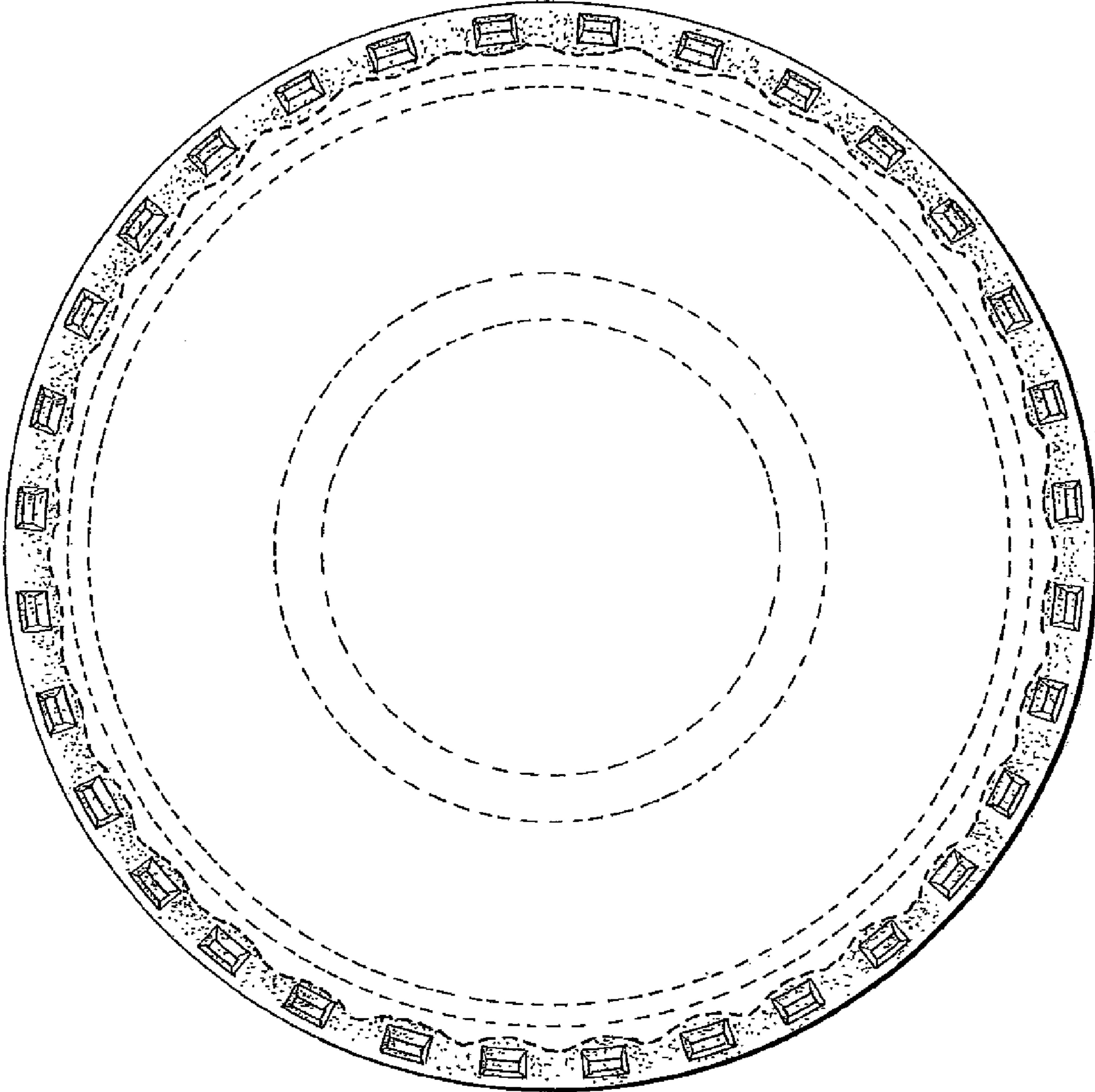
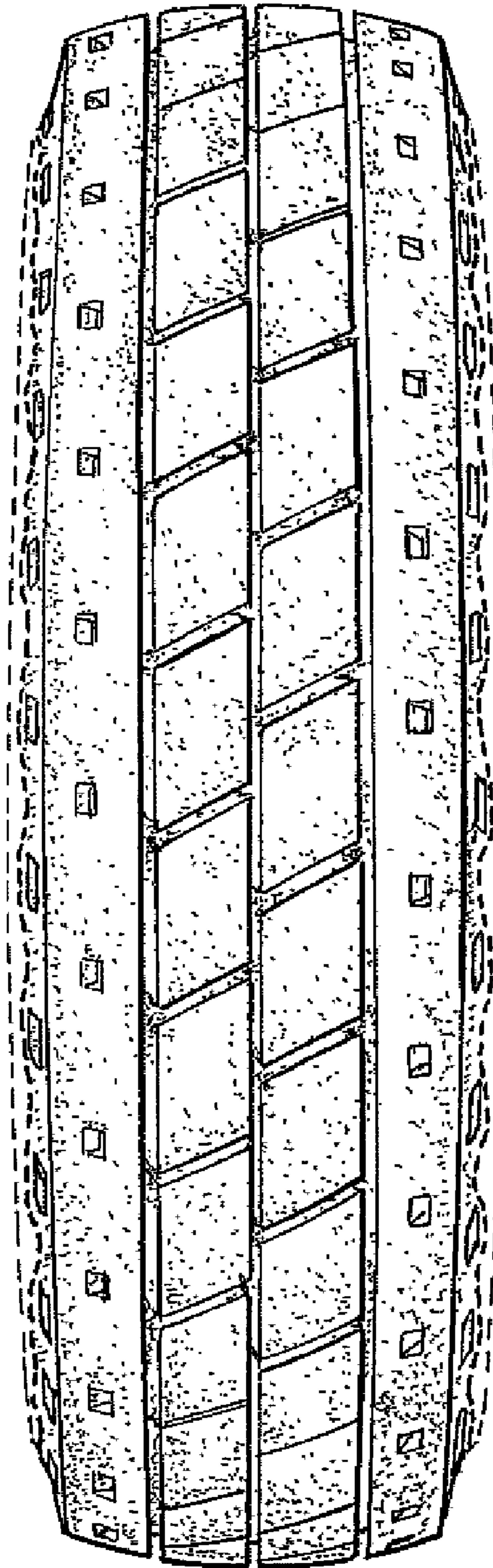

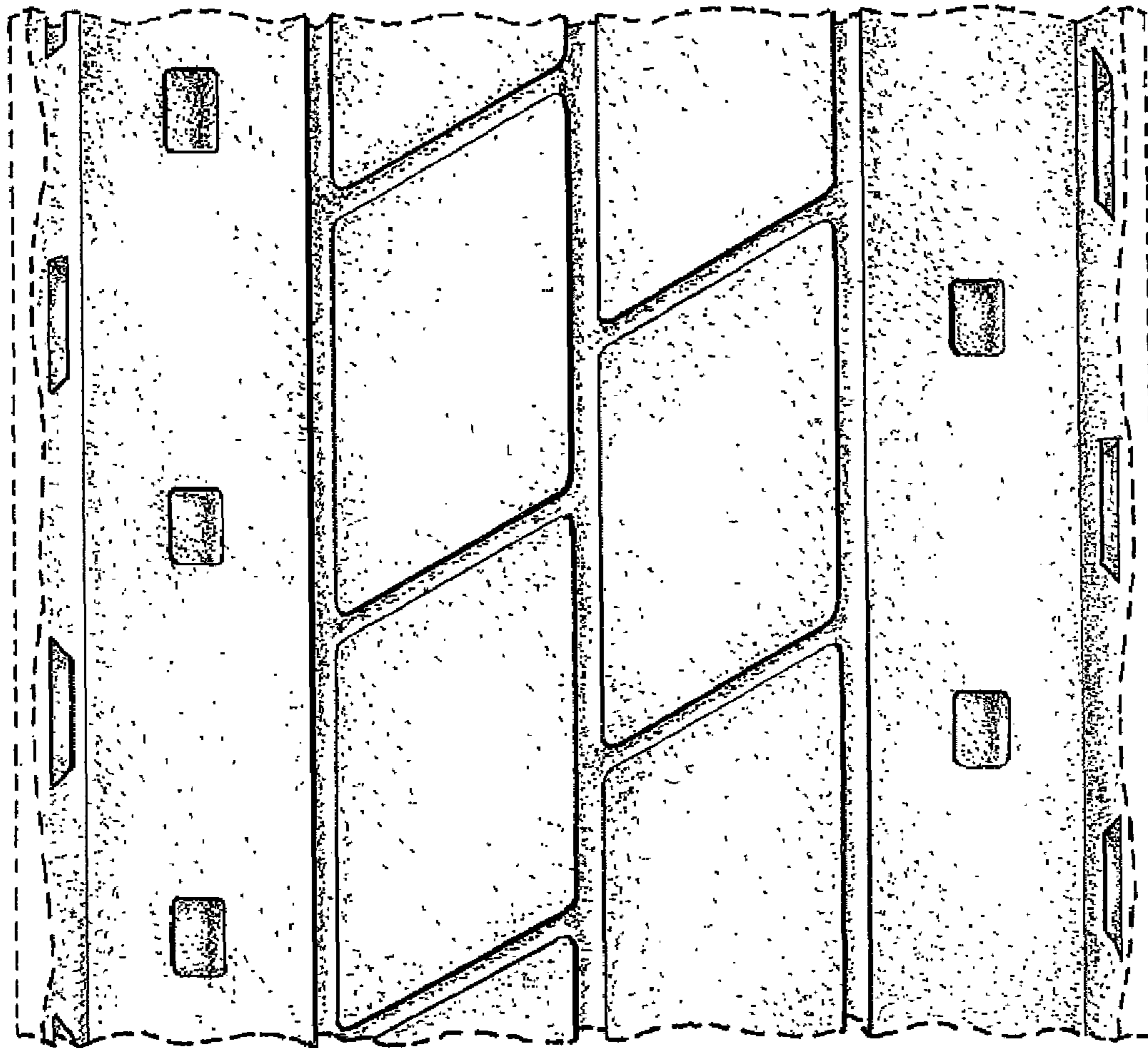
