**DESCRIPTION**

FIG. 1 is a top view of a basic block for mounting of instal-  
lation devices showing our new design;

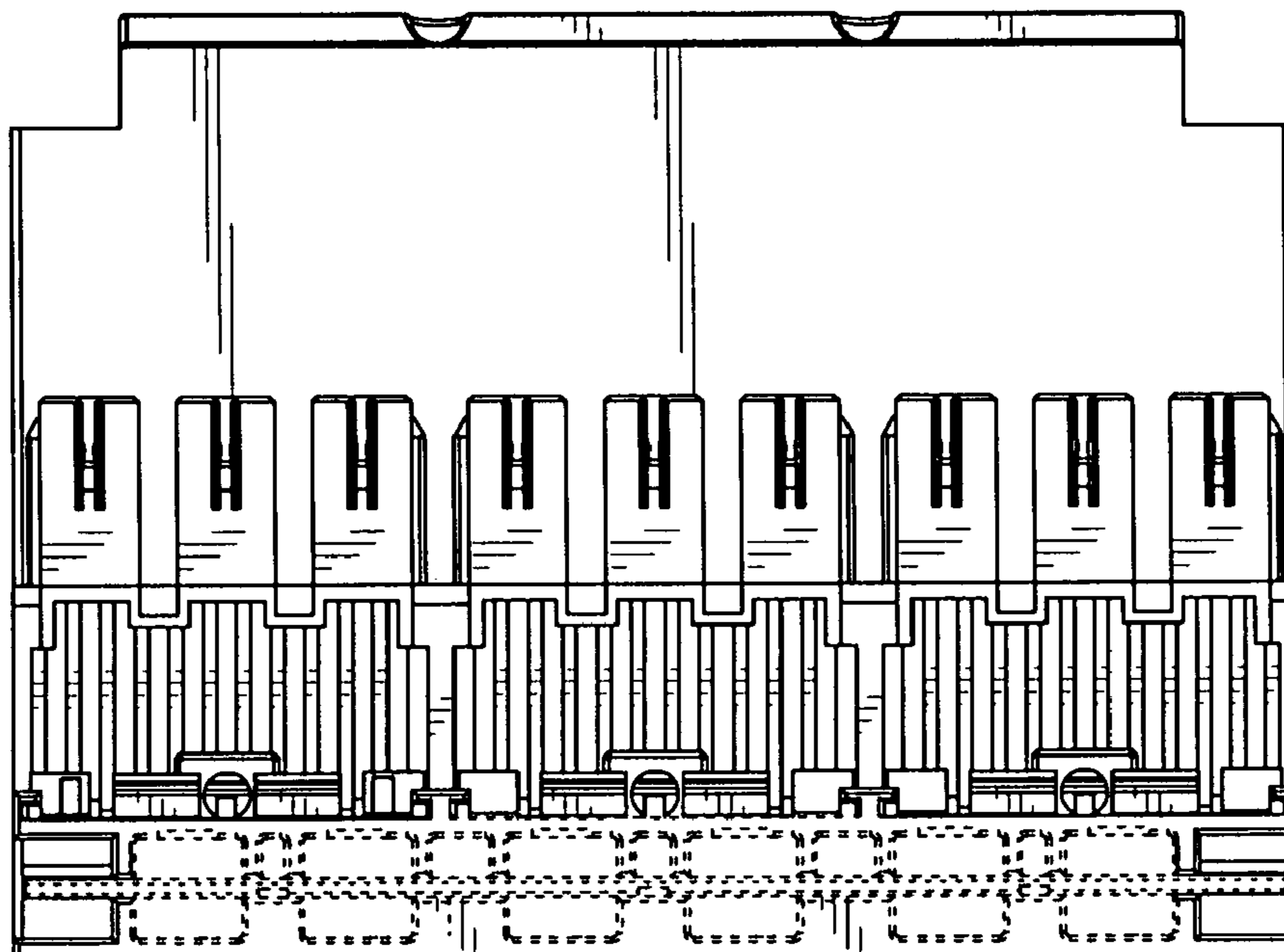

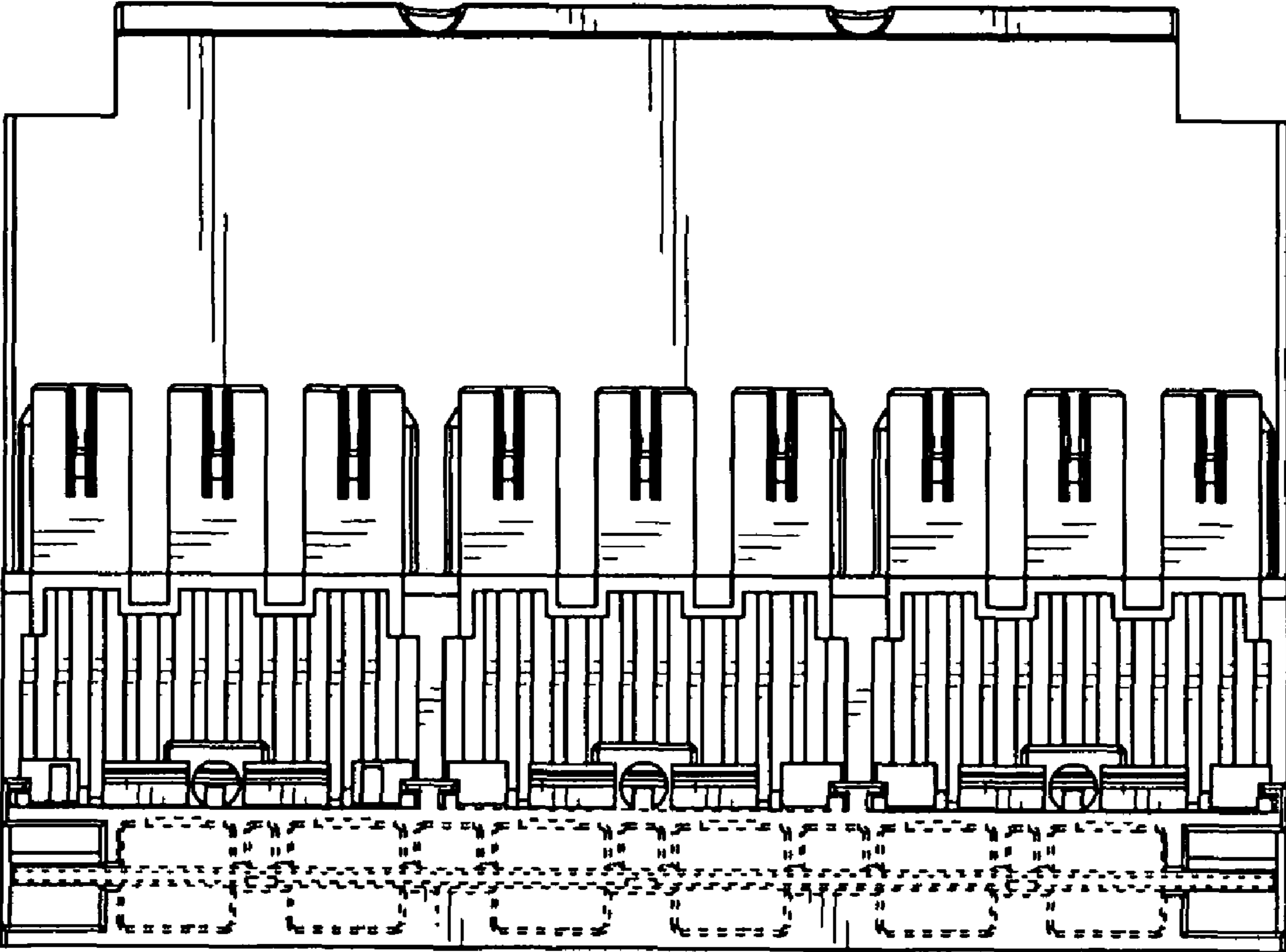

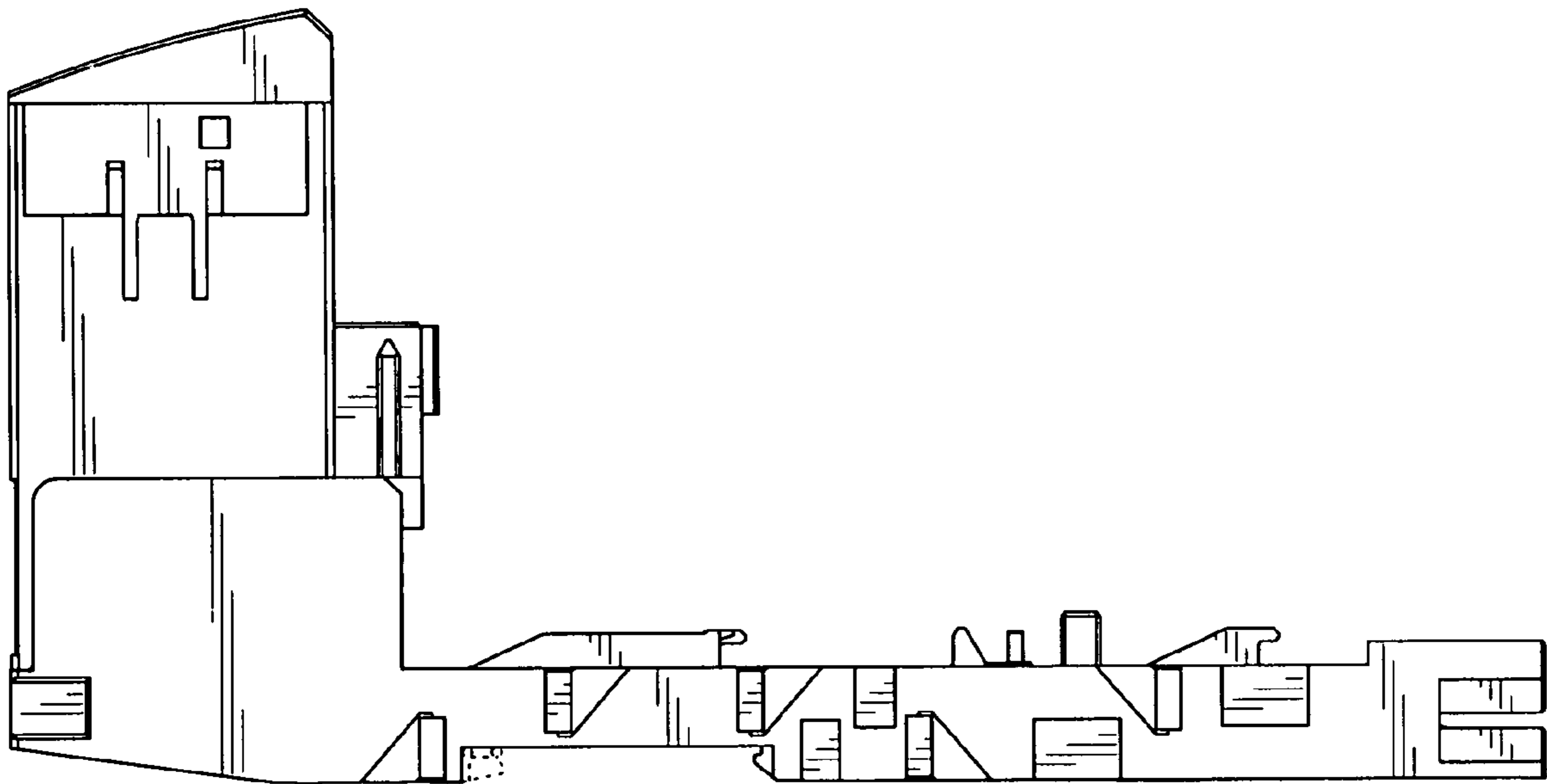

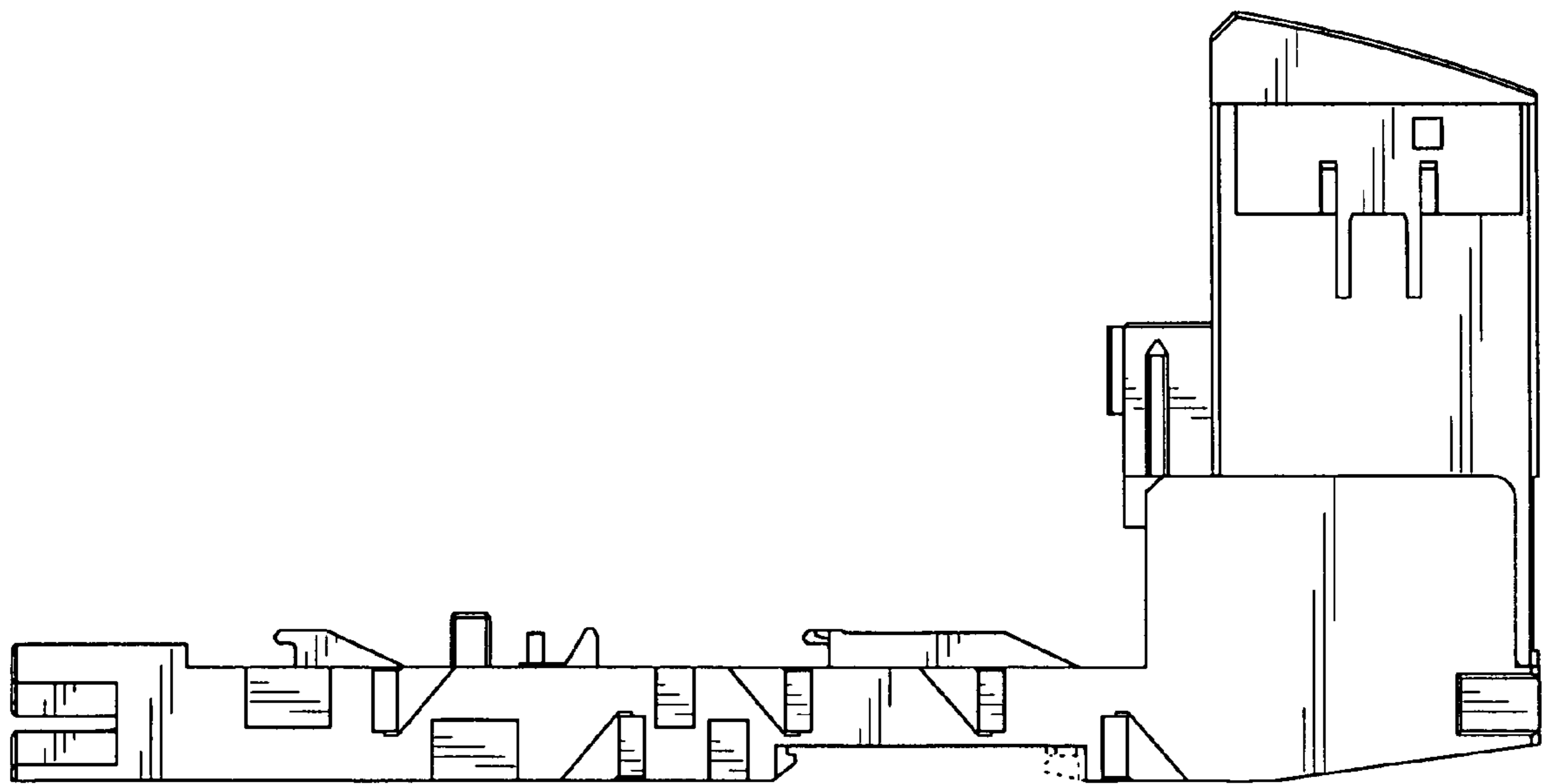

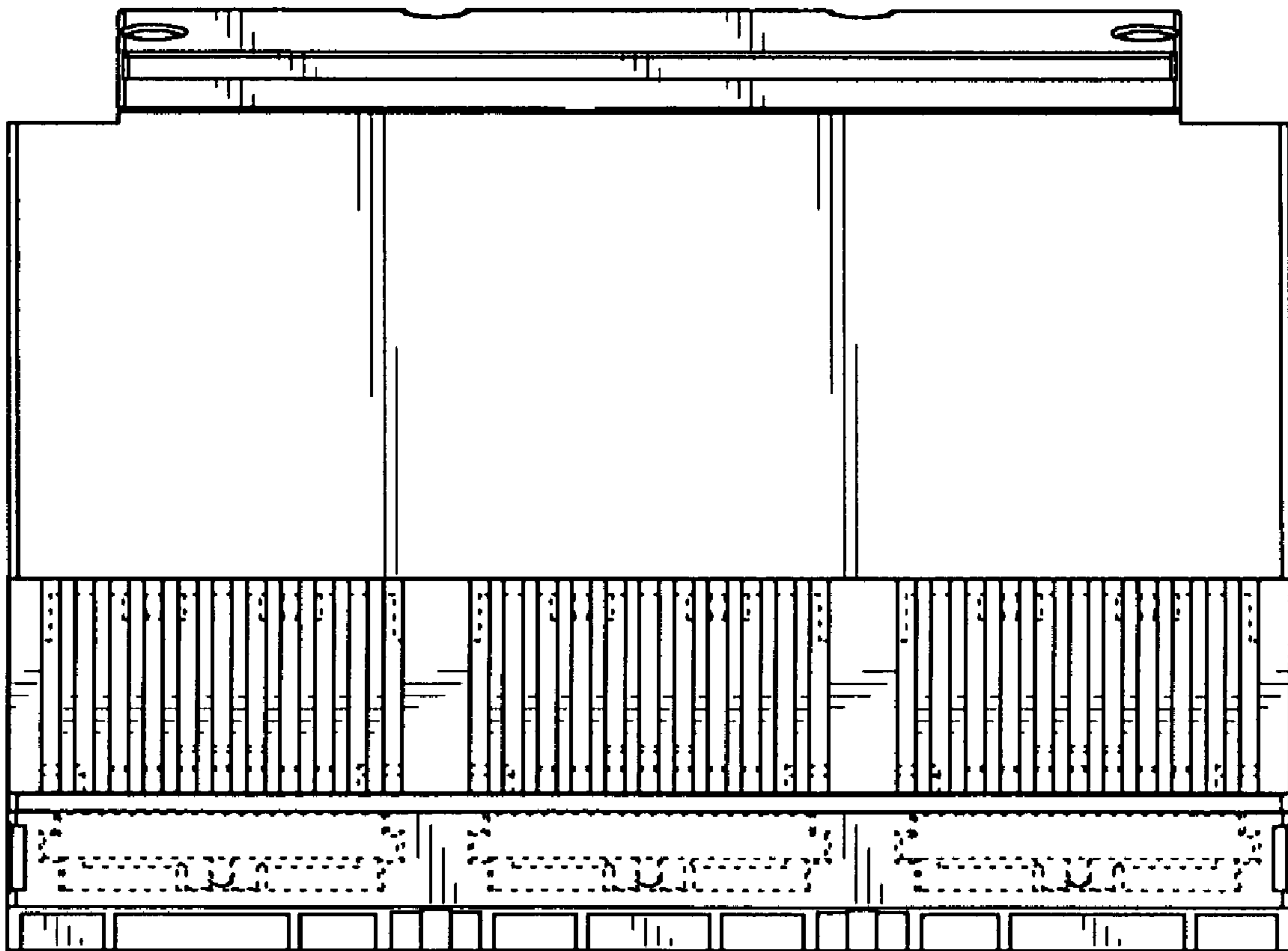

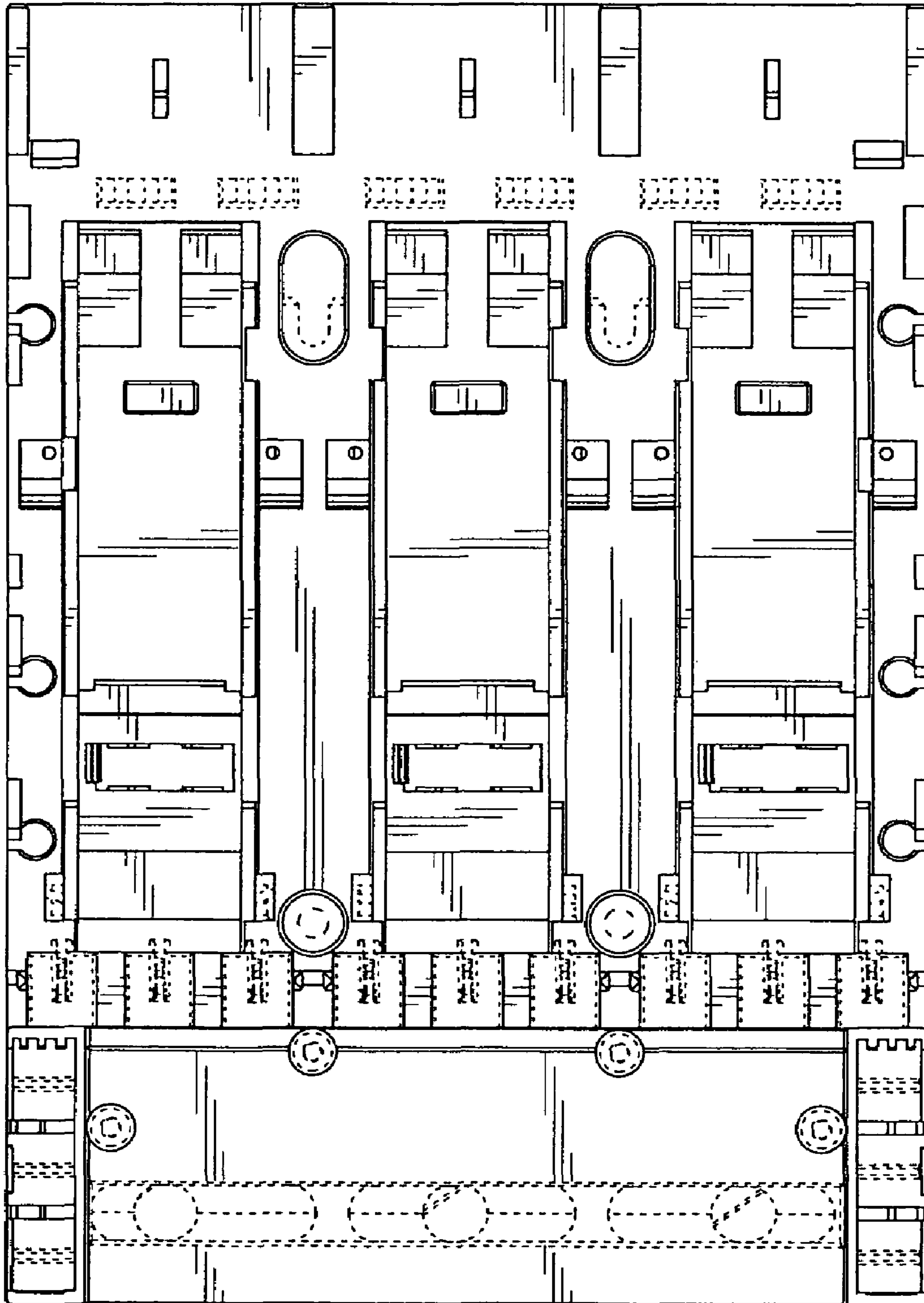

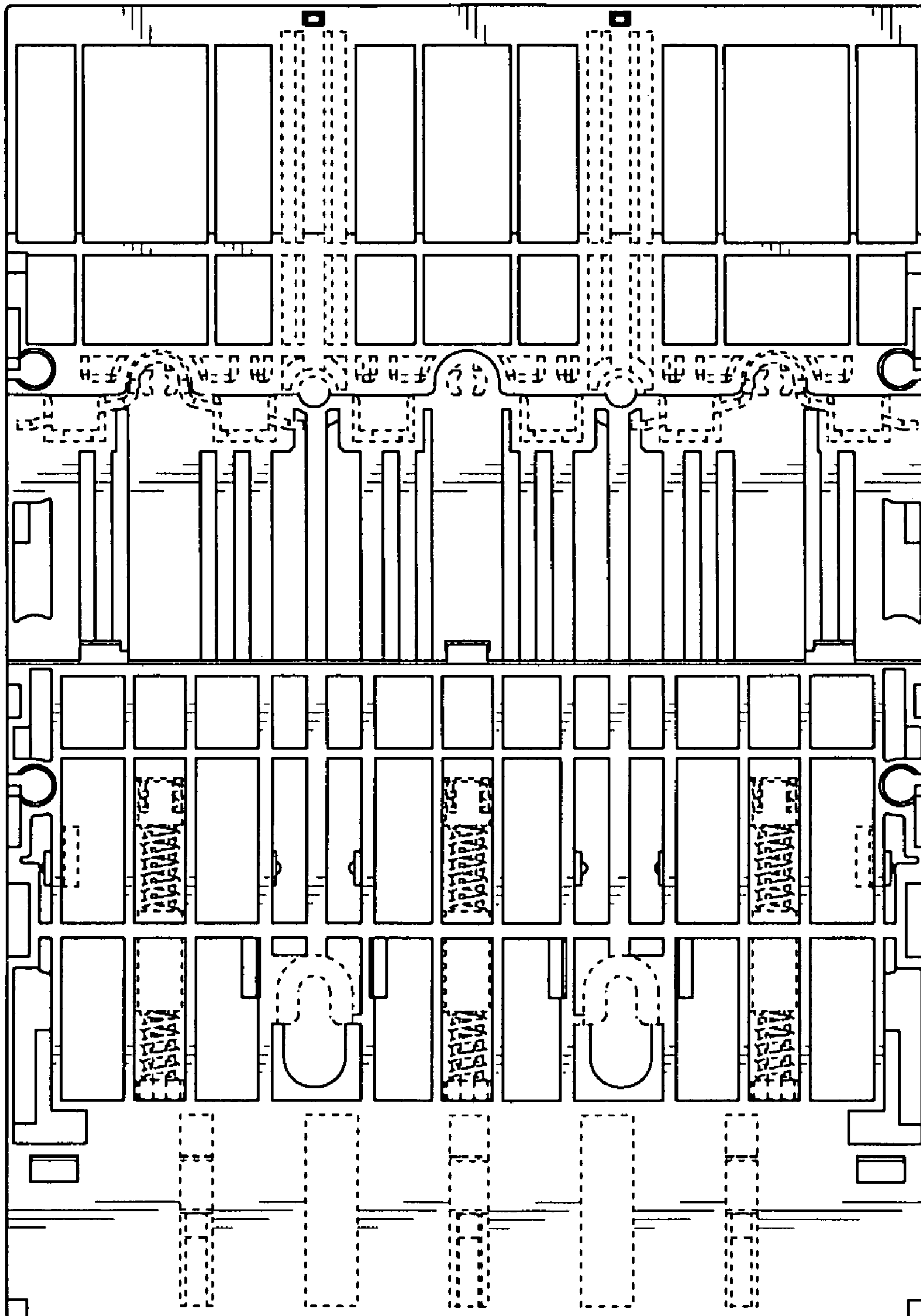
