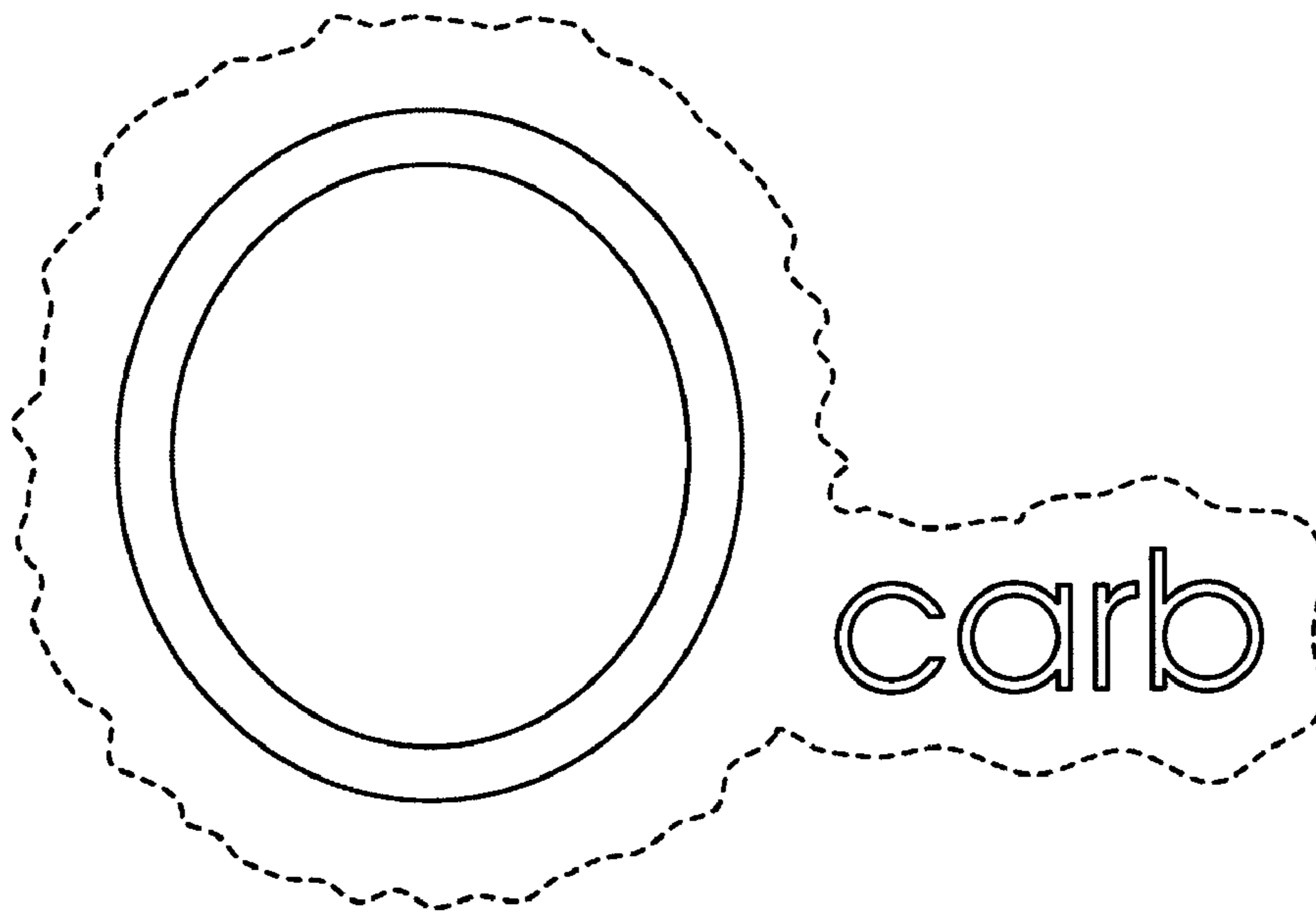
The ornamental design for icon for a display screen or packaging with surface ornamentation, as shown and described.

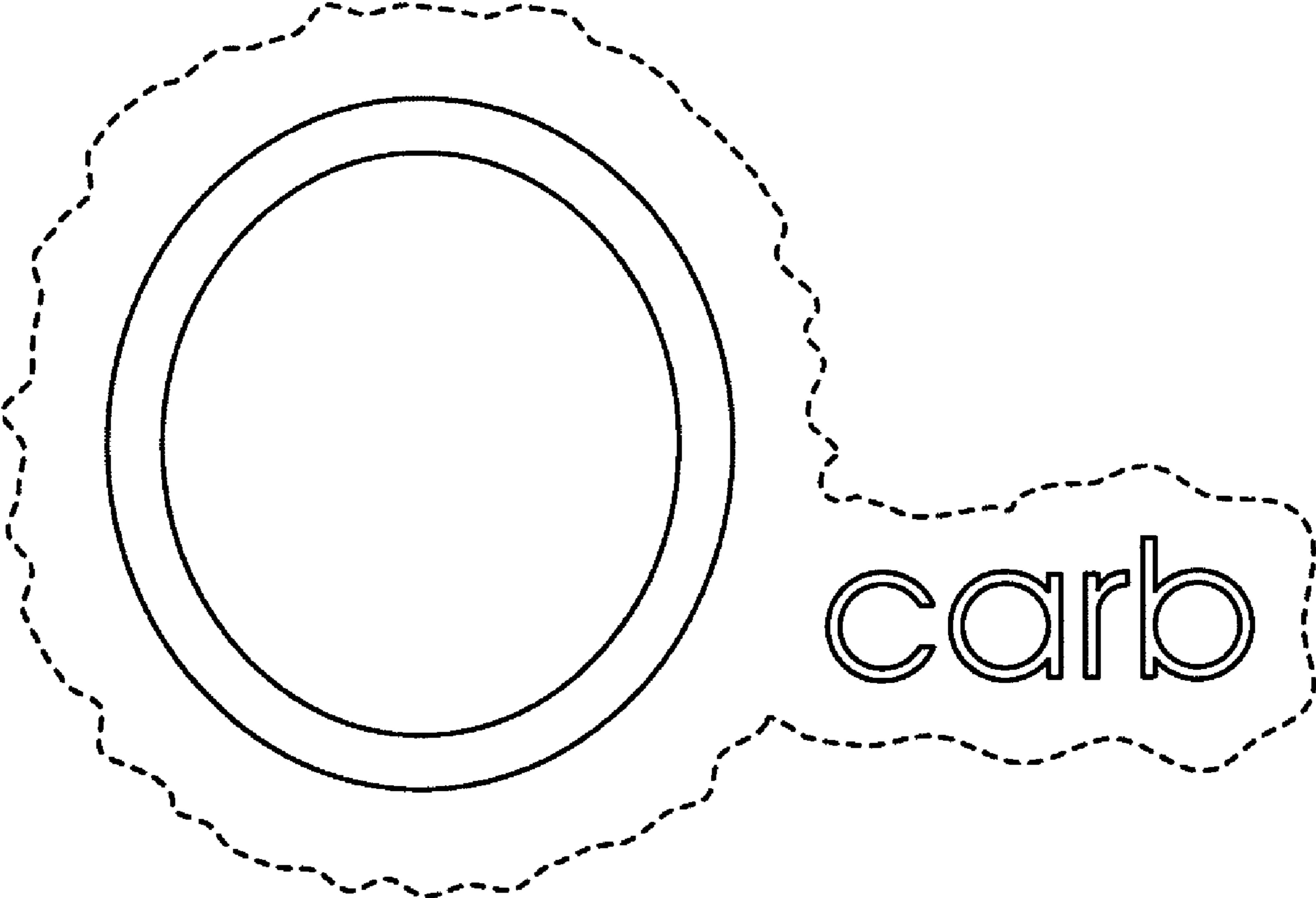
**DESCRIPTION**
