FIG. 1 is a perspective view from the front, above and to the right side of a shower drain pump controller housing showing our new design, the left side matches;

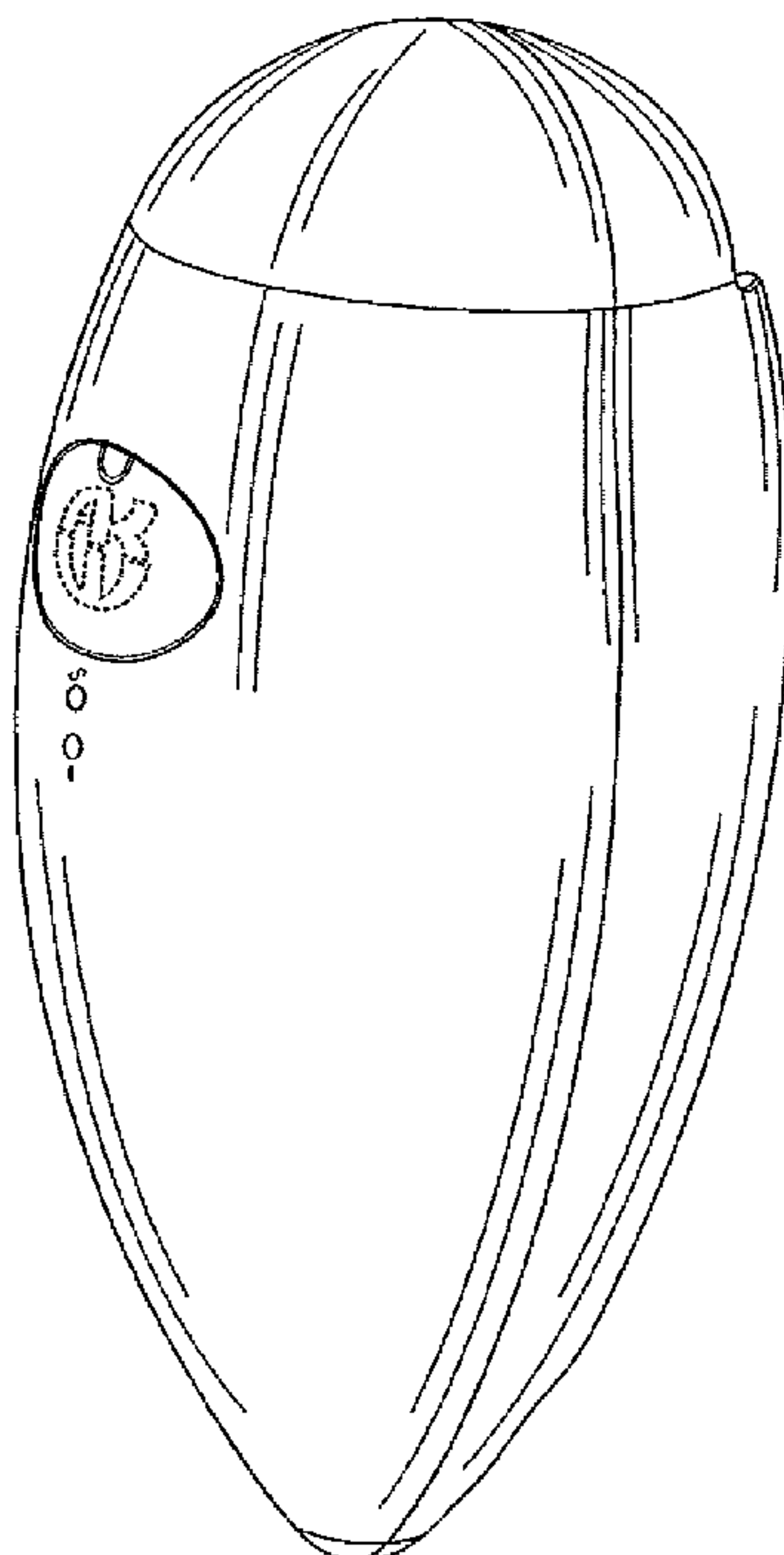
FIG. 2 is a front view;

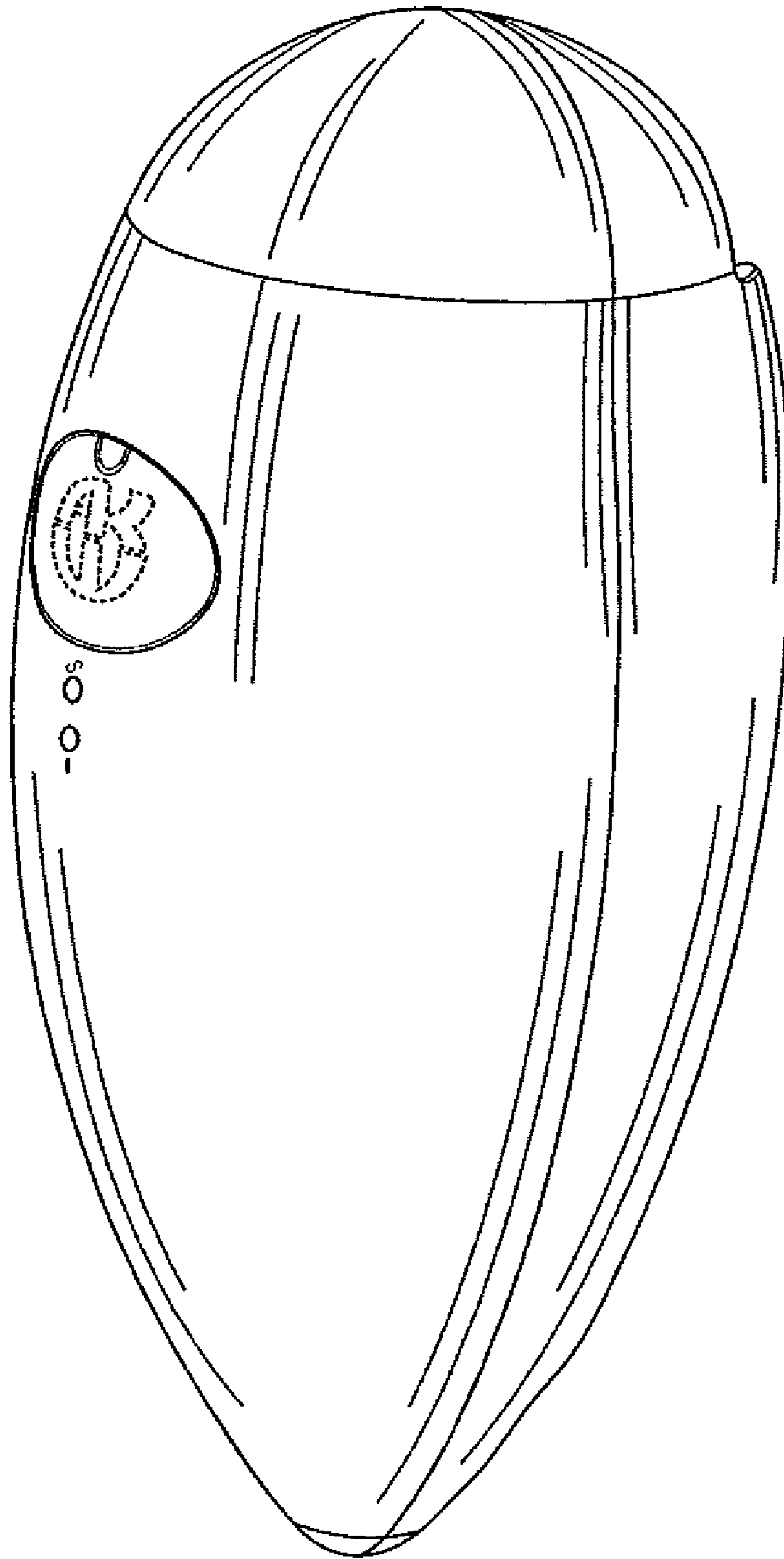

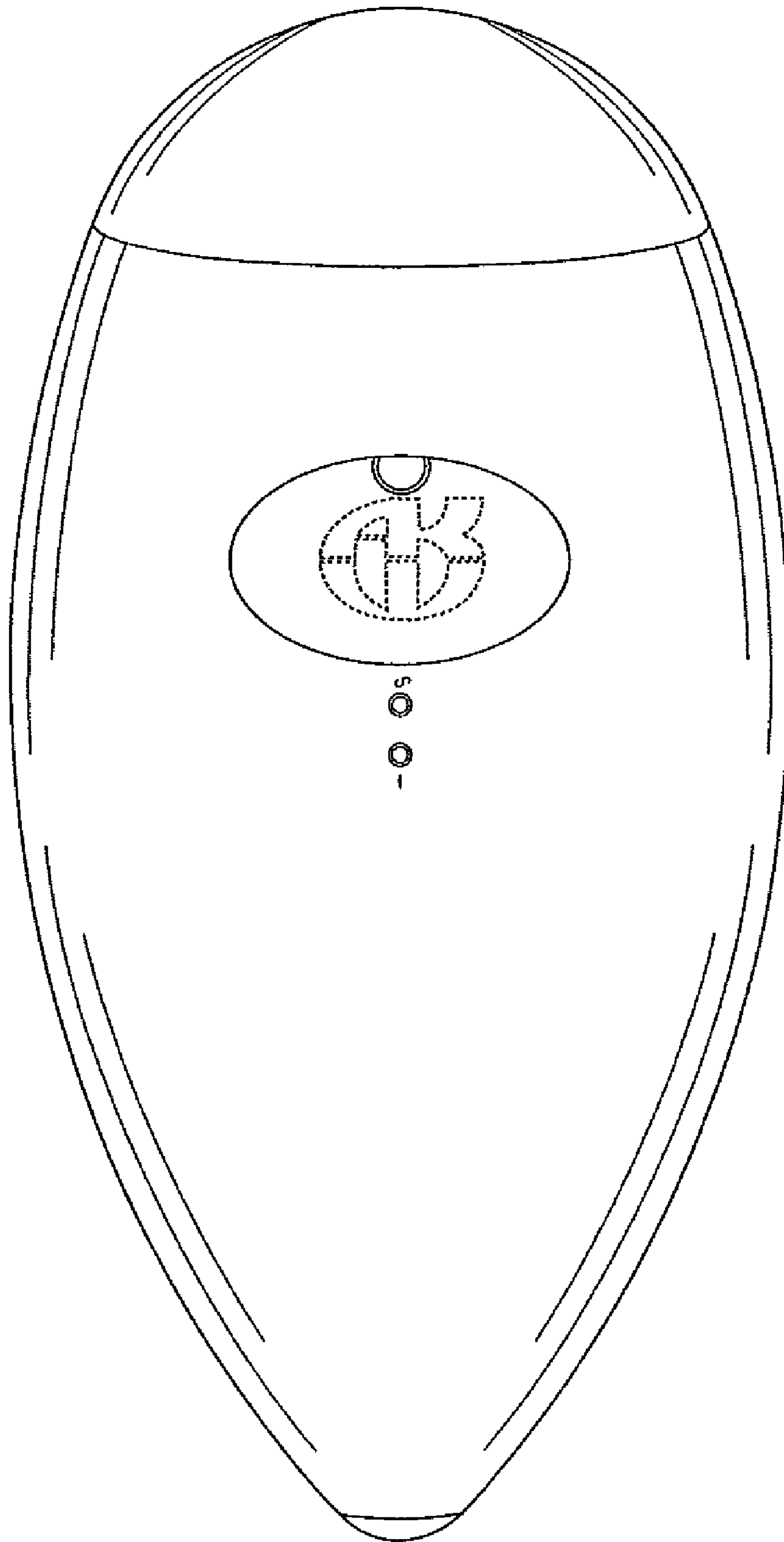

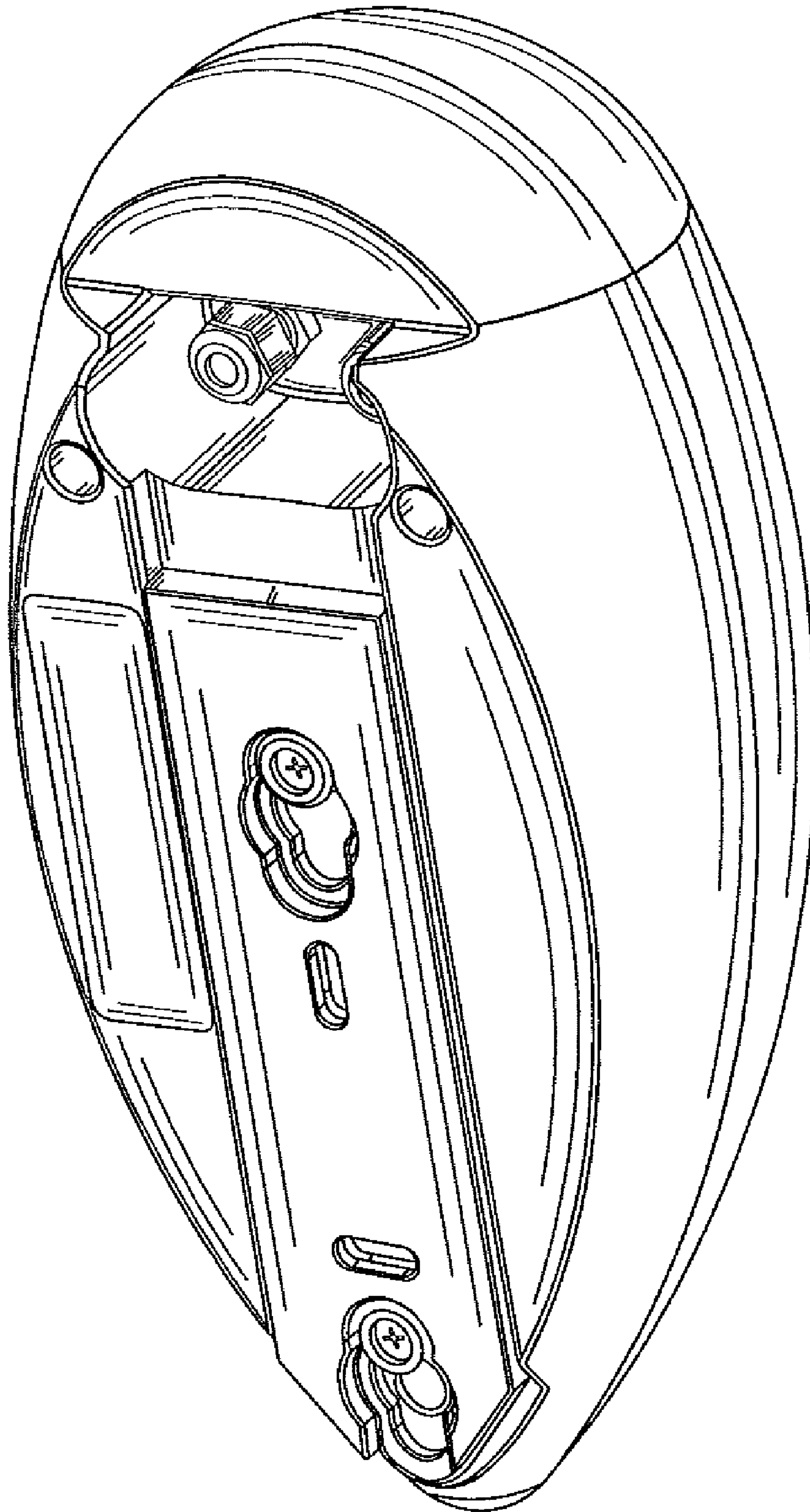

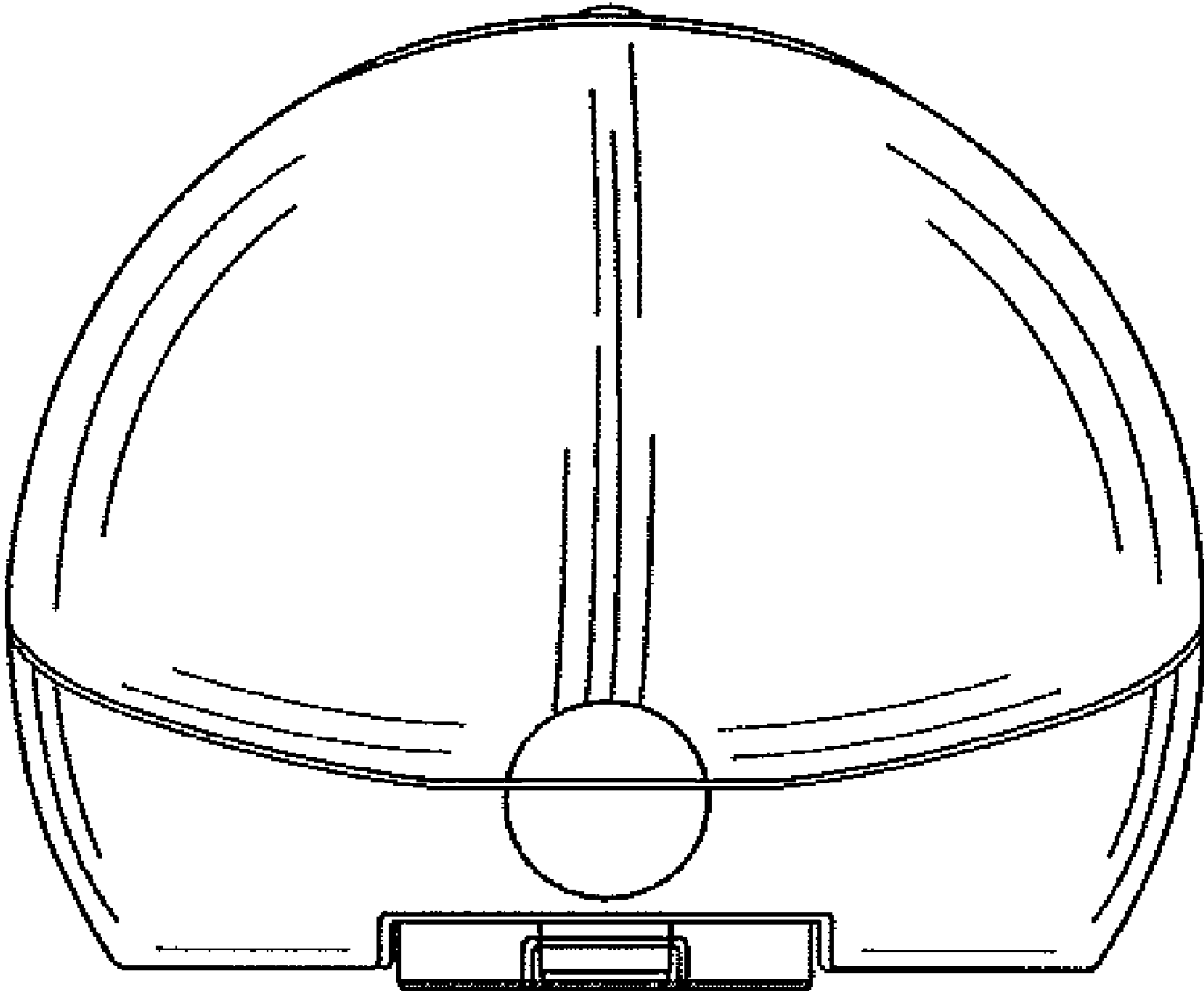
