(57) **CLAIM**

What is claimed is the ornamental design for a eye glasses made from spoons, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a eye glasses made from spoons, showing the new design;

FIG. 2 is a front elevational view thereof;


FIG. 3 is a rear elevational view thereof;

FIG. 4 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof; and,










