(57) **CLAIM**

The ornamental design for a handle for weight assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the handle for a weight assembly;

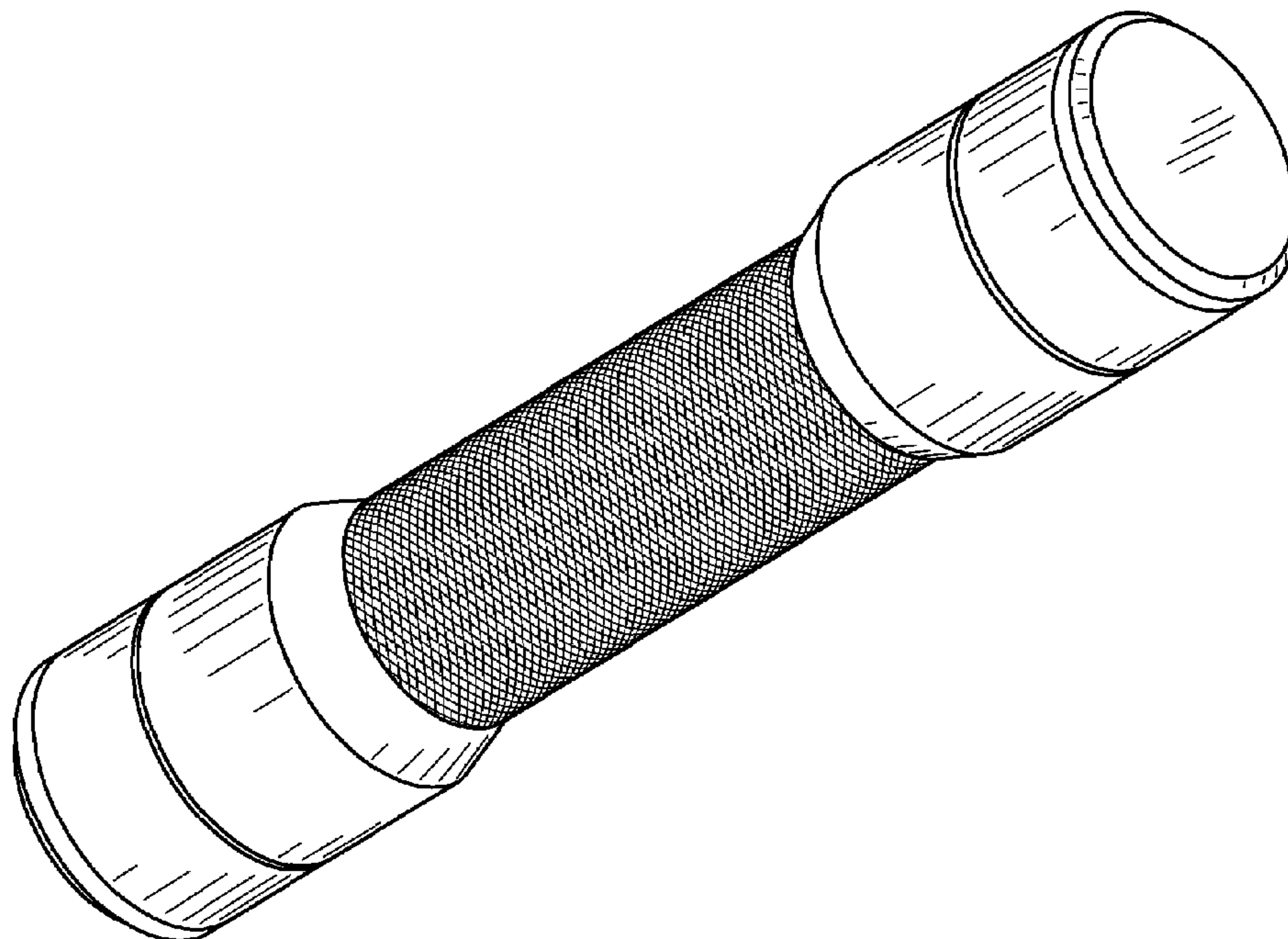
FIG. 2 is a front elevational view thereof, the rear elevational view, top plan view, and bottom plan view being identical to the front elevational view;

FIG. 3 is a left side elevational view thereof, the right side elevational view being identical to the left side elevational view; and,

FIG. 4 is a front elevational view thereof, showing the handle as part of a weight assembly.

The broken lines illustrate environmental structure which forms no part of the claimed design.

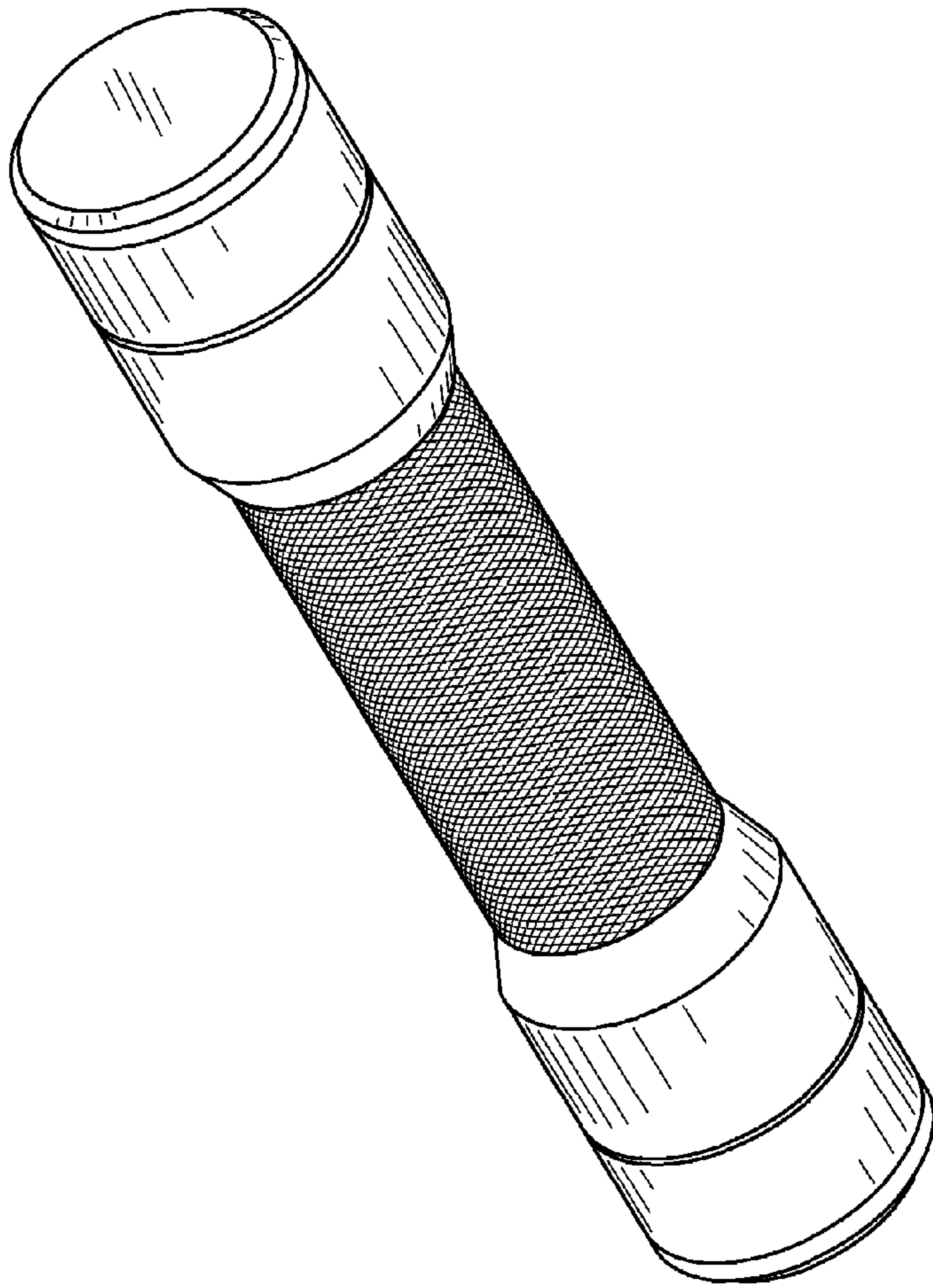

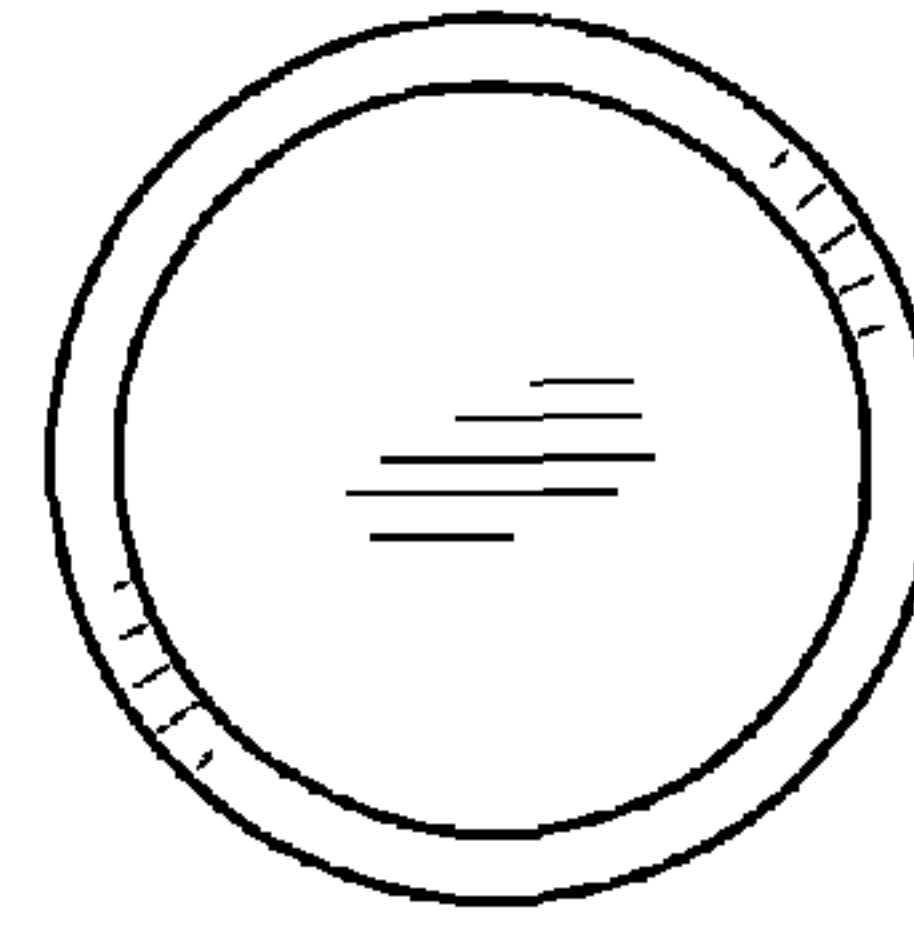

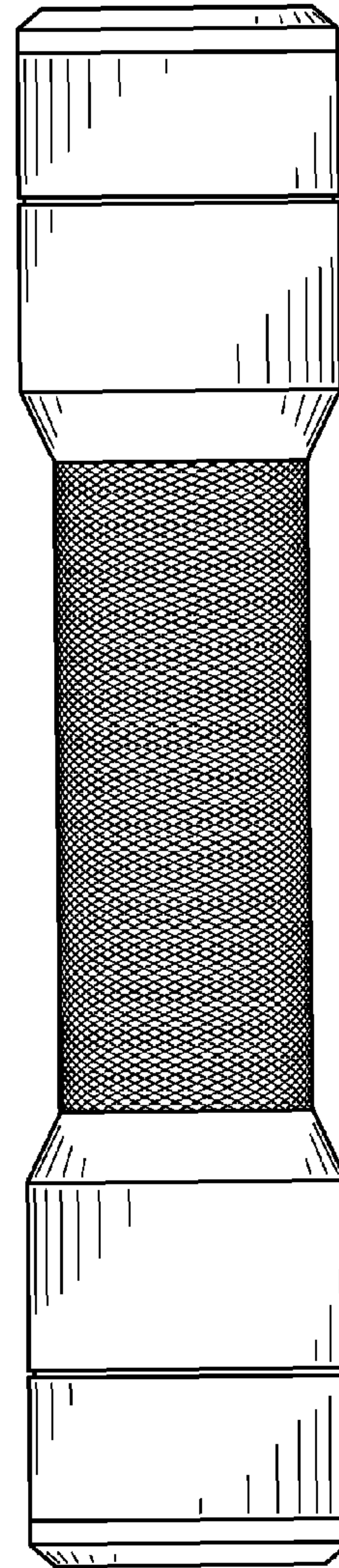

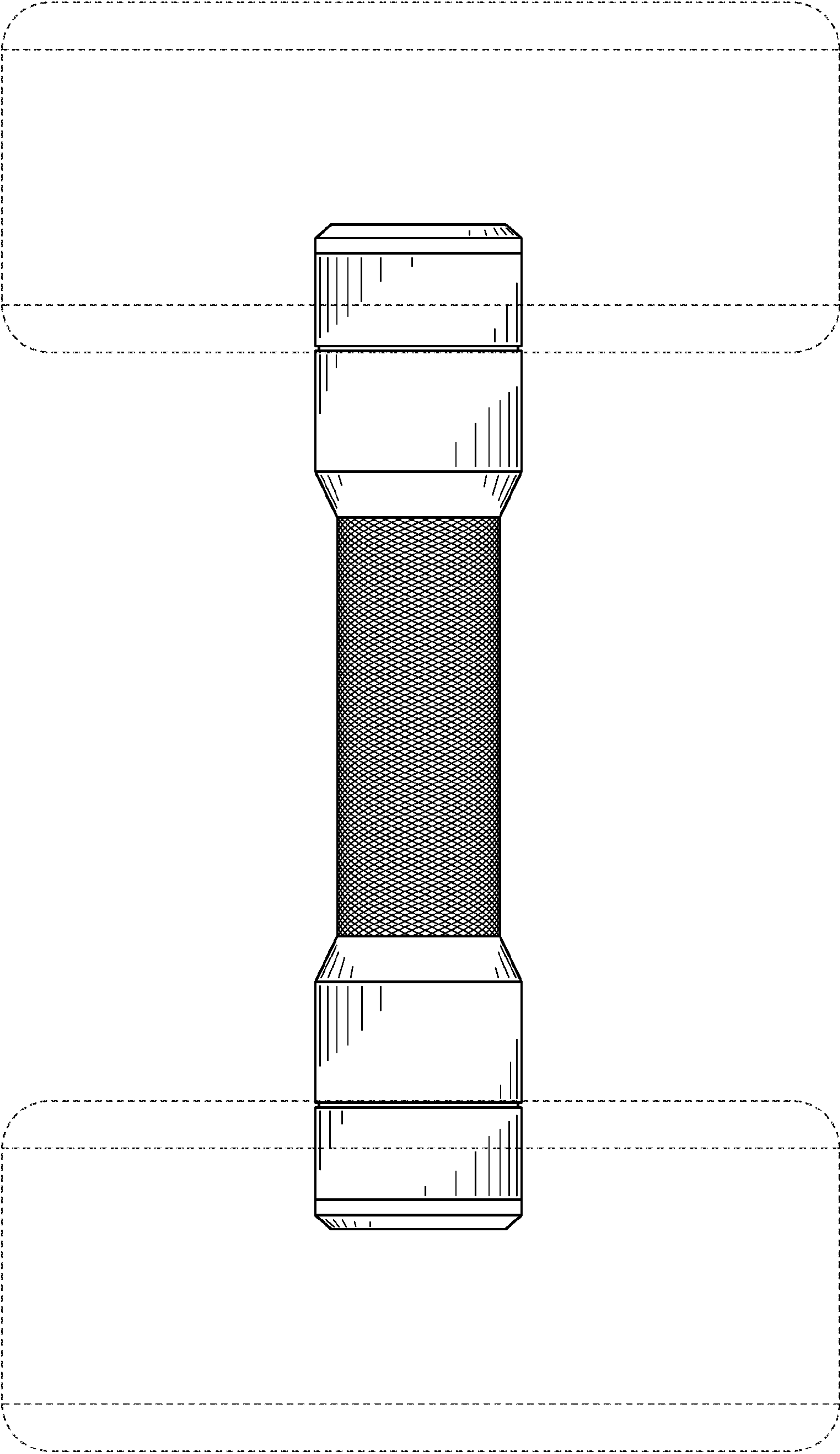
