**DESCRIPTION**

FIG. 4 is a right side elevation view of the massage apparatus of FIG. 1;

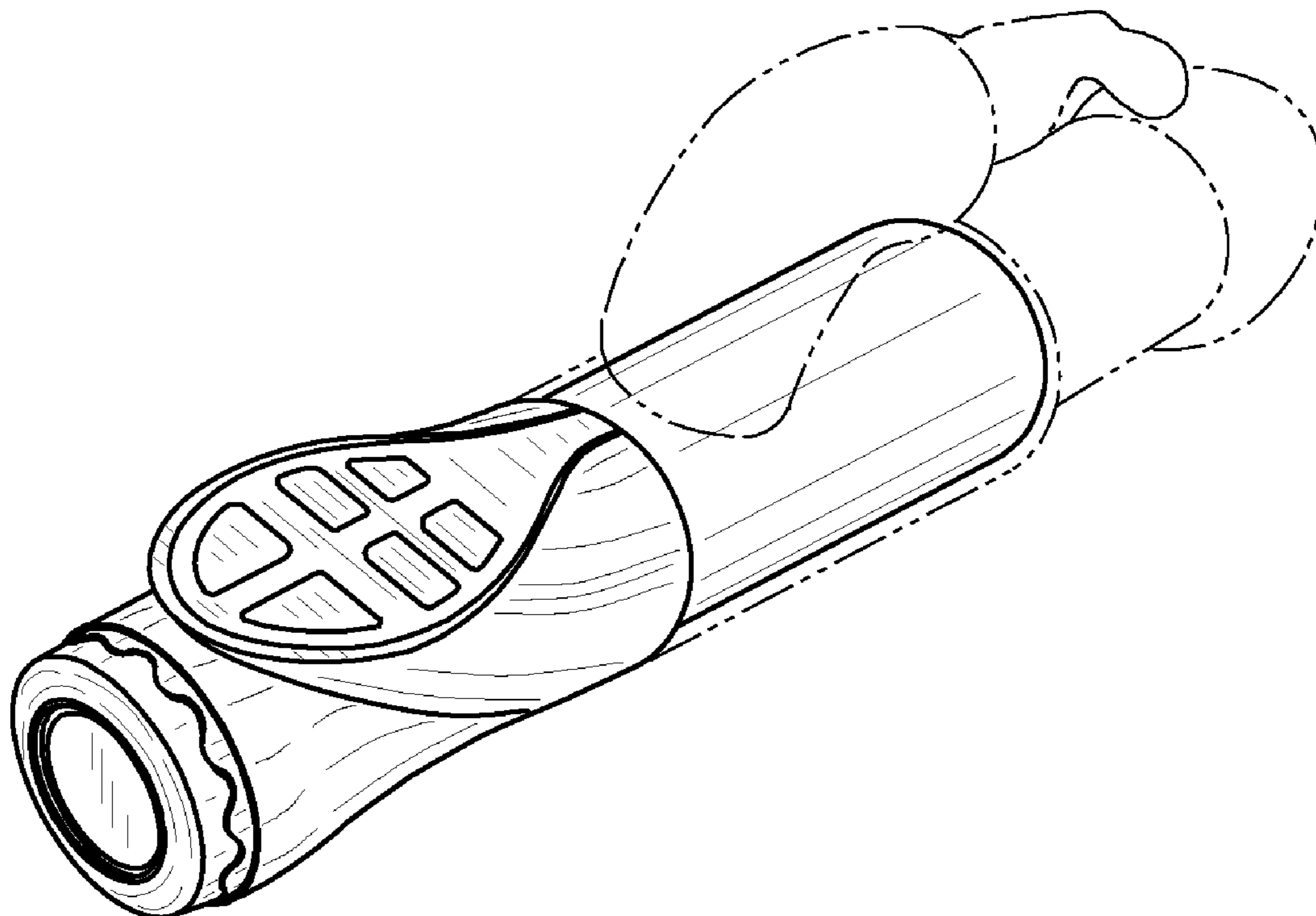
FIG. 5 is a left side elevation view of the massage apparatus of FIG. 1;

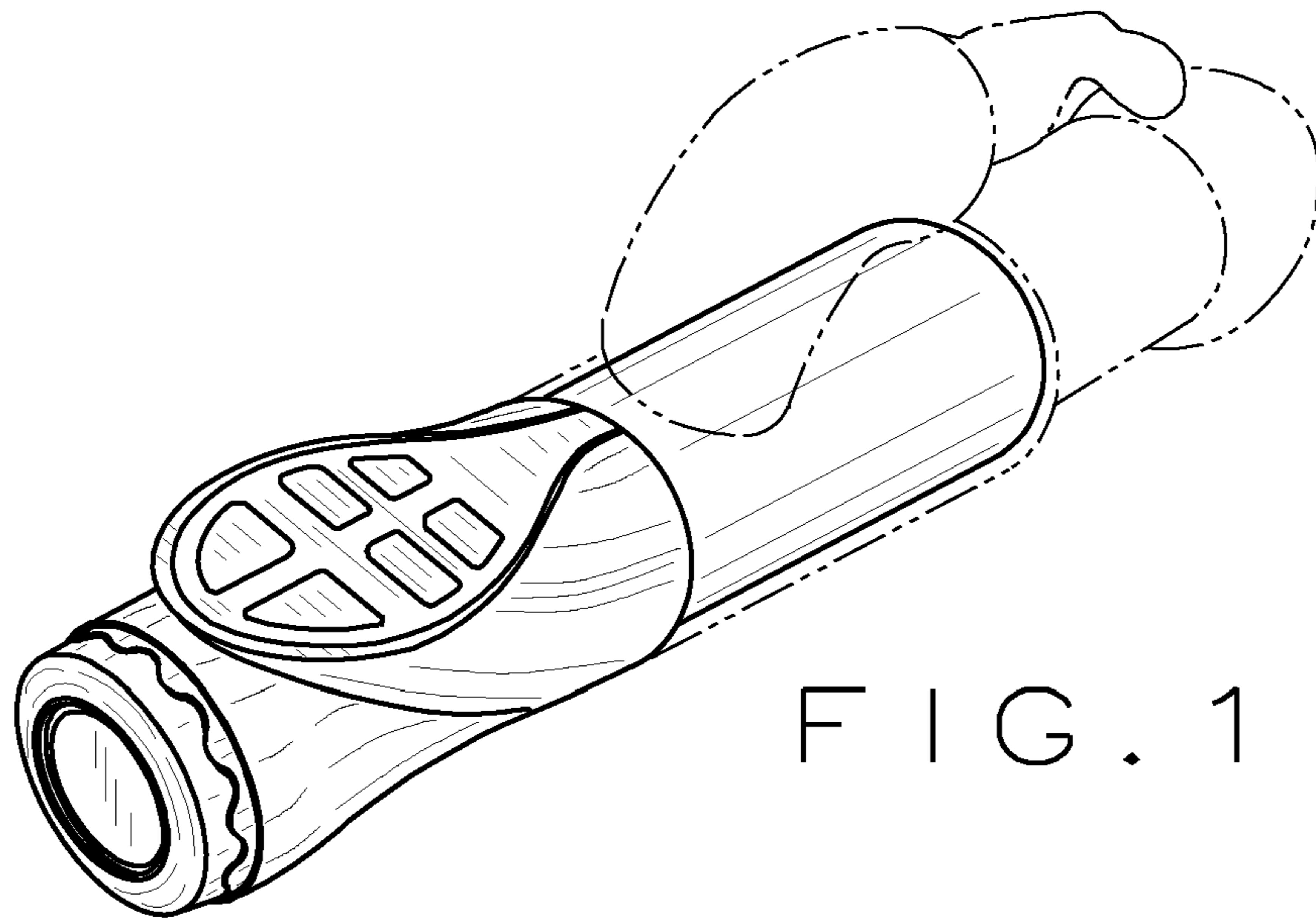

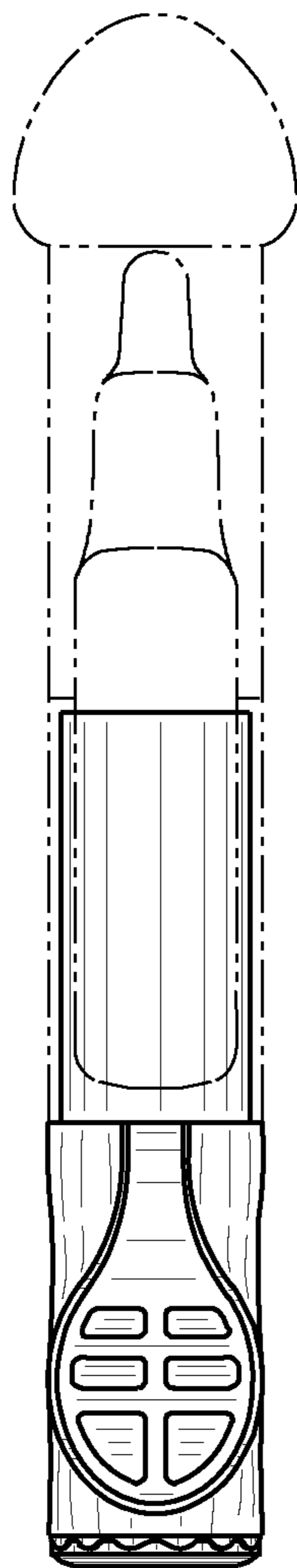

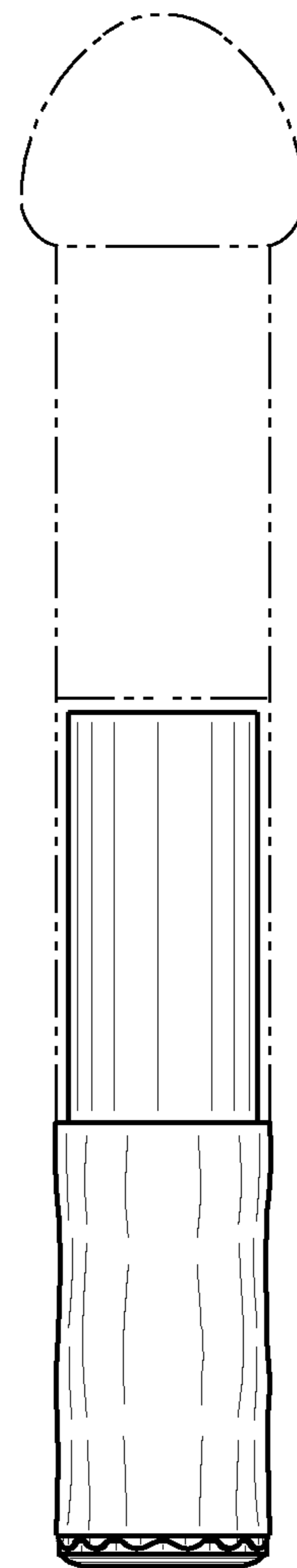

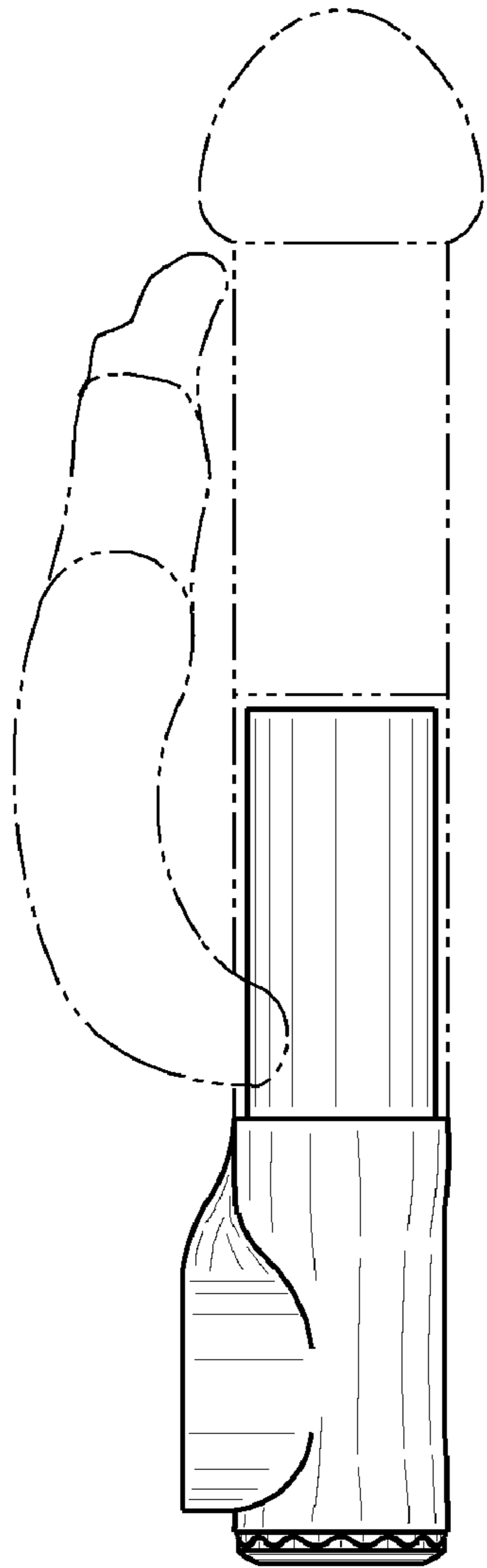

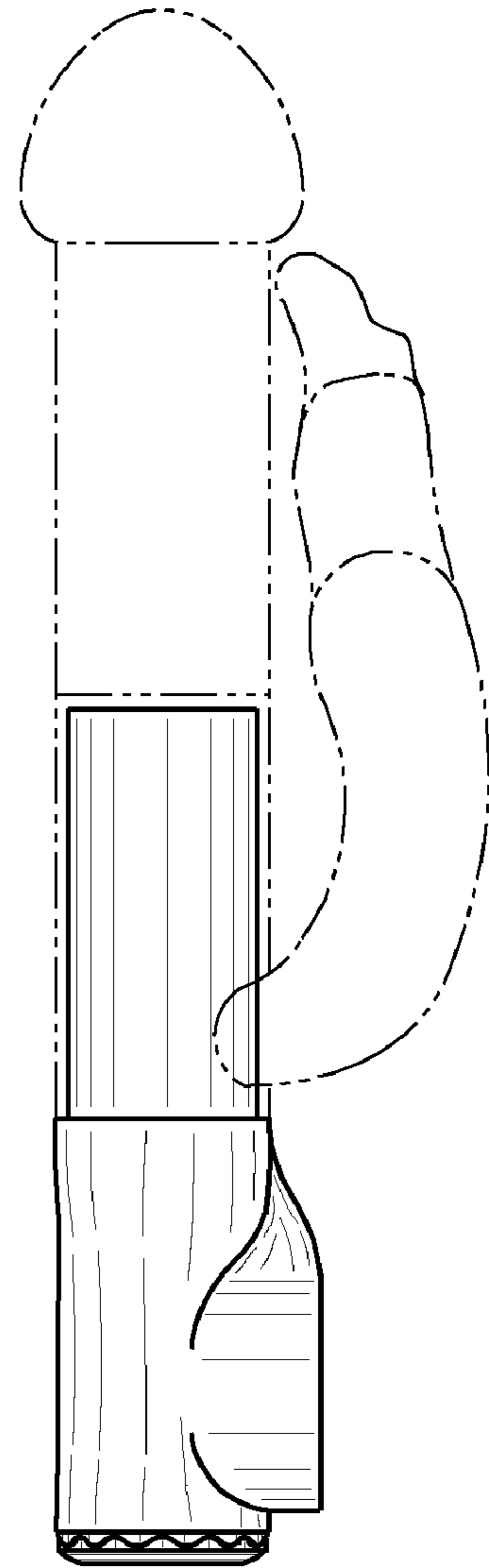

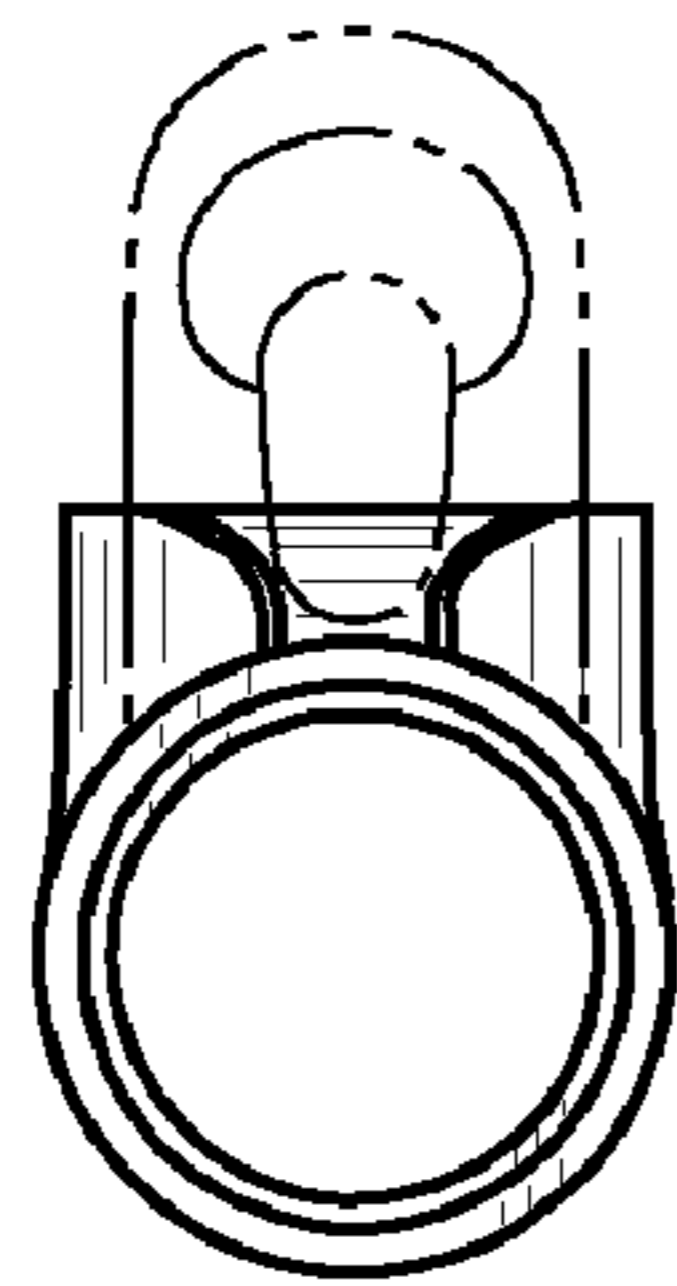

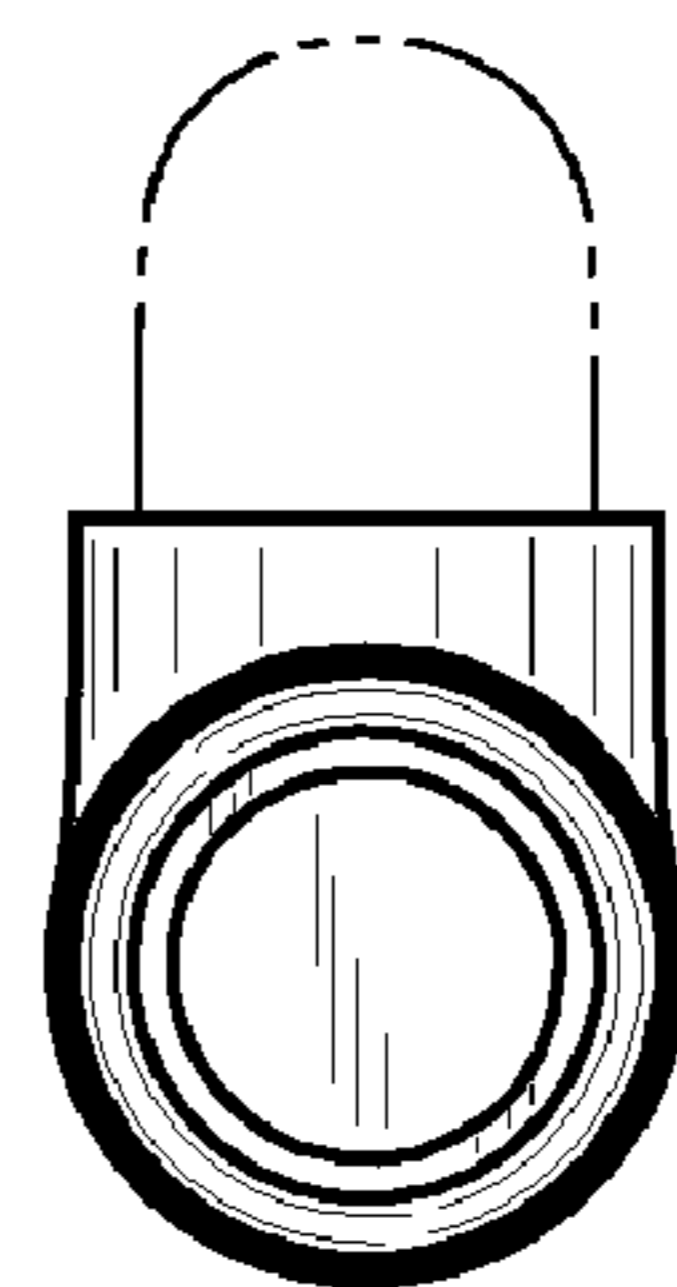
