(57) **CLAIM**

We claim, the ornamental design for a illuminating headlamp, as shown and described.

**DESCRIPTION**

FIG. 1 is an enlarged top, front, right side perspective view of the lamp portion of the design of FIG. 2 shown with the head strap removed;

FIG. 2 is a top, front, right side perspective view of an illuminated headlamp showing our new design;

FIG. 3 is a front elevational view thereof;

FIG. 4 is a rear elevational view thereof;

FIG. 5 is a right side elevational view thereof the left side elevation view thereof being a mirror image;

FIG. 6 is a top plan view thereof; and

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a front elevational view of the headlamp portion of the design of FIG. 2 shown with the head strap removed;

FIG. 9 is a rear elevational view thereof;

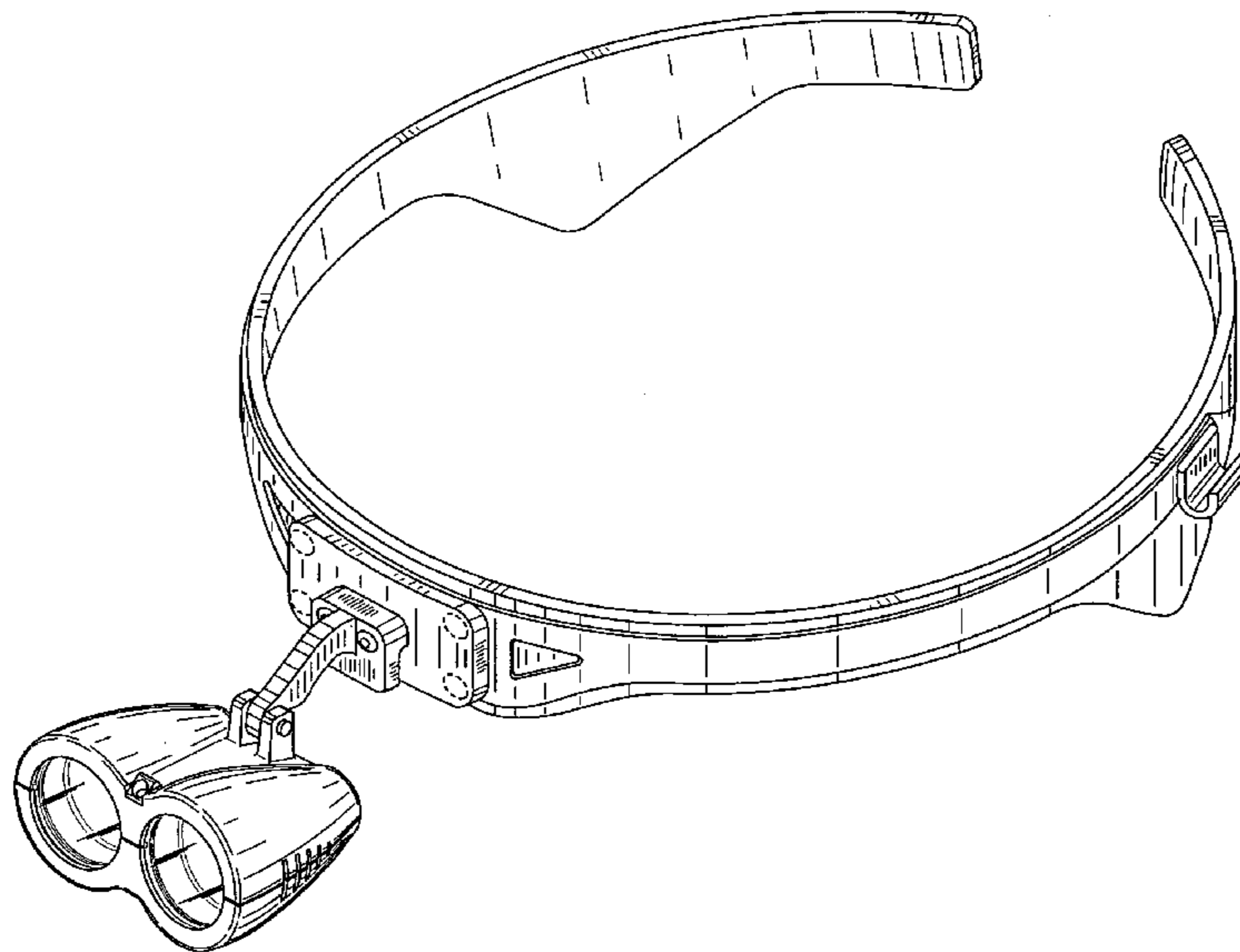
FIG. 10 is a right side elevational view thereof, the left side elevational view being a mirror image;

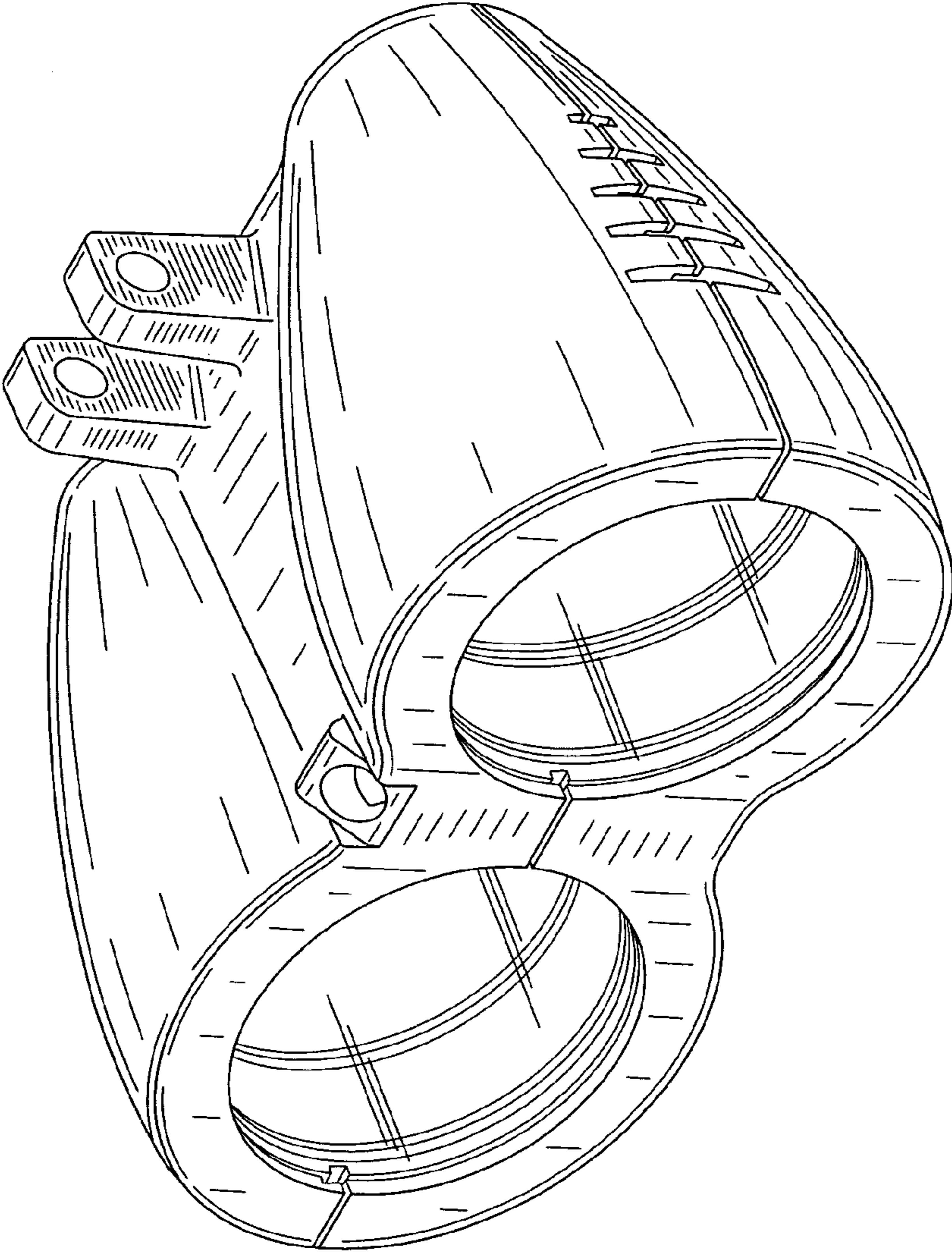

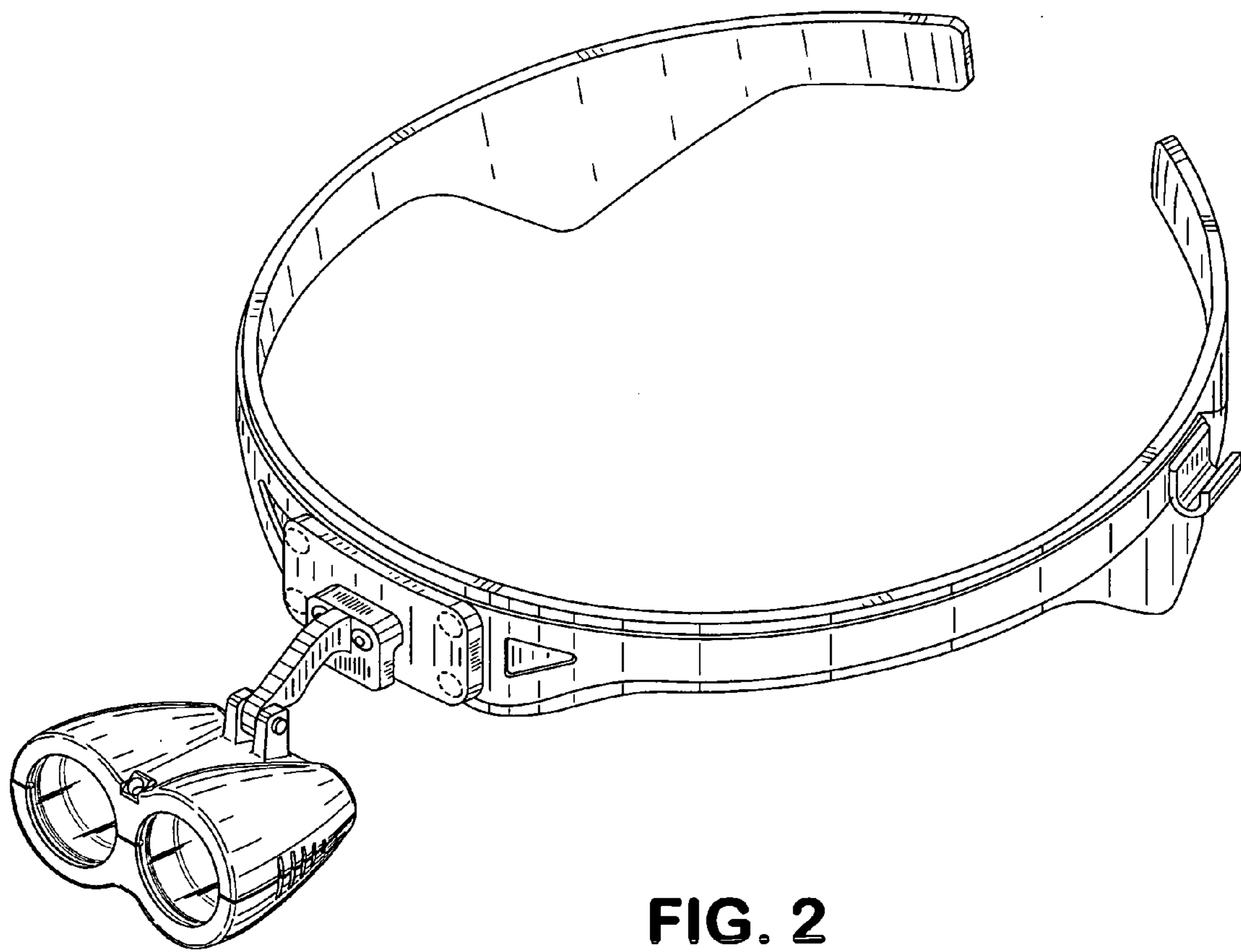
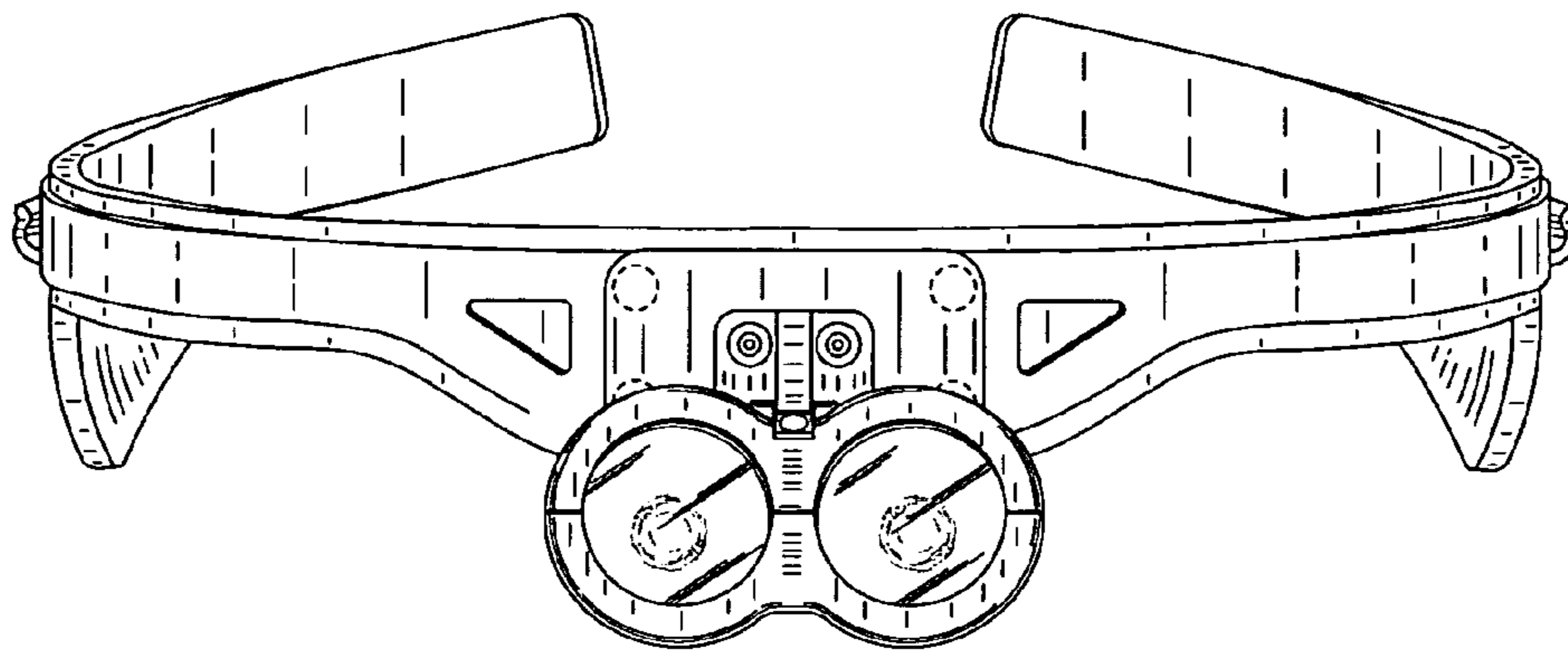
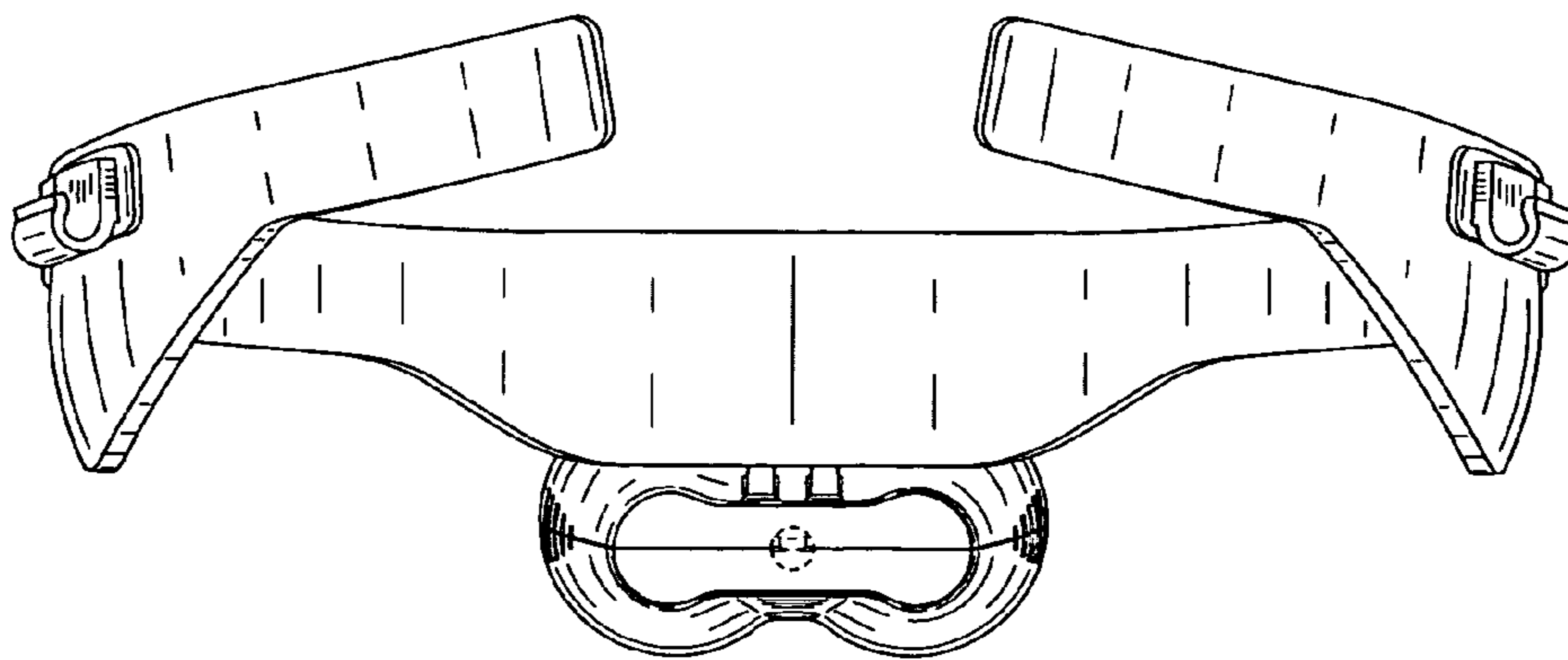

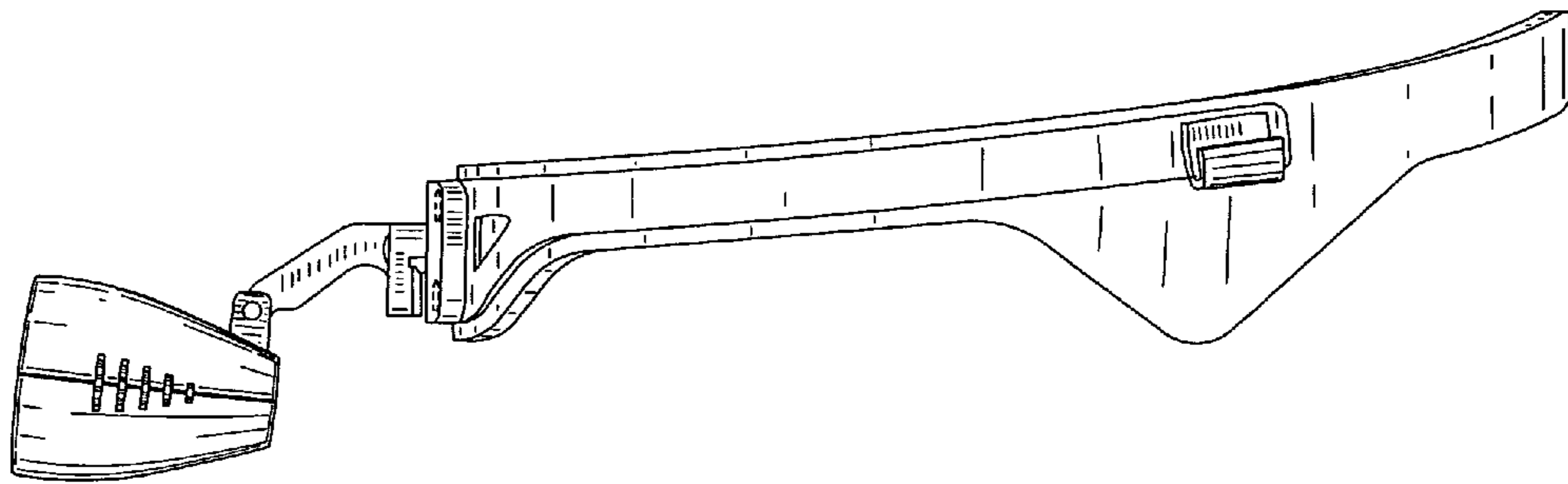

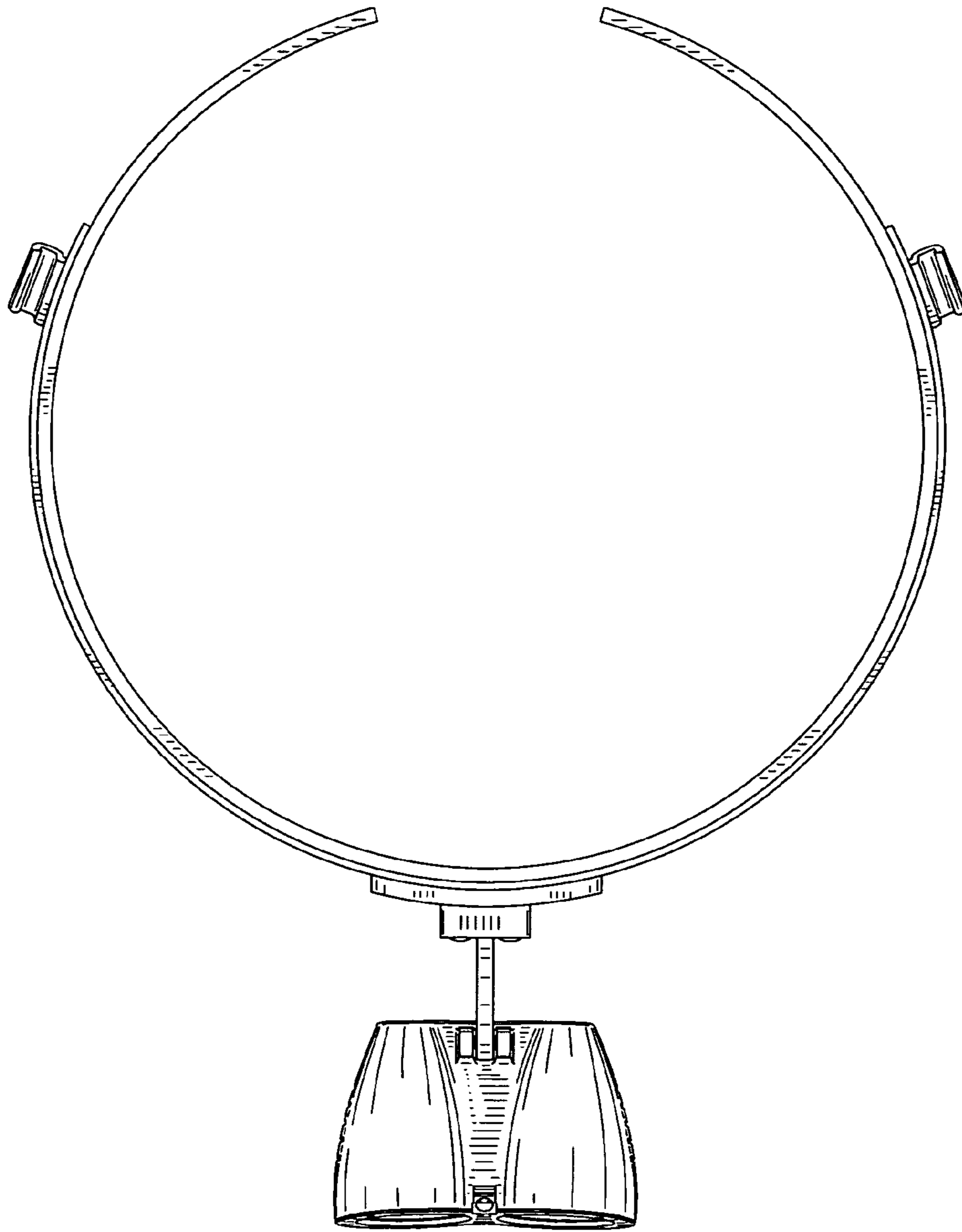
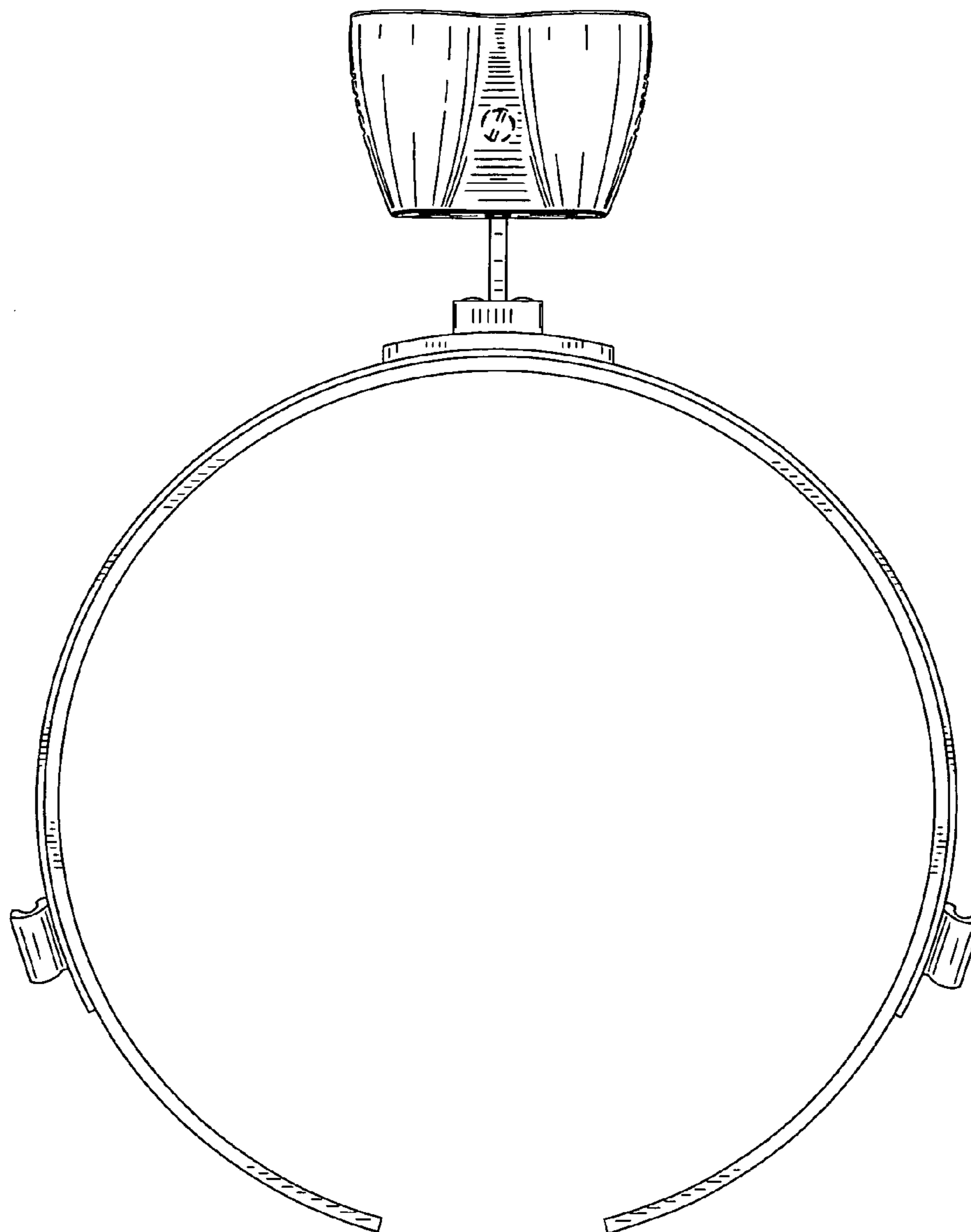

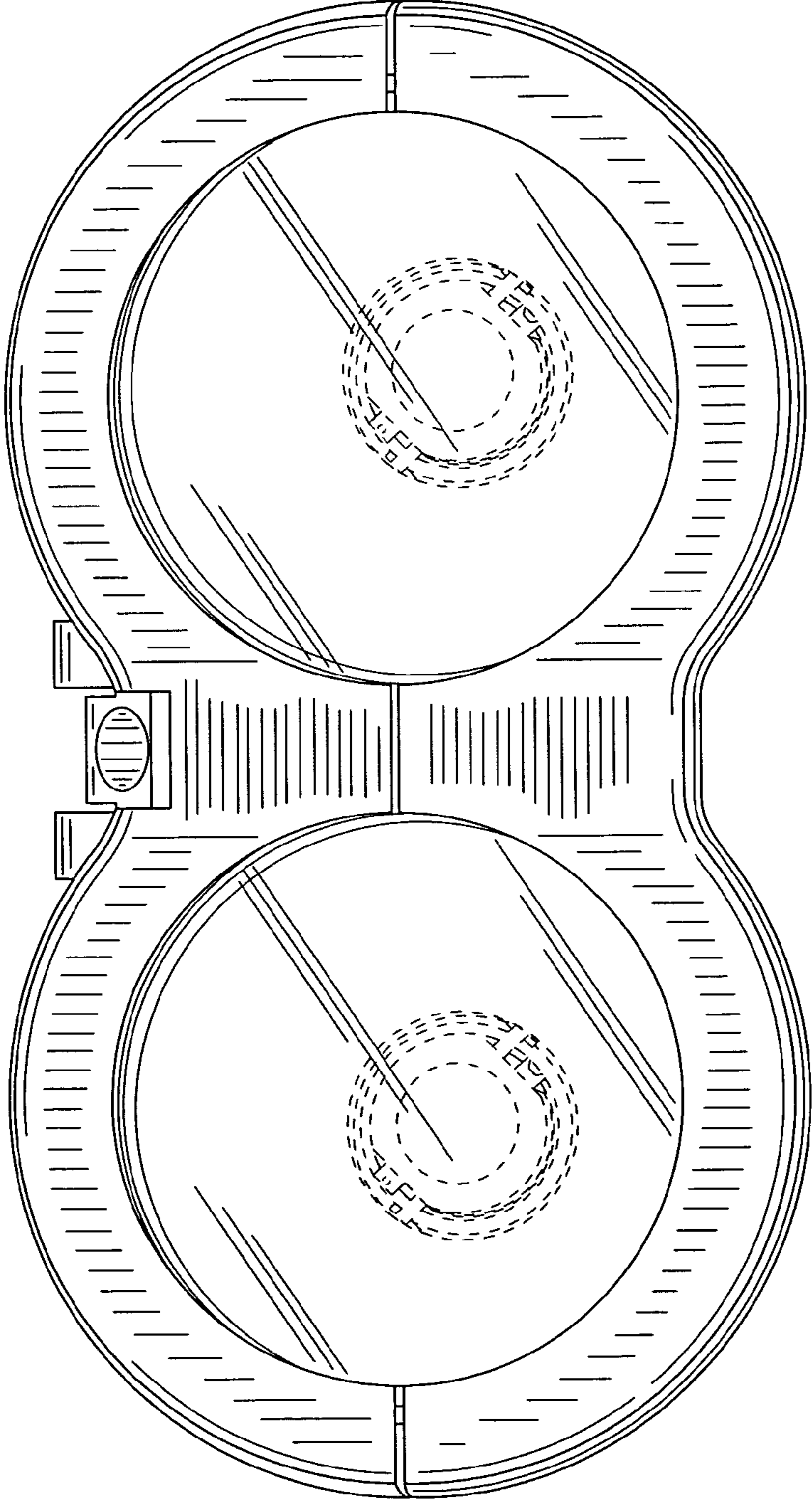

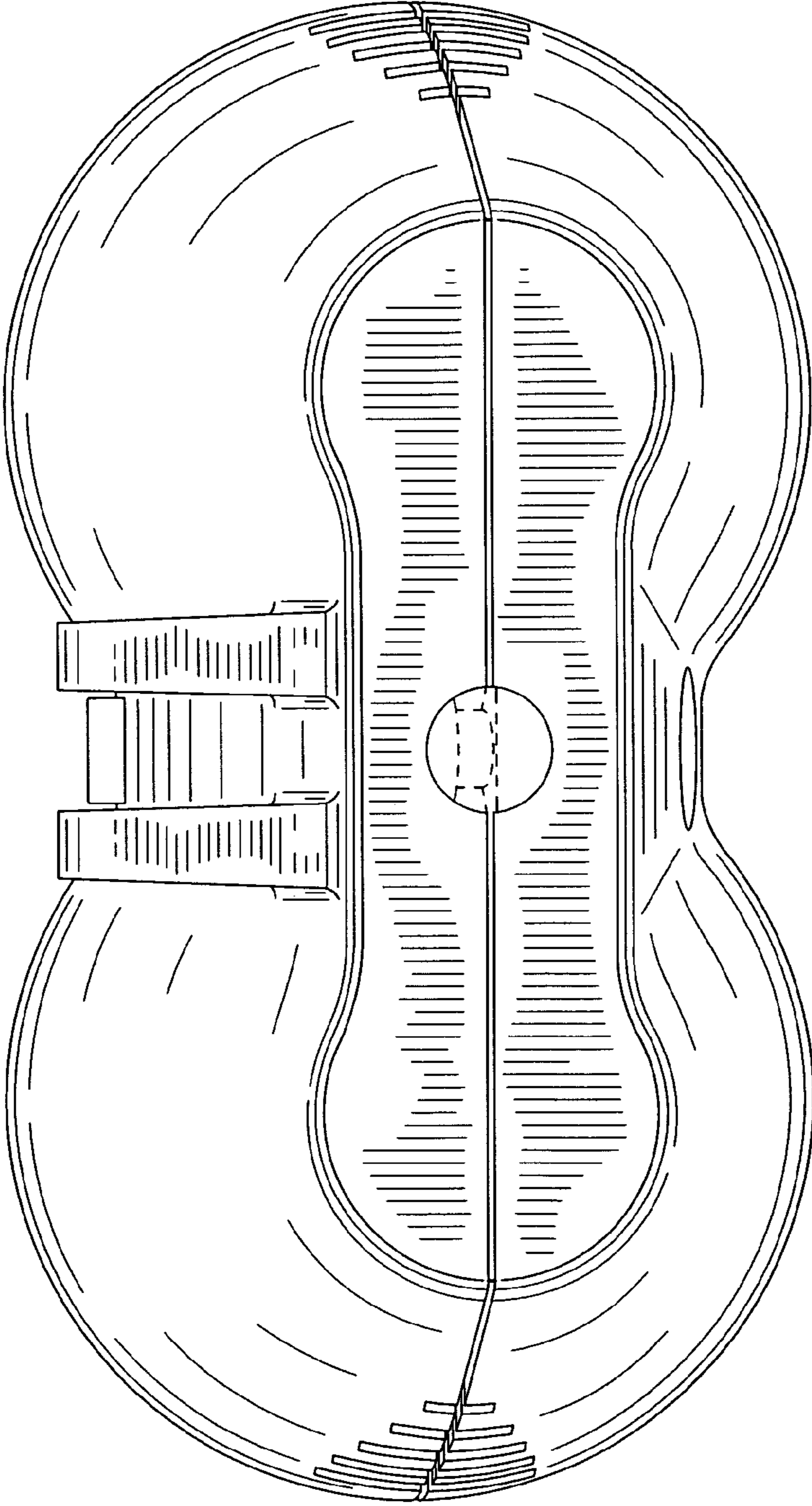

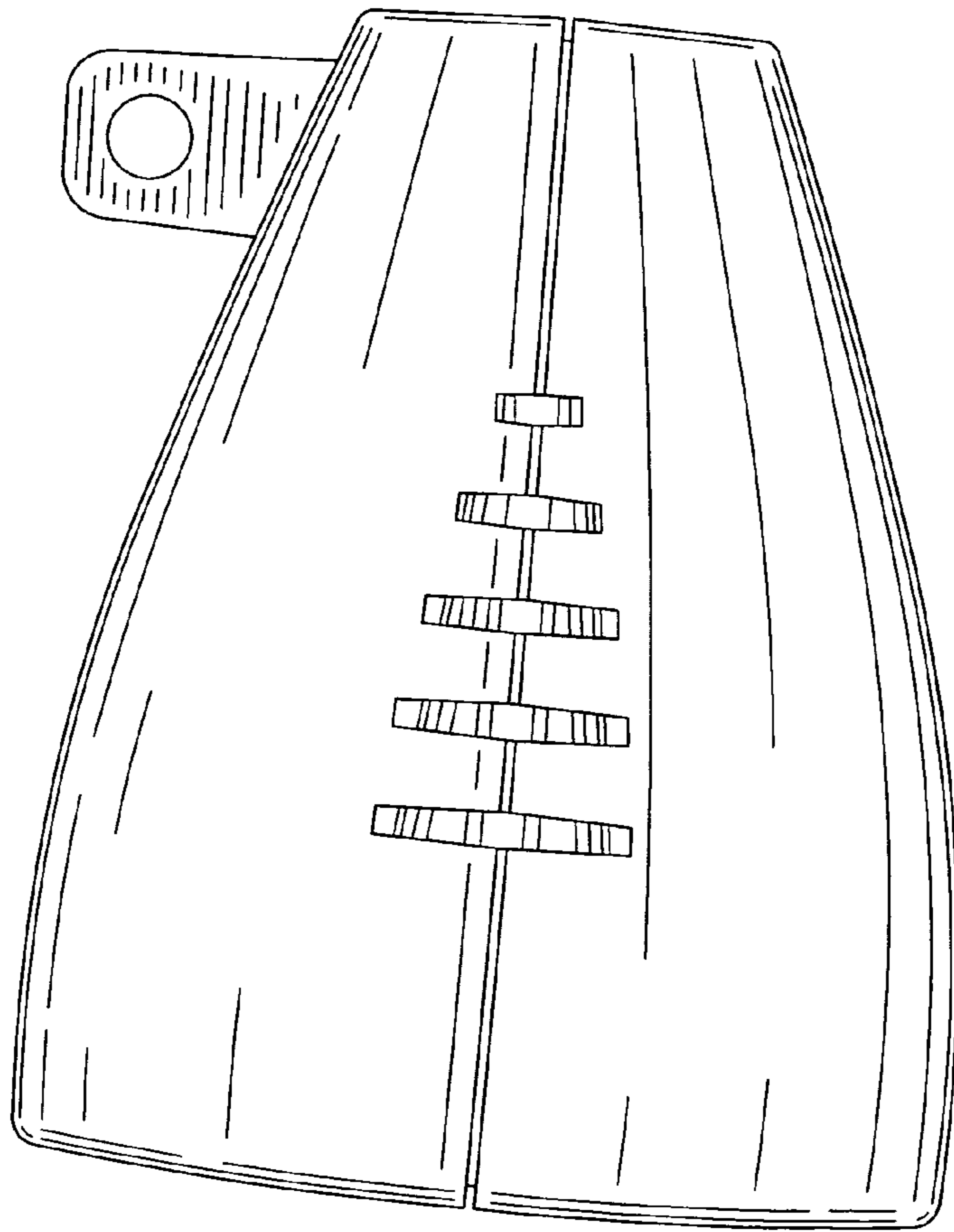

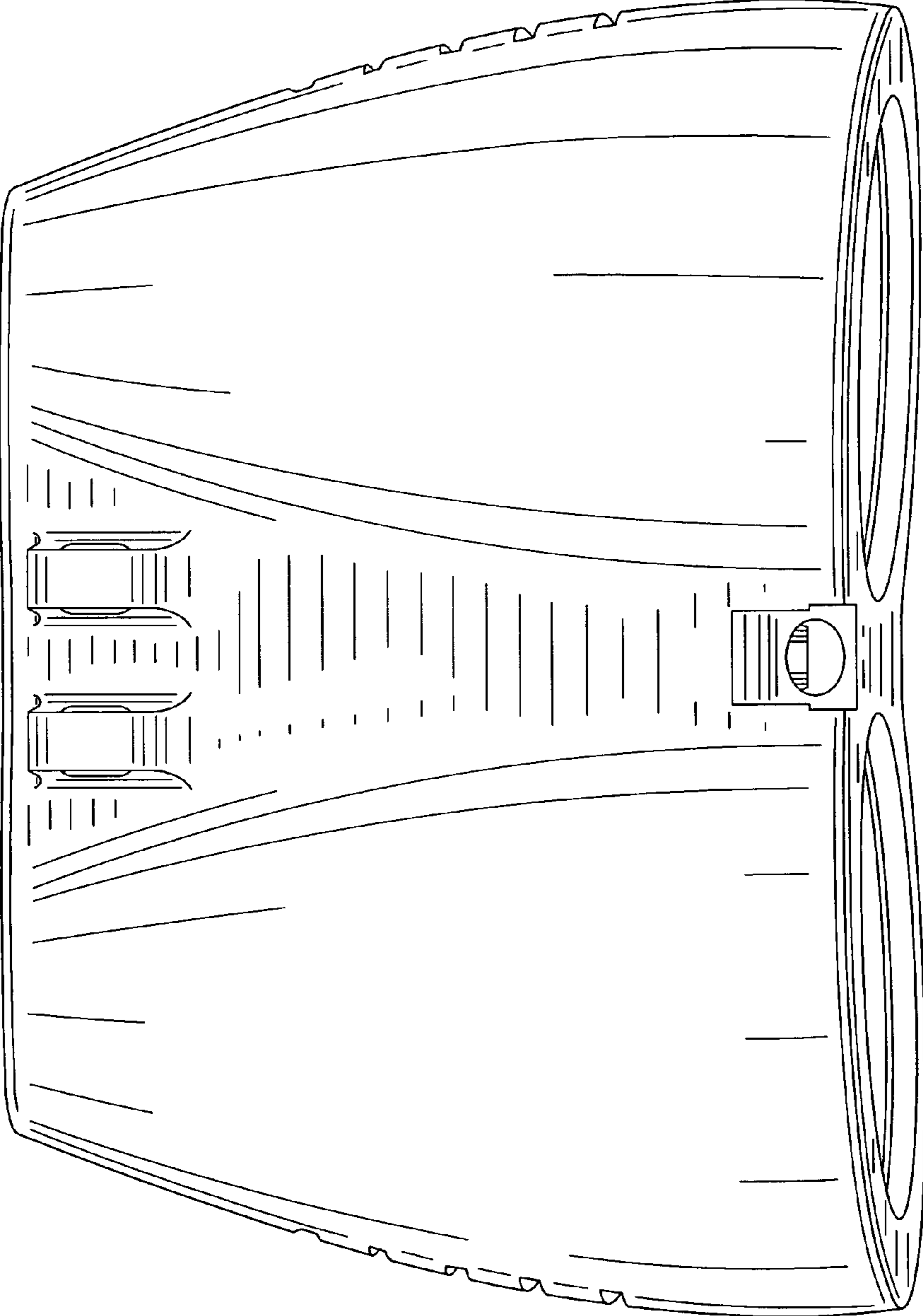

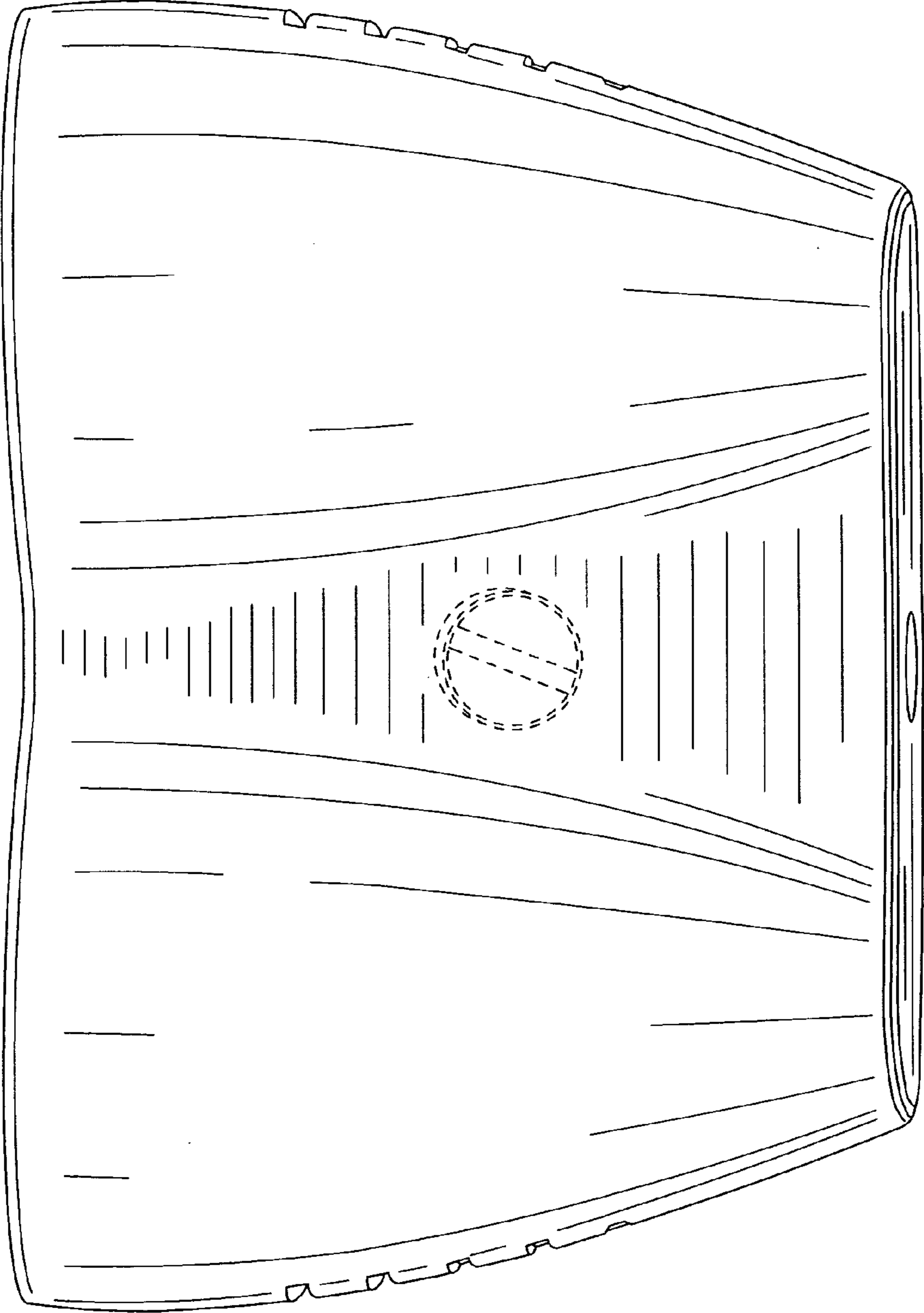
