FIG. 8 is a left side view thereof;

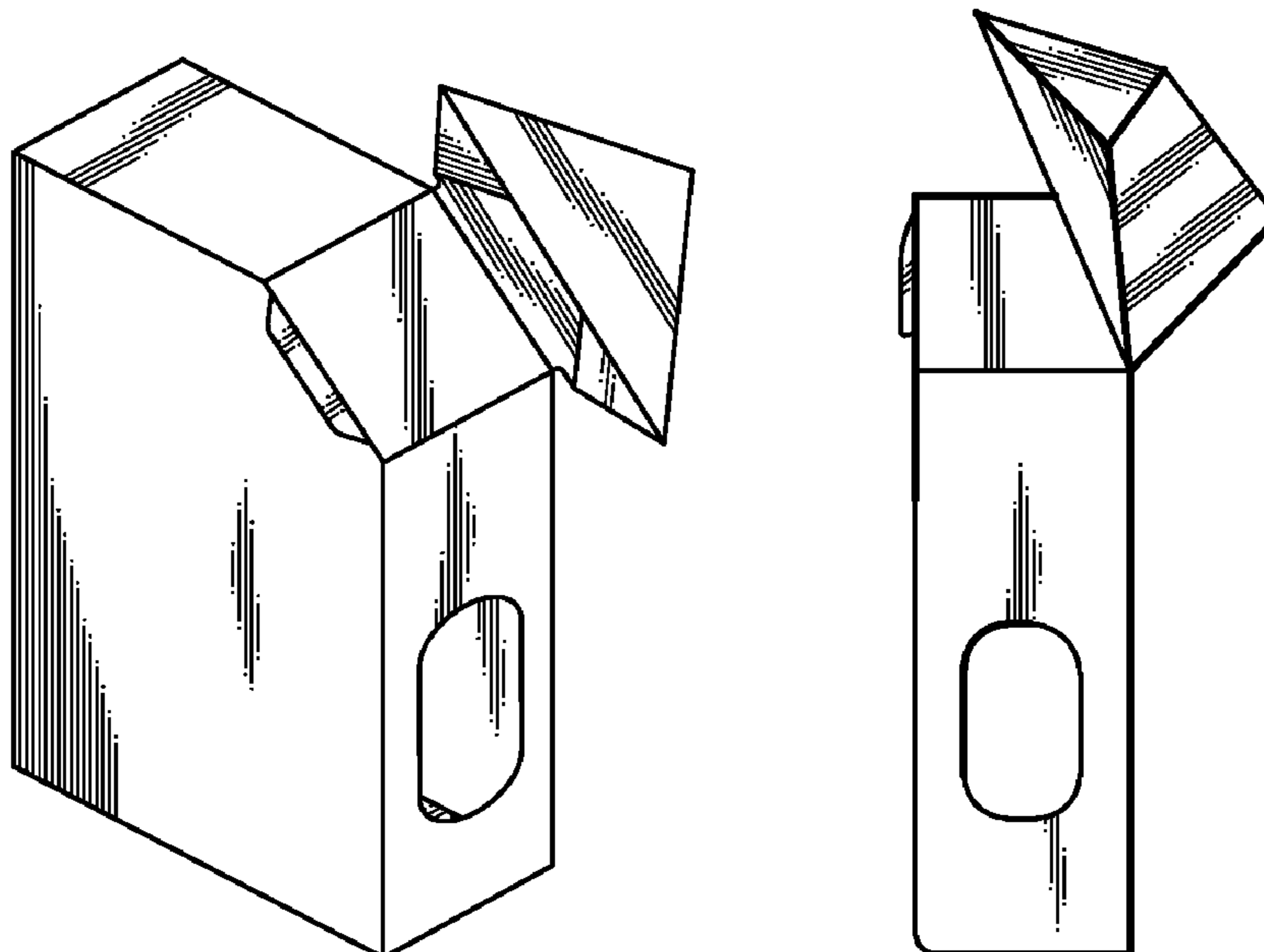
FIG. 9 is a top view thereof;

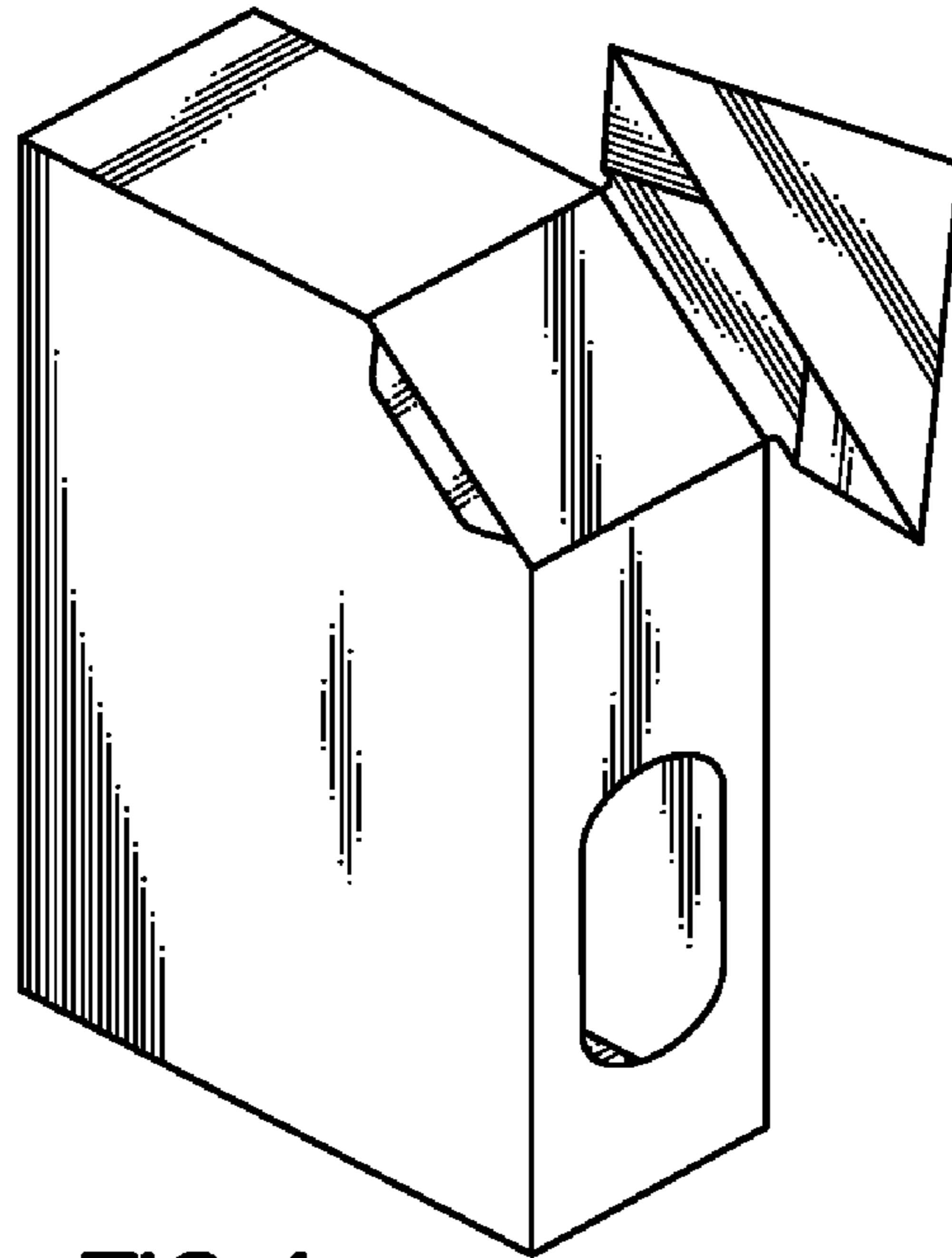
FIG. 10 is a bottom view thereof; and,

FIG. 11 is a right side view thereof with top open.

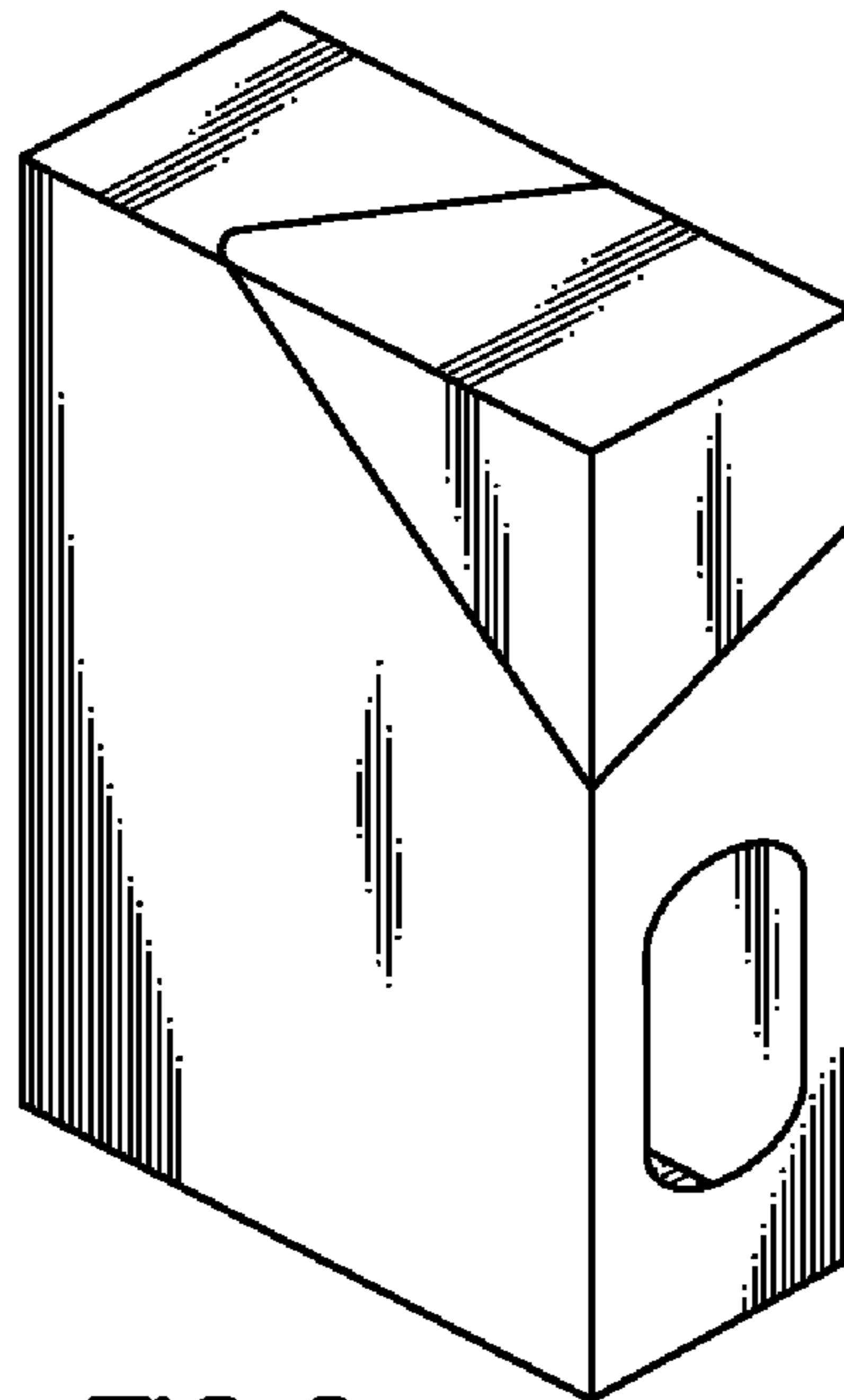
The broken lines in FIG. 3 and FIG. 8 are included for the purpose of illustrating a portion of the interior lines that forms no part of the claimed design.

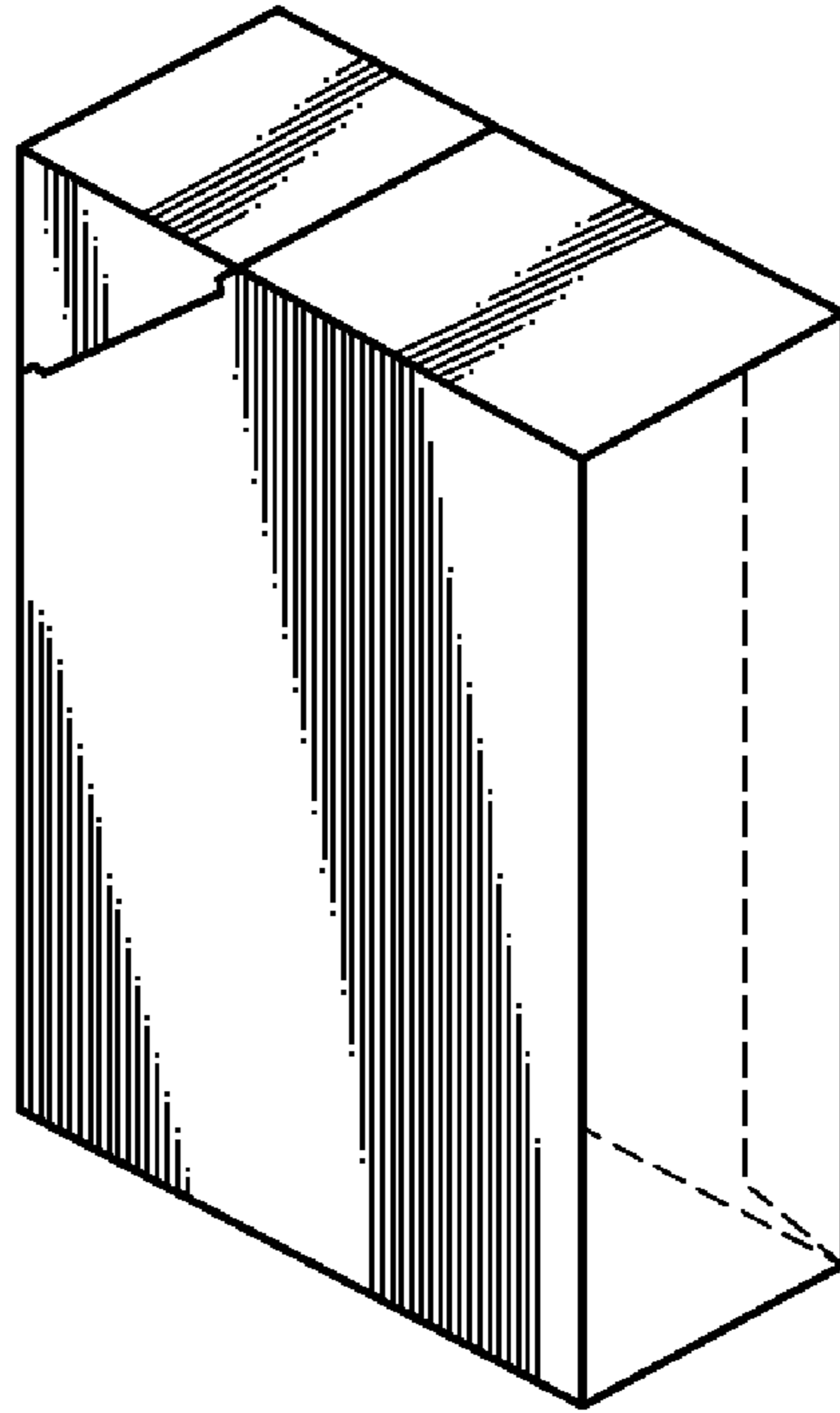

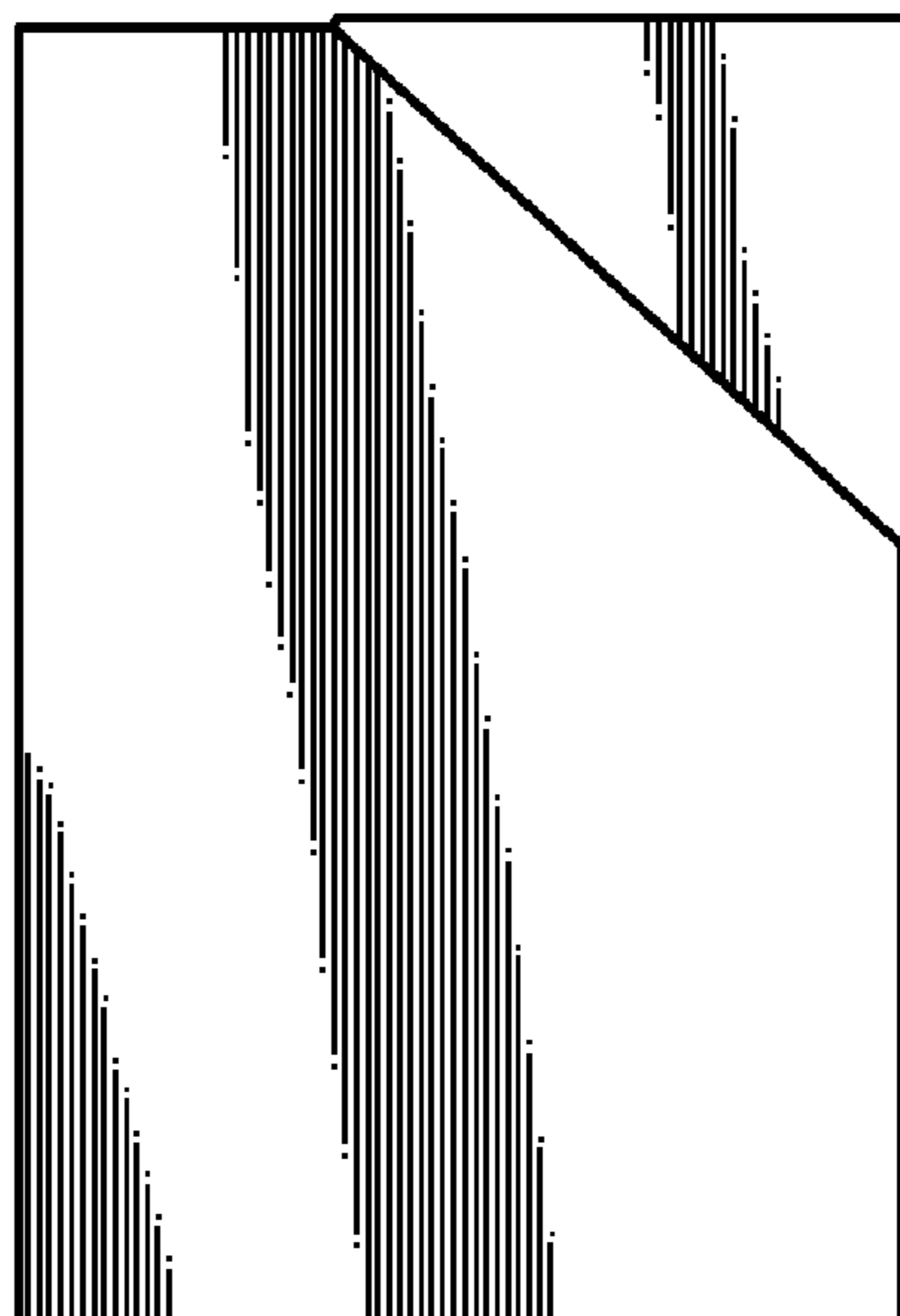

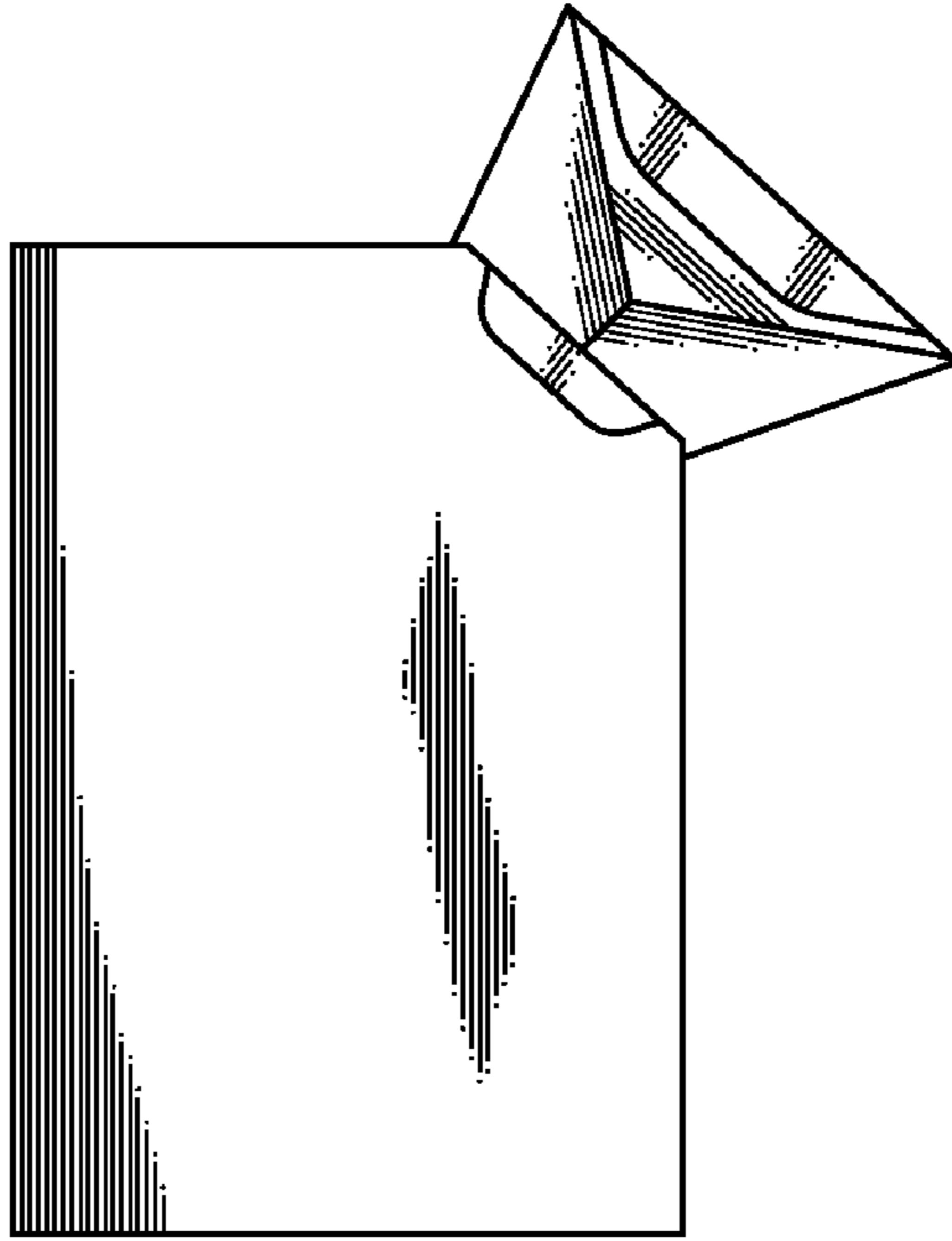

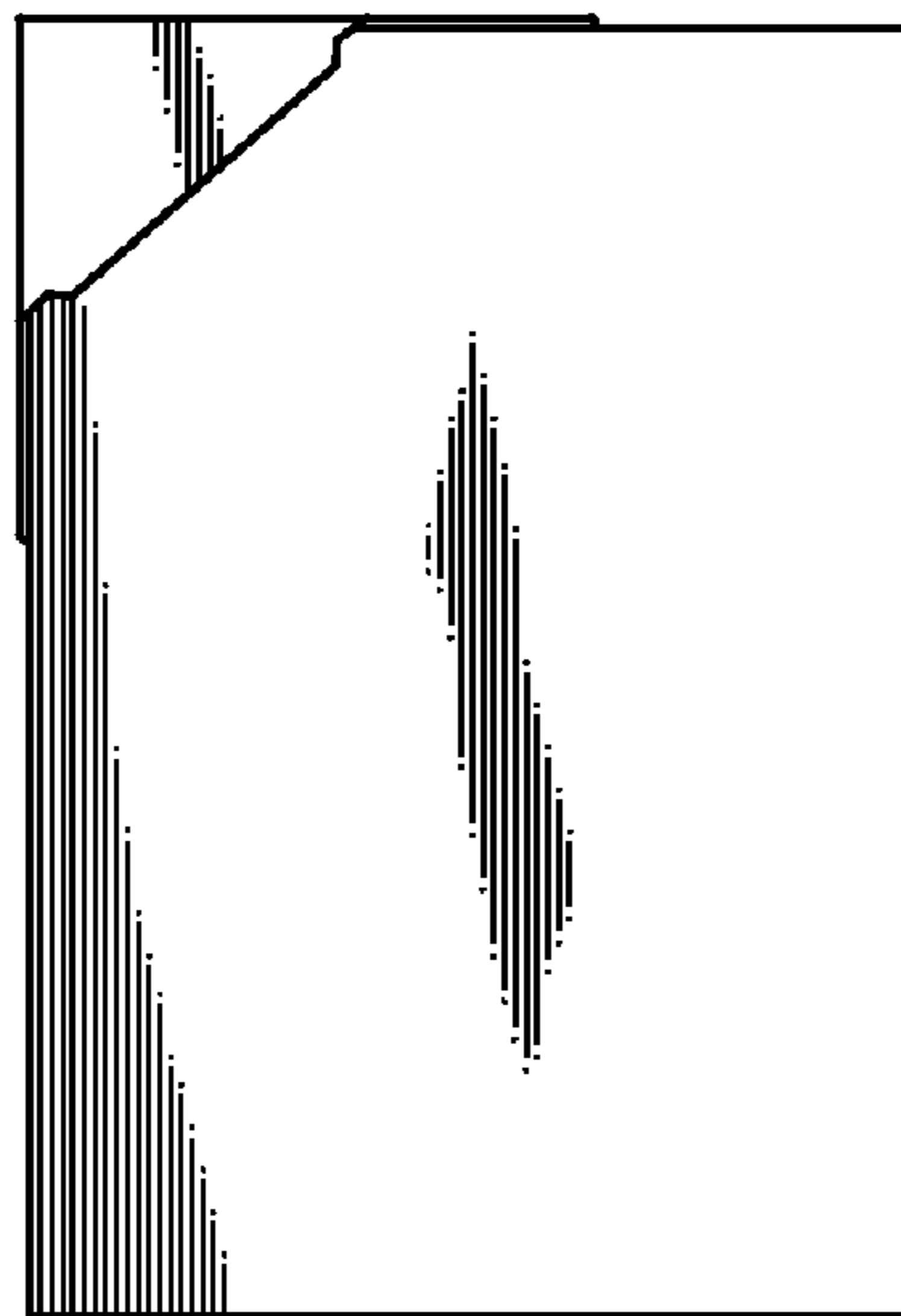
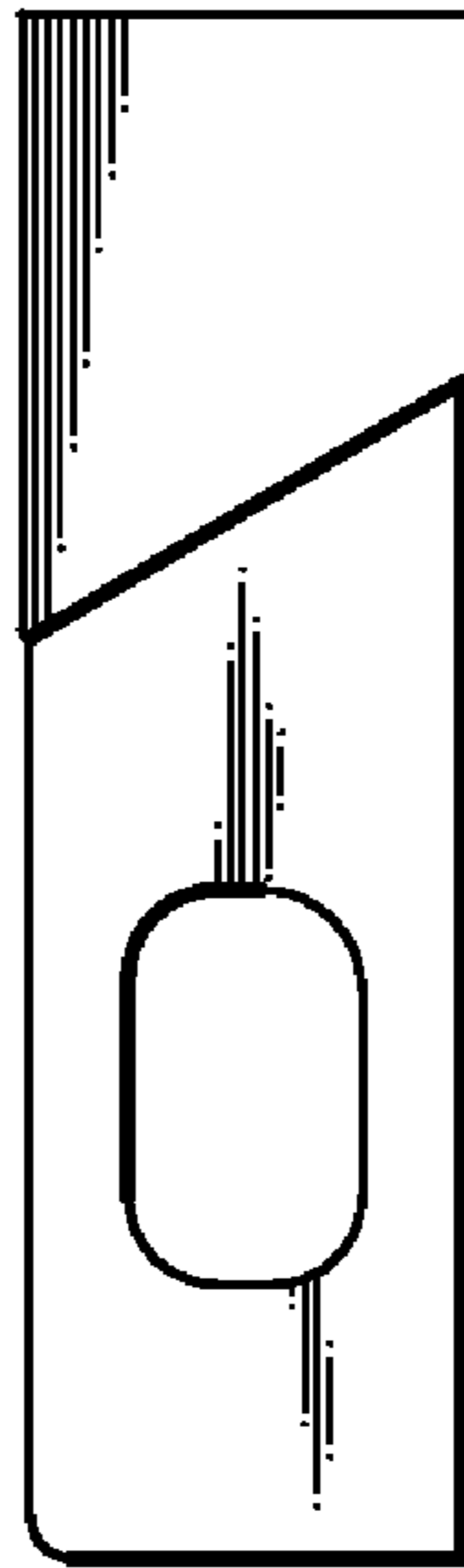
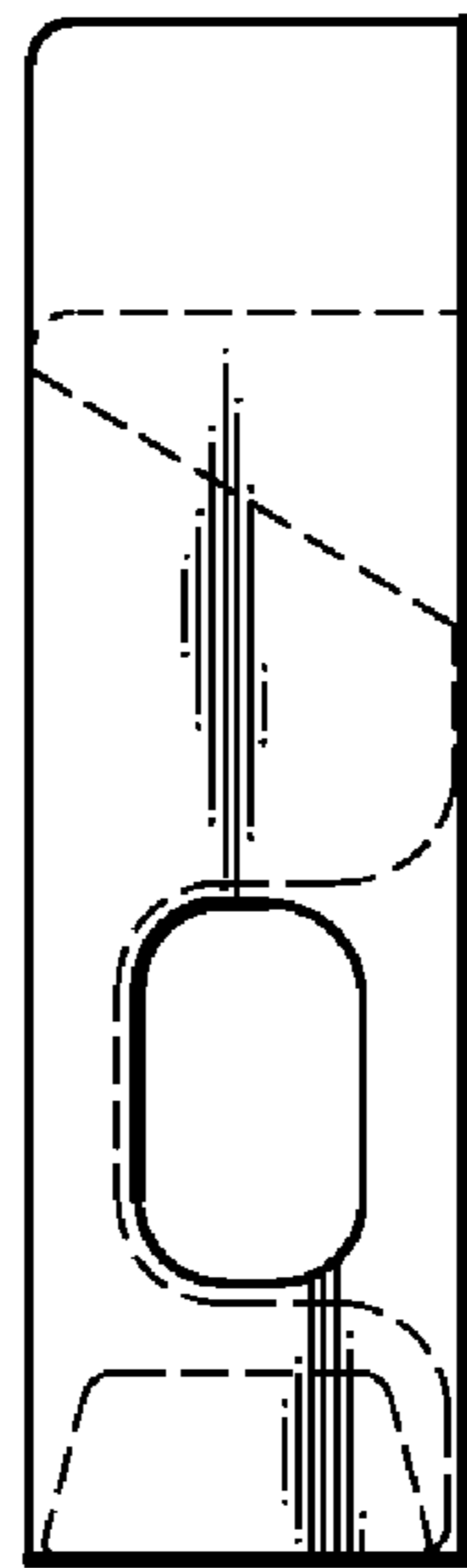

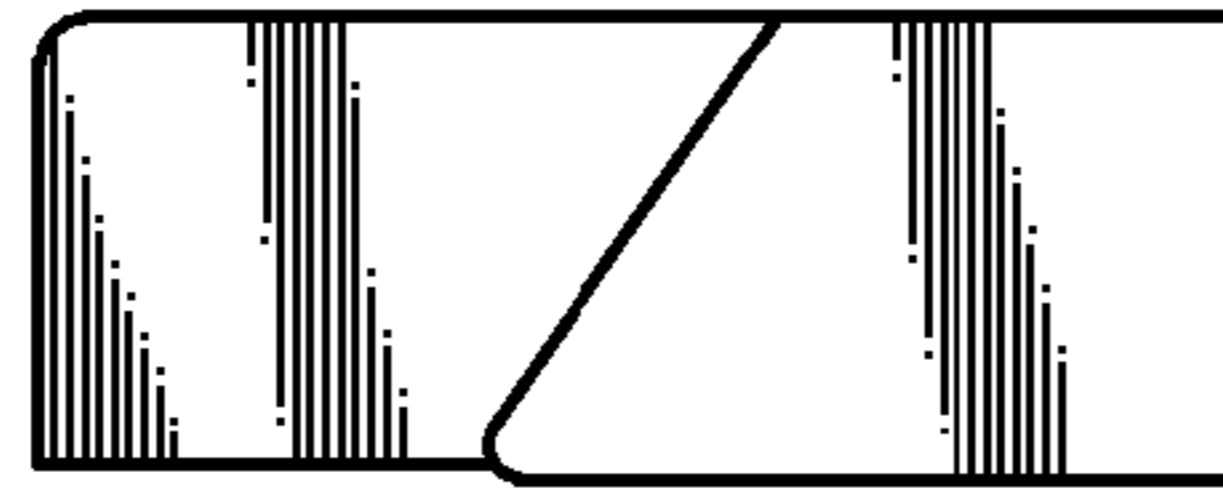

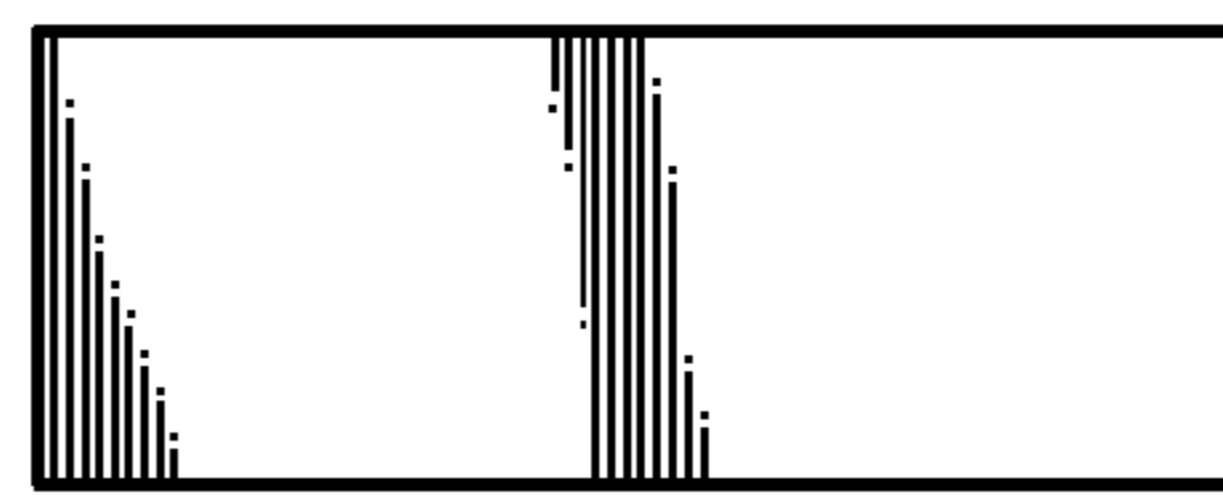

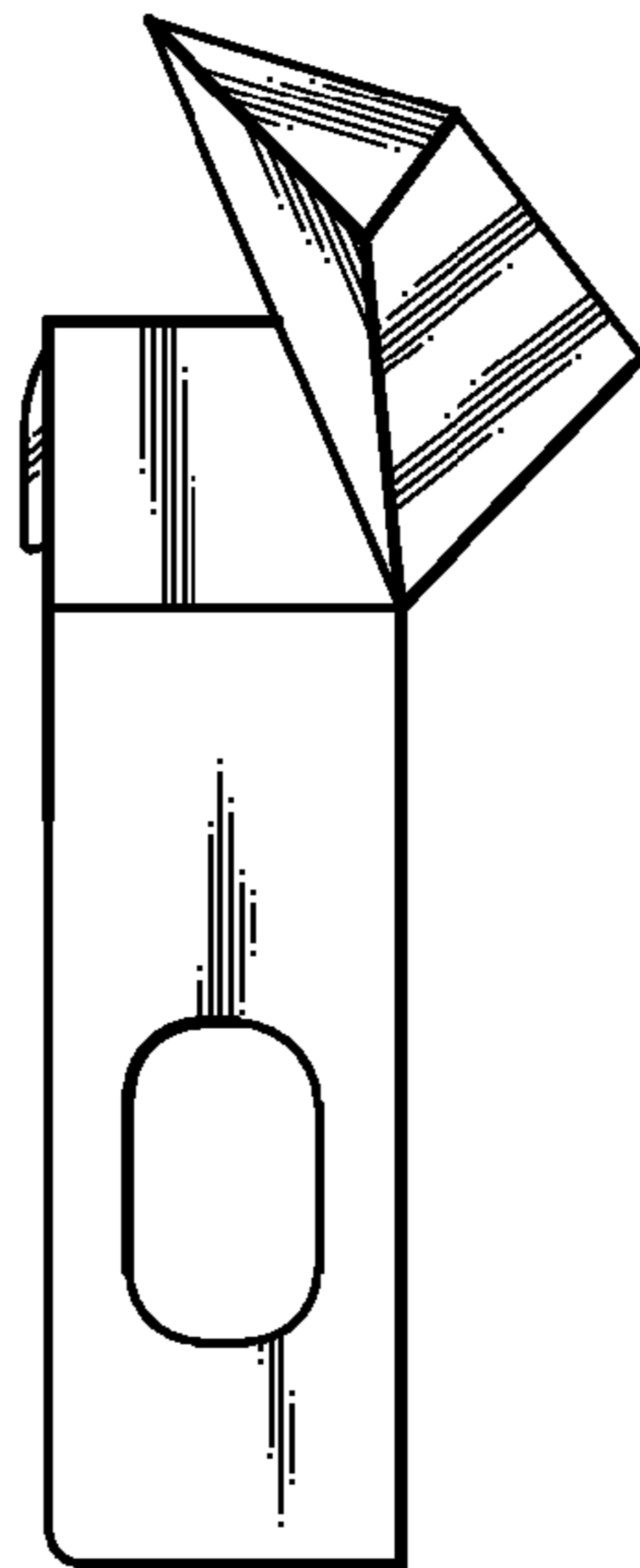
