FIG. 3 illustrates a bottom view of the chocolate tablet of FIG. 1;

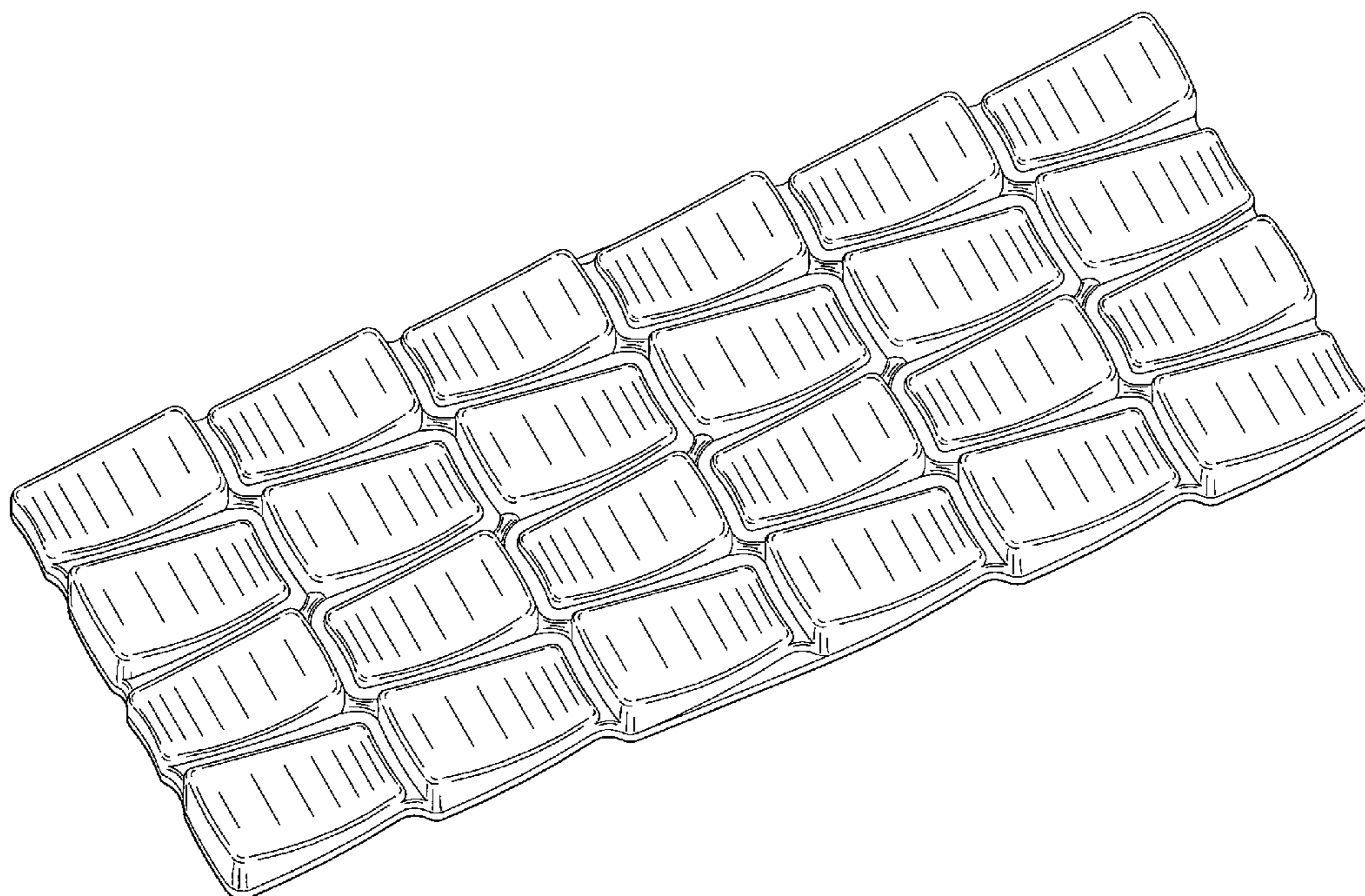
FIG. 4 illustrates a front elevation view of the chocolate tablet of FIG. 1;

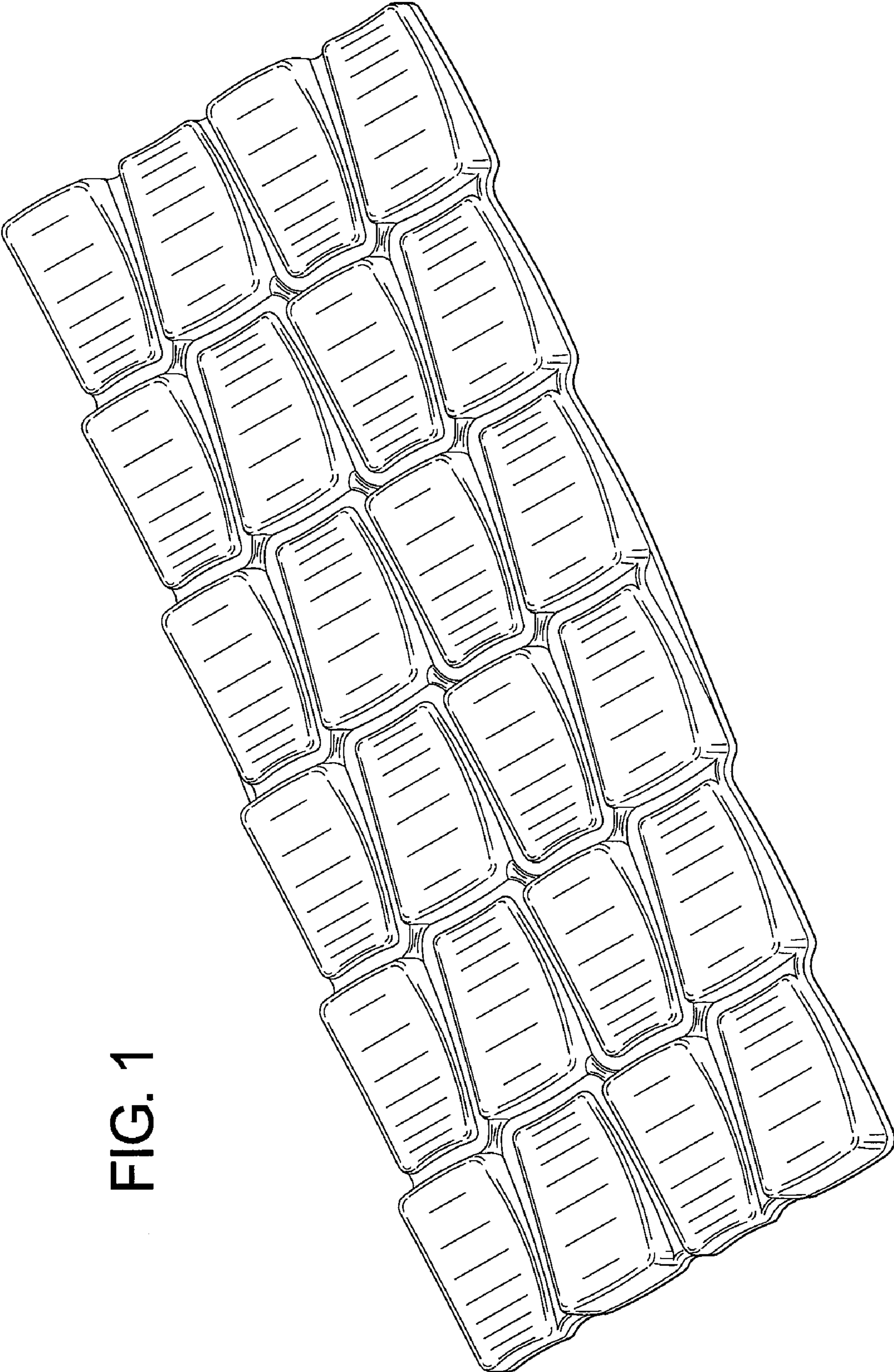

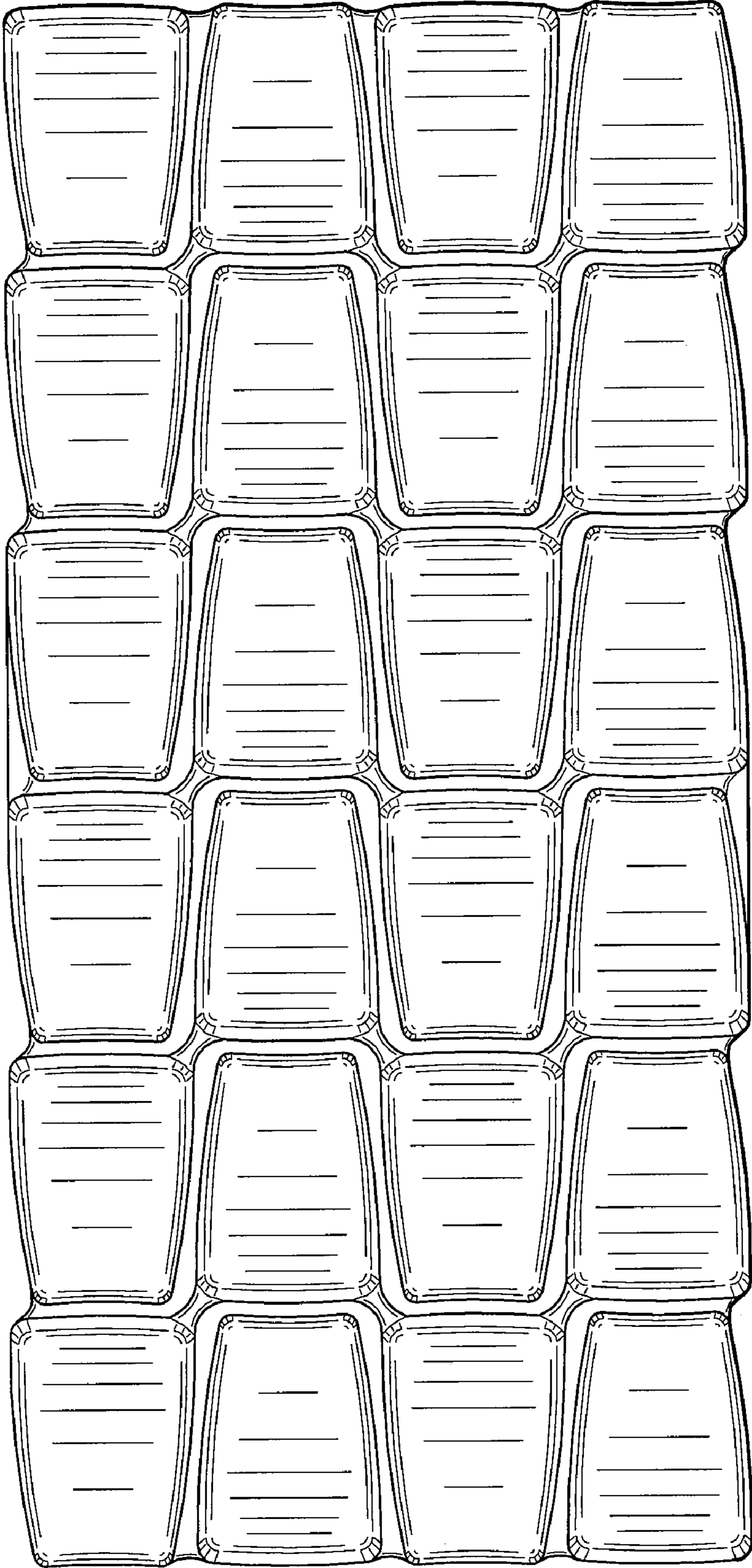

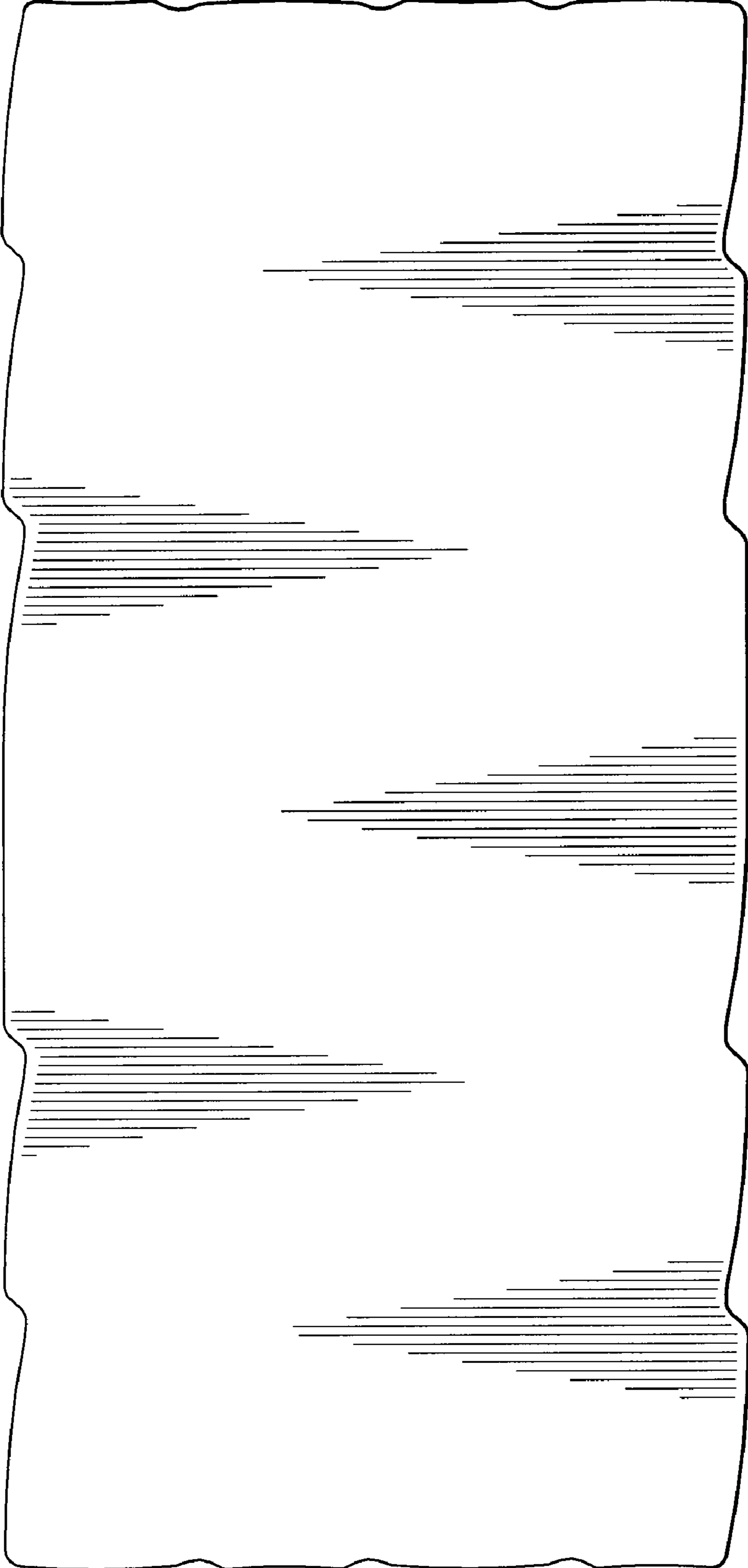

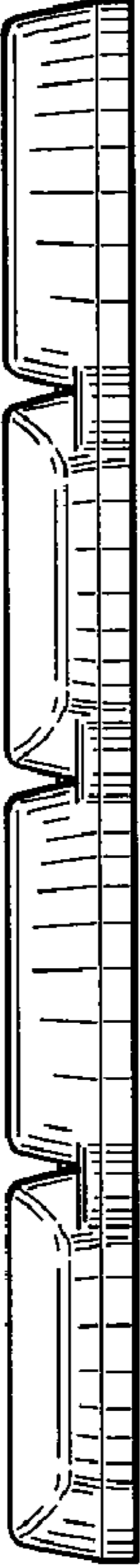
