FIG. 1 is a left foot perspective view of a sandal, showing my new design.

FIG. 2 is a perspective outer edge view thereof;

FIG. 7 is a rear elevation view thereof.

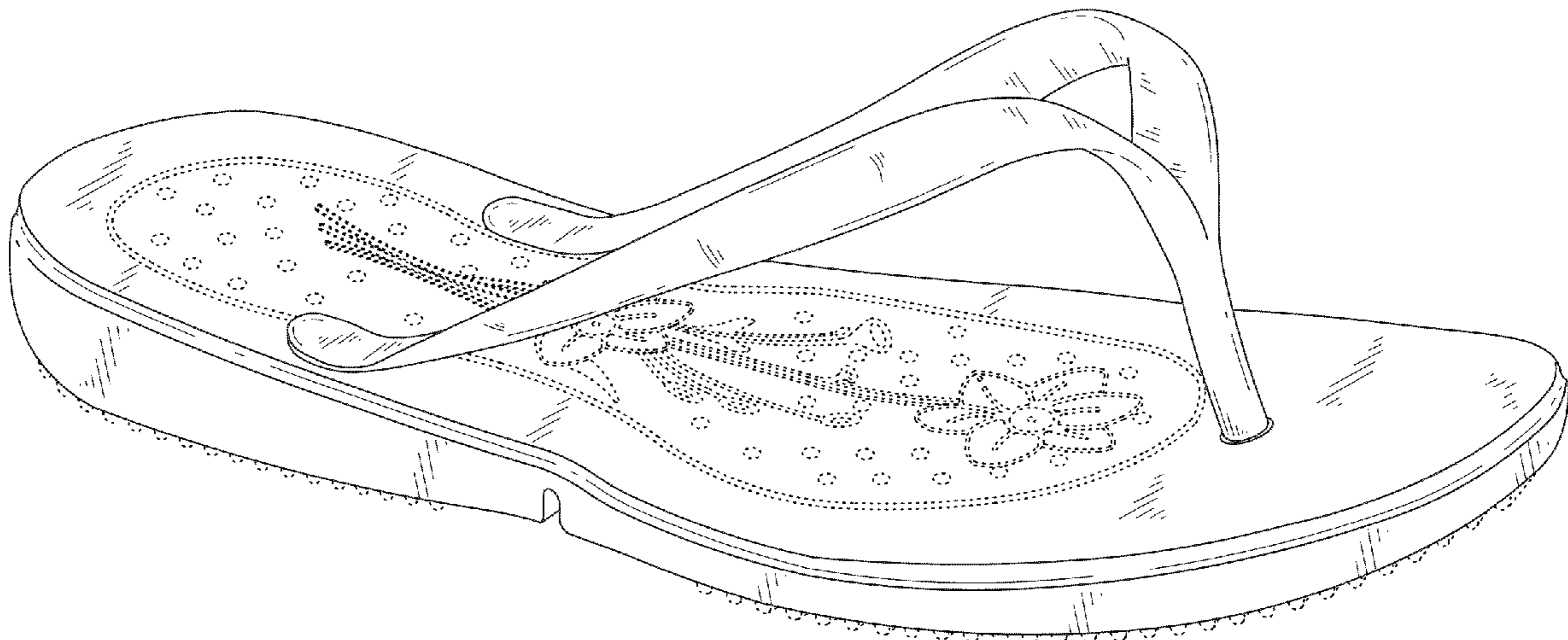

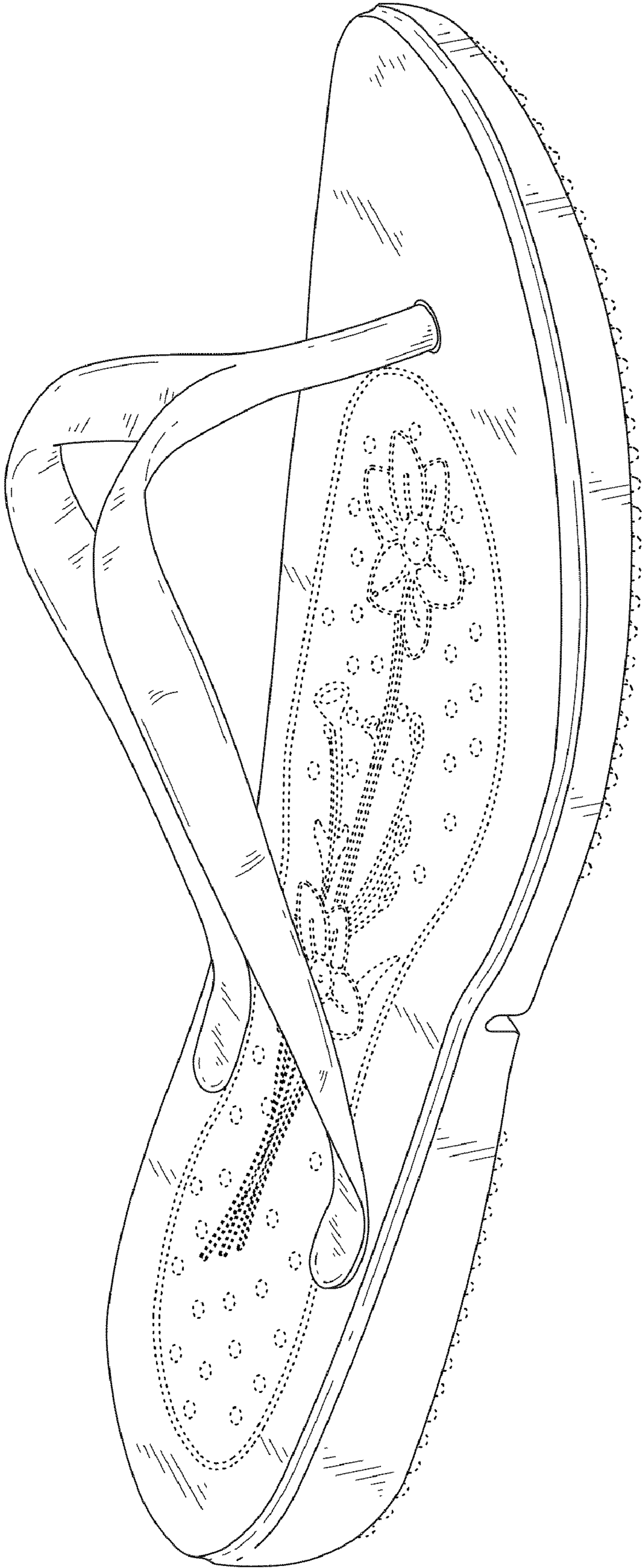

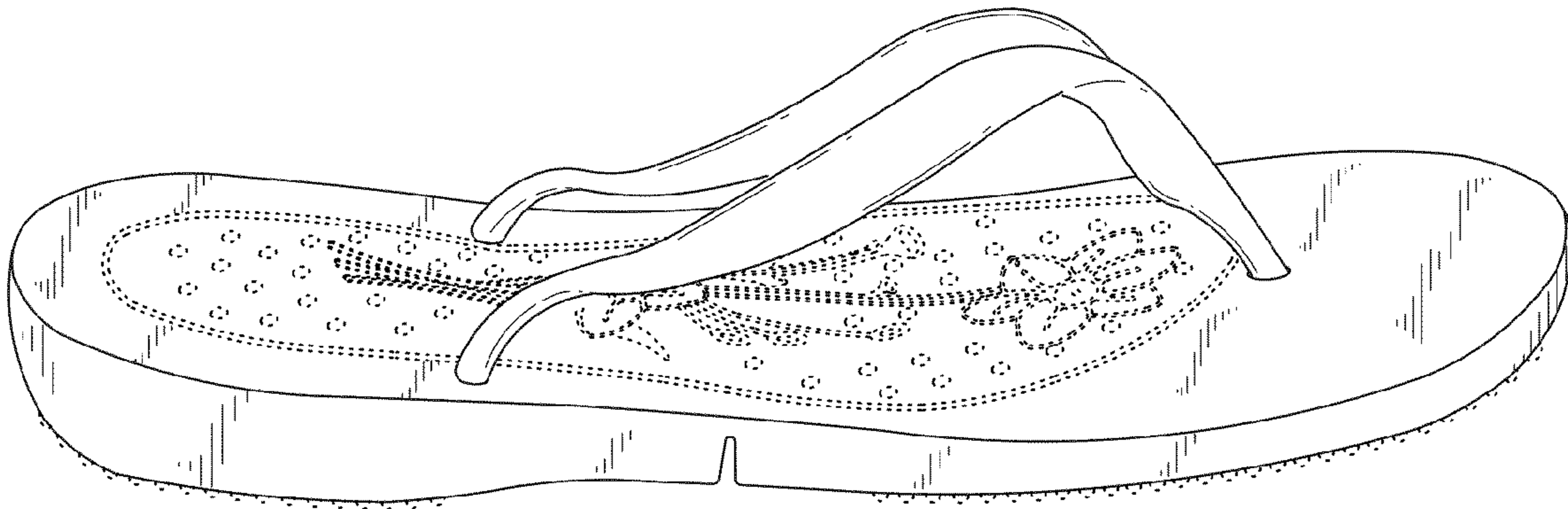

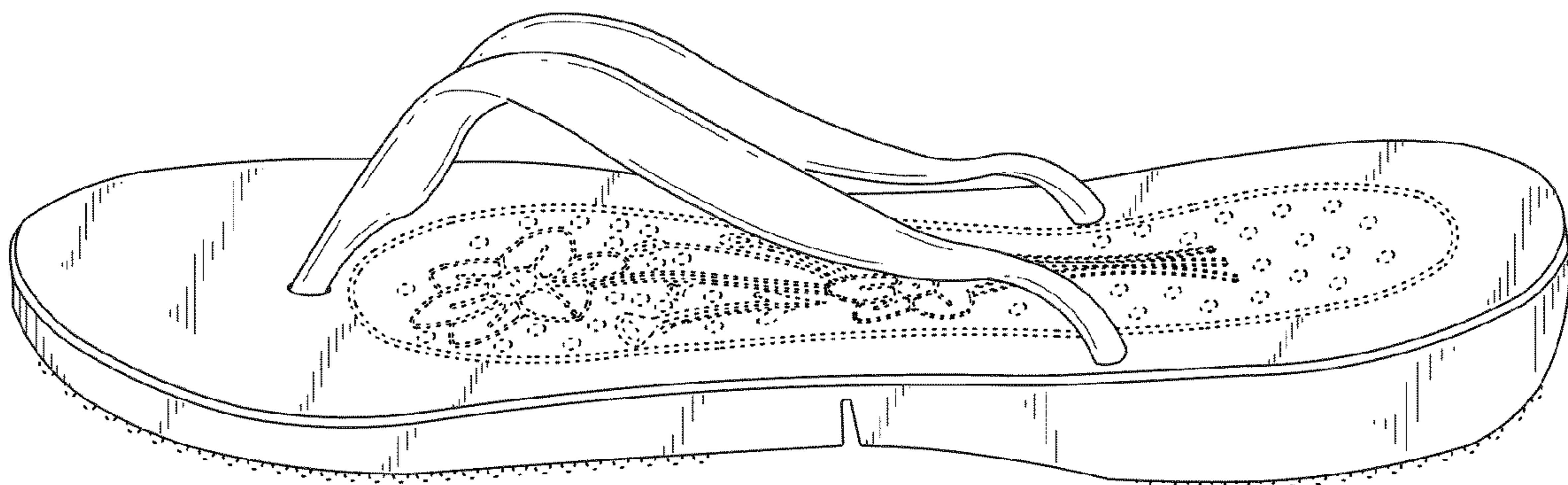

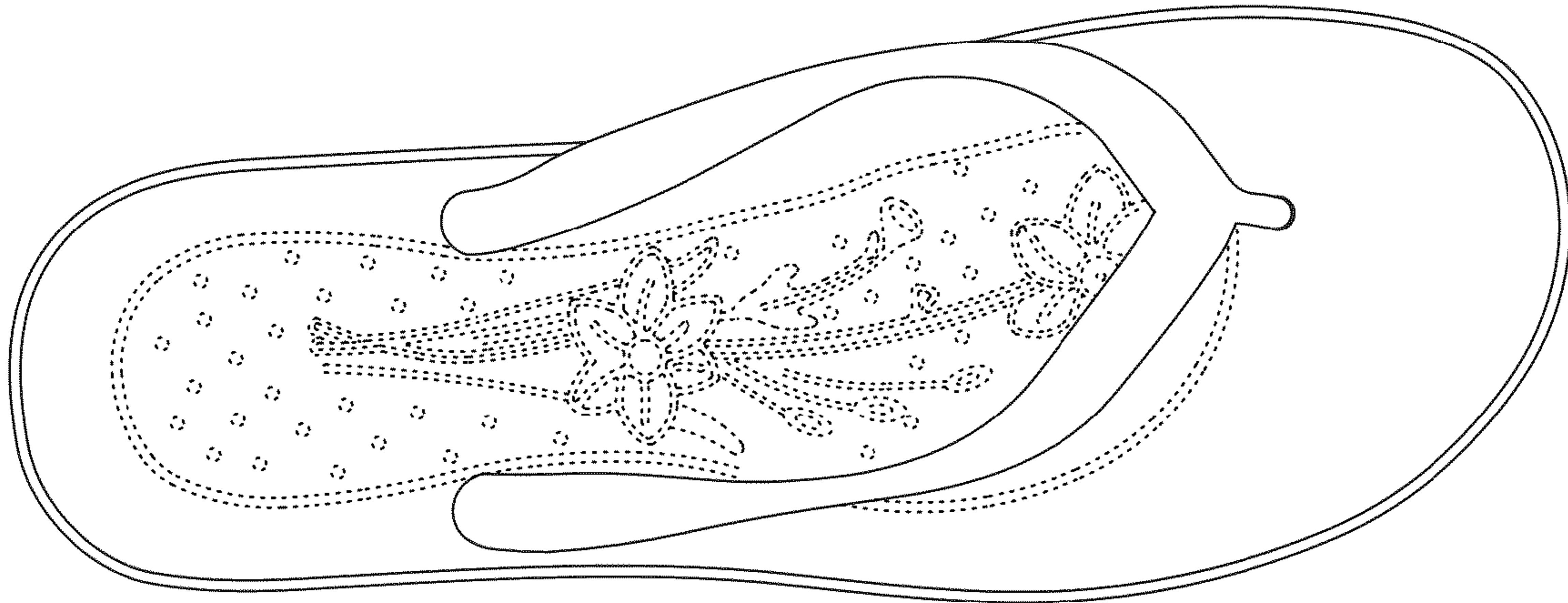

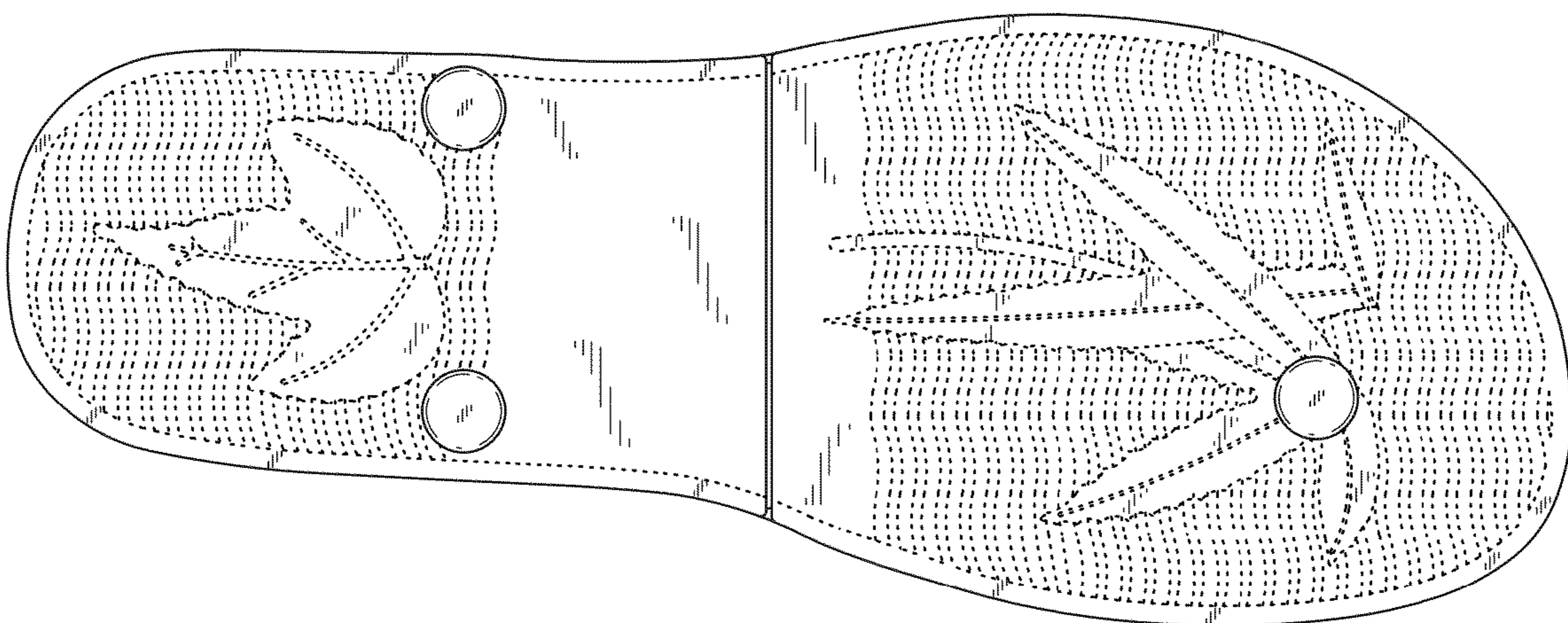

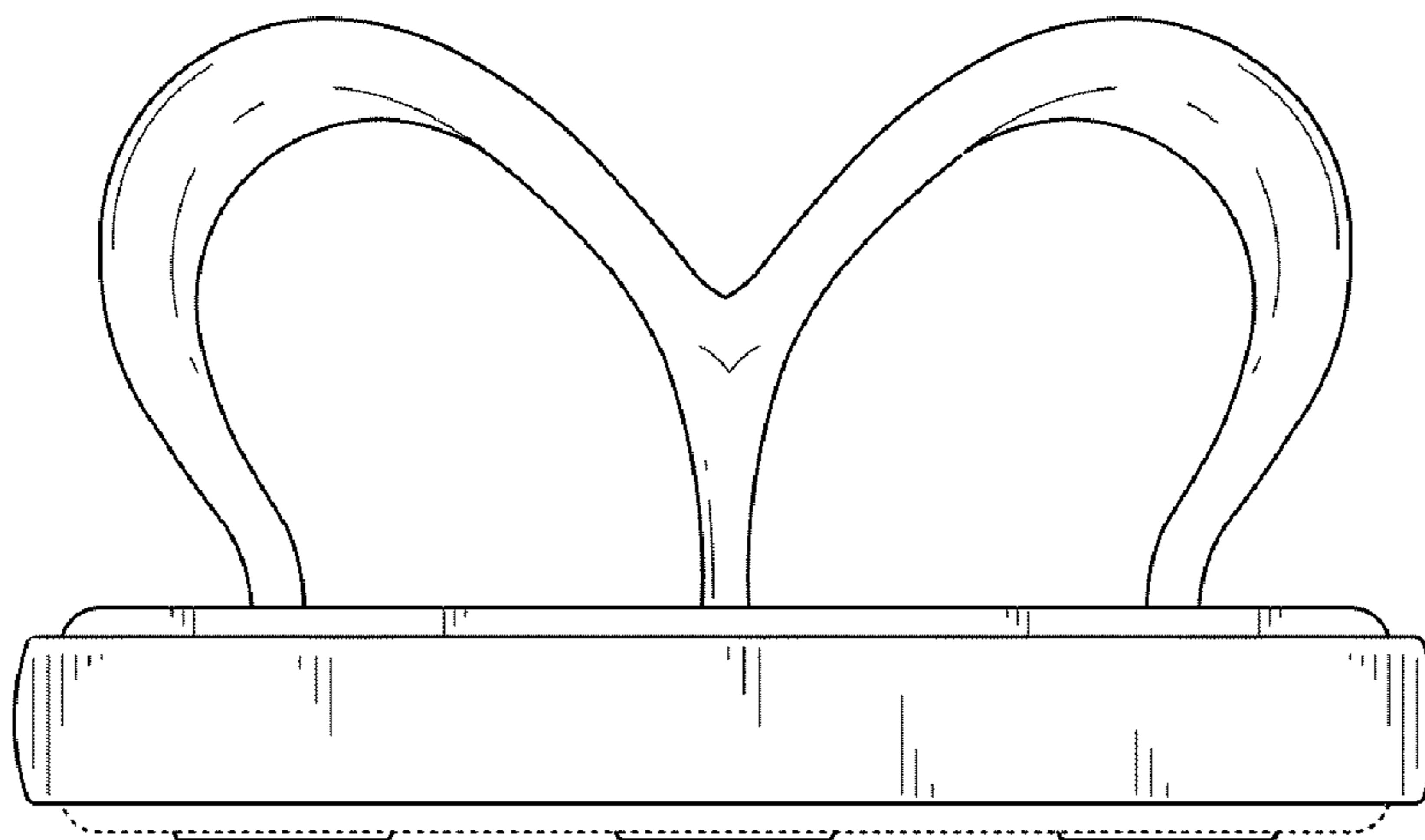

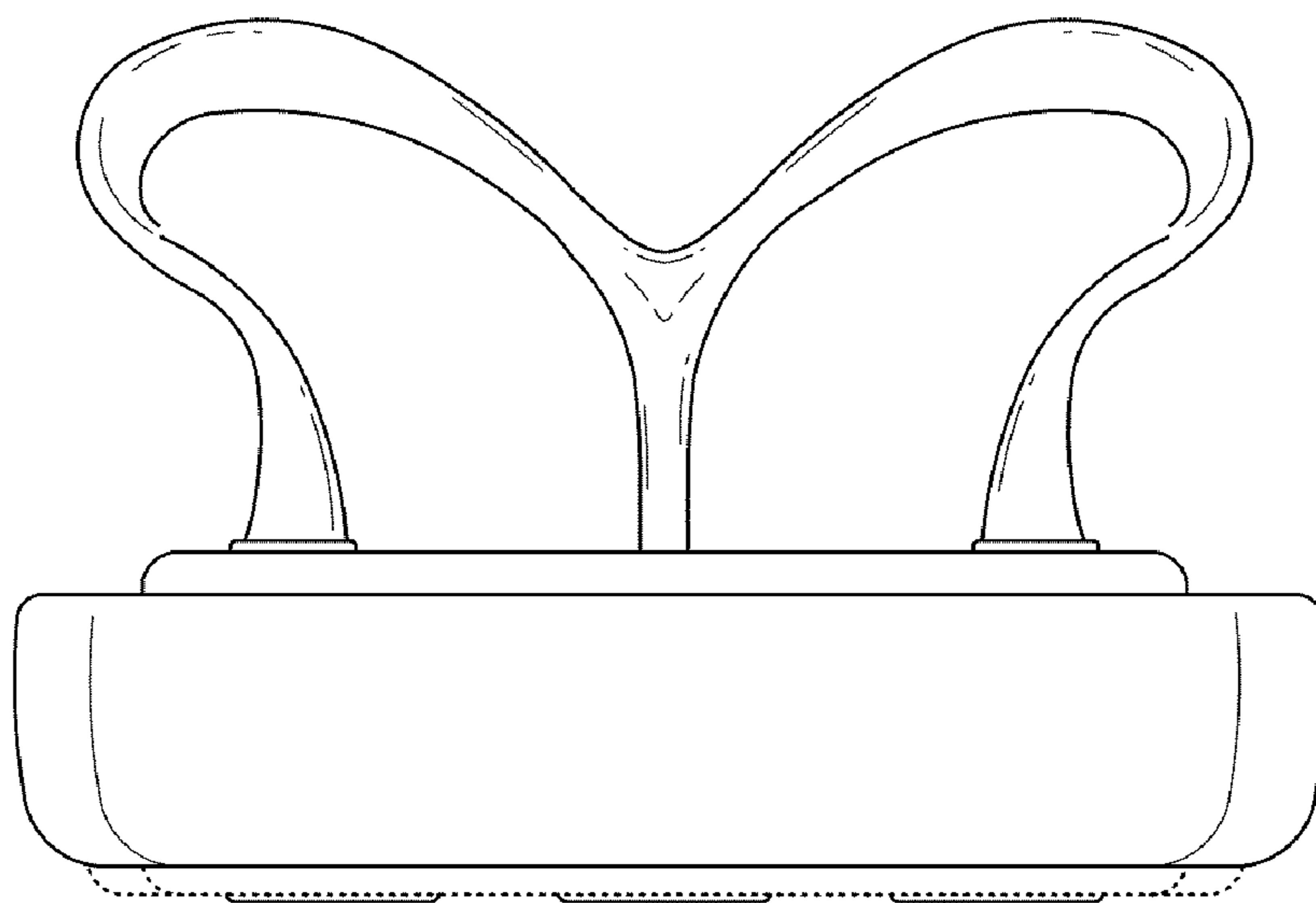
