FIG. 4 is a rear side view thereof;

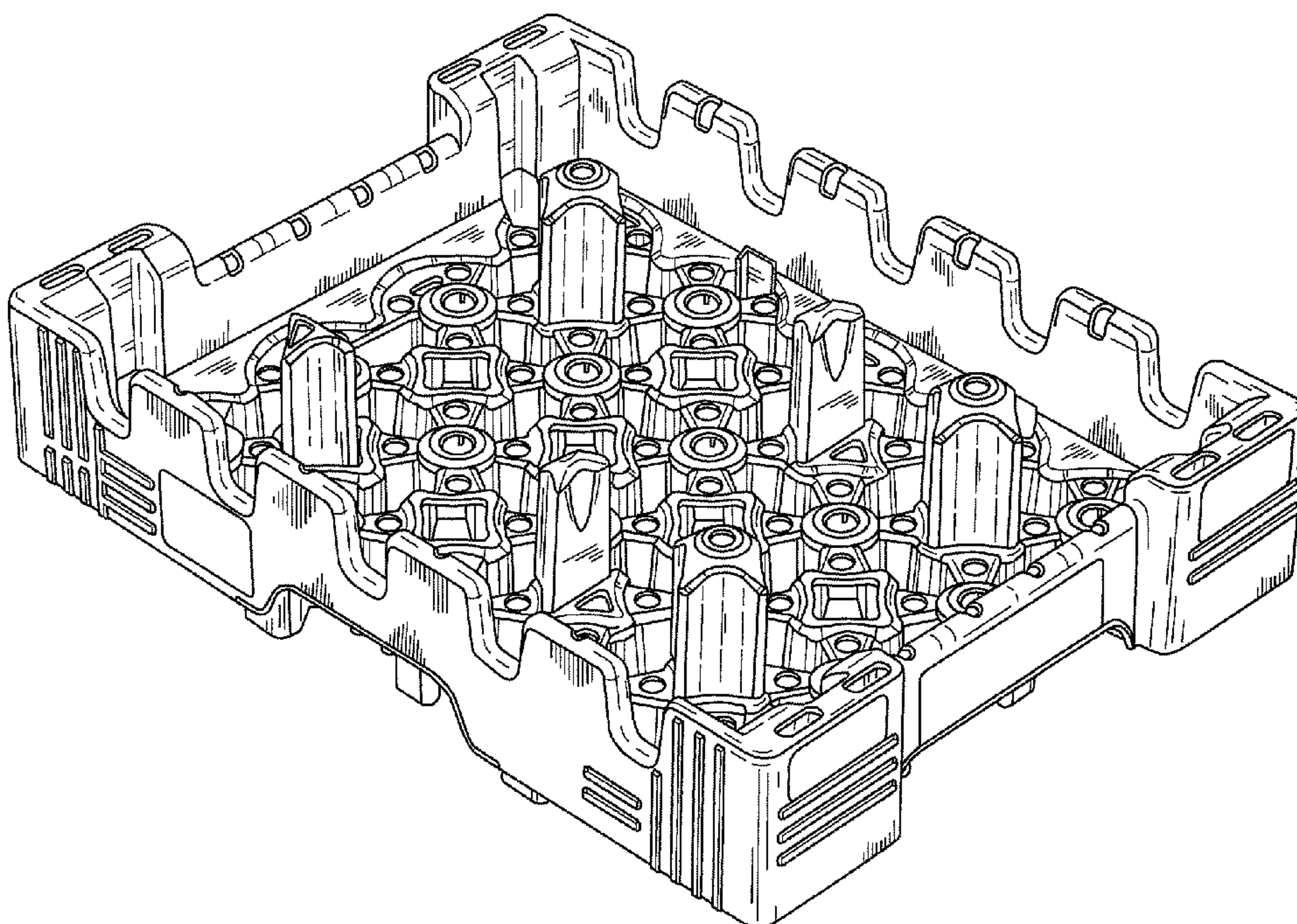
FIG. 5 is a top side view thereof;

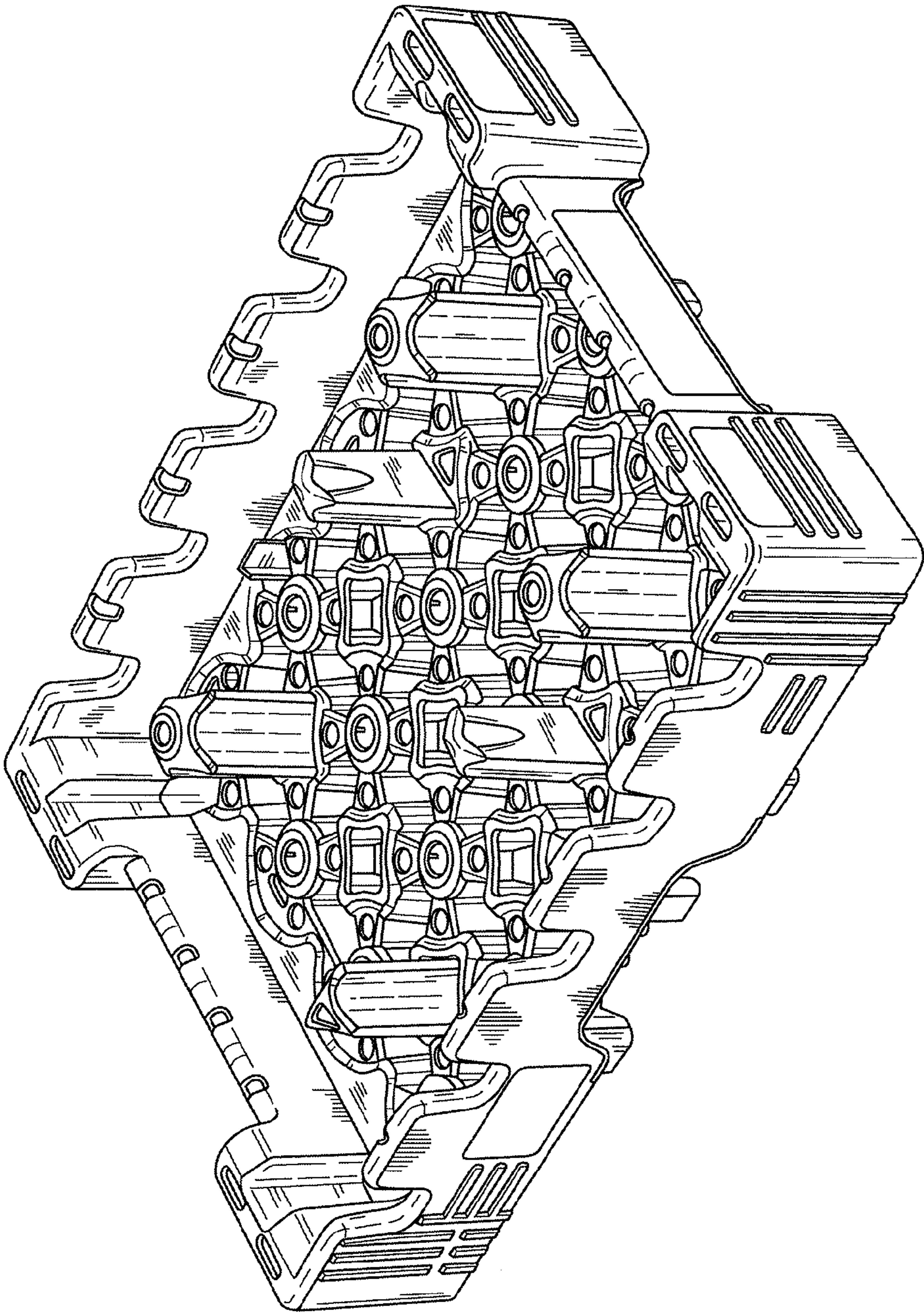

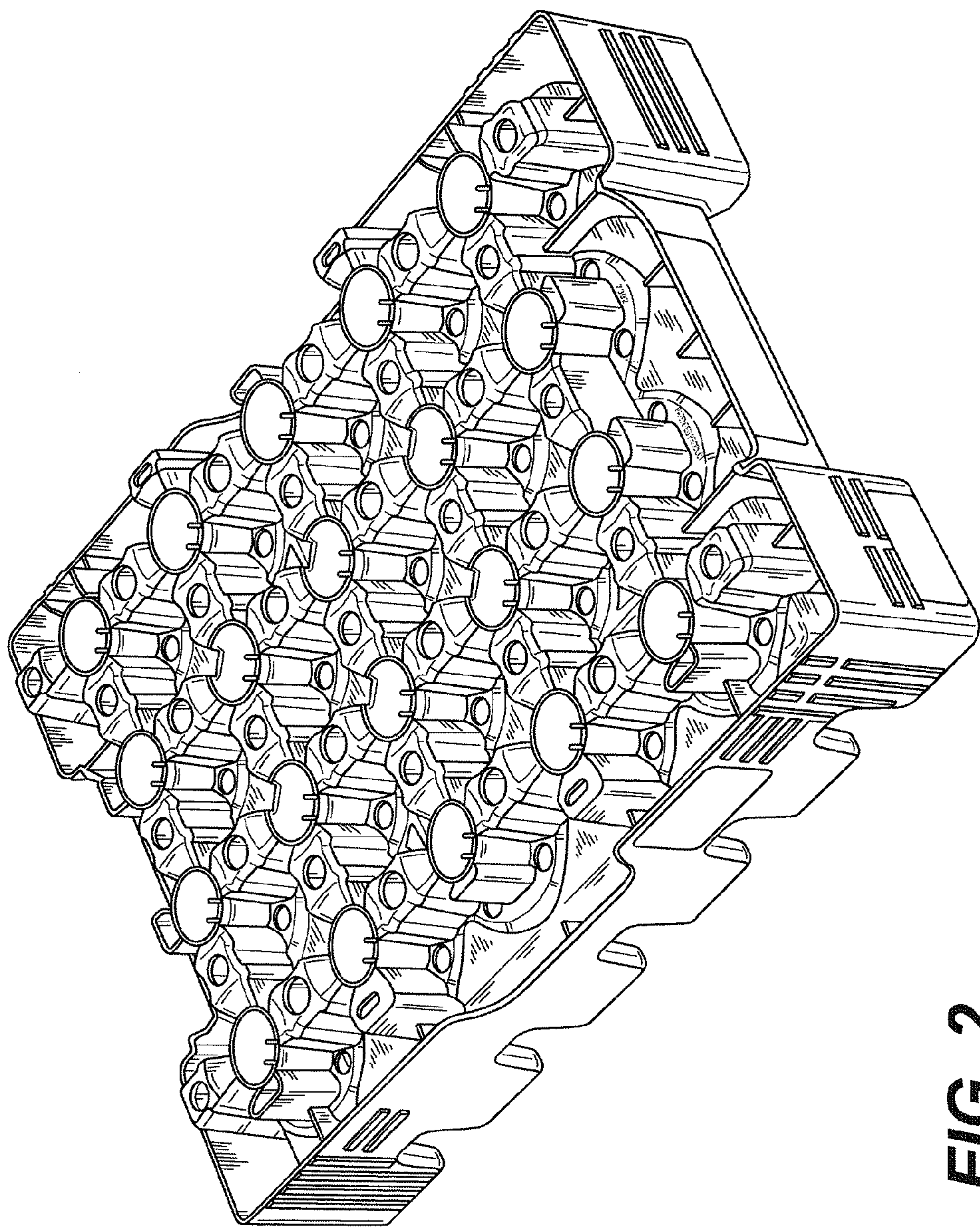

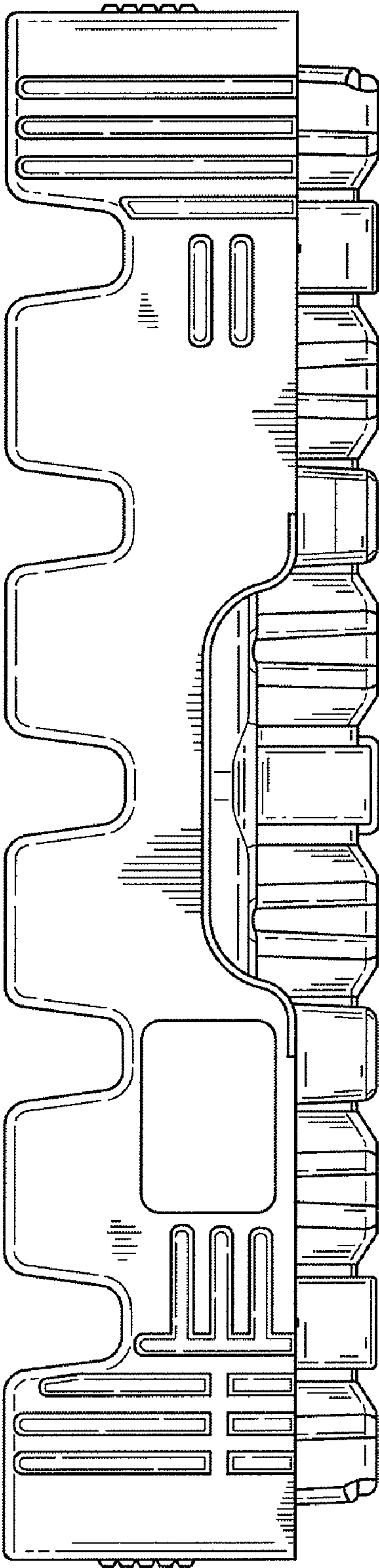

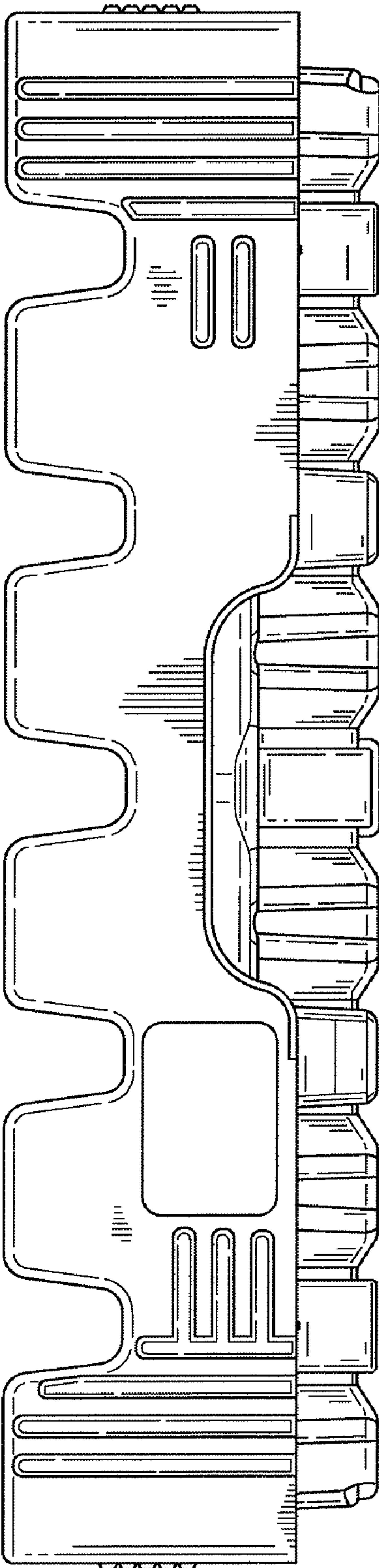

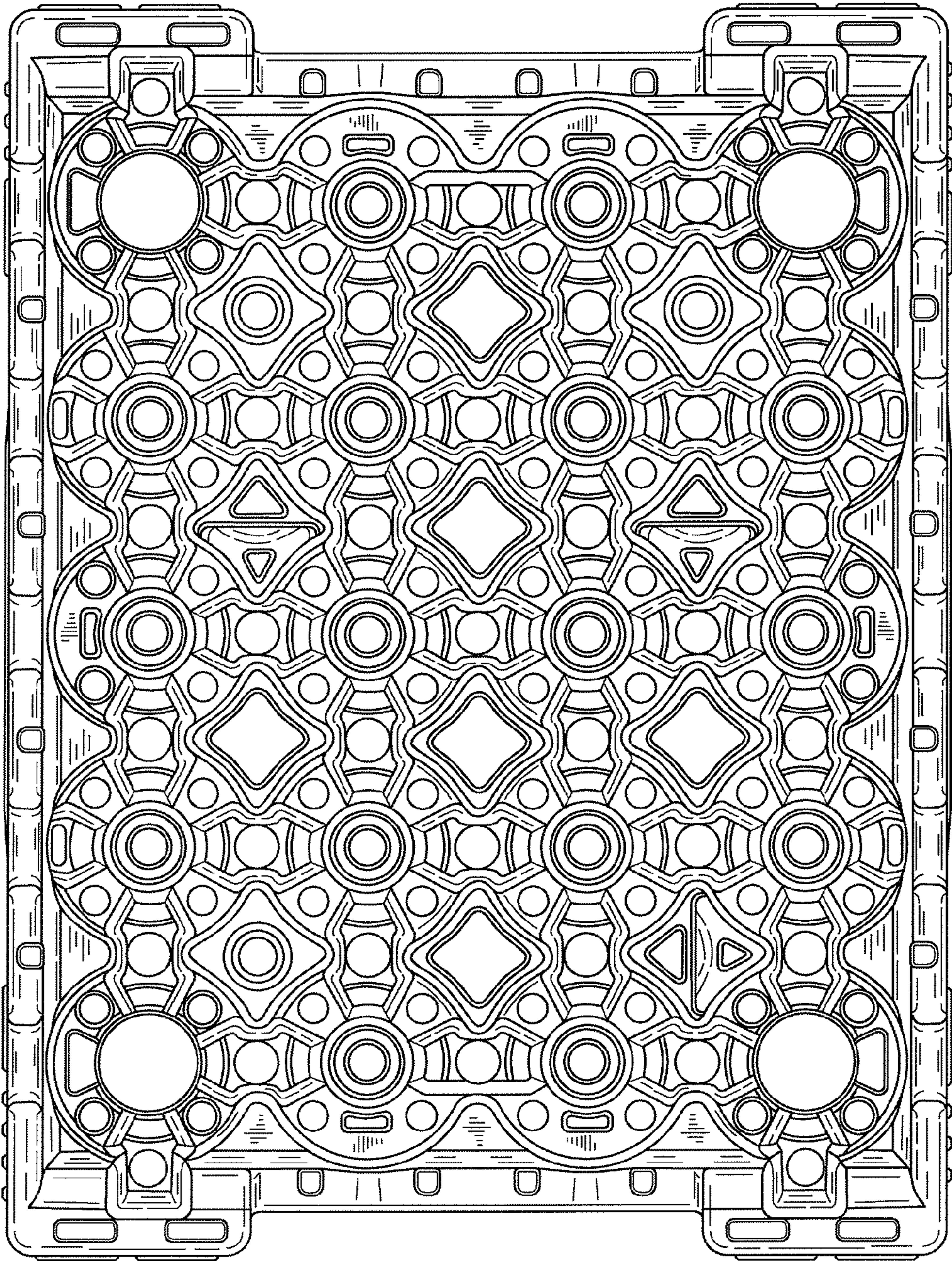

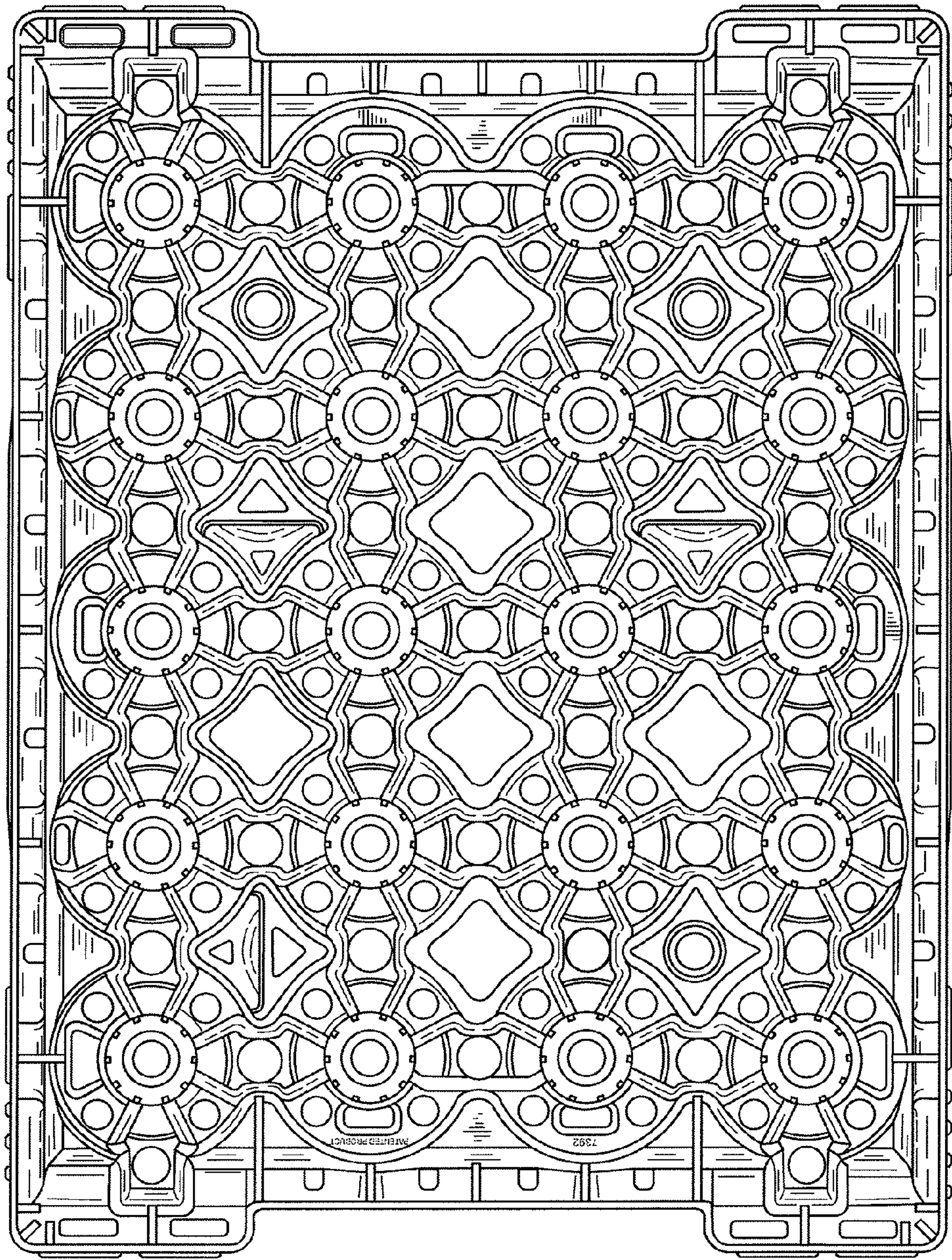

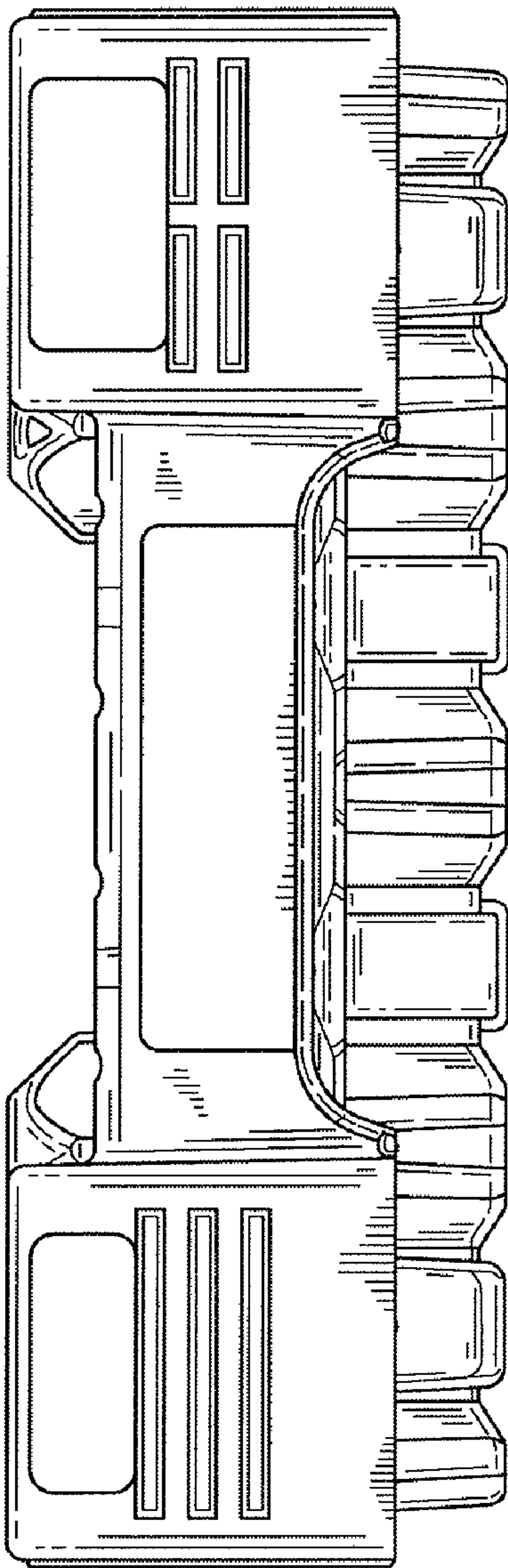

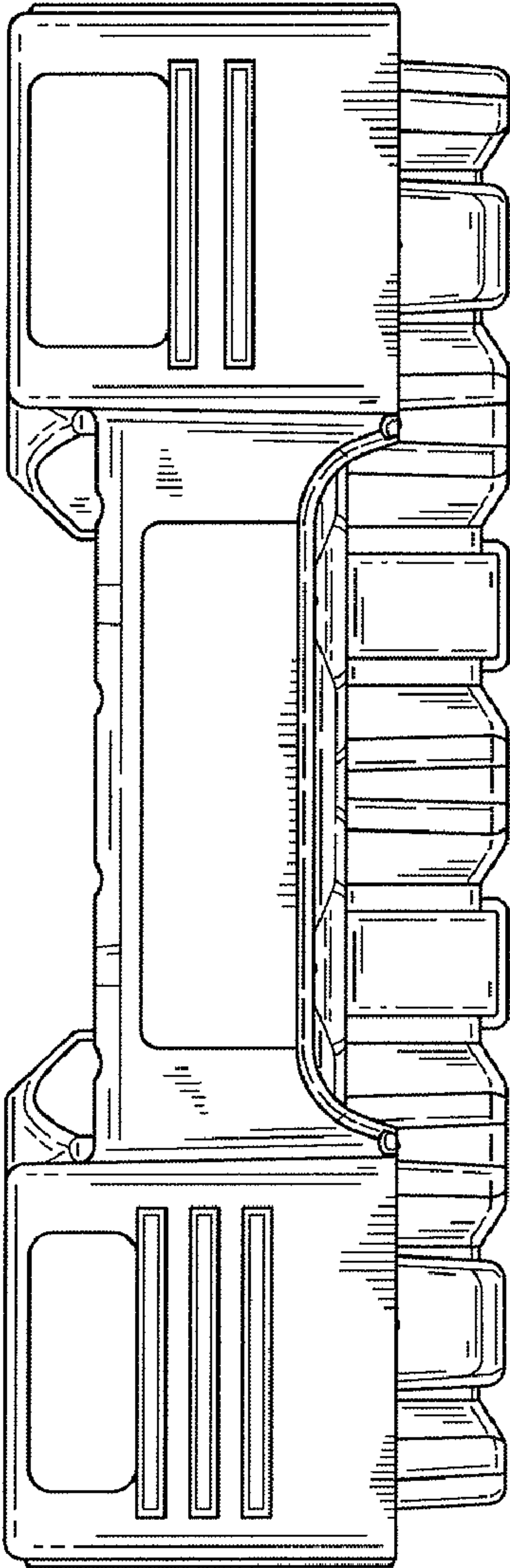
