DESCRIPTION

FIG. 1 is an exploded top perspective view of a microwavable food container with removable compartments;

FIG. 2 is an exploded bottom perspective view thereof;

FIG. 3 is a front elevational view of a tray thereof, the rear elevational view being a mirror image thereof;

FIG. 4 is a right-side elevational view thereof;

FIG. 5 is a left-side elevational view thereof;

FIG. 8 is a front elevational view of a removable compartment thereof, the rear elevational view being a mirror image thereof;

FIG. 9 is a left-side elevational view thereof, the right-side elevational view being a mirror image thereof;

FIG. 10 is a top plan view thereof;

FIG. 11 is a bottom plan view thereof;

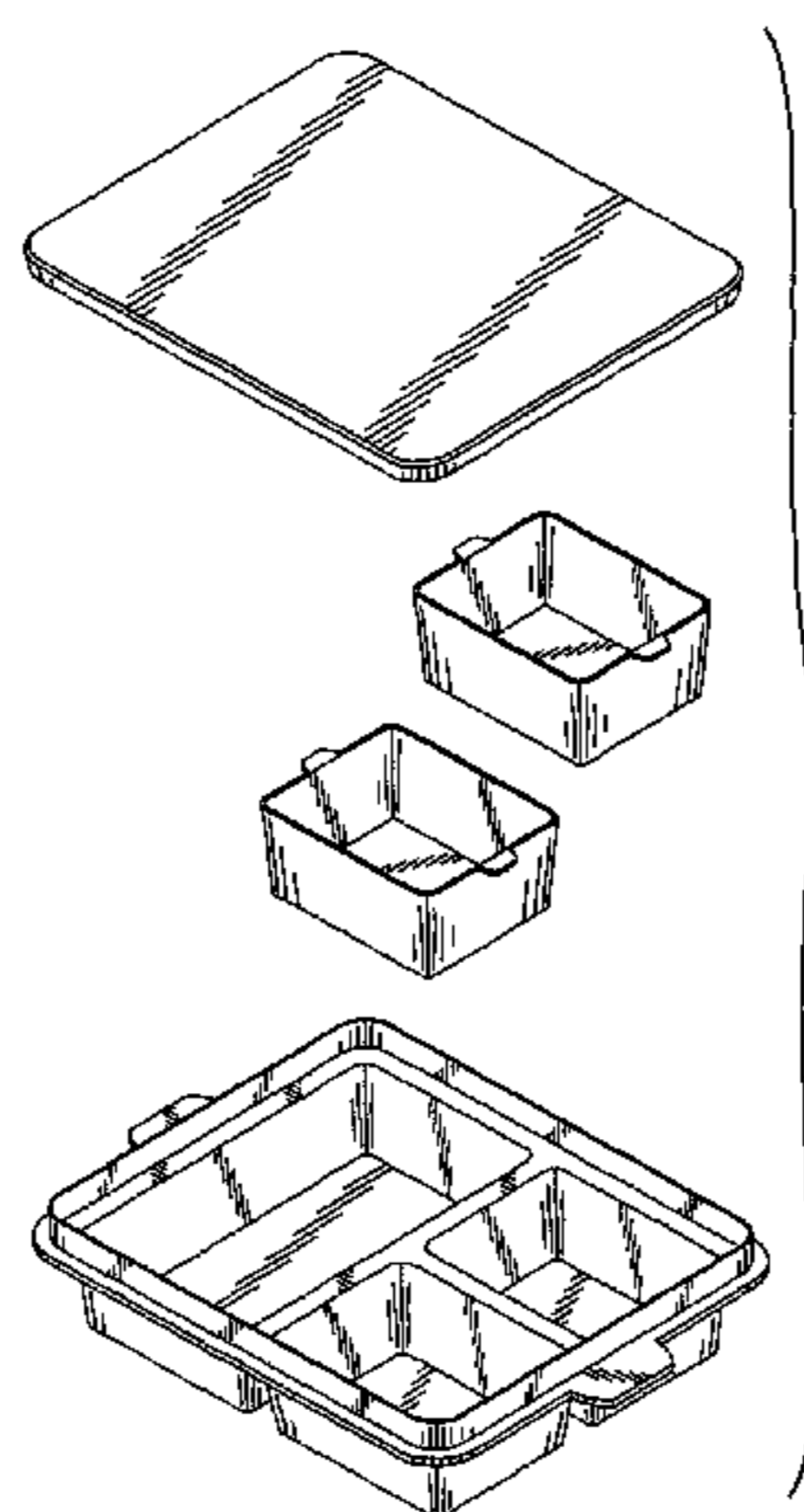
FIG. 12 is a front elevational view of a cover thereof, the rear elevational view being a mirror image thereof;

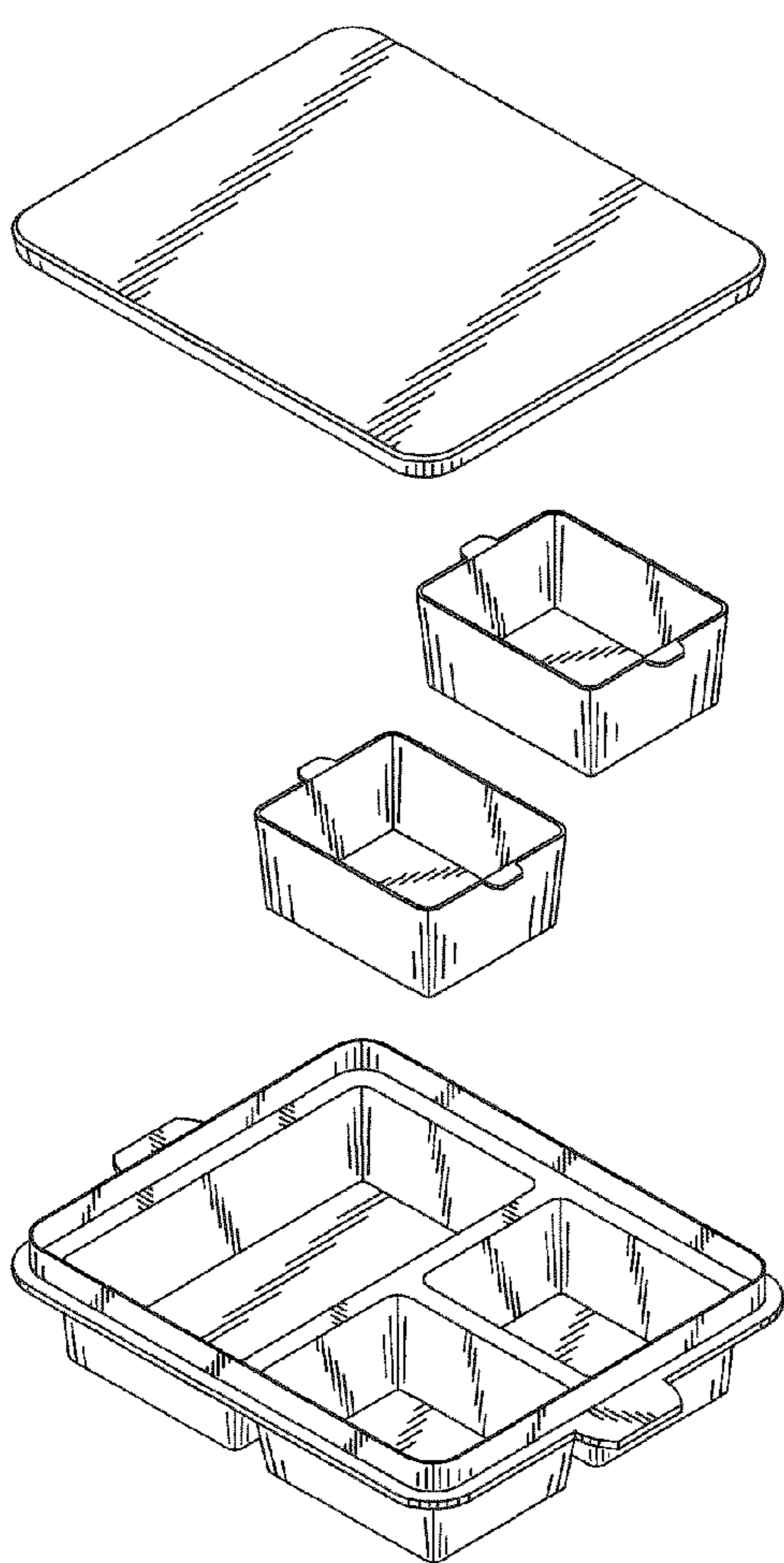

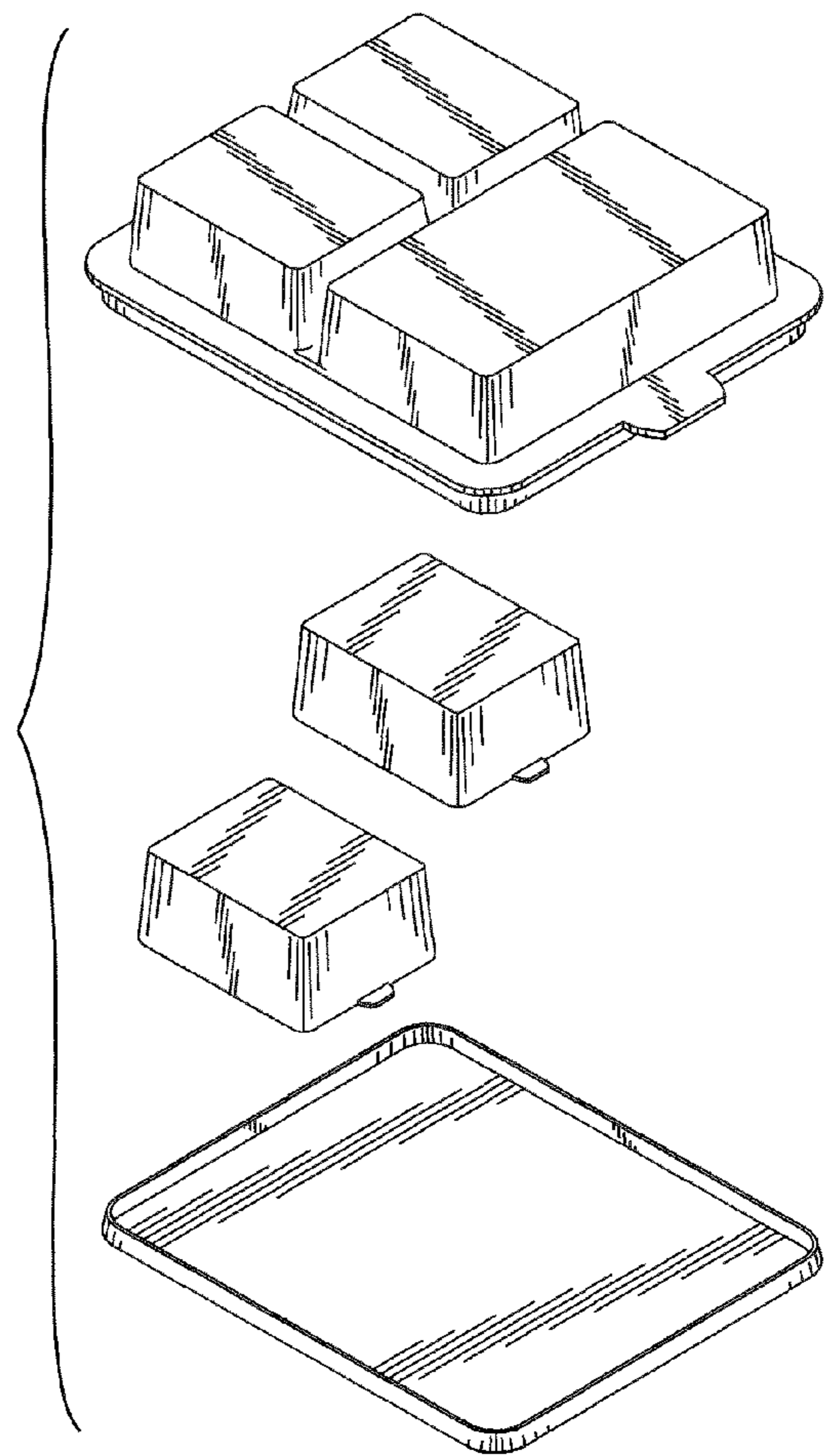

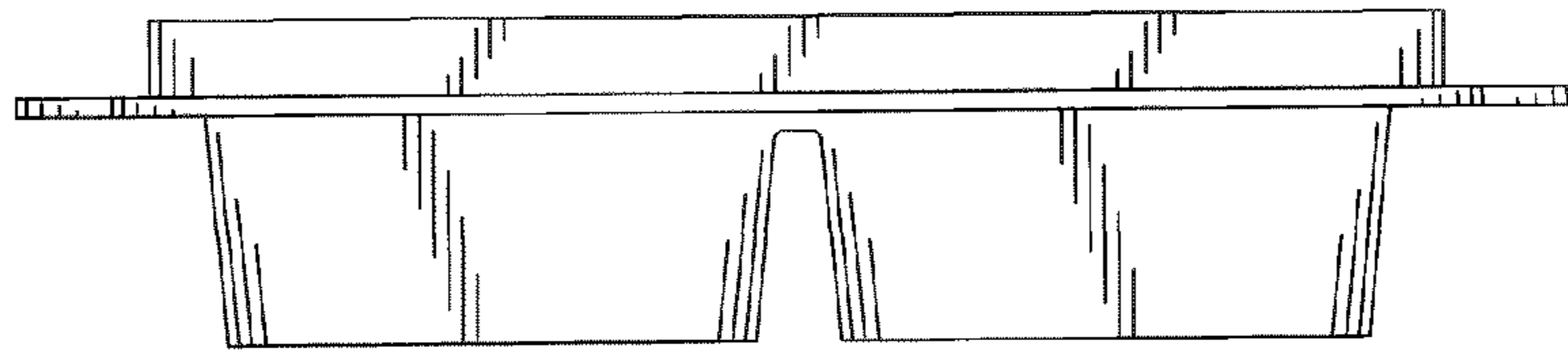

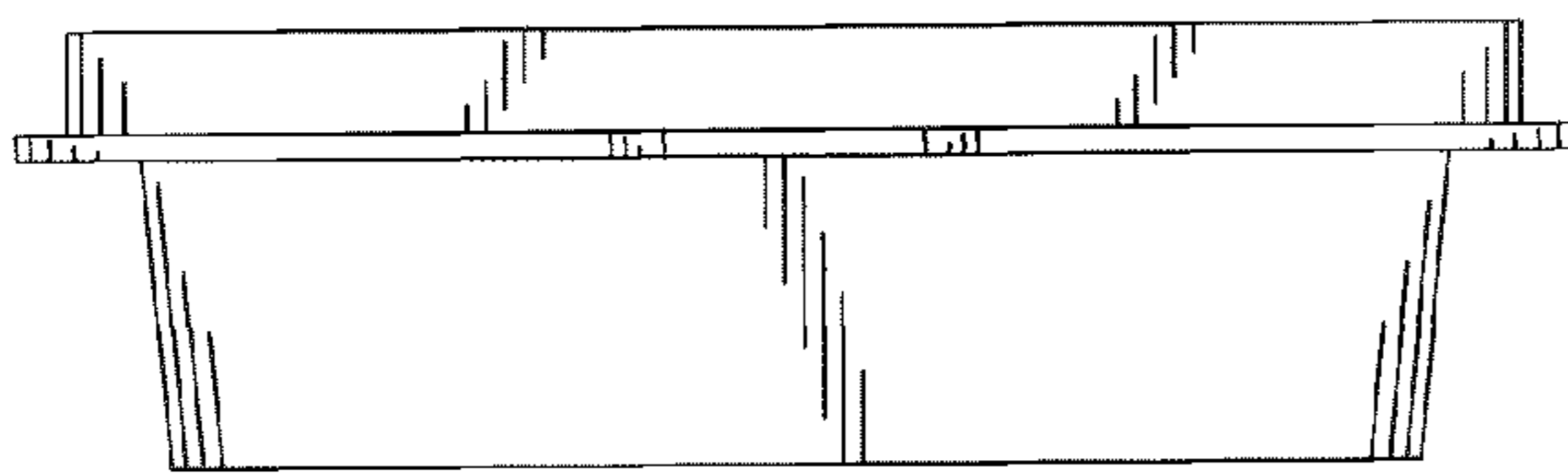

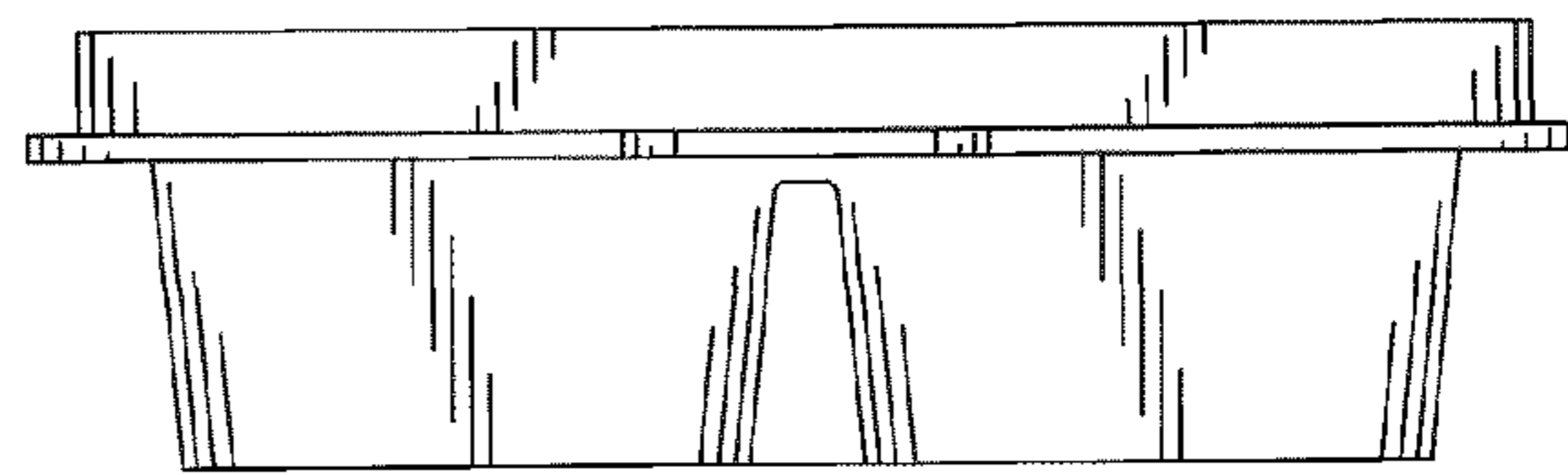

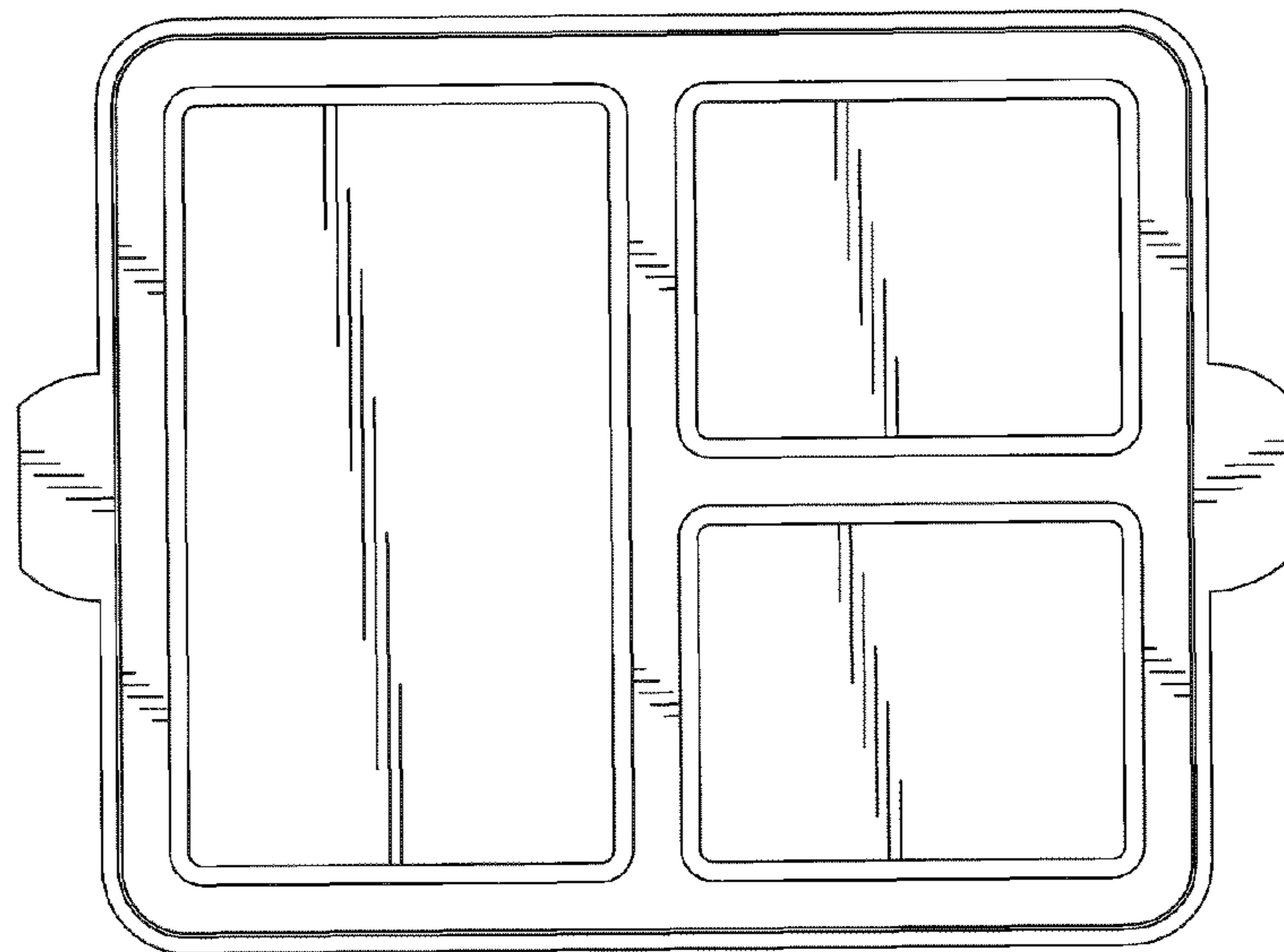

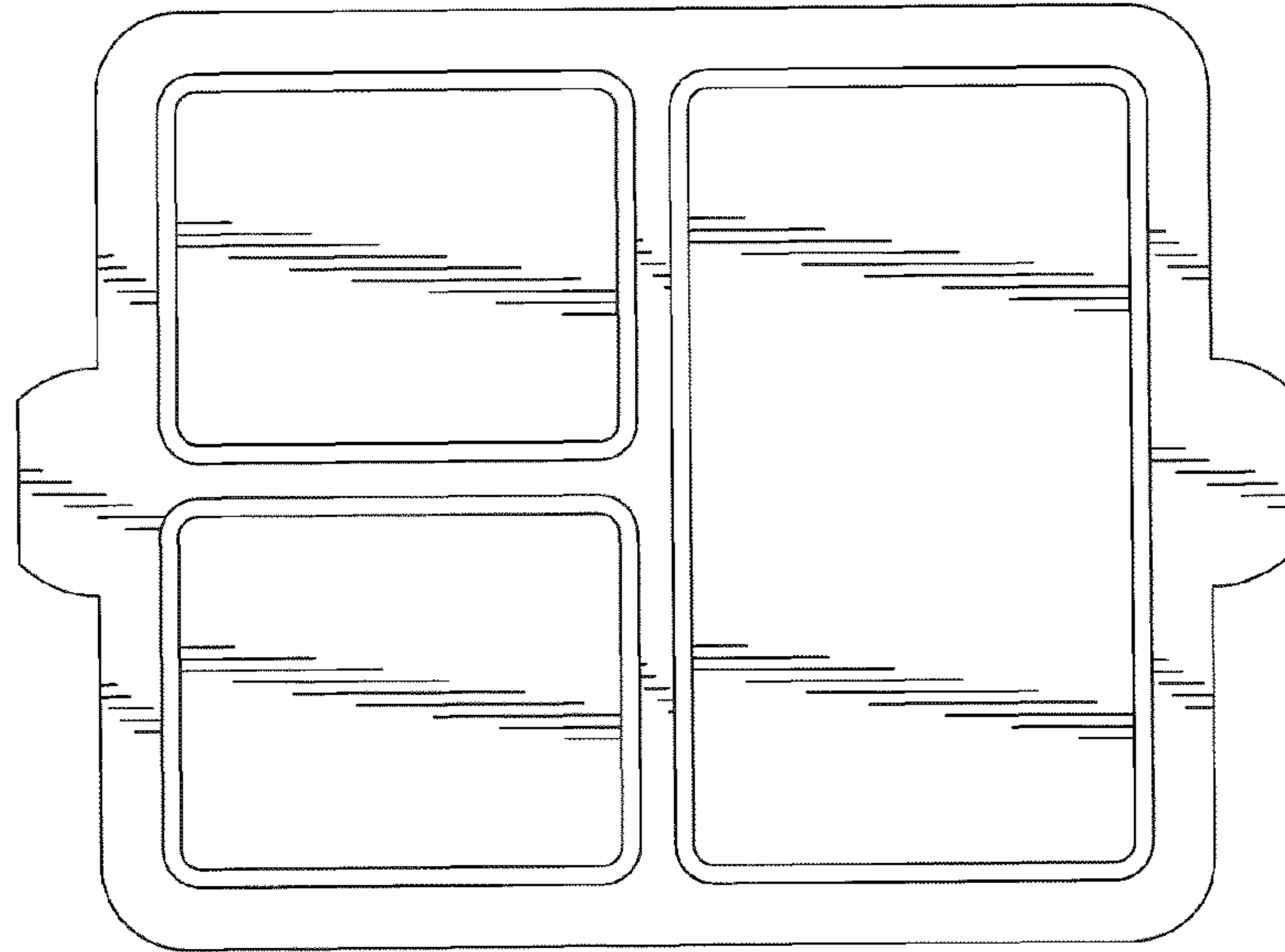

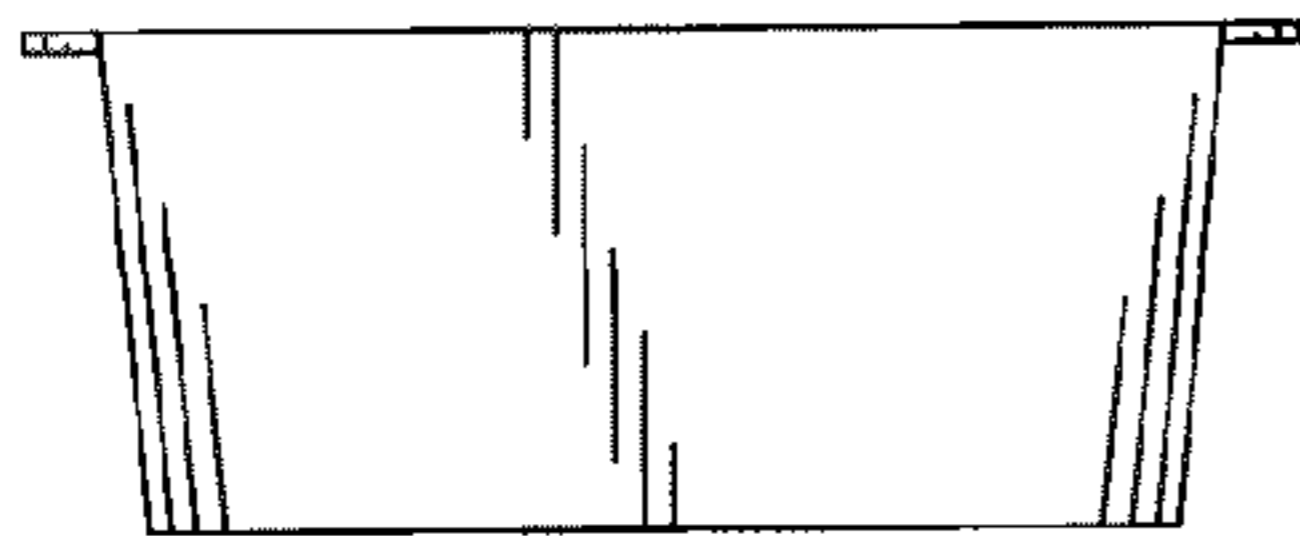

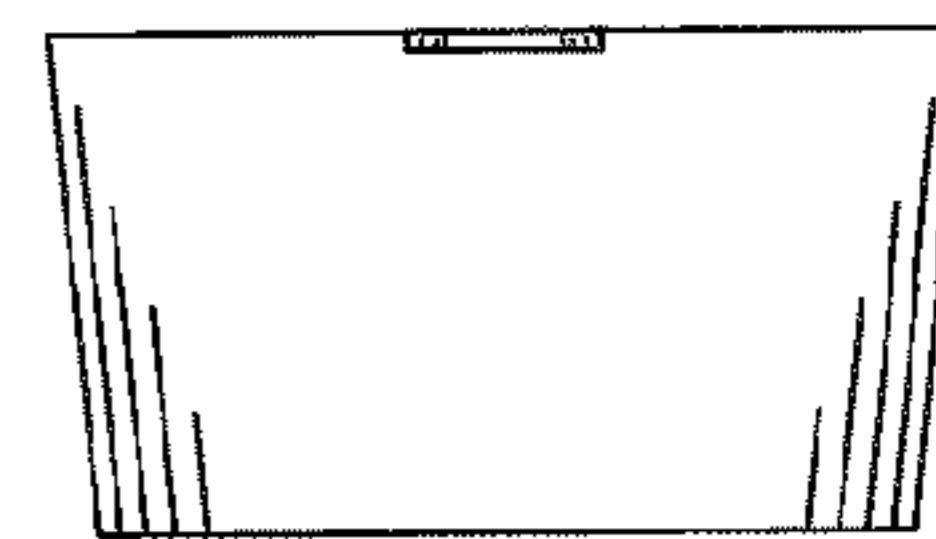

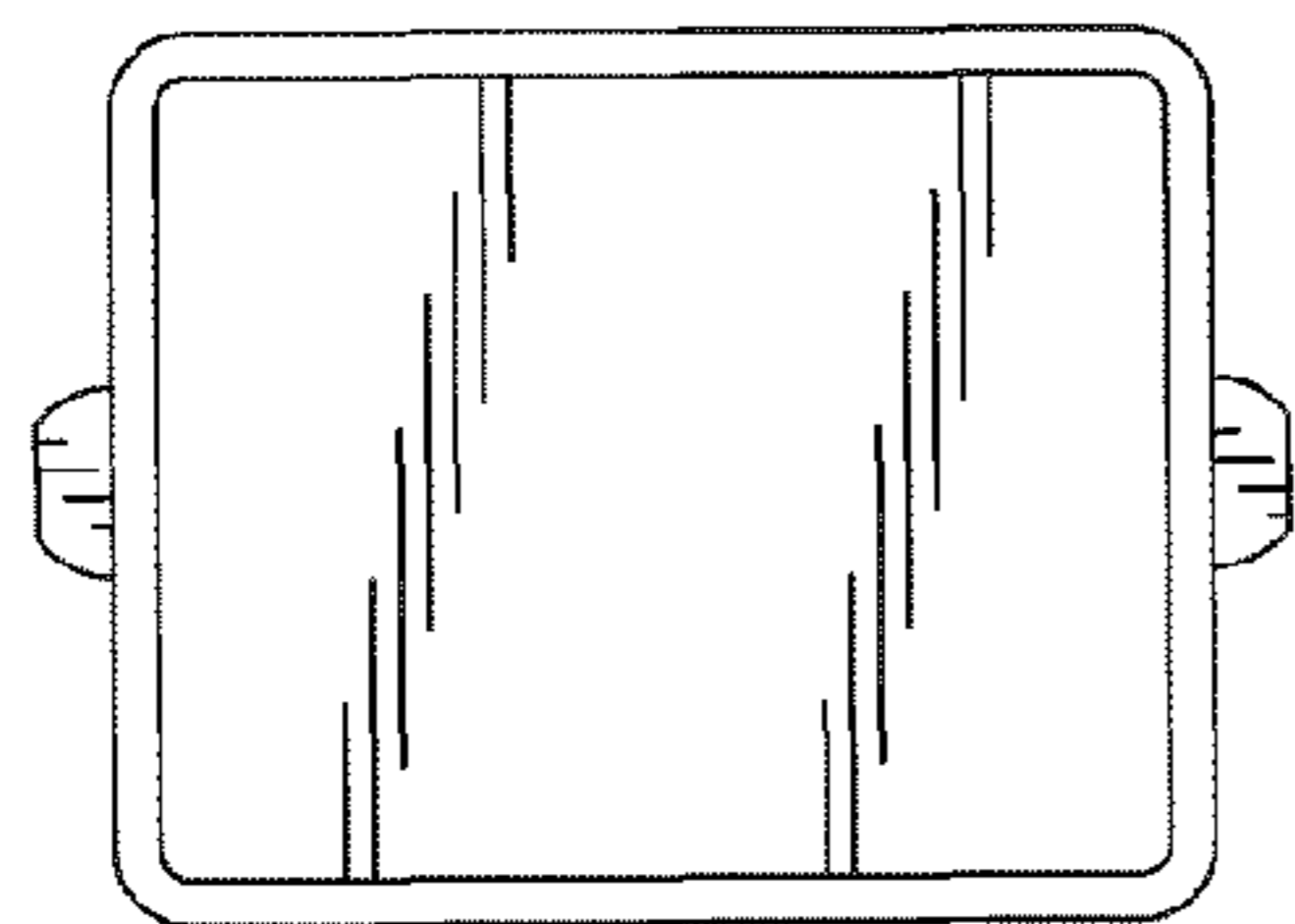

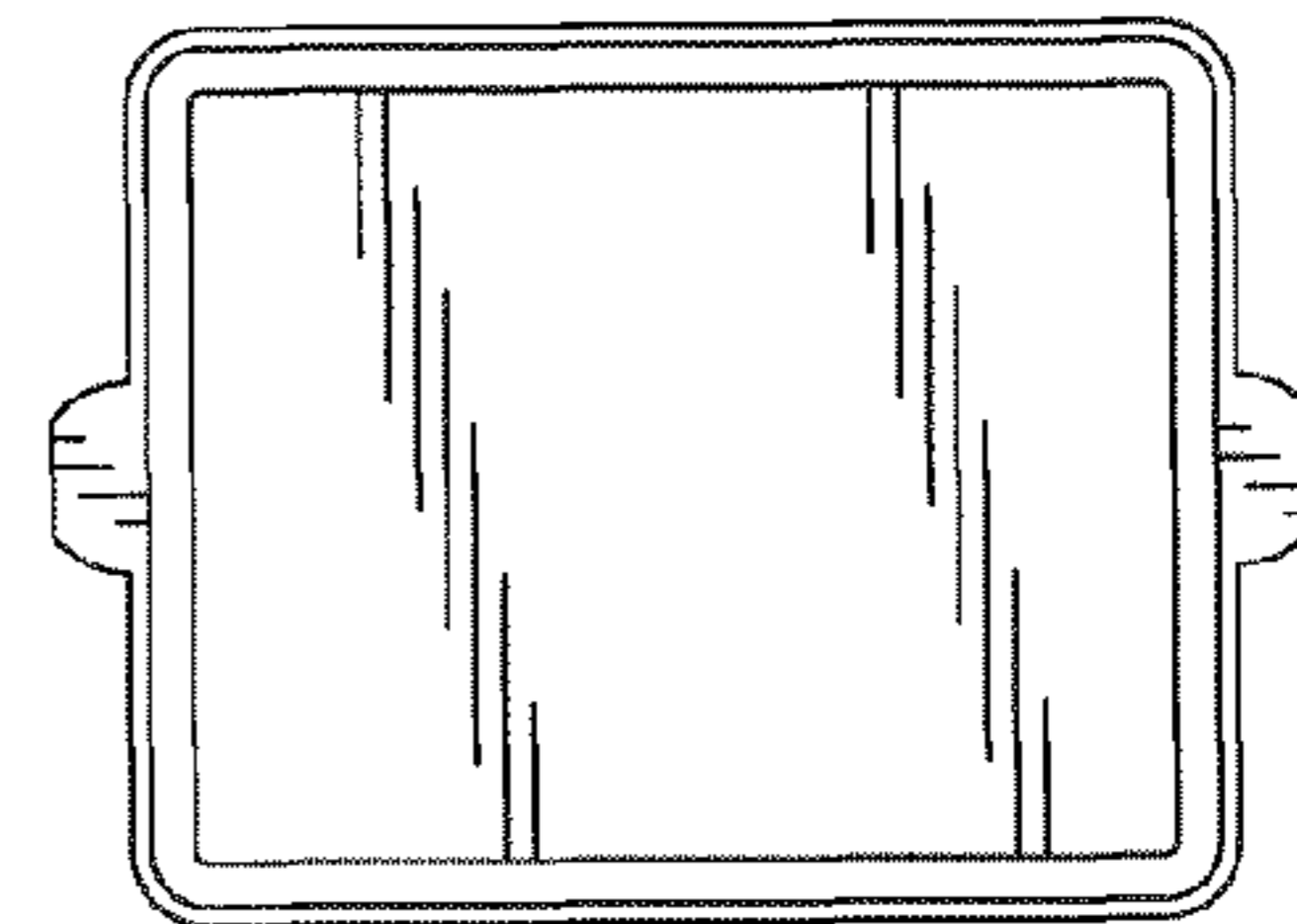

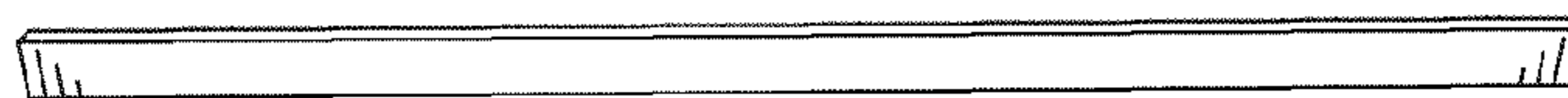

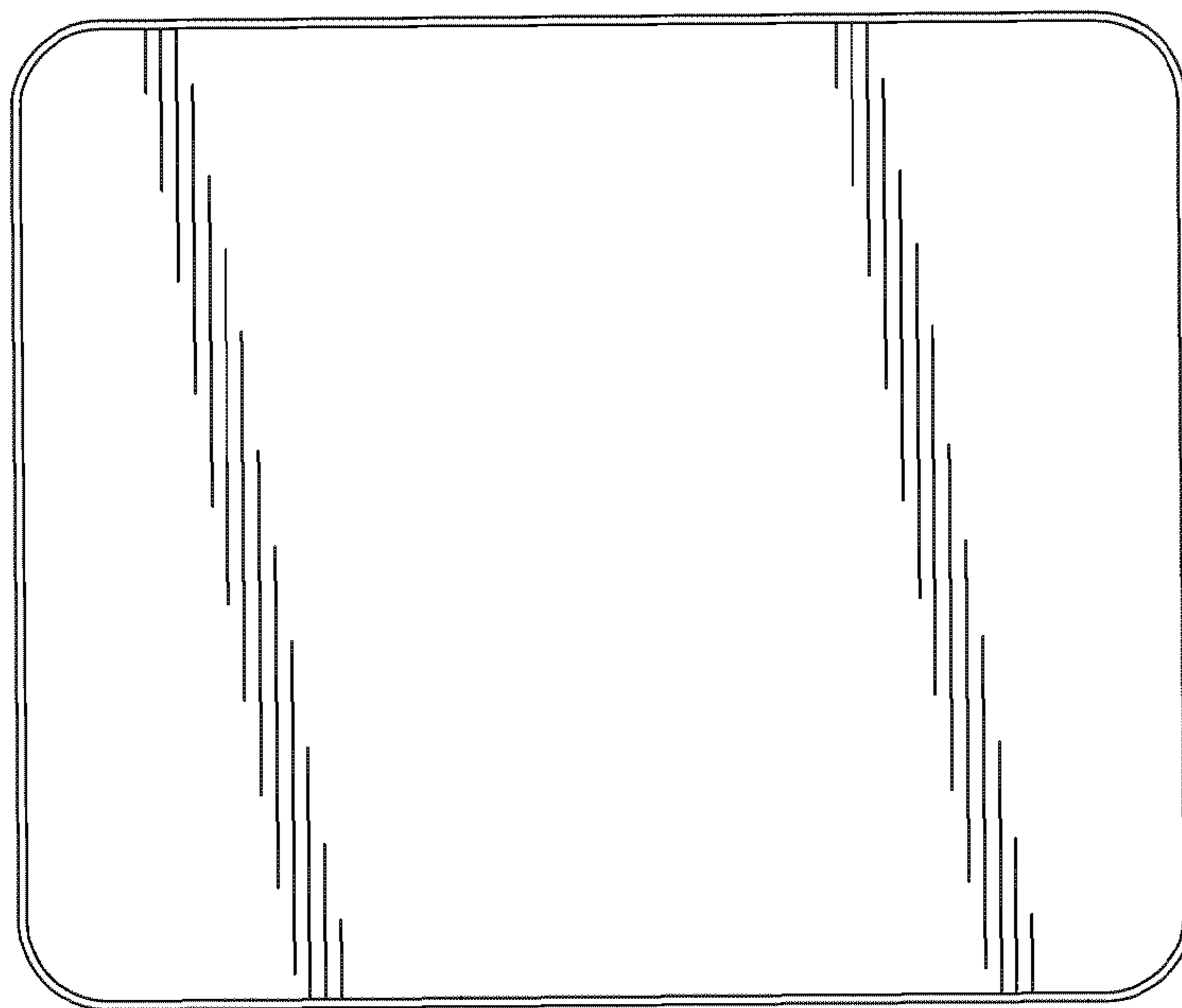

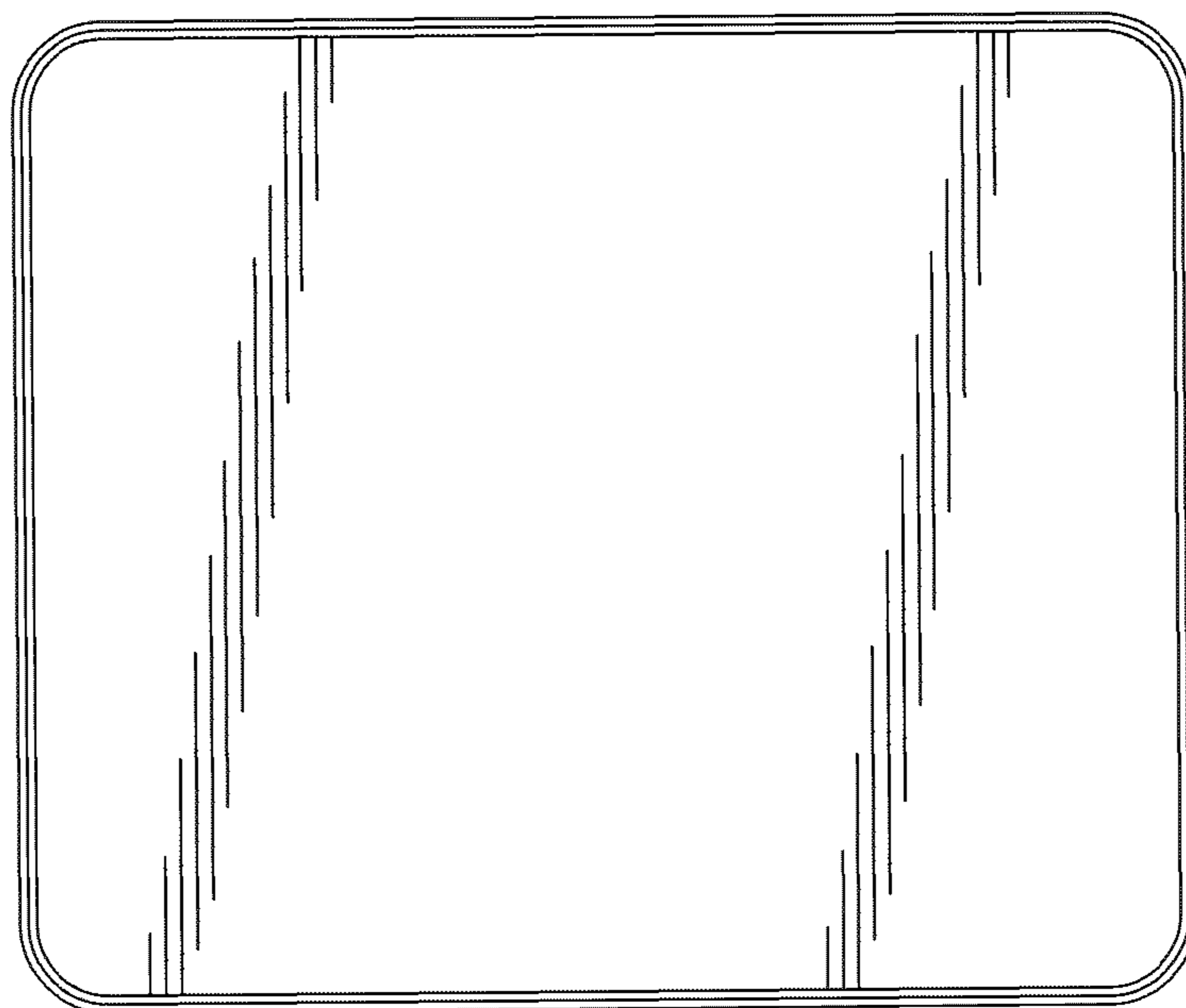
