(57) **CLAIM**

The ornamental design for a support cage for tomato plants and other live plants, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a support cage for tomato plants and other live plants showing our new design;

FIG. 2 is a side view thereof, the other side views being the same;

FIG. 3 is a top view thereof;

FIG. 4 is a bottom view thereof; and,

FIG. 5 is a section view thereof, taken on the line 5—5 of FIG. 3.

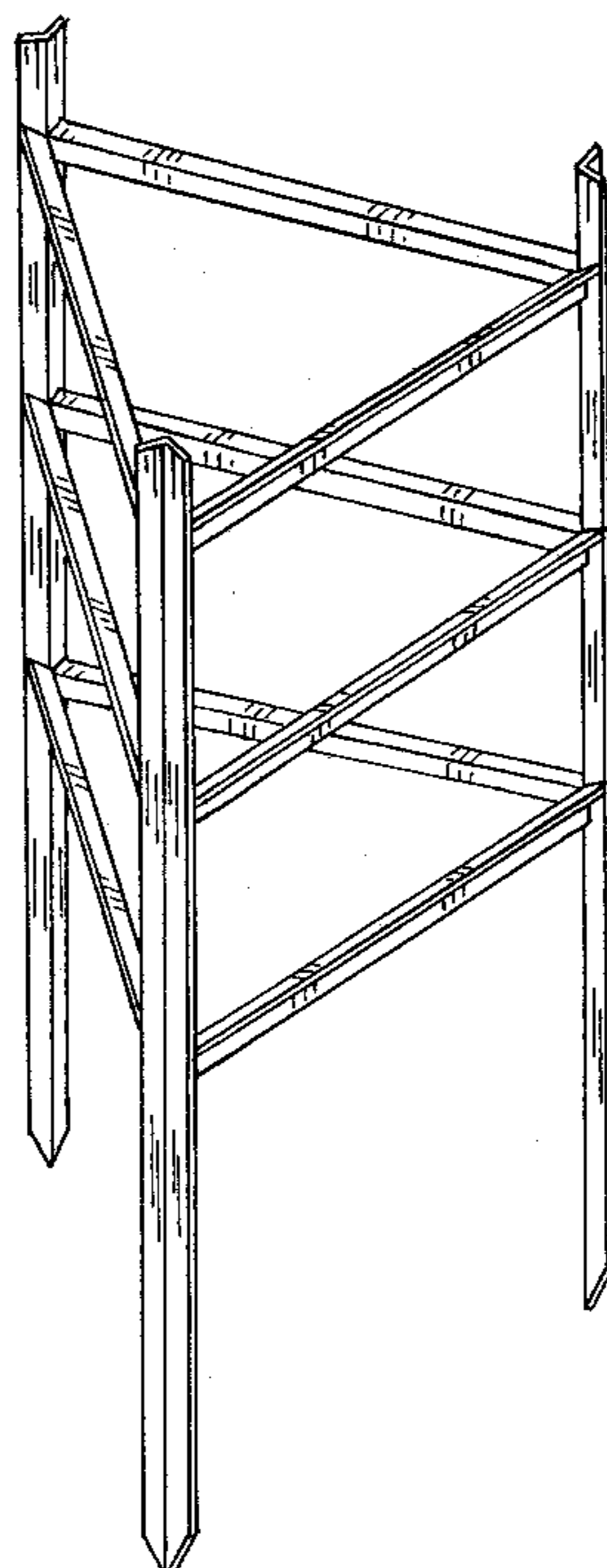

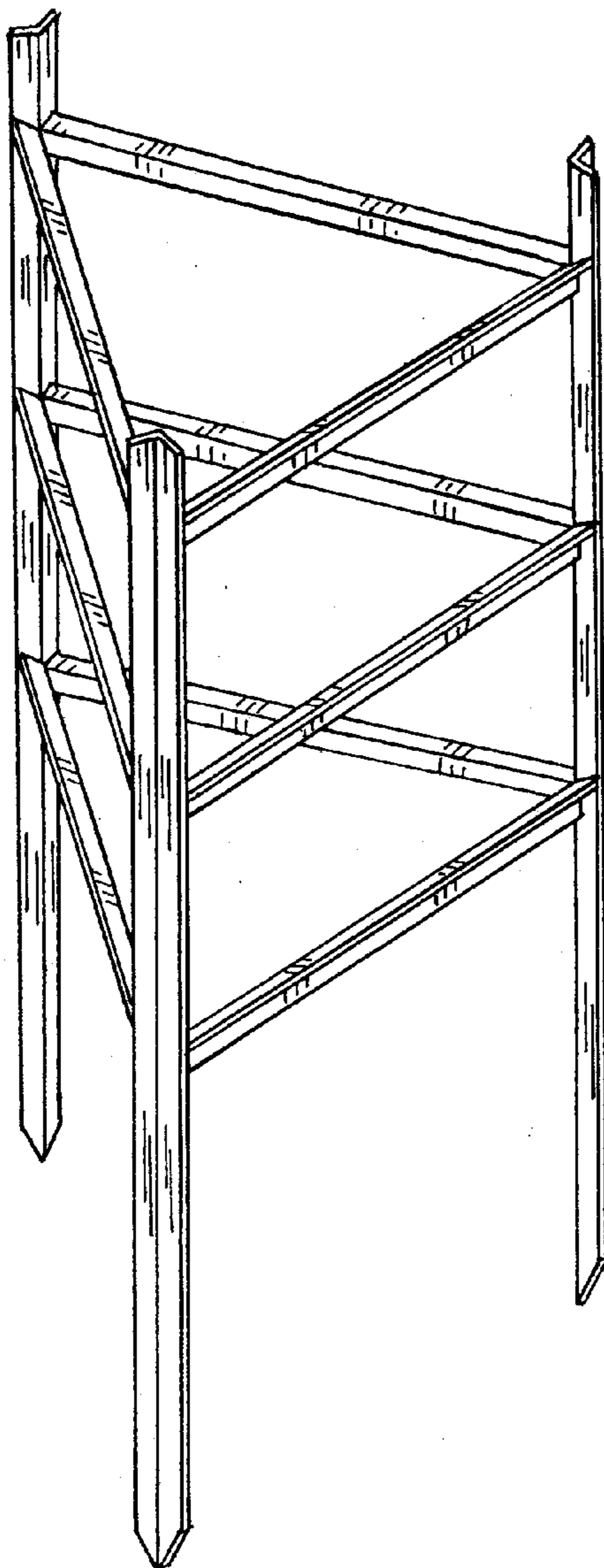

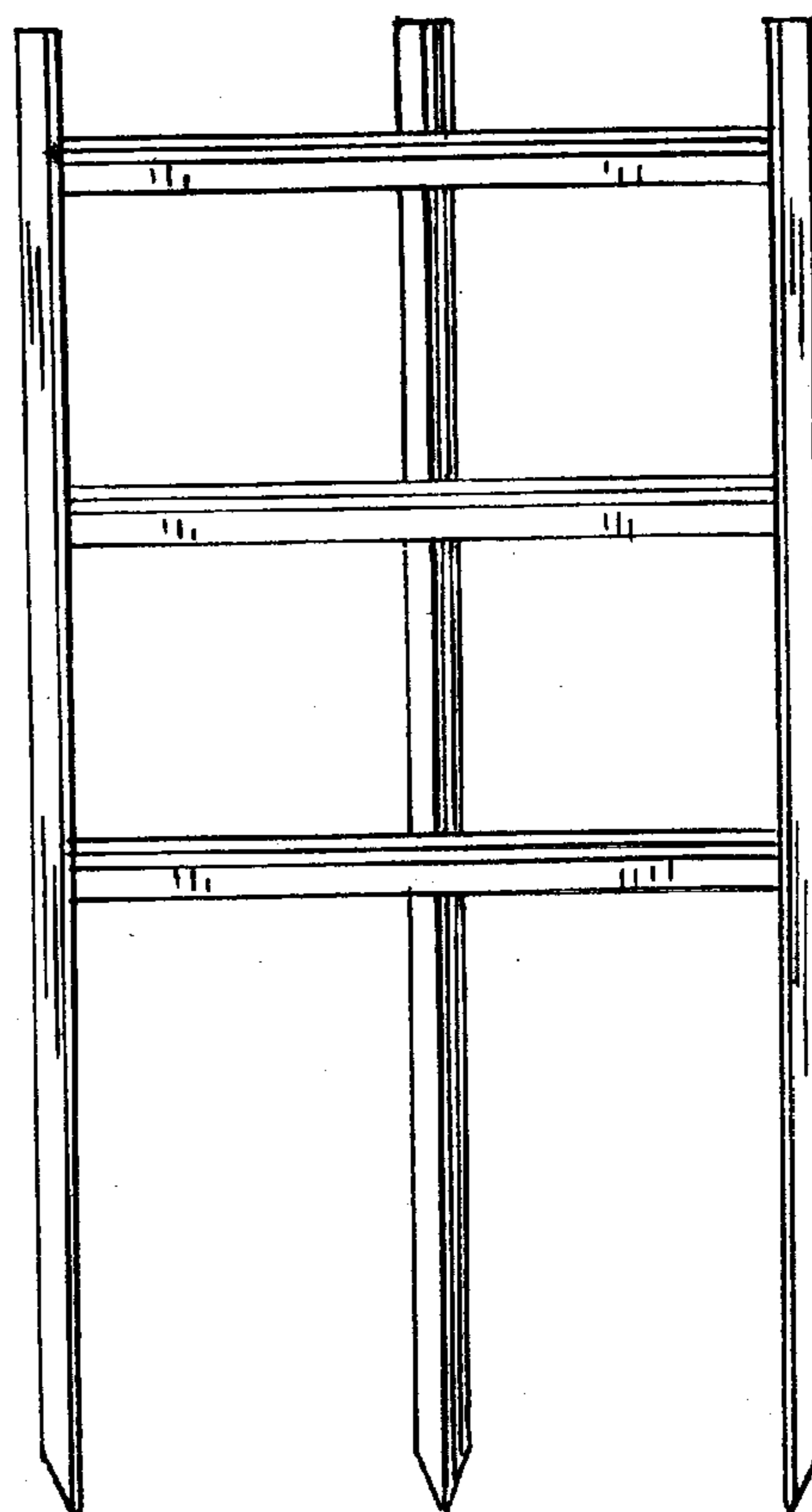

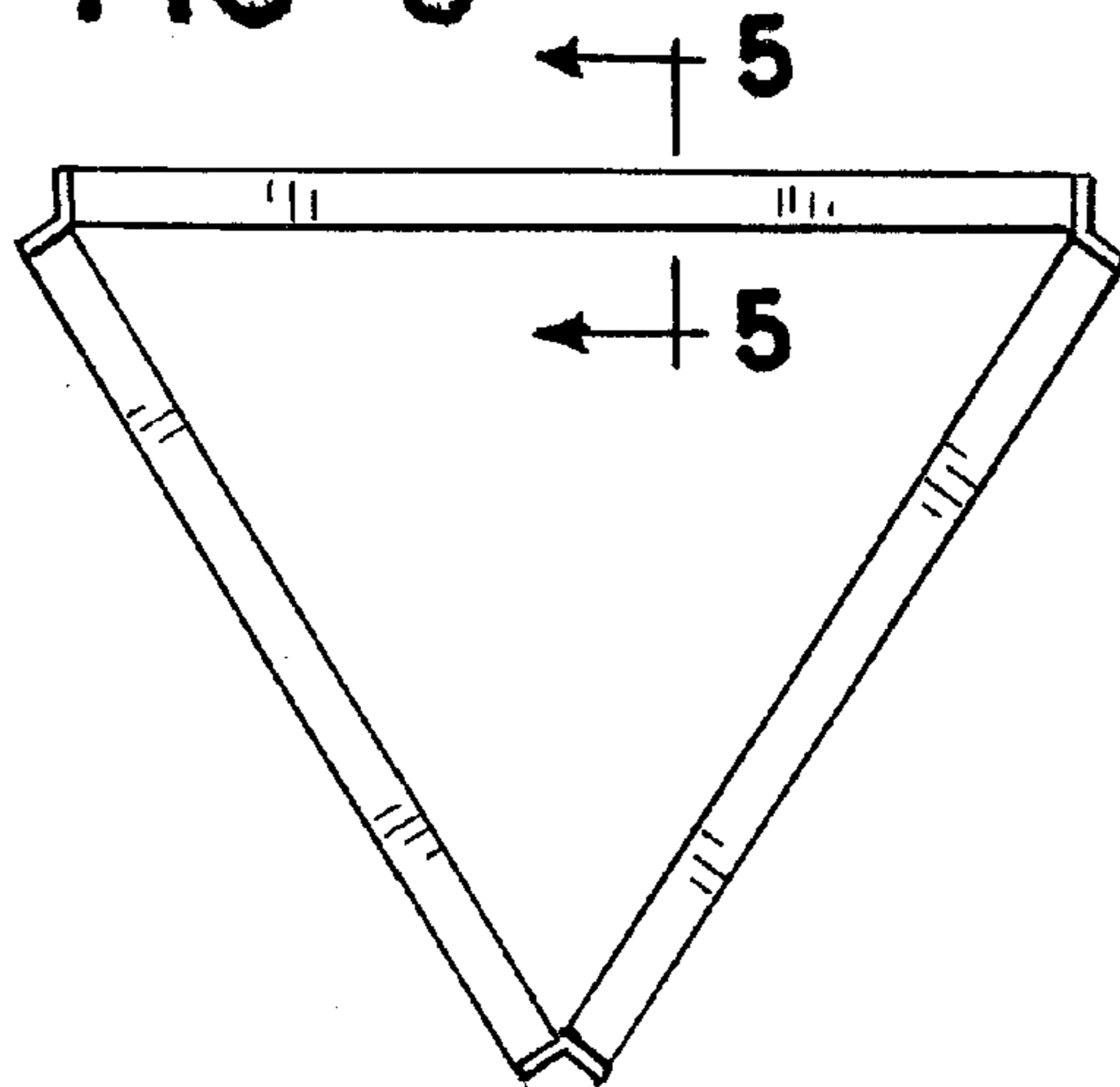

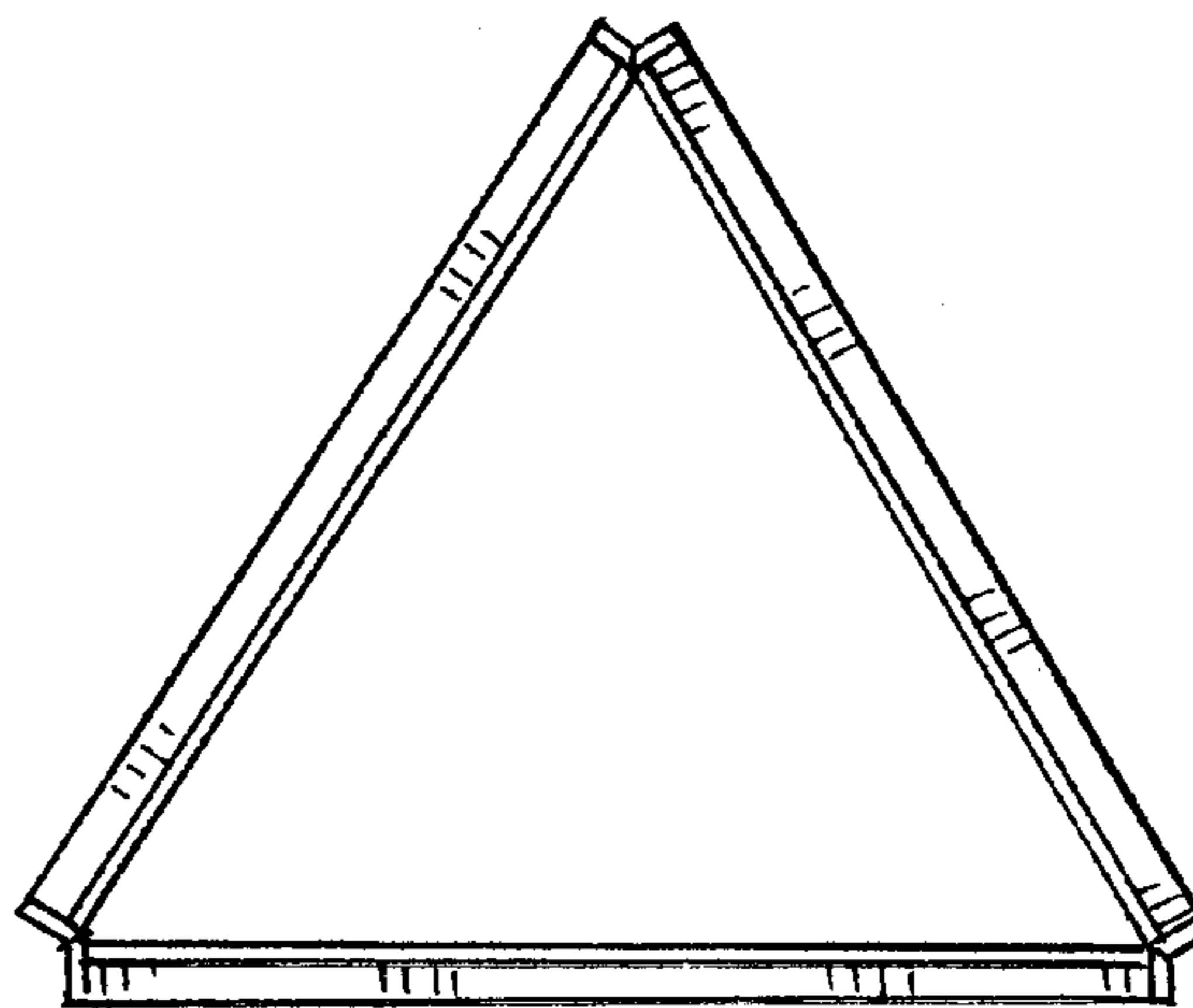
