(57) **CLAIM**

We claim the ornamental design for a blast lock handle with angled body, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a blast lock handle with angled body showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a side elevation view thereof;

FIG. 4 is an opposite side elevational view thereof;

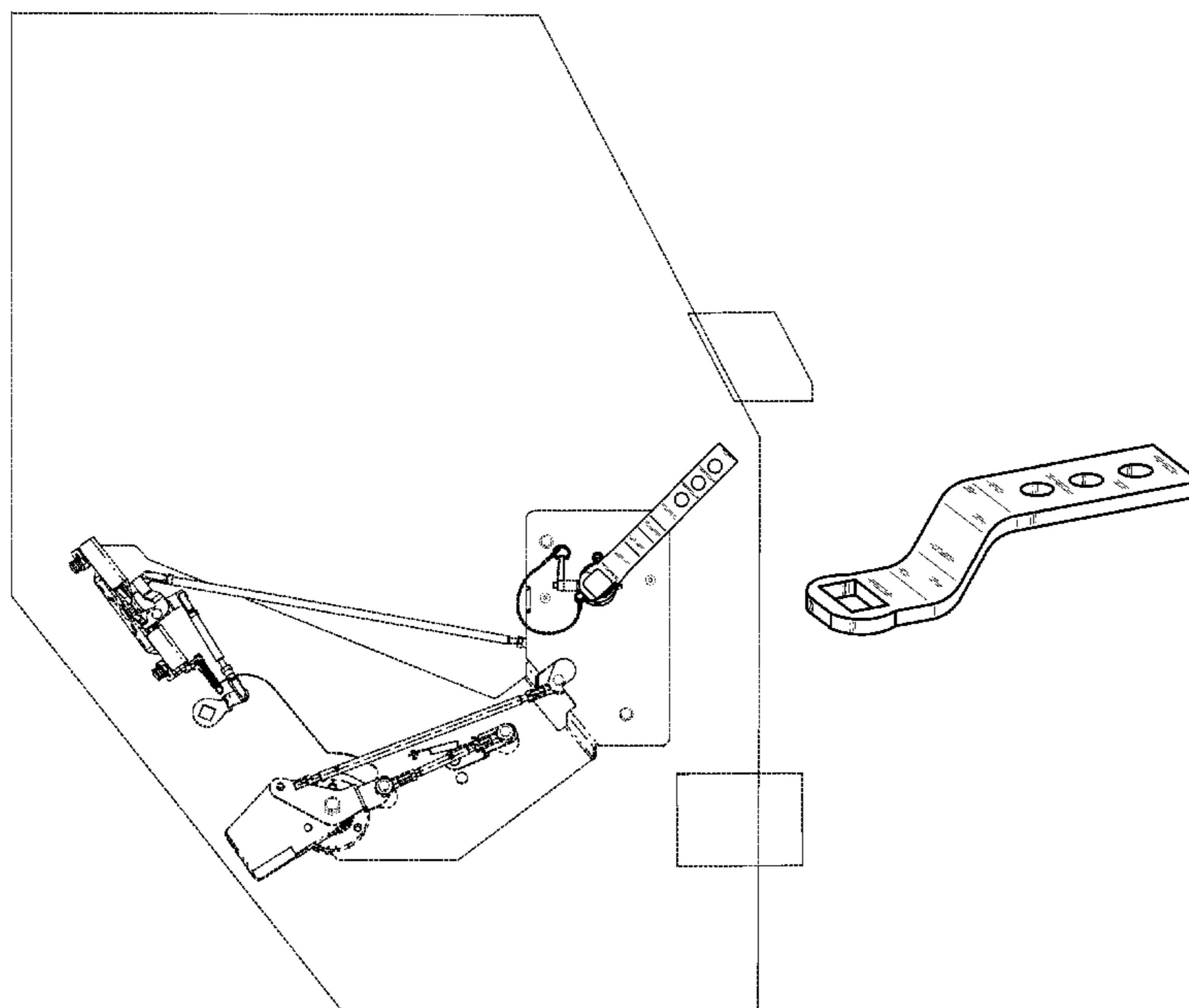
FIG. 5 is an end elevational view thereof;

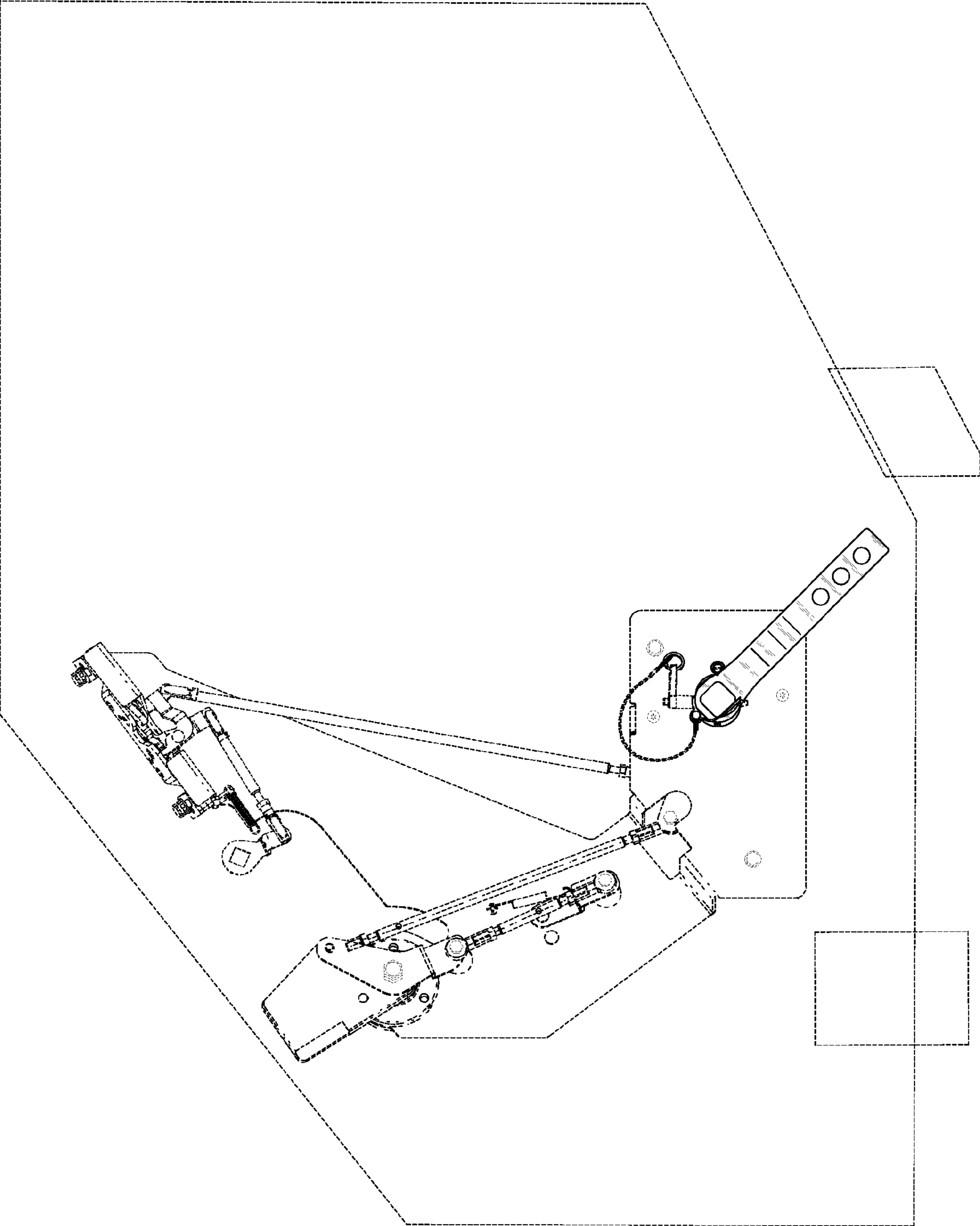

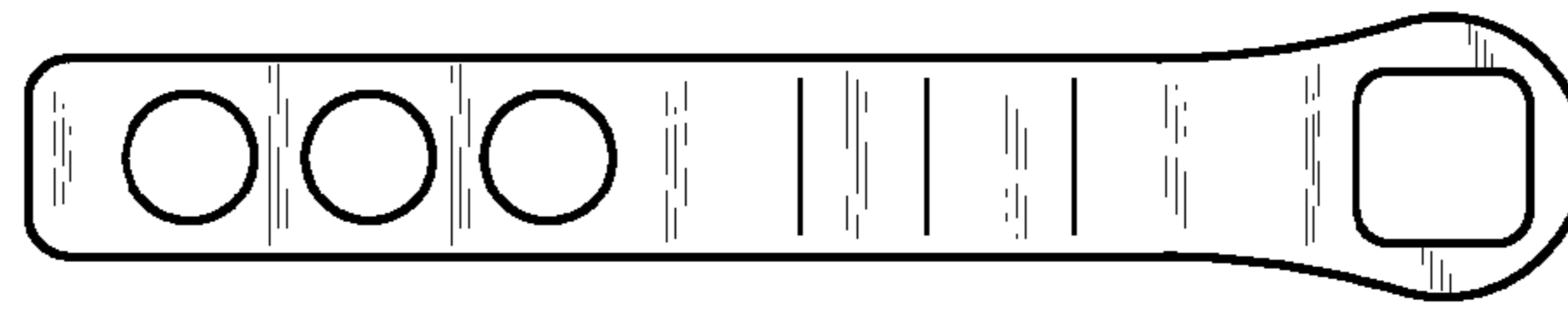

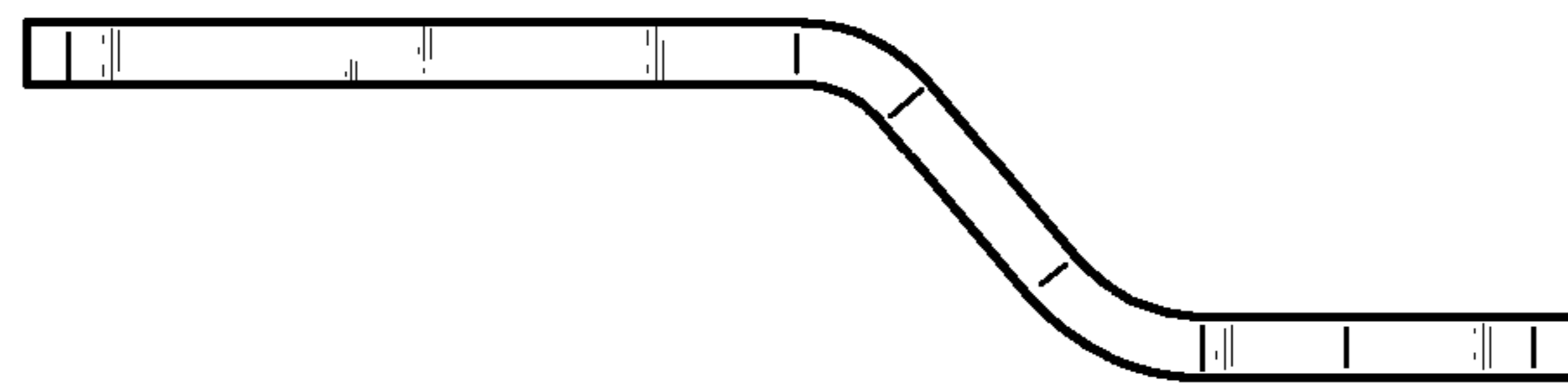

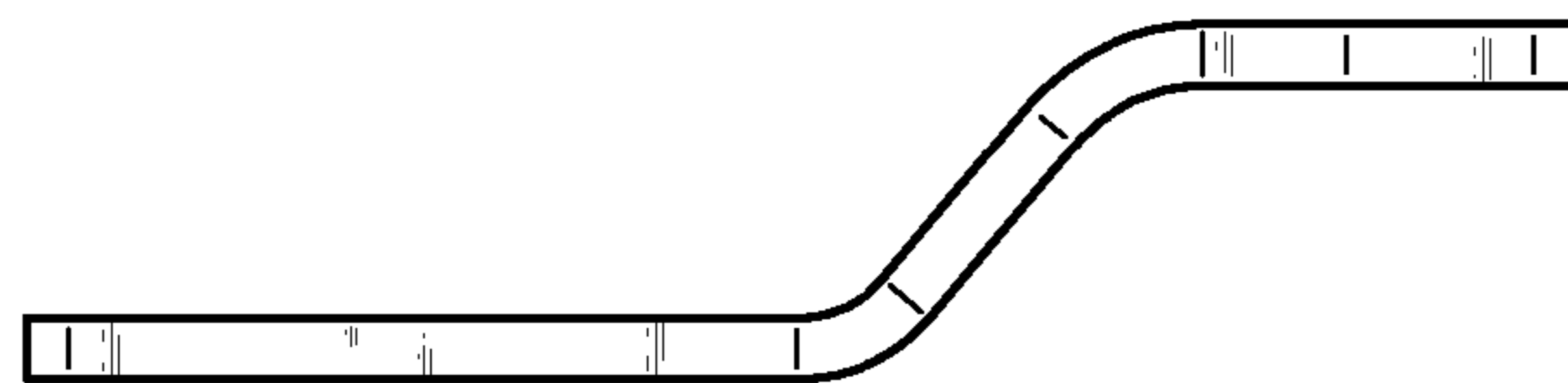

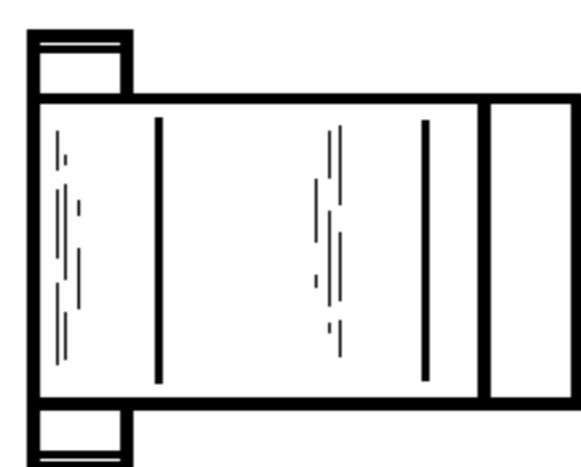

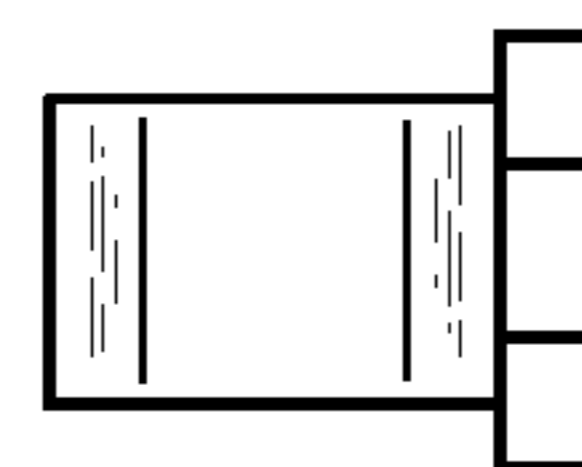

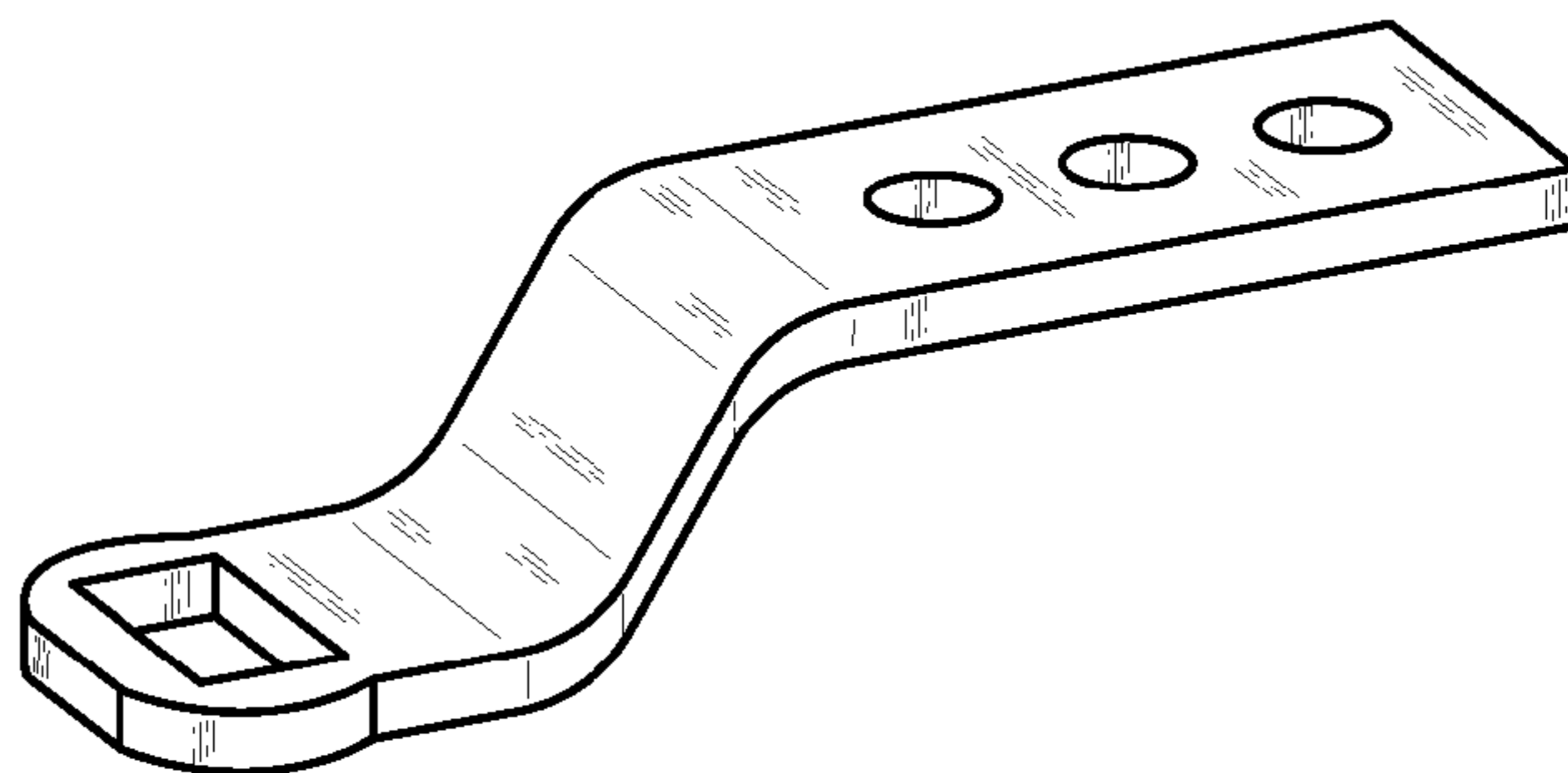
