(57) **CLAIM**

The new, original, and ornamental design for a tamper evident lid for a container, as shown and described.

DESCRIPTION

FIG. 1 is a top, left, and front perspective view of a tamper evident lid for a container;

FIG. 2 is a top plan view thereof;

FIG. 3 is a bottom plan view thereof;

FIG. 4 is a top, right, and front perspective view thereof when in a closed position;

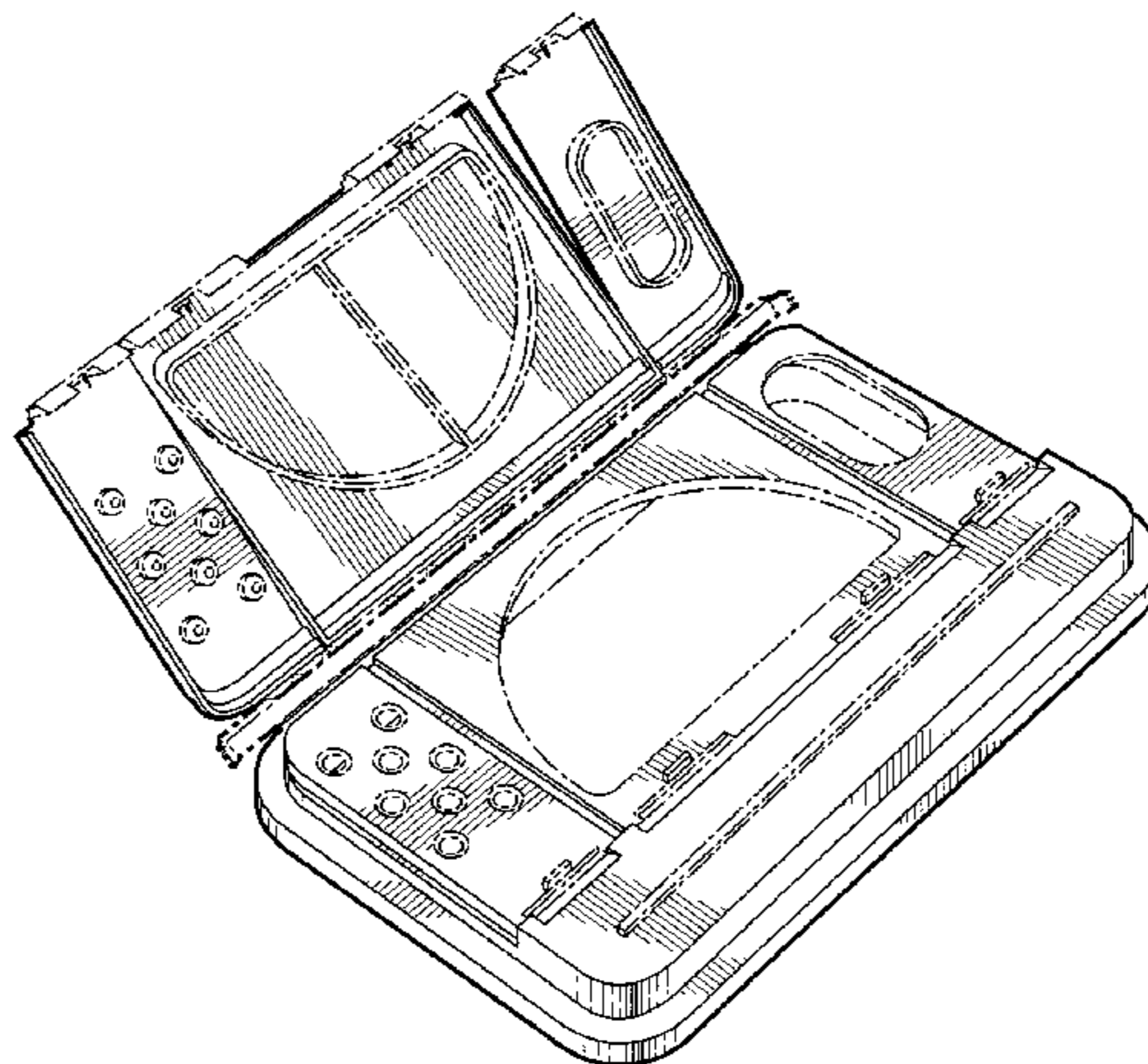
FIG. 5 is a right side elevational view thereof;

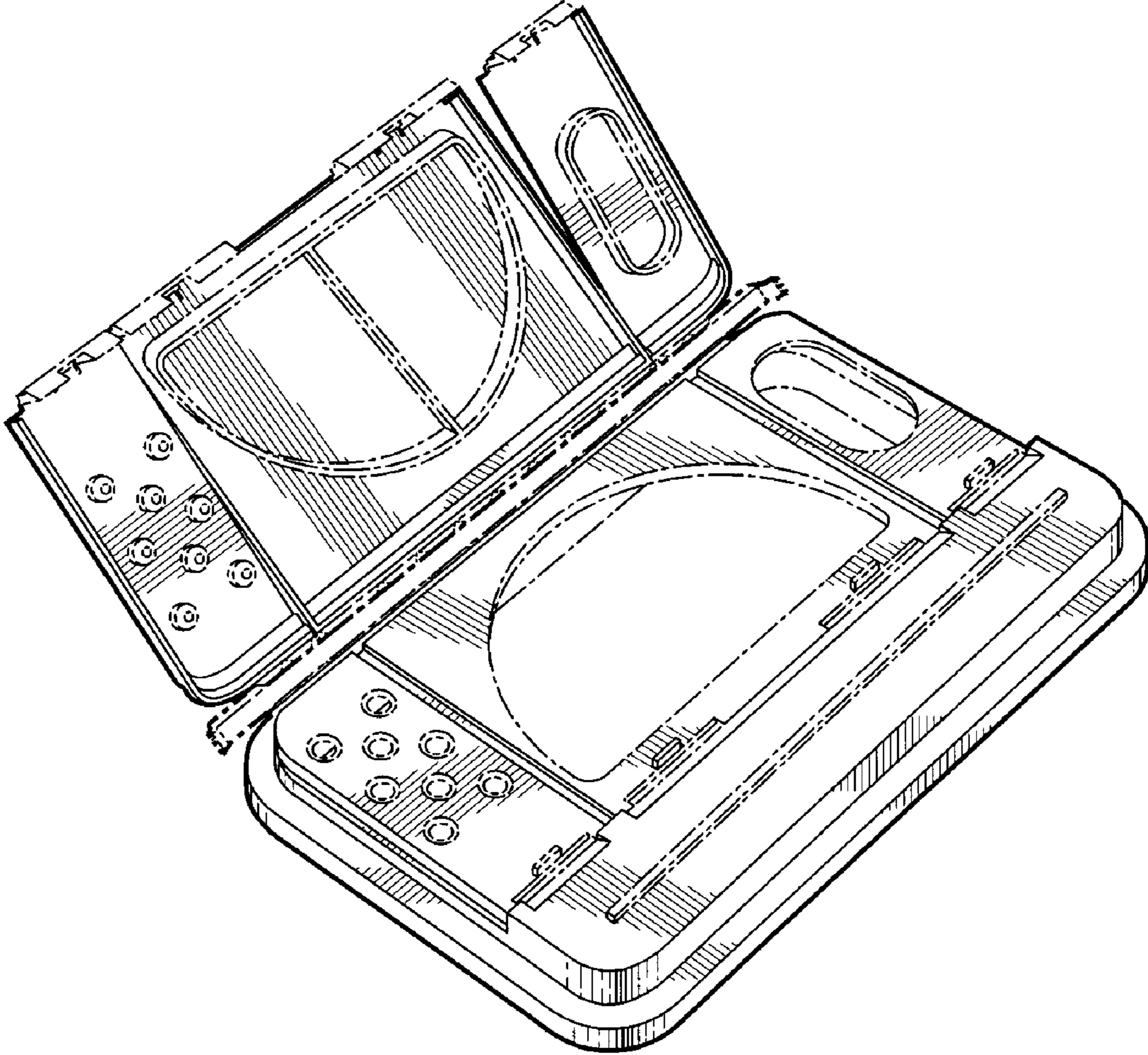

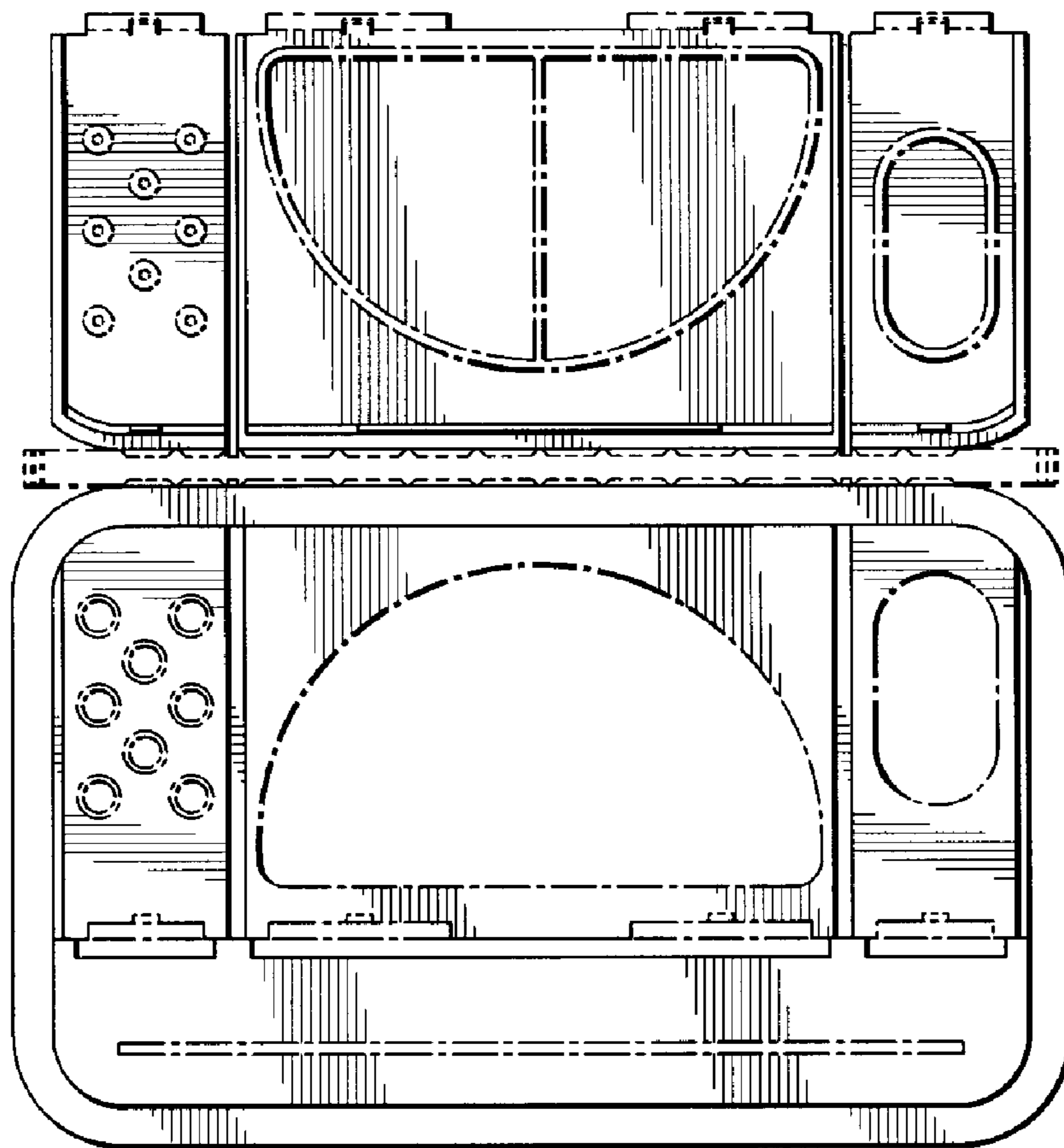

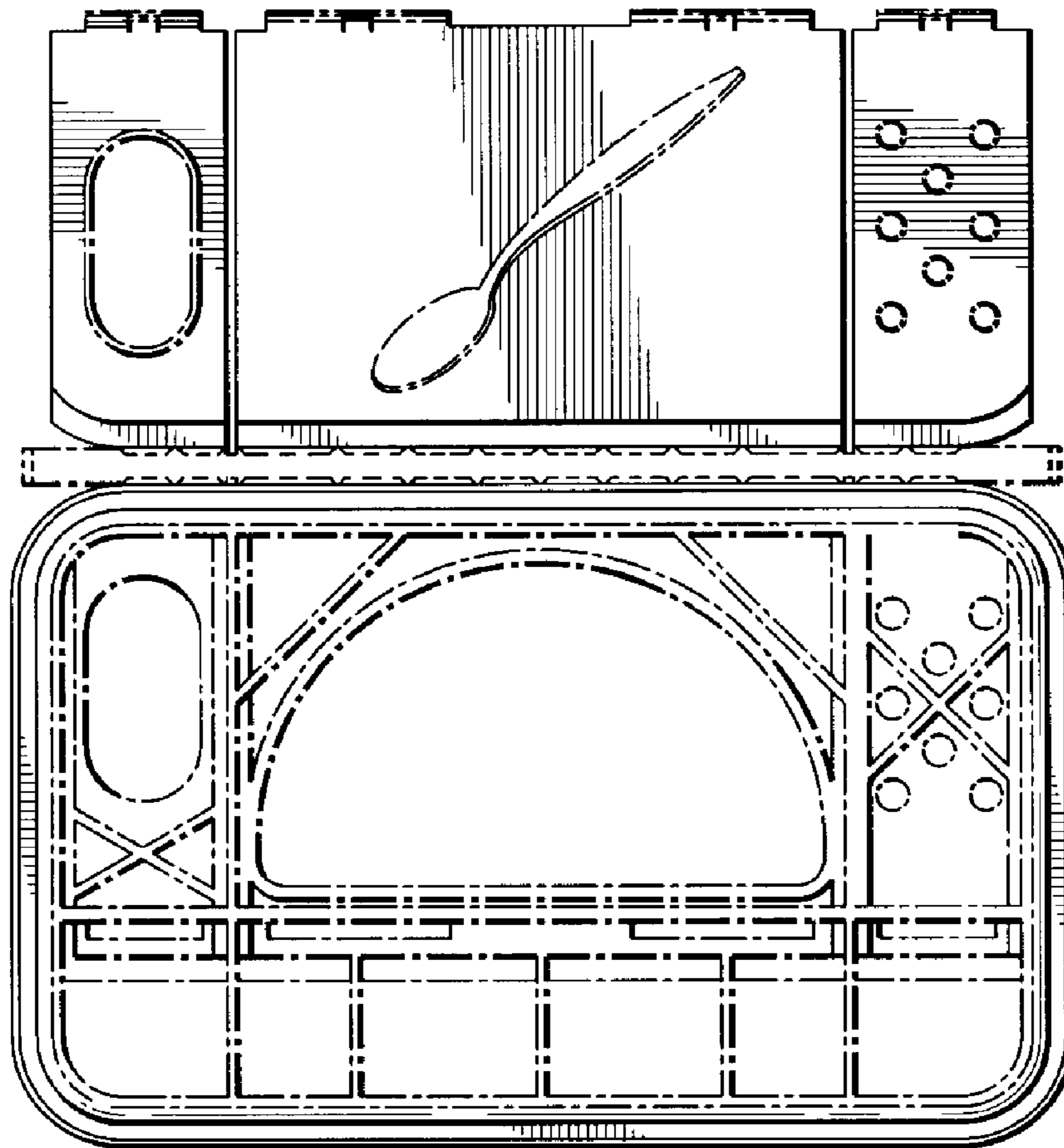

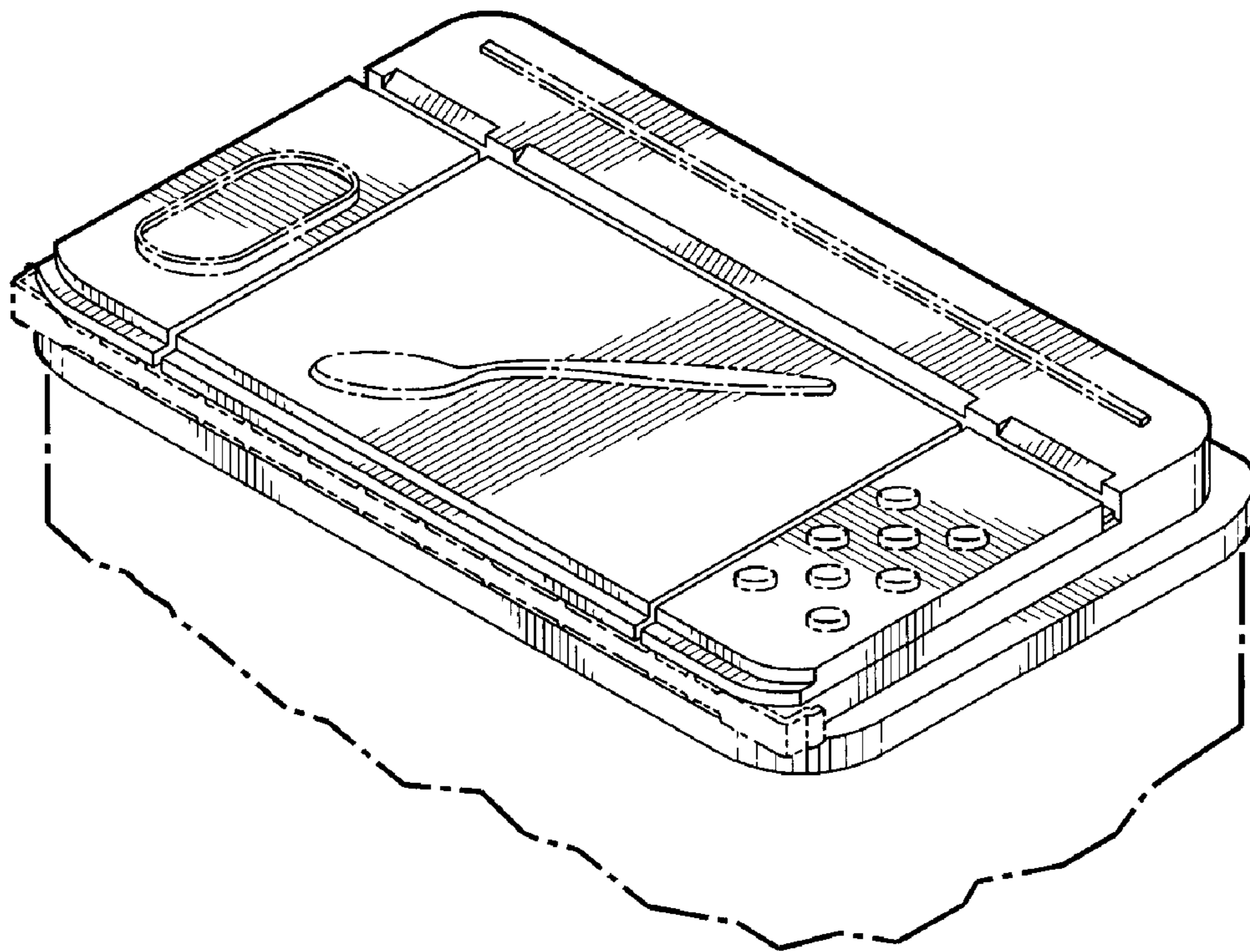

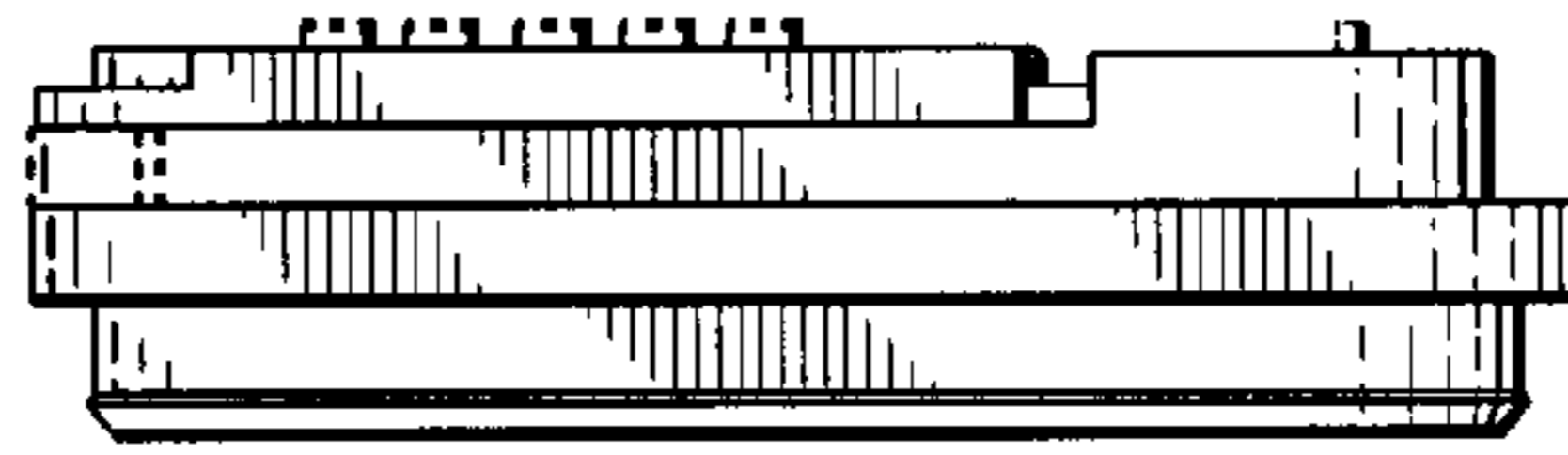

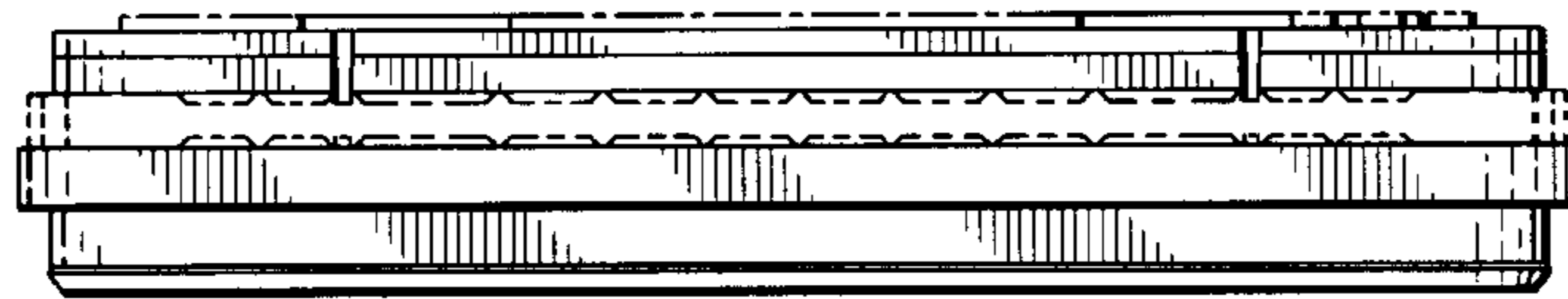

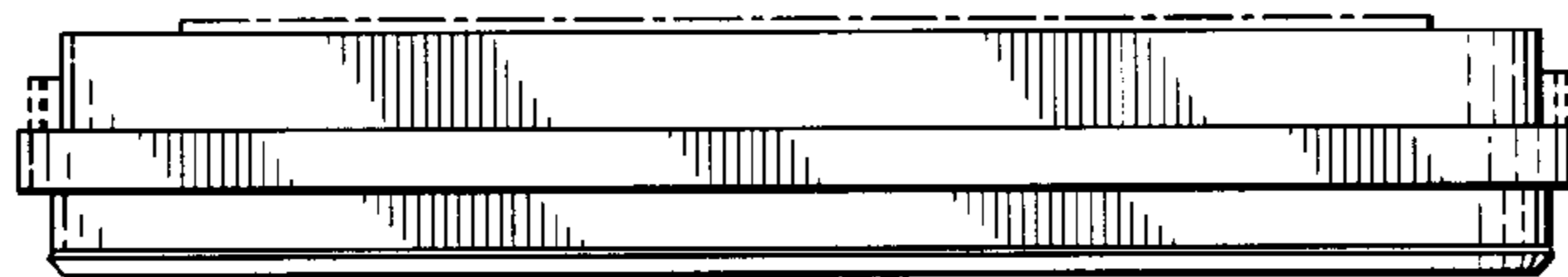
