**DESCRIPTION**

FIG. 3 is a front, elevation view of the bottle of FIG. 1;

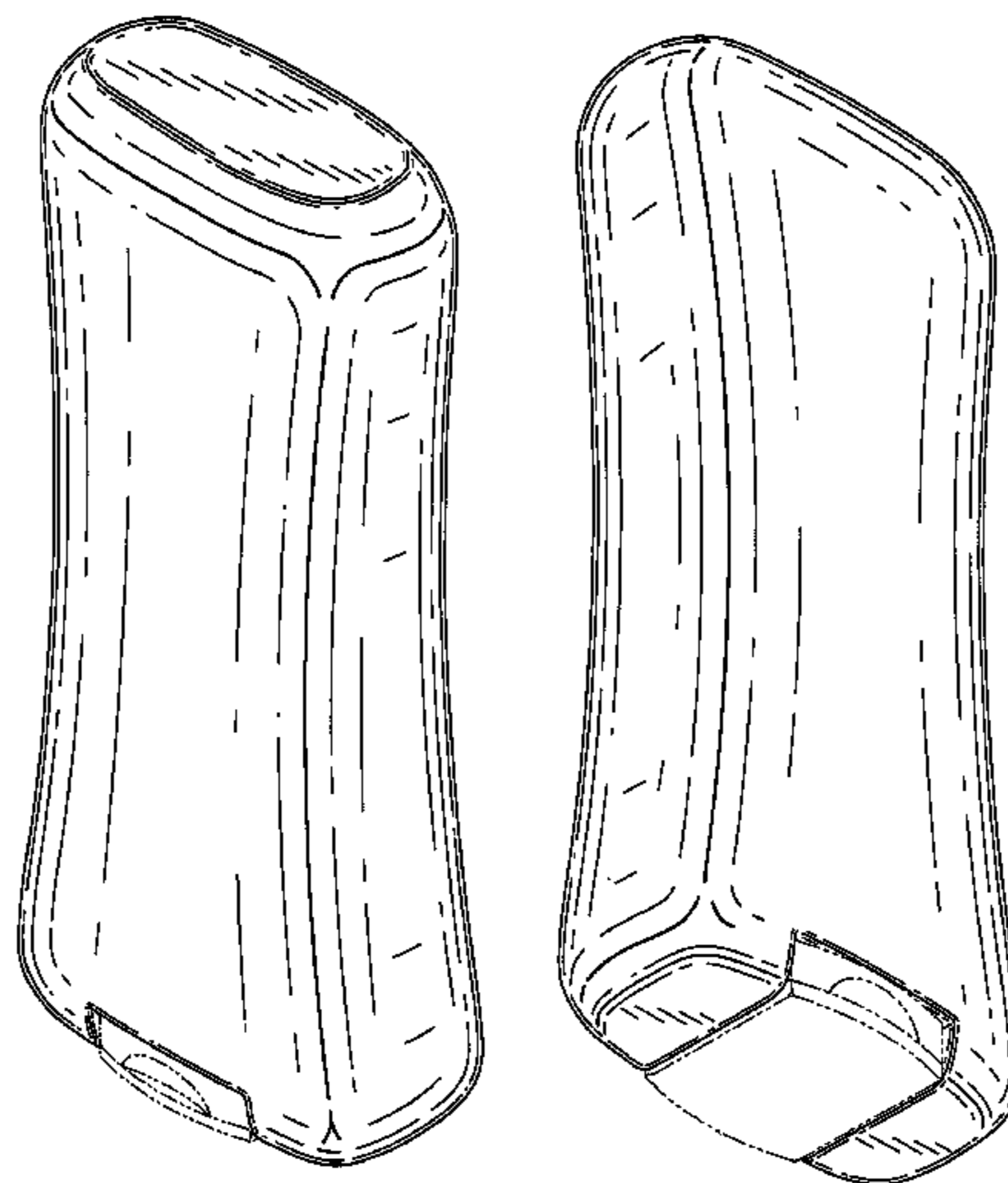
FIG. 4 is a rear, elevation view of the bottle of FIG. 1;

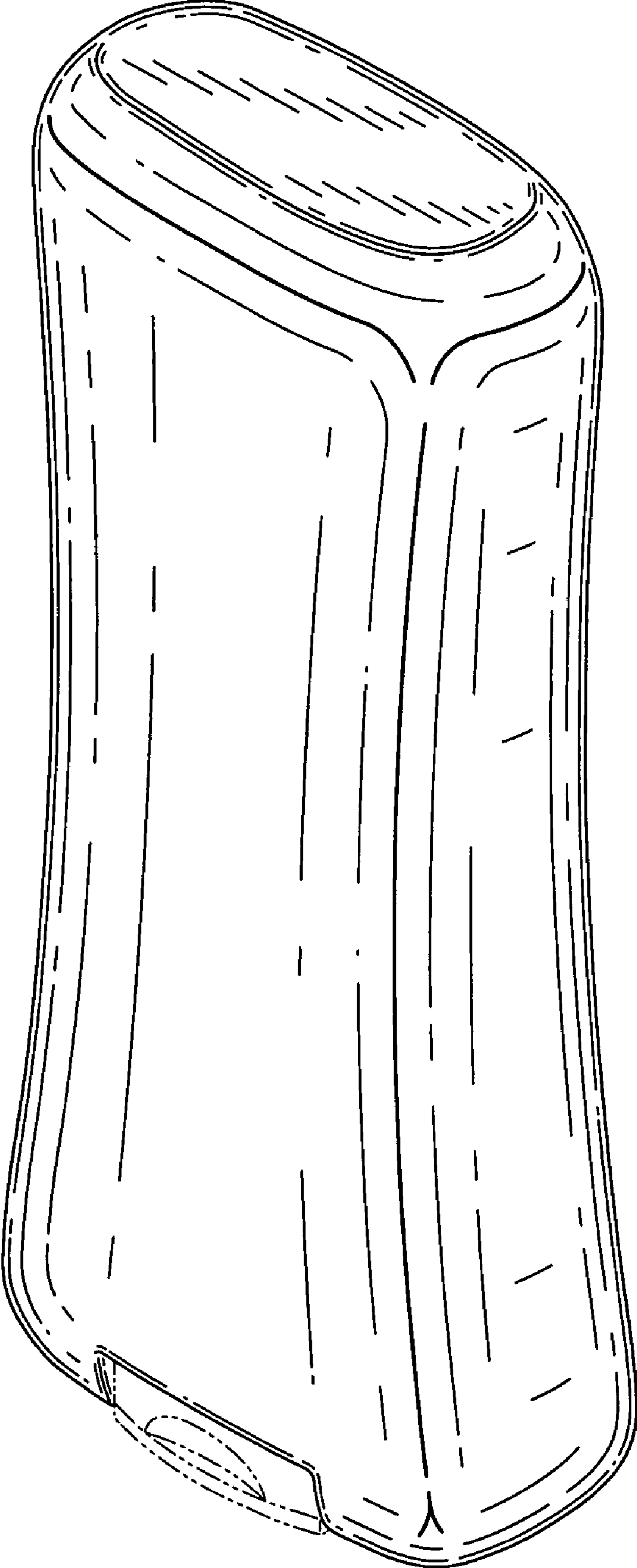

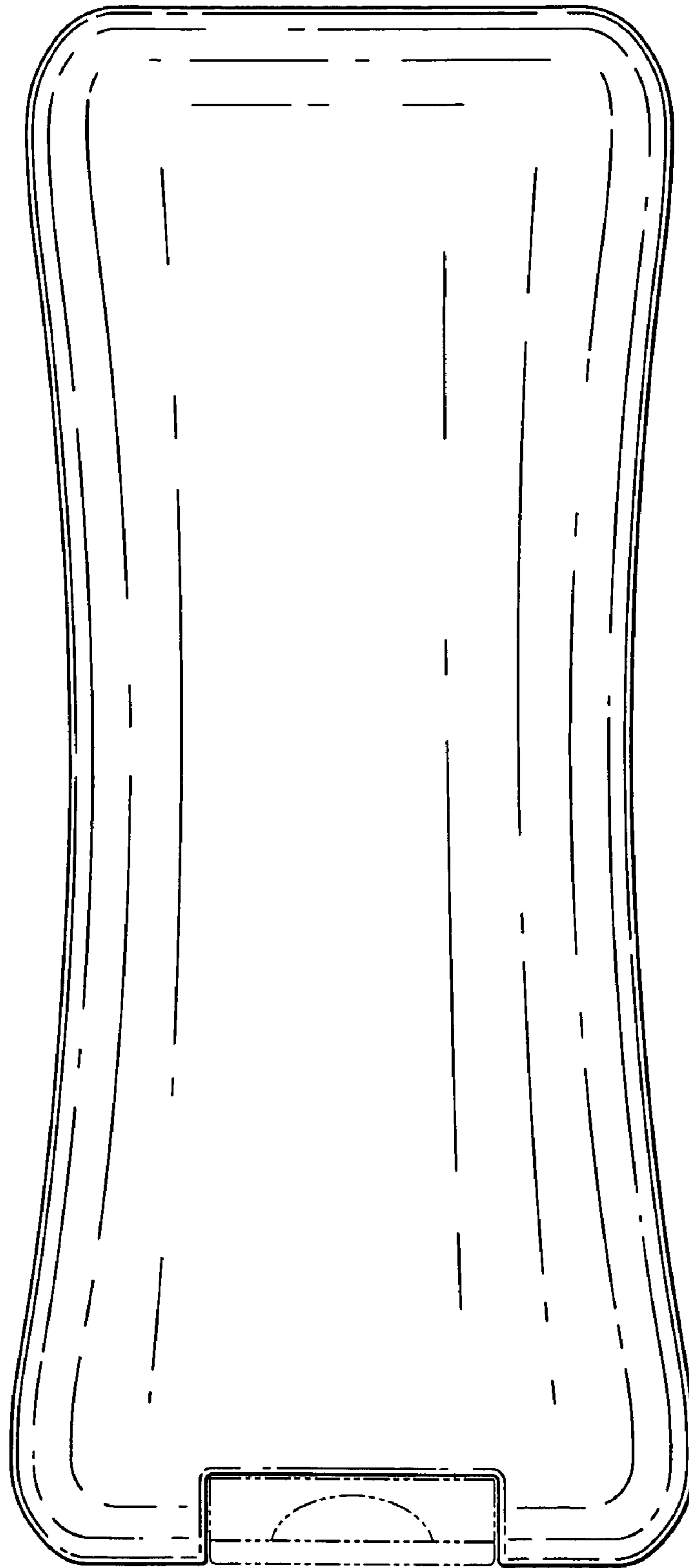

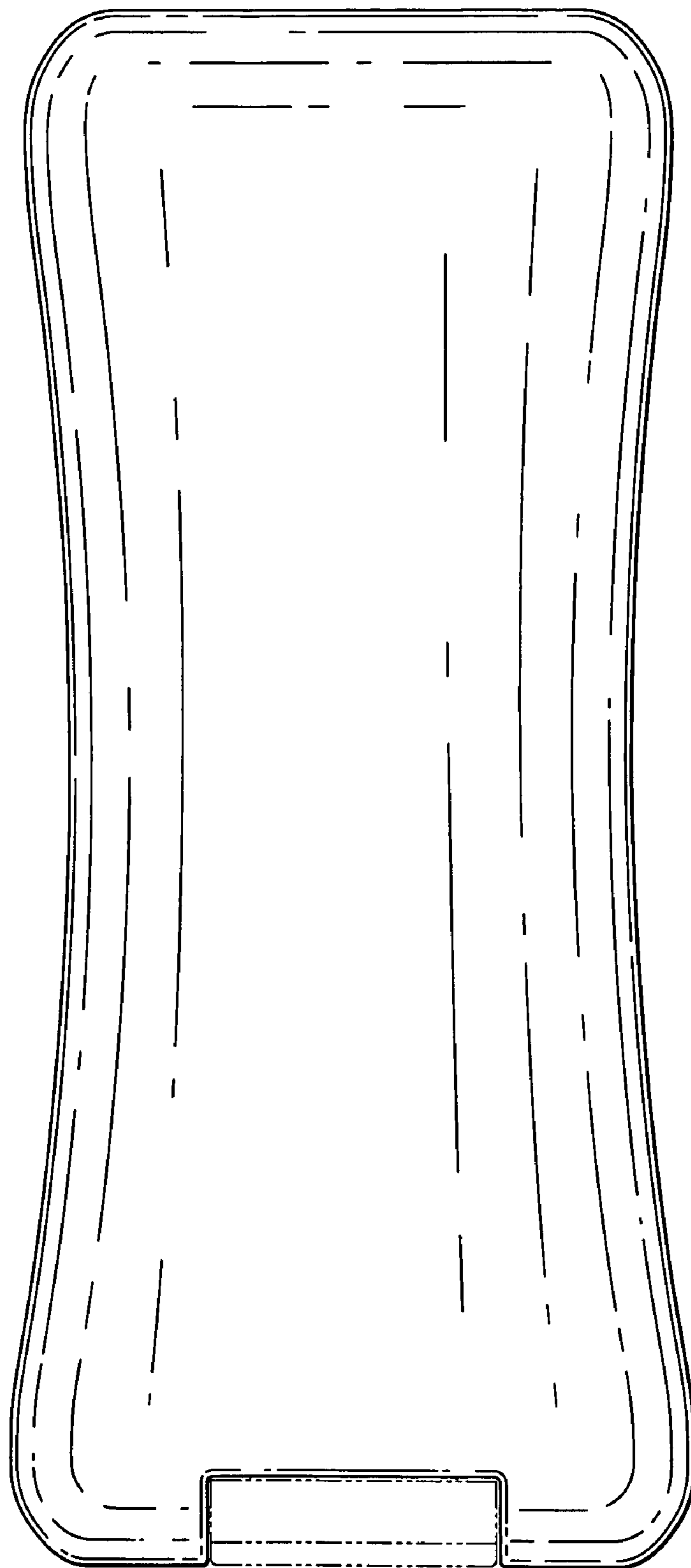

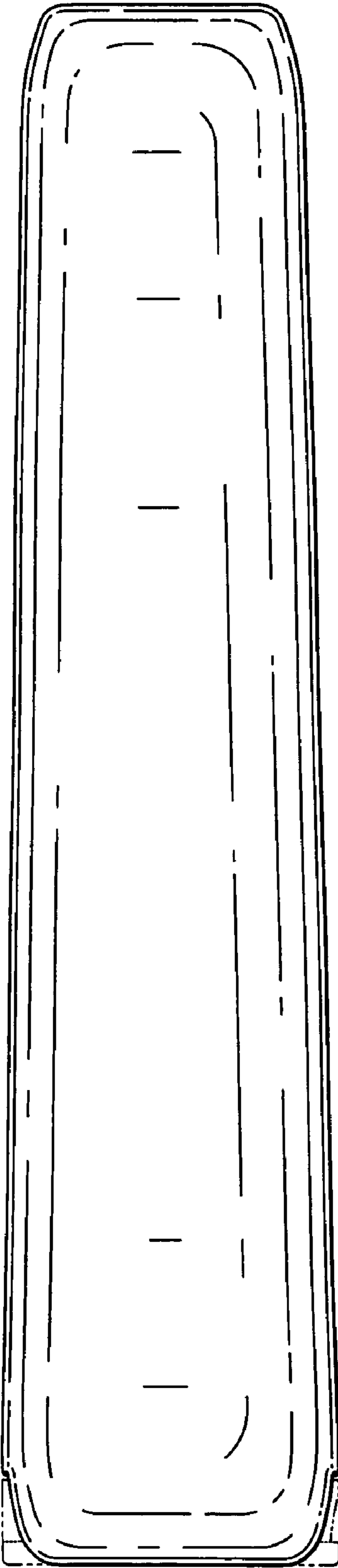

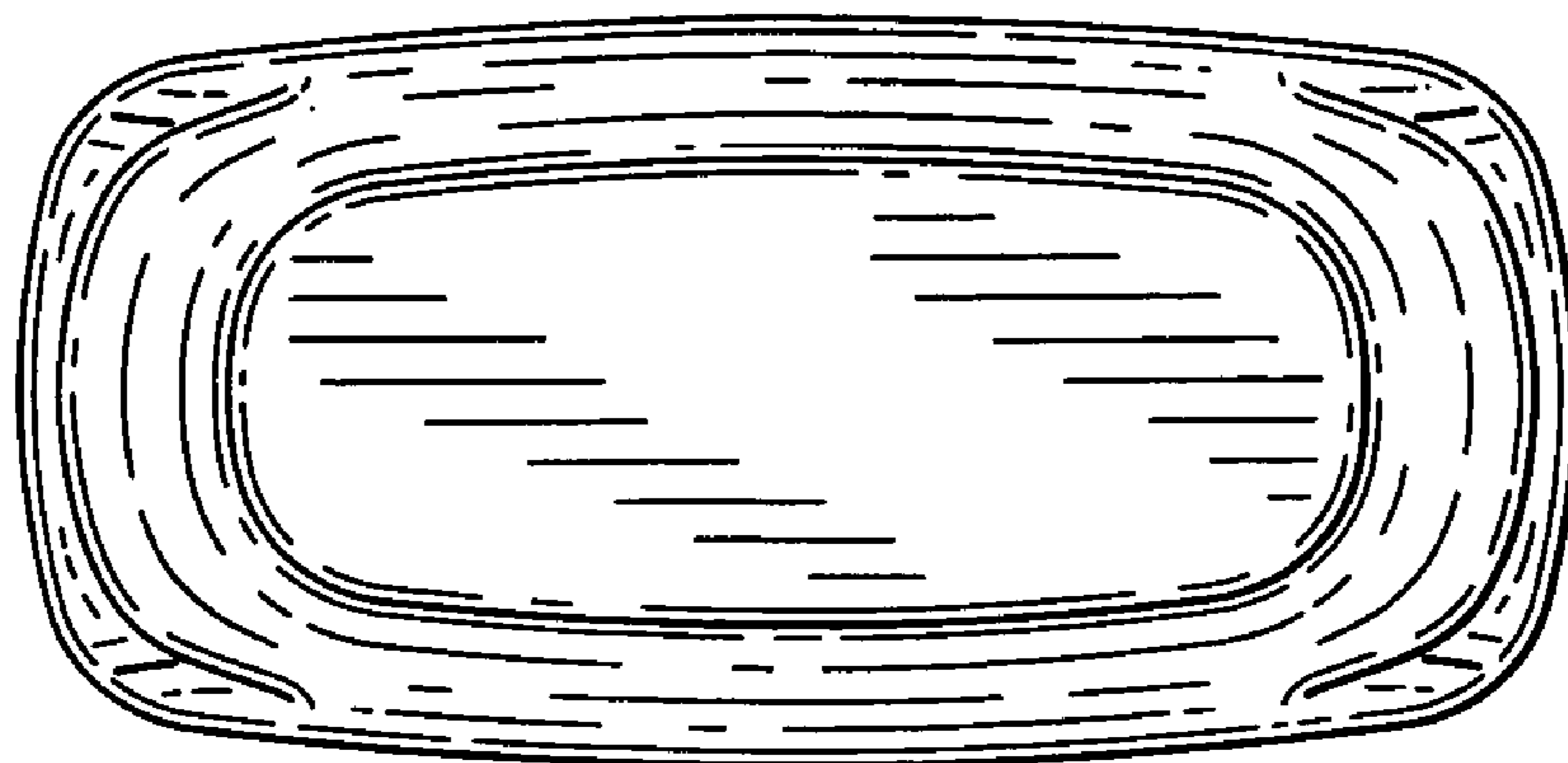

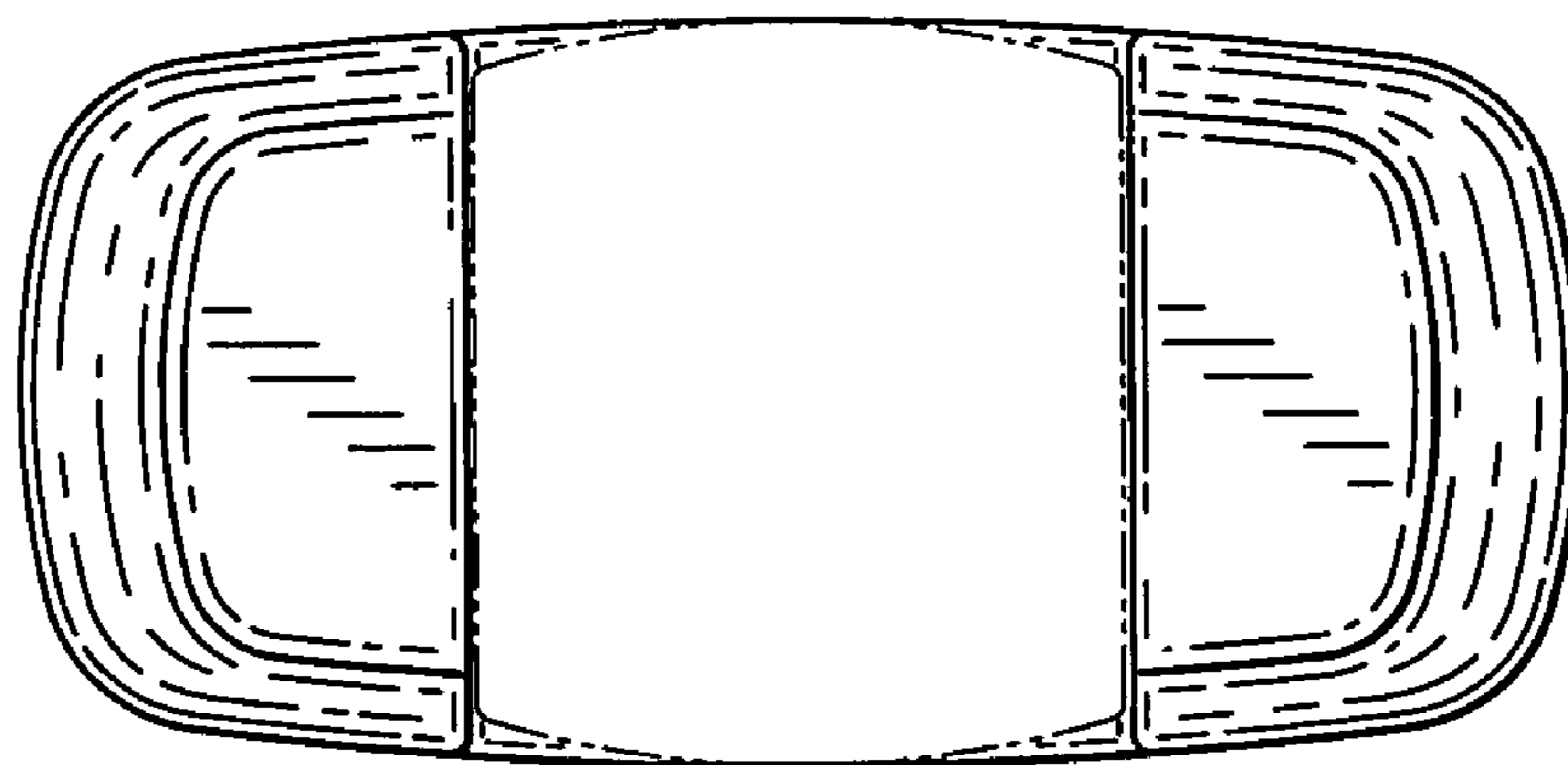
