DESCRIPTION

FIG. 1 is a front view of my new, original and ornamental design for a watch;

FIG. 2 is a rear view thereof;

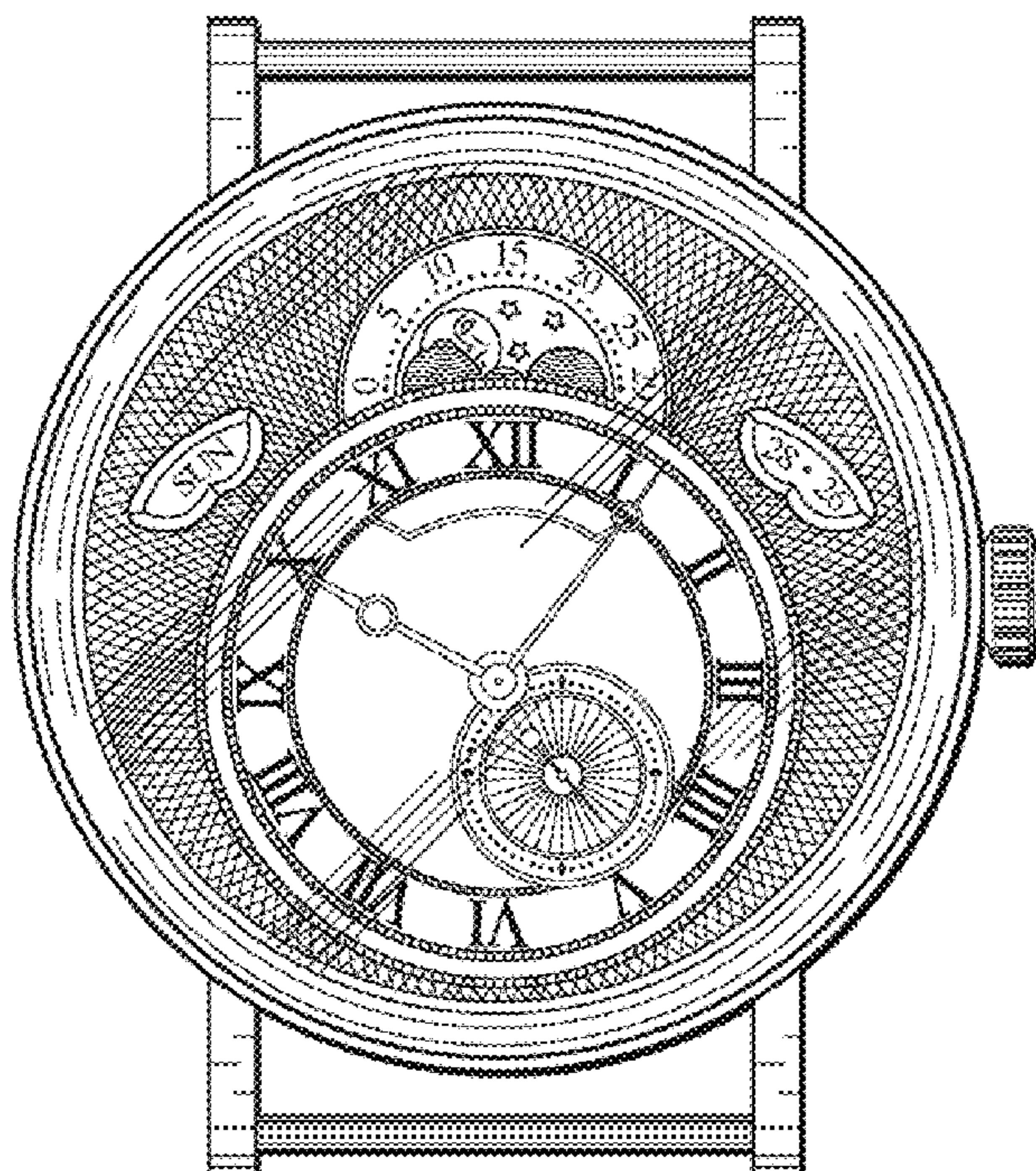

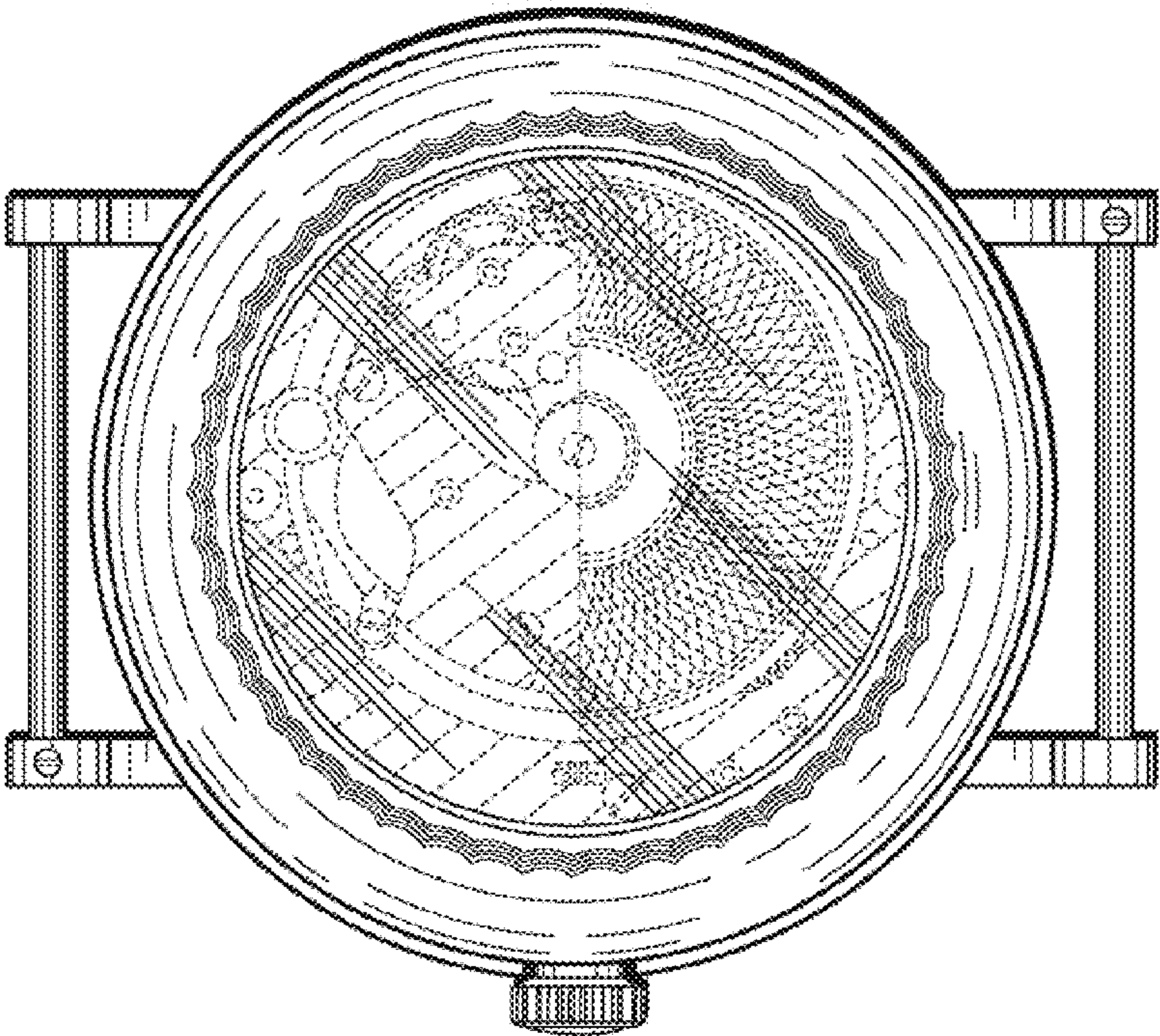

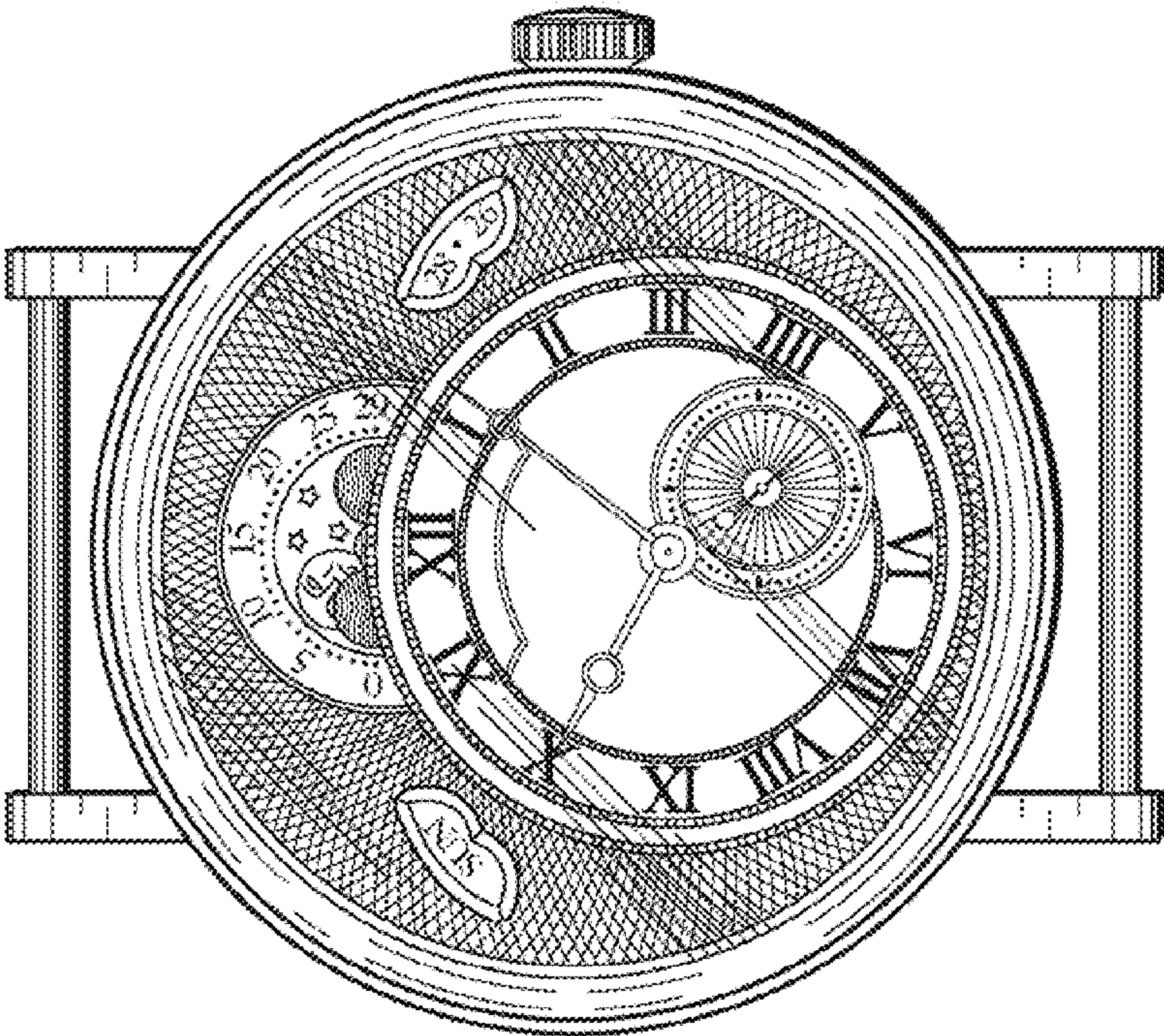

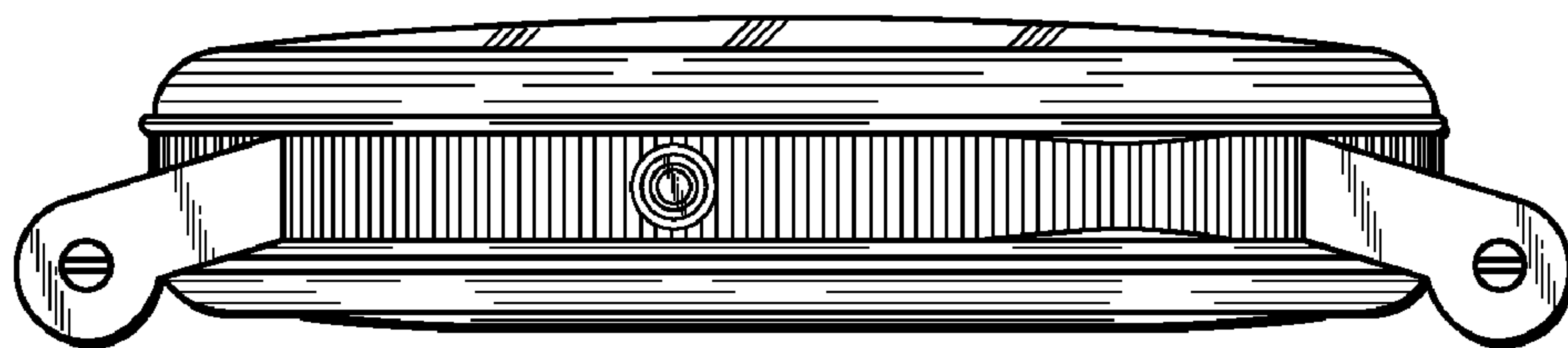

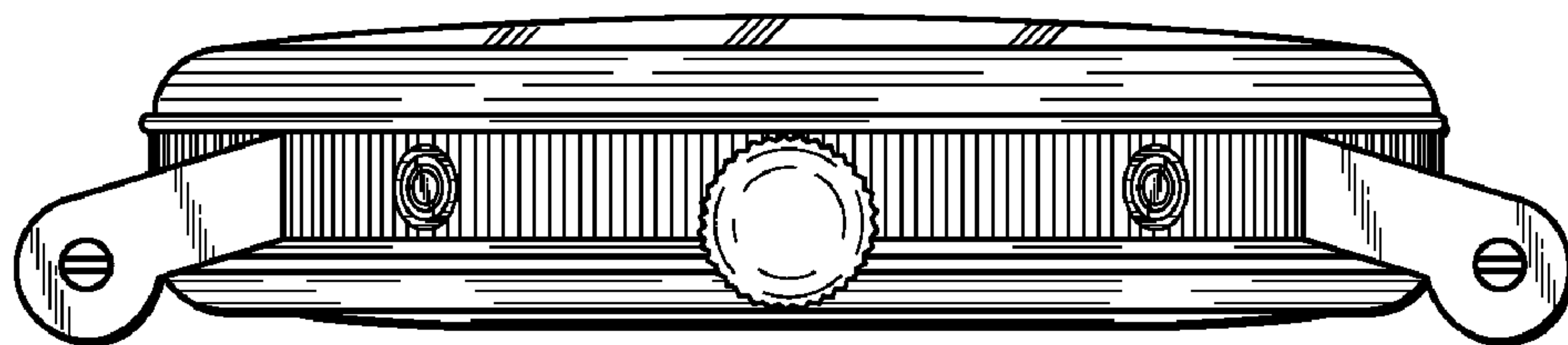

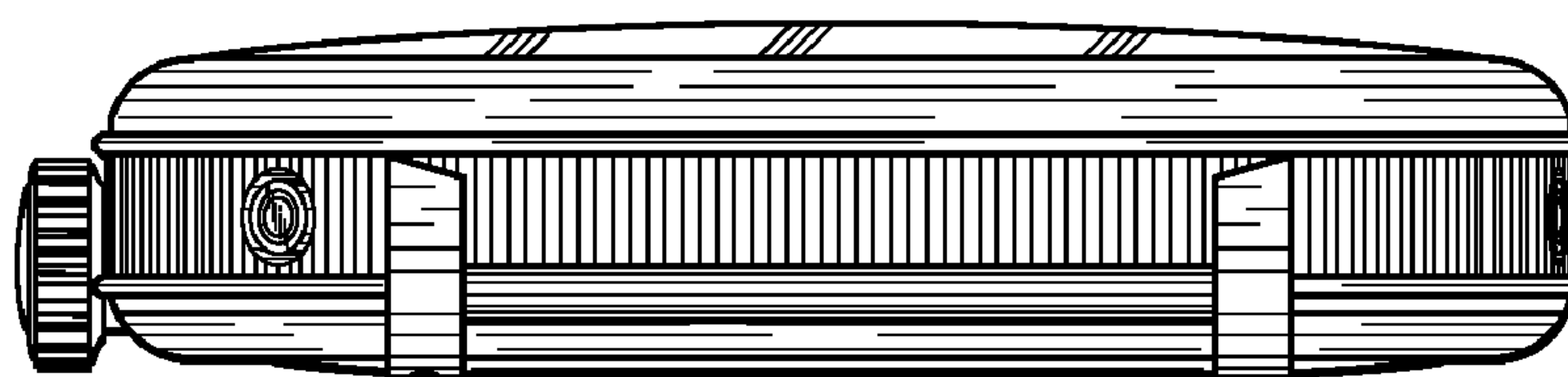

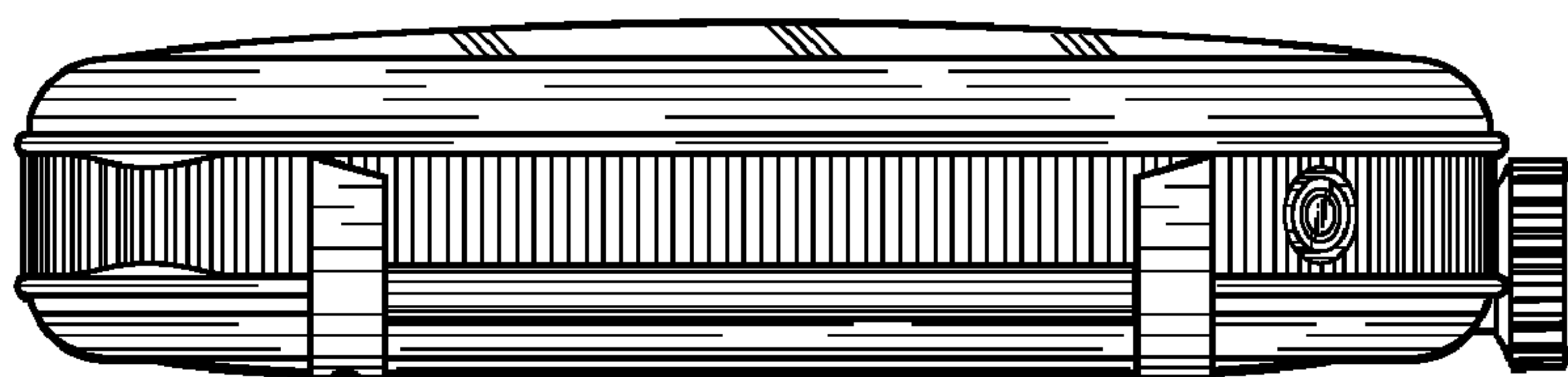
