(57) **CLAIM**

The ornamental design for a display of fantasy sports confidence scores, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a display of fantasy sports confidence scores showing our new design; and,

FIG. 2 is a front elevational view of another embodiment of a fantasy sports confidence scores.
