FIG. 2 is a rear view of the mouse;

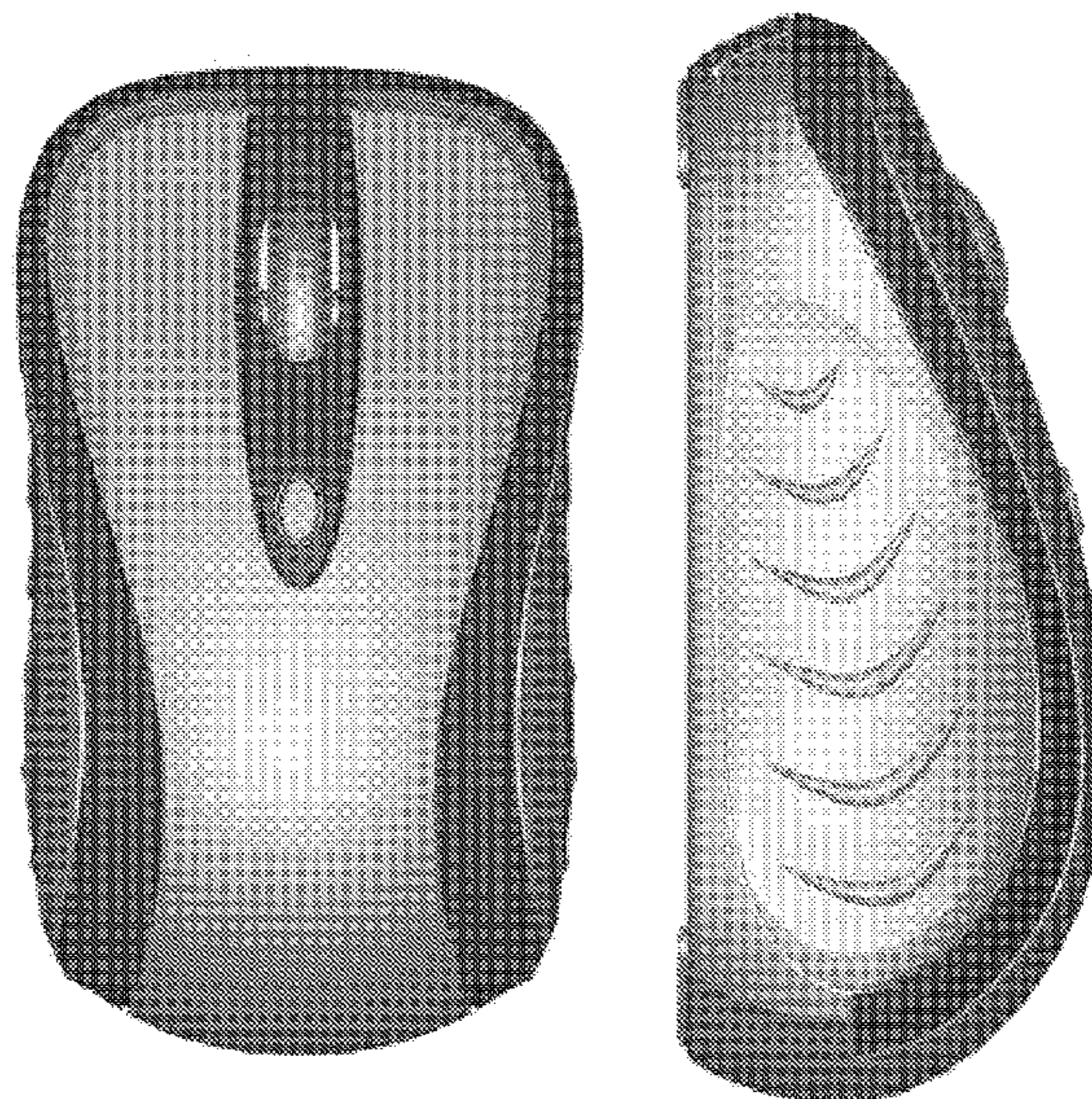
FIG. 3 is a left side view of the mouse;

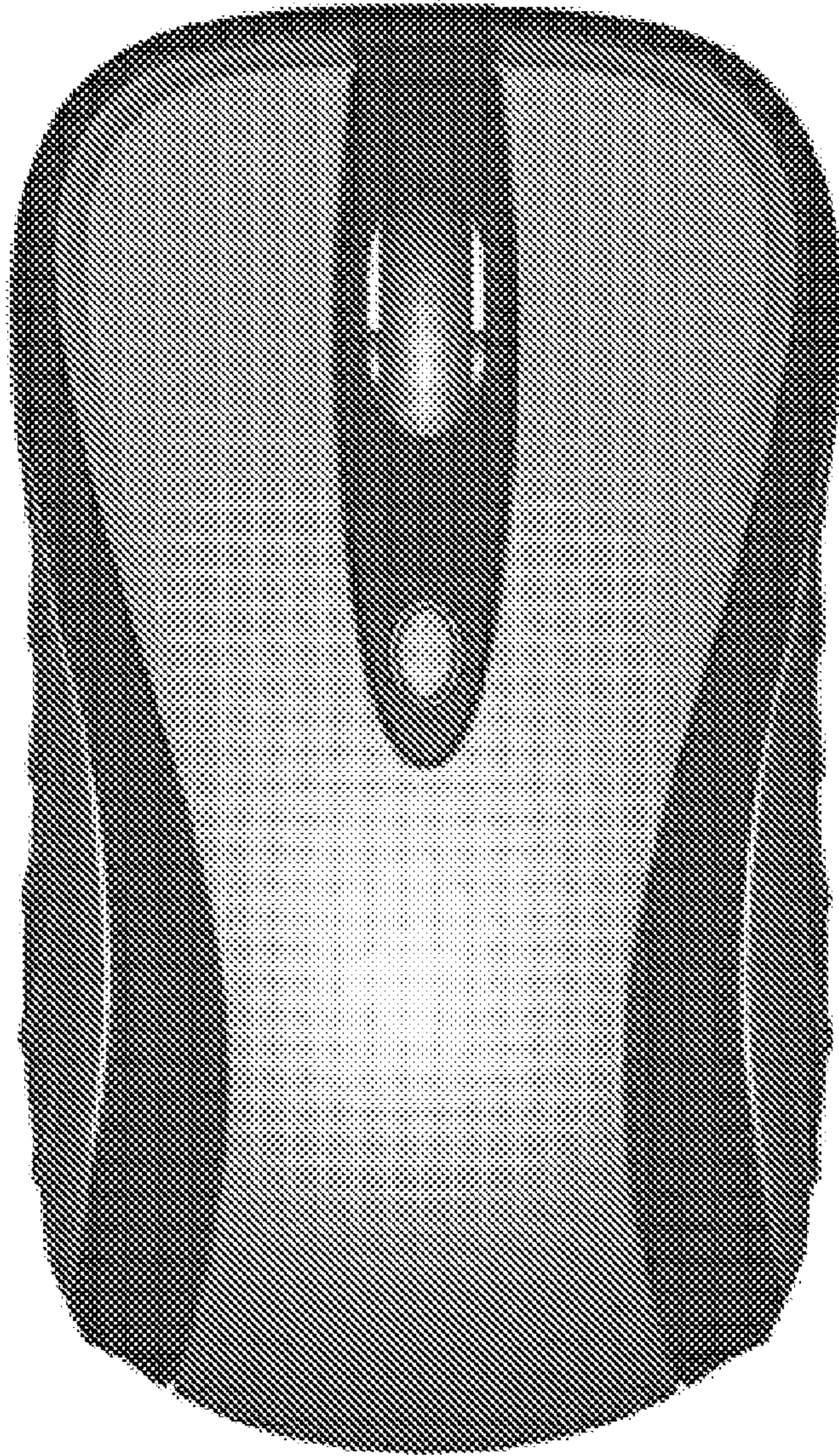

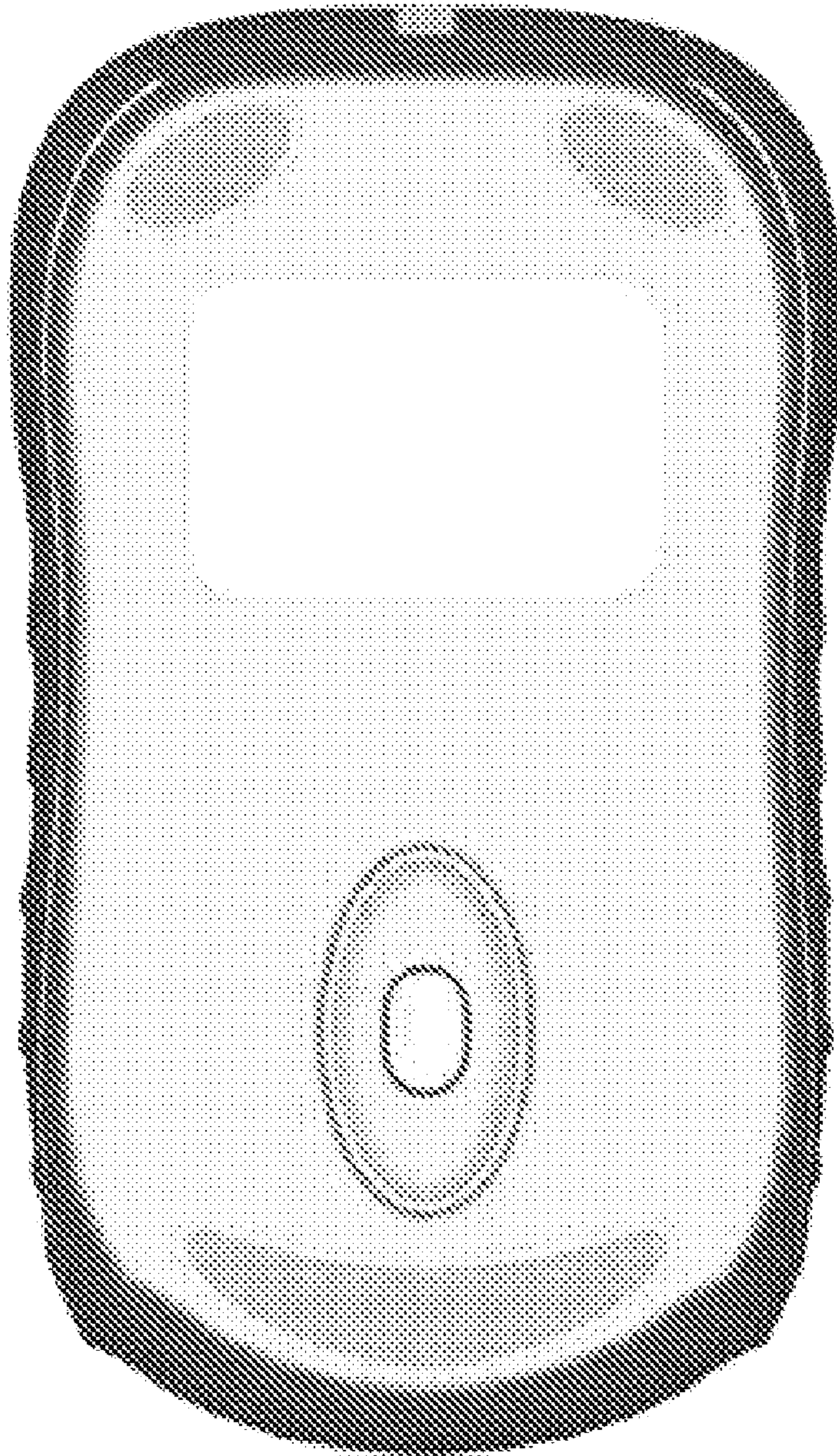

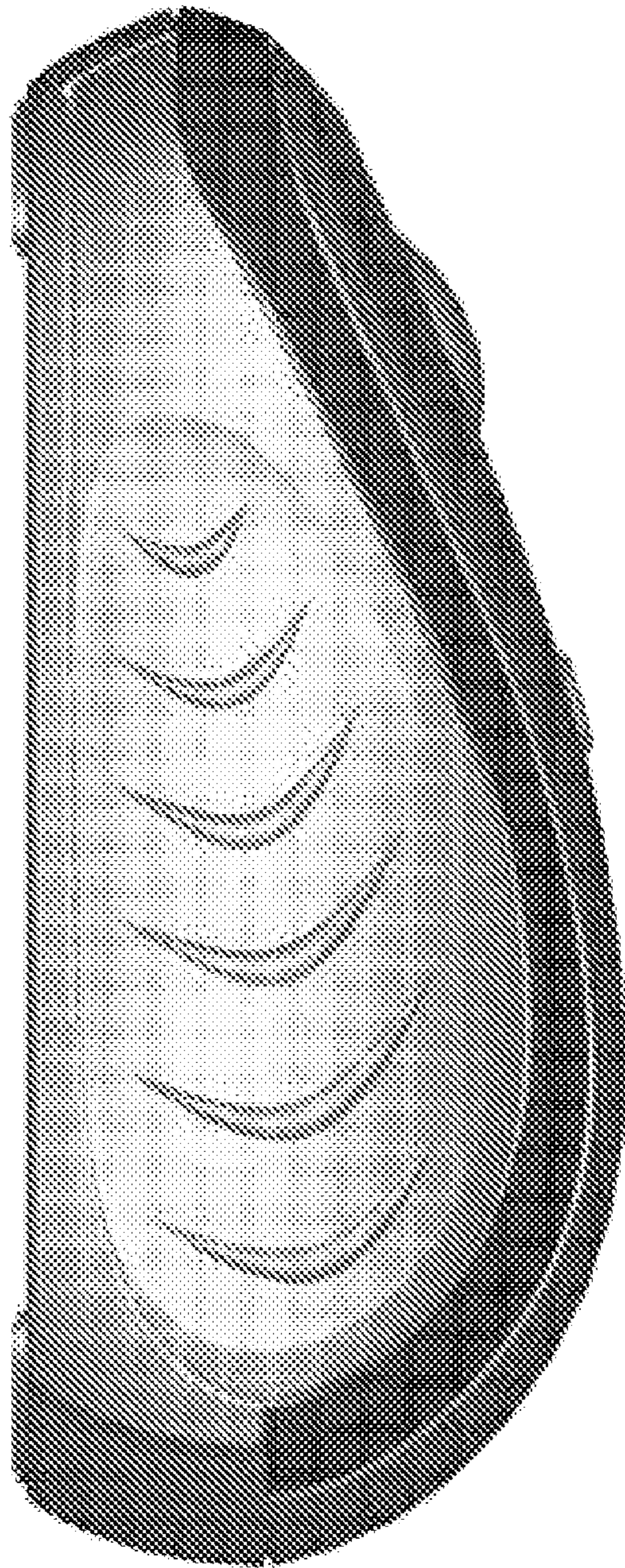

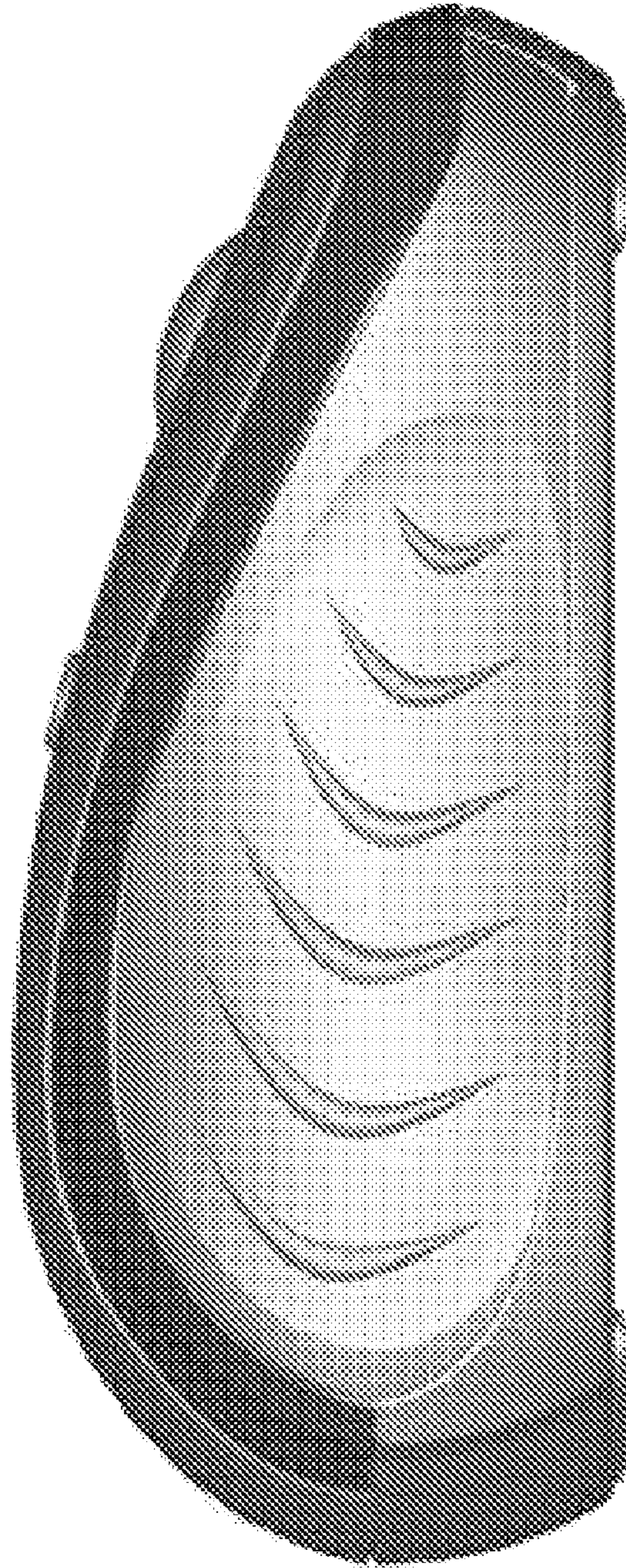

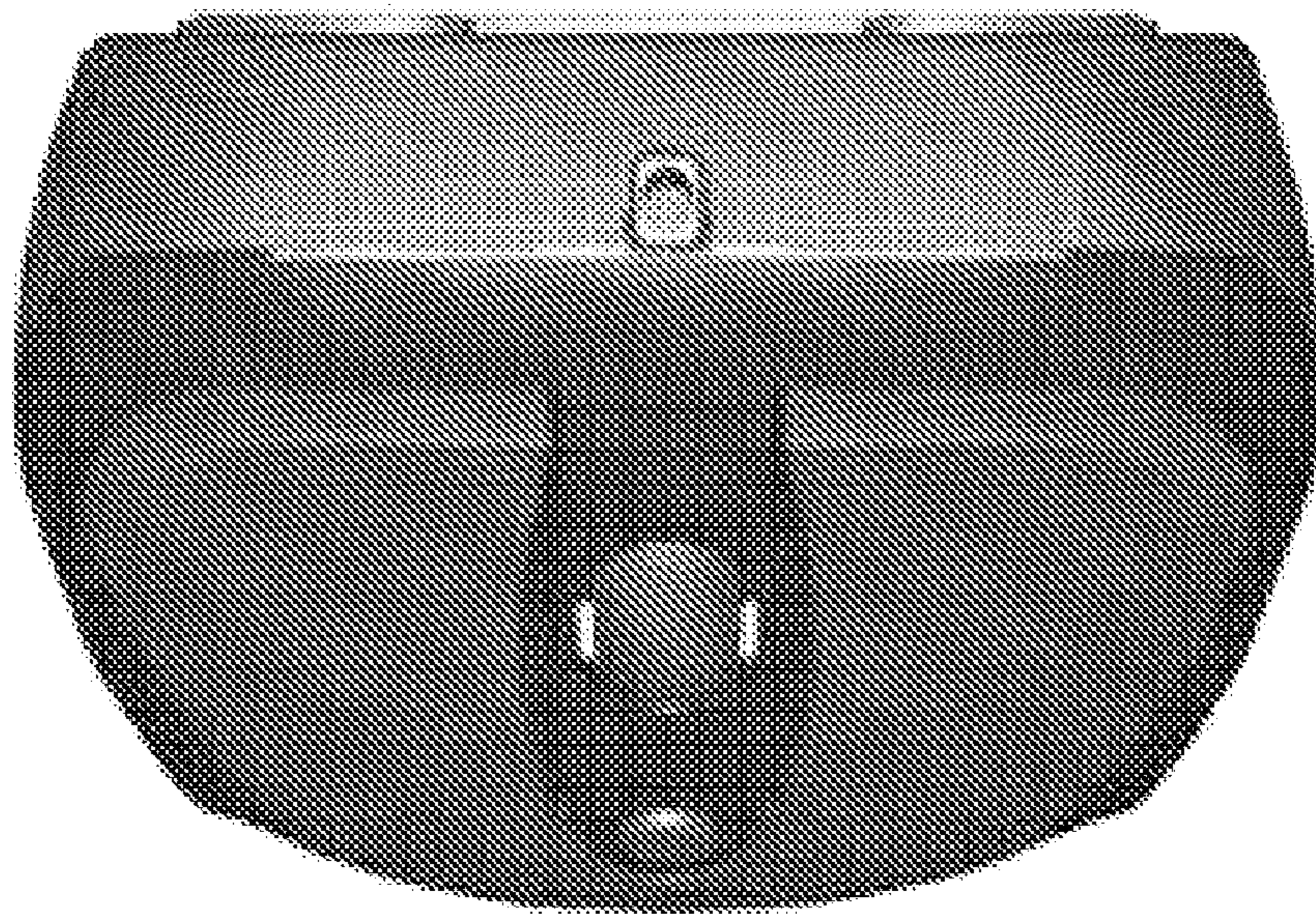

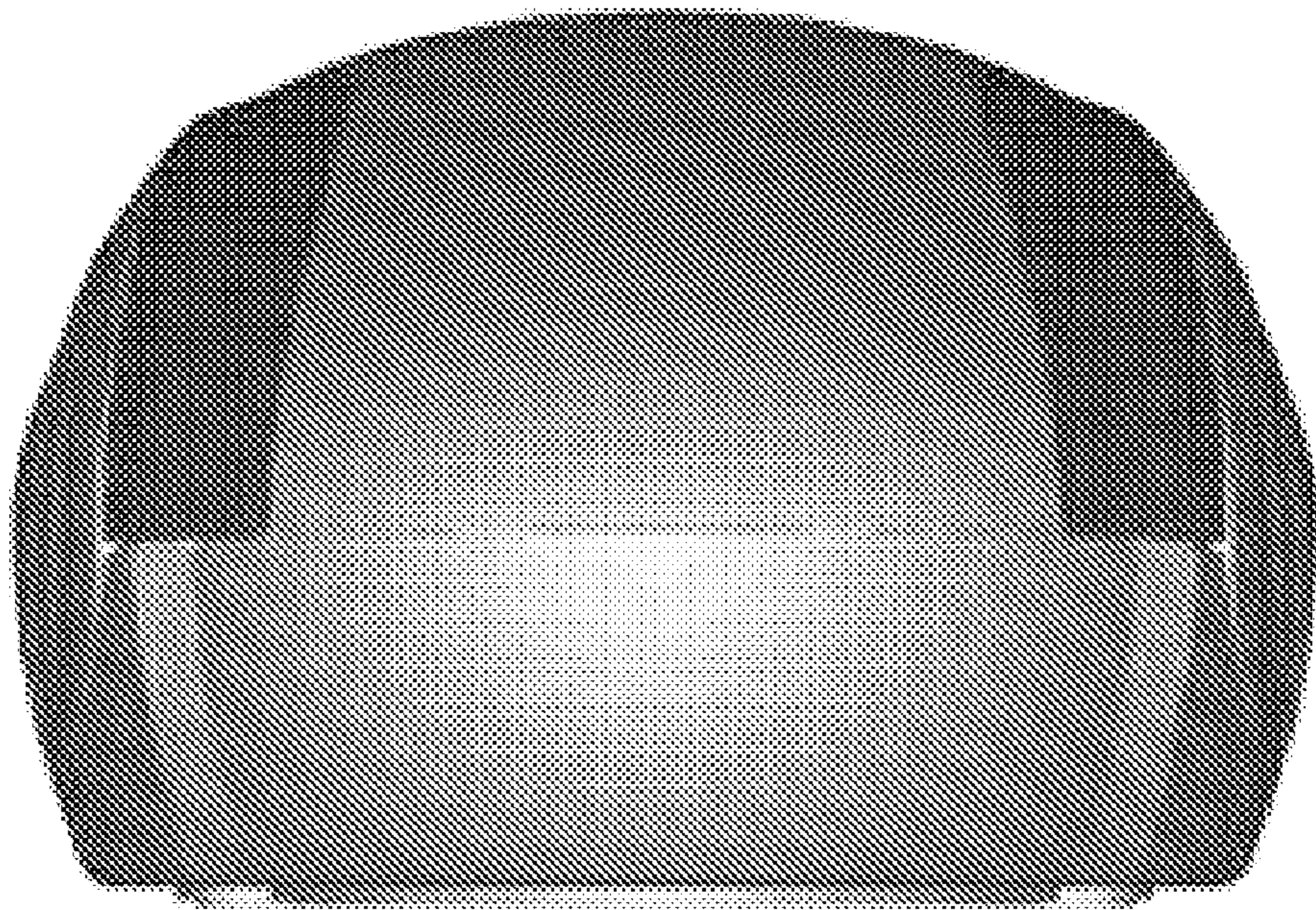
