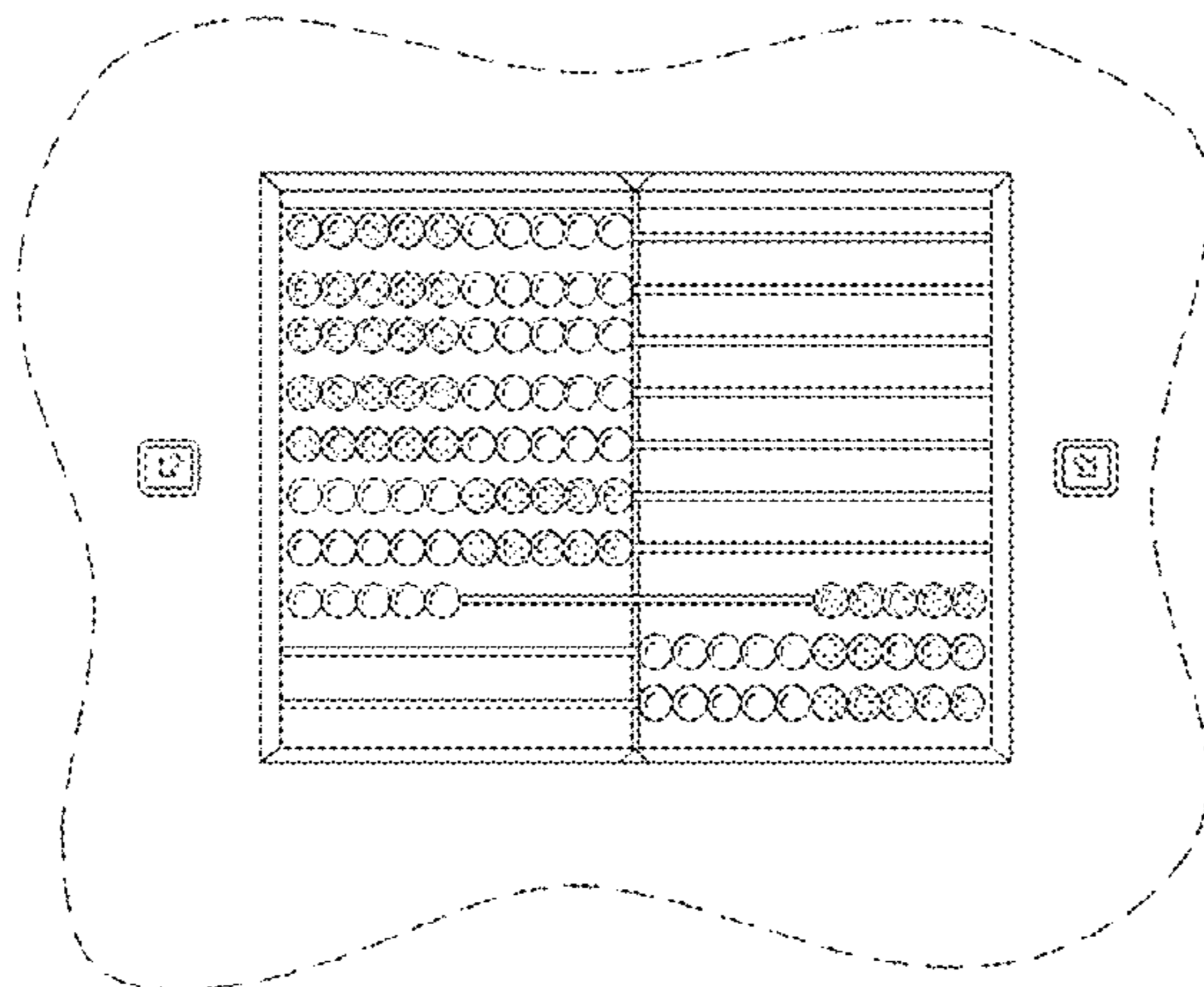
We claim the ornamental design for a user interface for a computer display, as shown and described.
