FIG. 2 is a right side view and left side view thereof;

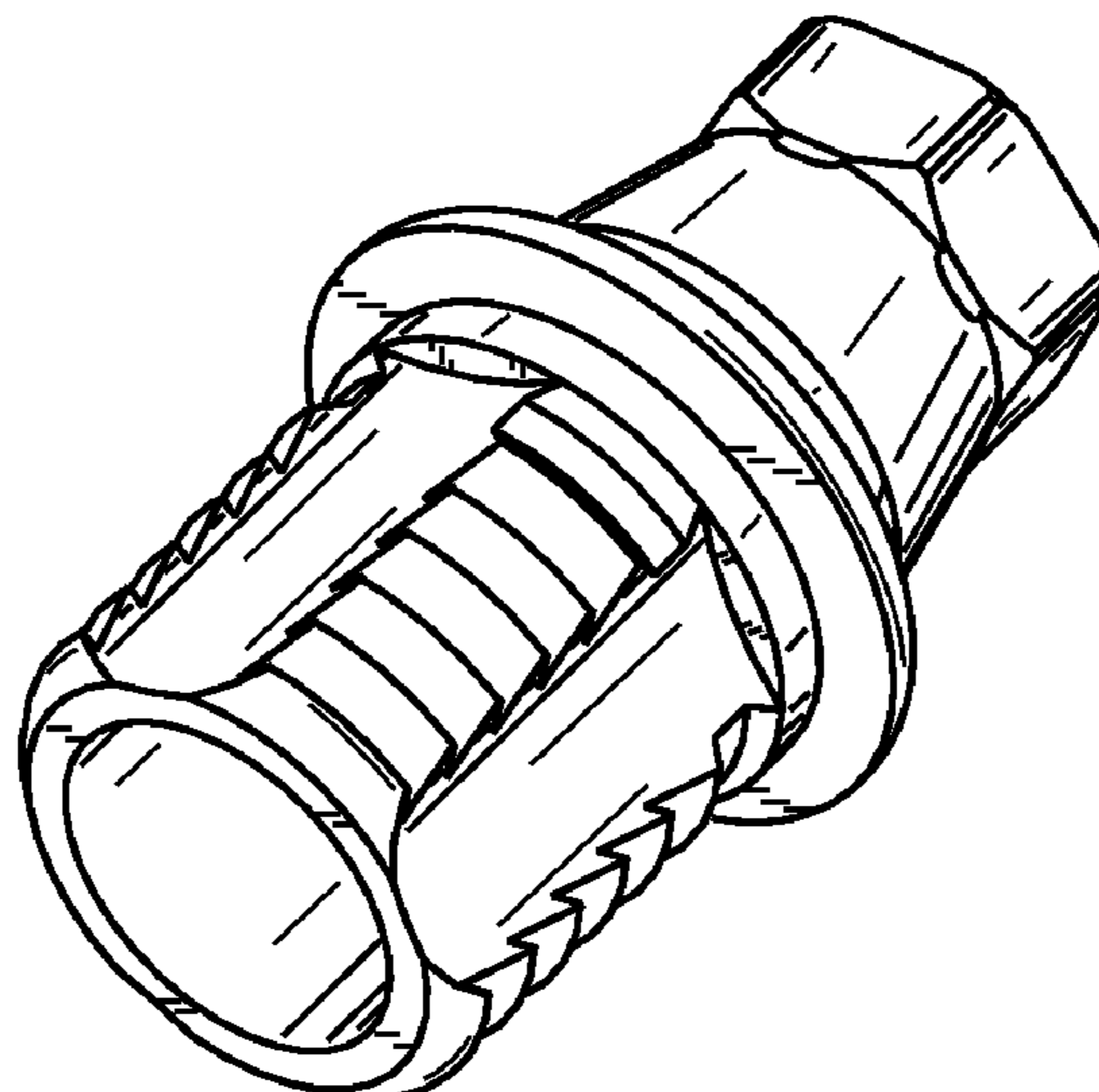
FIG. 3 is a front view thereof; and

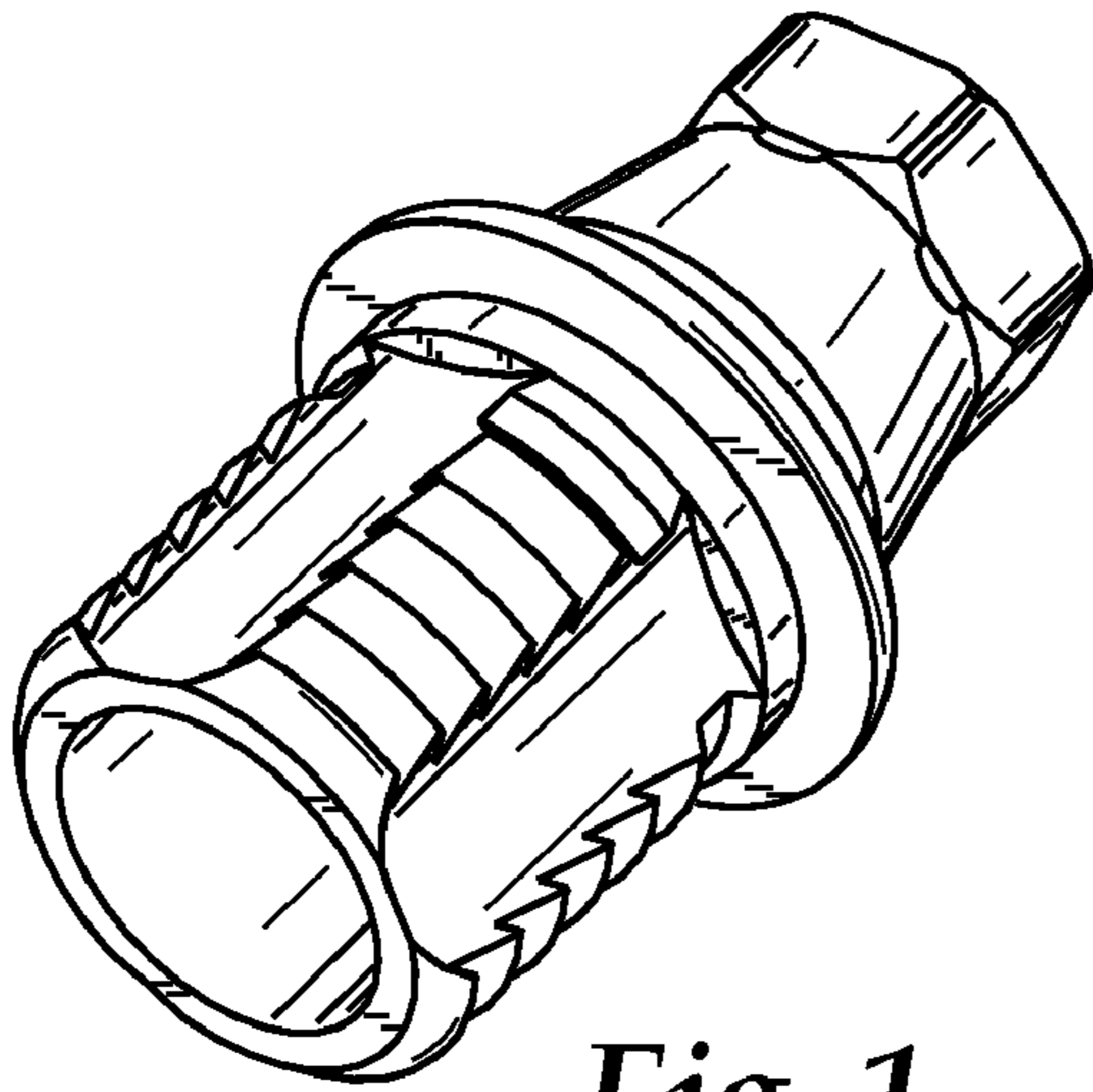

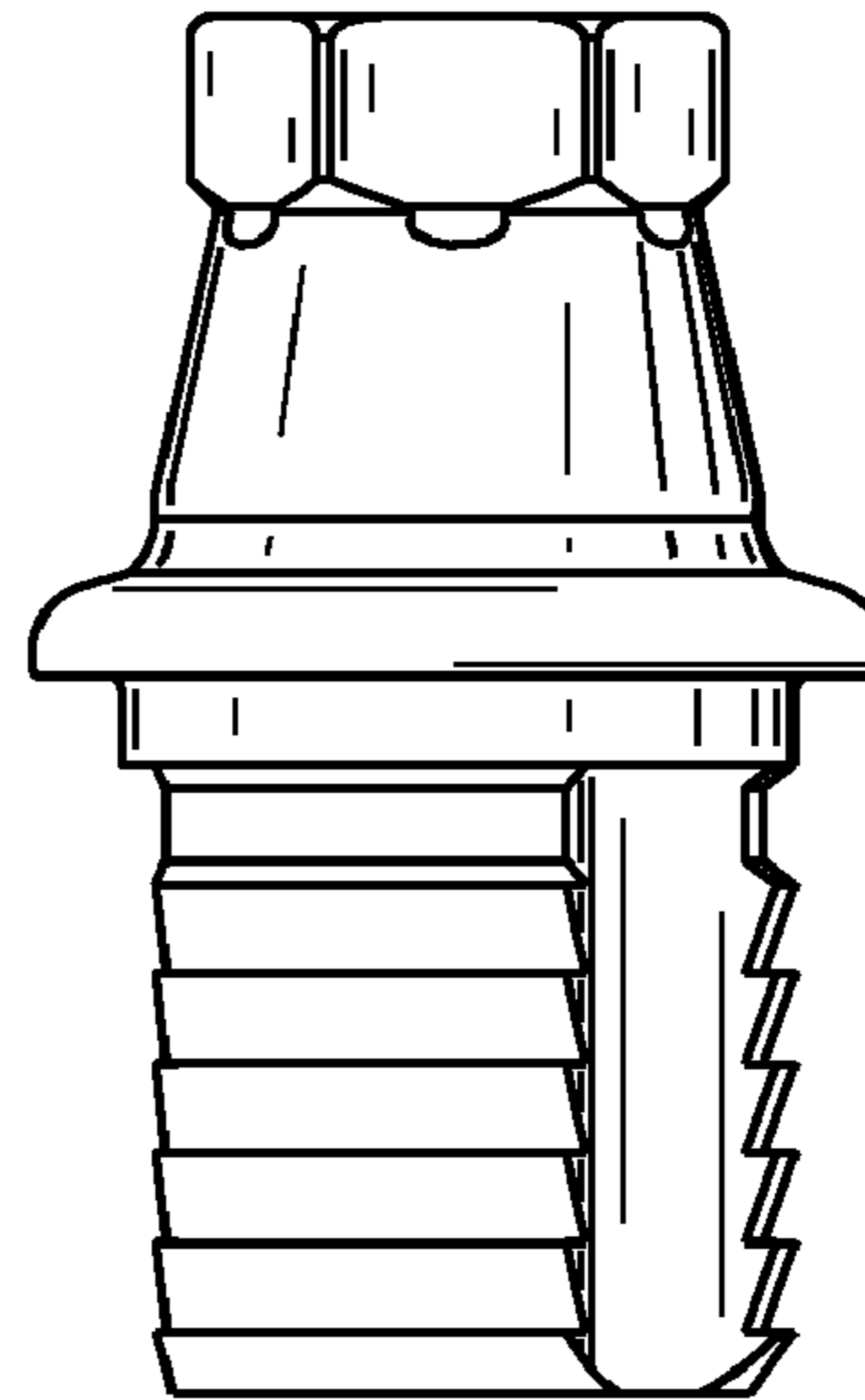

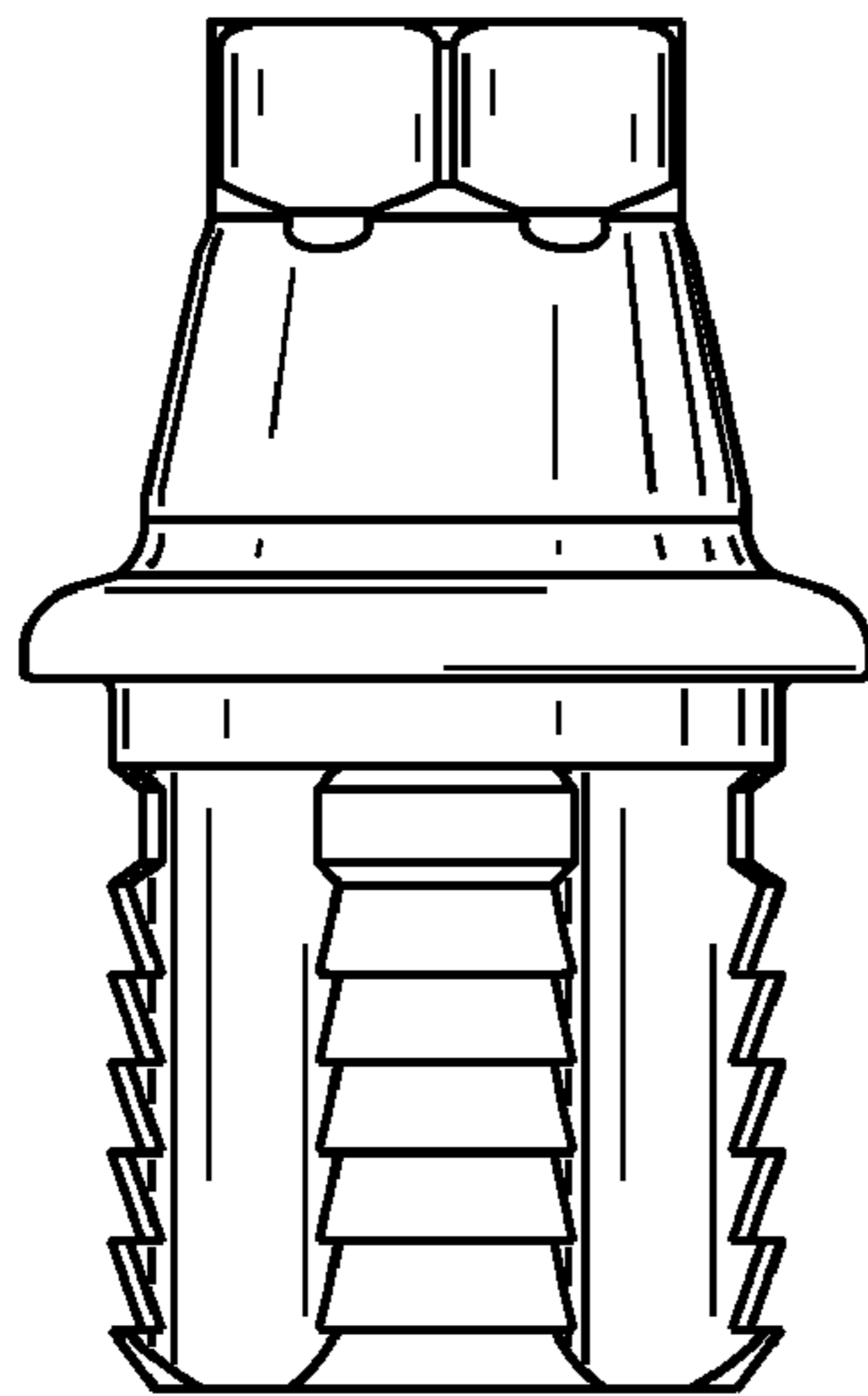

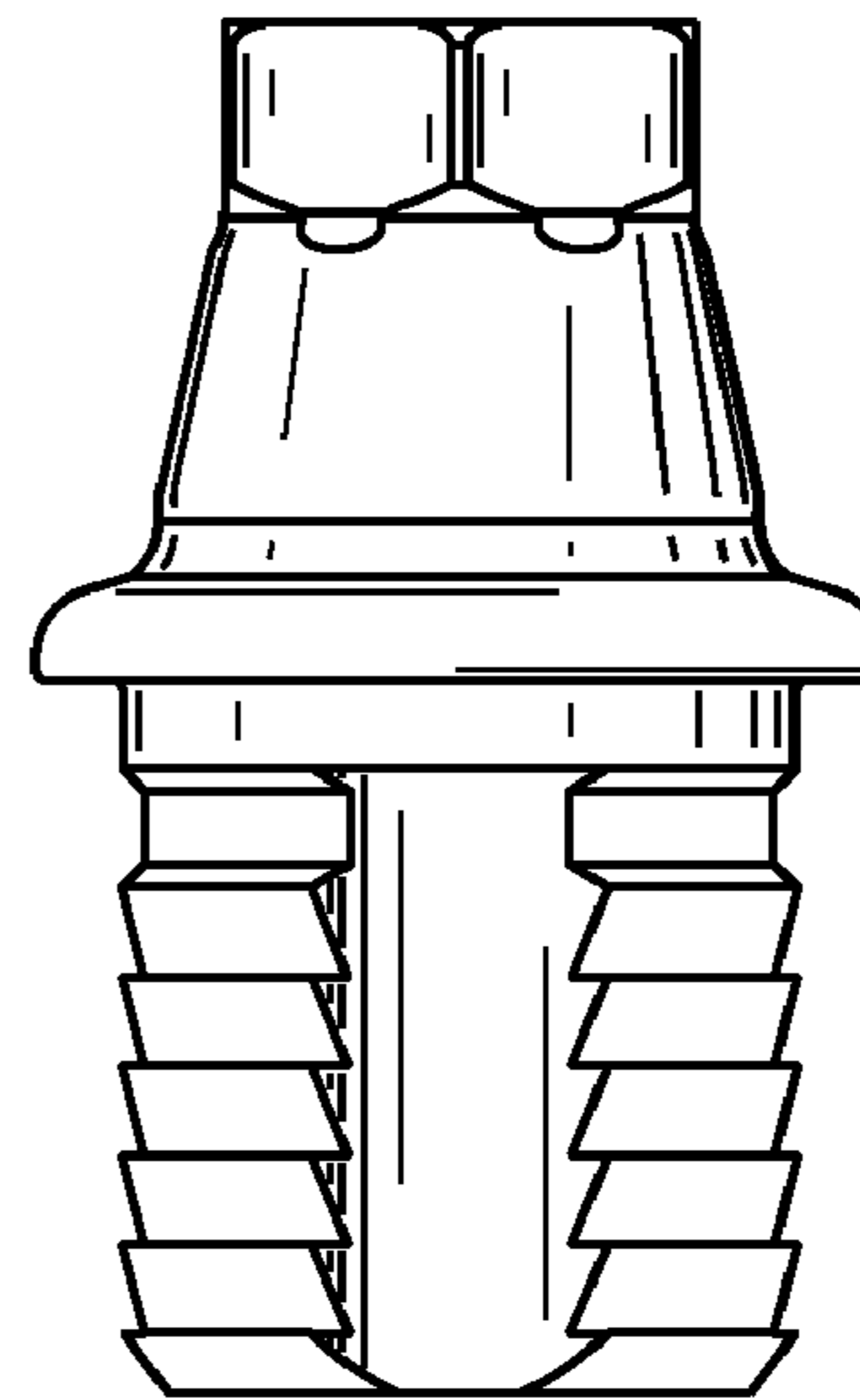

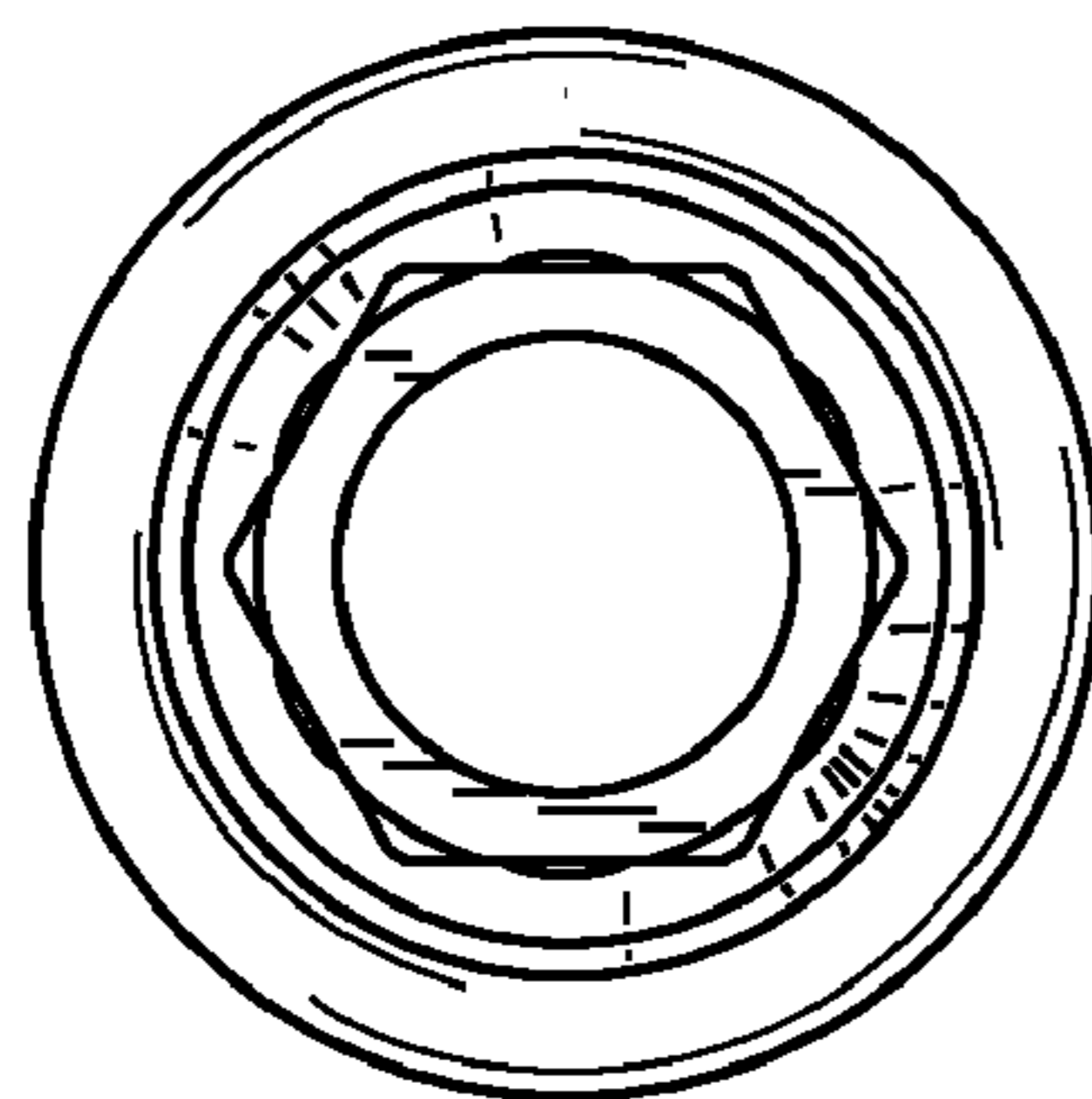

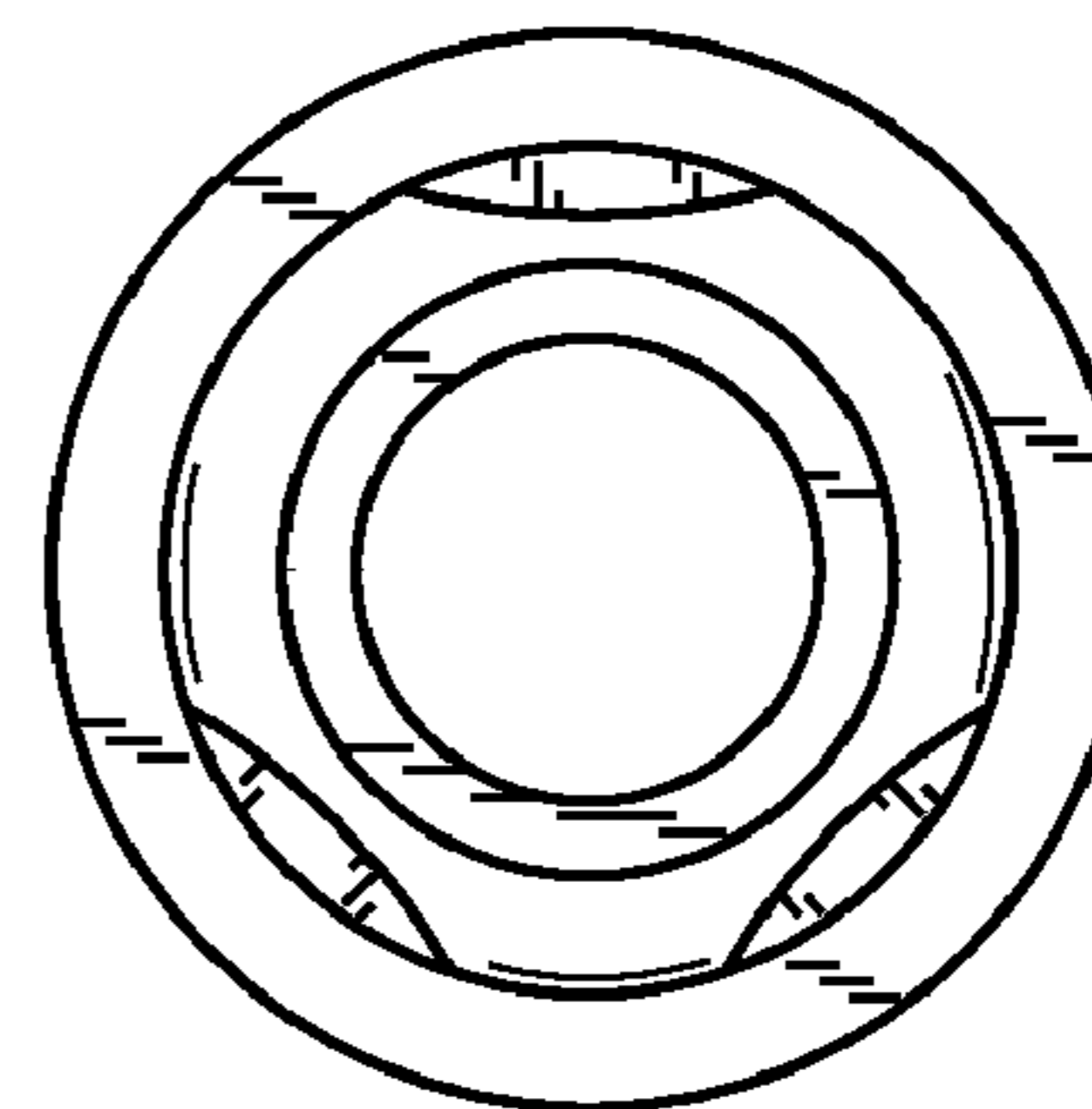
