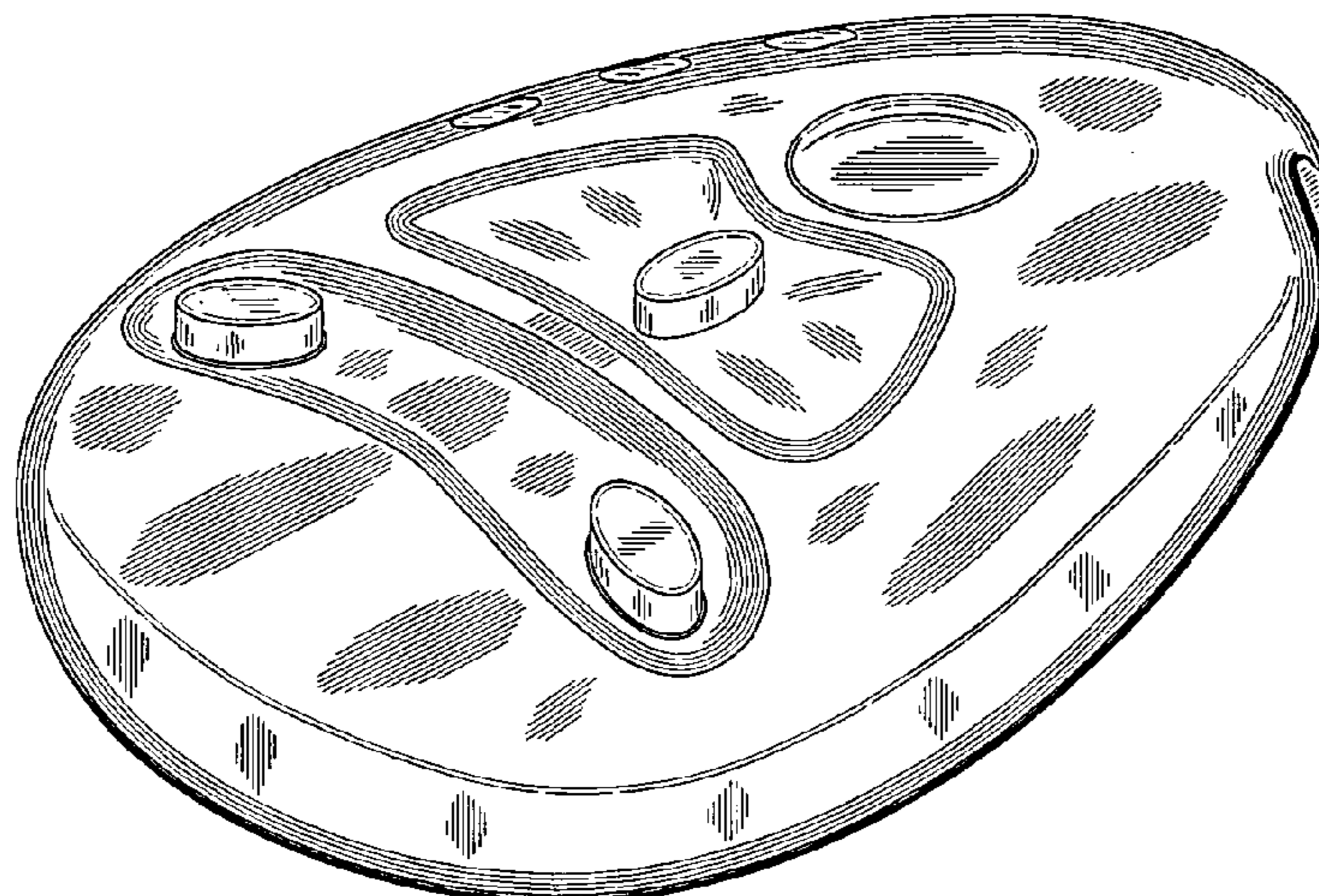

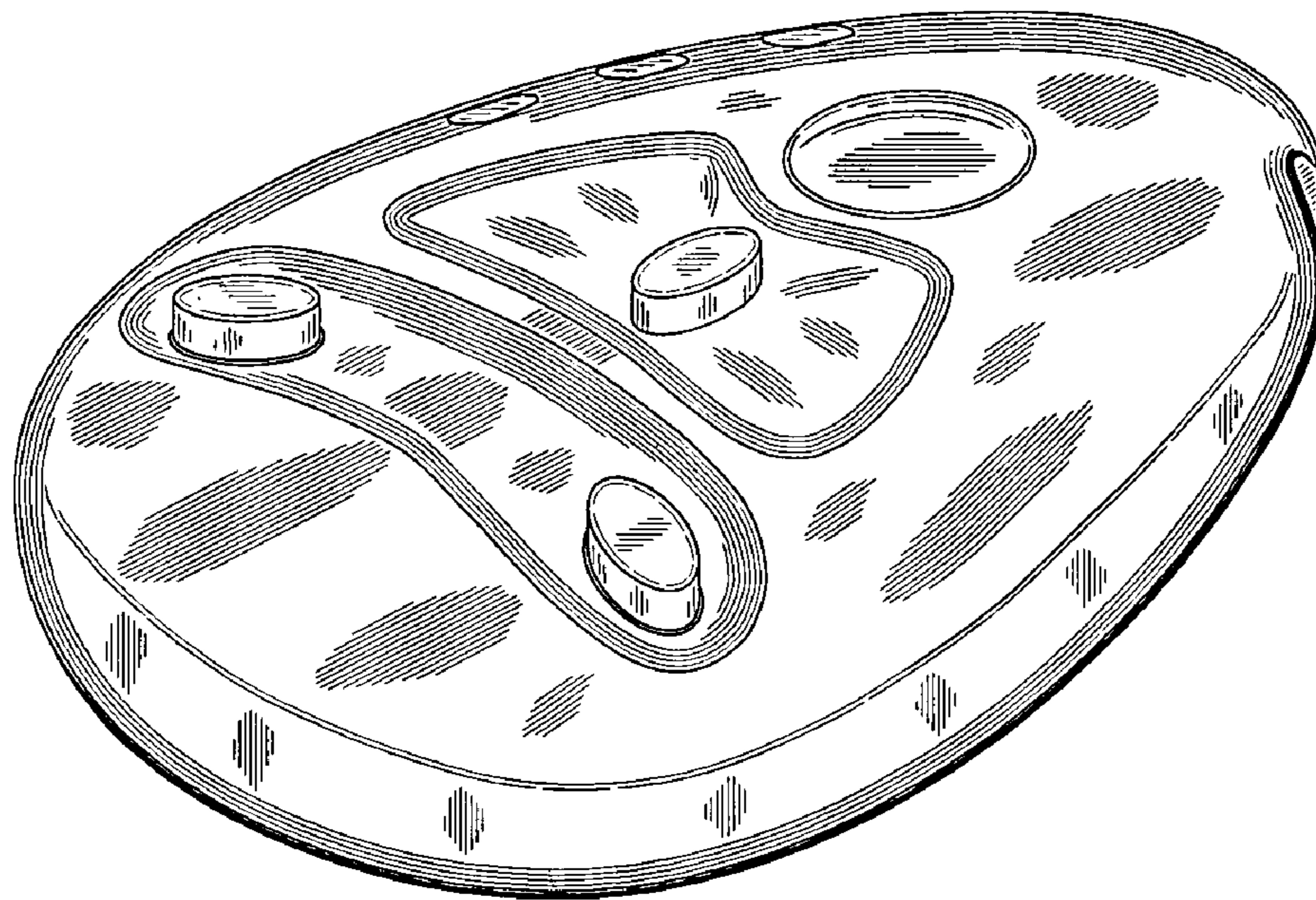
The ornamental design for a meditation device, as shown and described.

**DESCRIPTION**

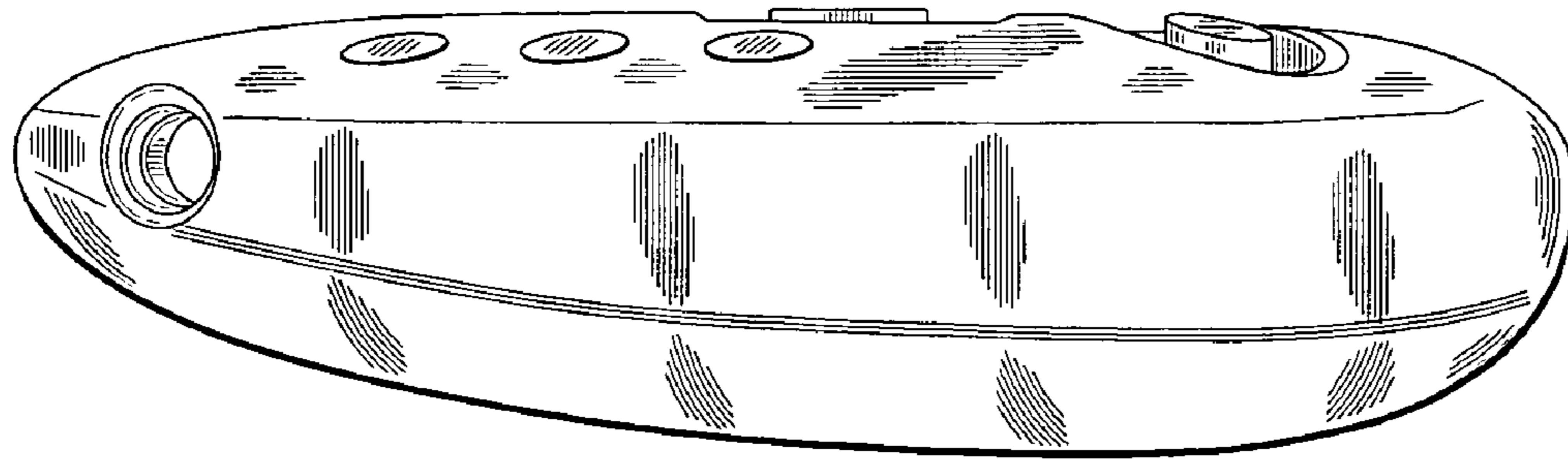

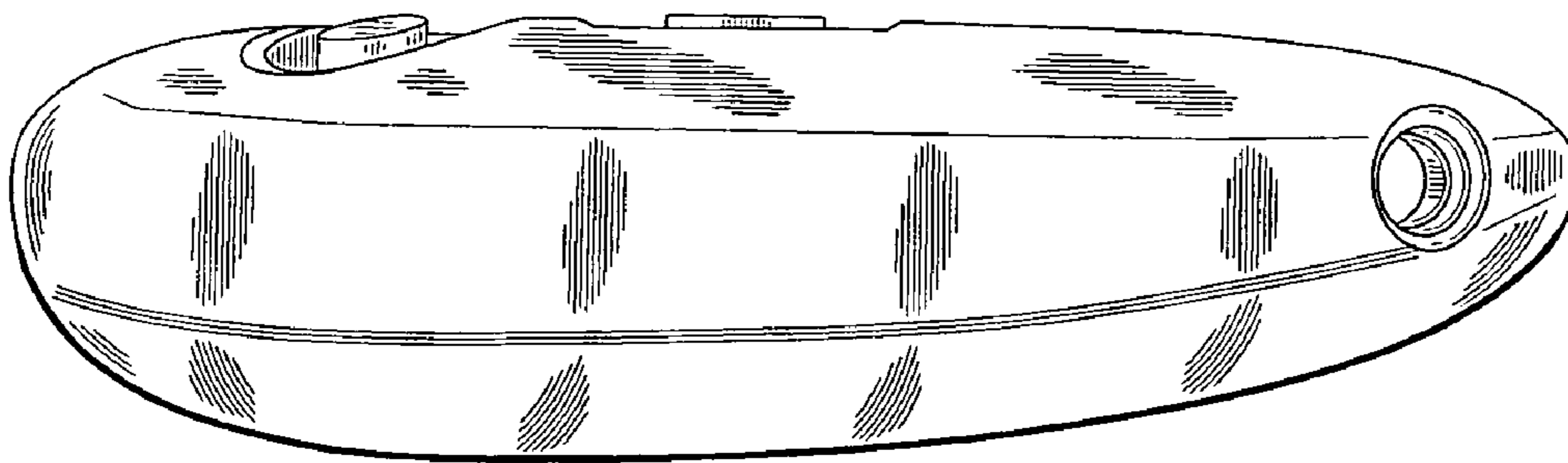




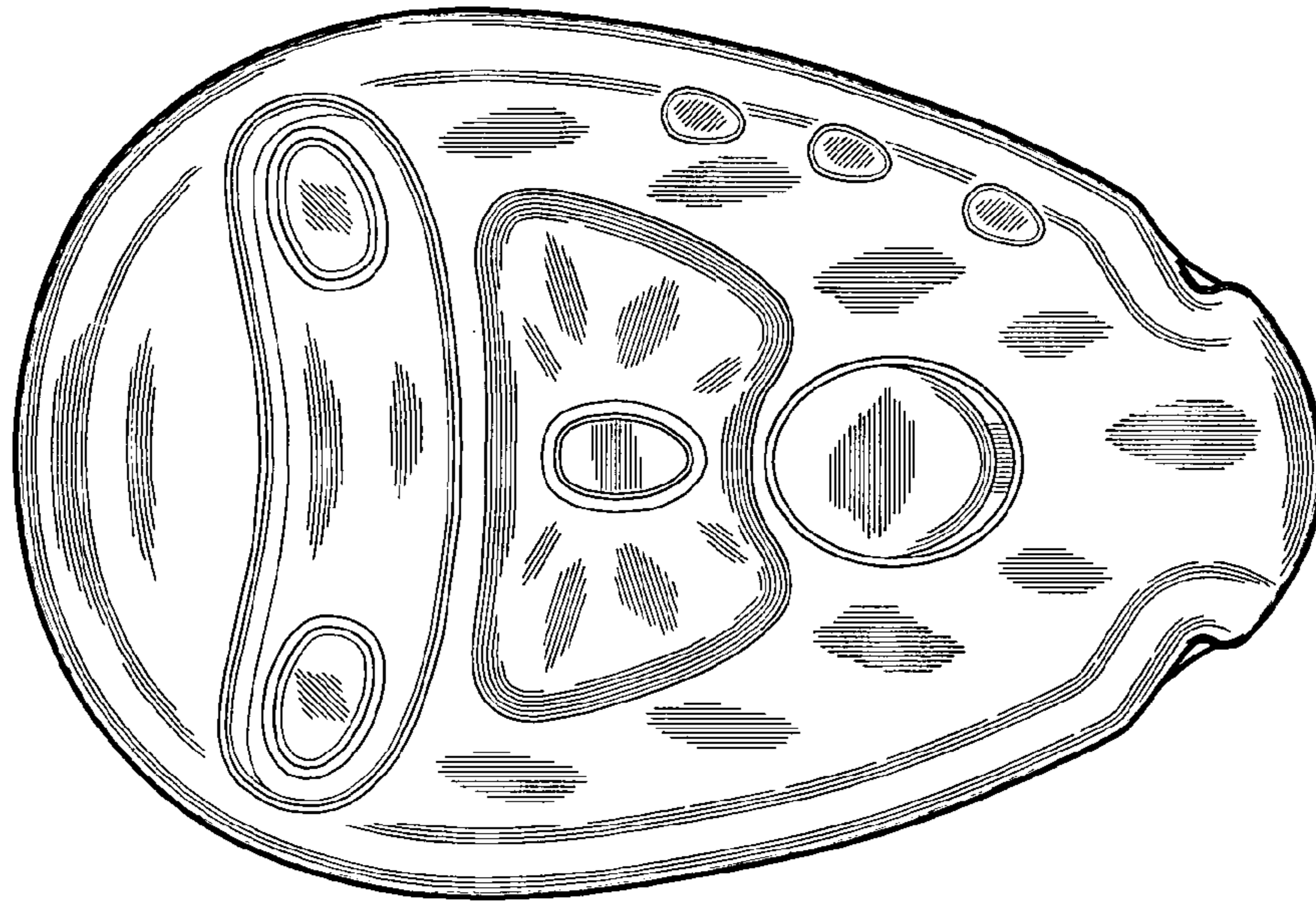

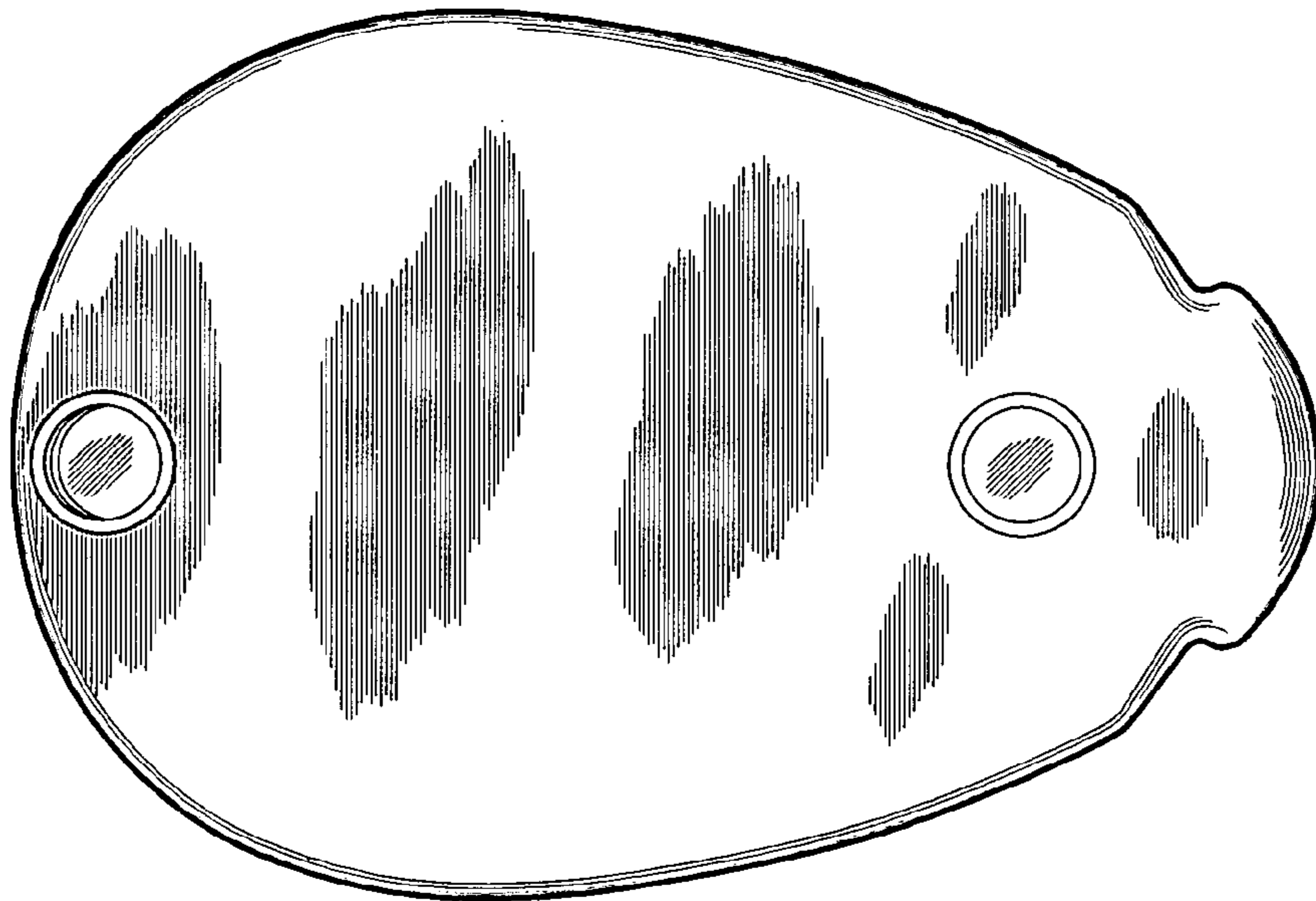

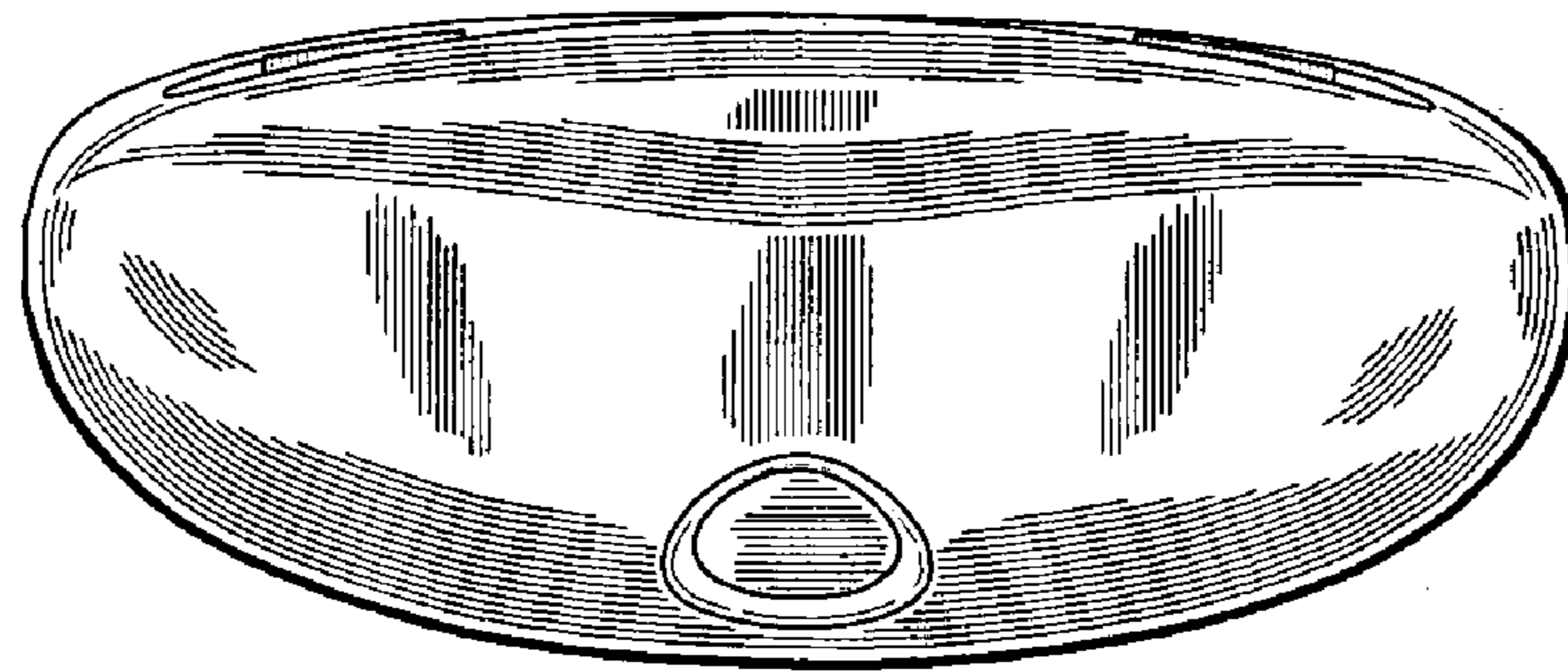

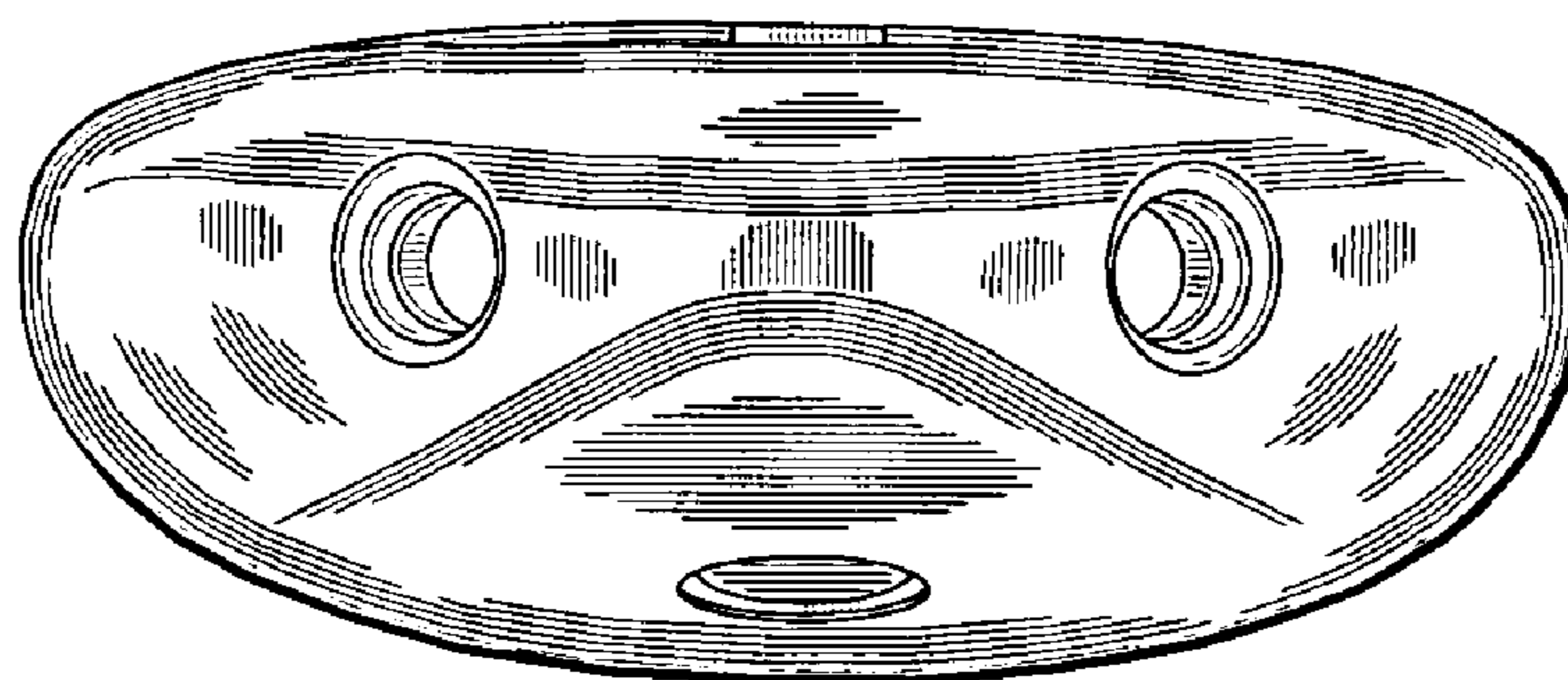
