2.

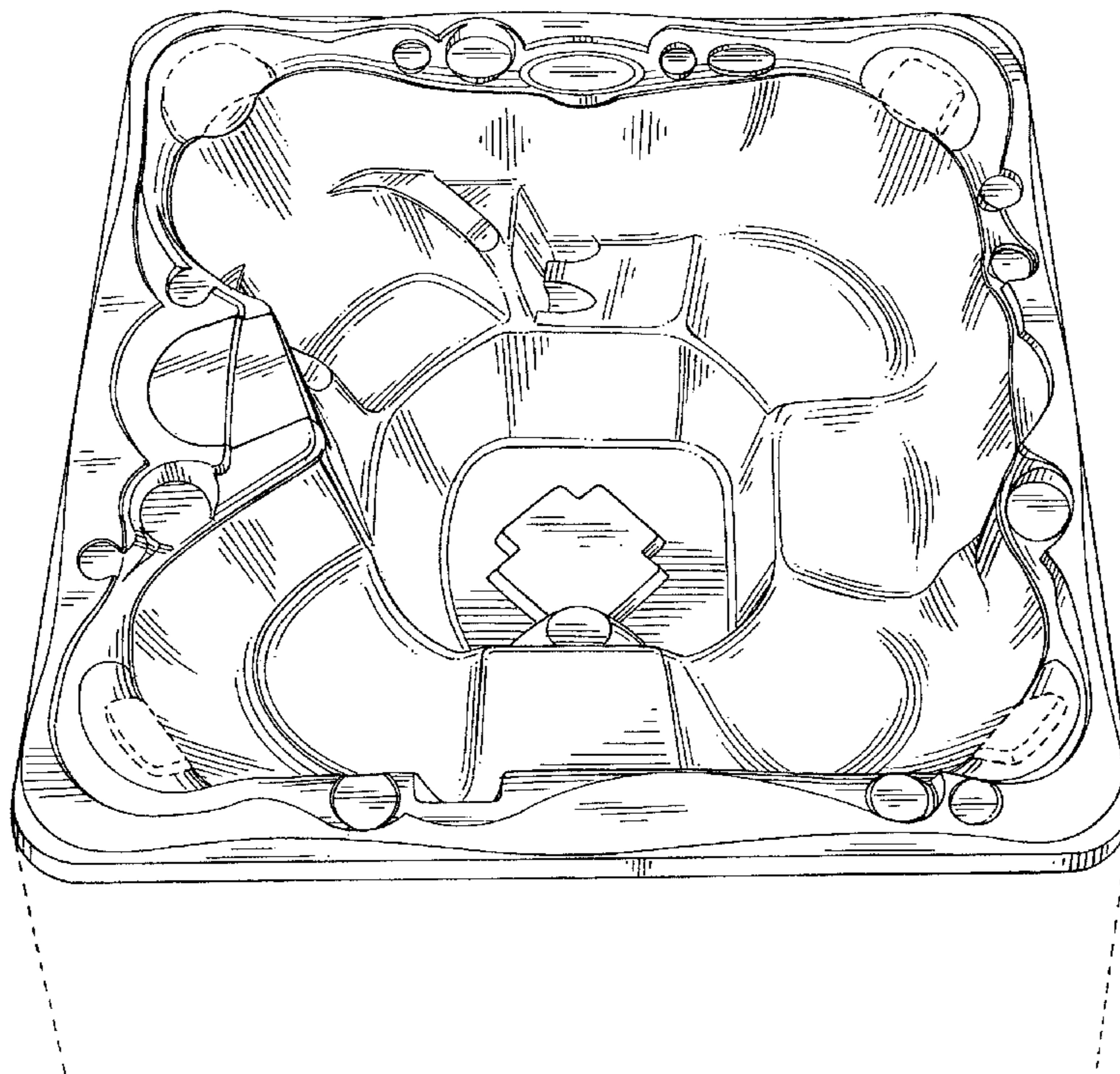

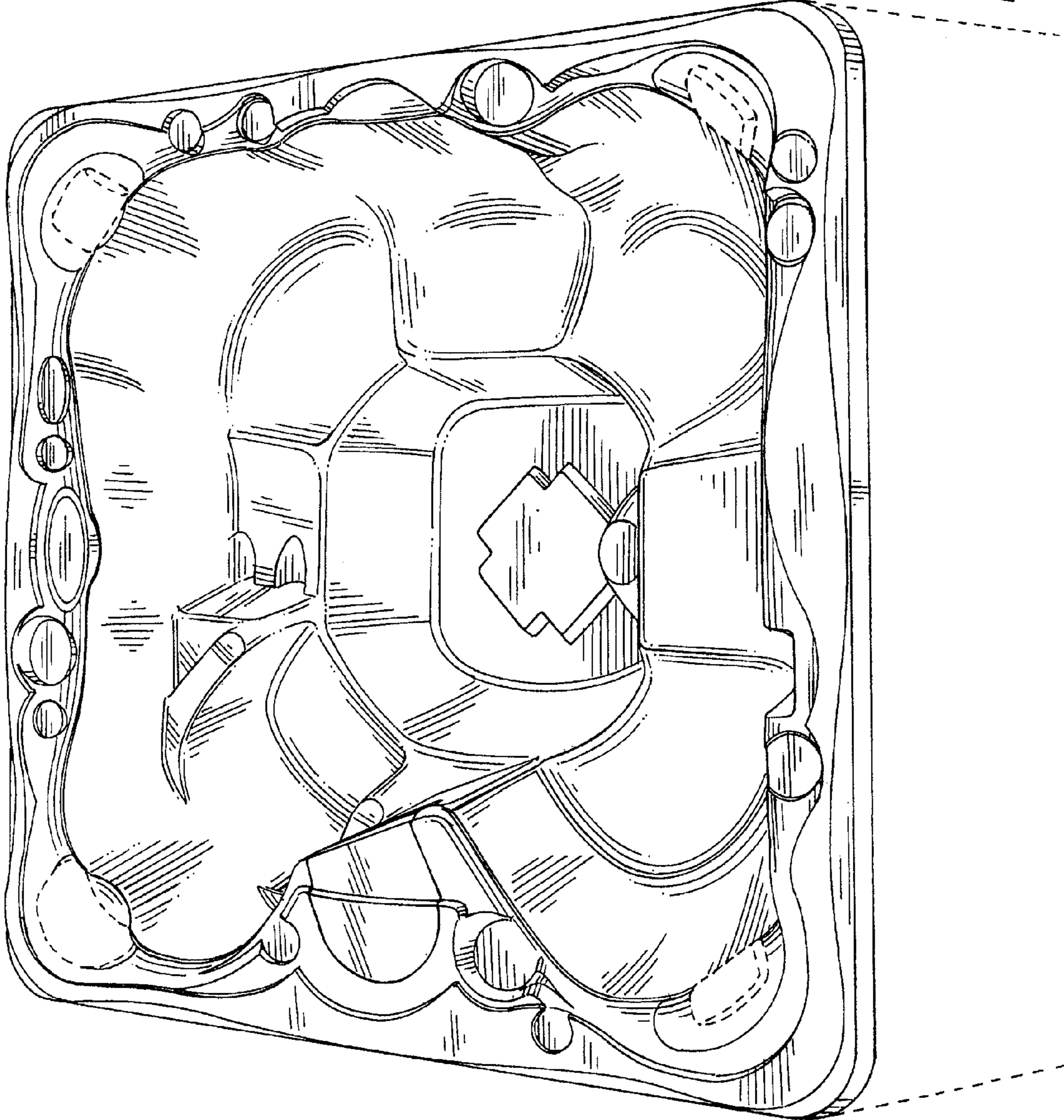
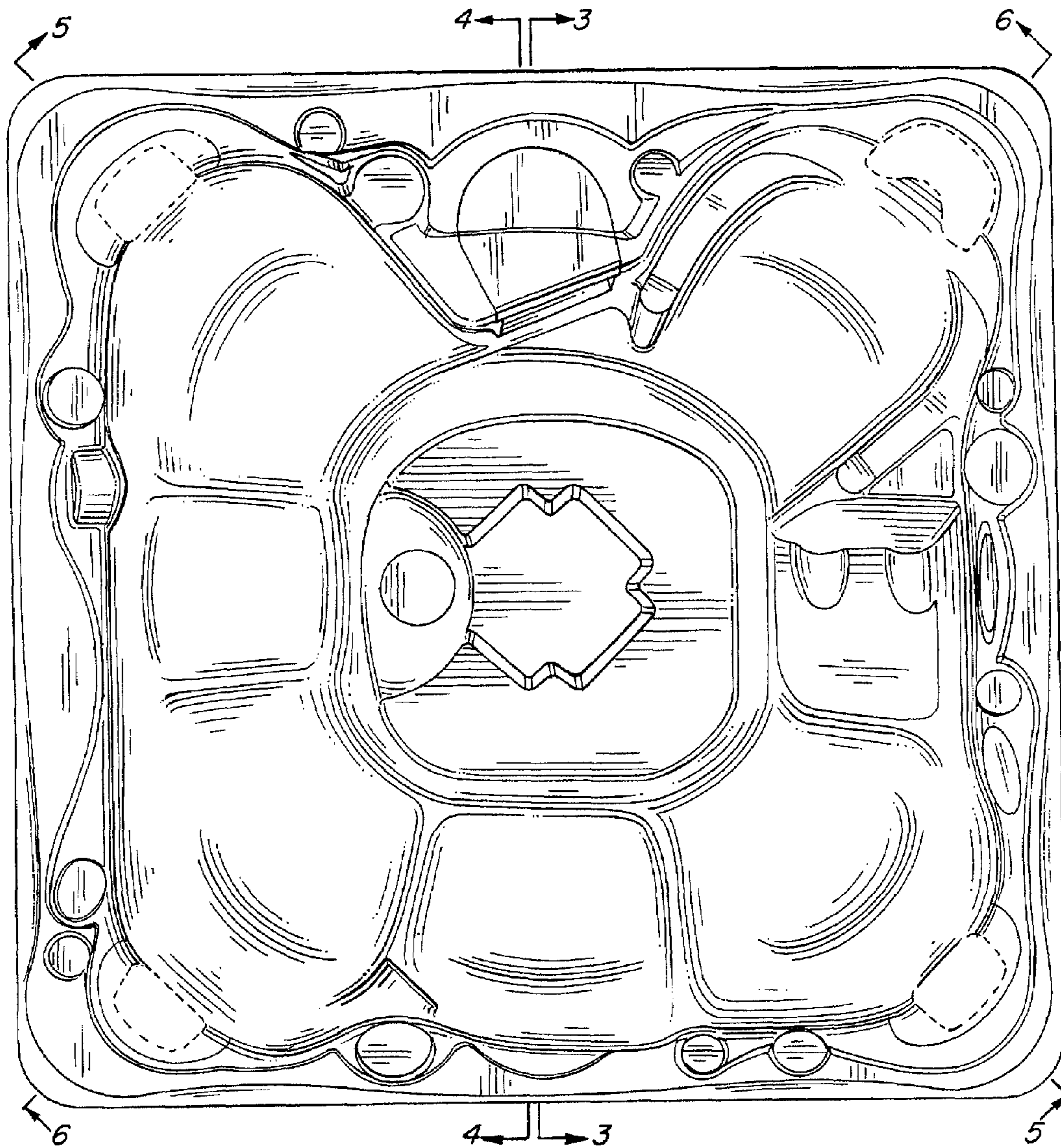
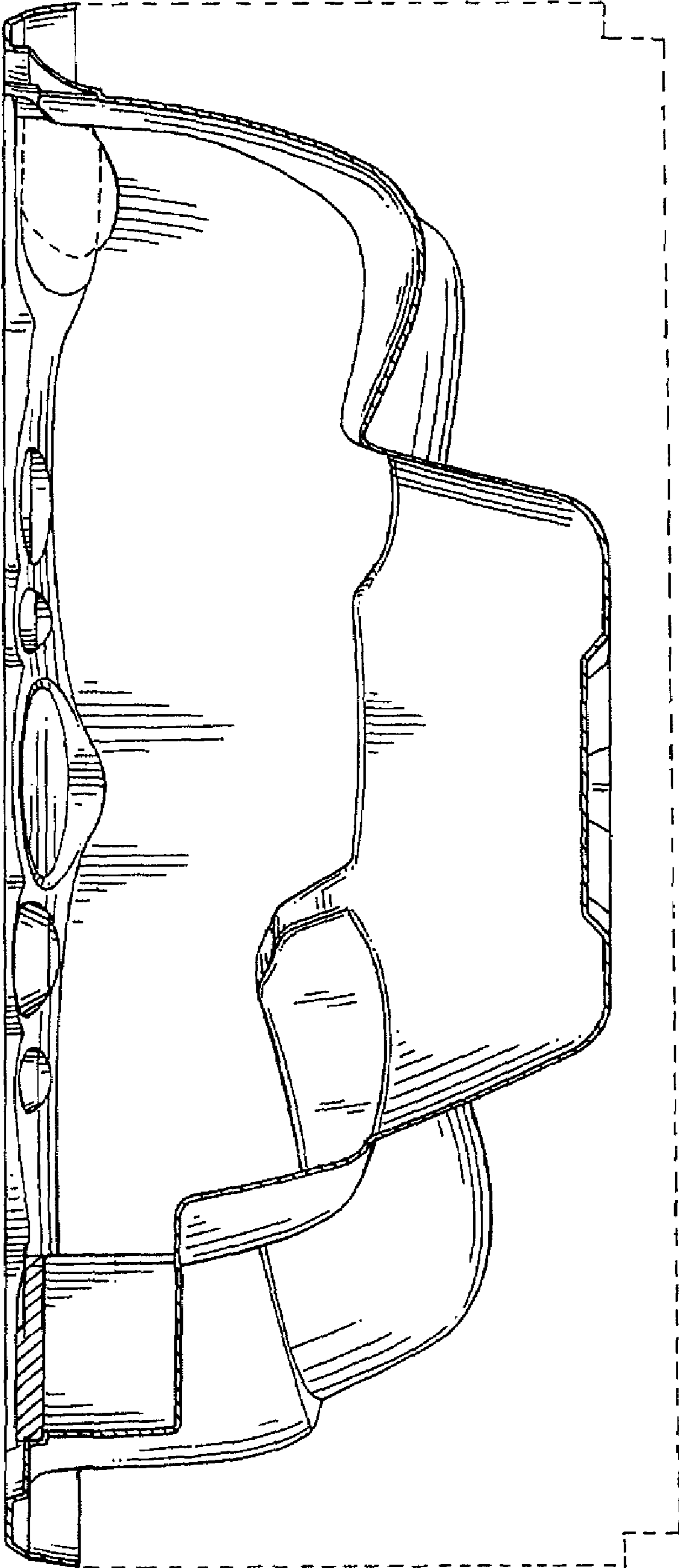


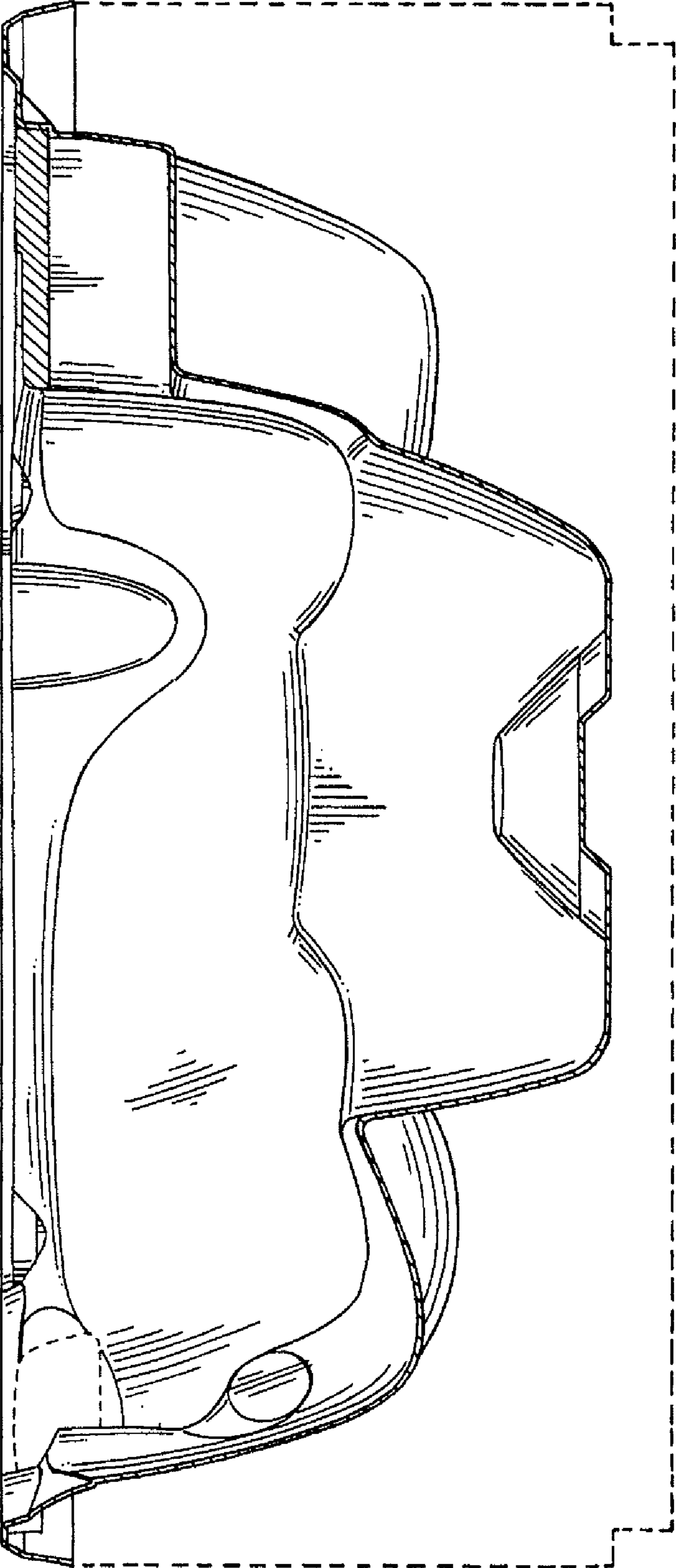

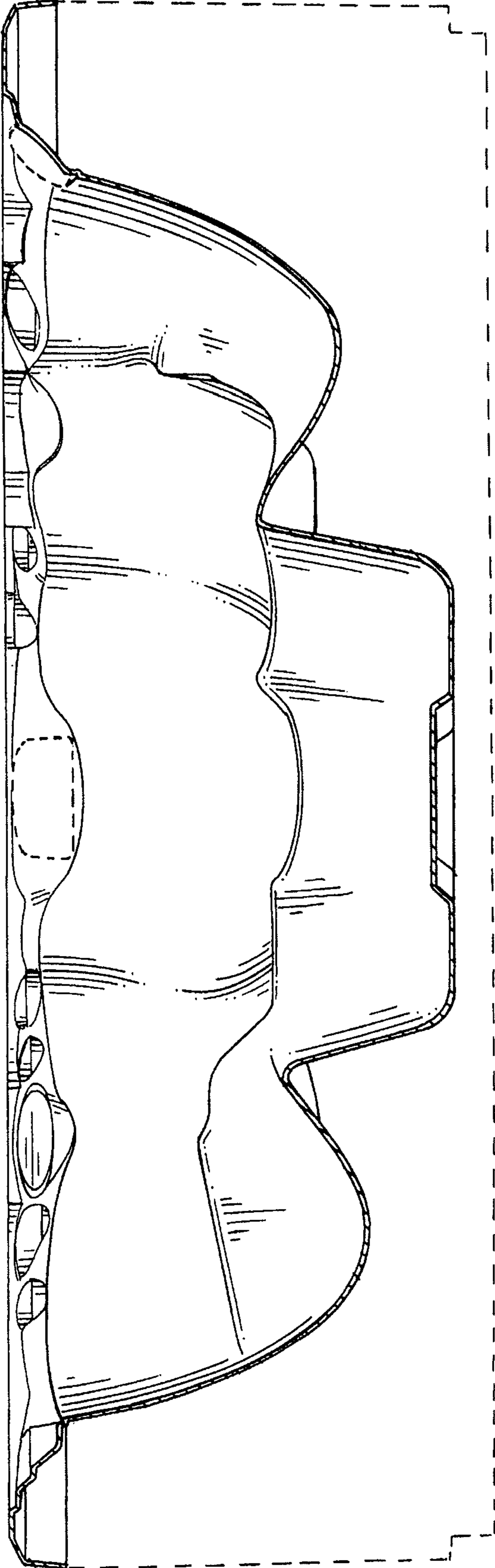

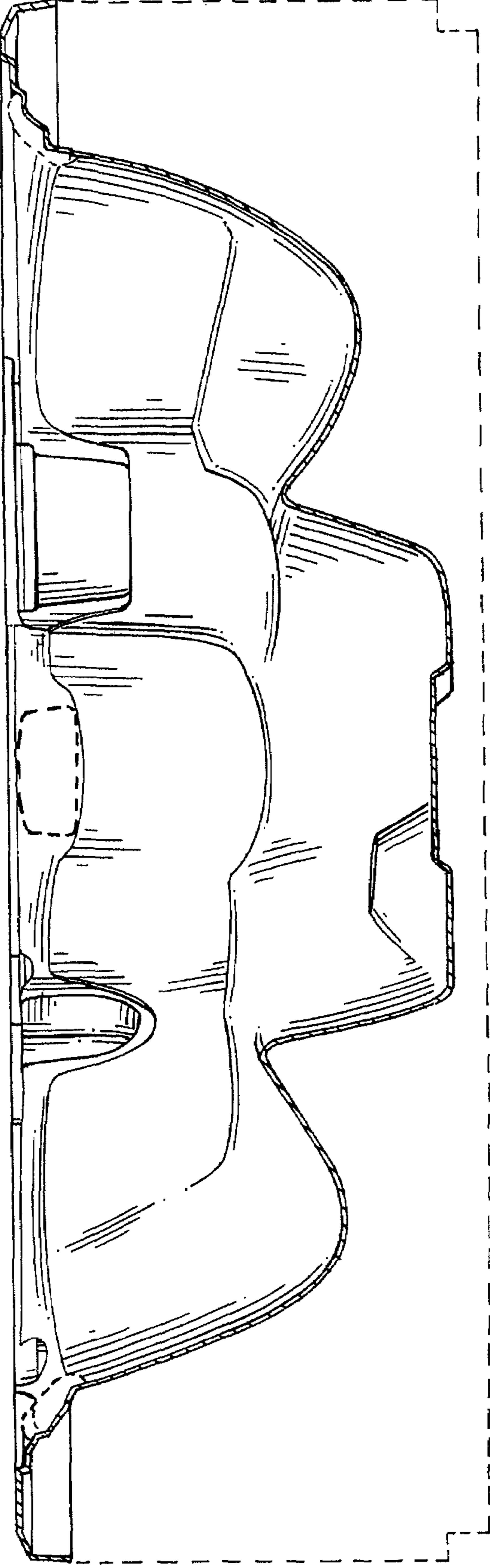
