FIG. 2 is a side elevational view thereof; the left, right, front and back side elevation views being the same;

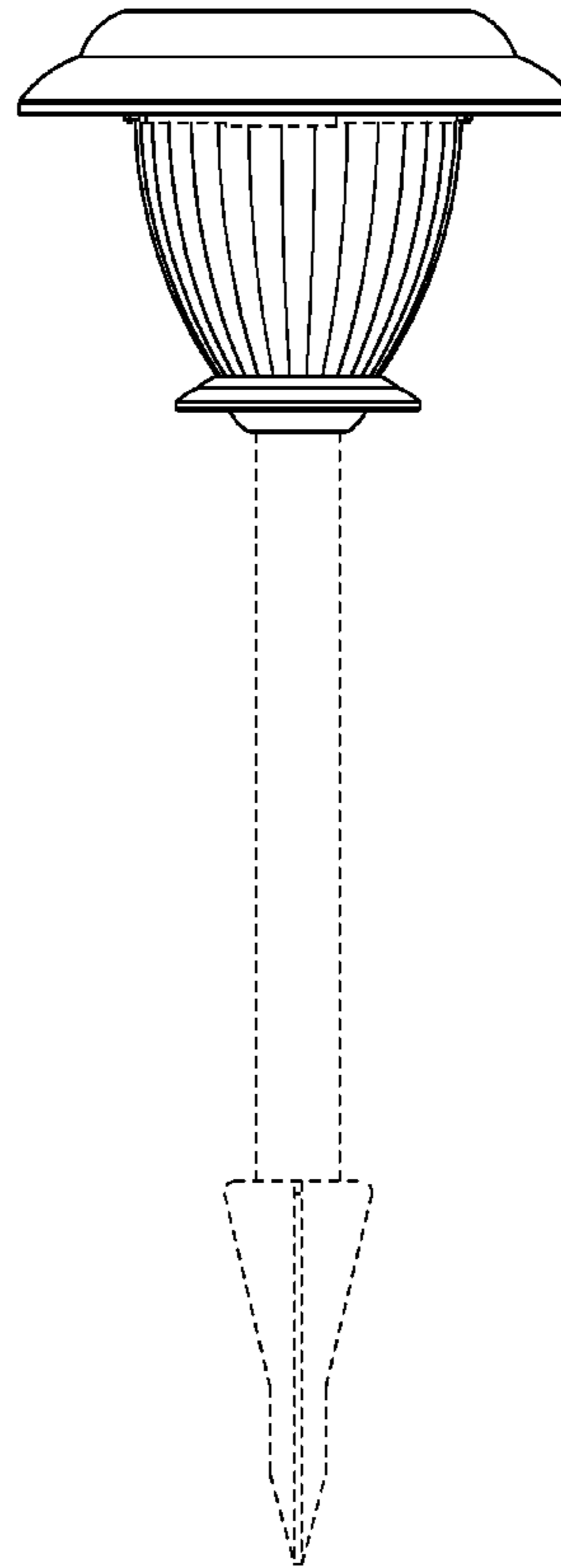
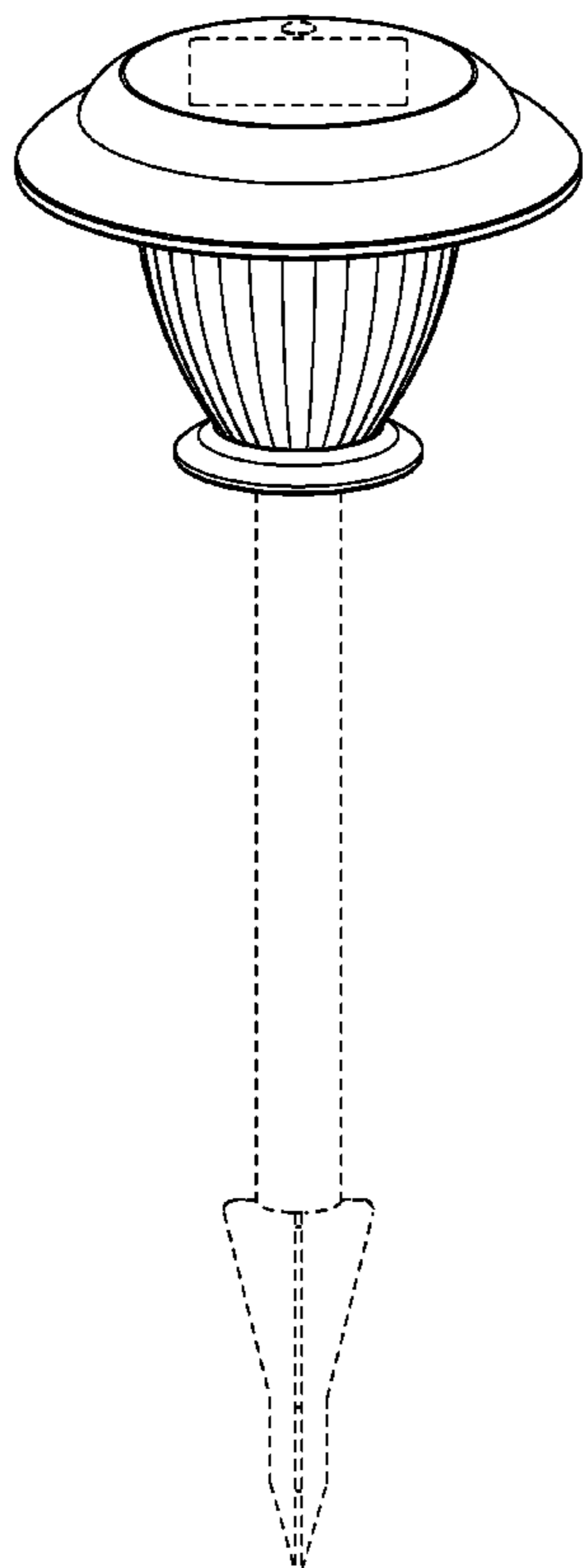
FIG. 3 is a top plan view thereof;

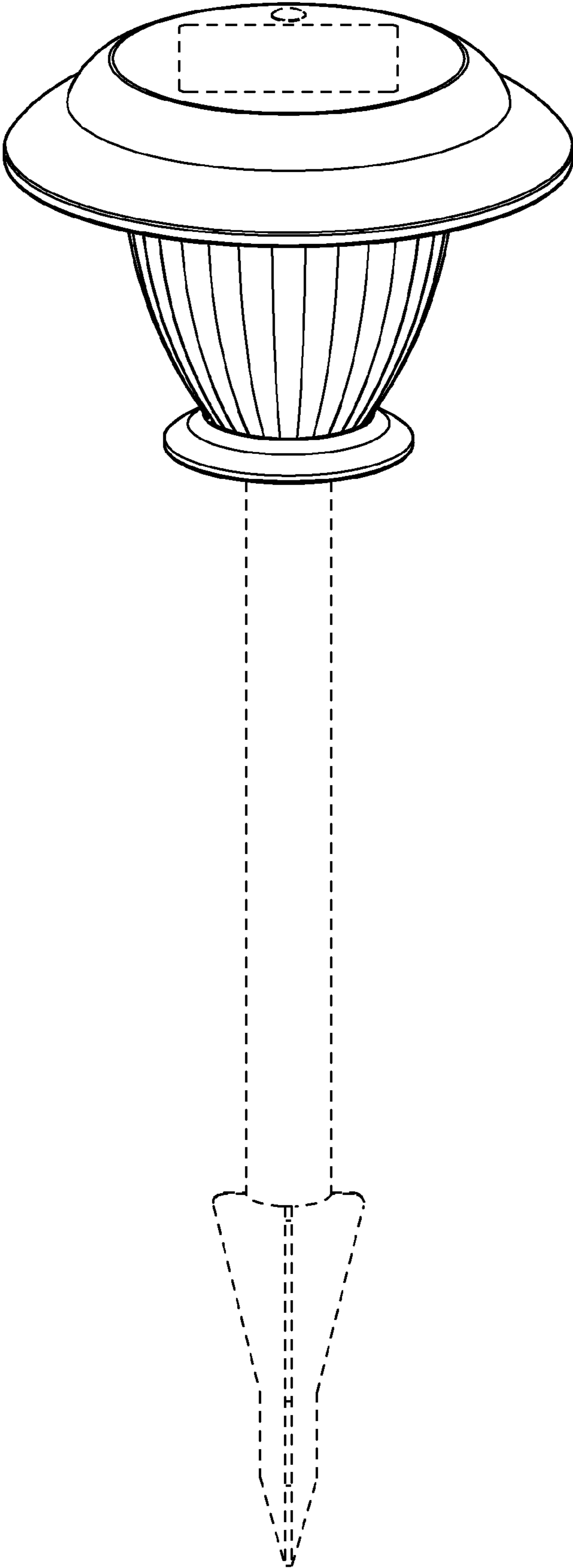

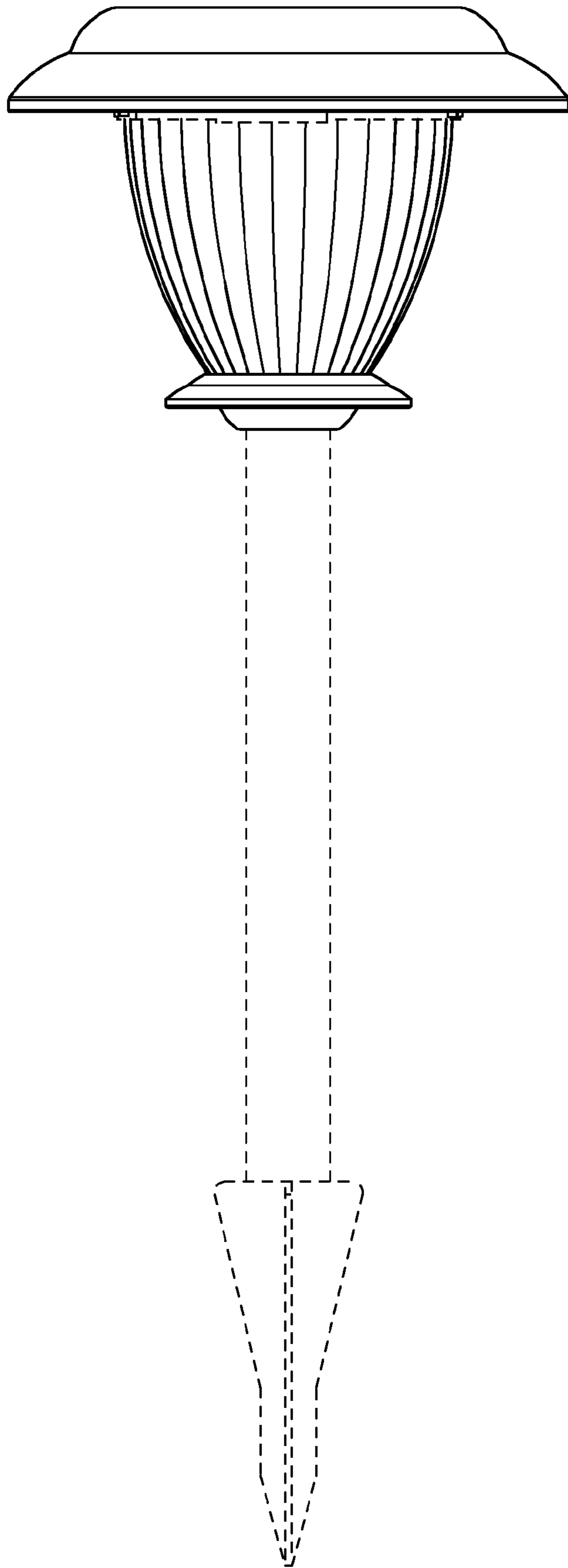

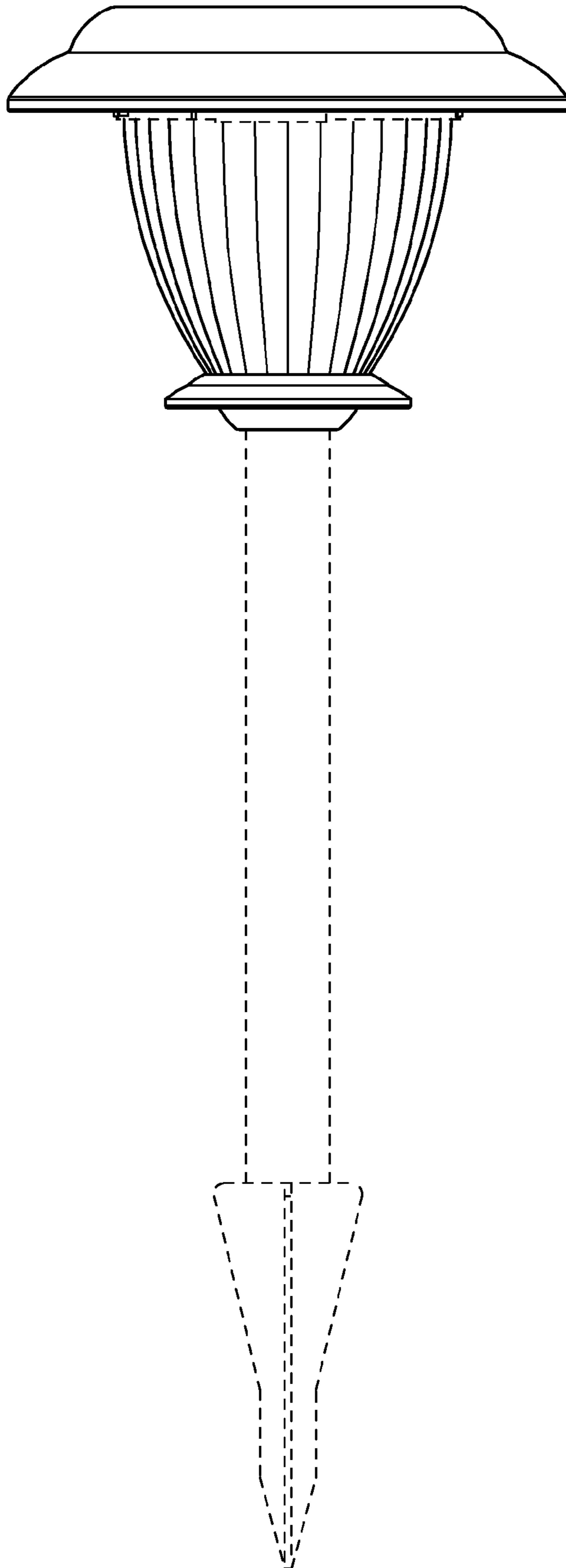
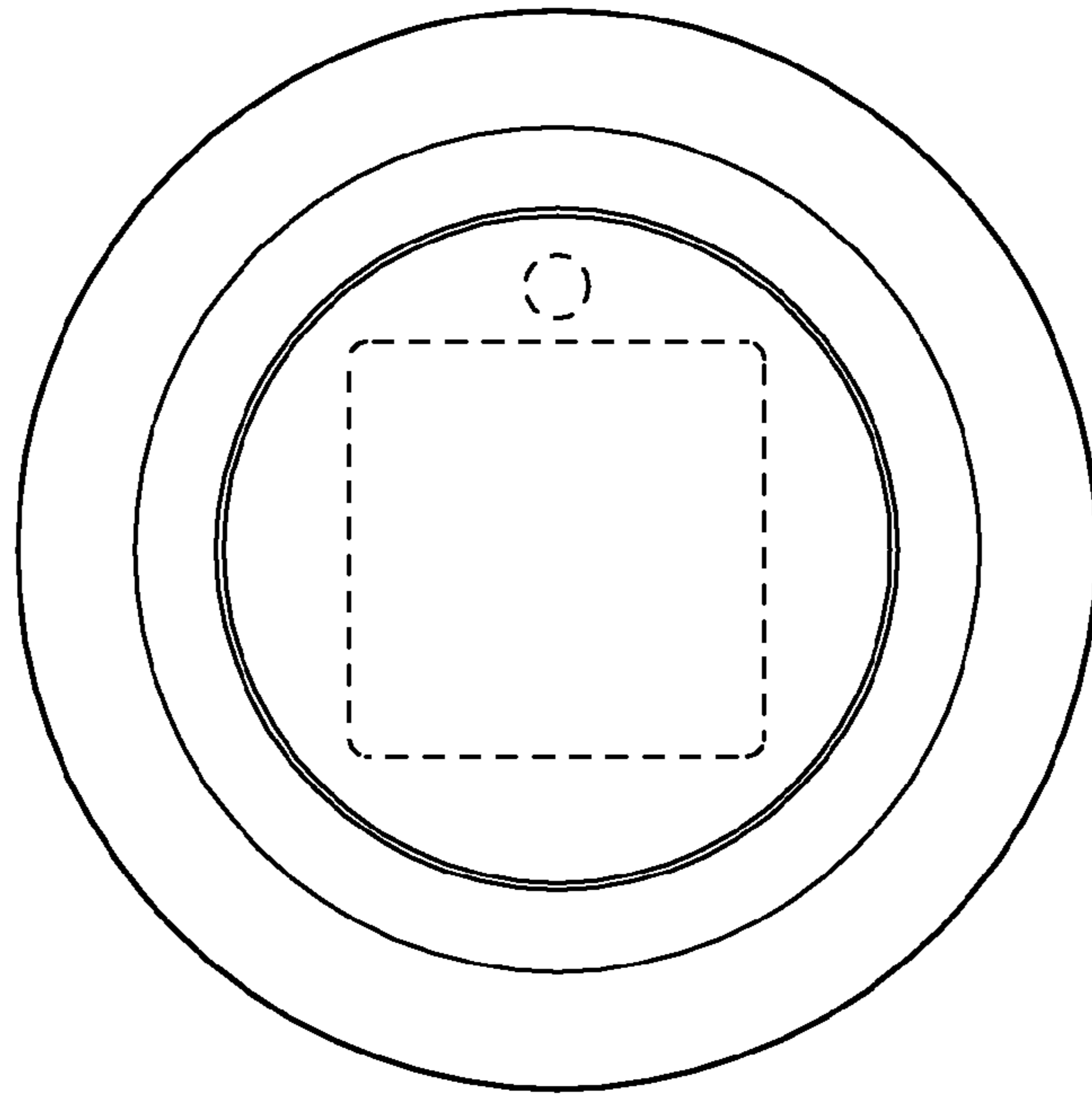
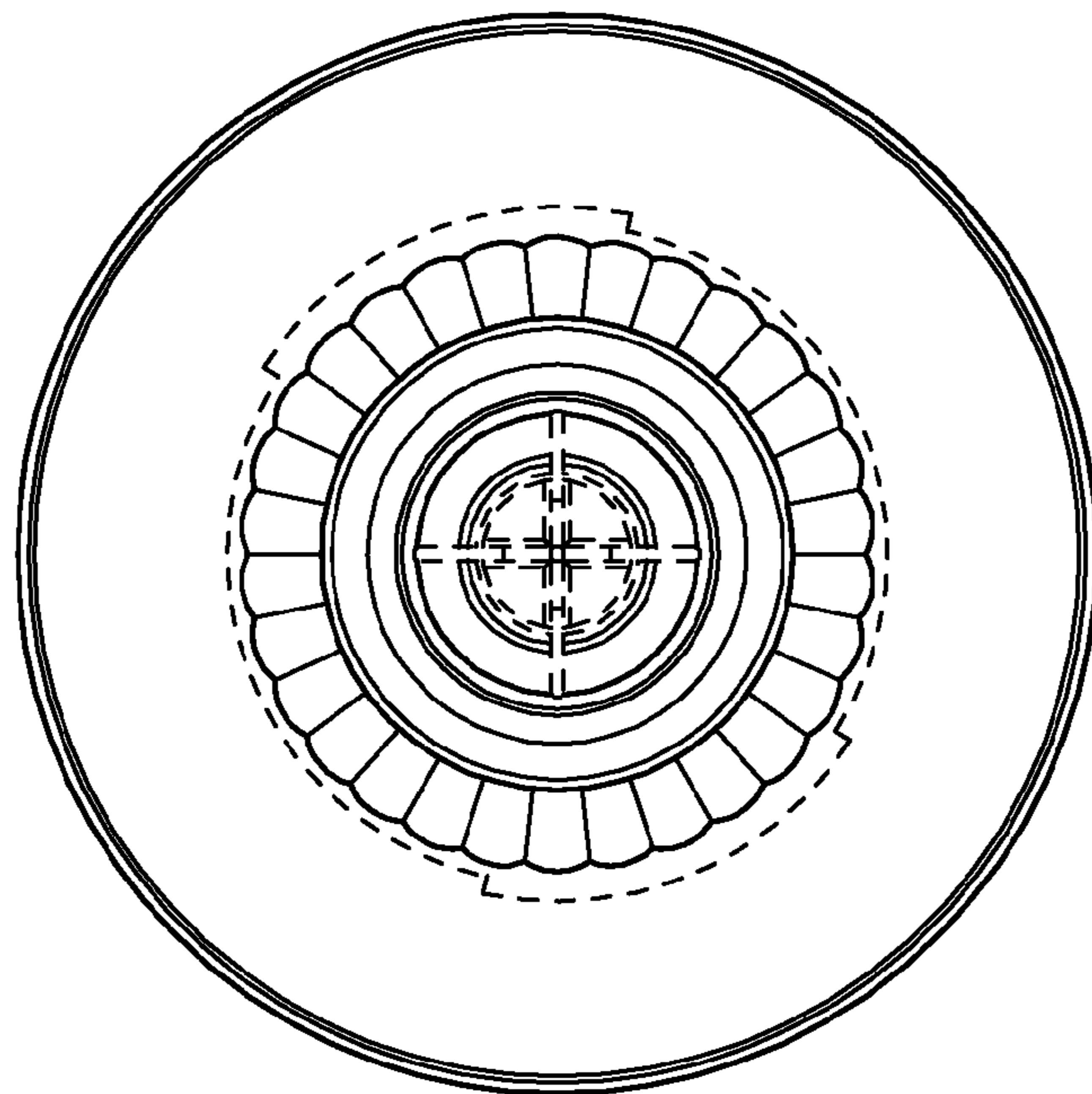
