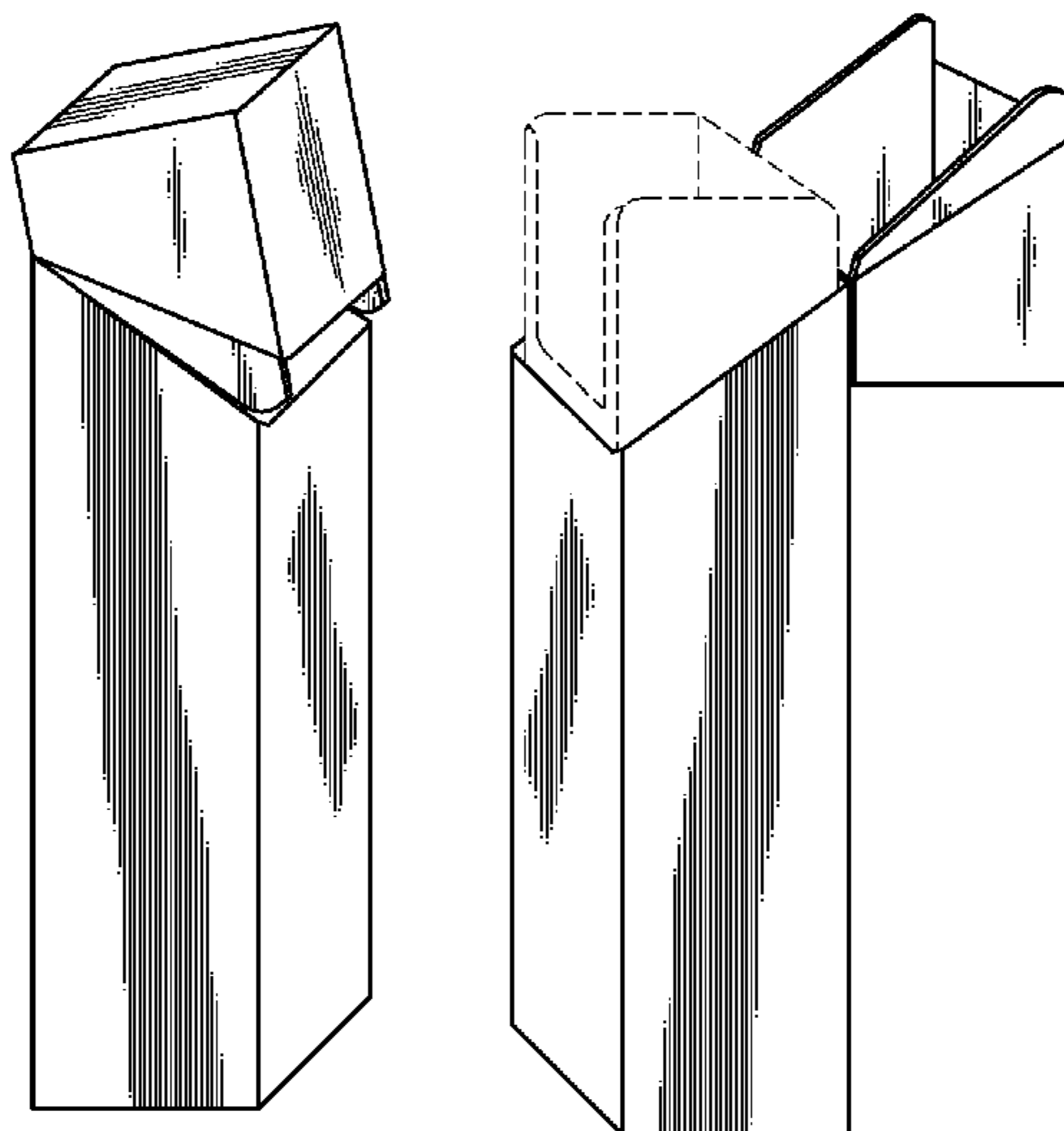

(57) **CLAIM**

The ornamental design for cigarette packaging, as shown and described.

FIG. 1 is a top front right side perspective view of the cigarette packaging with the lid closed showing the design of the disclosed invention;
FIG. 2 is a front view thereof;
FIG. 3 is a front view of the cigarette packaging with the lid open 90 degrees;
FIG. 4 is a left side view of the cigarette packaging with the lid slightly open;
FIG. 5 is a left side view of the cigarette packaging with the lid open 180 degrees;
FIG. 6 is a front view of the cigarette packaging with the lid slightly open;
FIG. 7 is a top front right side perspective view of a first embodiment of the cigarette packaging with the lid slightly open;
FIG. 8 is a left perspective view of the first embodiment of the cigarette packaging with the lid open 180 degrees;
FIG. 9 is a top front right side perspective view of a second embodiment of the cigarette packaging with the lid closed;
FIG. 10 is a front view thereof;
FIG. 11 is a front view of the second embodiment of the cigarette packaging with the lid open 90 degrees;
FIG. 12 is a left side view of the second embodiment of the cigarette packaging with the lid slightly open;
FIG. 13 is a left side view of the second embodiment of the cigarette packaging with the lid open 180 degrees;
FIG. 14 is a front view of the second embodiment of the cigarette packaging with the lid slightly open;
FIG. 15 is a top front right side perspective view of a second embodiment of the cigarette packaging with the lid slightly open; and,
FIG. 16 is left perspective view of the second embodiment of the cigarette packaging with the lid open 180 degrees.

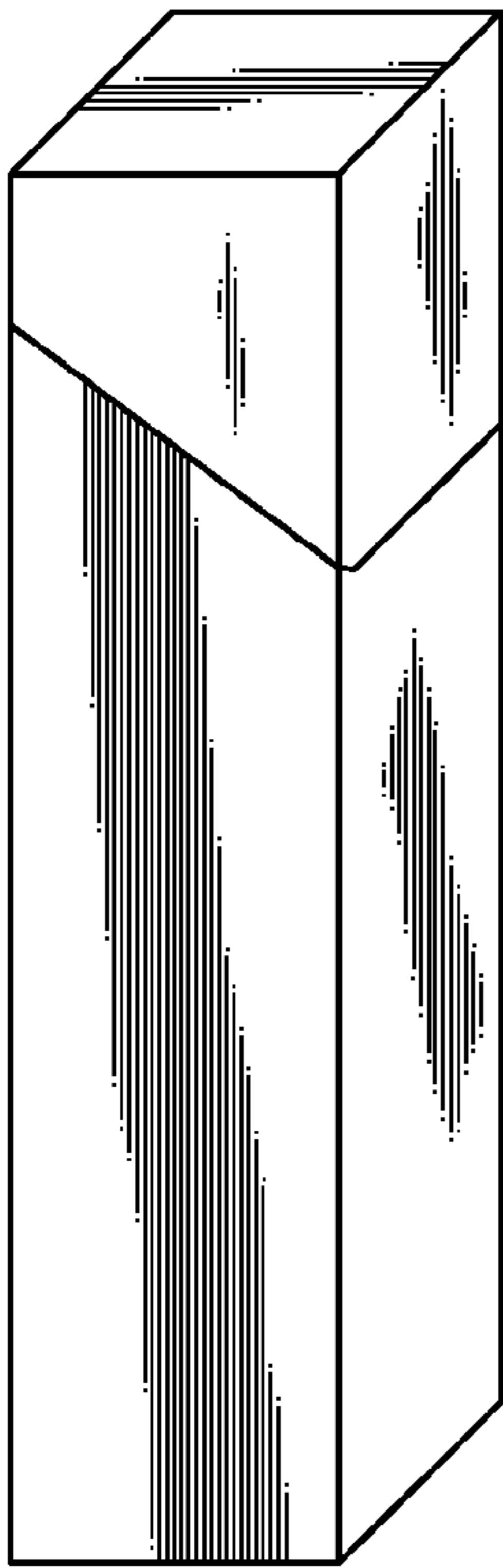

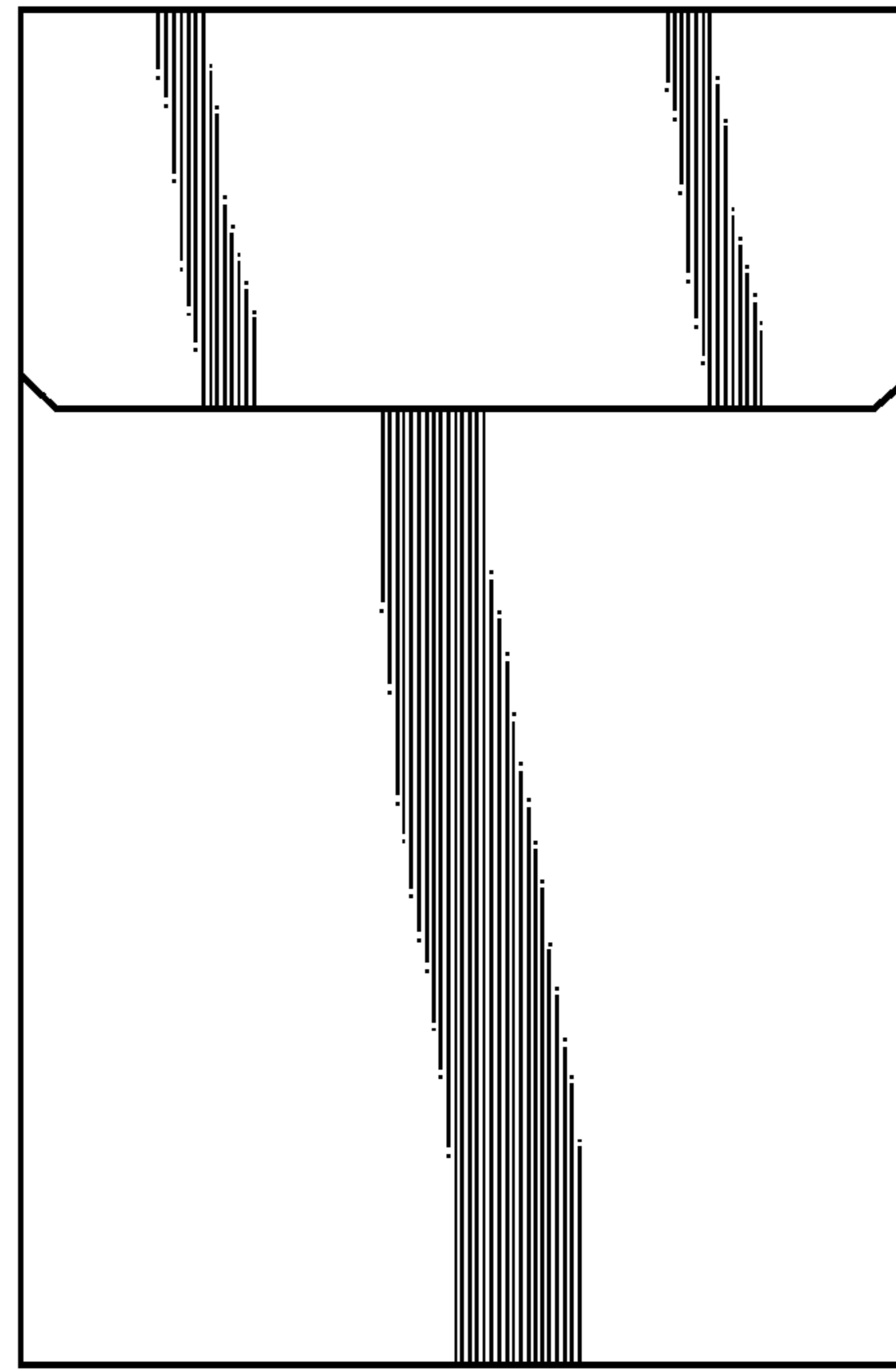

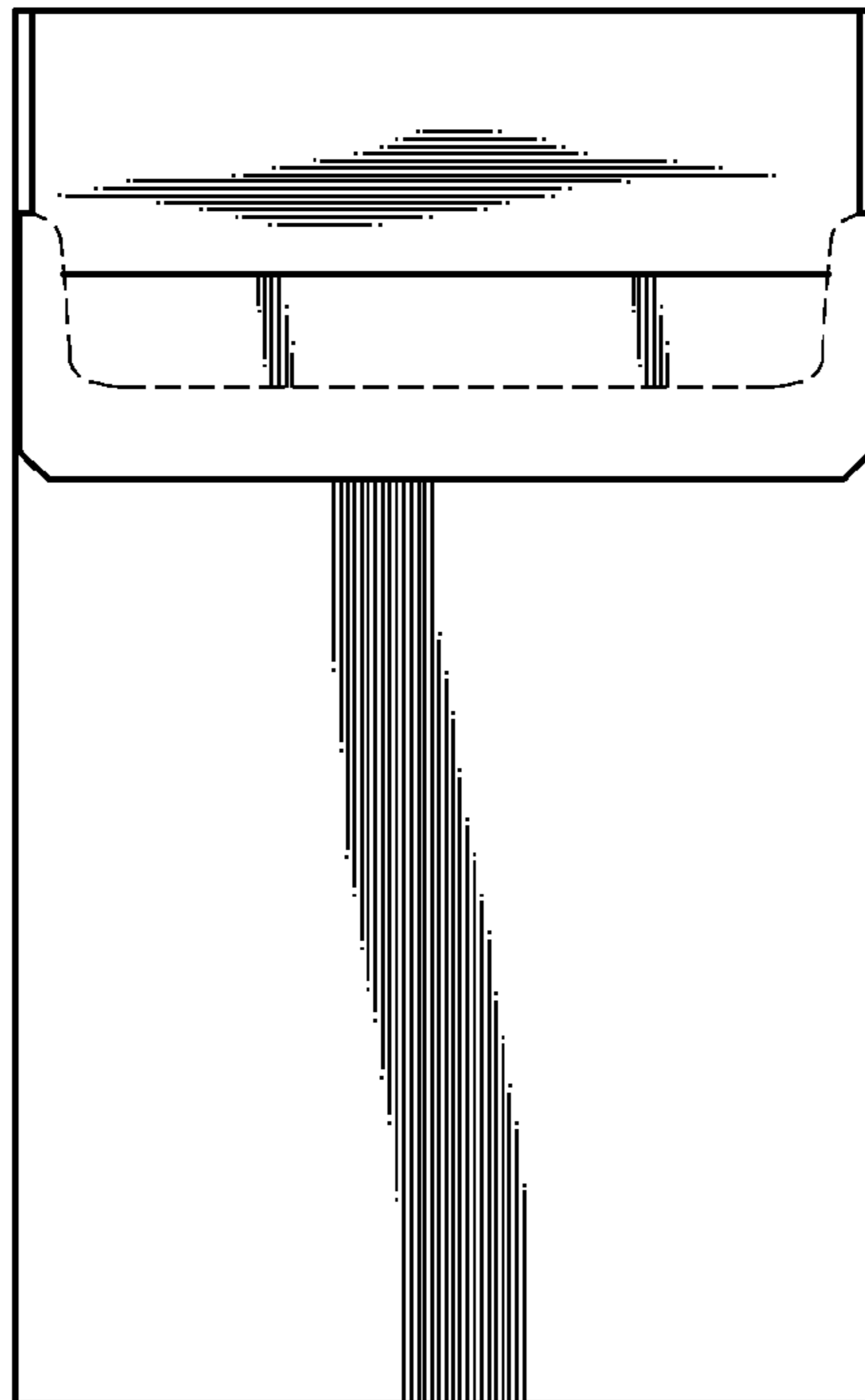

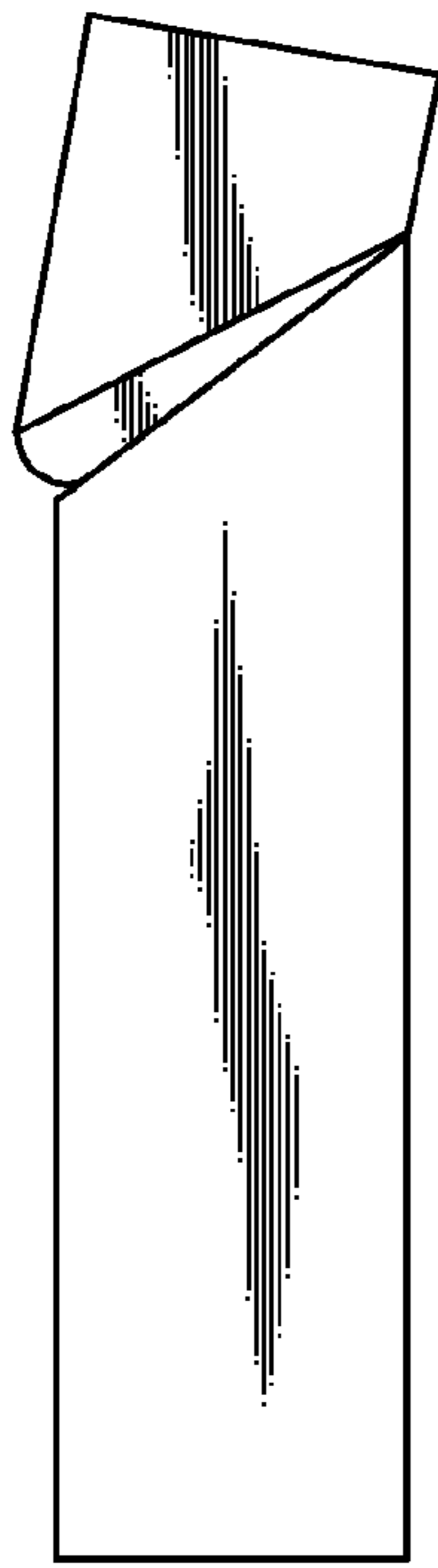

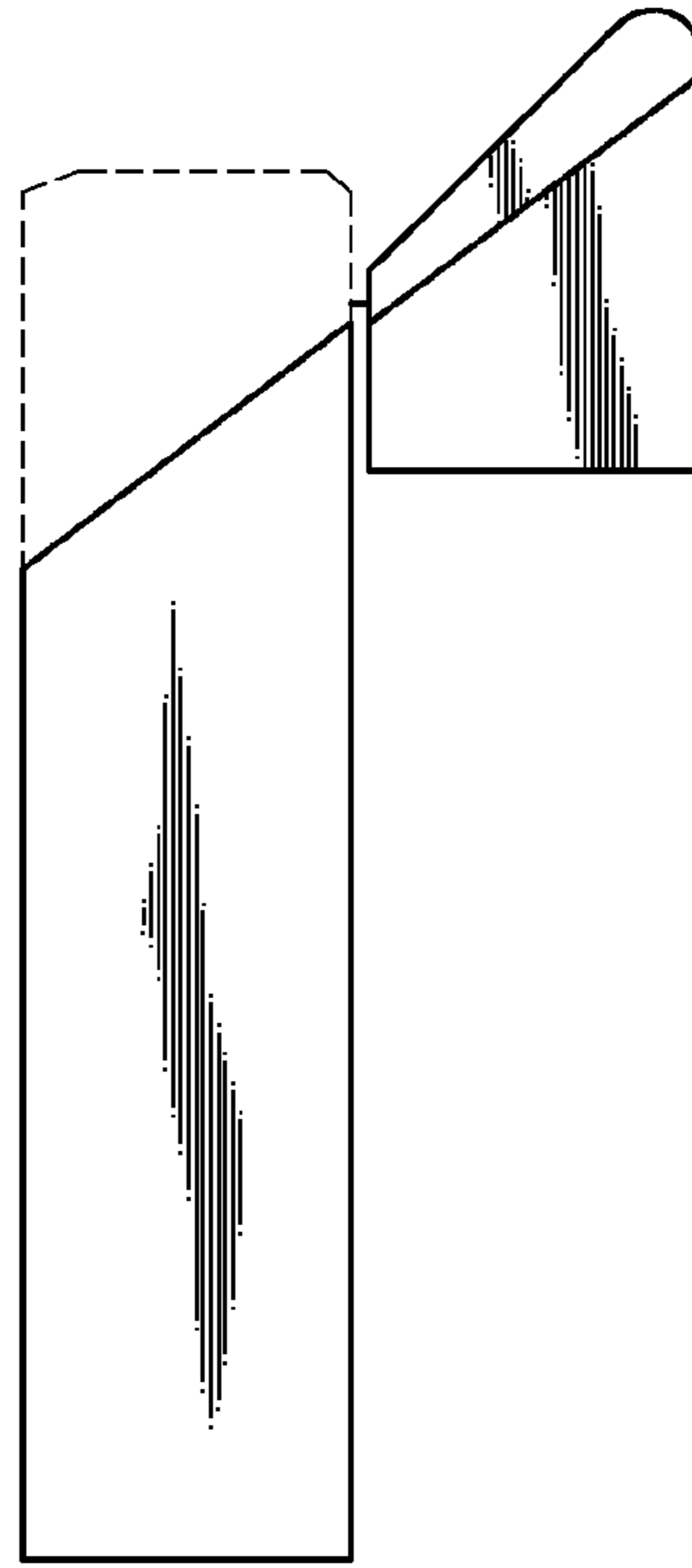

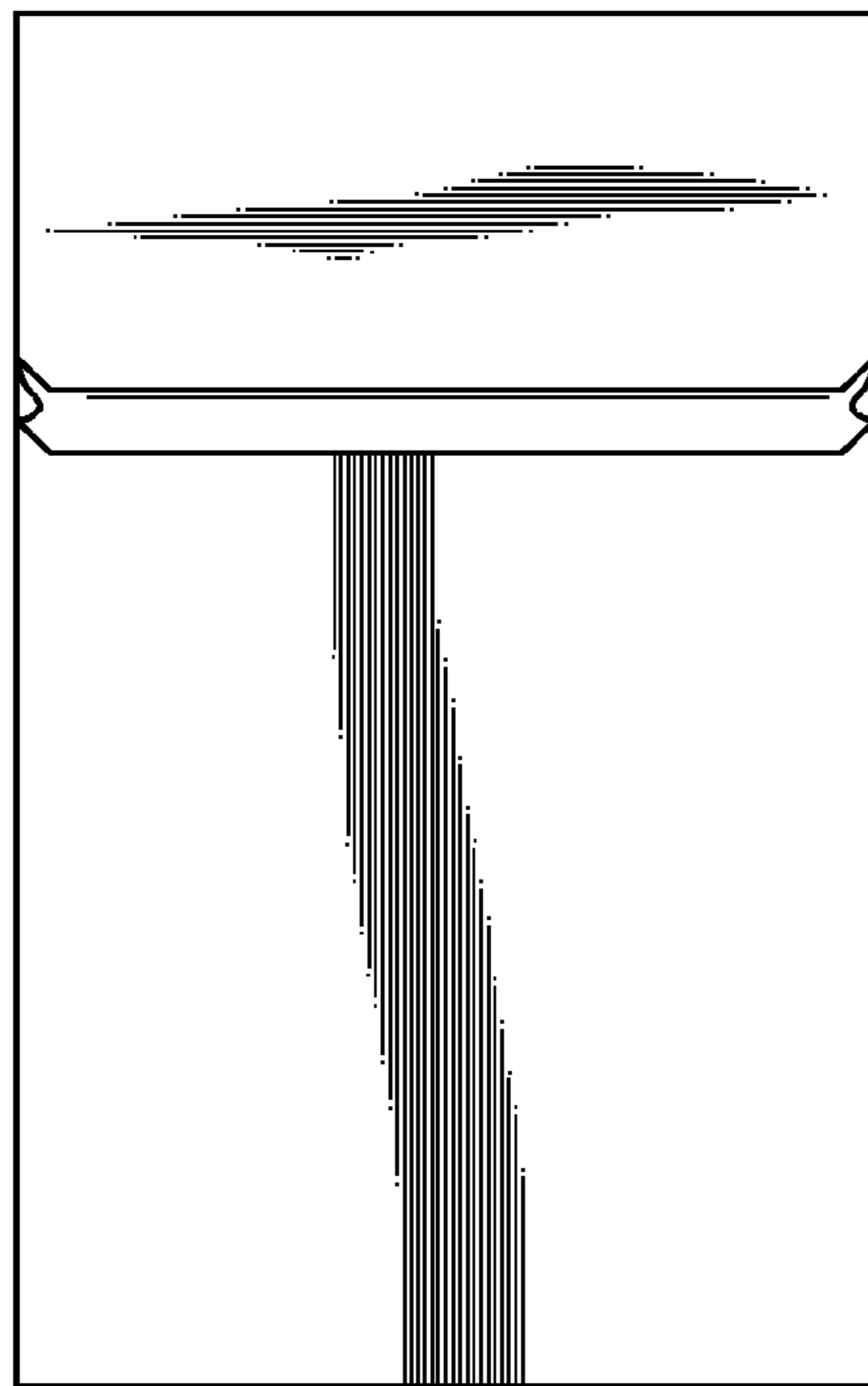

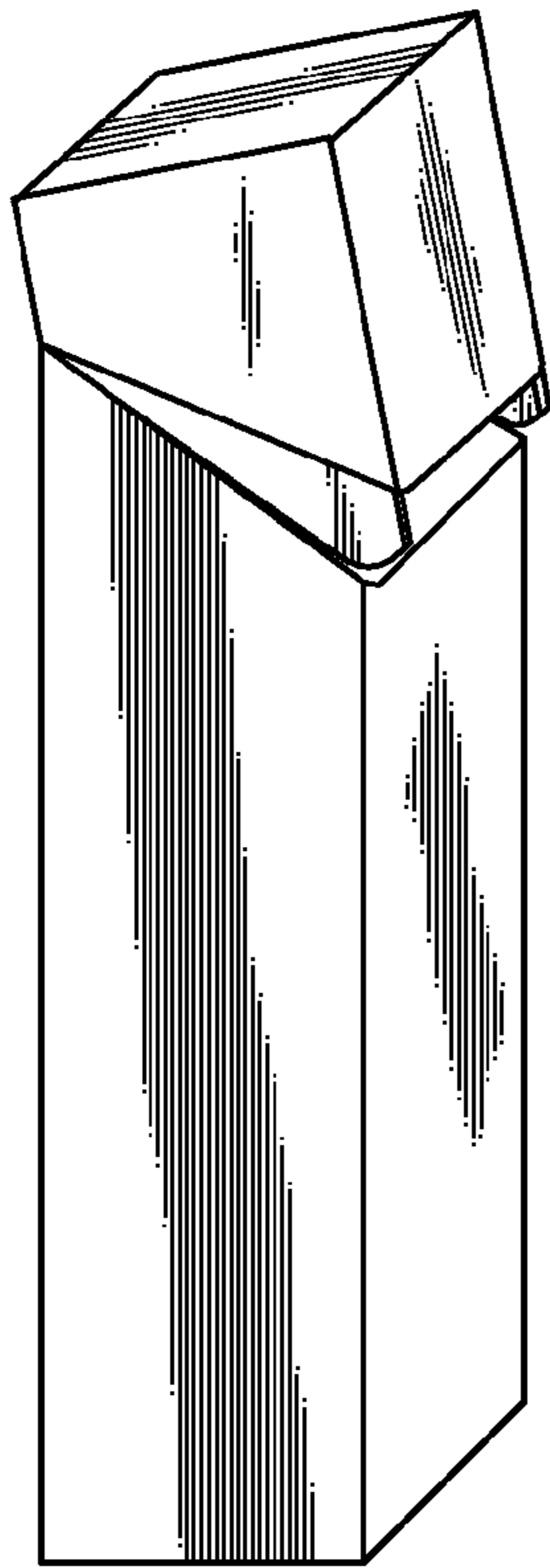

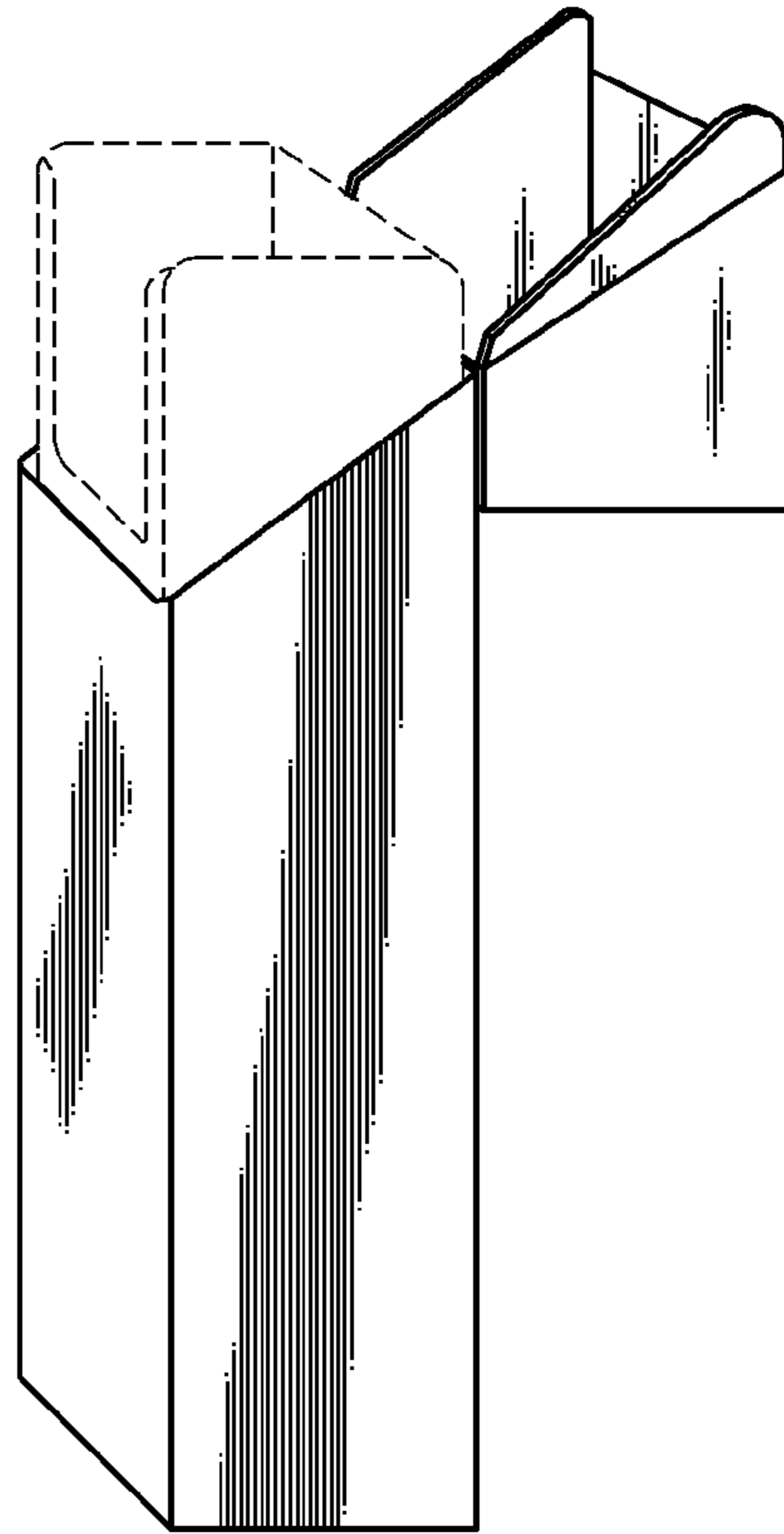

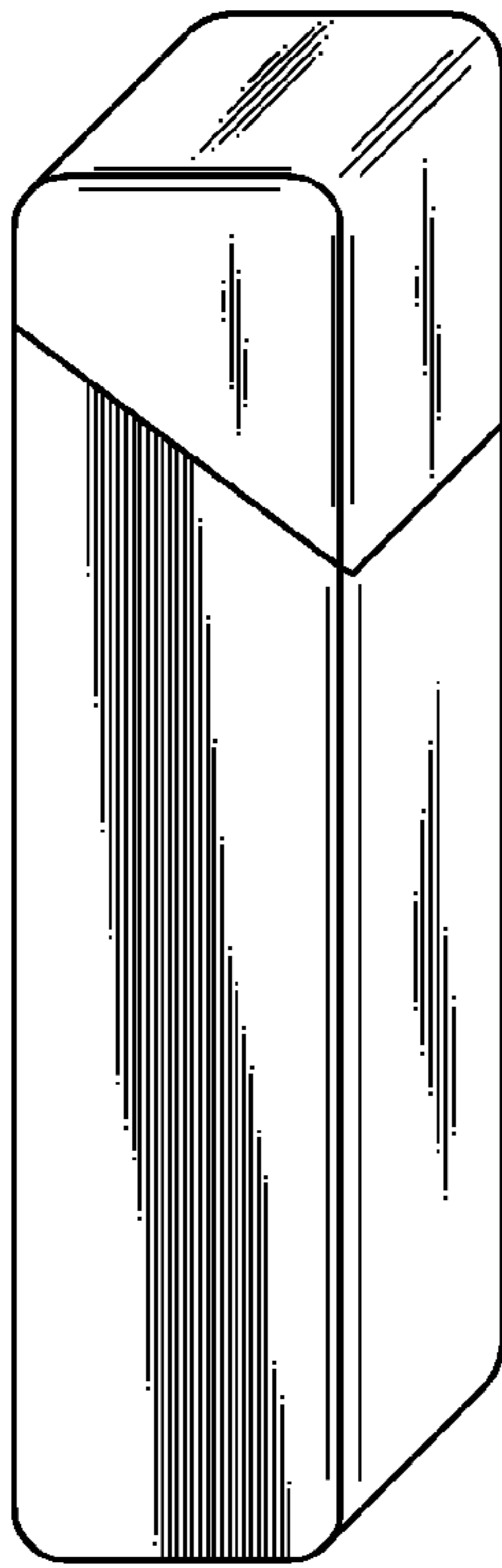

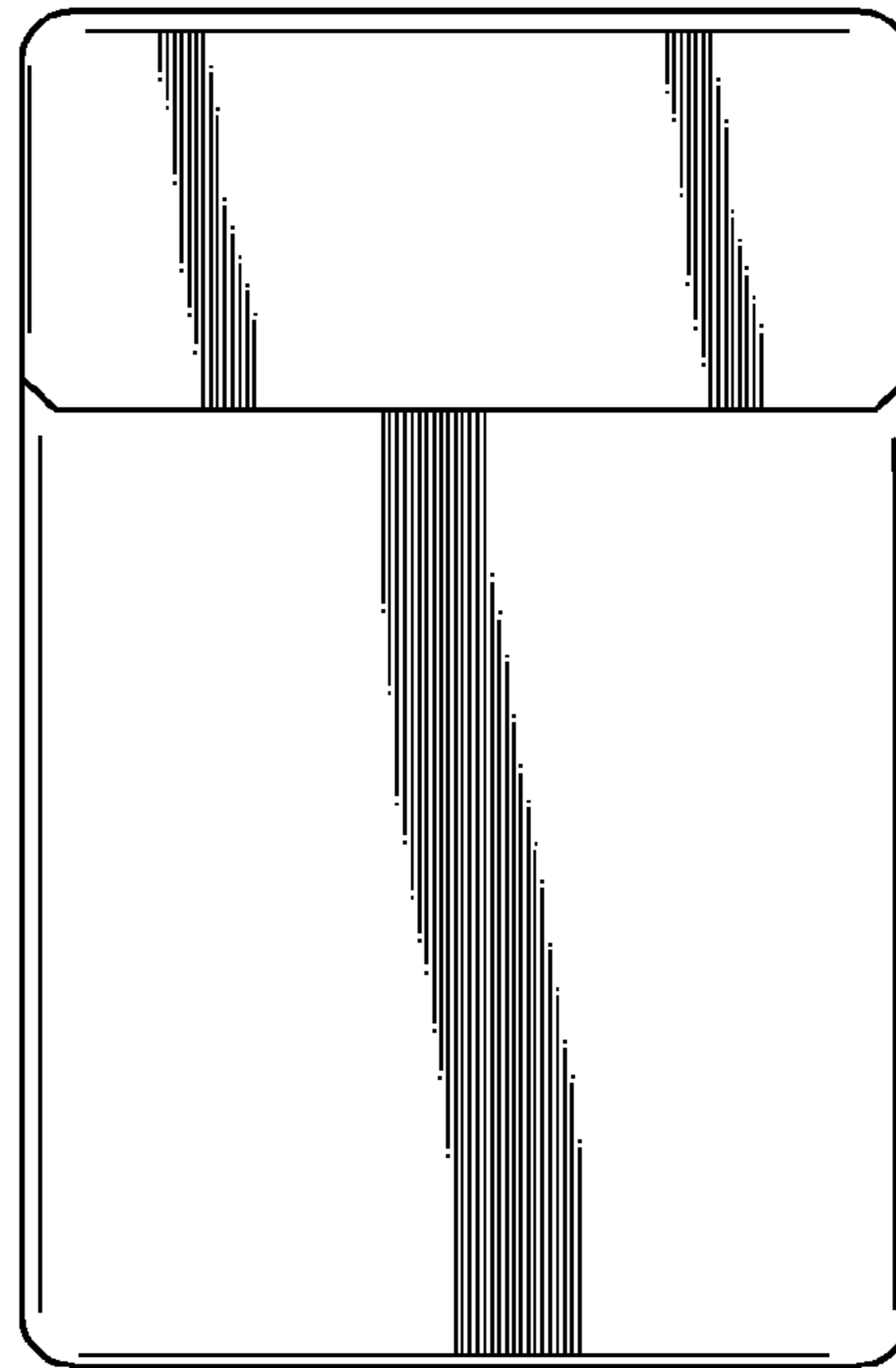

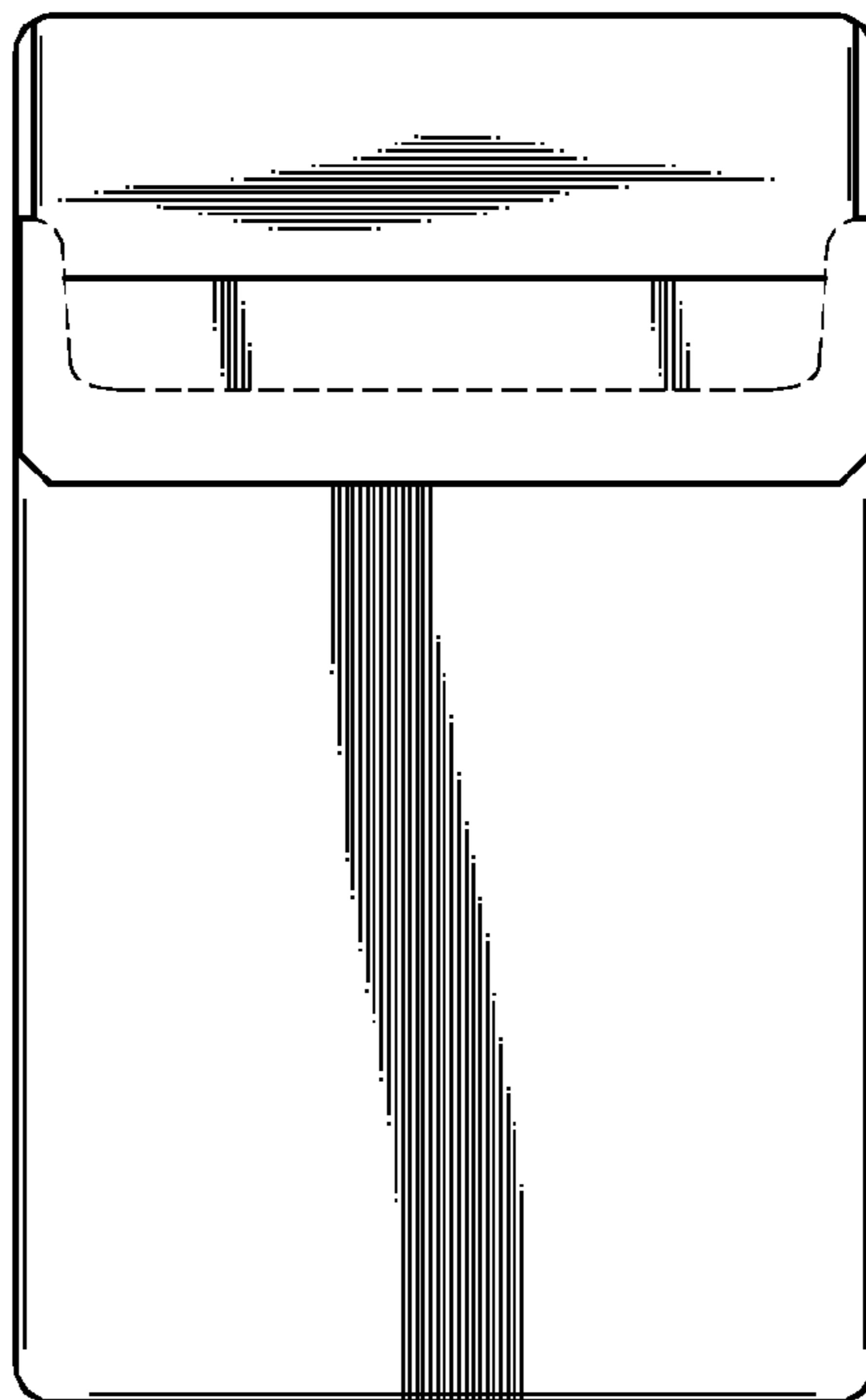

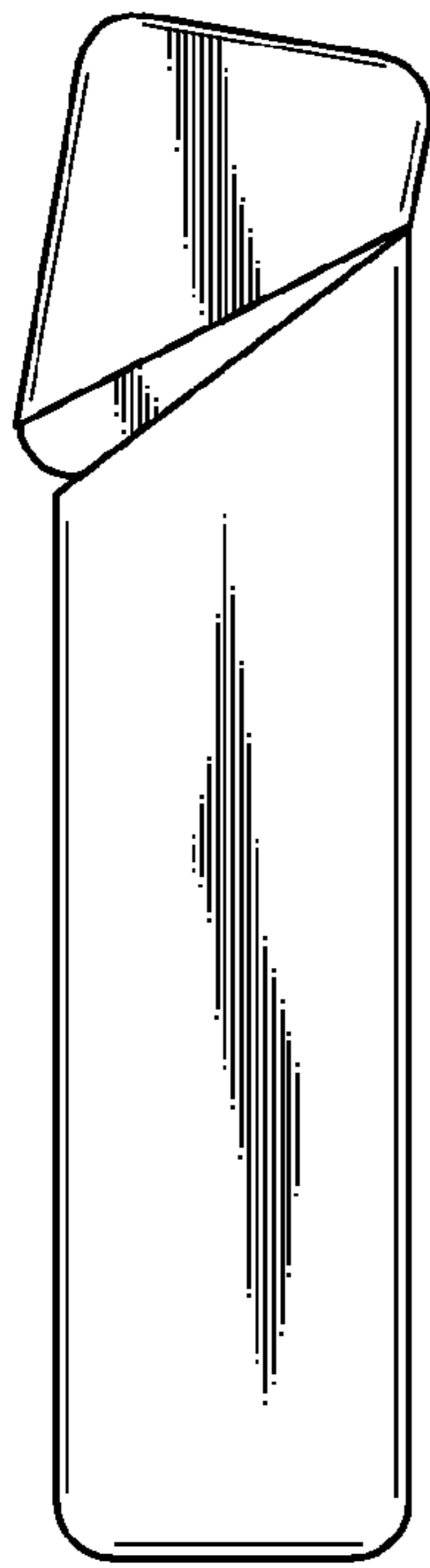

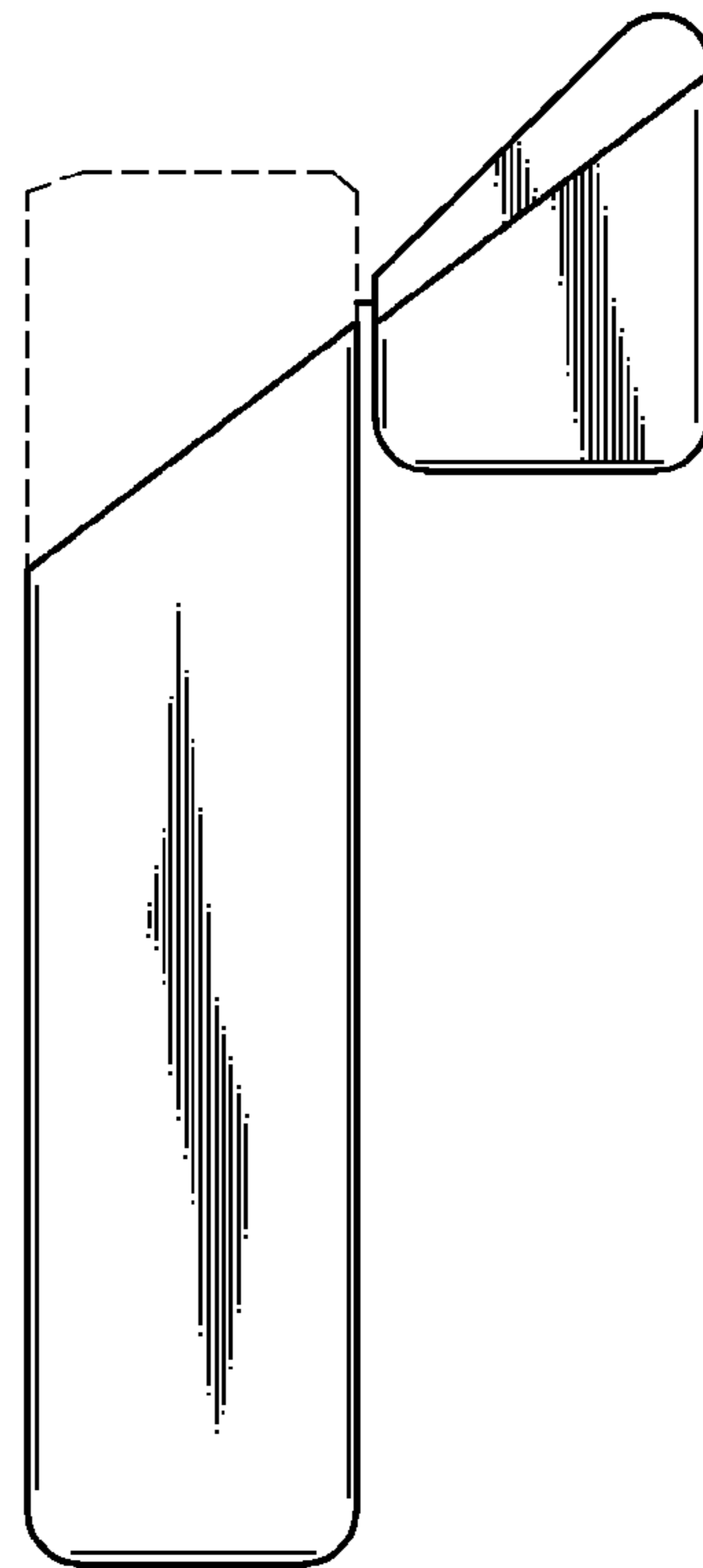

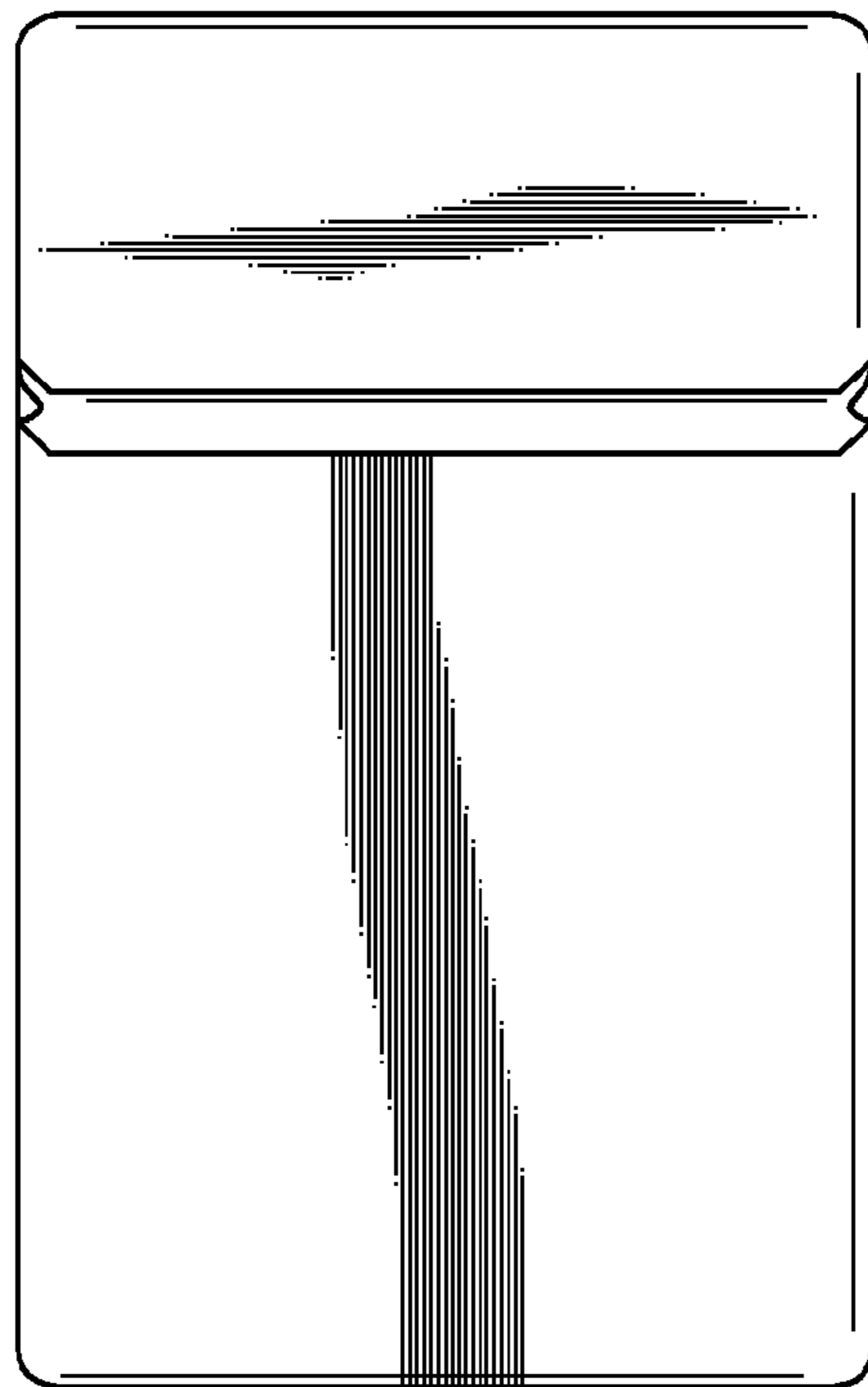

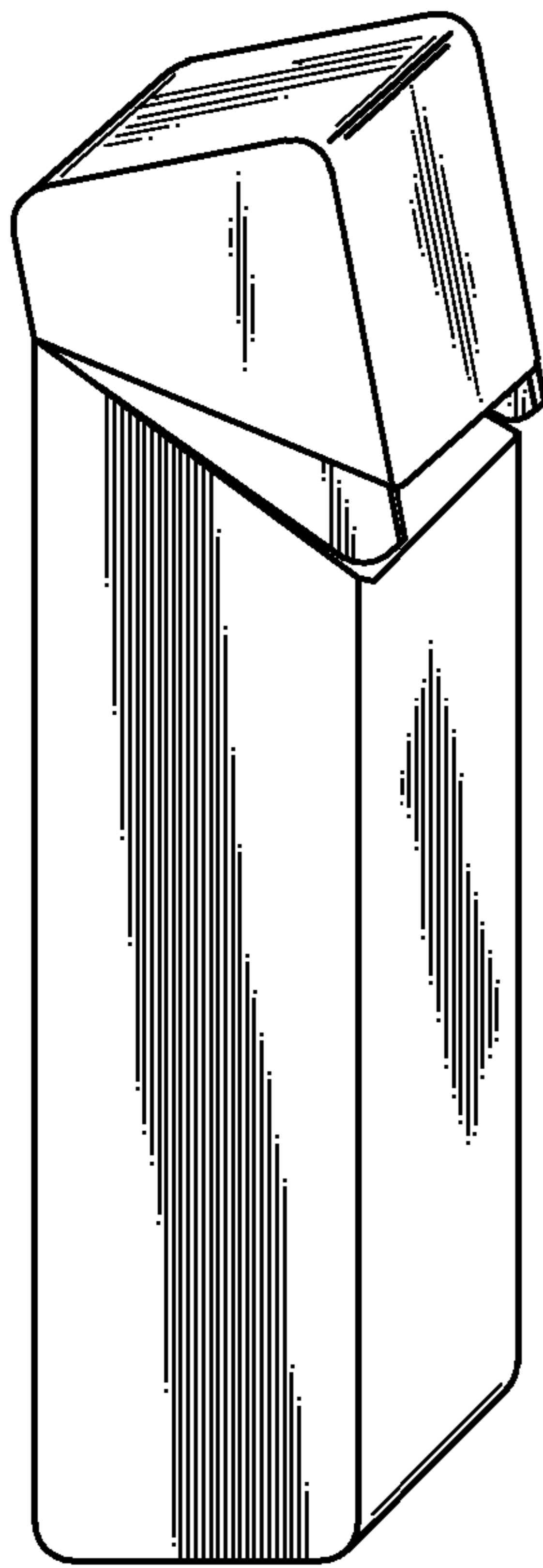

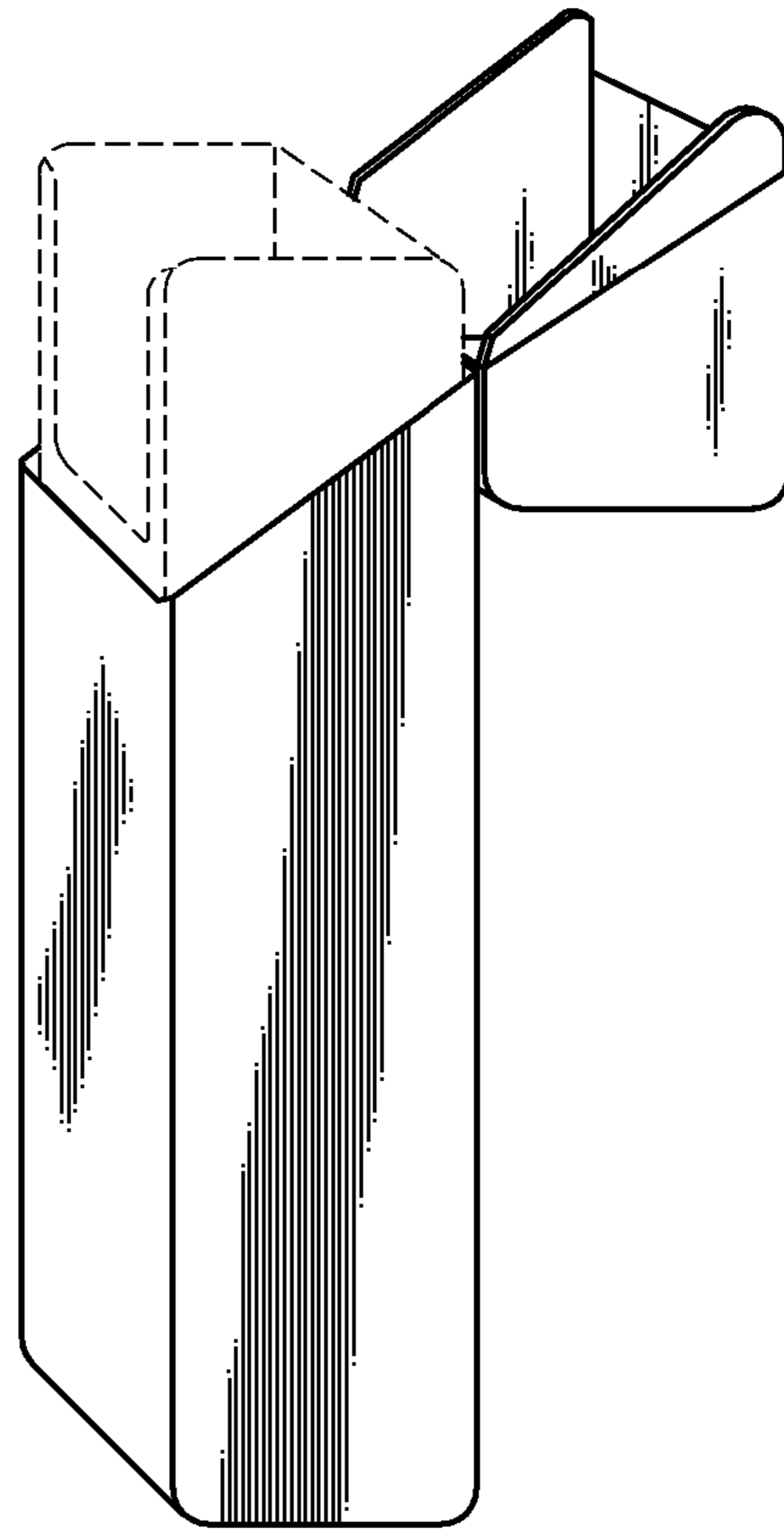
