(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective top view of a shoe sole showing the new design;

FIG. 2 is a perspective bottom view of the shoe sole depicted in FIG. 1;

FIG. 3 is a front elevational view of the shoe sole depicted in FIG. 1;

FIG. 4 is a rear elevational view of the shoe sole depicted in FIG. 1;

FIG. 5 is a left side elevational view of the shoe sole depicted in FIG. 1;

FIG. 6 is a right side elevational view of the shoe sole depicted in FIG. 1;

FIG. 7 is a top elevational view of the shoe sole depicted in FIG. 1;

FIG. 8 is a bottom elevational view of the shoe sole depicted in FIG. 1;

FIG. 9 is a perspective top view of another embodiment of a shoe sole of FIG. 1;

FIG. 10 is a perspective bottom view of the shoe sole depicted in FIG. 9;

FIG. 11 is a front elevational view of the shoe sole depicted in FIG. 9;

FIG. 12 is a rear elevational view of the shoe sole depicted in FIG. 9;

FIG. 13 is a left side elevational view of the shoe sole depicted in FIG. 9;

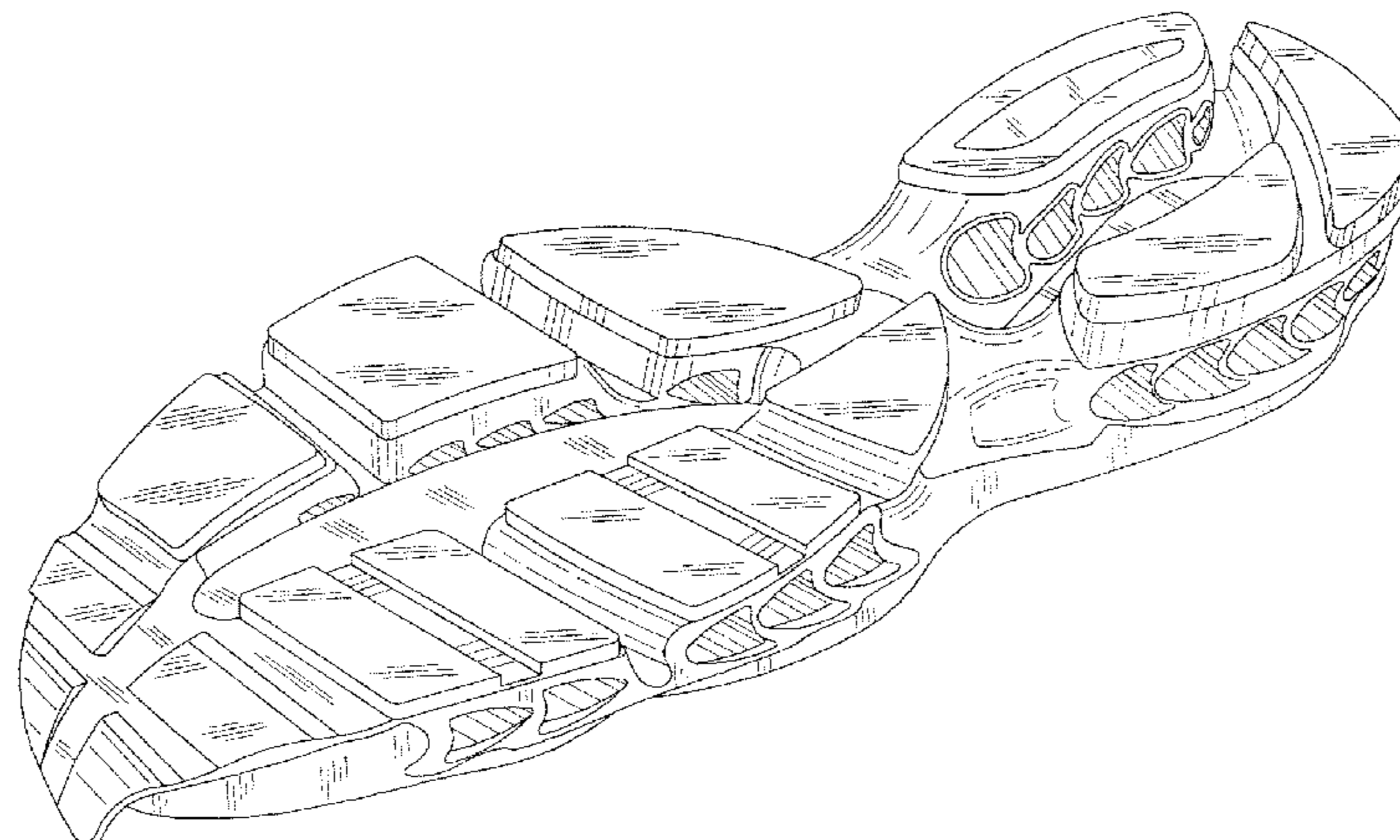
FIG. 14 is a right side elevational view of the shoe sole depicted in FIG. 9;

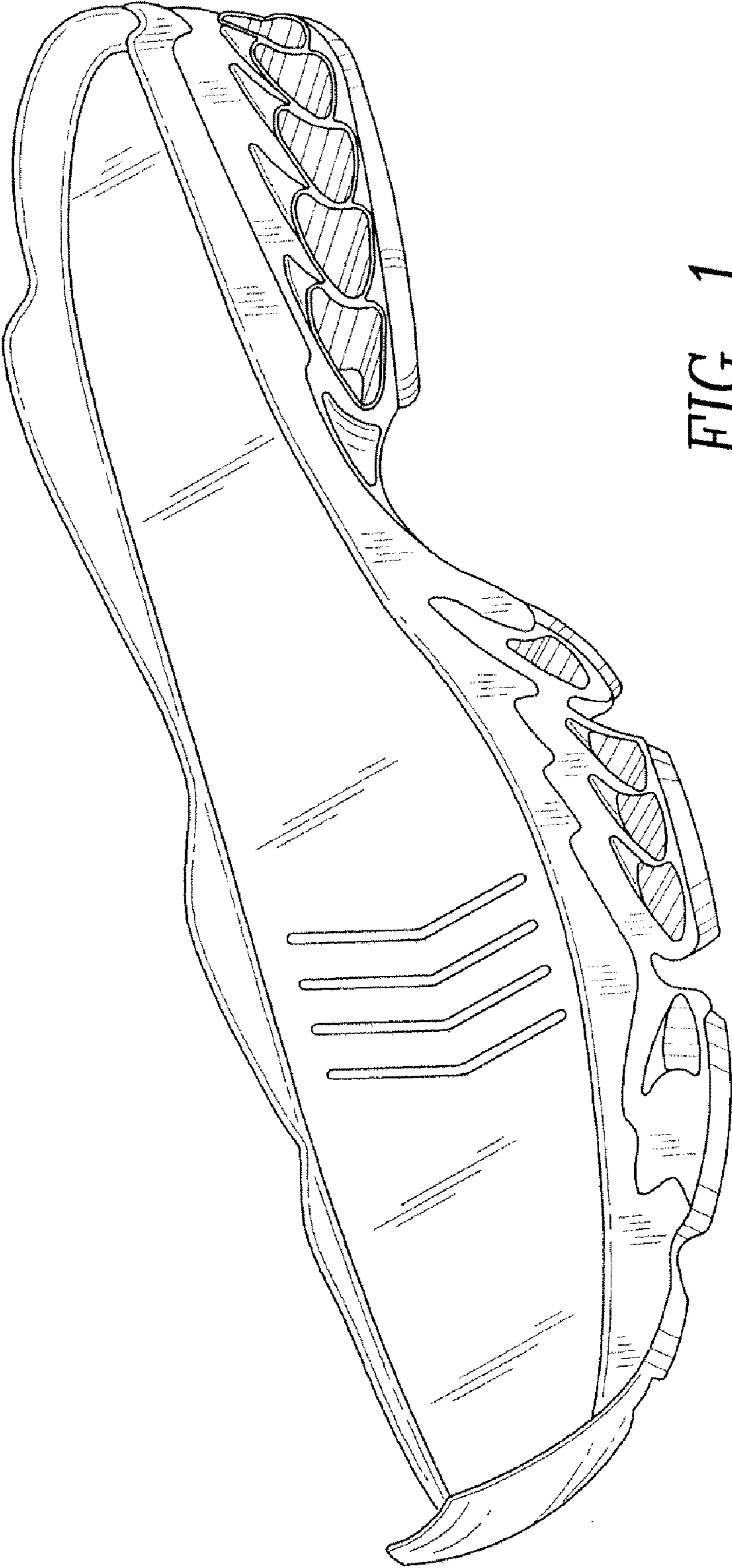

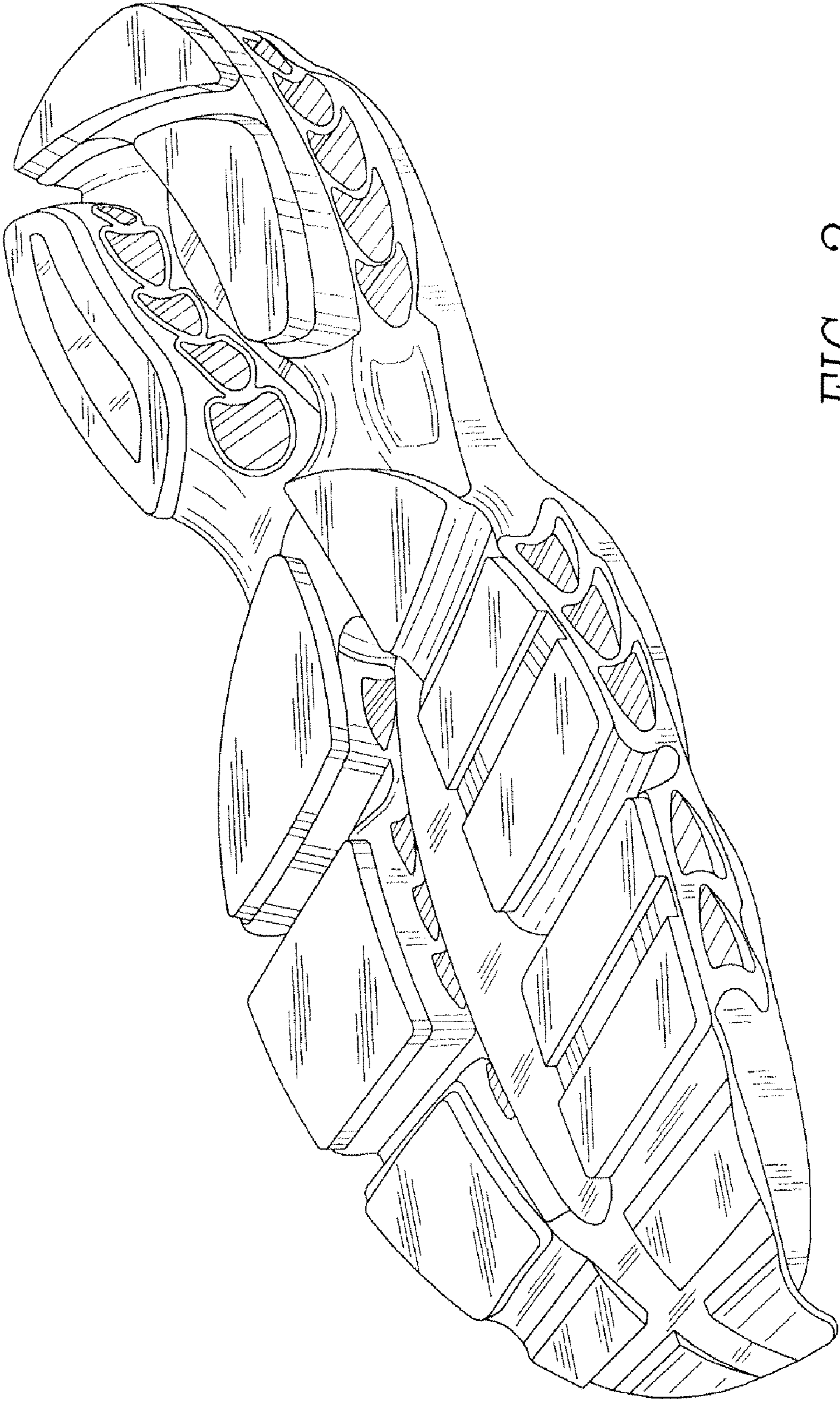
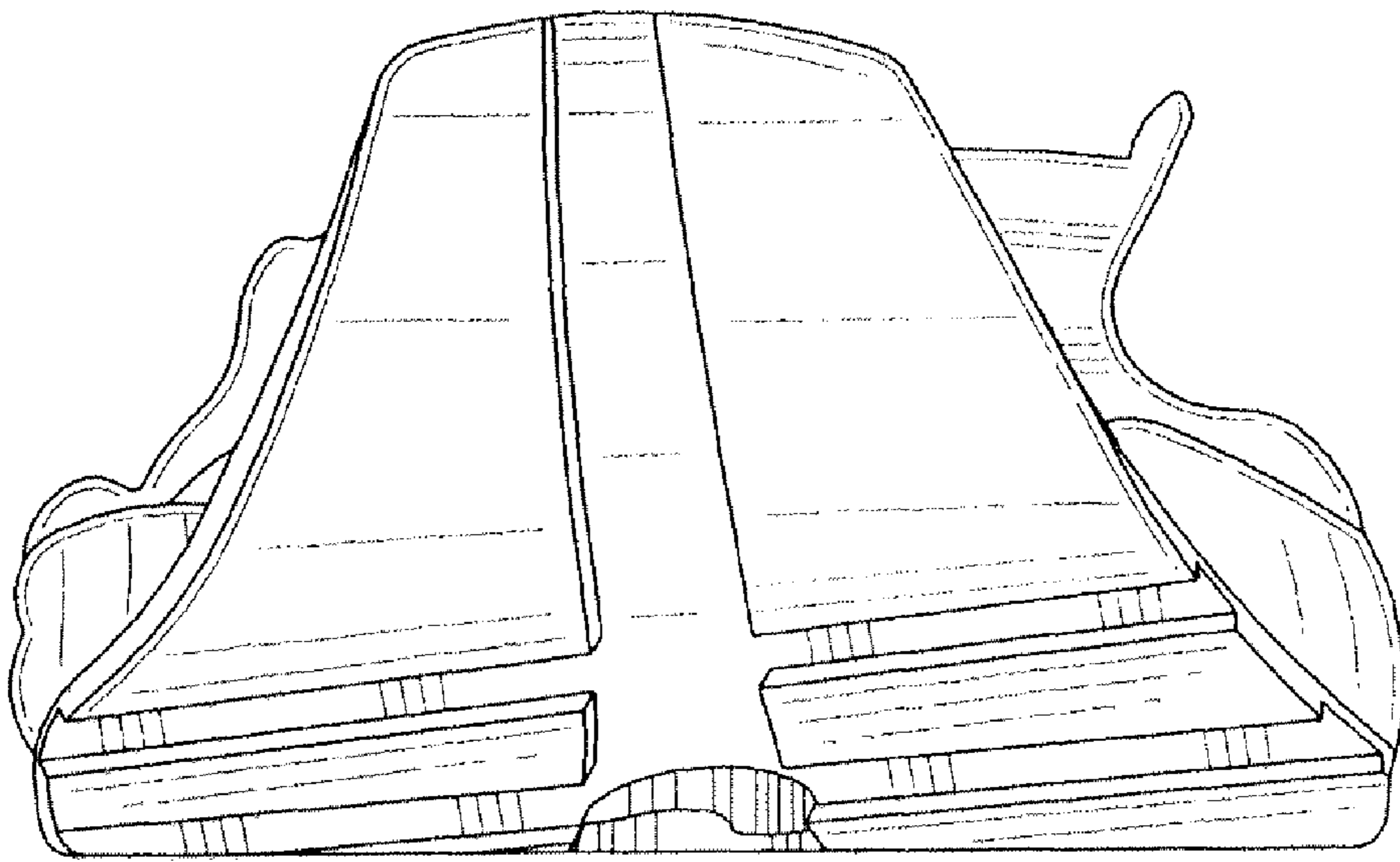
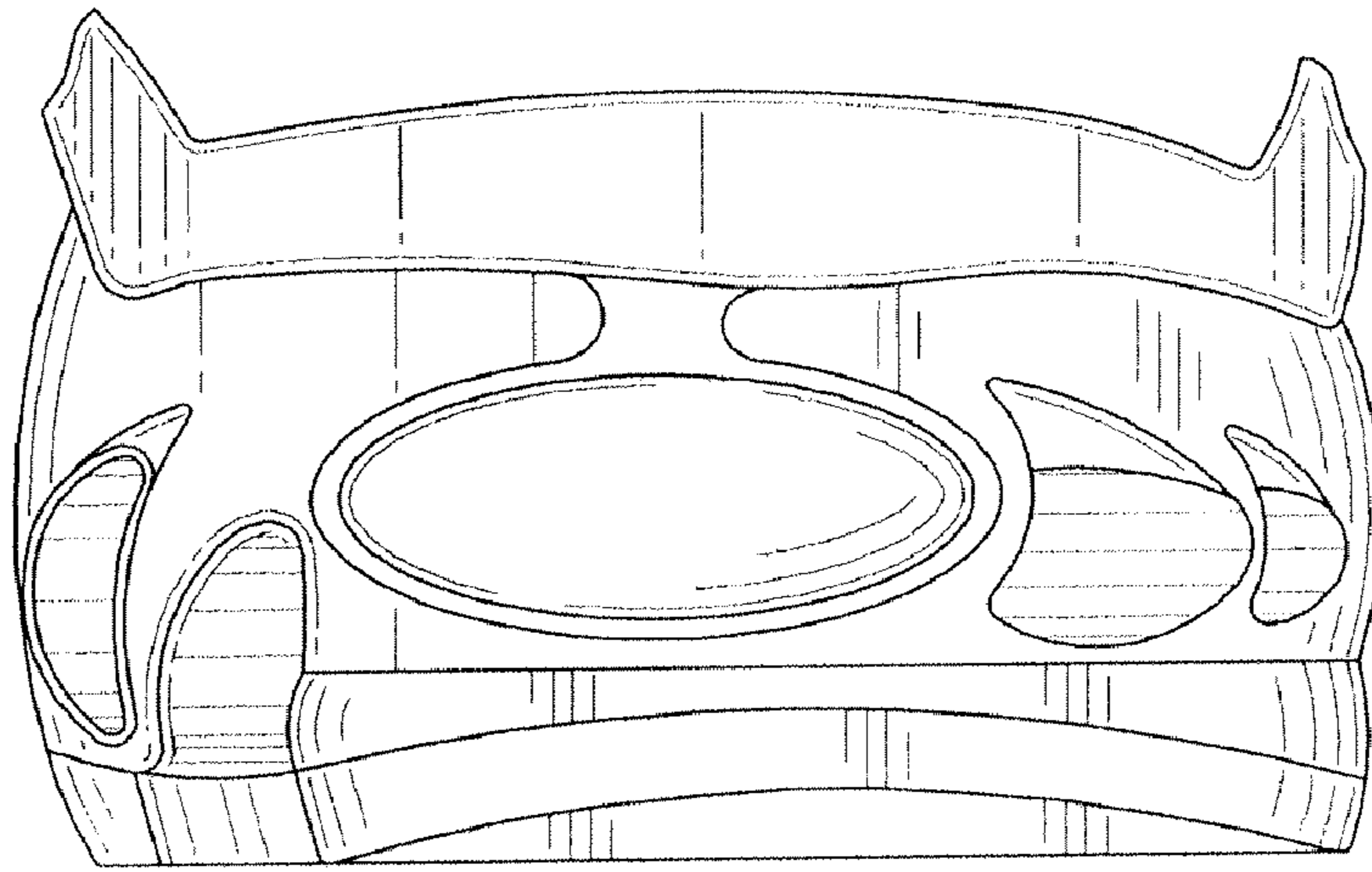

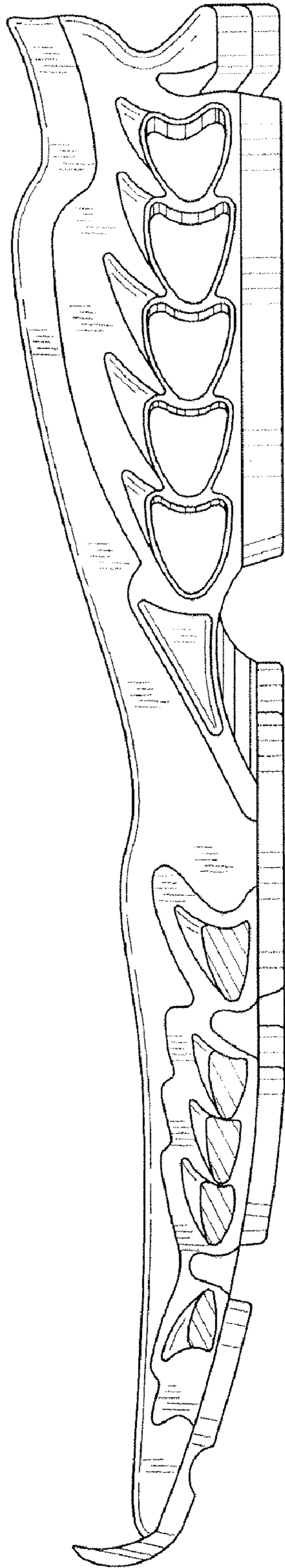

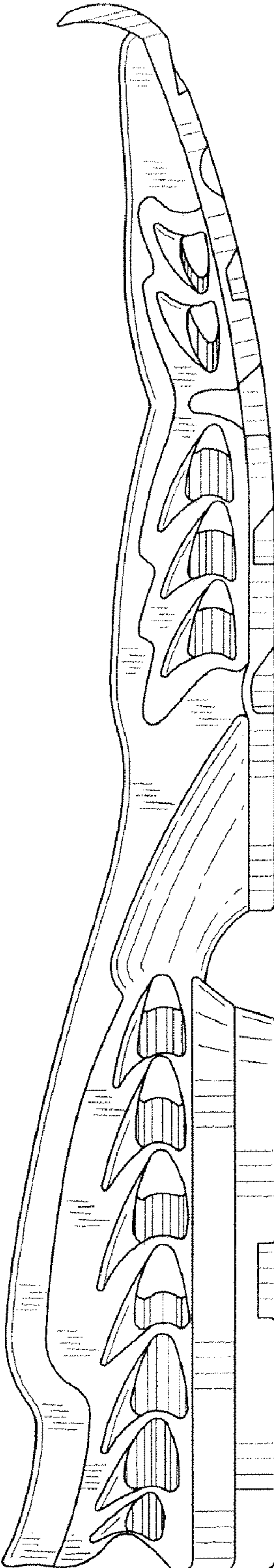

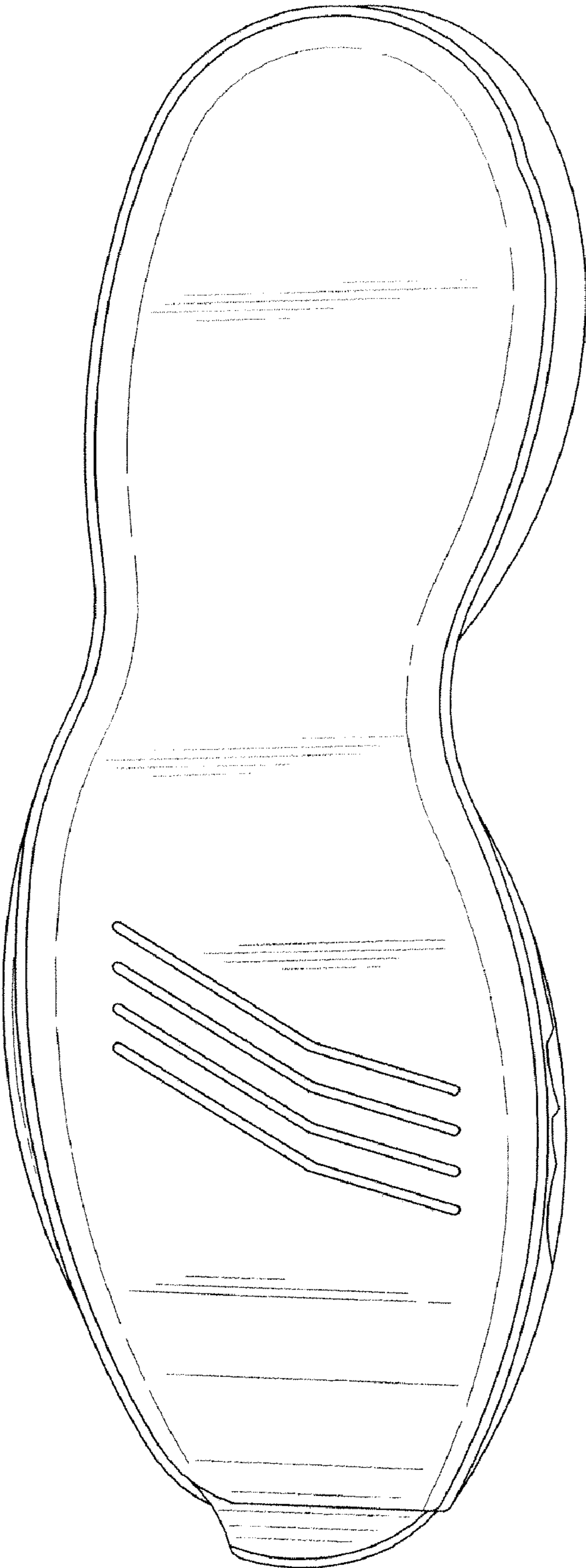

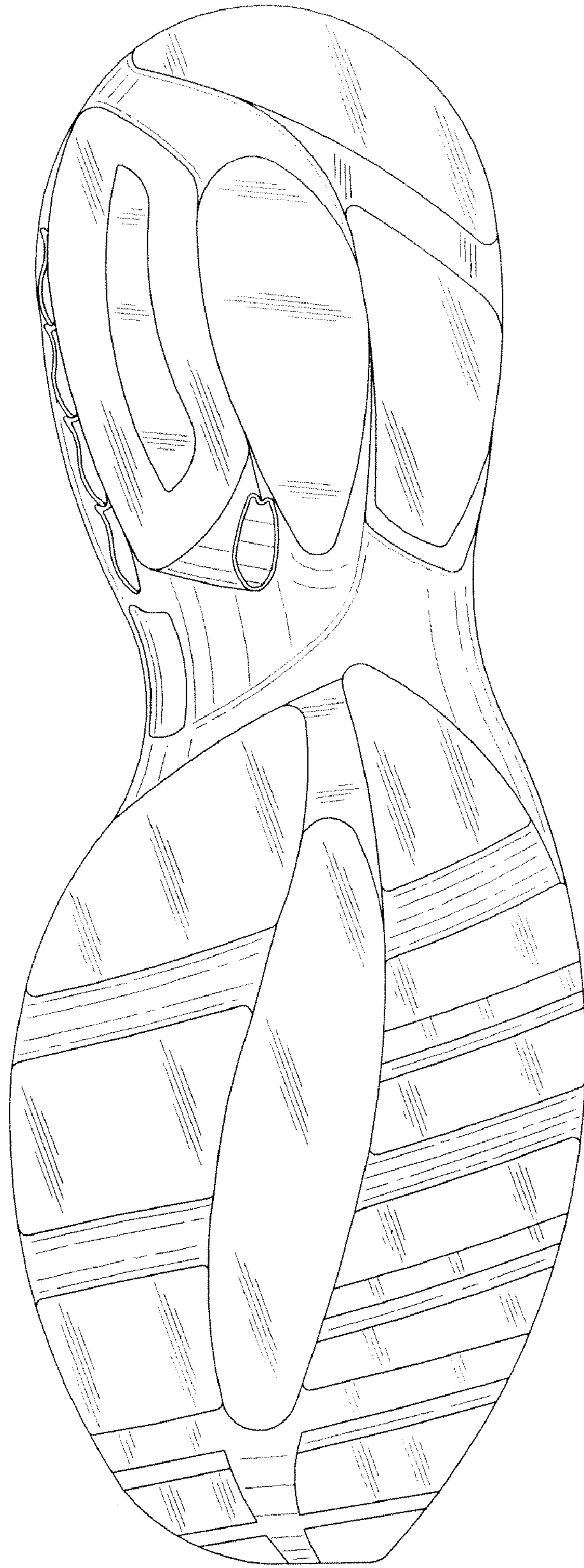

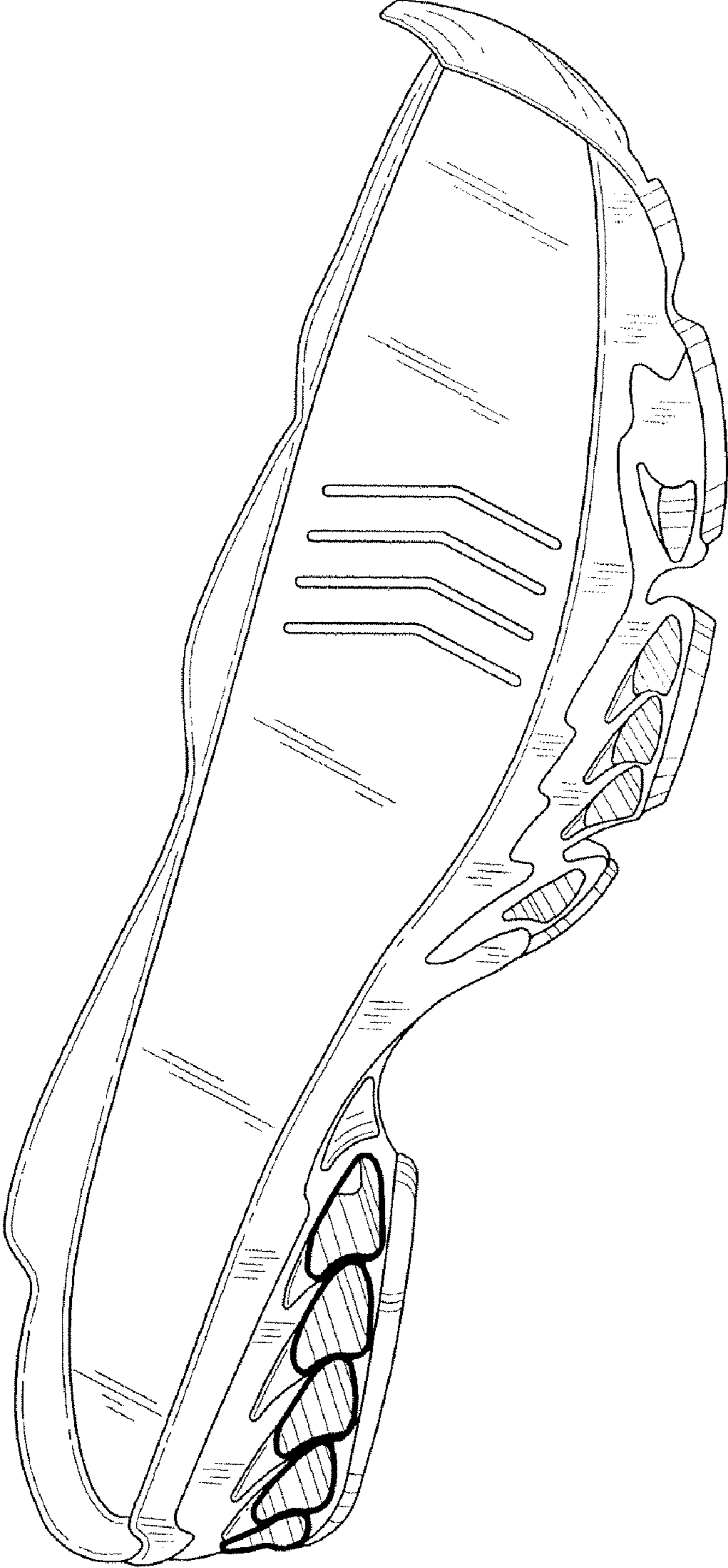

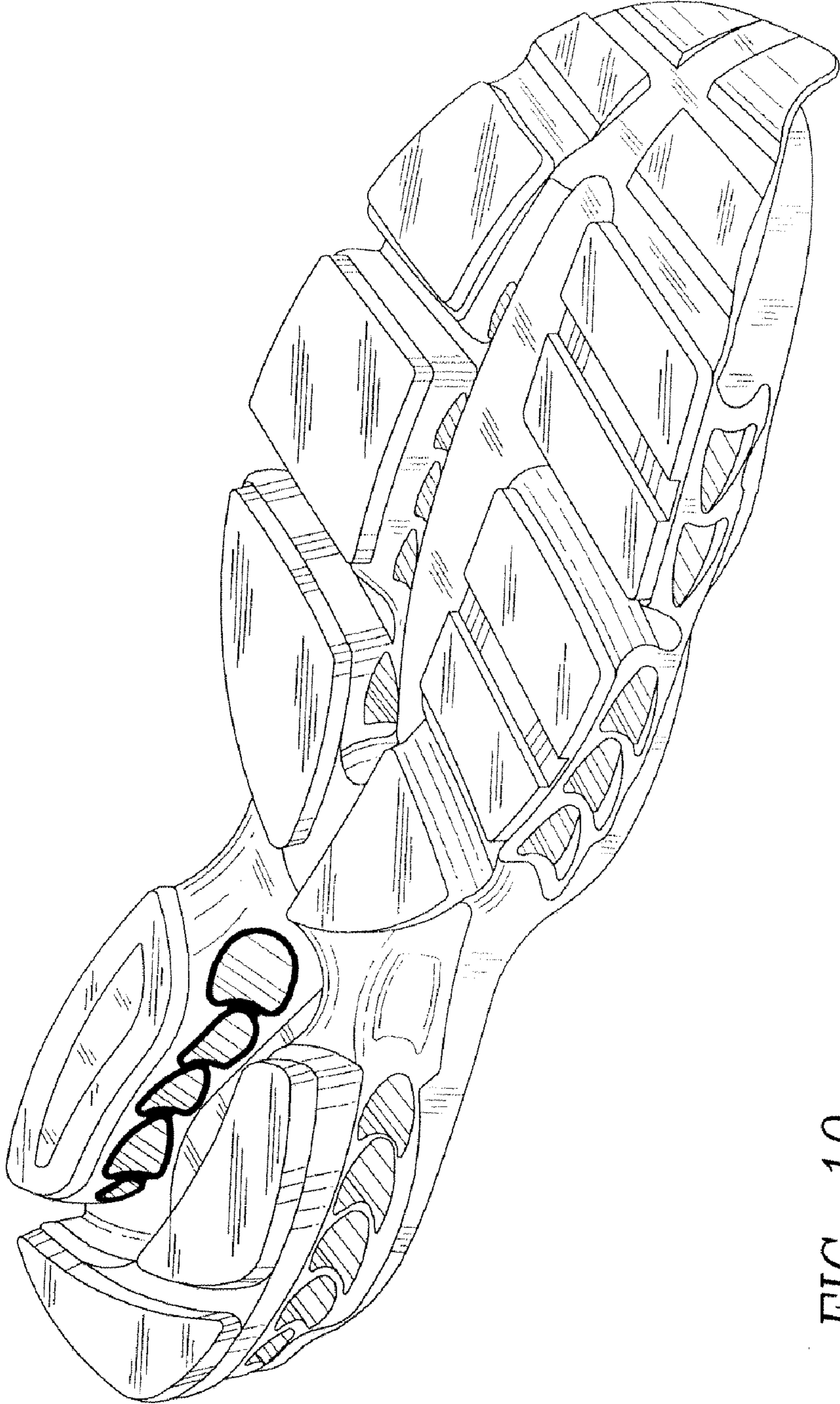
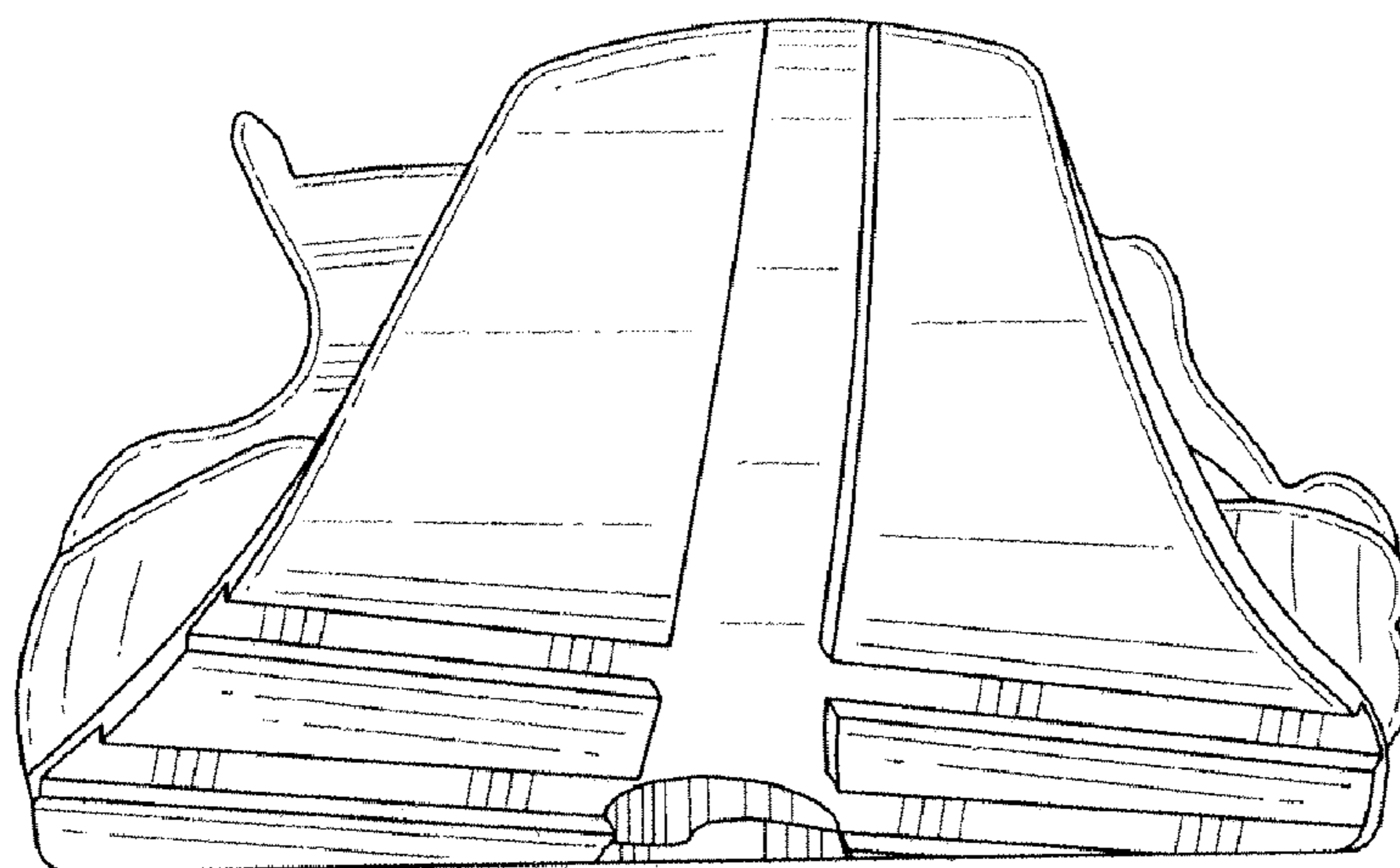
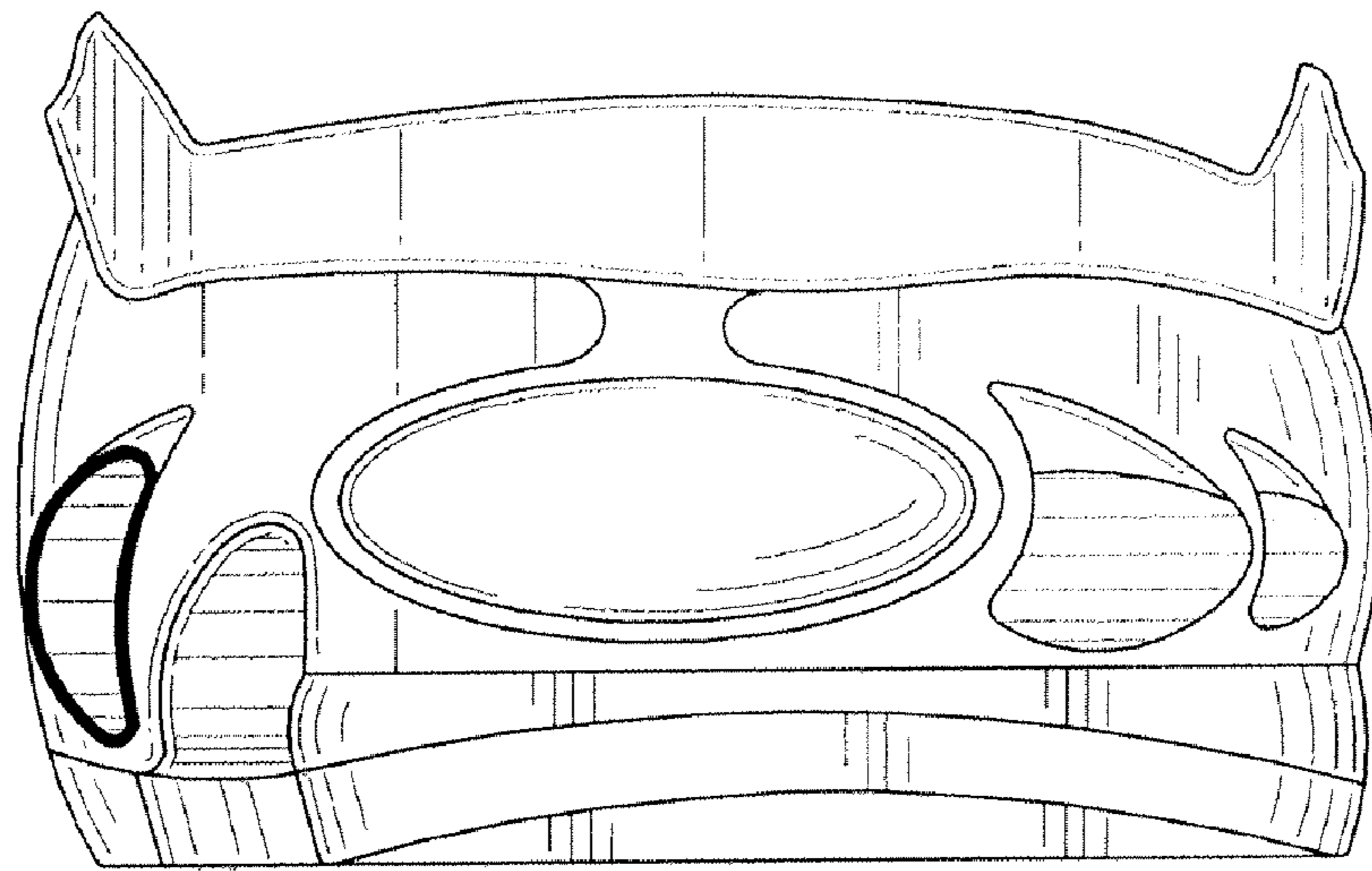

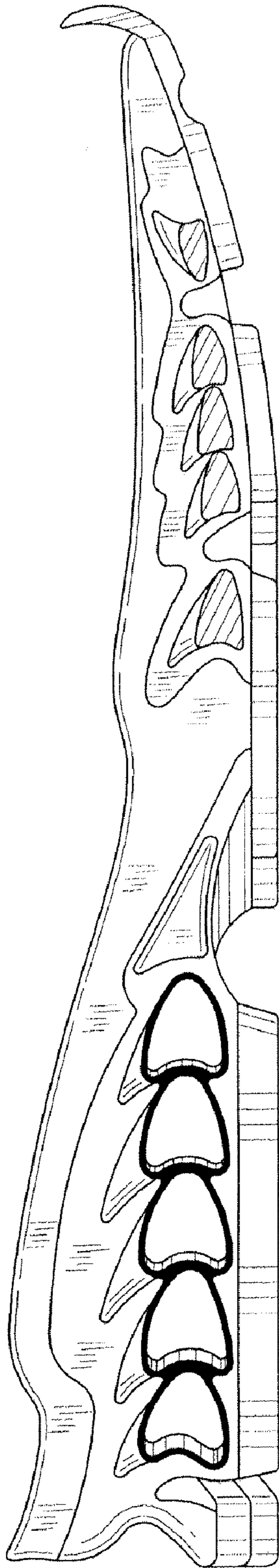

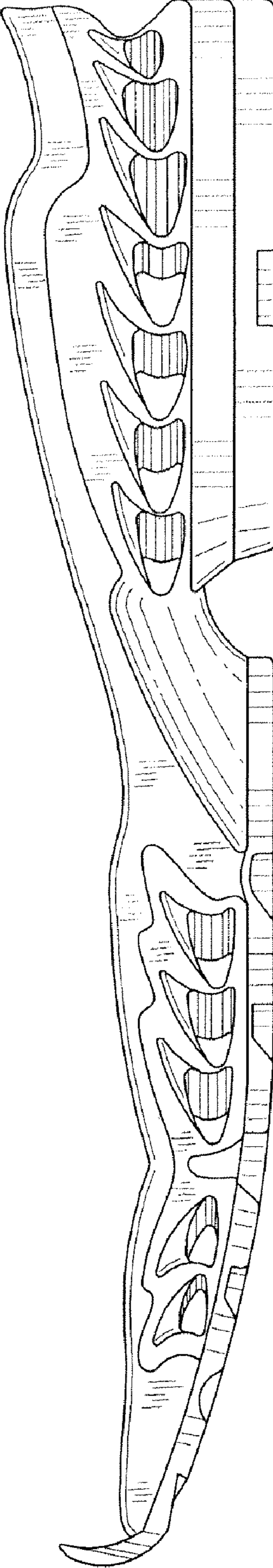

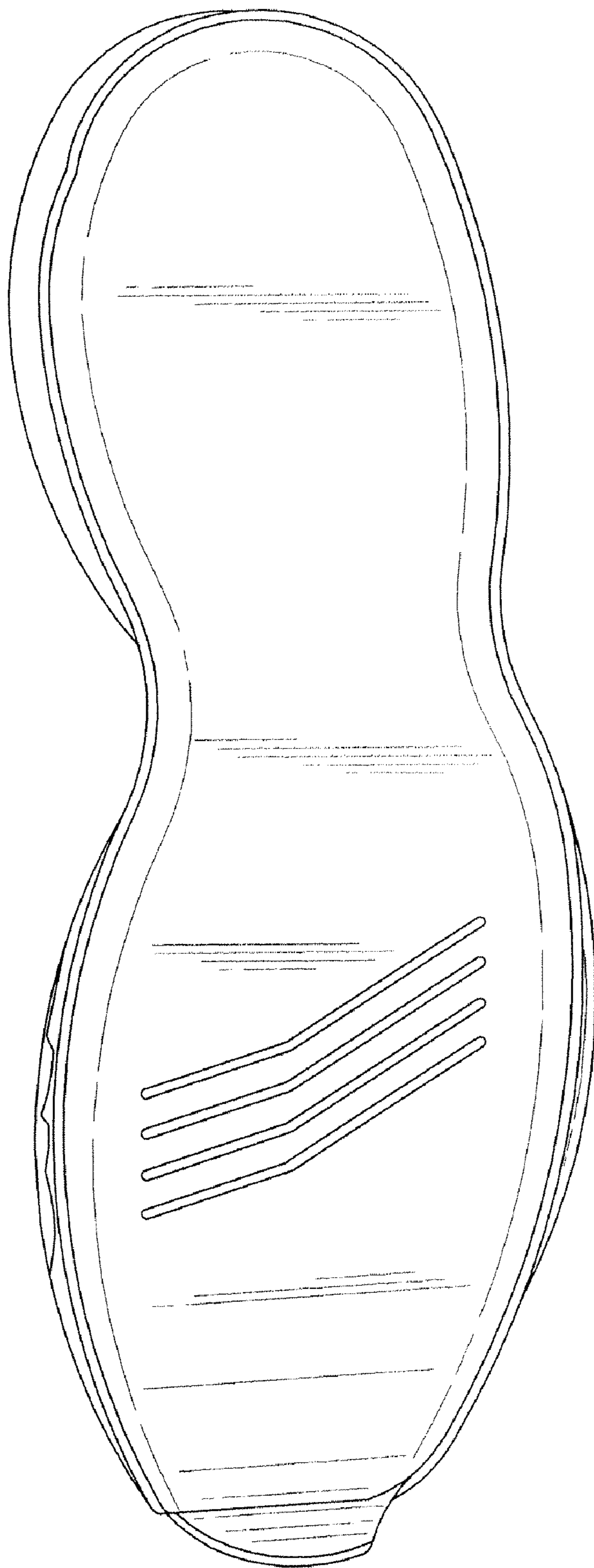

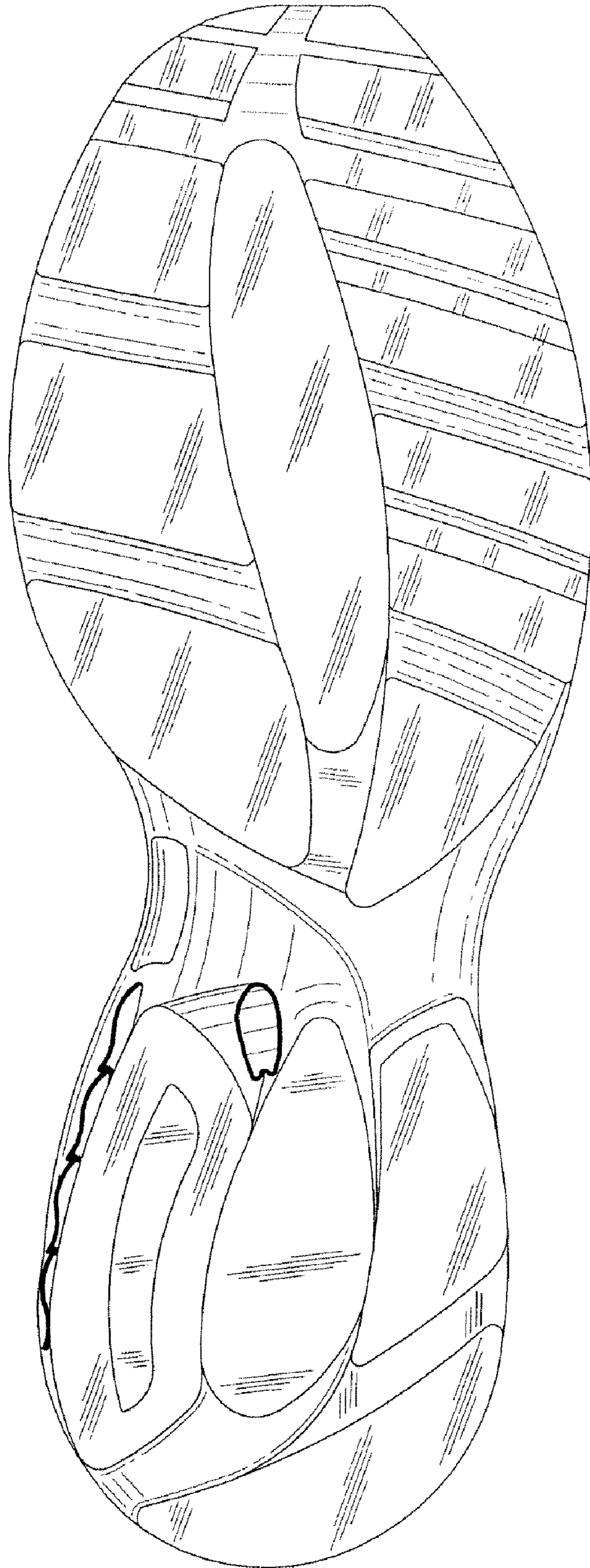
