The ornamental design for a license plate frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of the license plate frame of the present invention, showing our new design.

FIG. 2 is a perspective view of a portion of the license plate frame of the present invention, shown at a magnified scale from that used in FIG. 1.

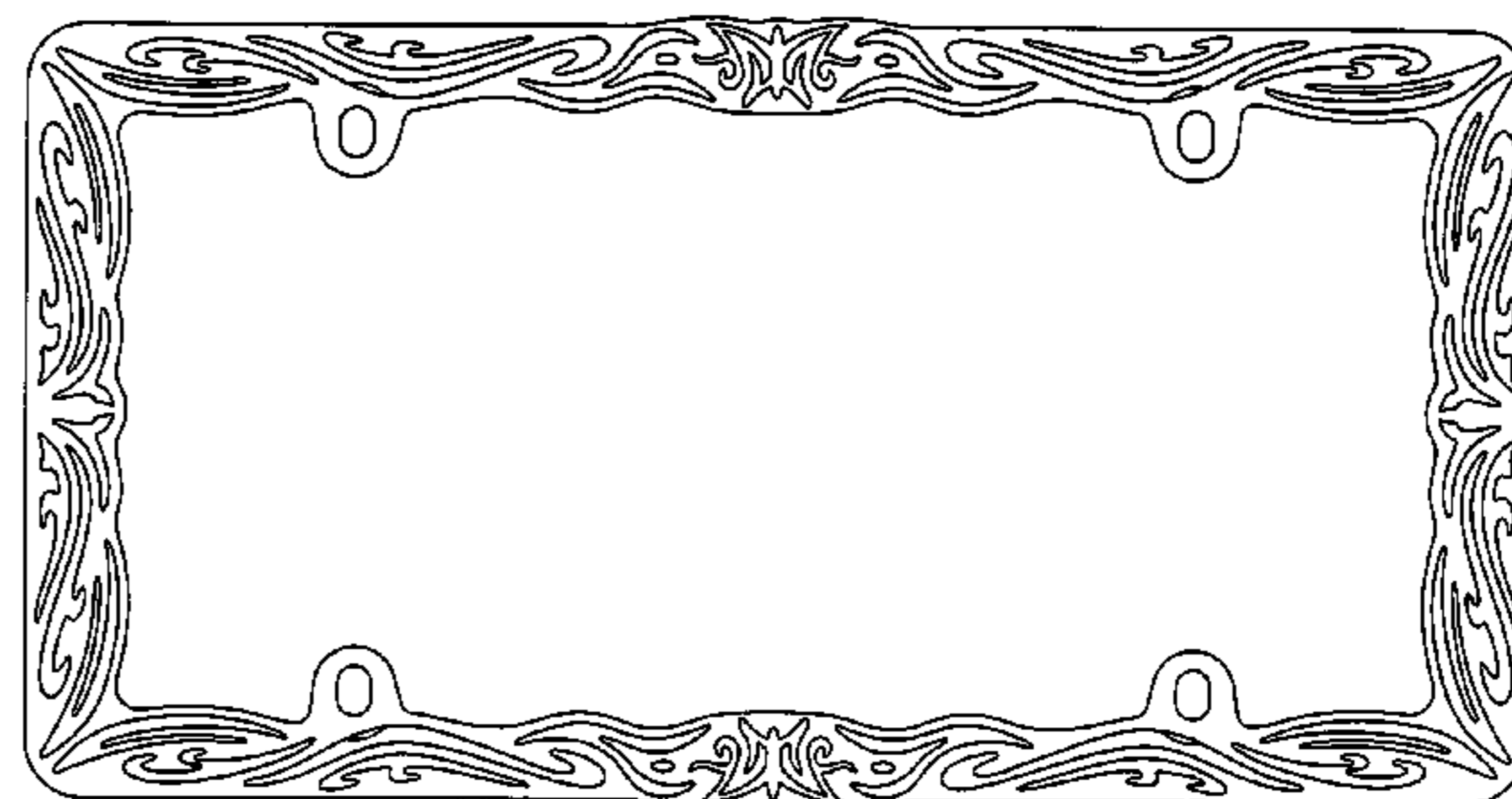
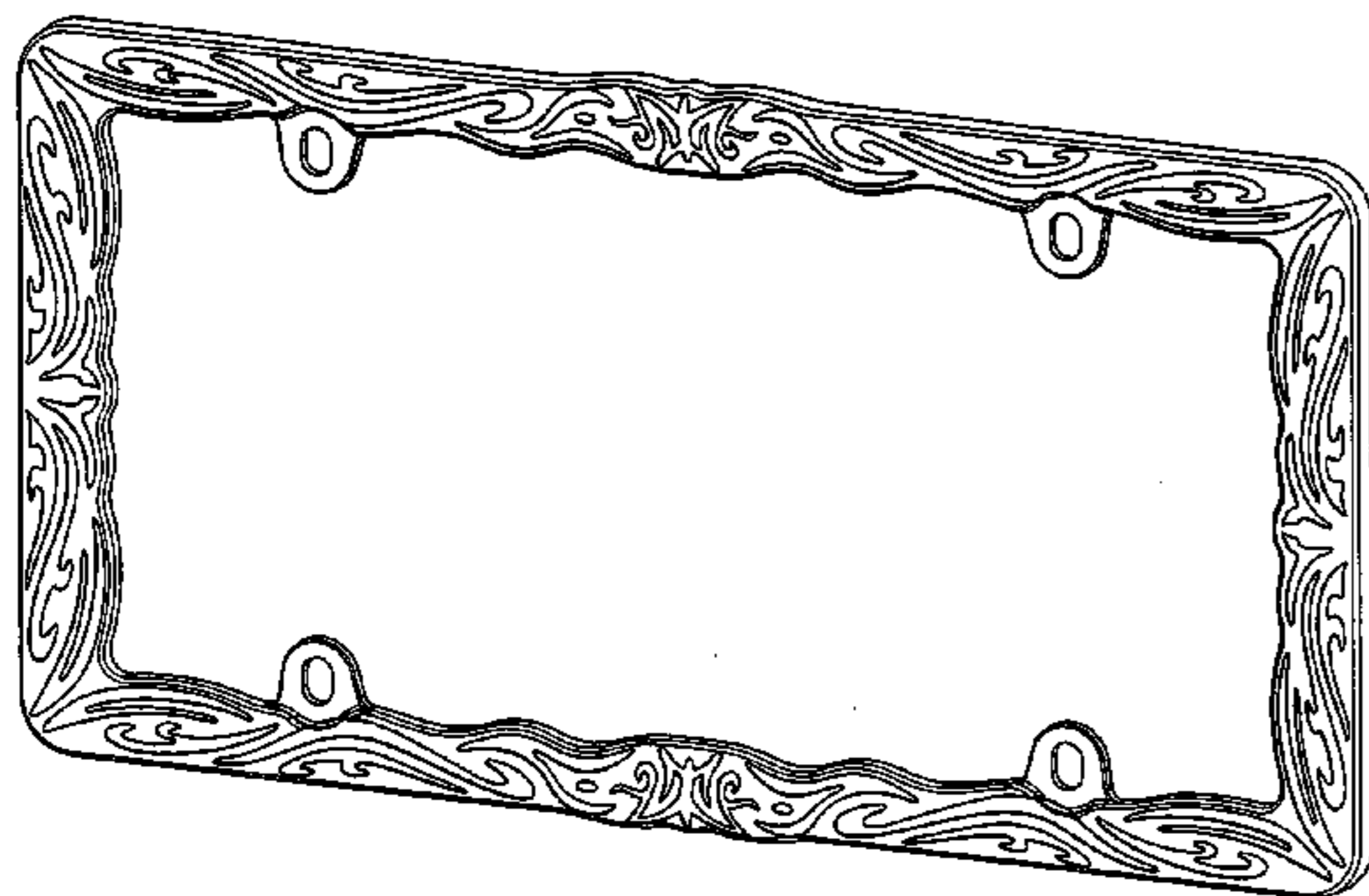
FIG. 3 is a front view of the license plate frame of the present invention

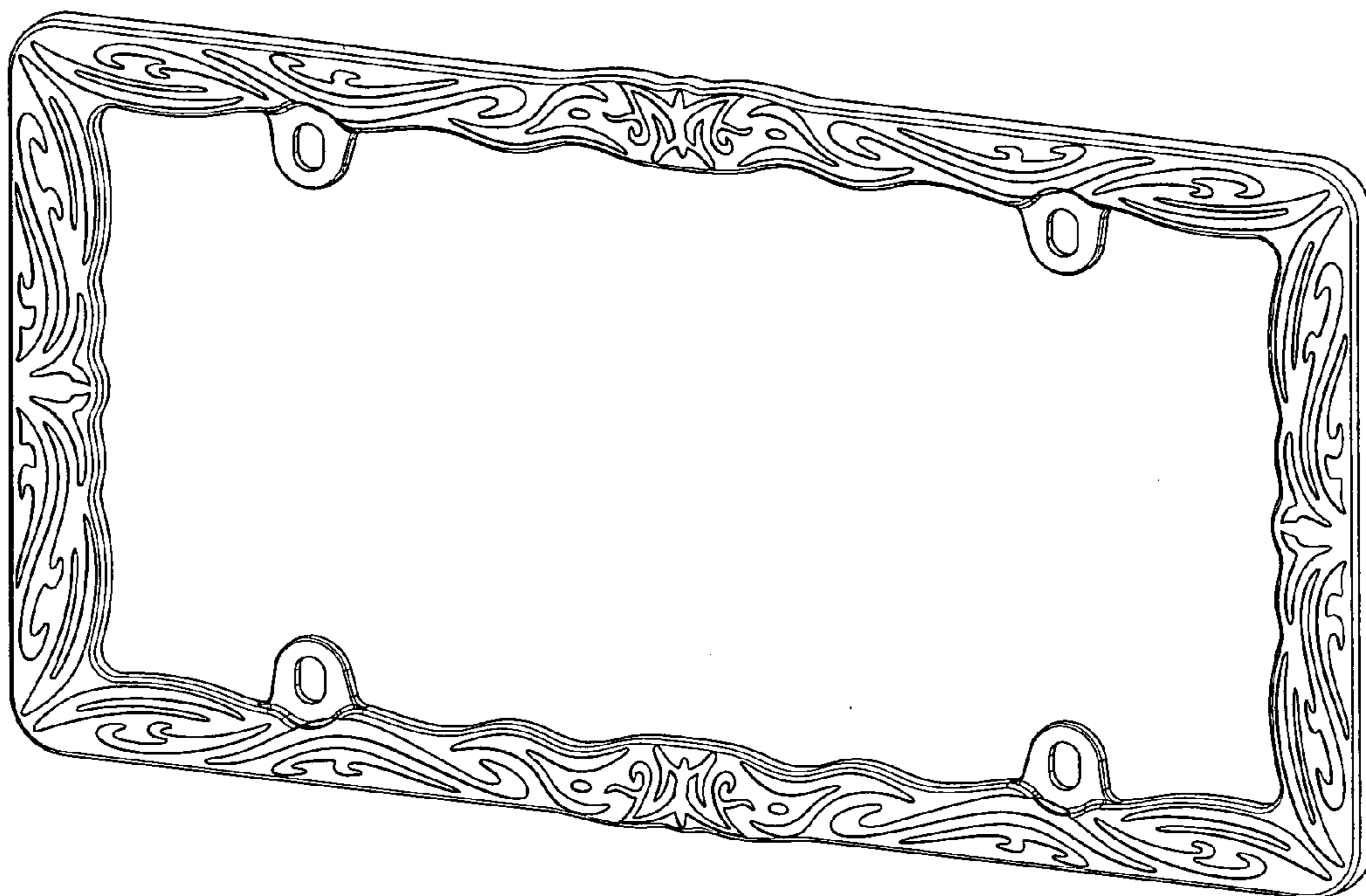

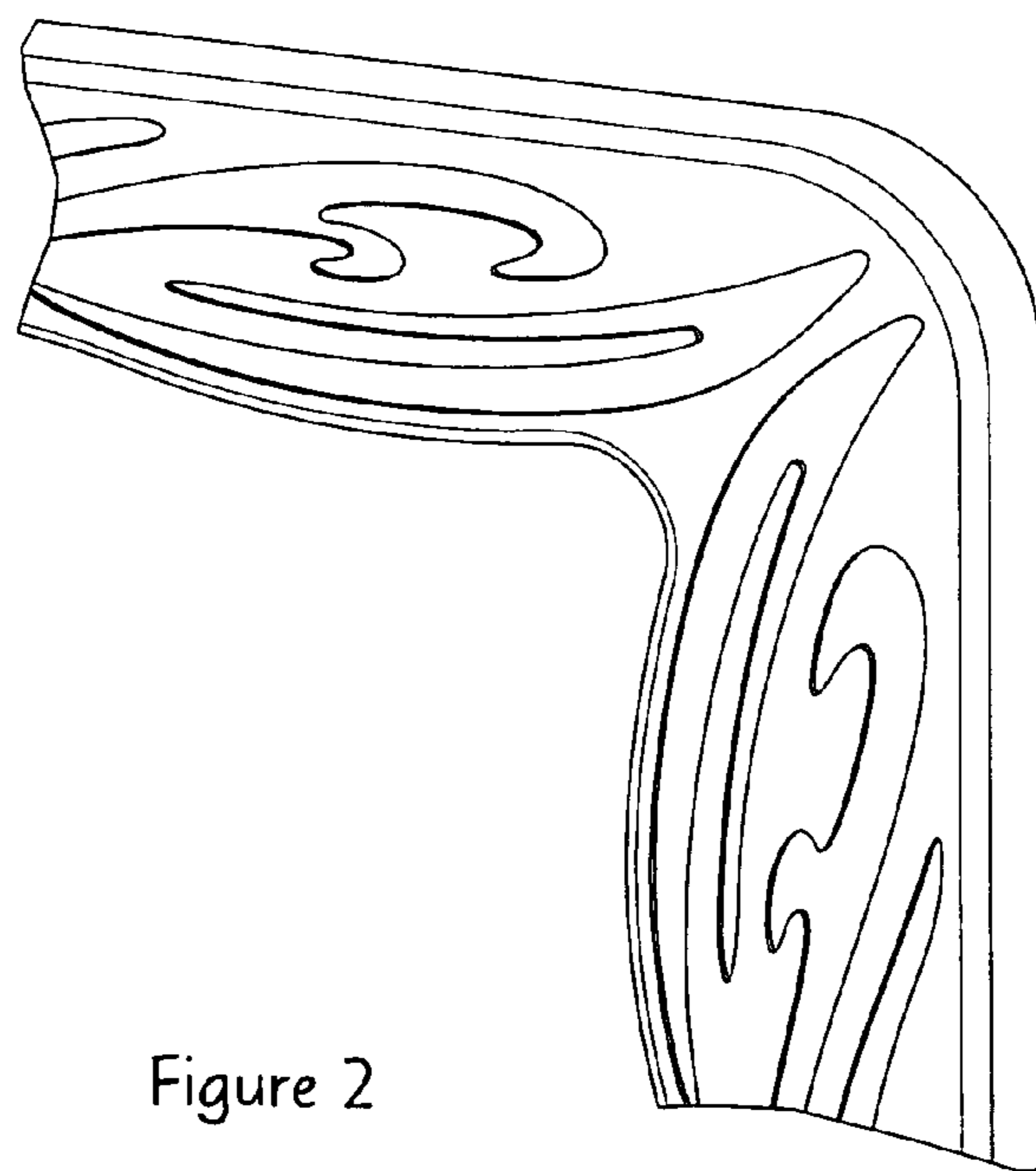

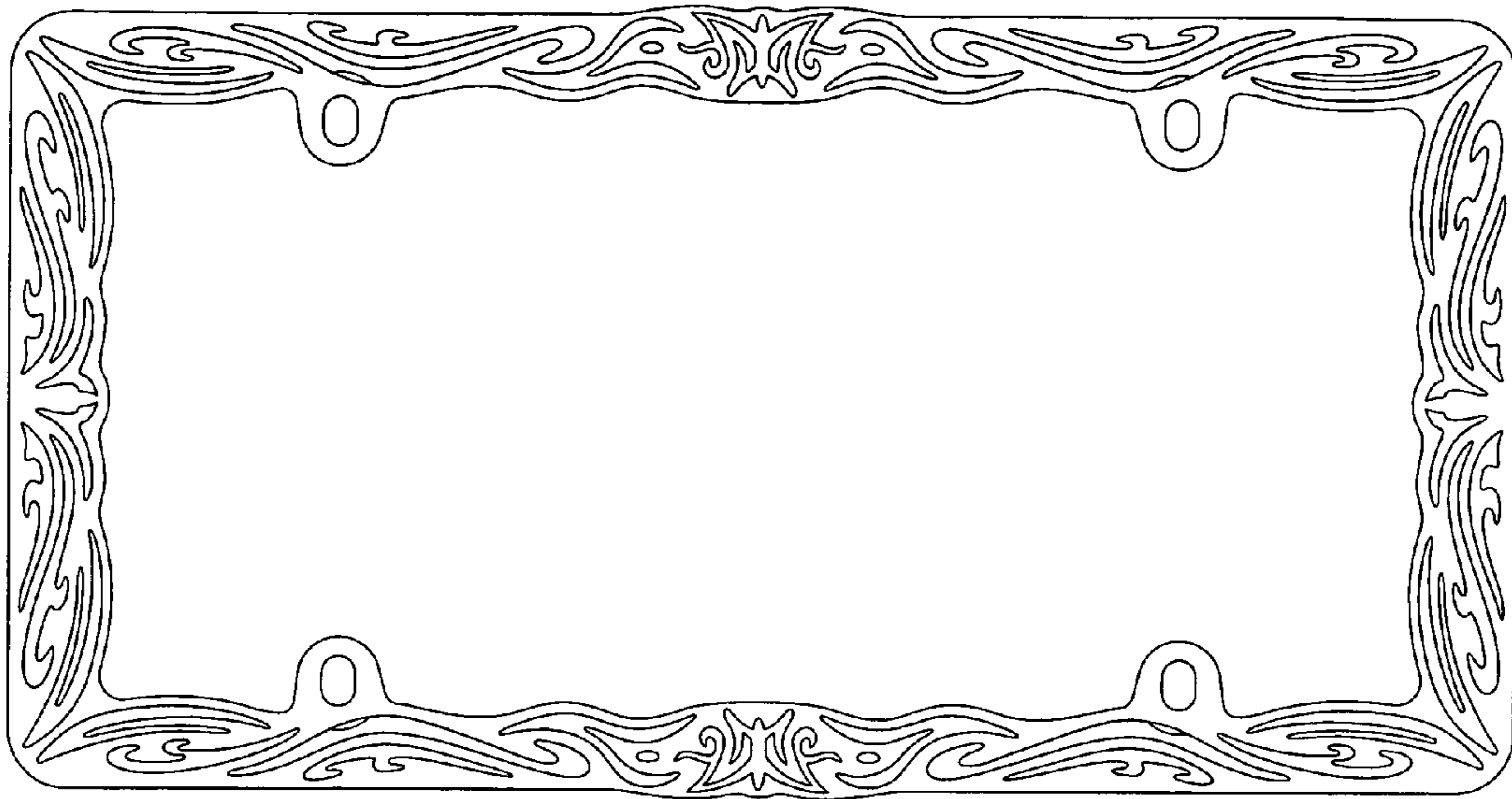

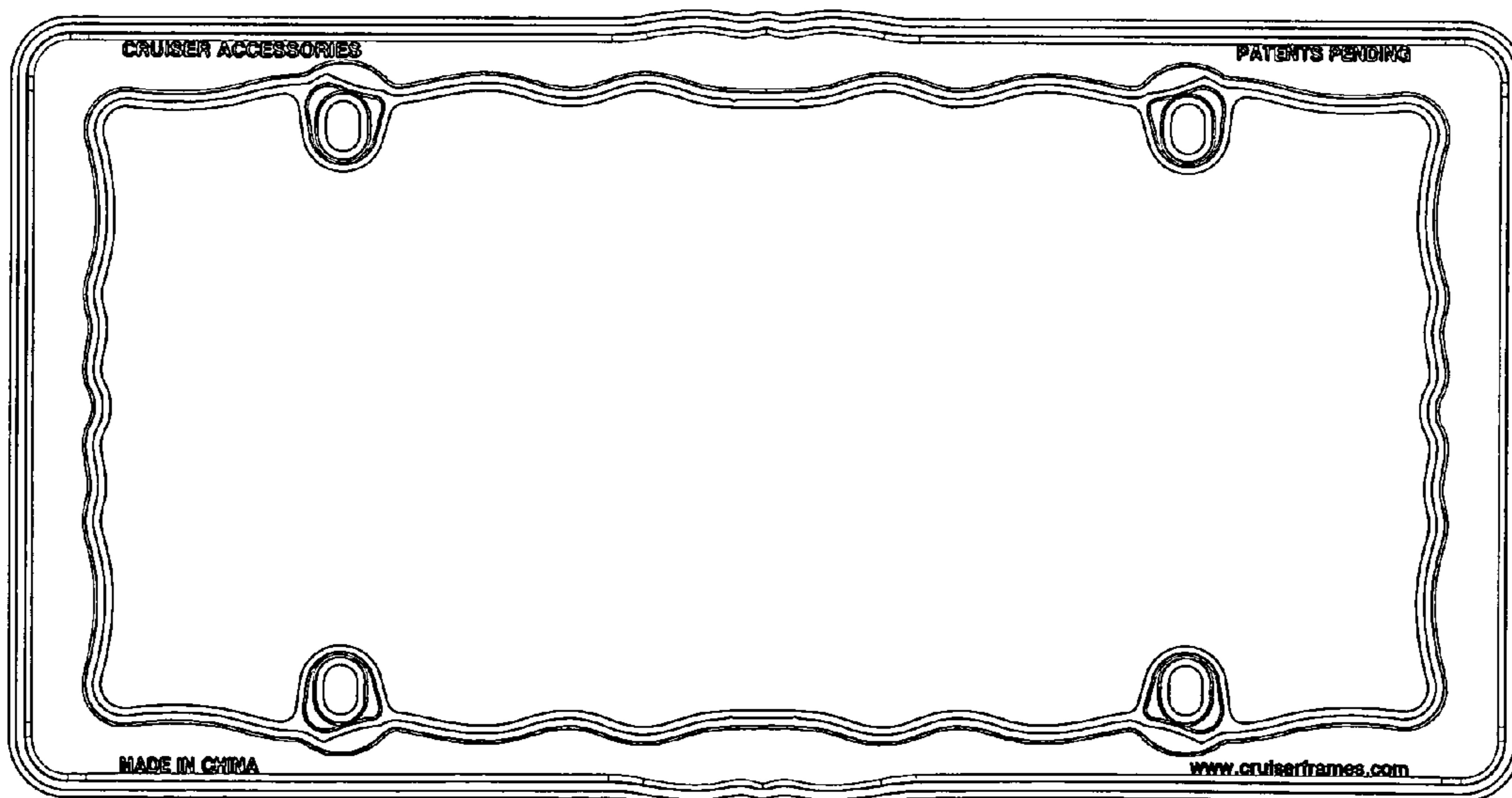
