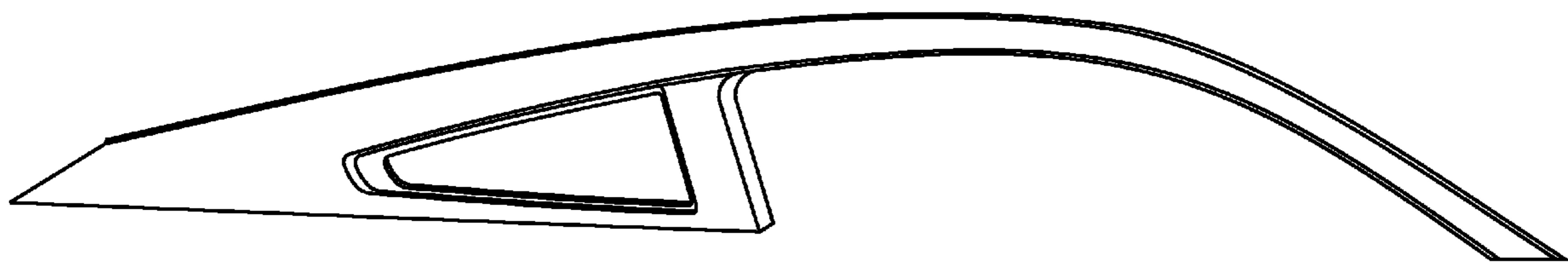
FIG. 1 is a front perspective view of a right vehicle pillar unit with opening showing my new design, the left being a mirror image thereof;

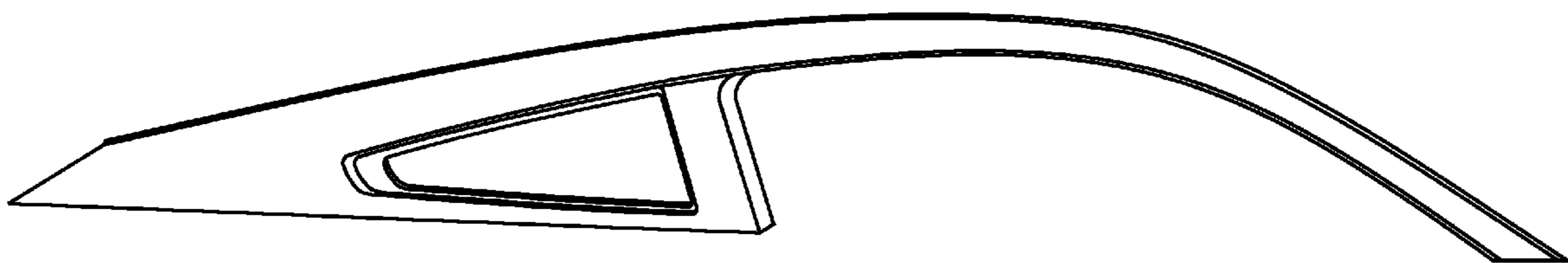

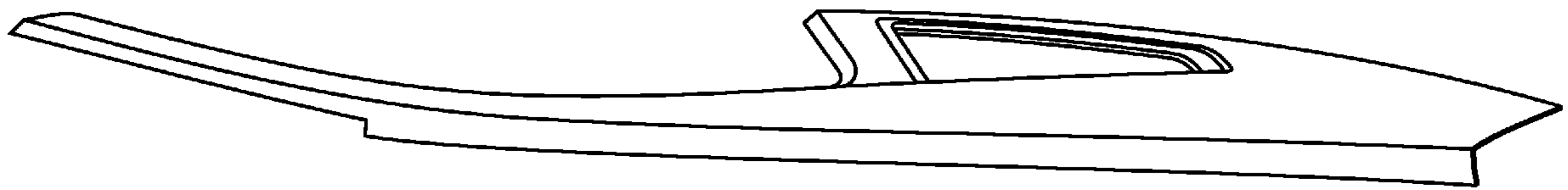

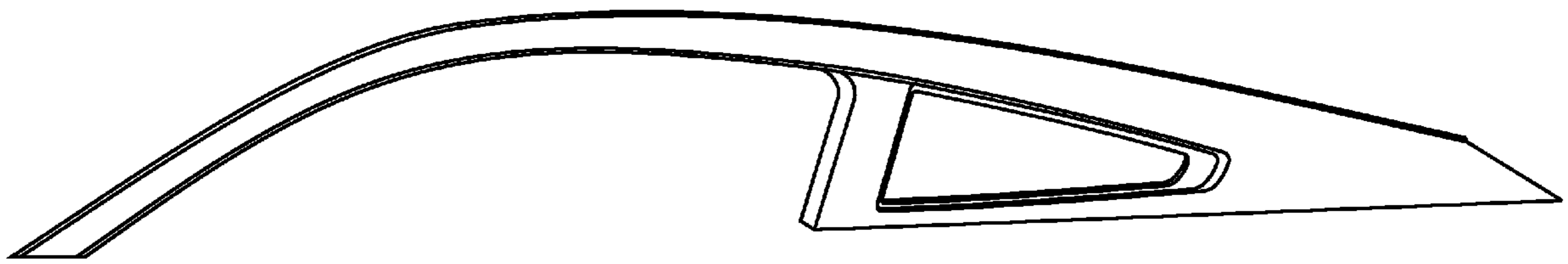

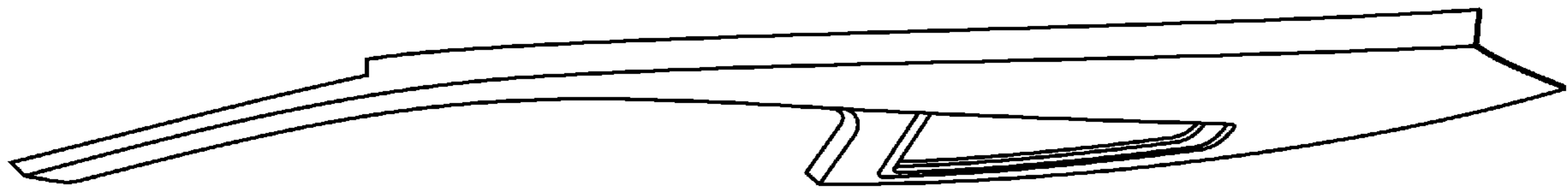
