(57) **CLAIM**

I claim the ornamental design for an OLED television receiver, as shown and described.

DESCRIPTION

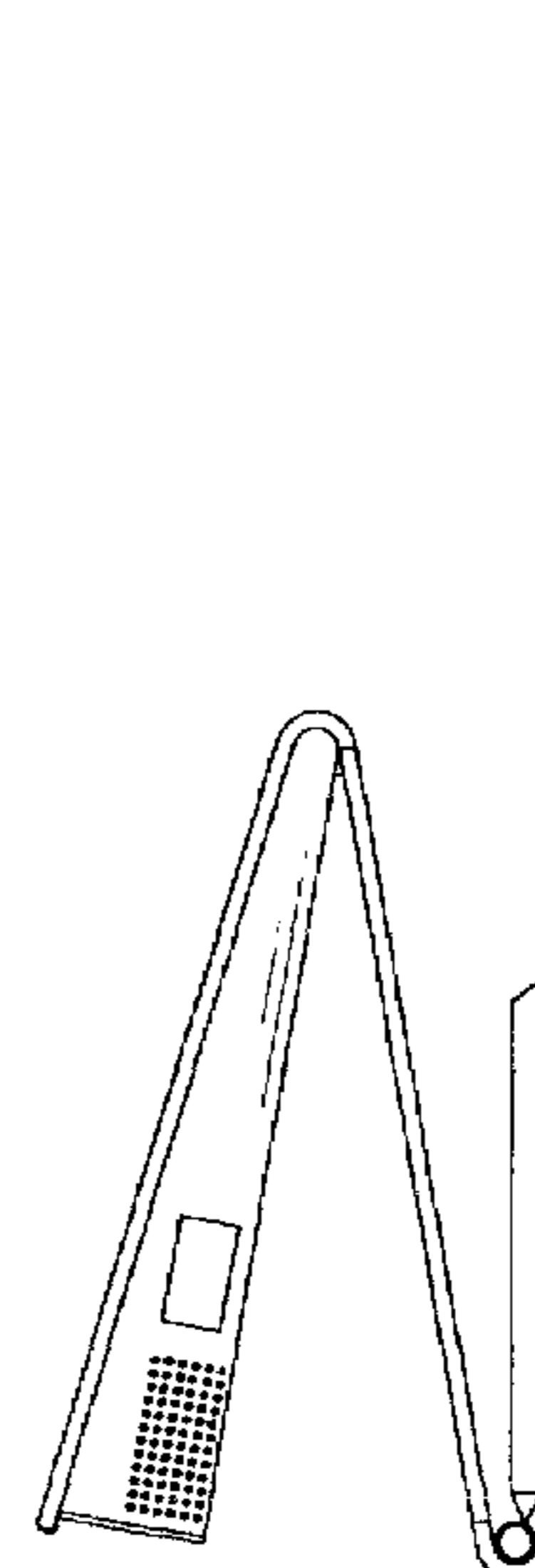
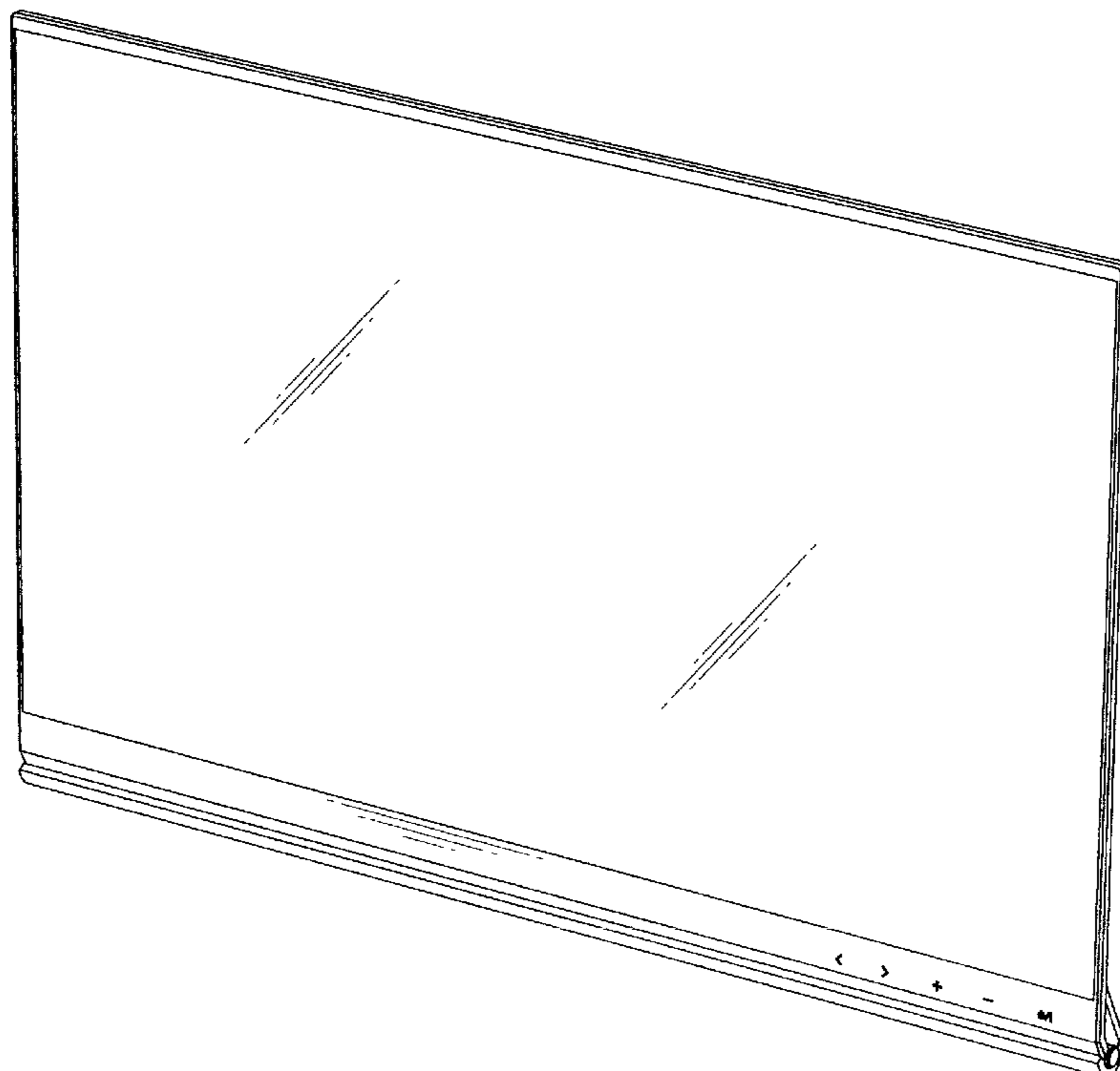

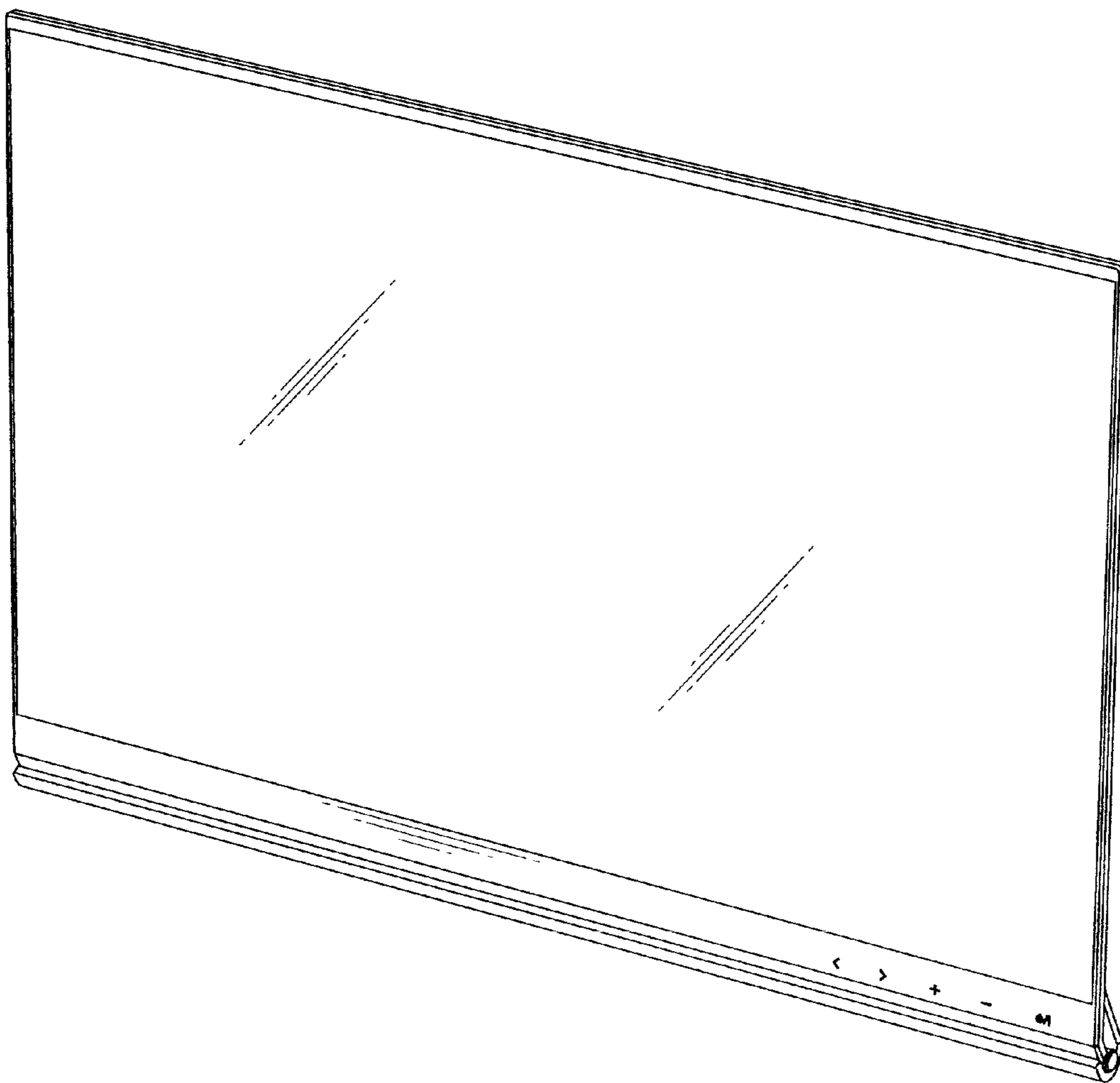

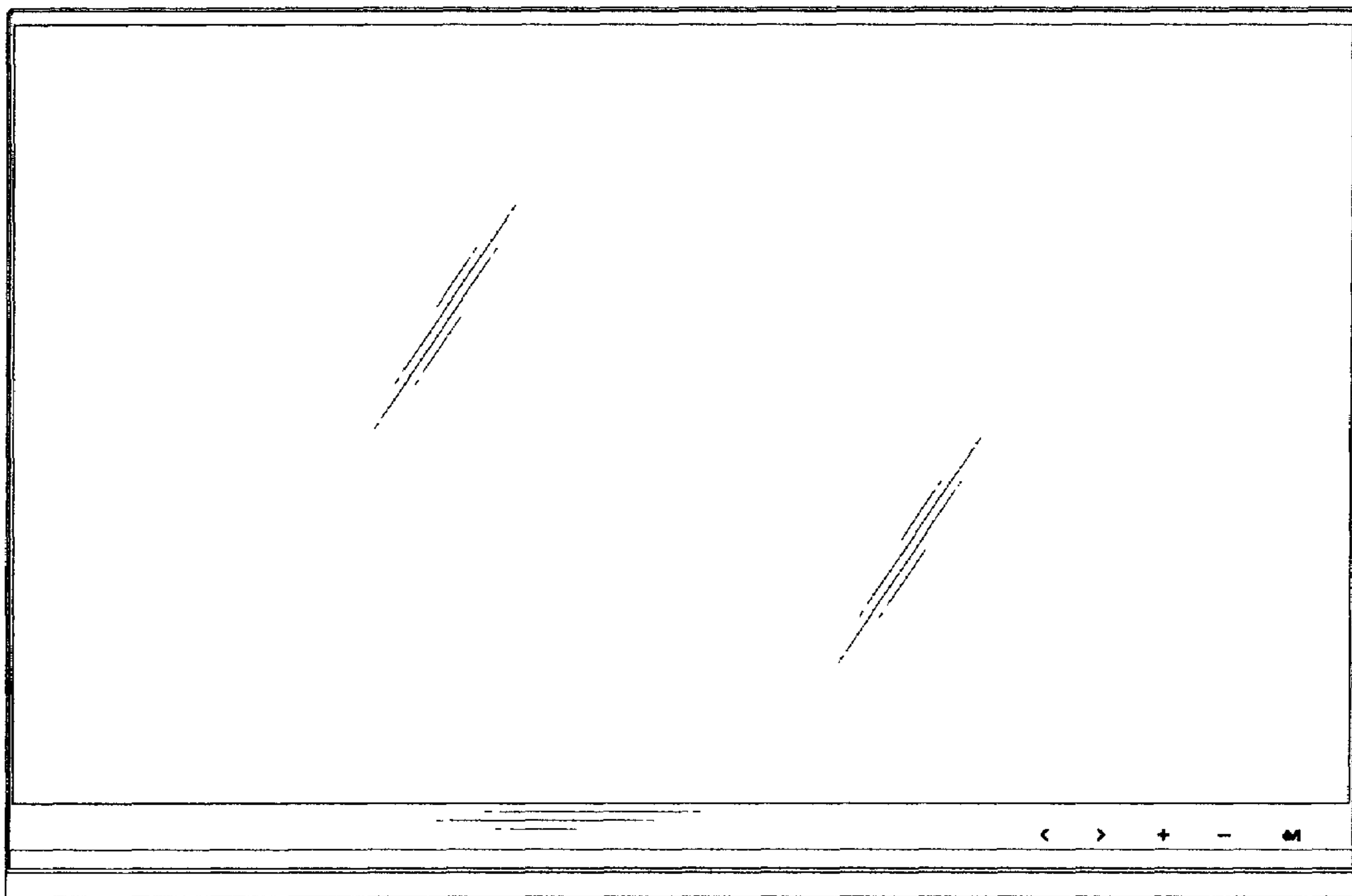

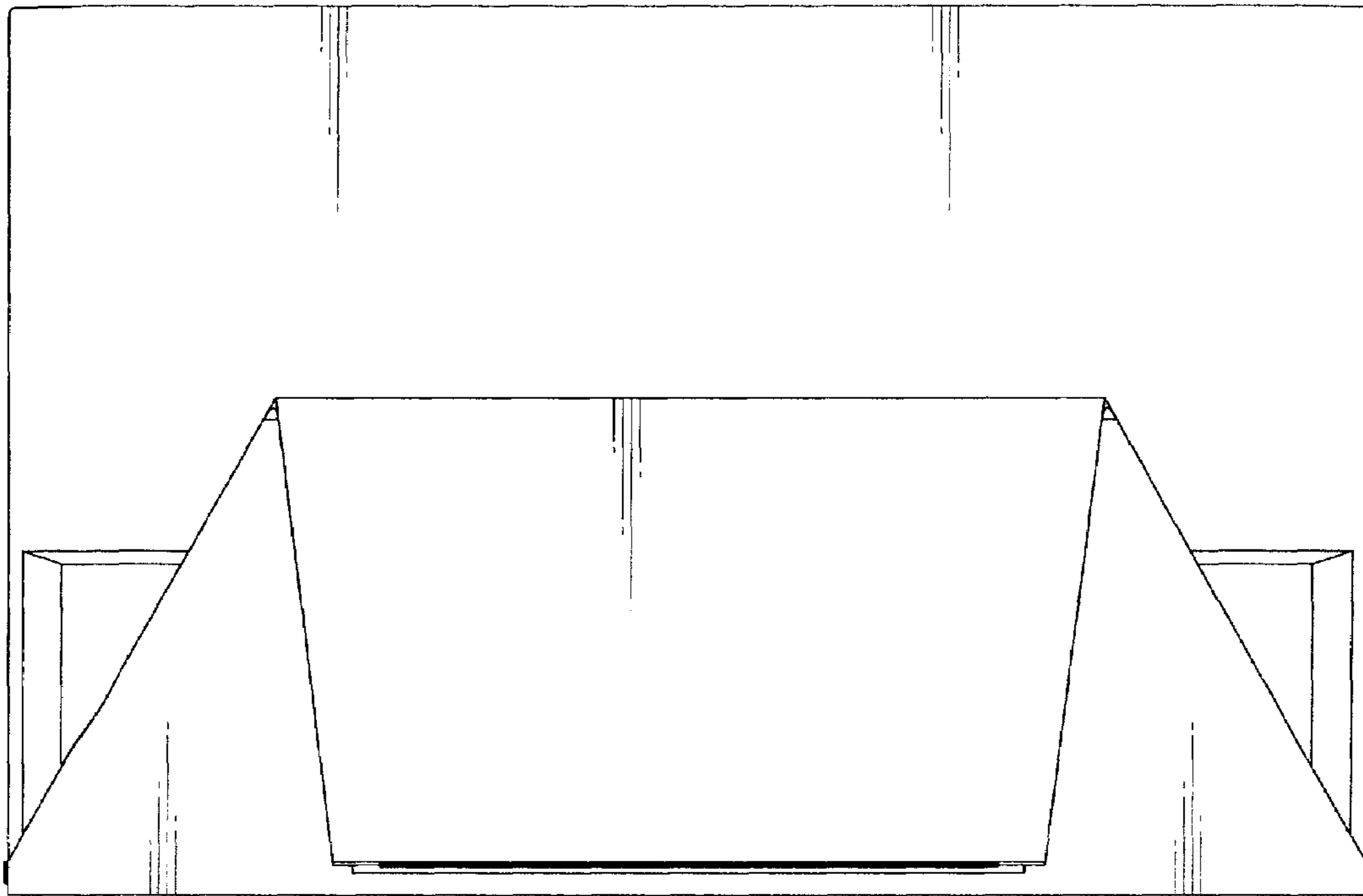

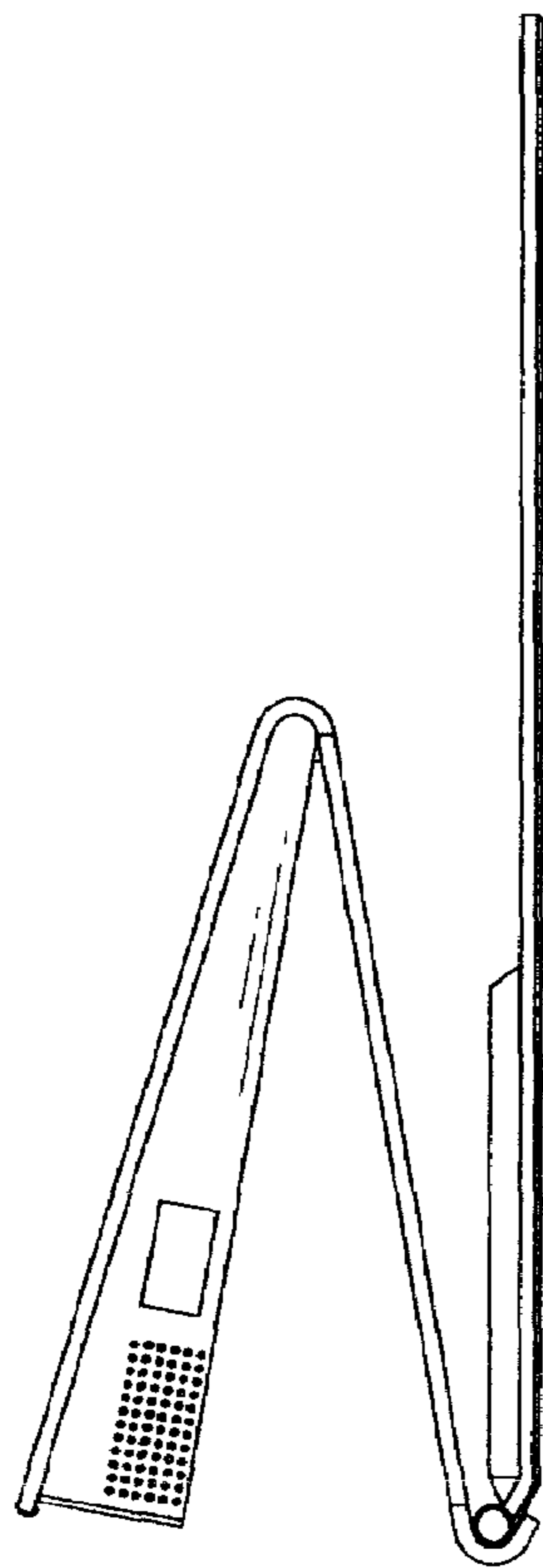

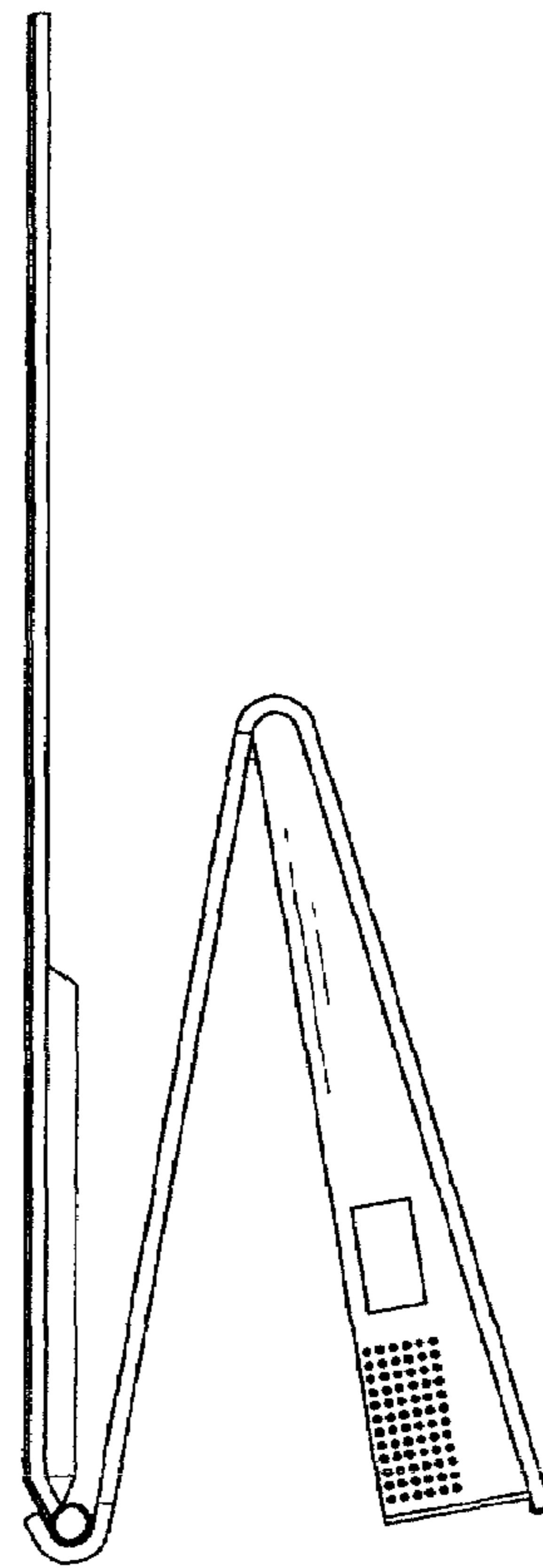

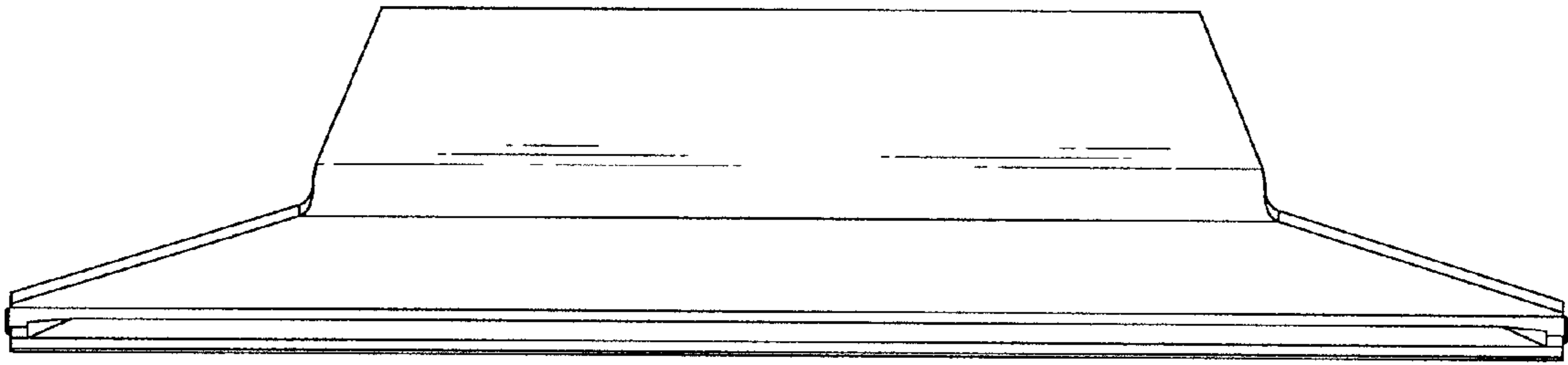
