FIG. 1 is a front perspective view of a jukebox showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;

FIG. 6 is a right side elevational view thereof, the left side elevational view being a mirror image thereof; and,
FIG. 7 is a rear perspective view thereof.

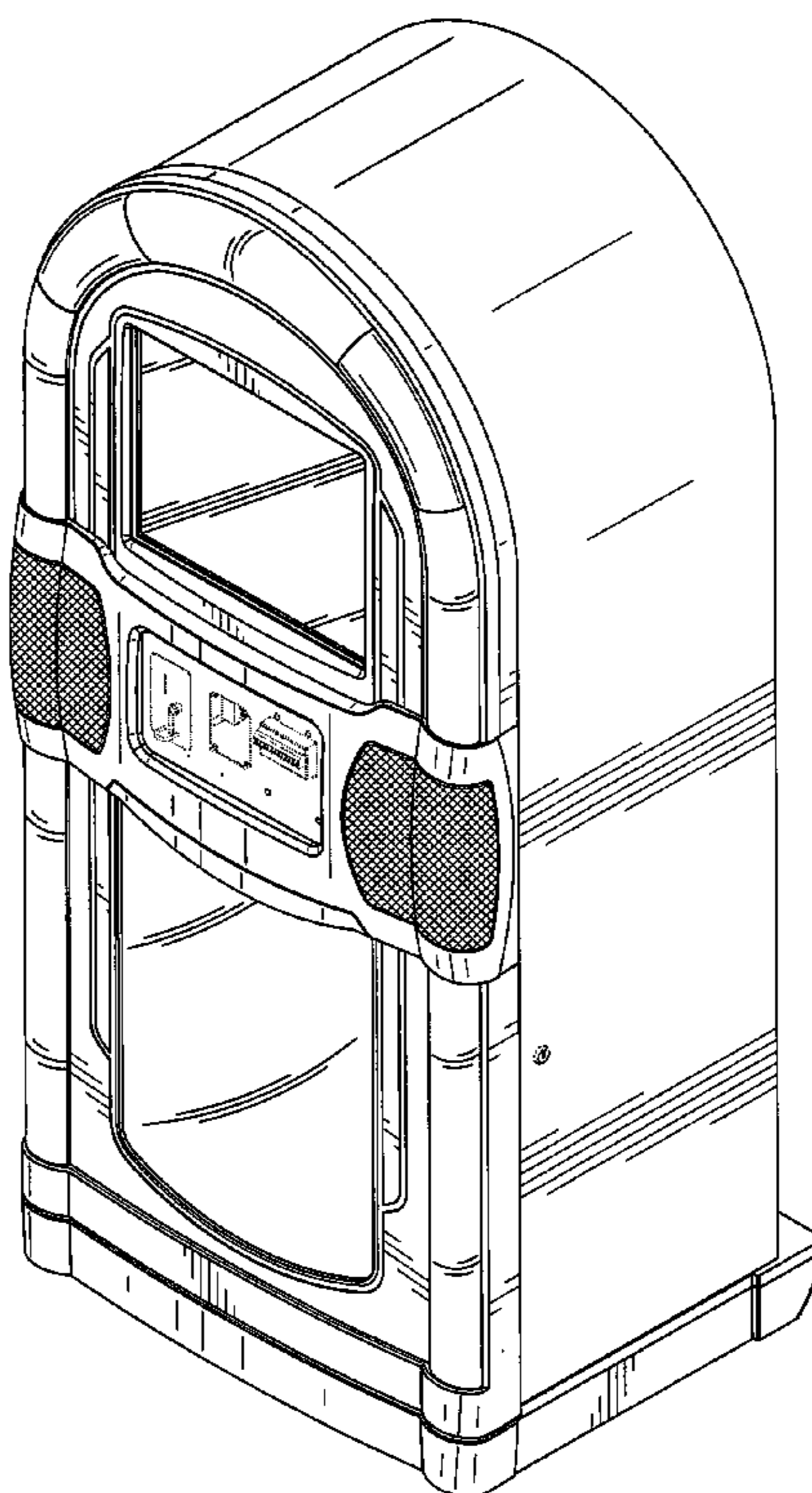

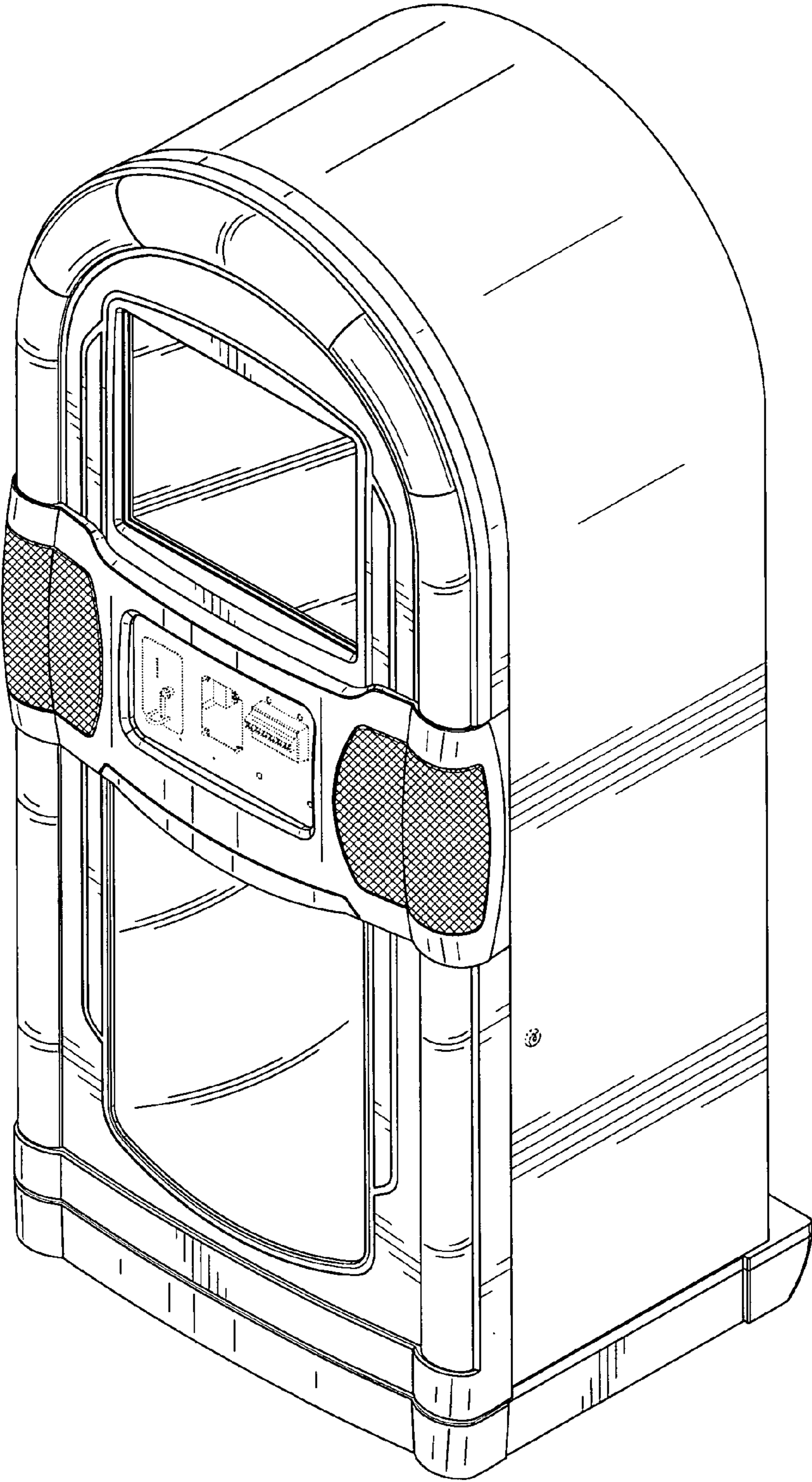

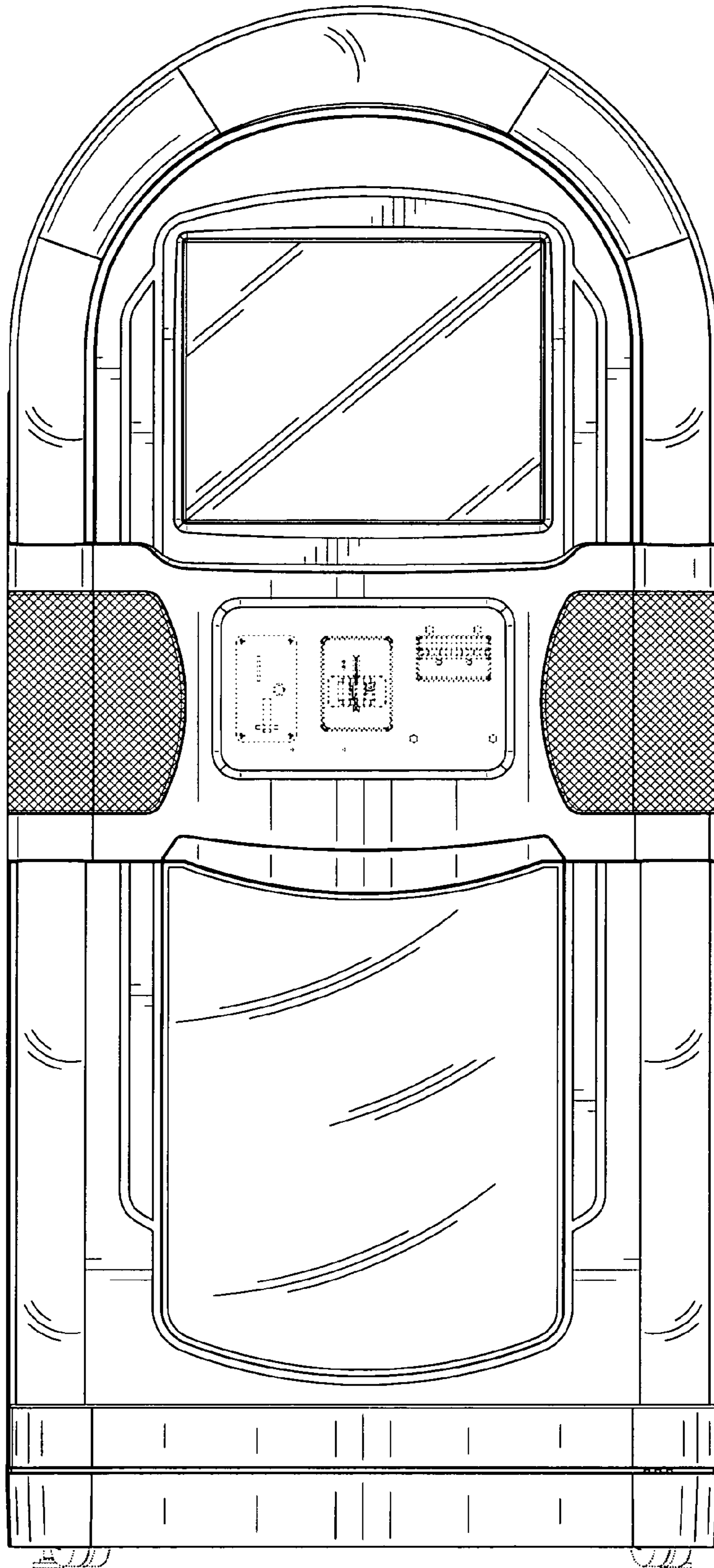

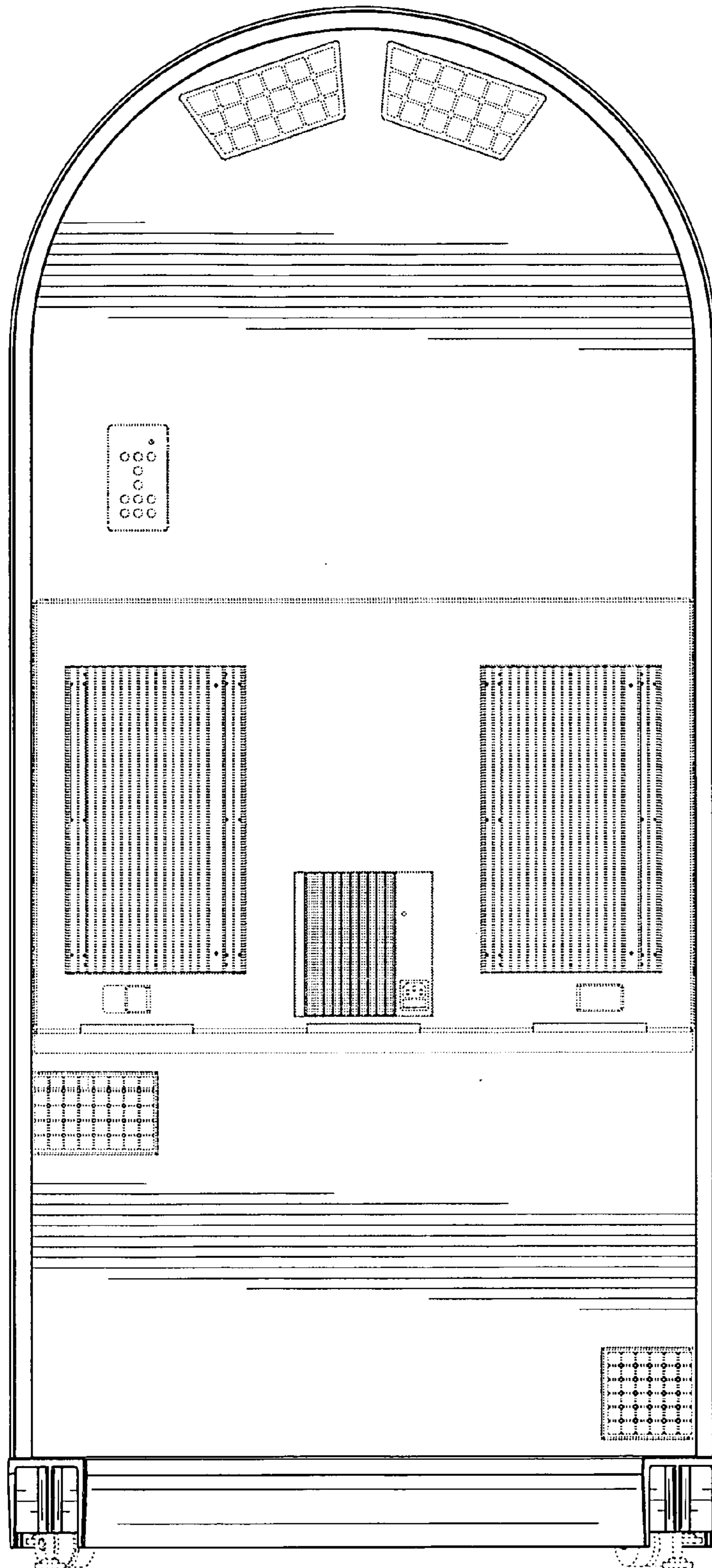

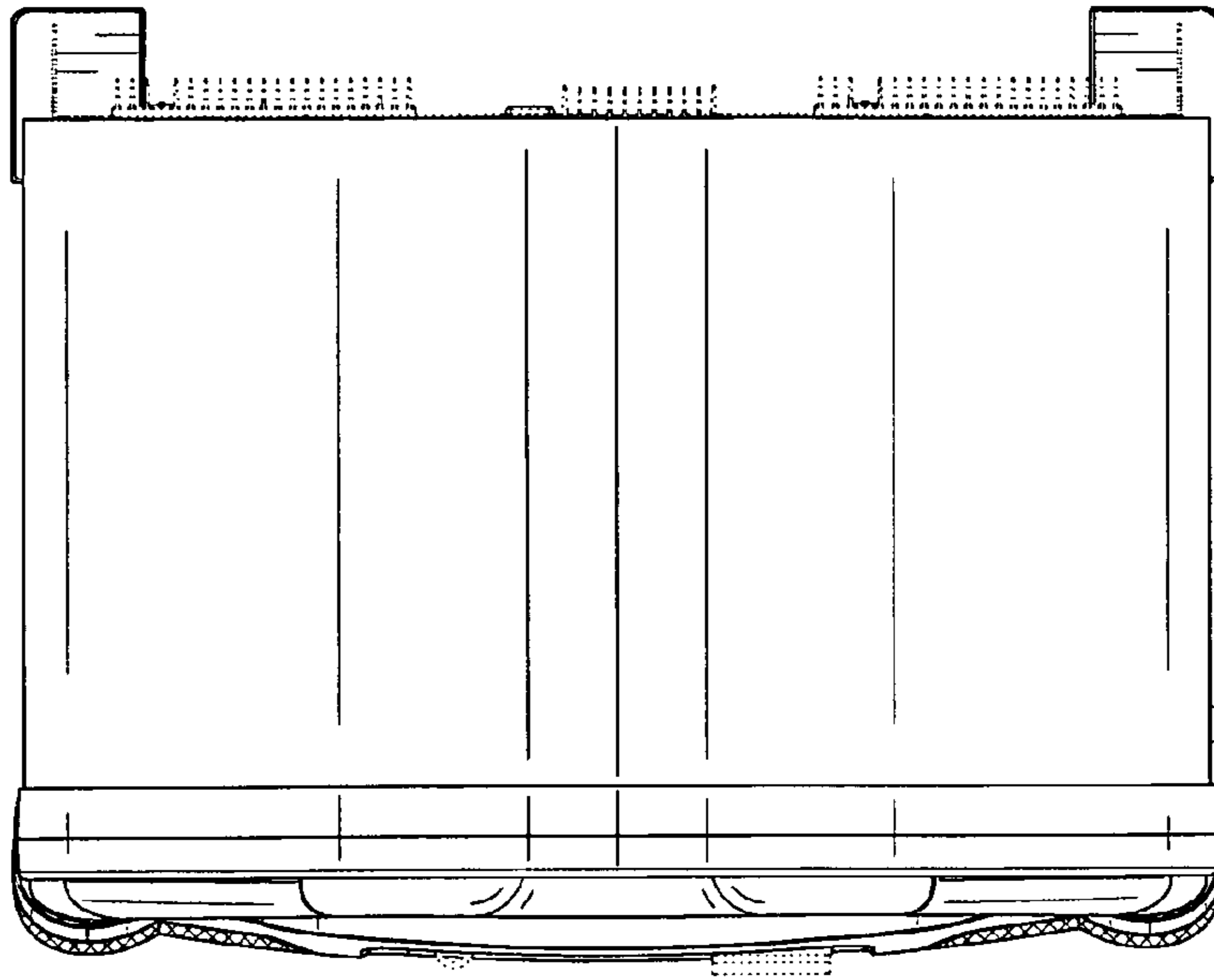

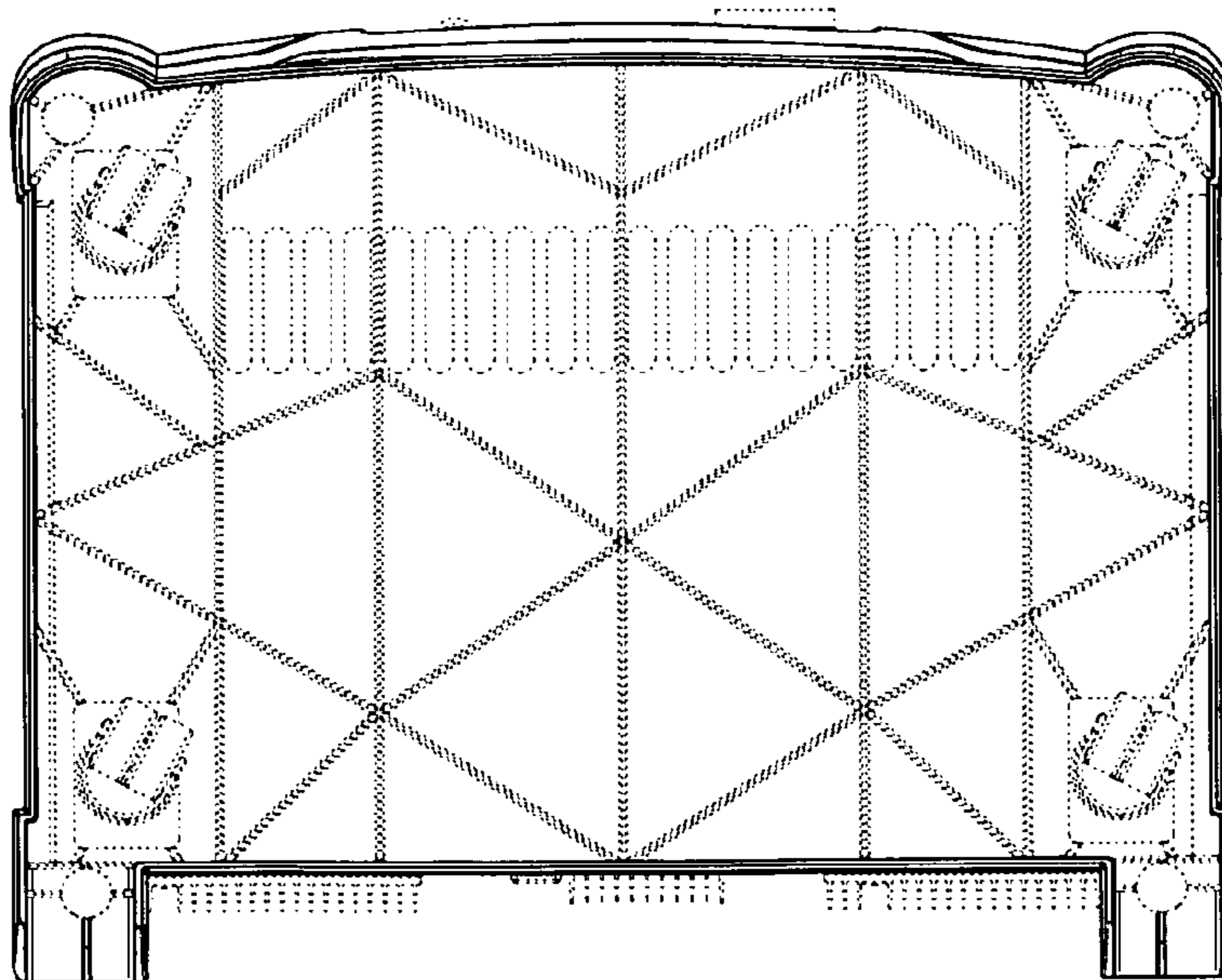

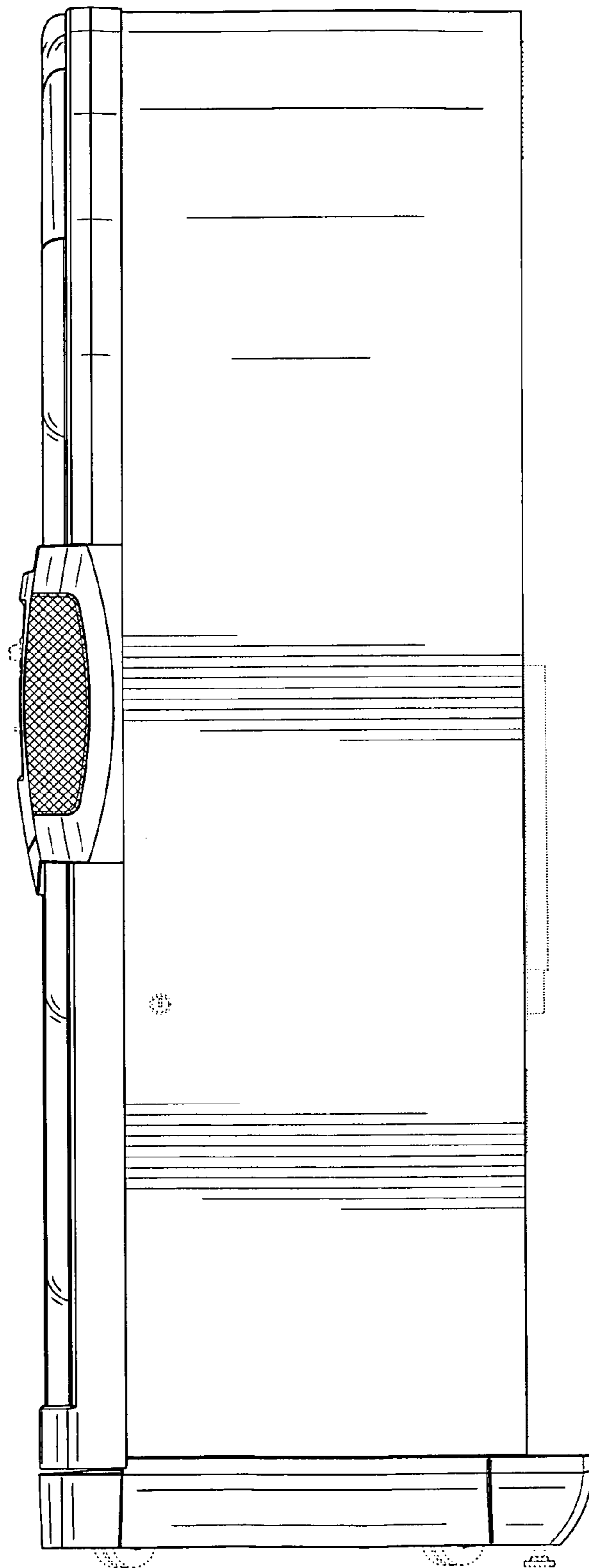

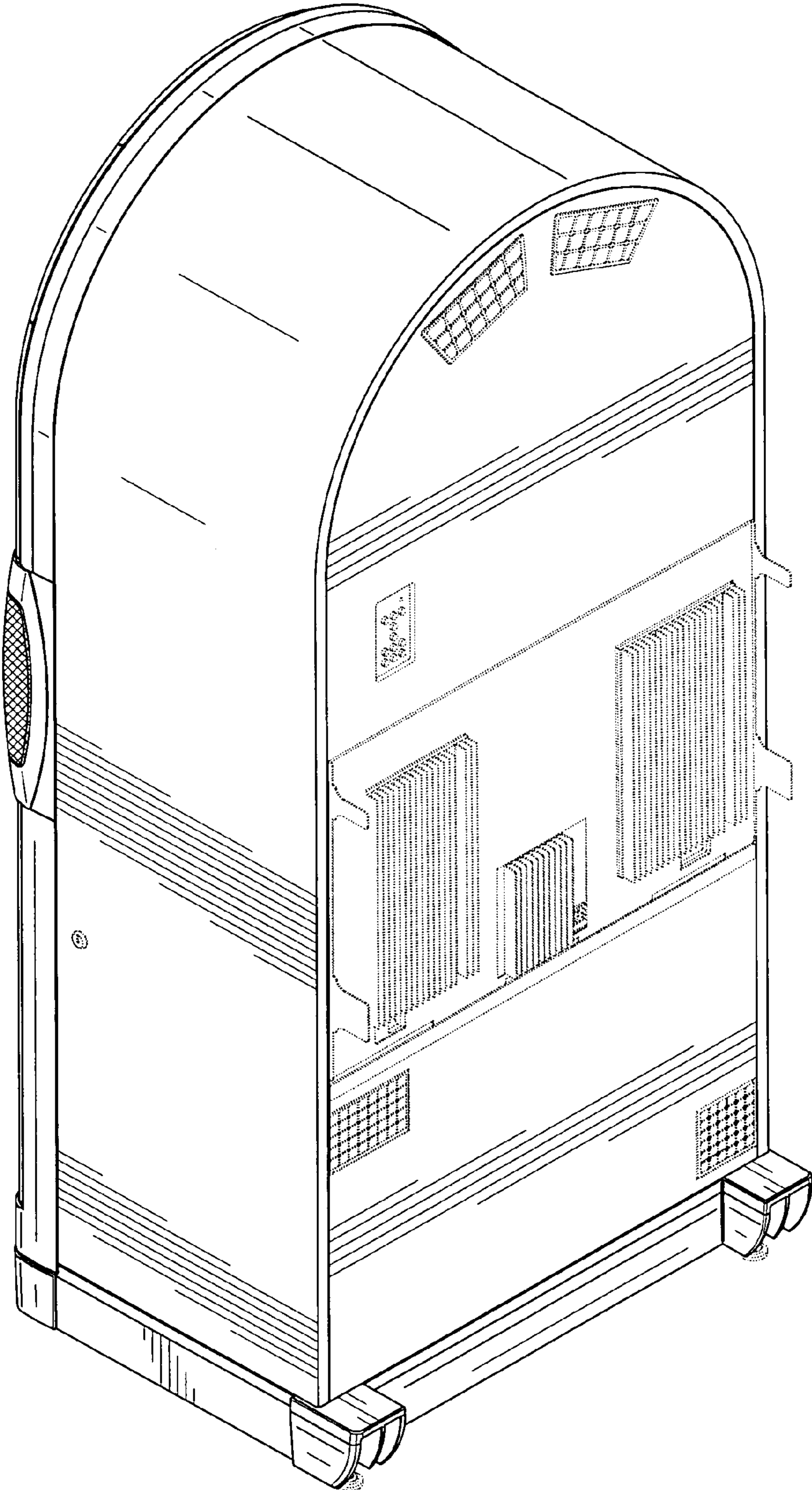
