(57) **CLAIM**

The ornamental design for a magnetic bookmark, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a magnetic bookmark showing our new design;

FIG. 2 is a perspective view showing the magnetic bookmark as it appears on the page of a book thereof;

FIG. 3 is a top plan view thereof;

FIG. 4 is a front view thereof;

FIG. 5 is rear view thereof;

FIG. 6 is a left-side view thereof, the right-side being a mirror image; and

FIG. 7 is a bottom plan view thereof;

FIG. 8 is a perspective view of a second magnetic bookmark showing our new design;

FIG. 9 is a perspective view showing the second magnetic bookmark as it appears on the page of a book thereof;

FIG. 10 is a top plan view thereof;

FIG. 11 is a front view thereof;

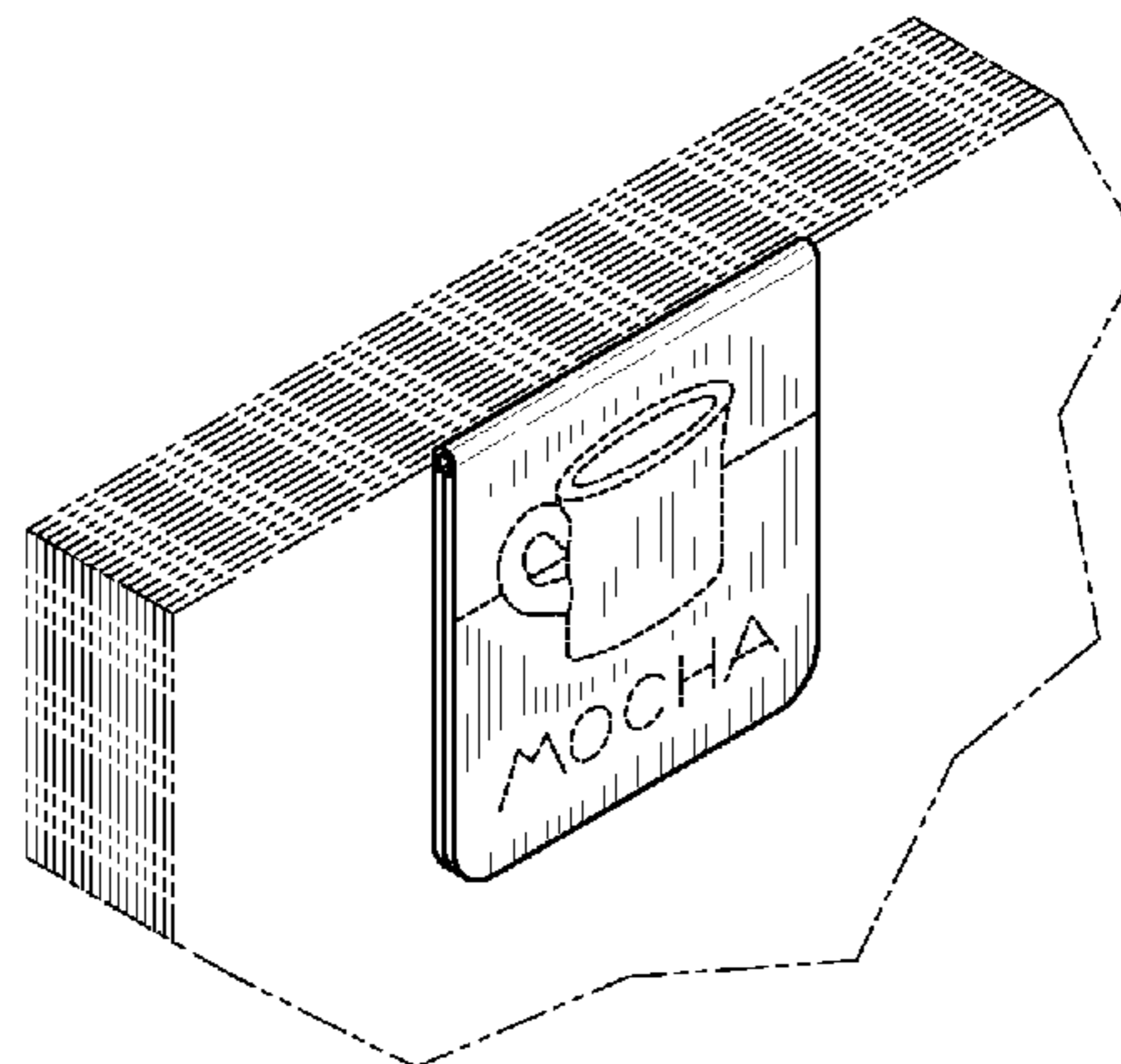
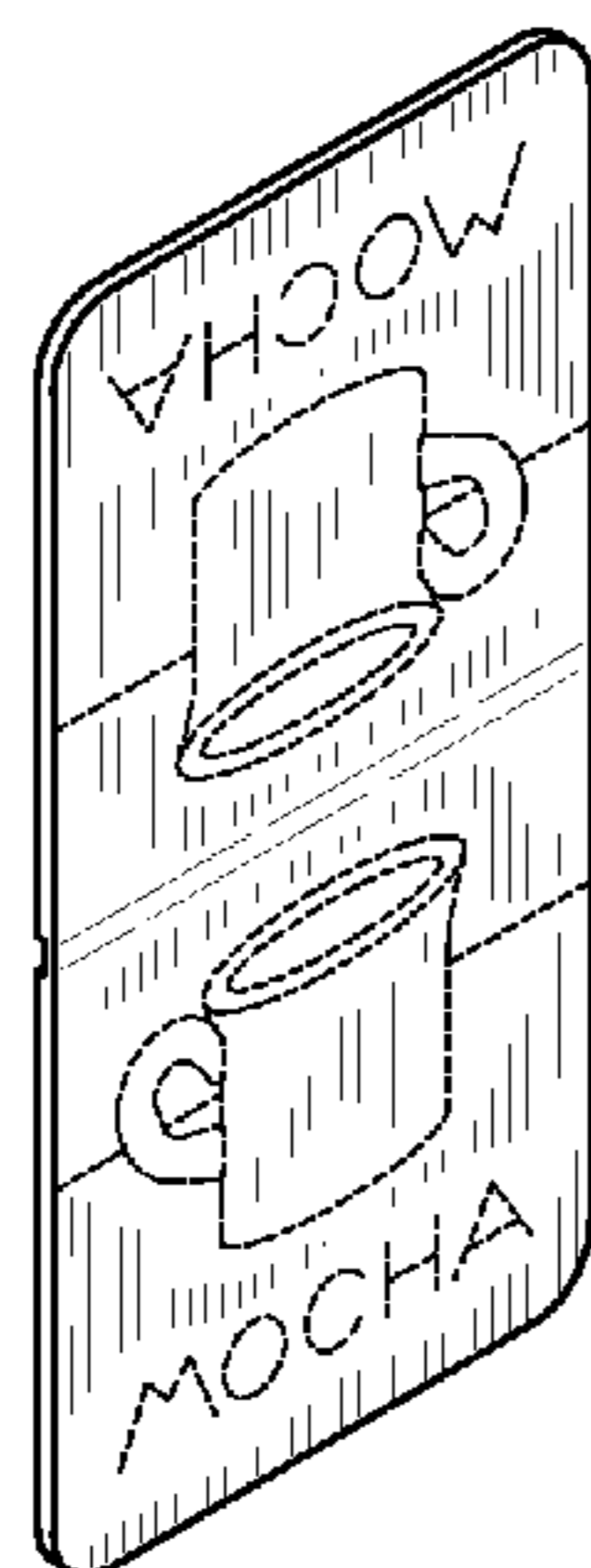
FIG. 12 is rear view thereof;

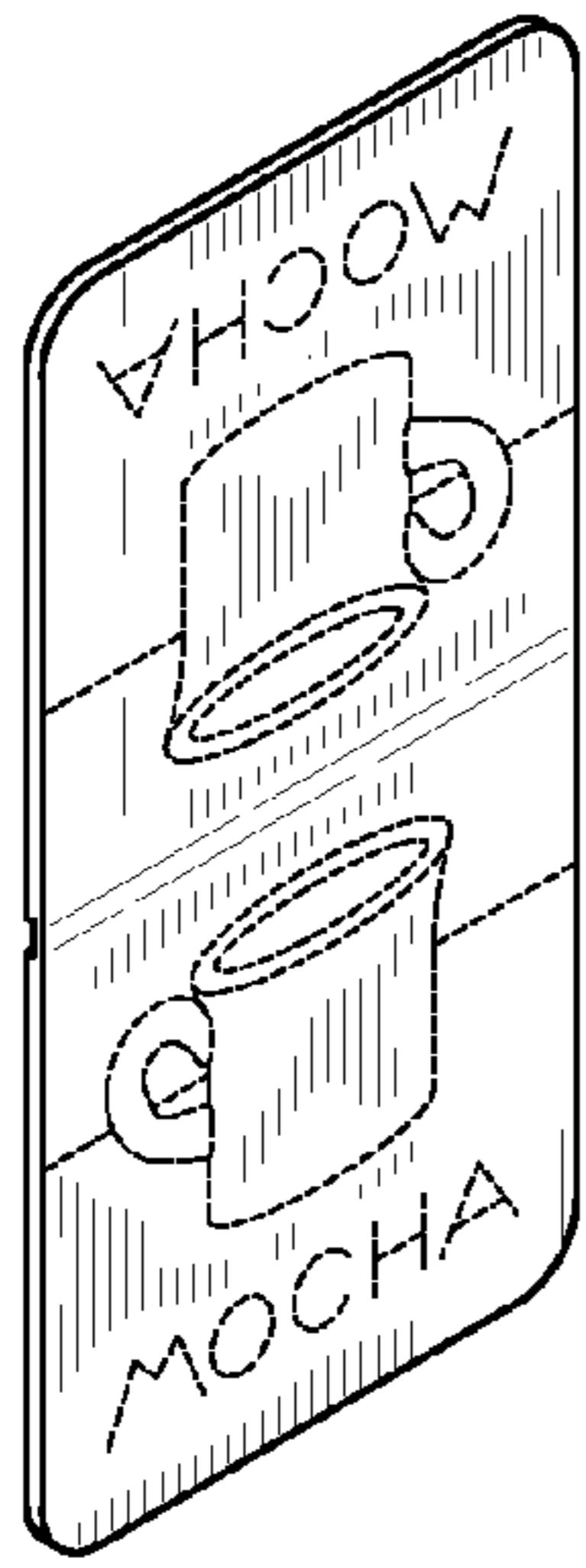

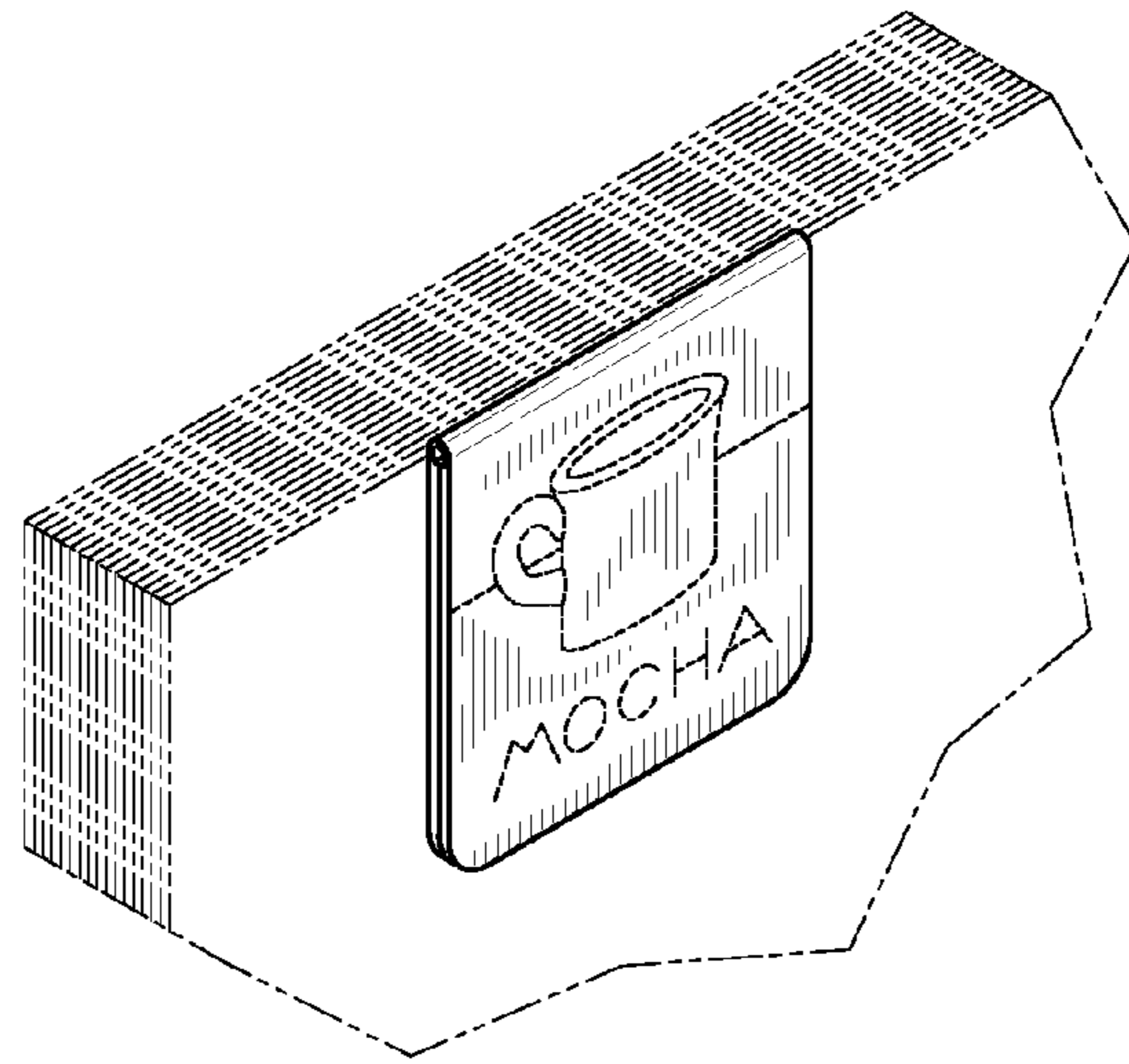

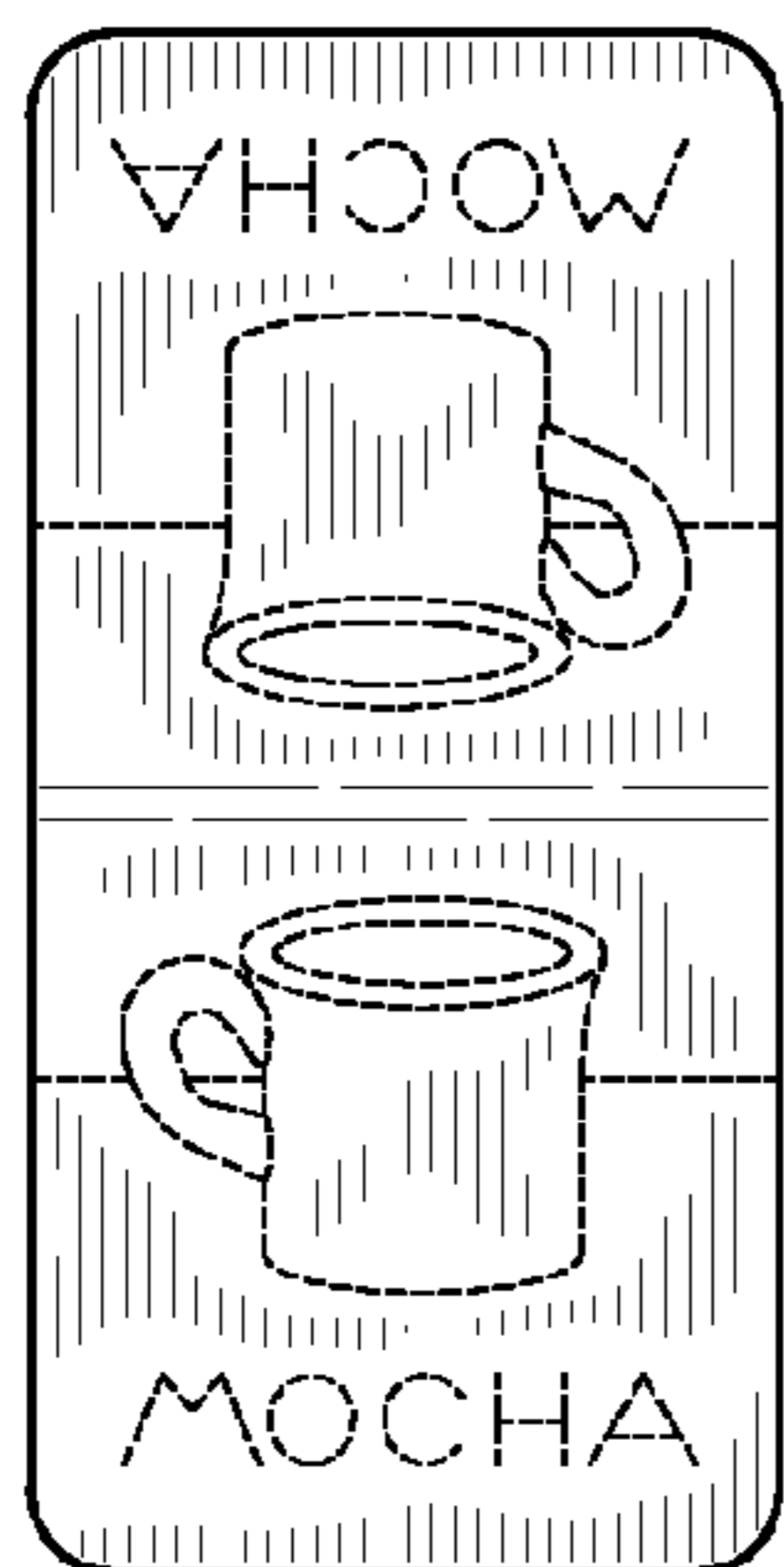

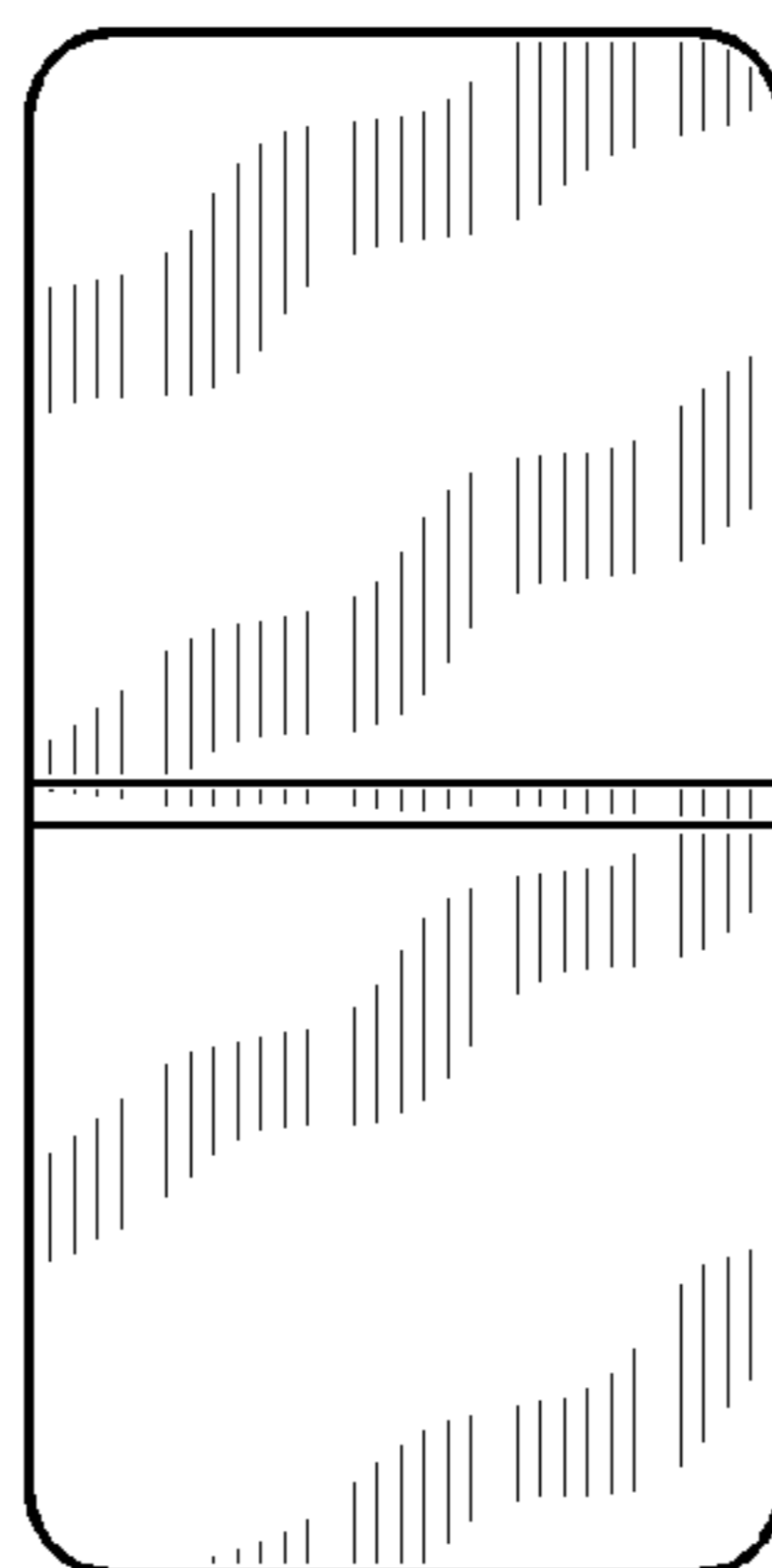

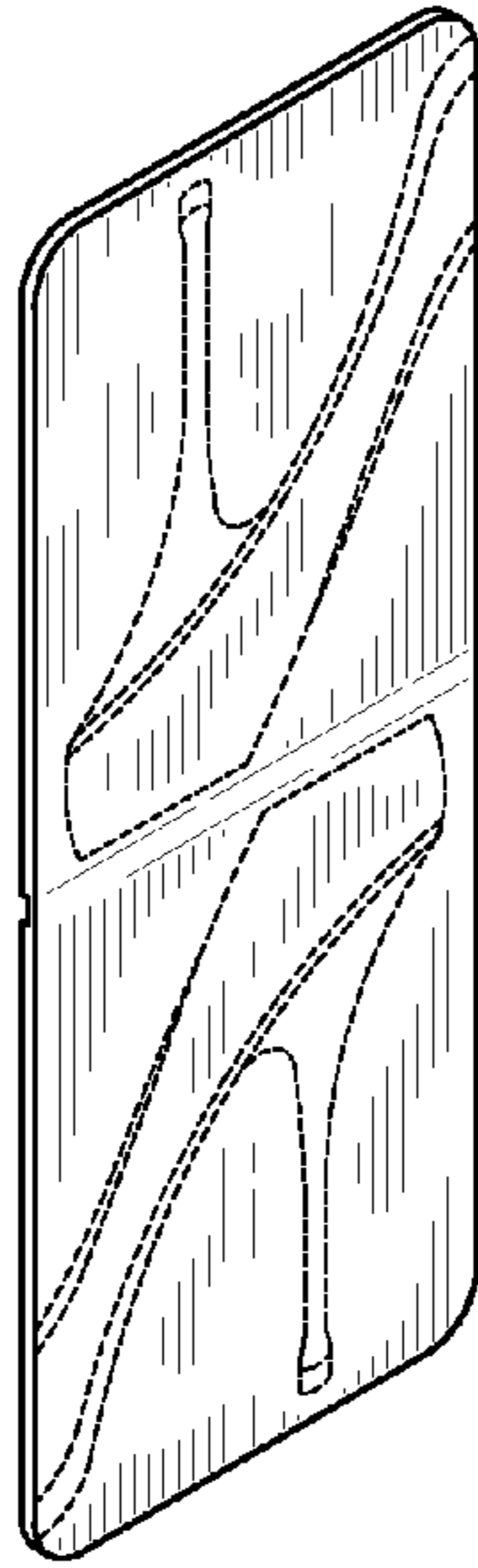

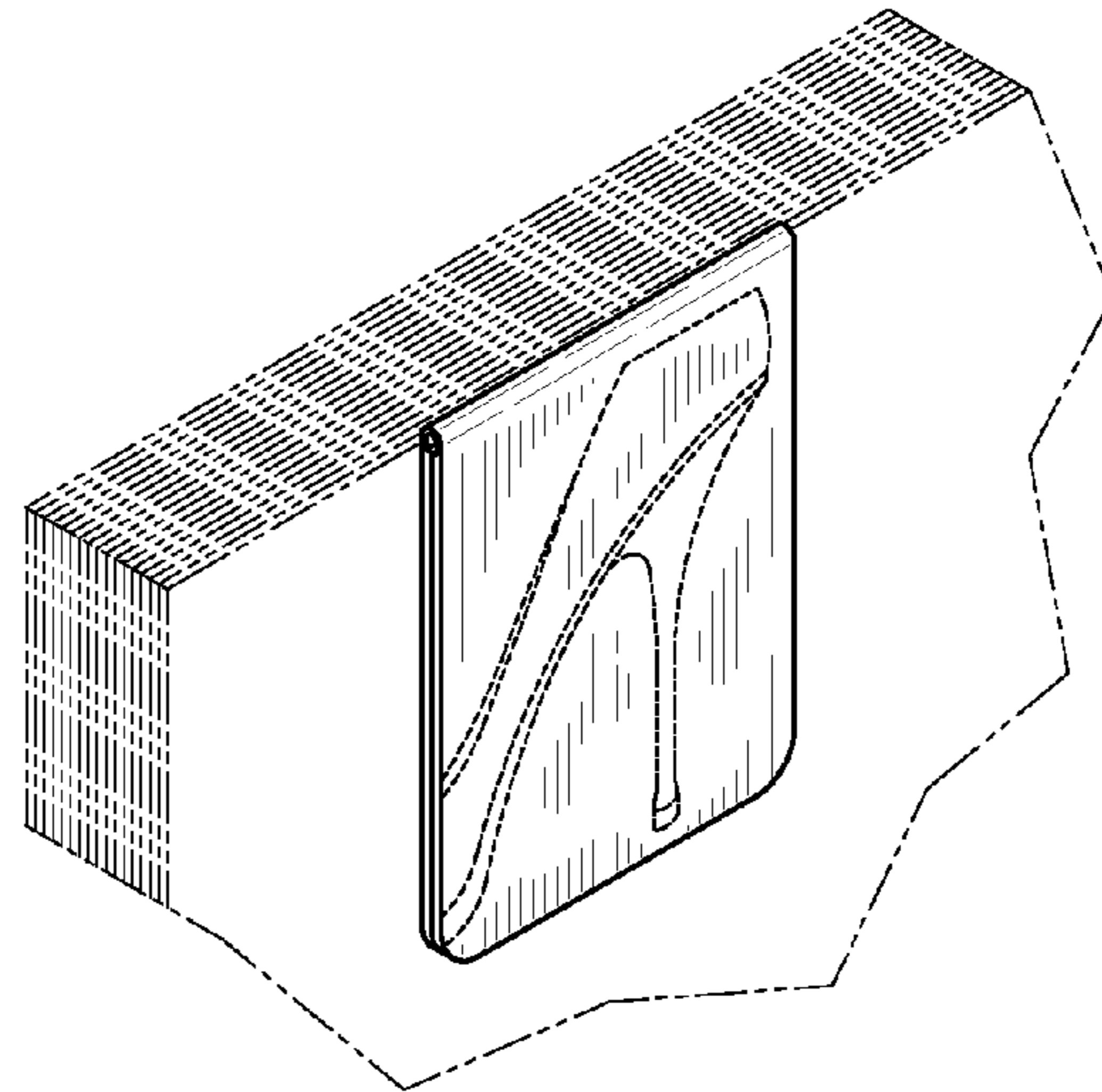

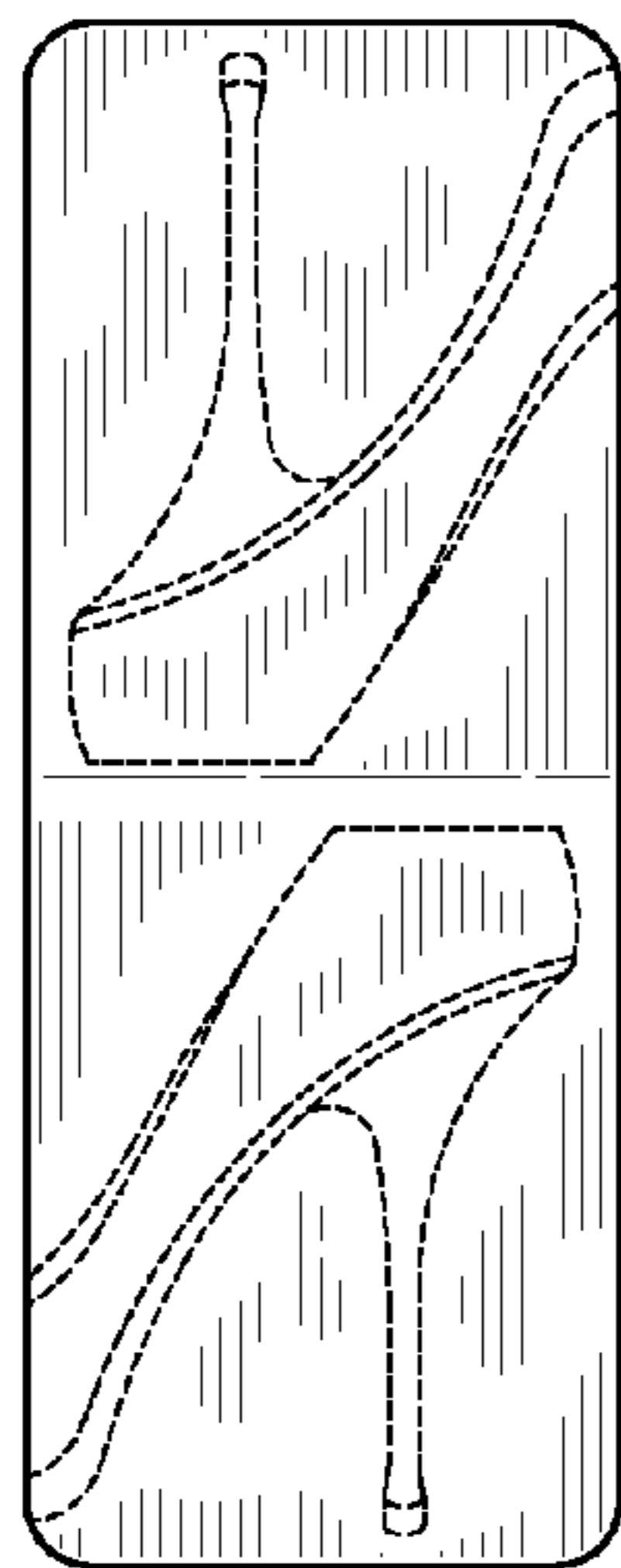

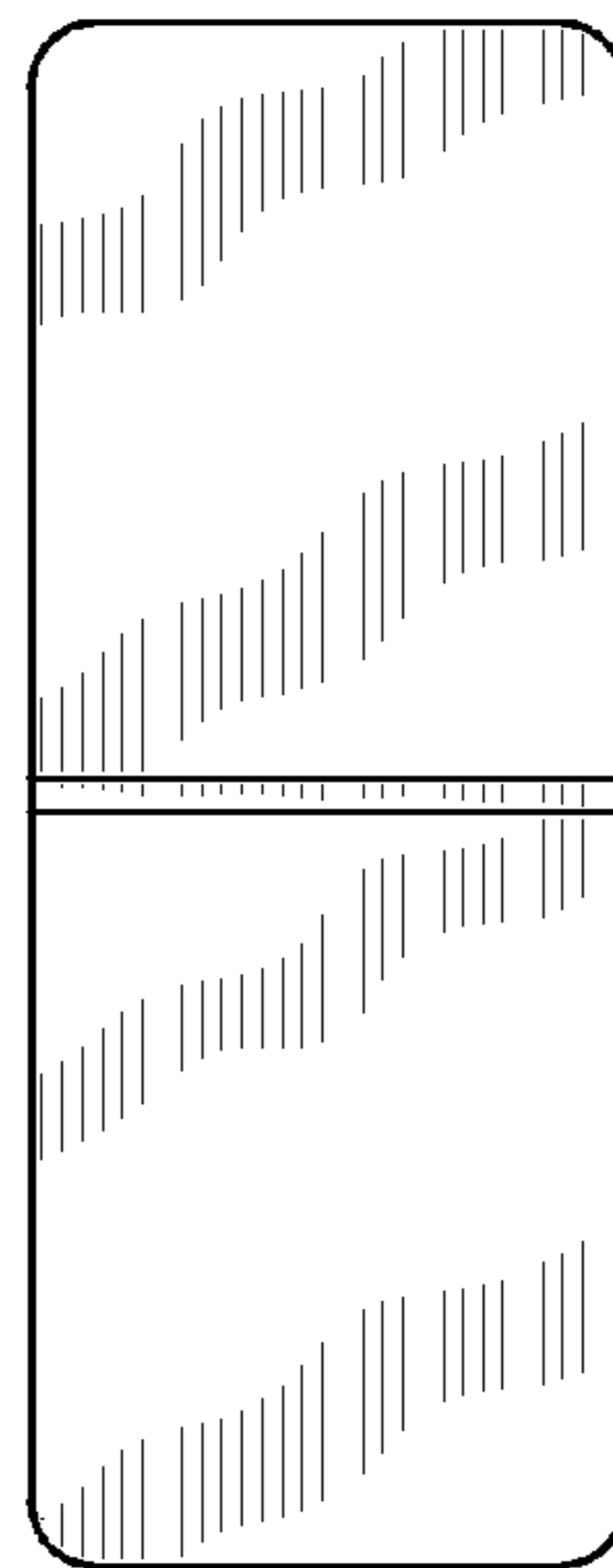
